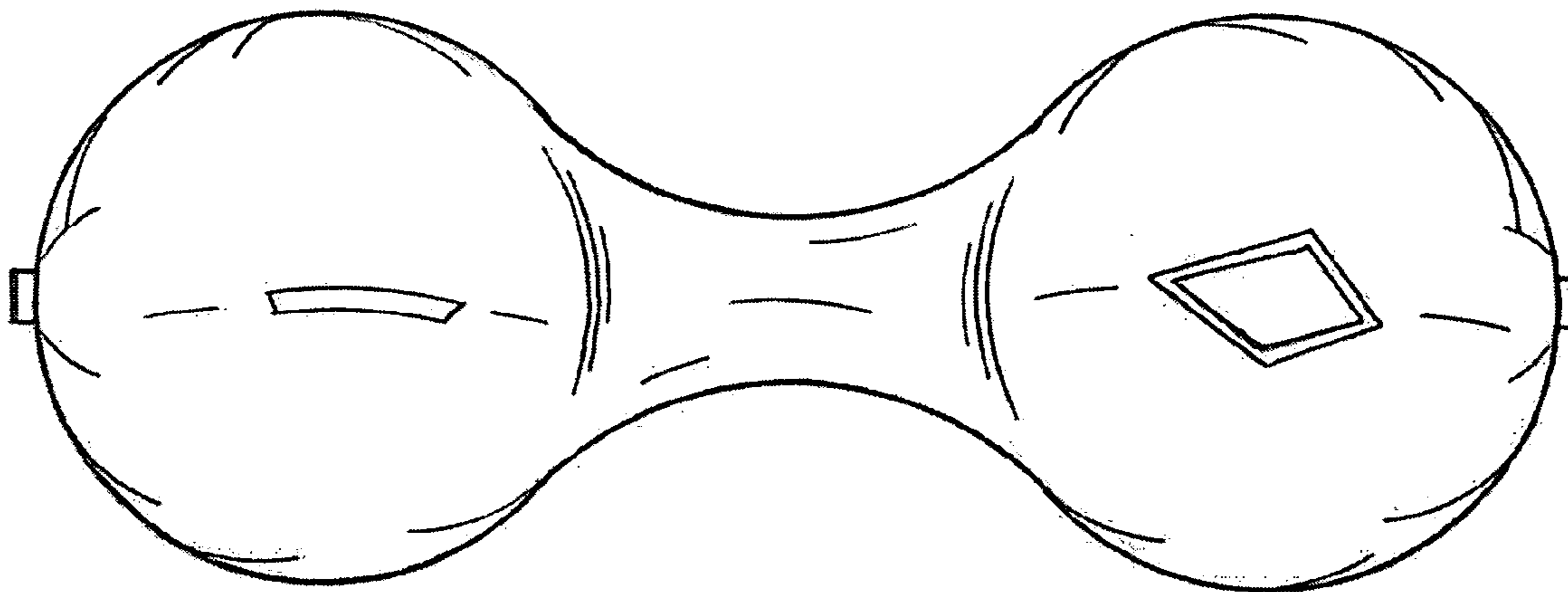
FIG. 1 is a first side view of the travel pillow;

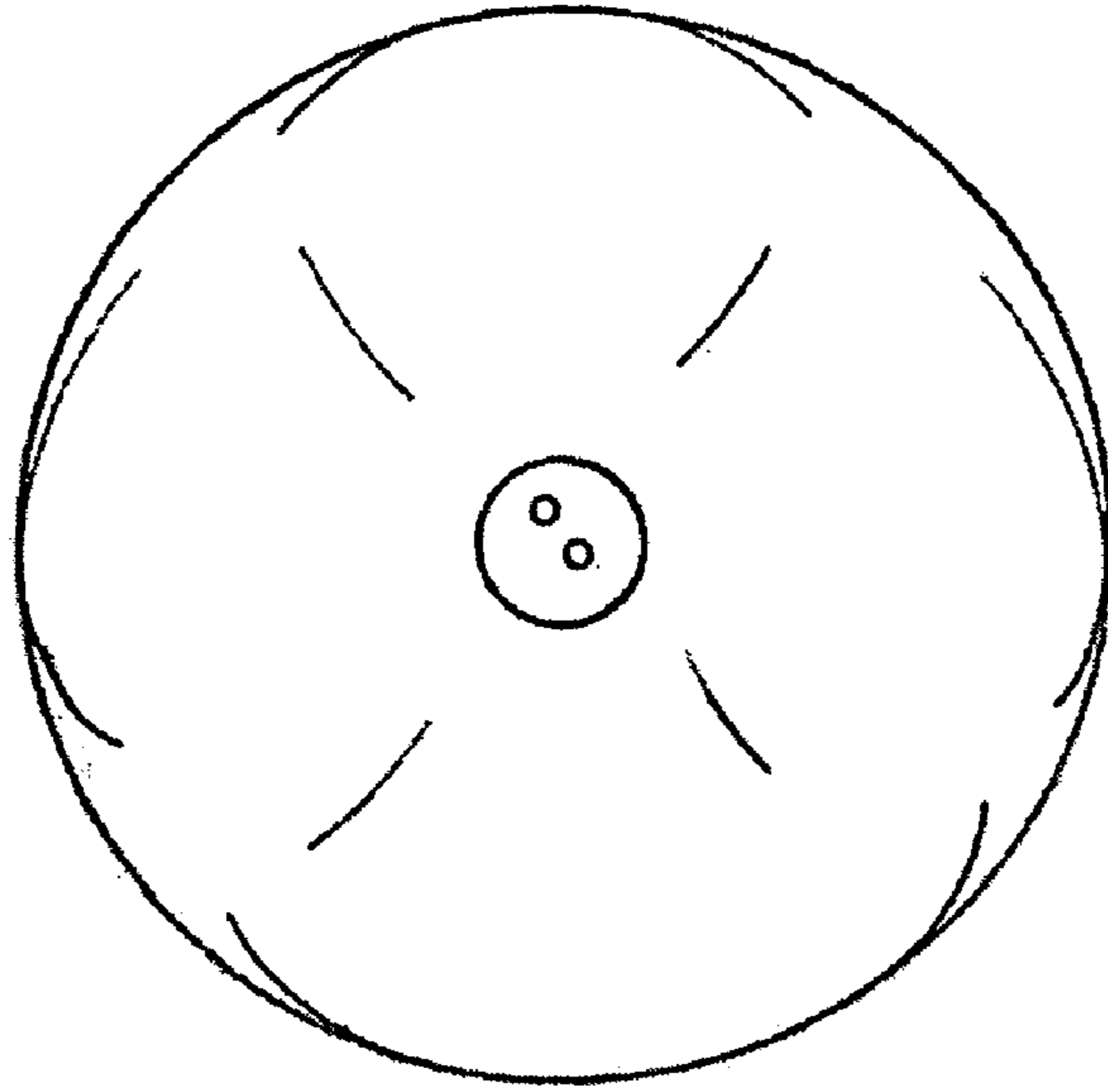

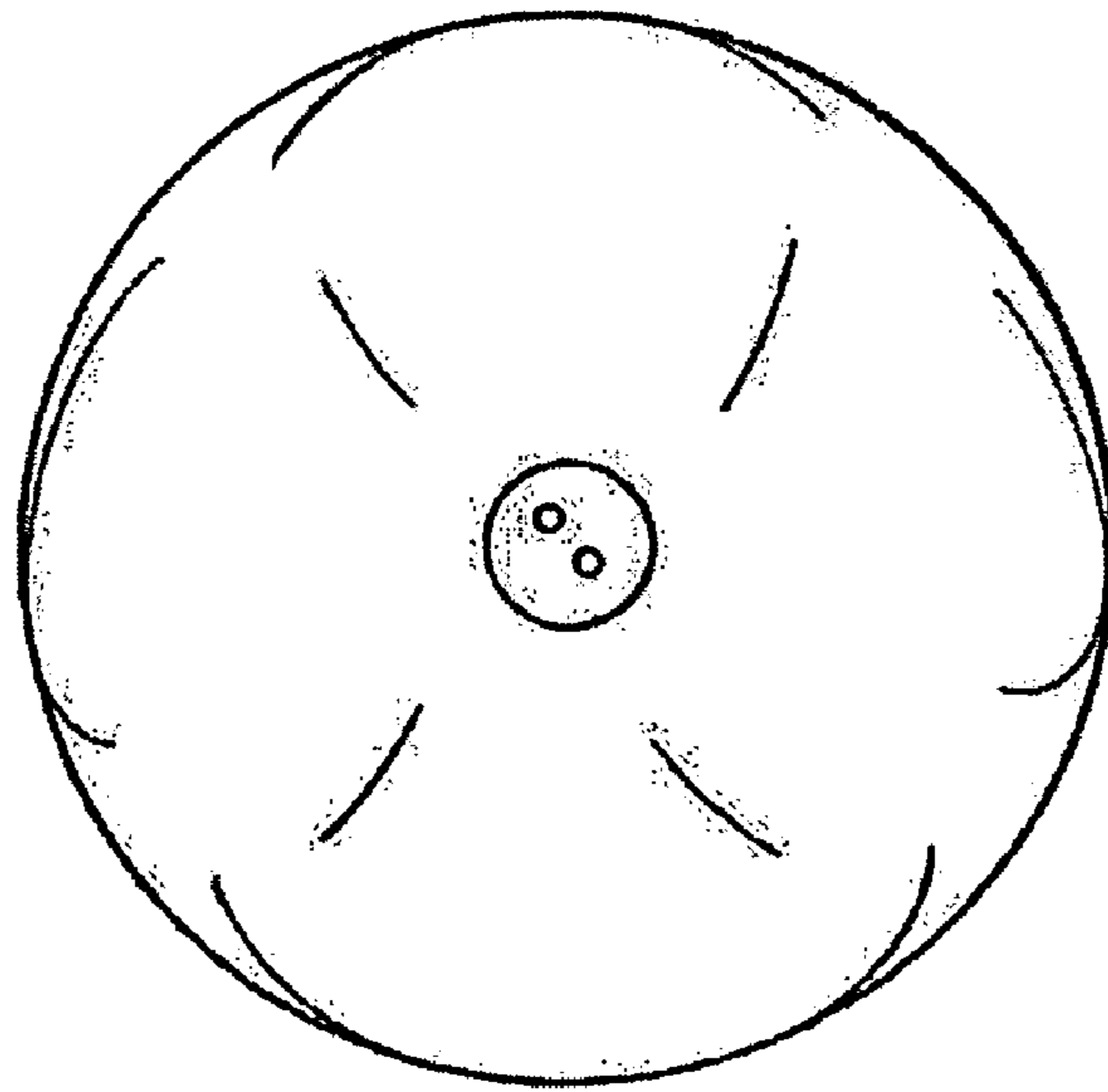

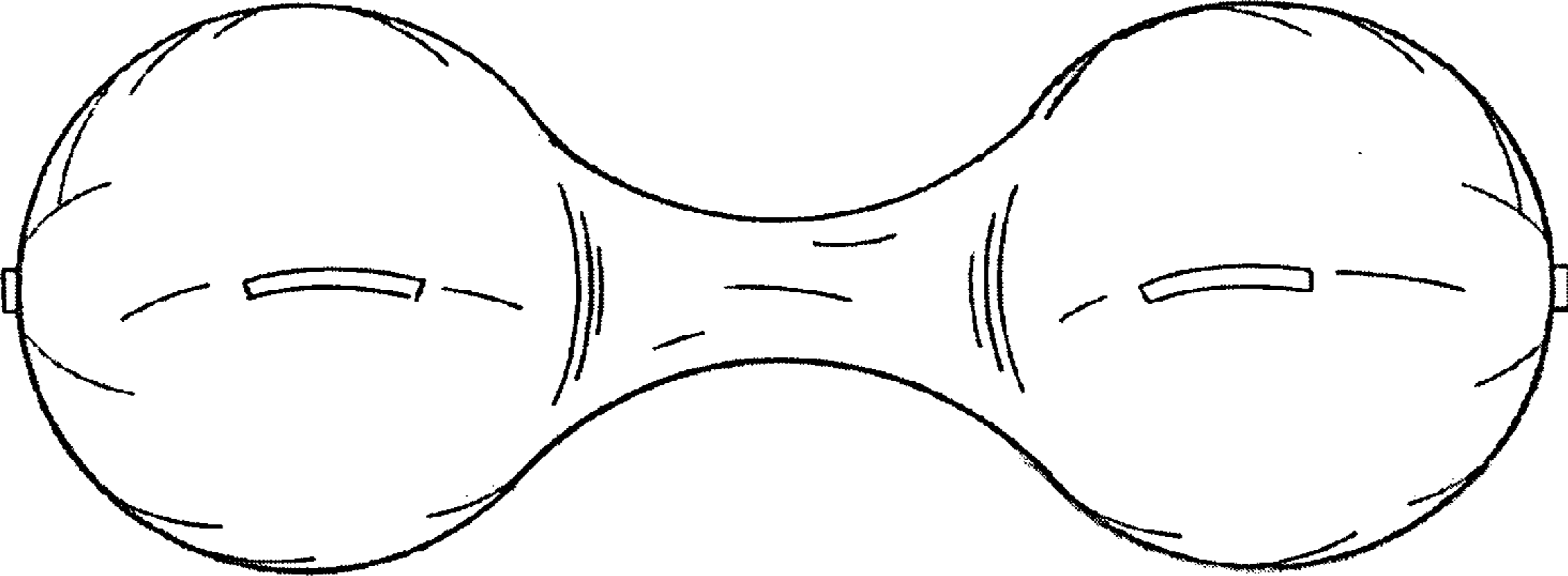

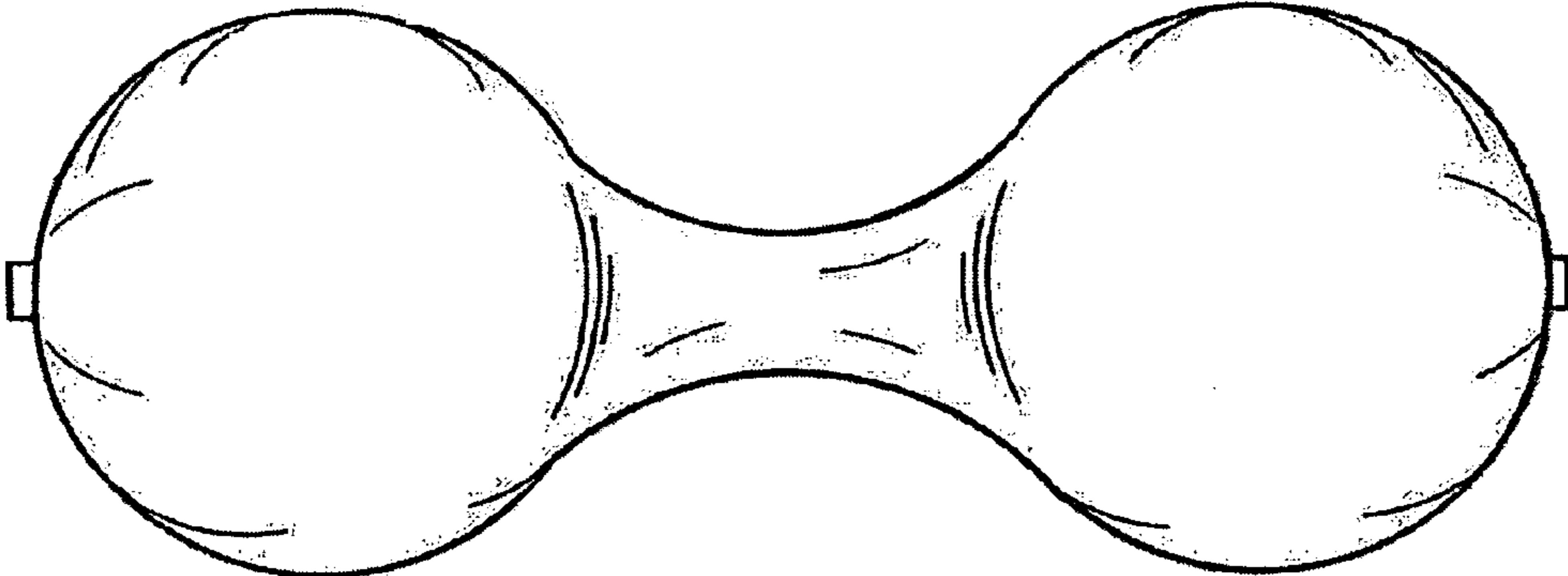

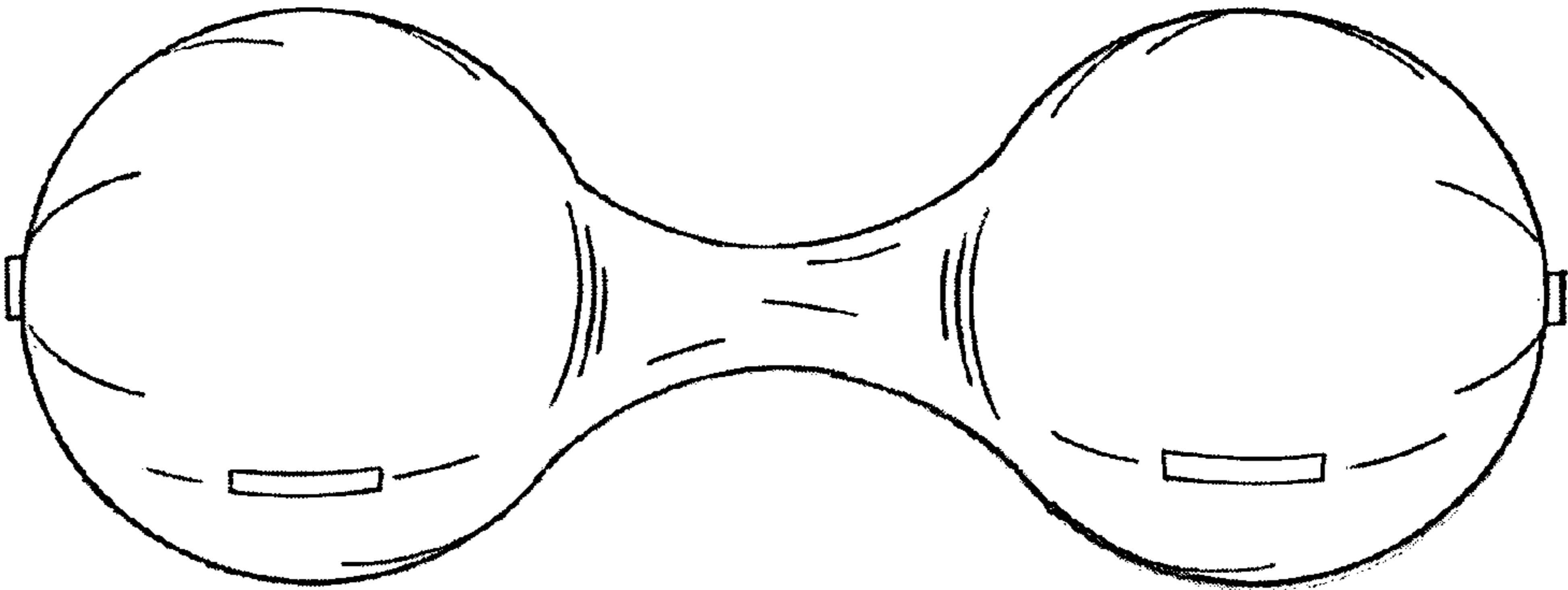

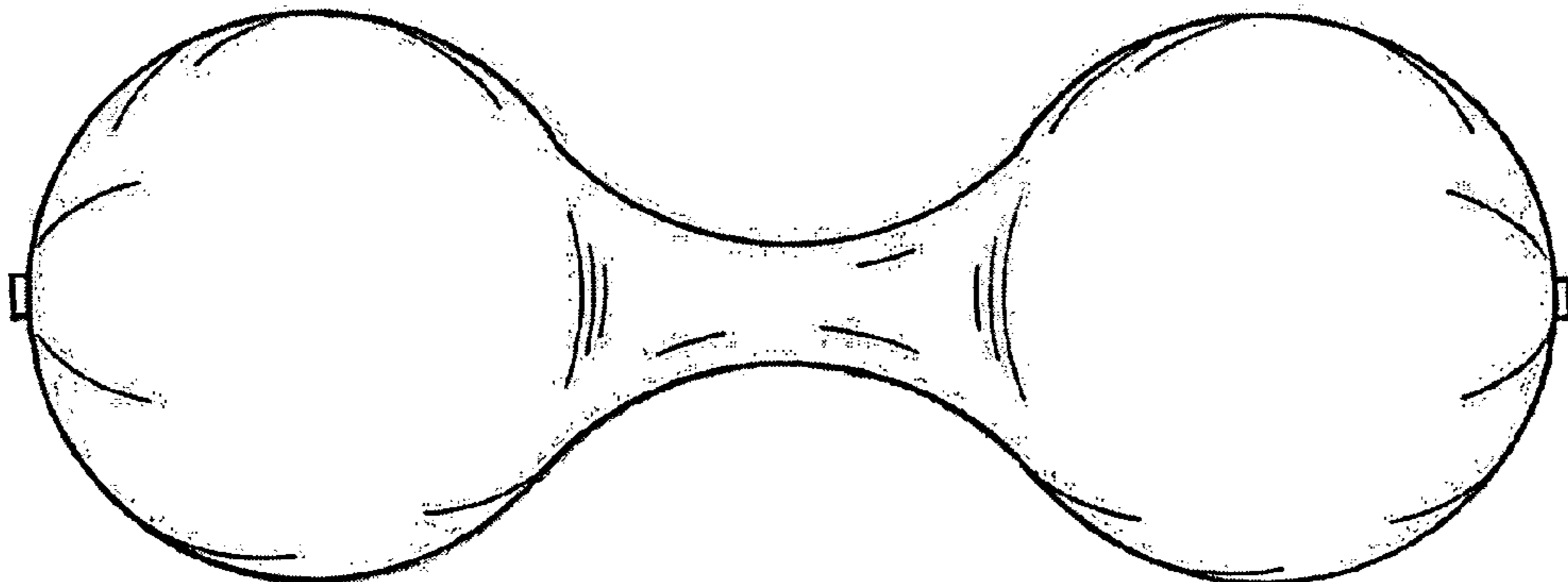

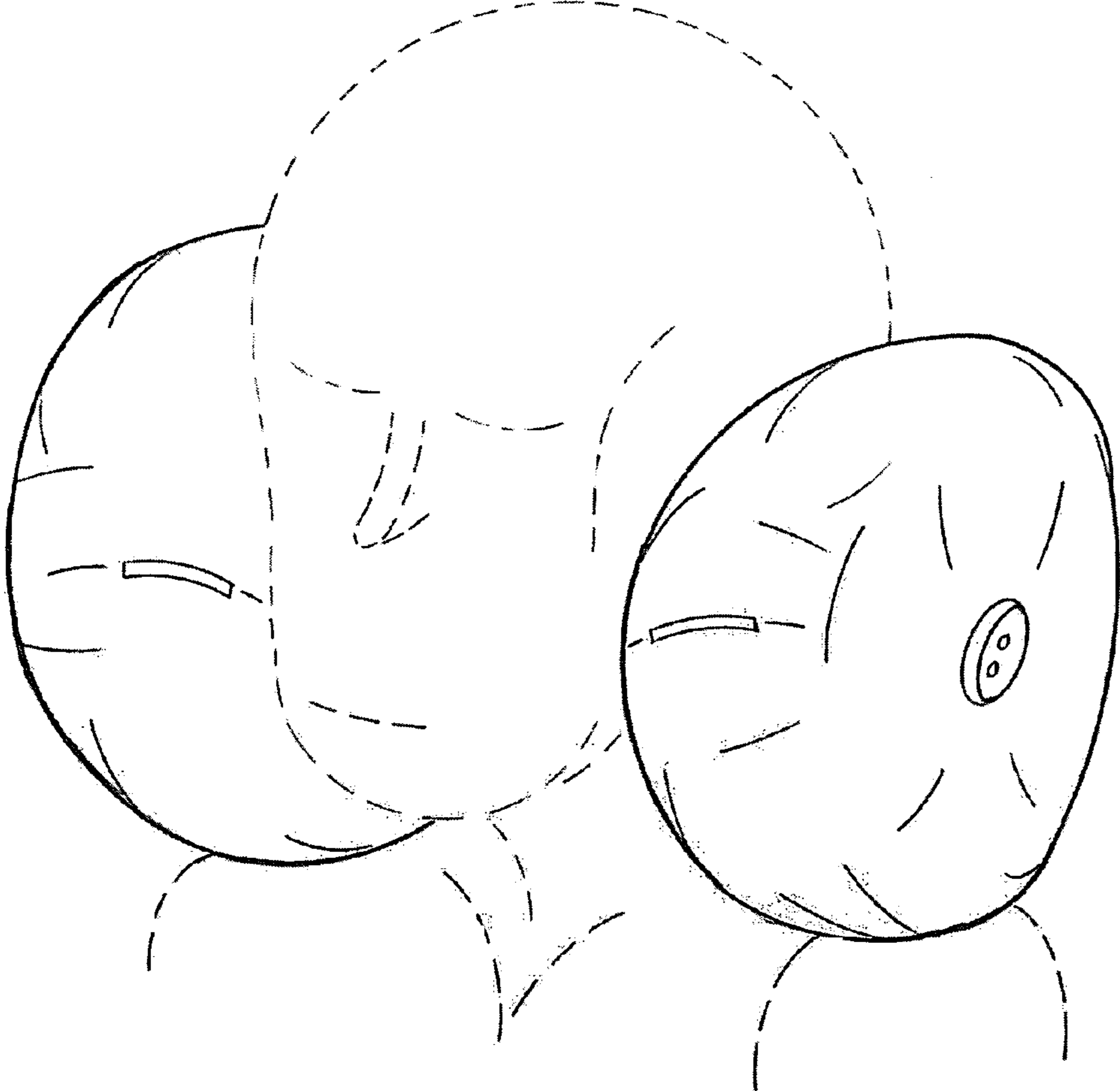

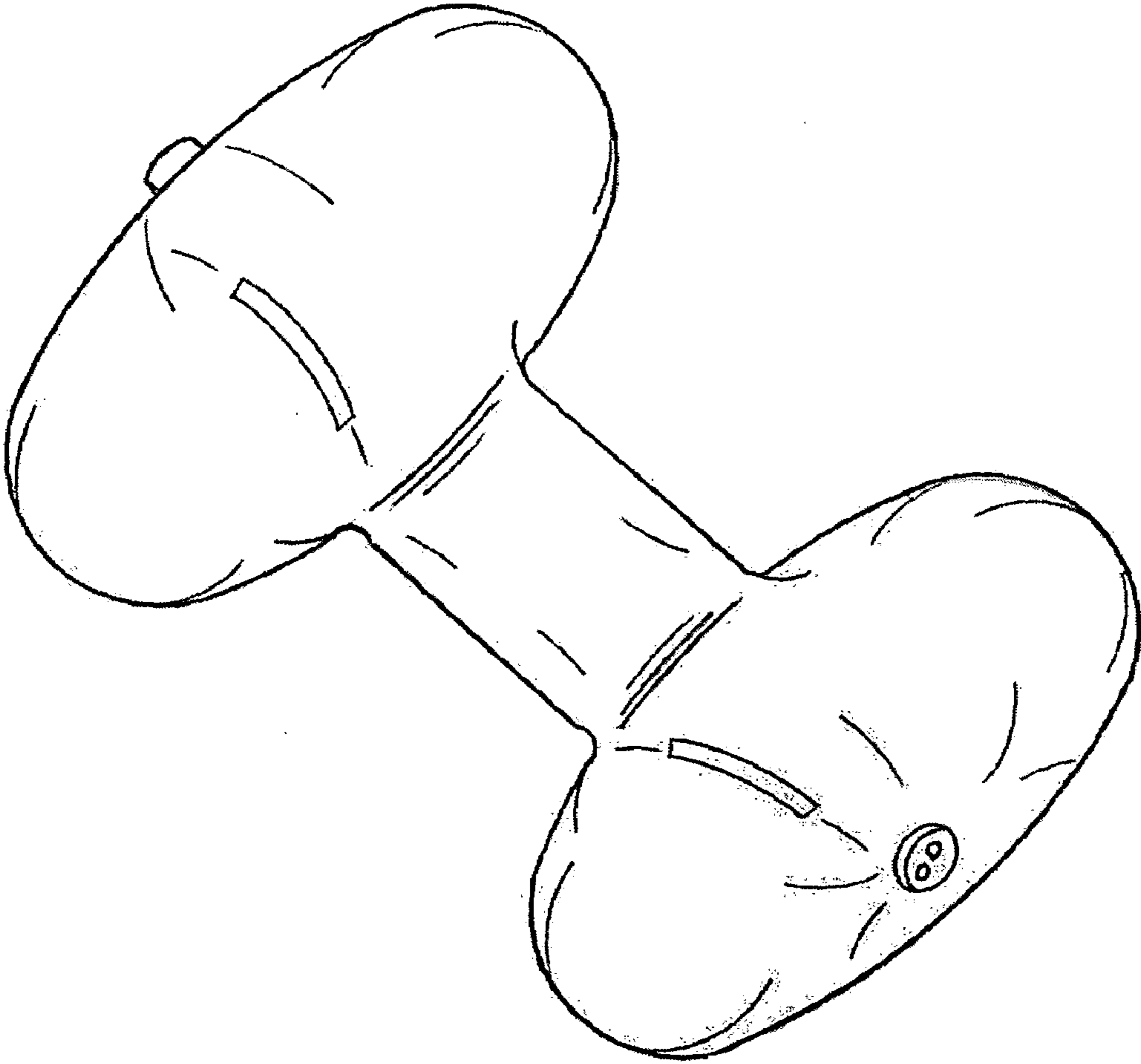

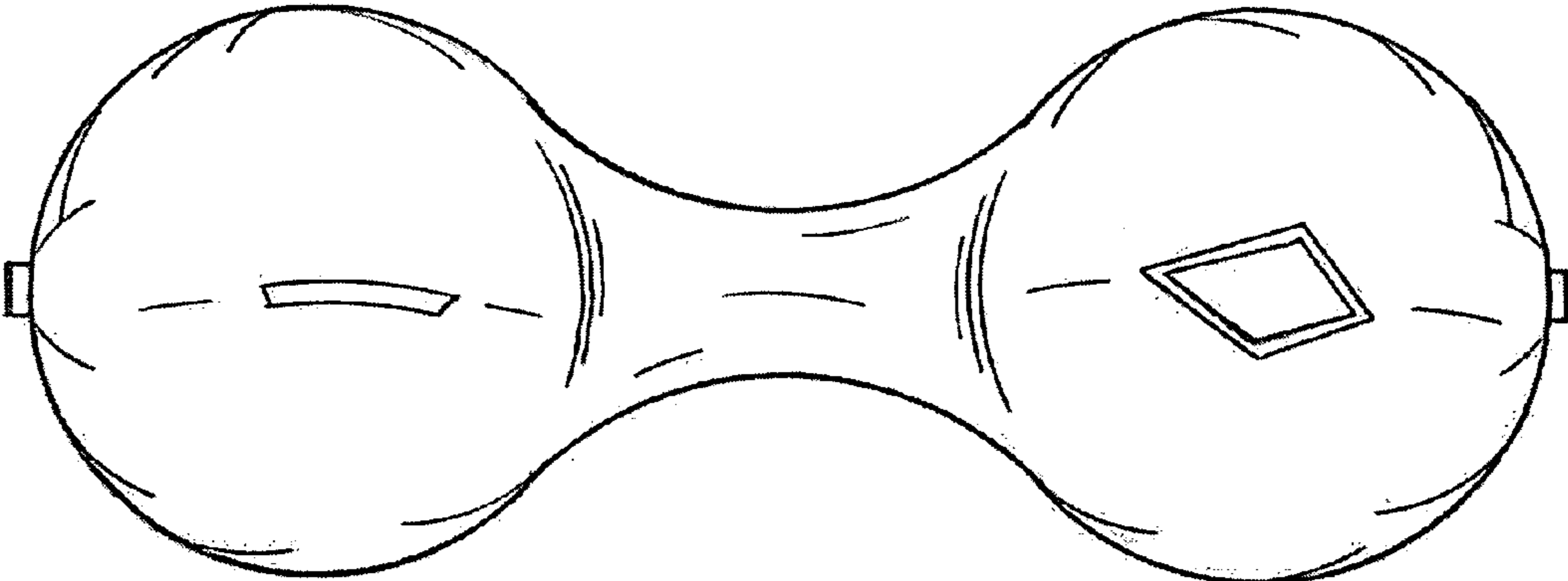
