mirror image of this).

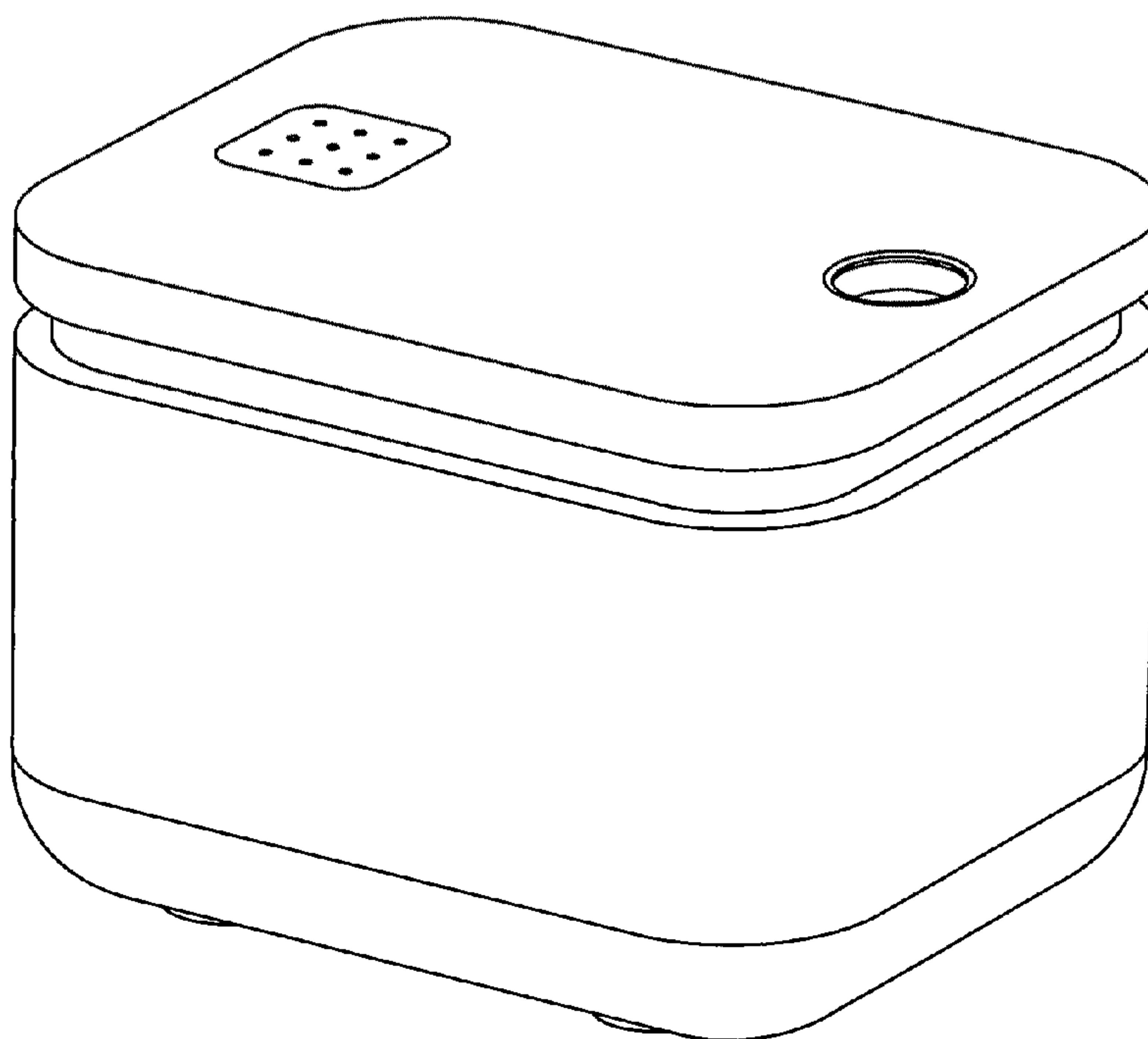
FIG. 3 is the left side view thereof.

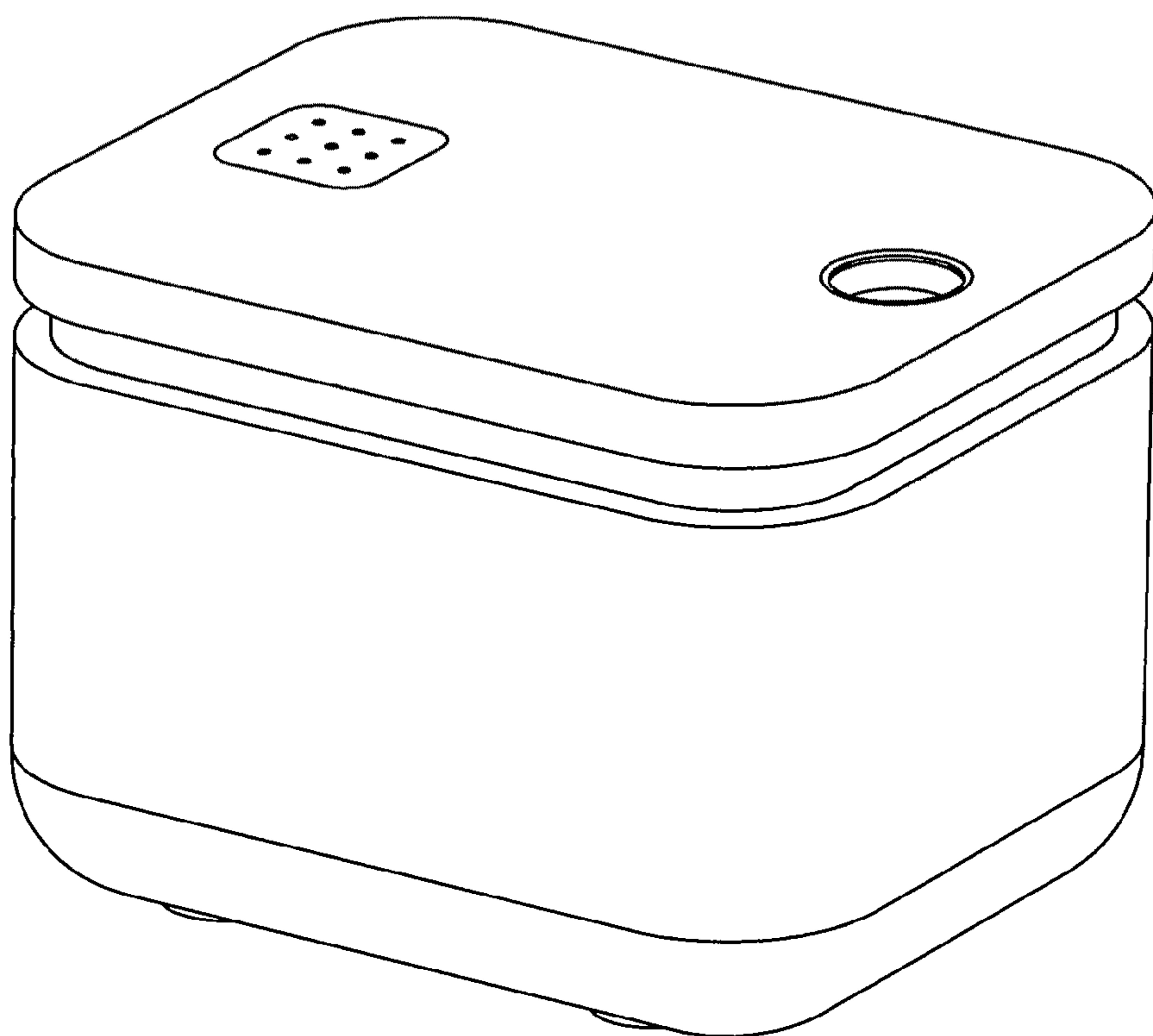

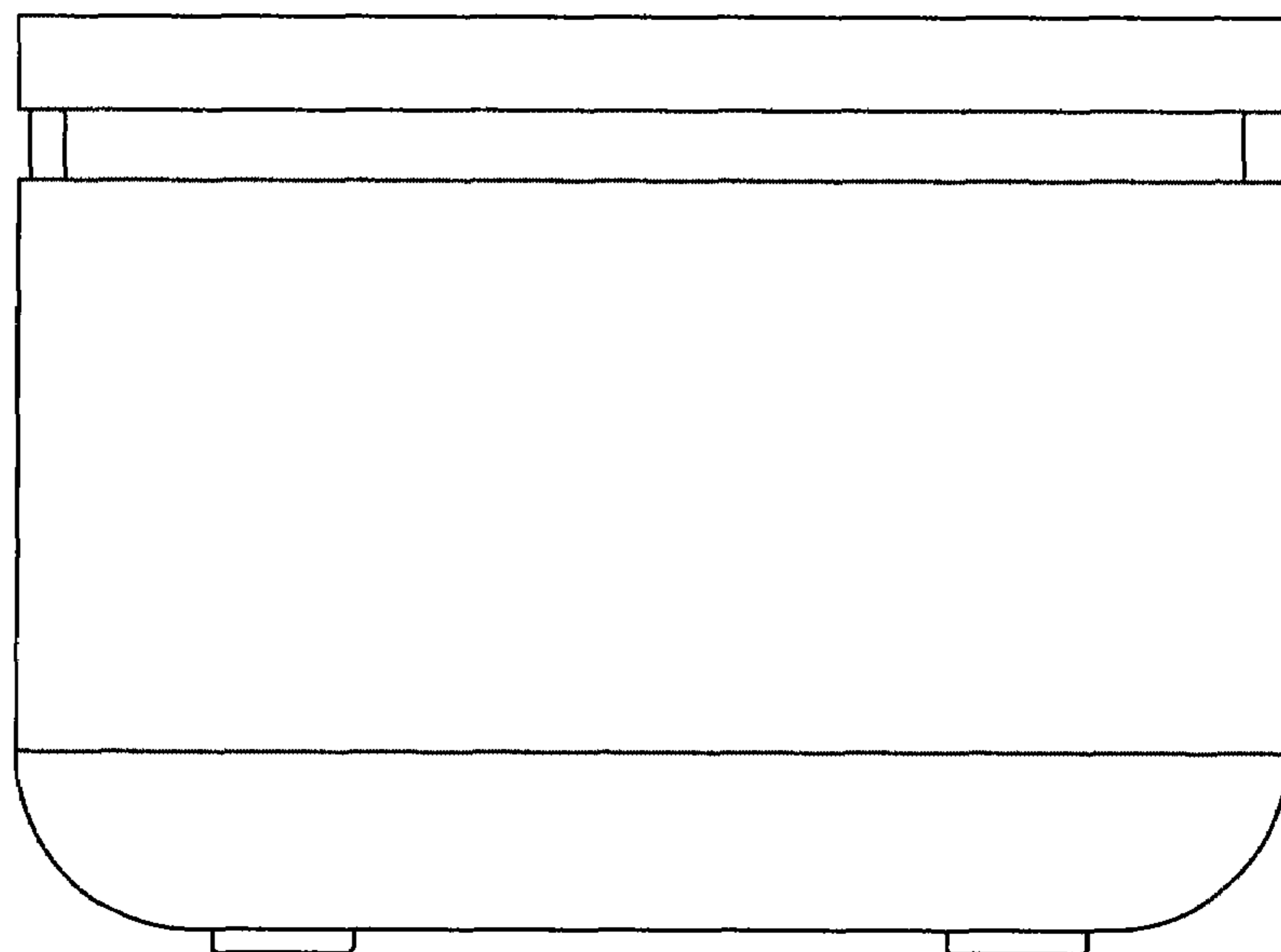

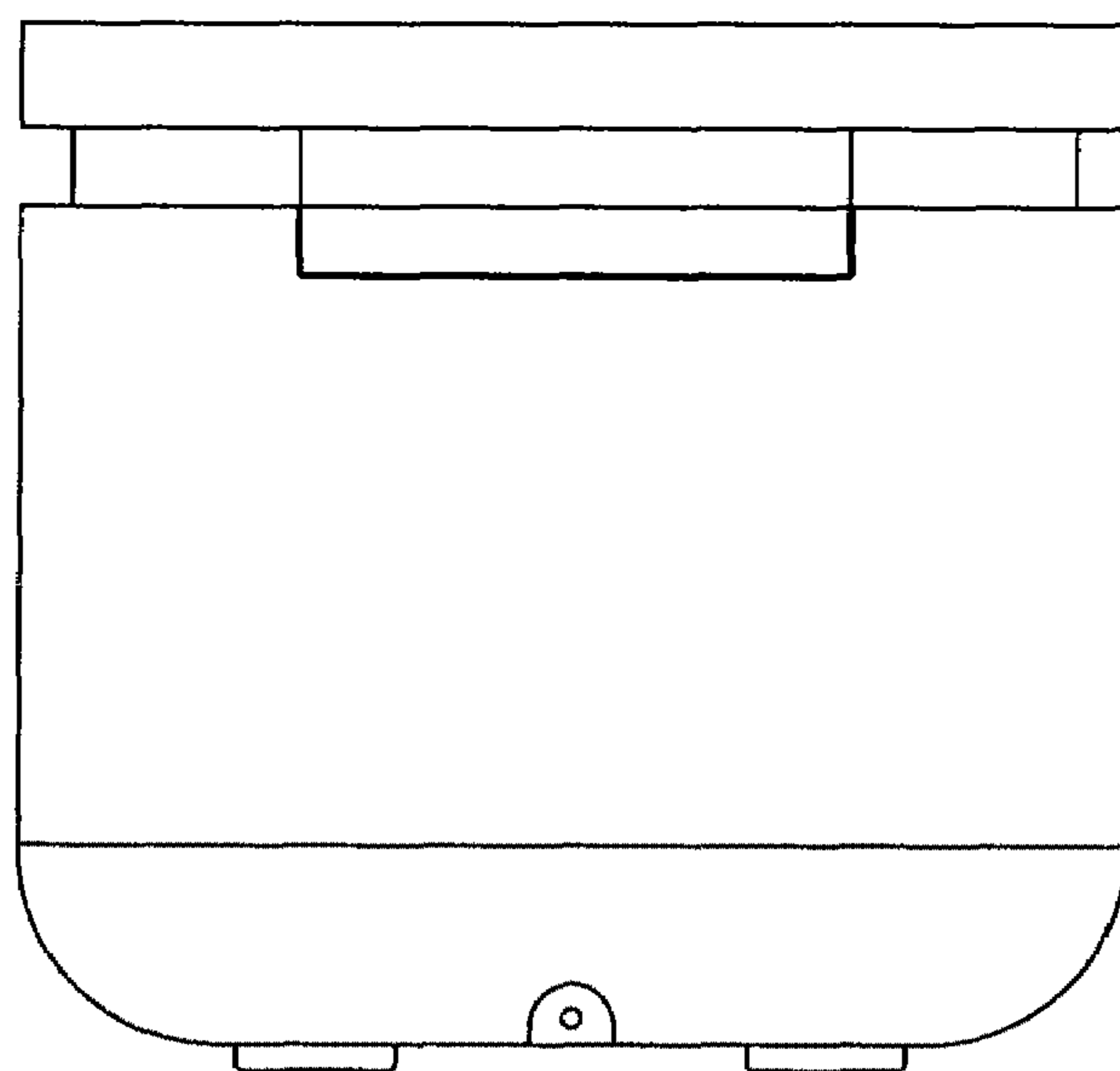

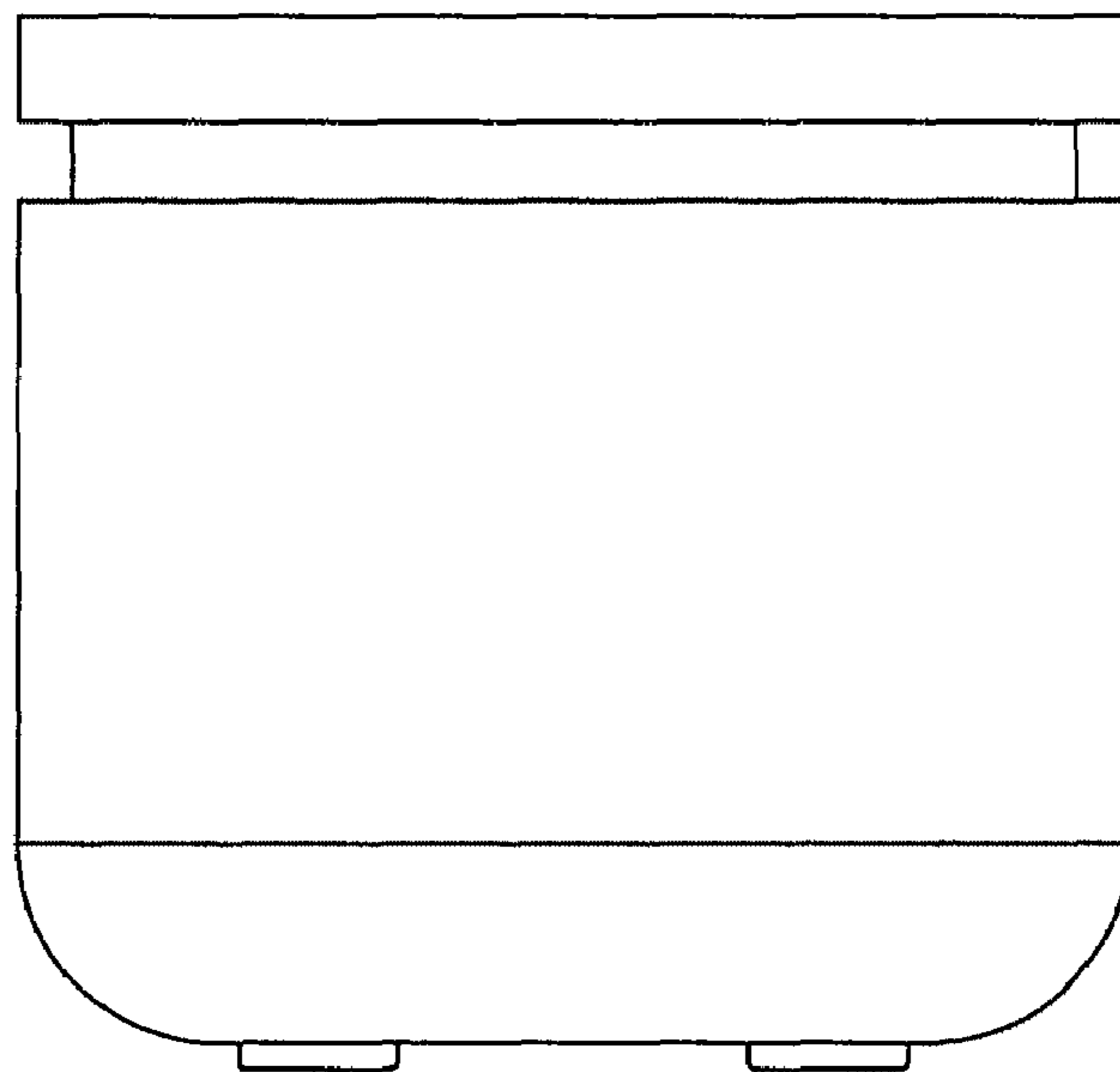

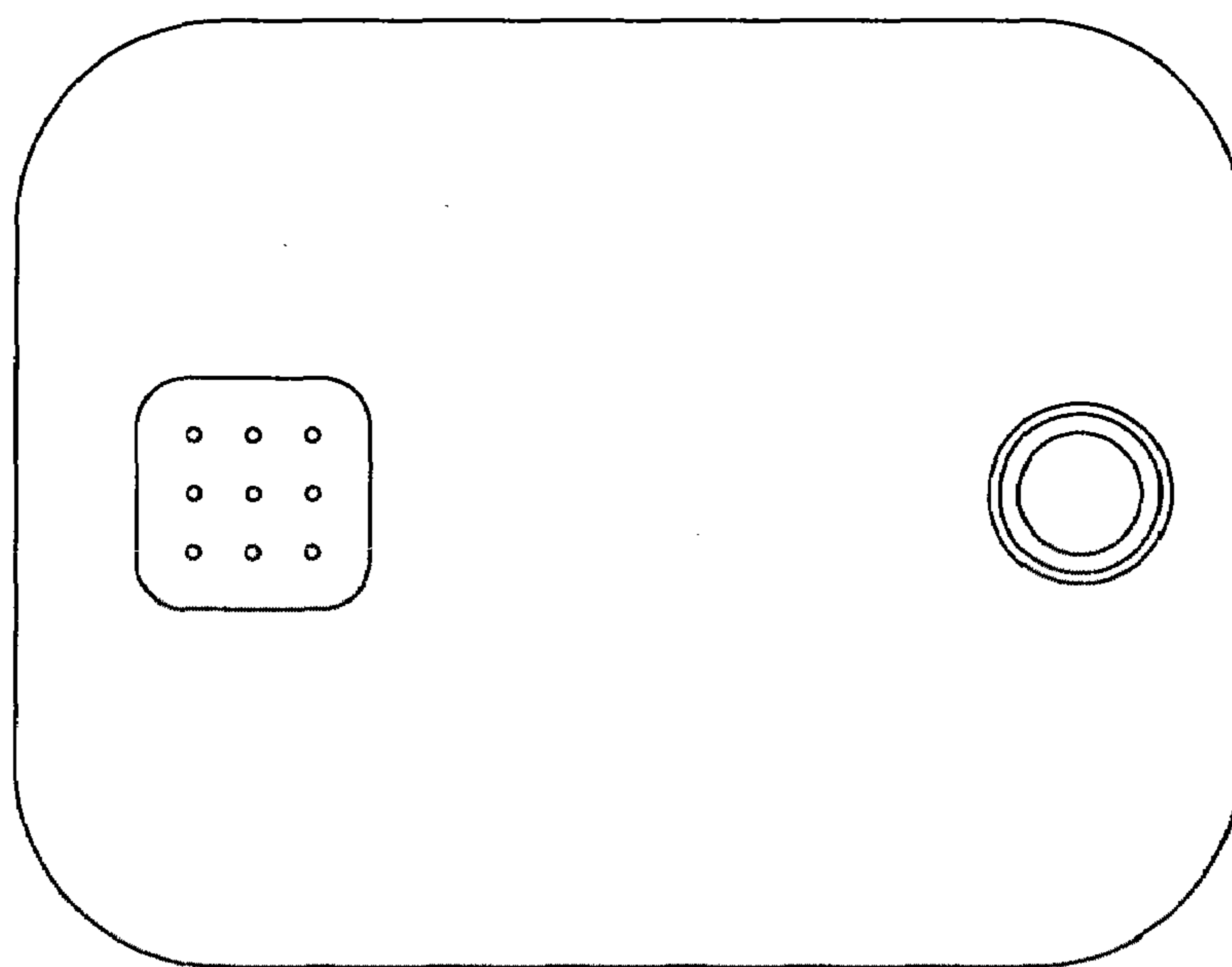

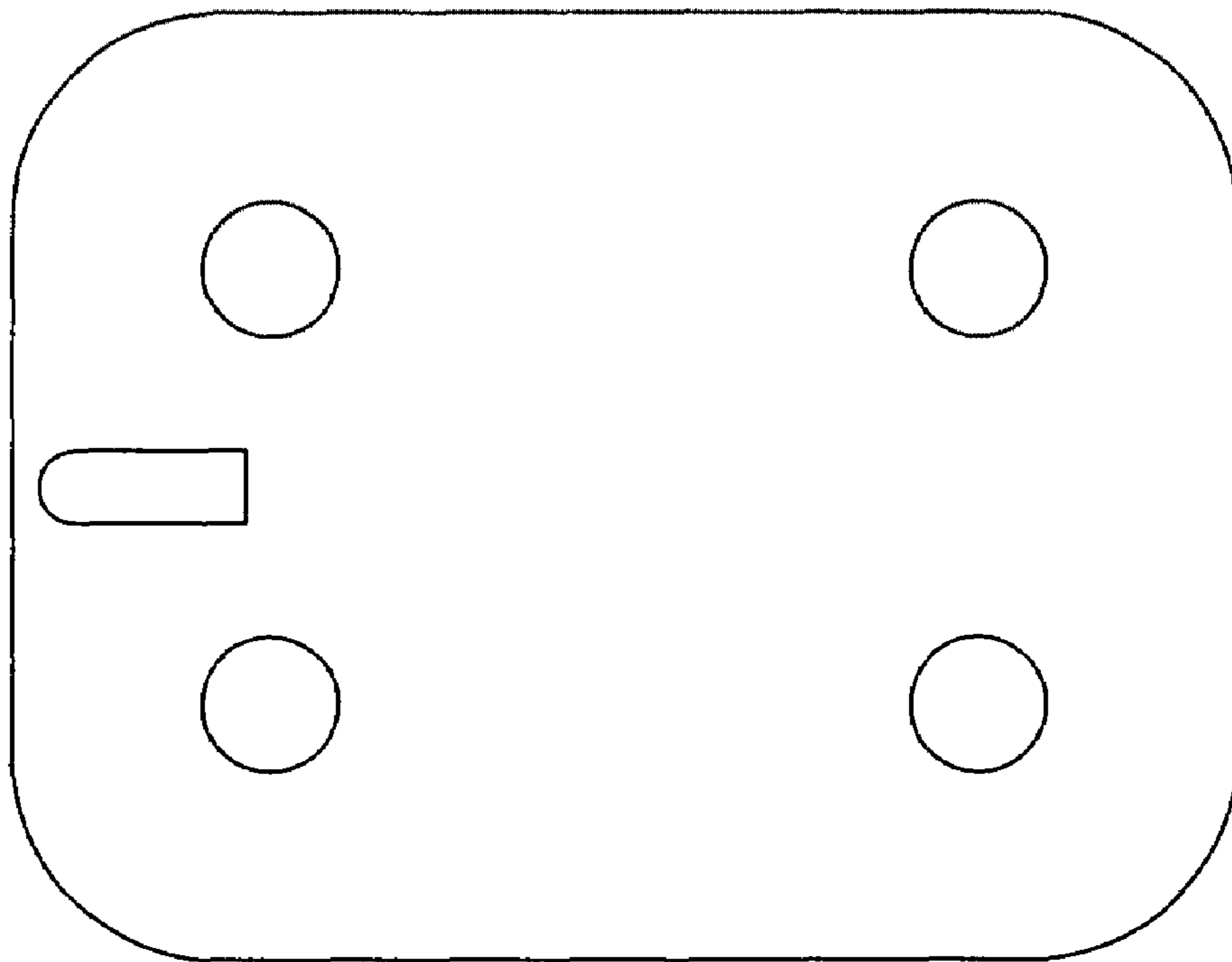
