**DESCRIPTION**

FIG. 1 is a perspective view of the spice dispenser, showing my new design;

FIG. 2 is a front view of the spice dispenser;

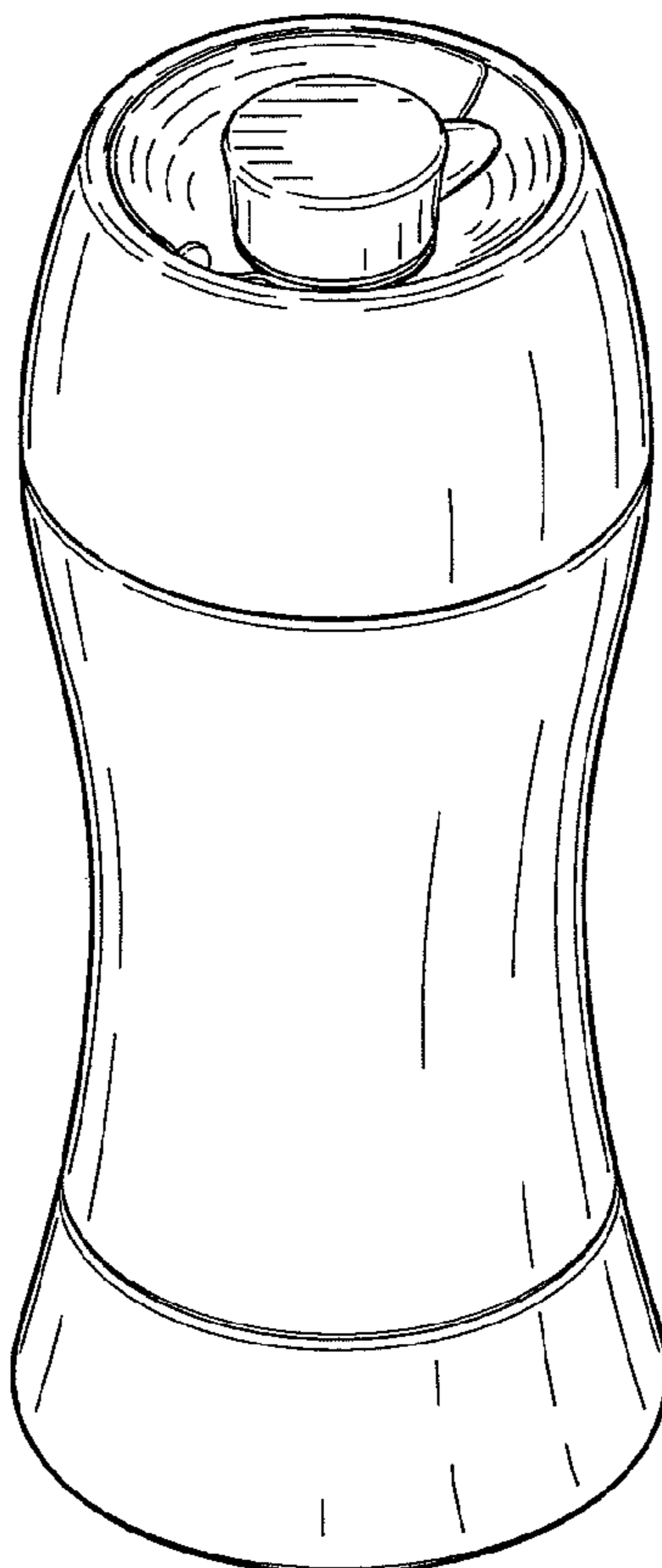
FIG. 3 is a top view of the spice dispenser;

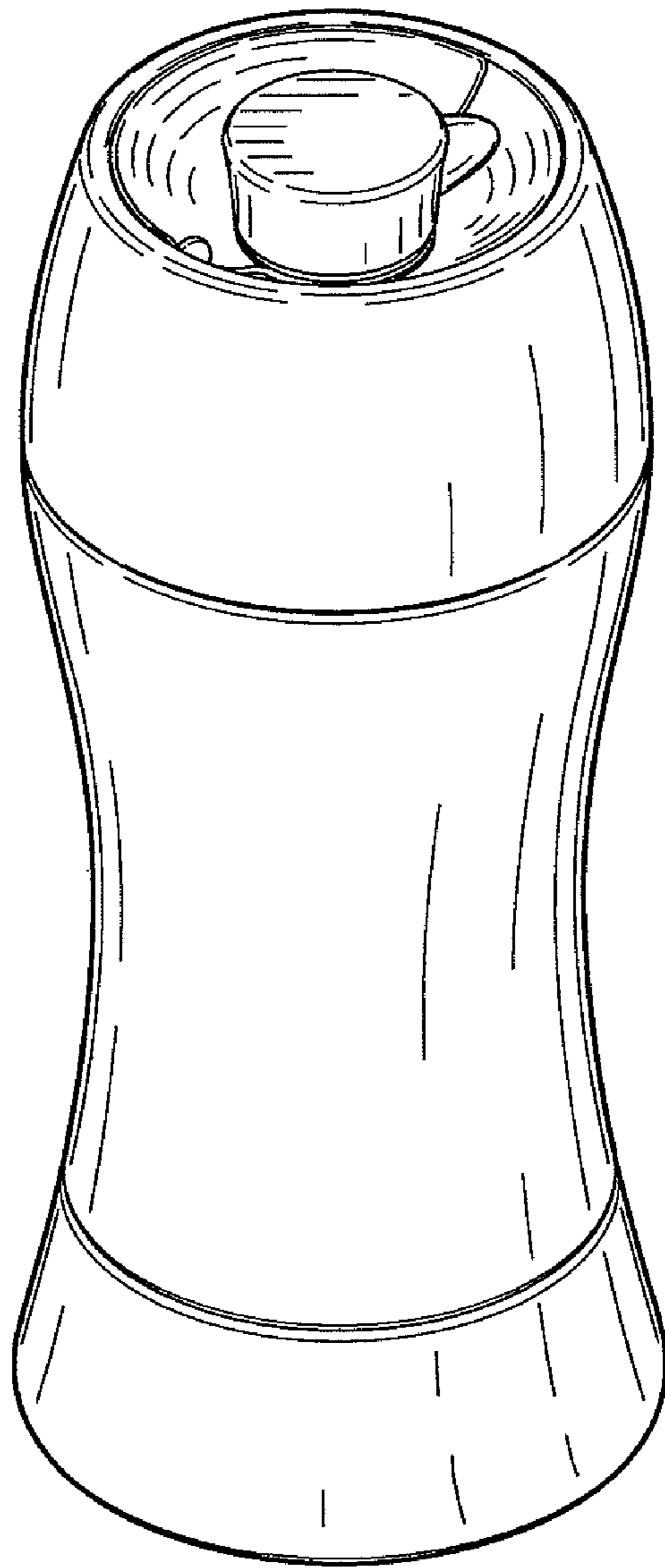

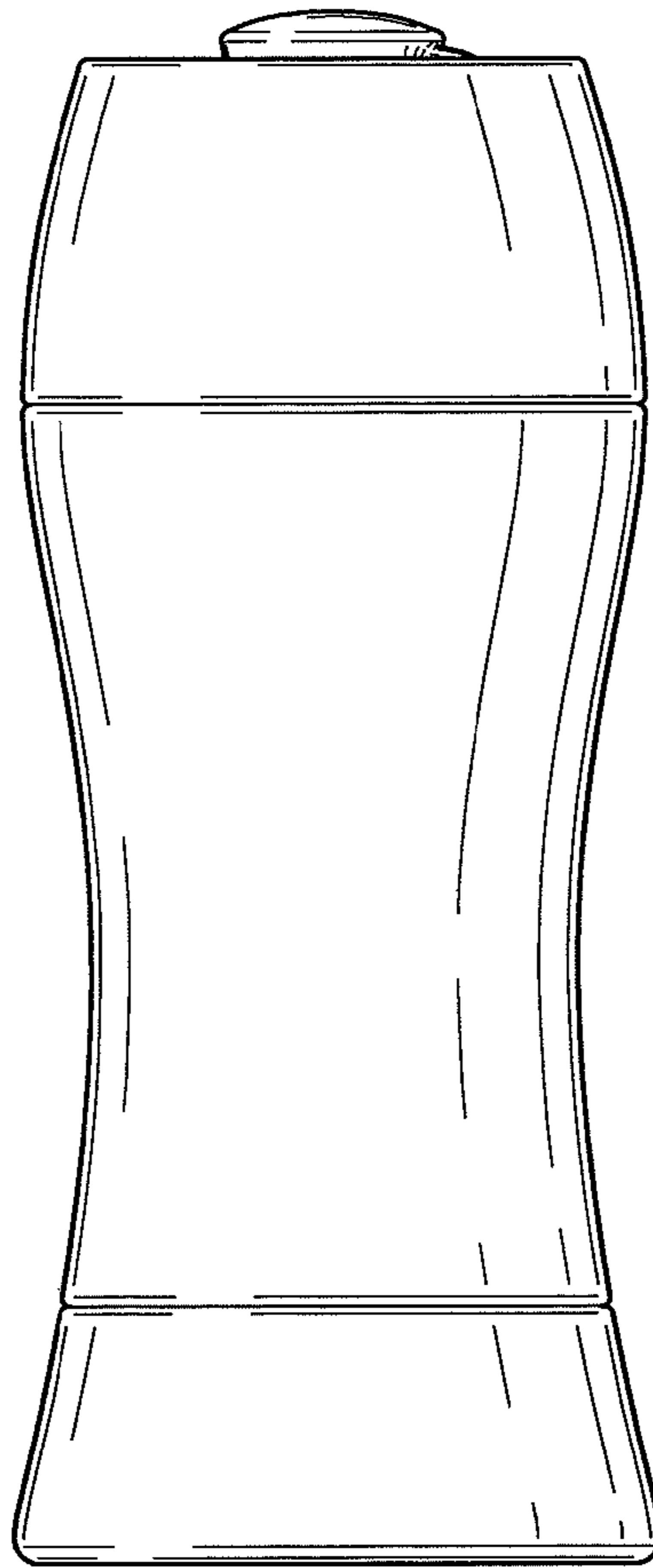

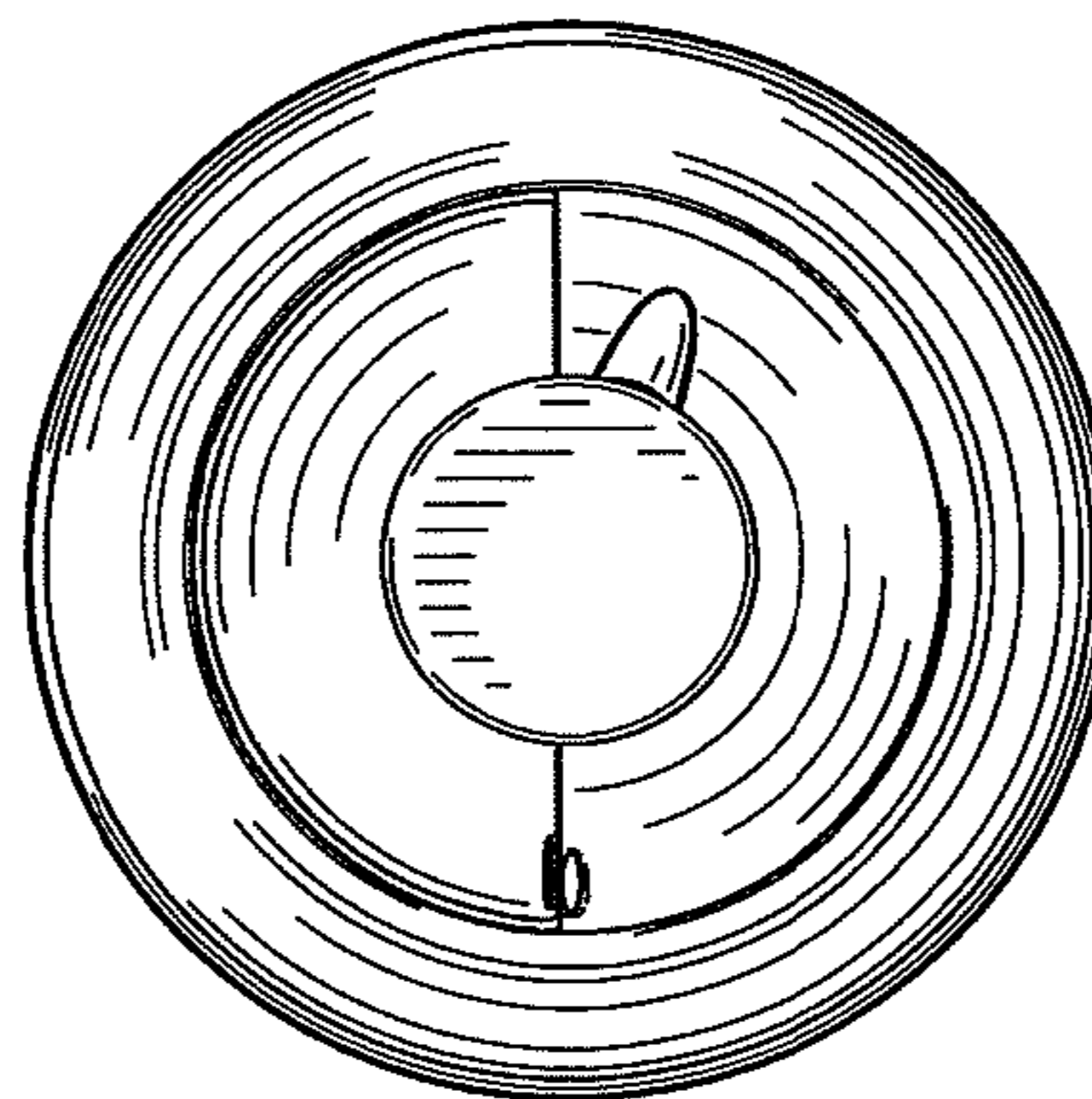

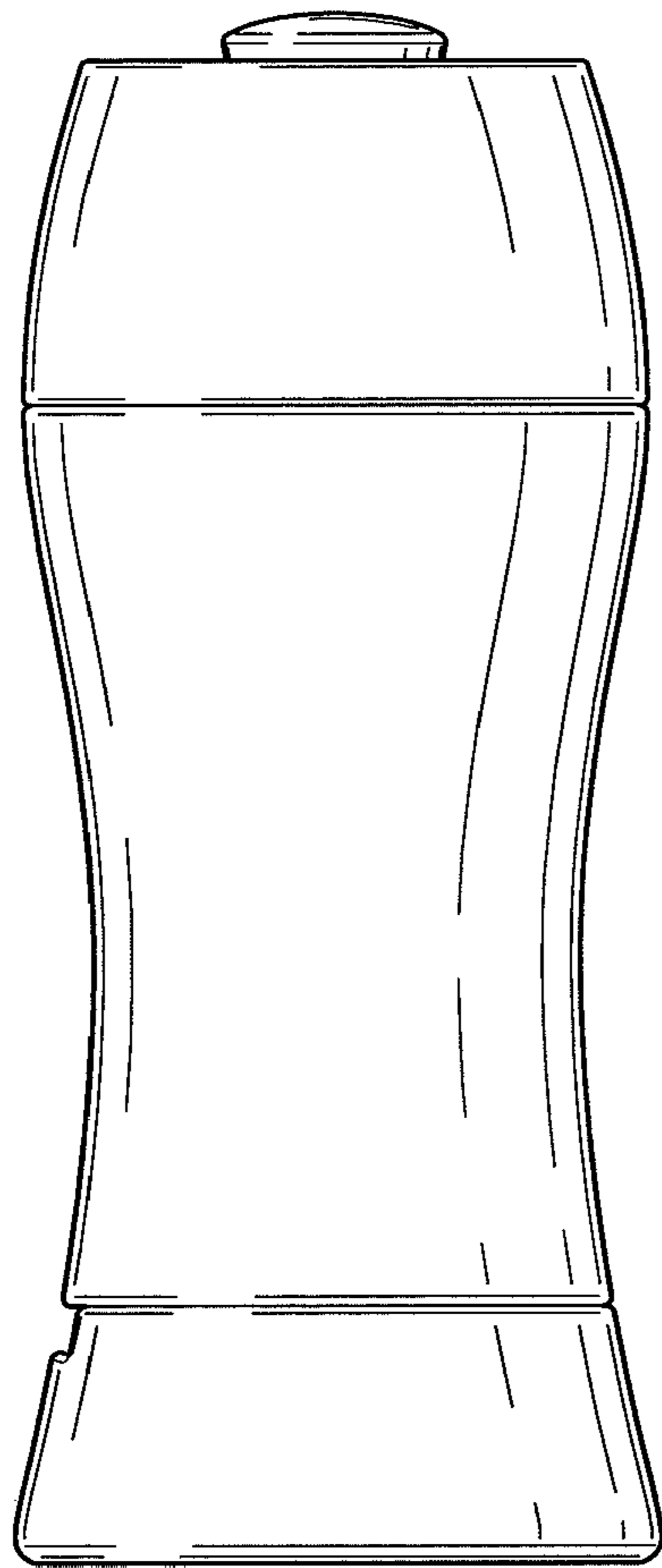

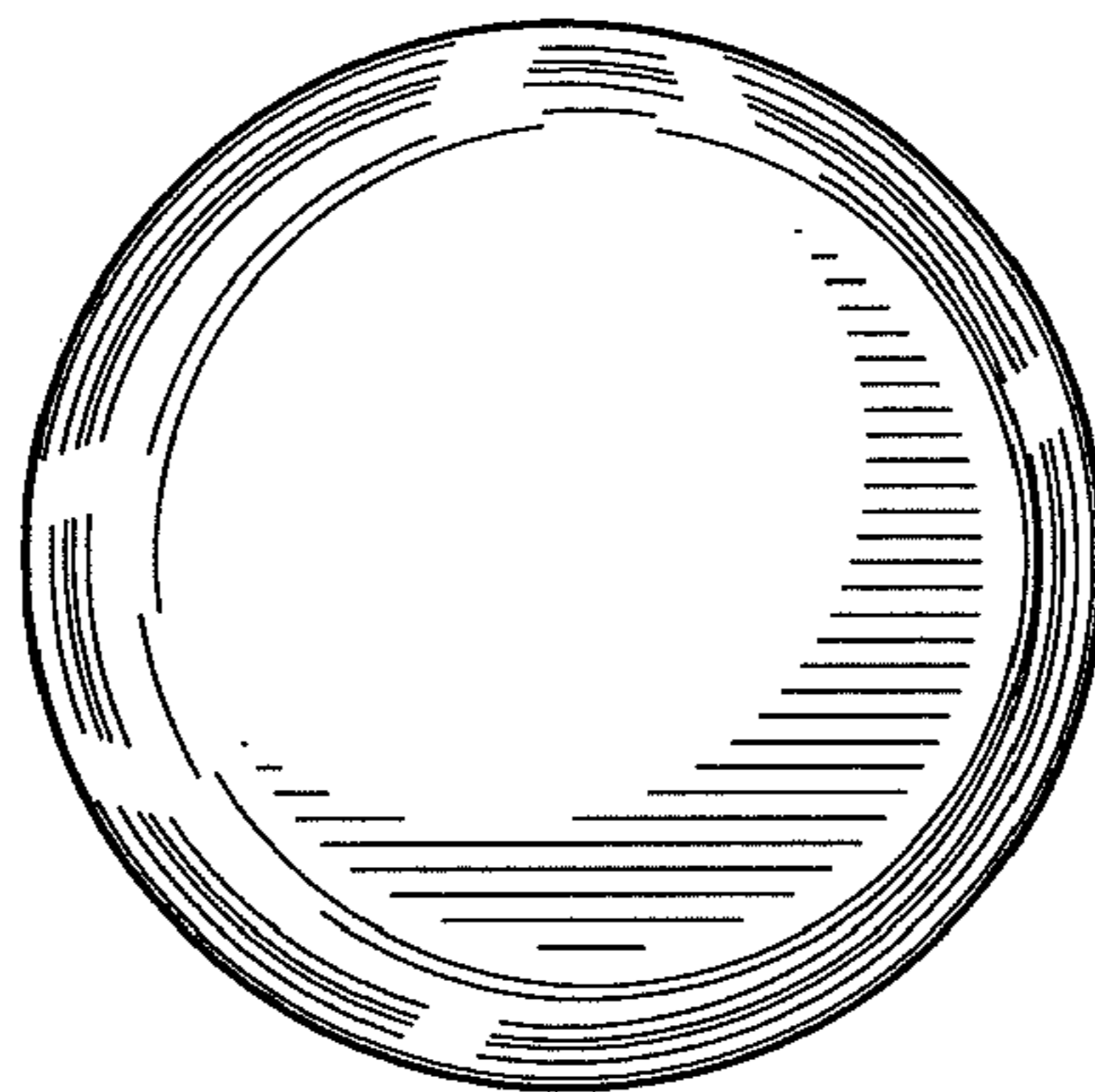
