FIG. 1 is a front, perspective view of a bottle showing my new design;

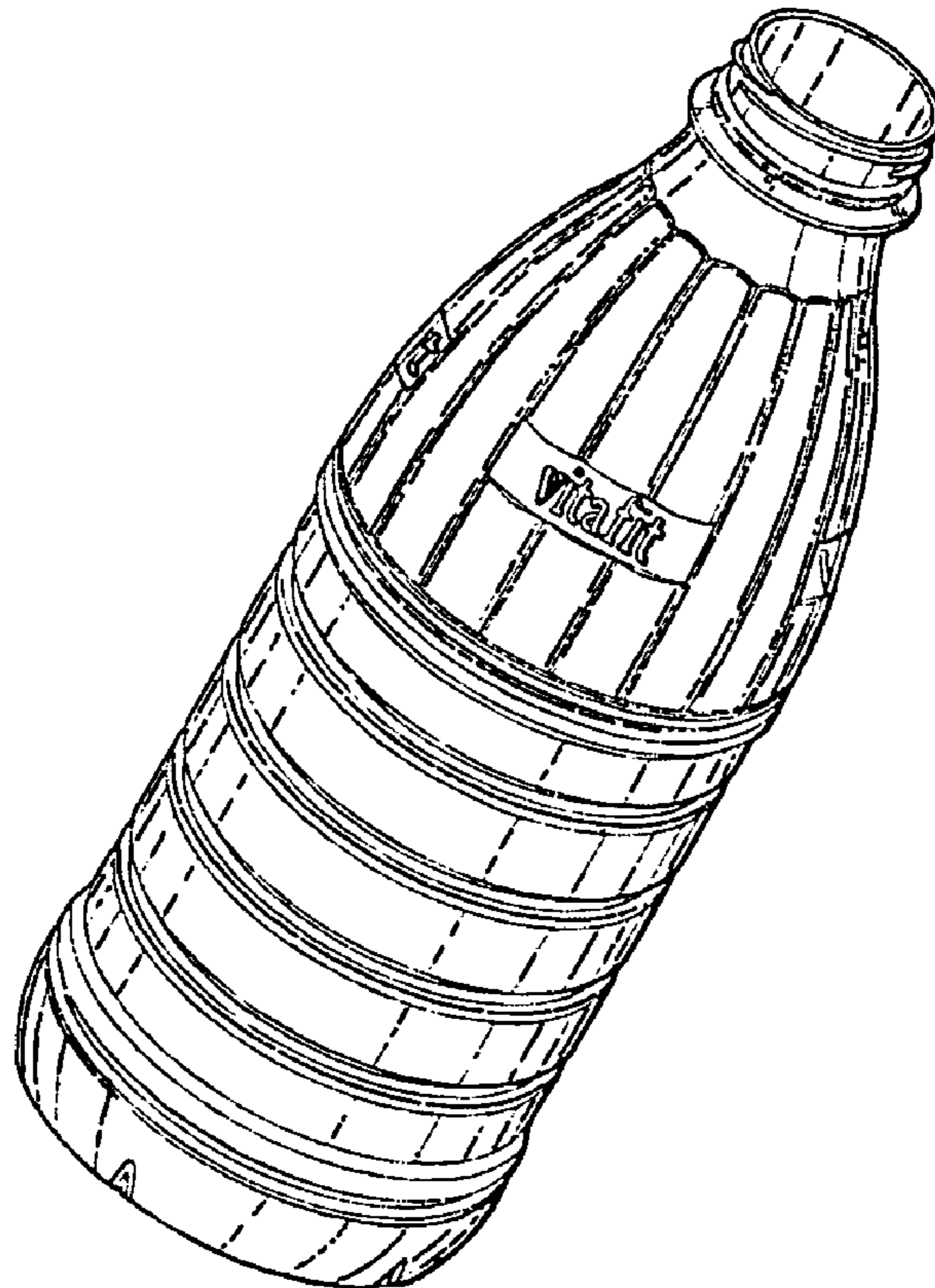
FIG. 2 is a front elevation view thereof;

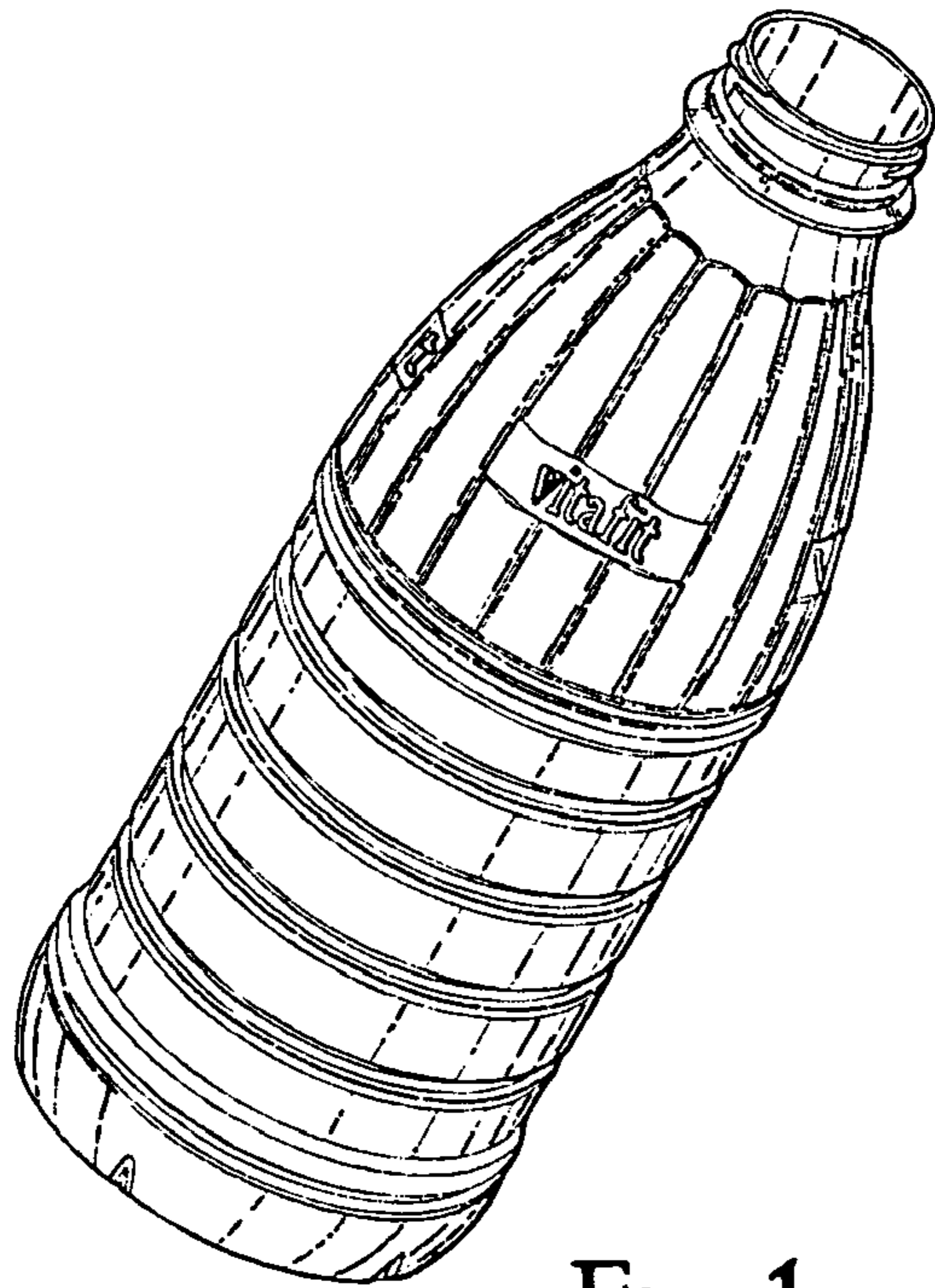

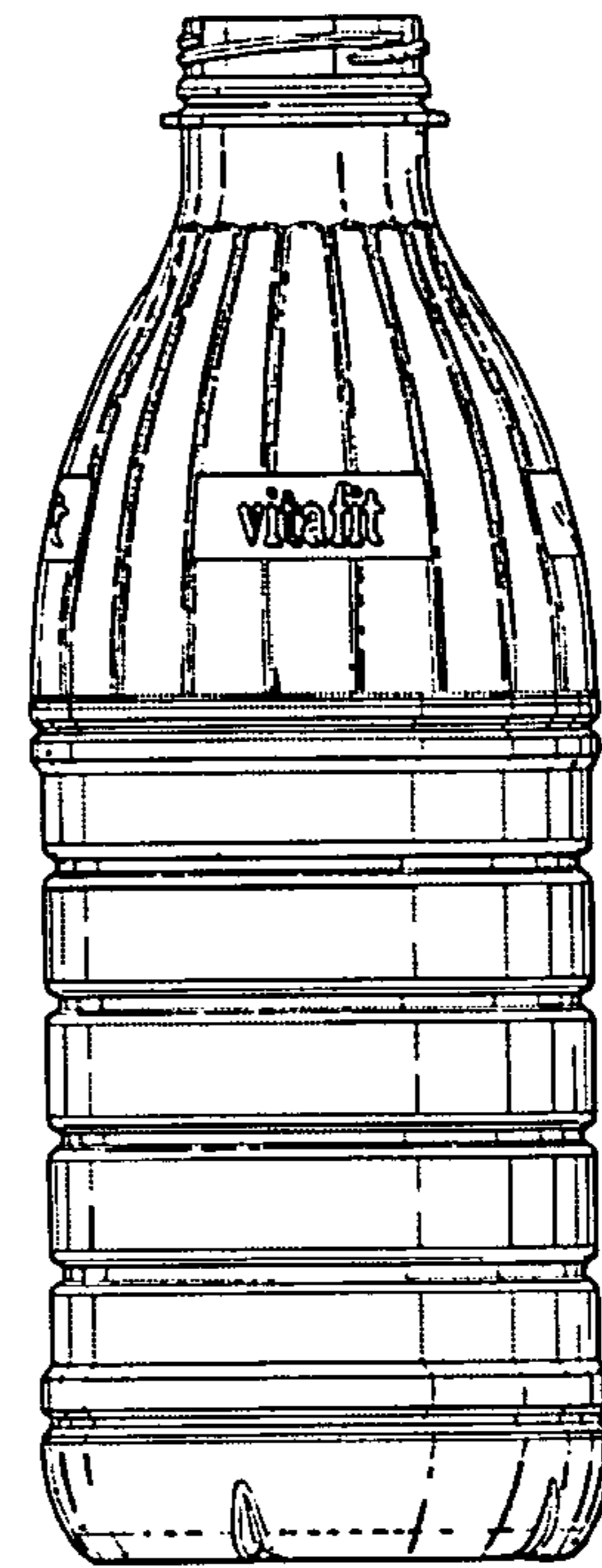

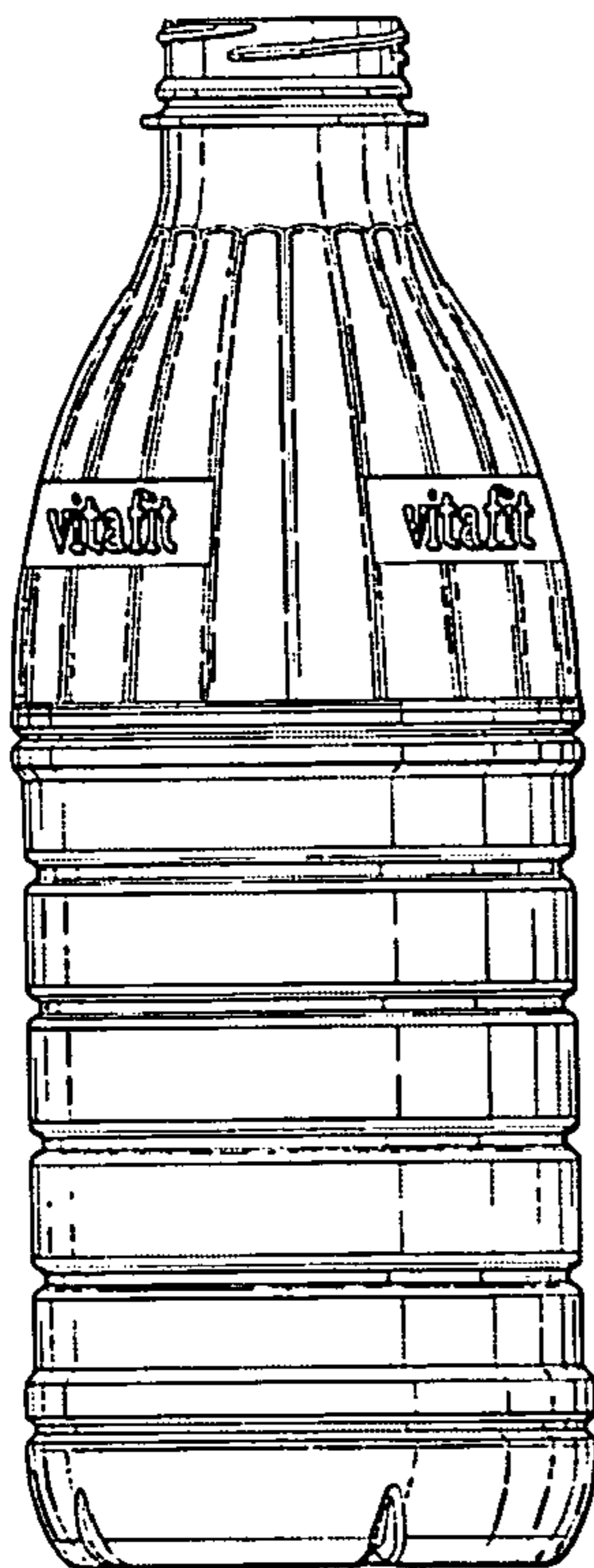

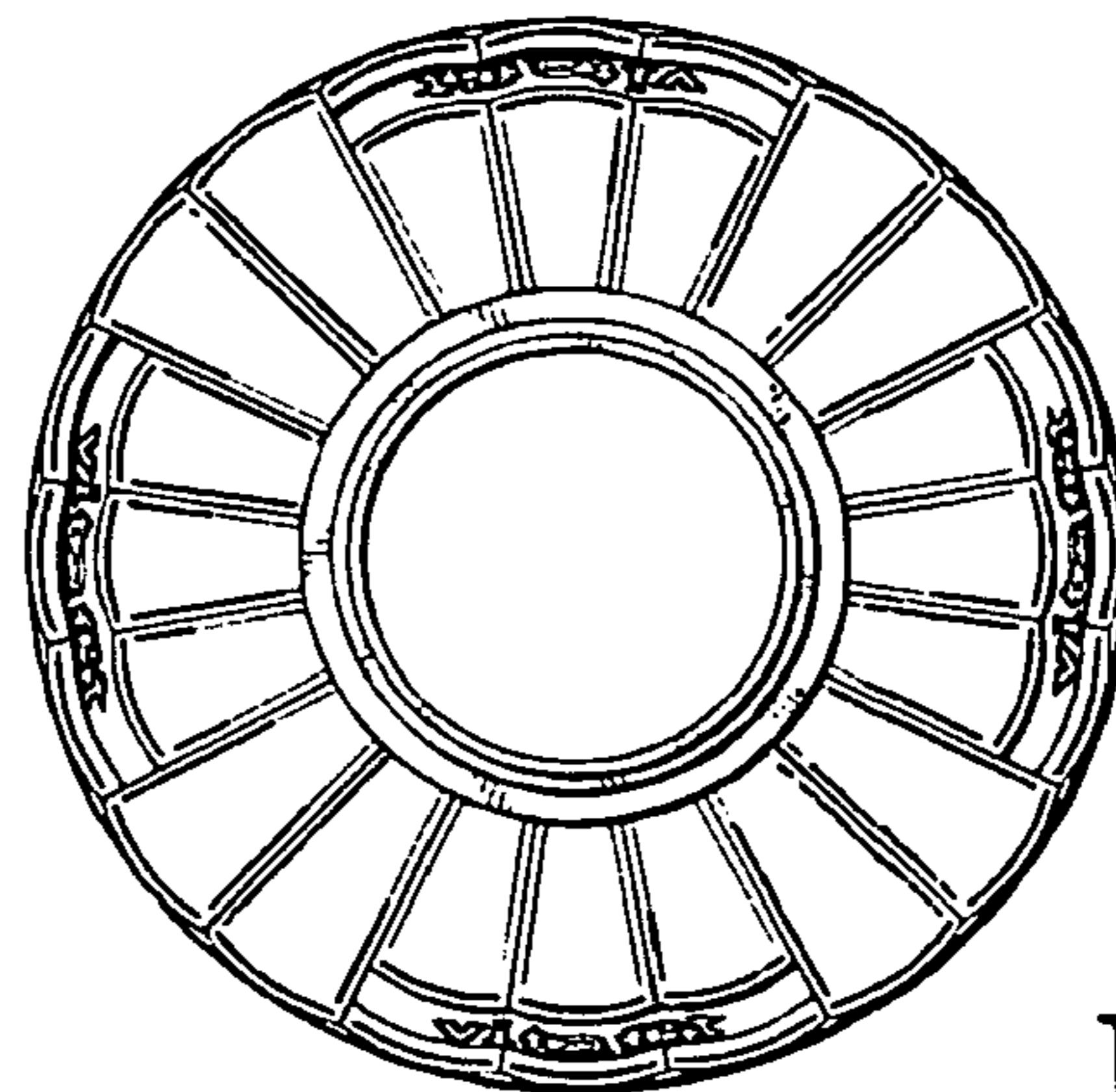

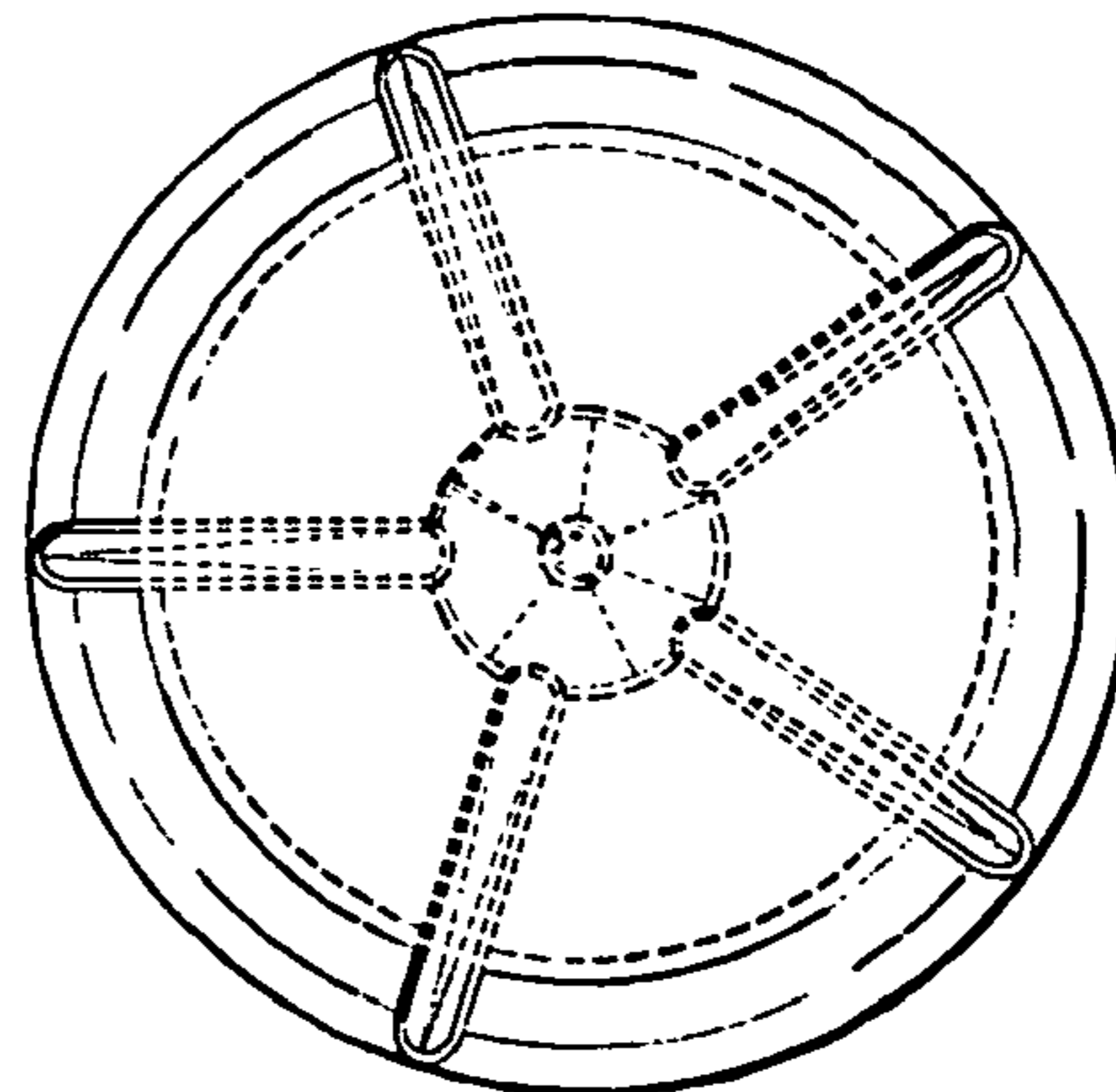
