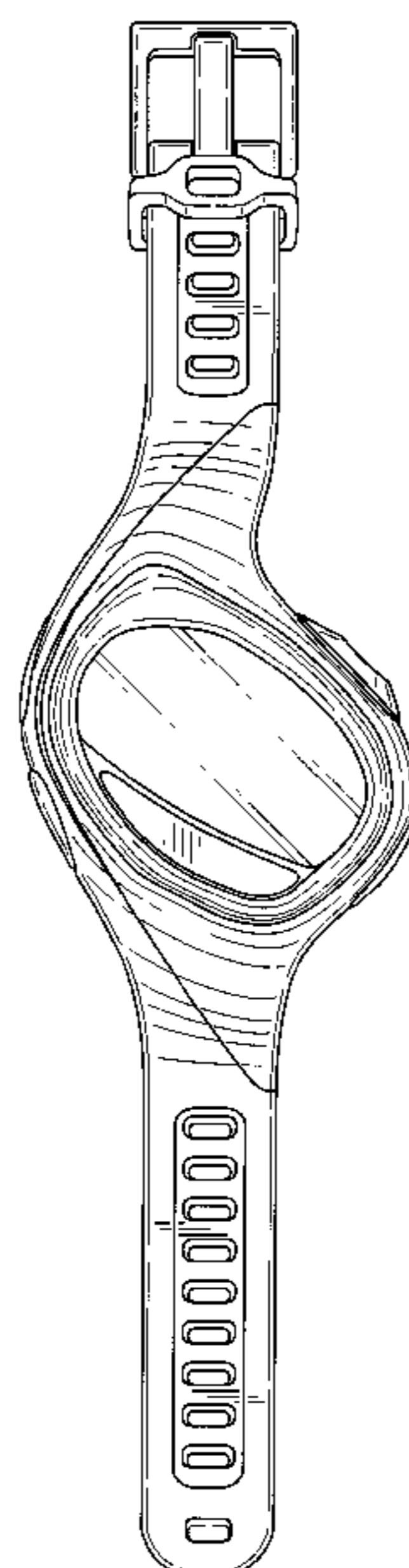
(57) **CLAIM**

The ornamental design for a watch case with a strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the top, front and right side of a watch case with a strap showing my new design;  
FIG. 2 is a front view thereof;

FIG. 4 is a left side view thereof;

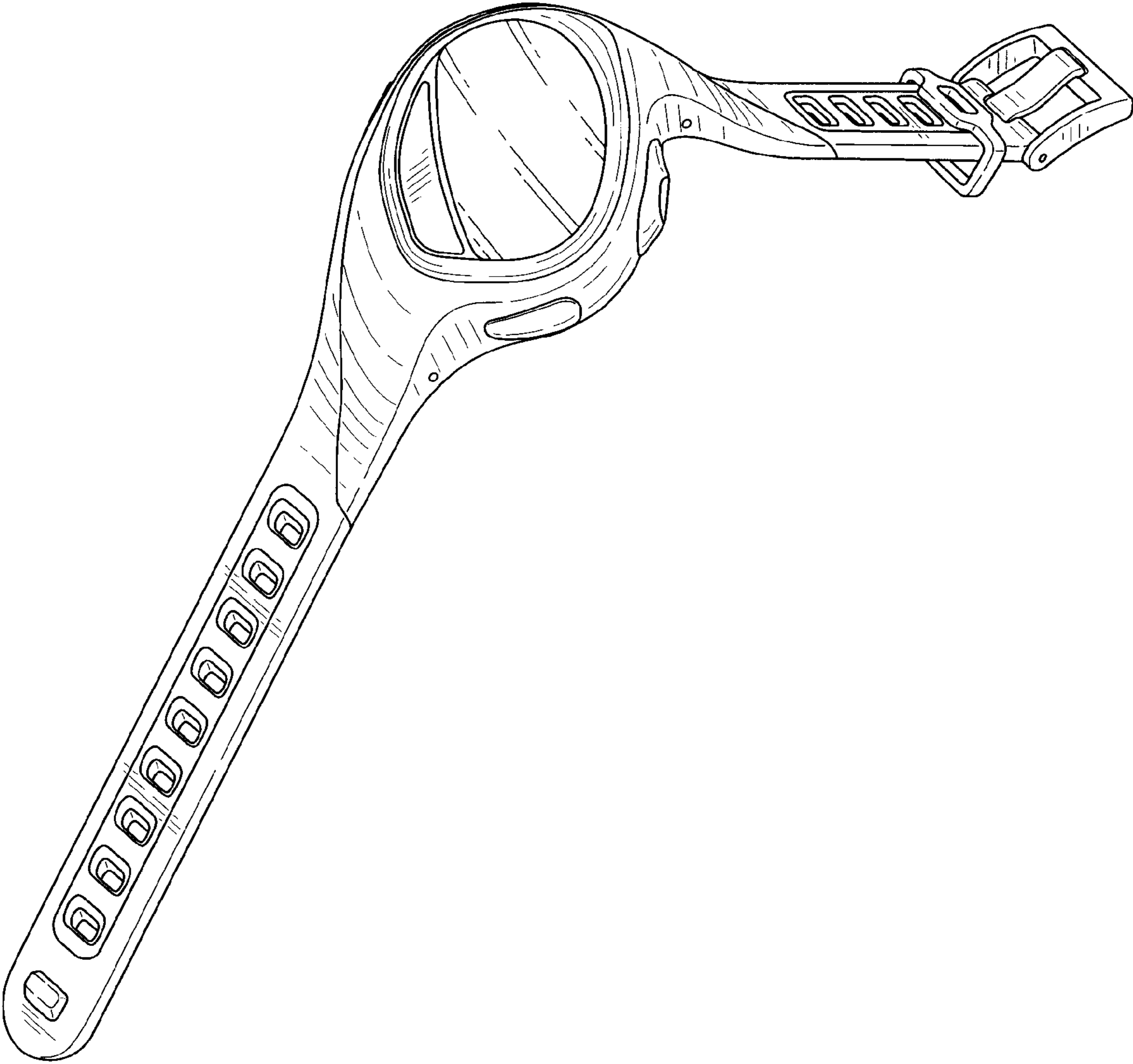

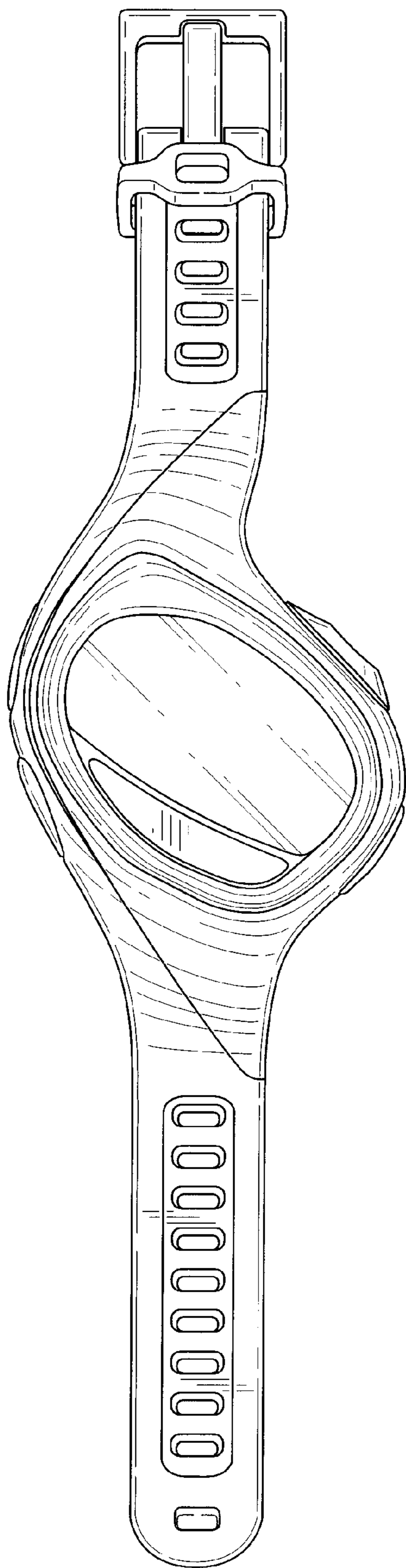

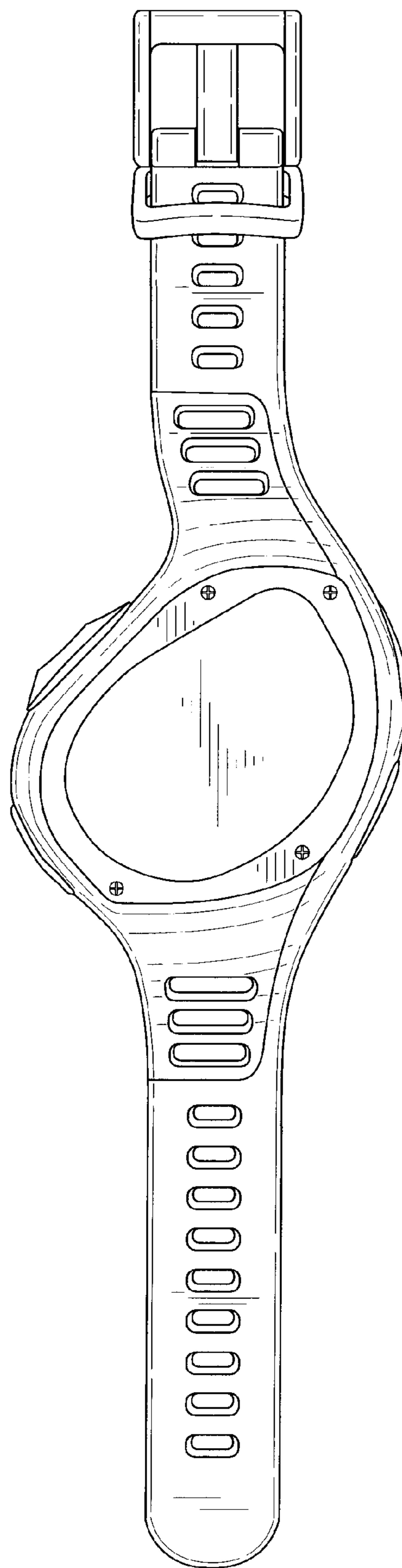

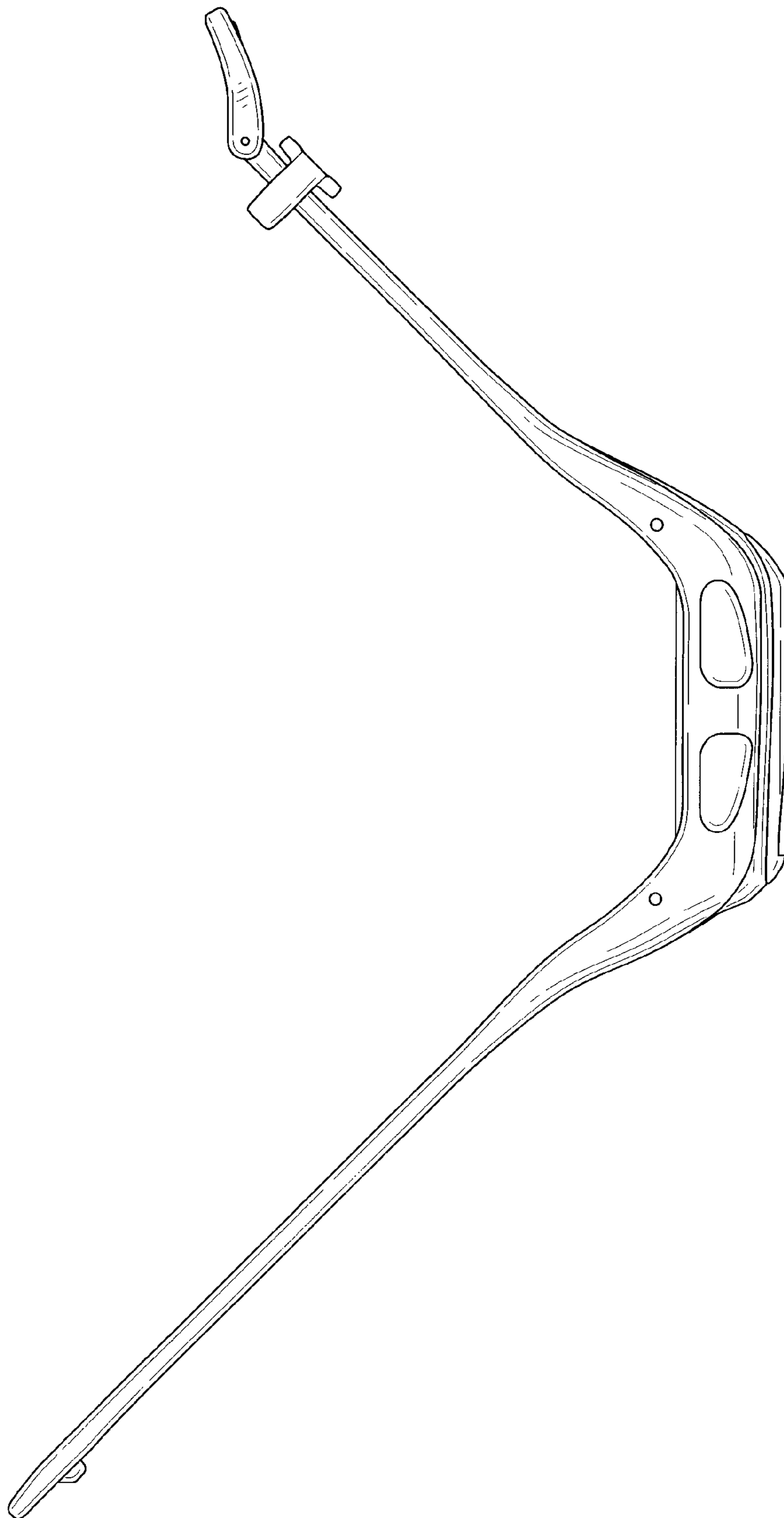
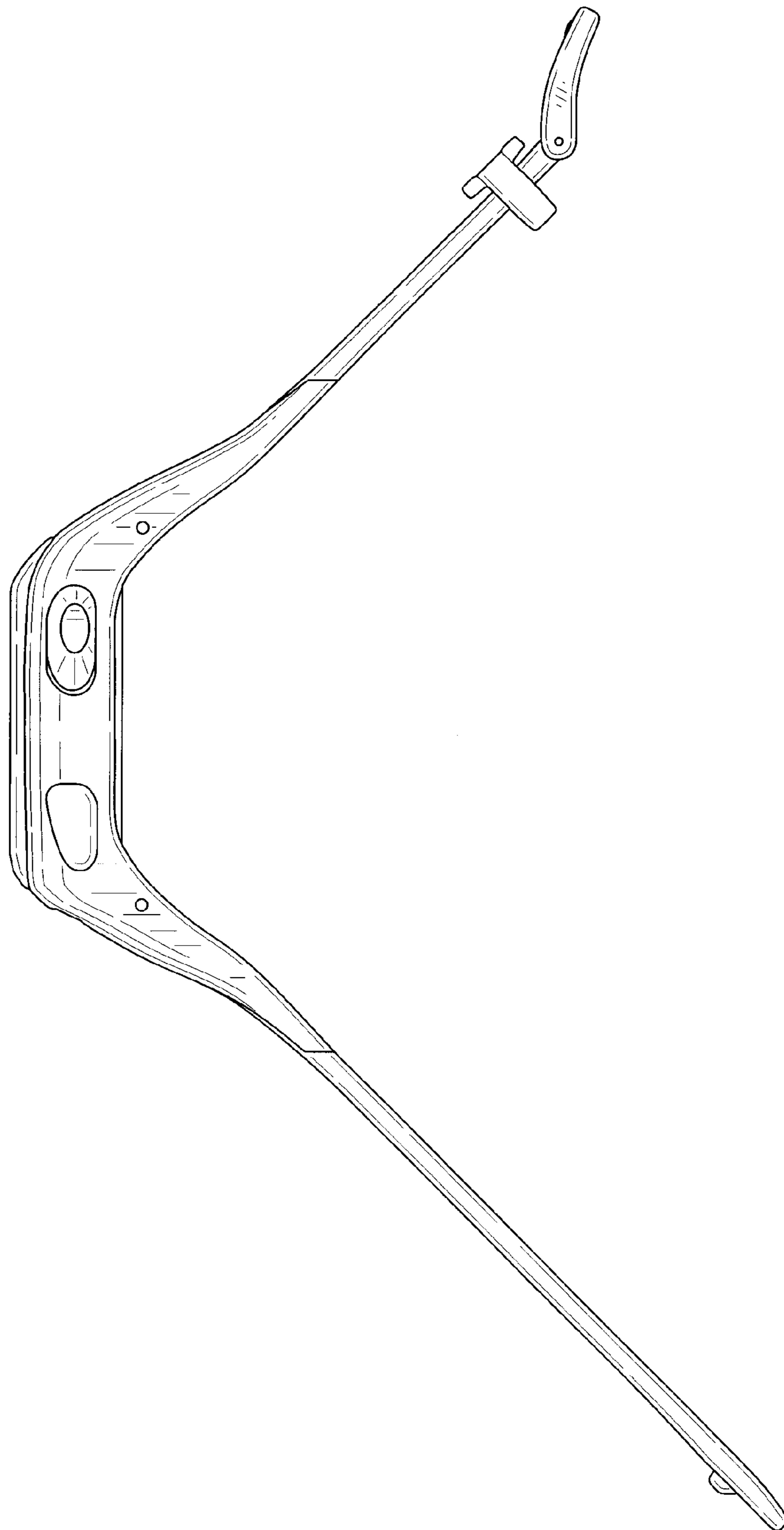
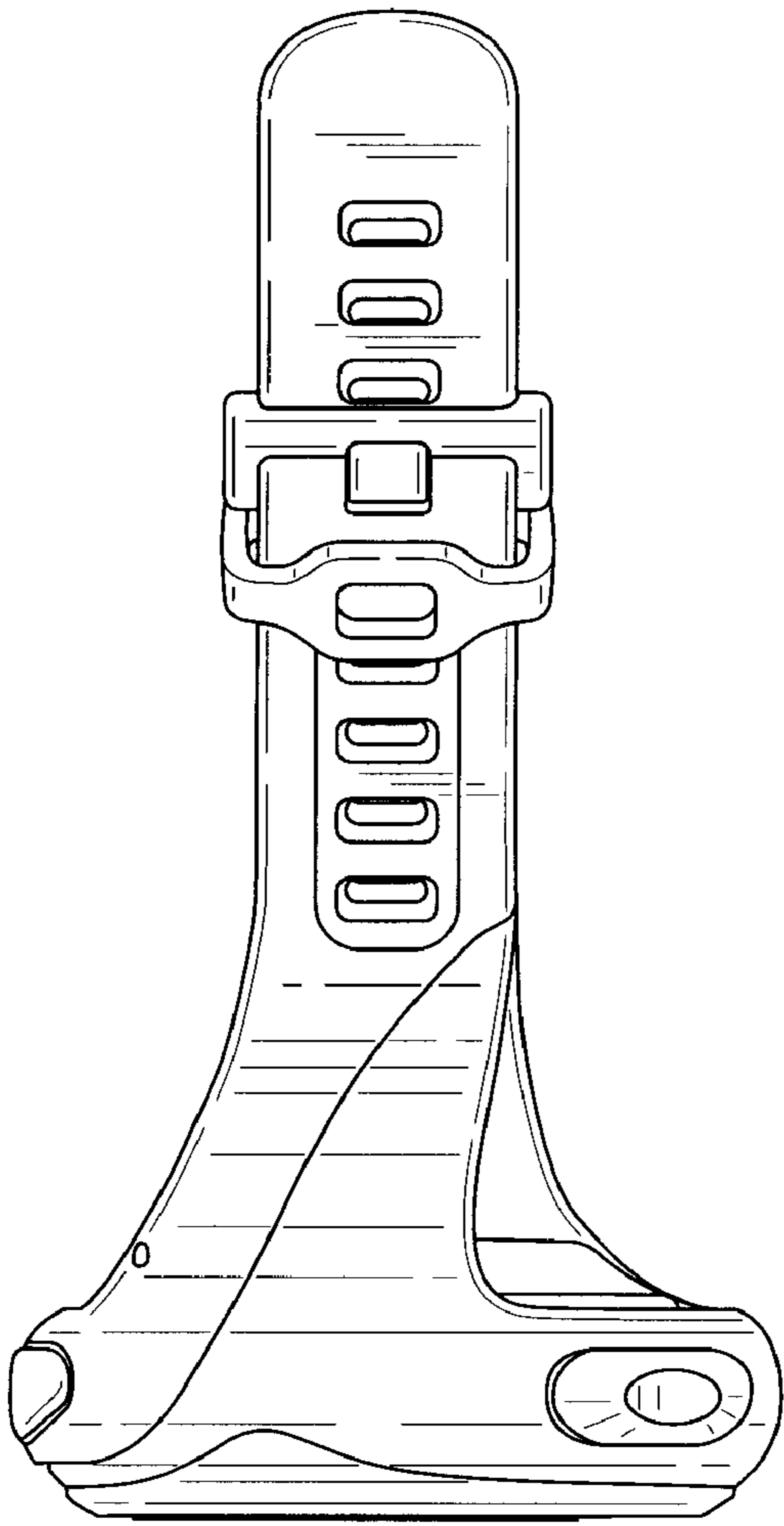


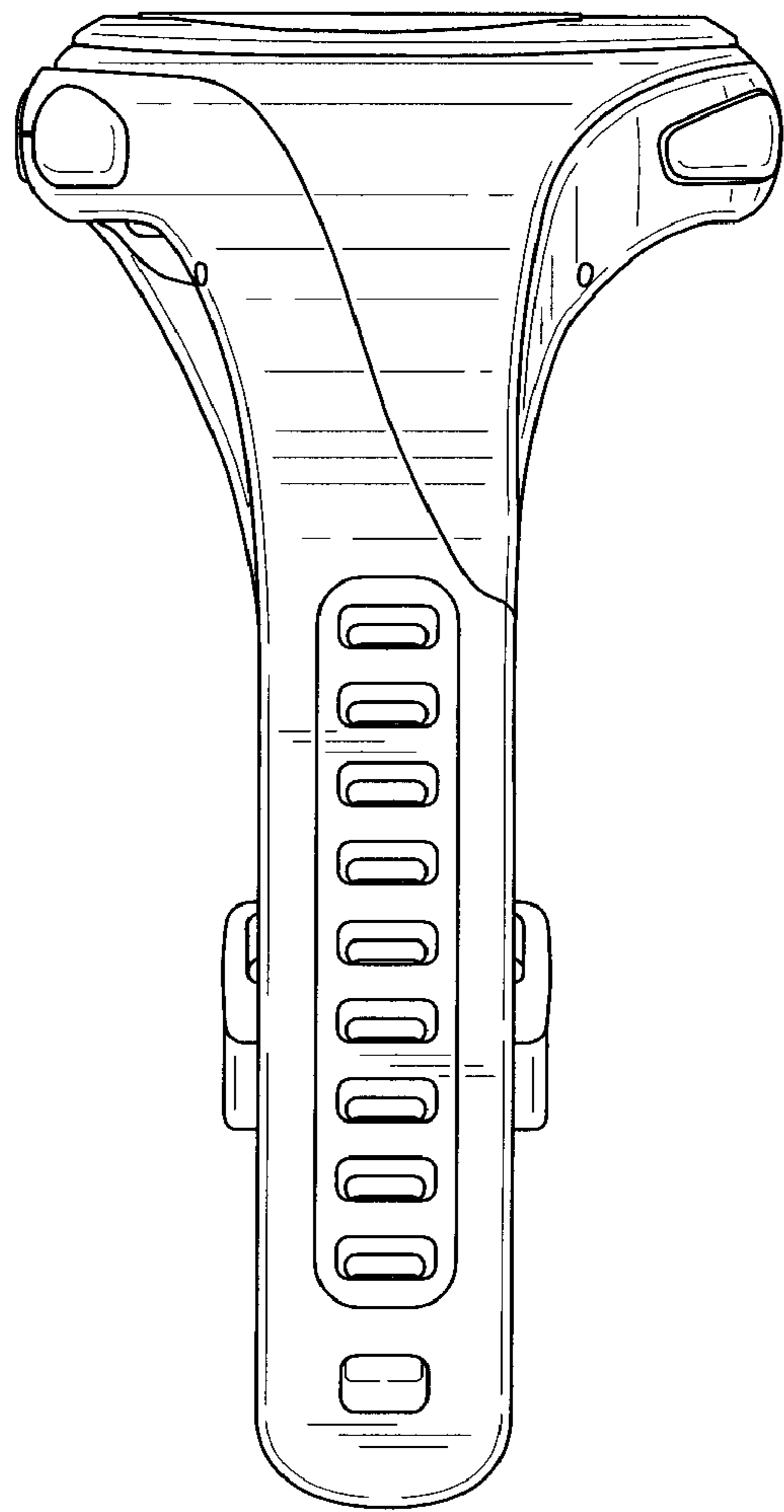
