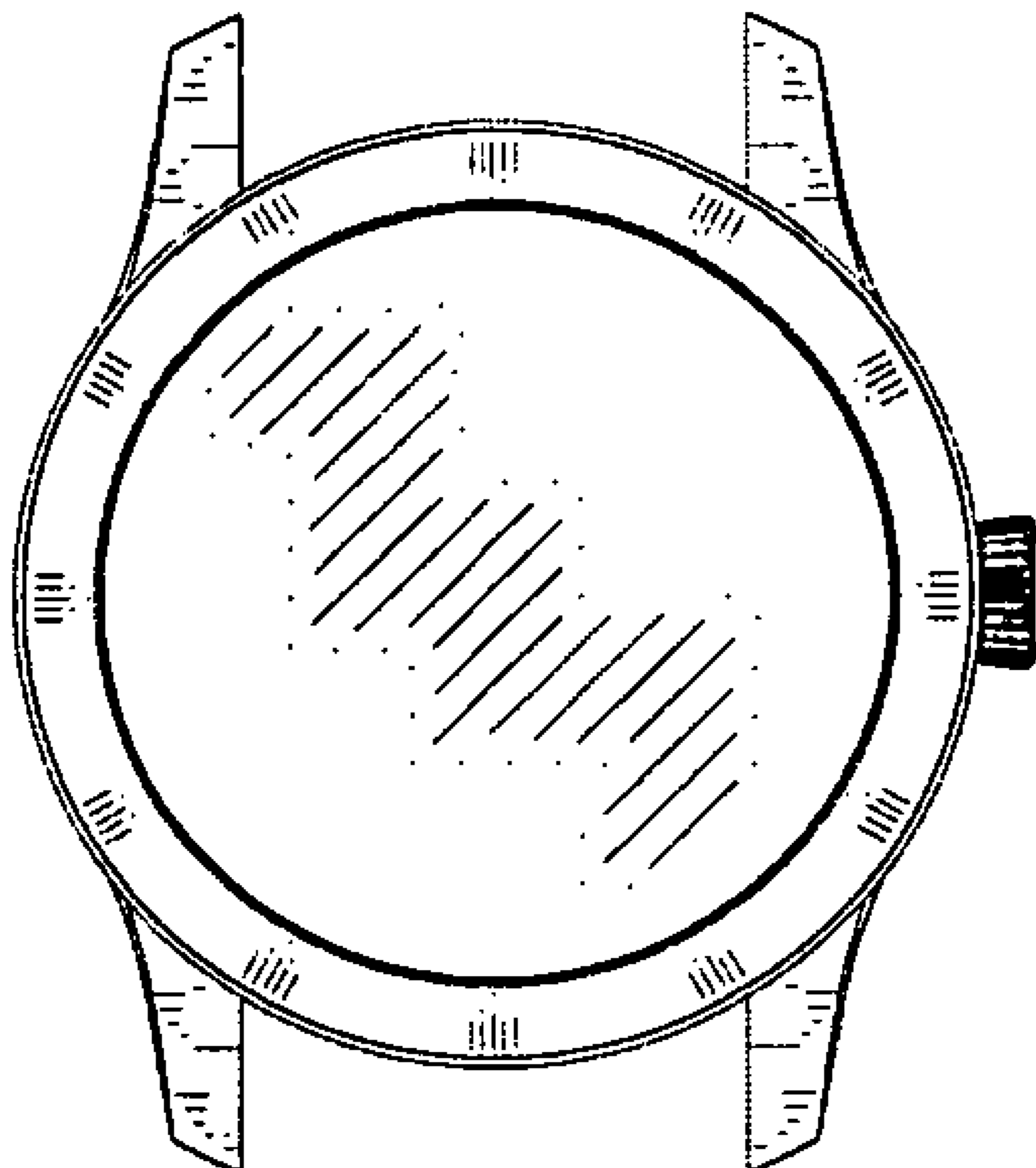
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top view of the watch case.  
FIG. 2 is a bottom view of the watch case.  
FIG. 3 is a side view from the right of FIG. 1.  
FIG. 4 is a side view from the left of FIG. 1.  
FIG. 5 is a side view from the bottom of FIG. 1.  
FIG. 6 is a side view from the top of FIG. 1; and,  
FIG. 7 is a perspective view of the watch case.

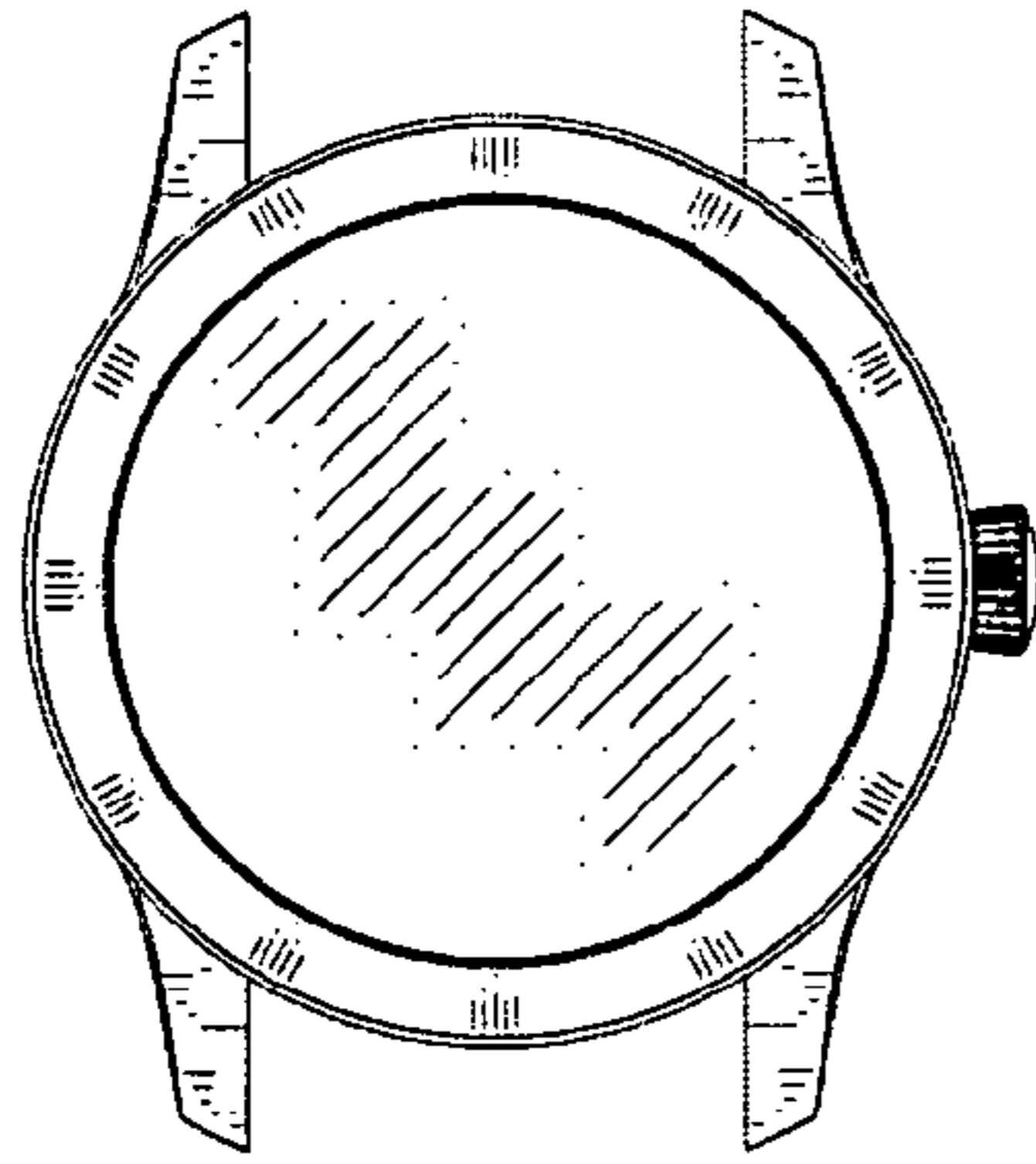

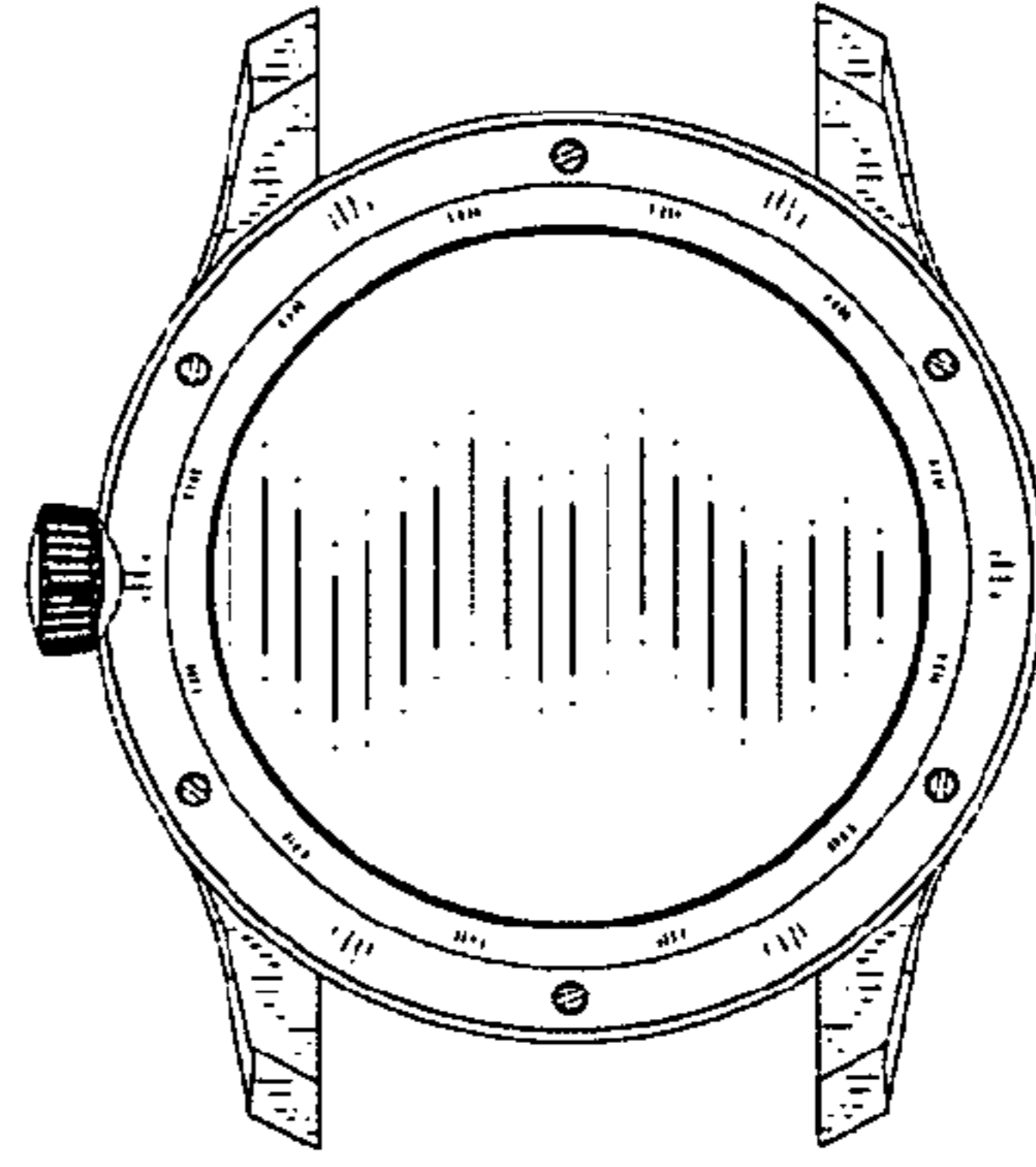

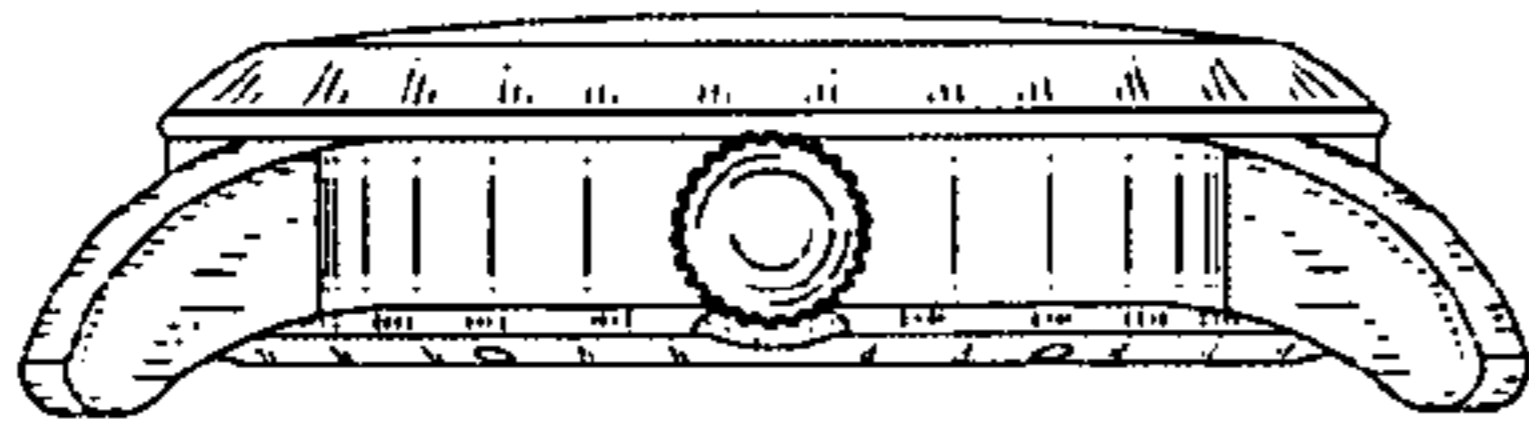

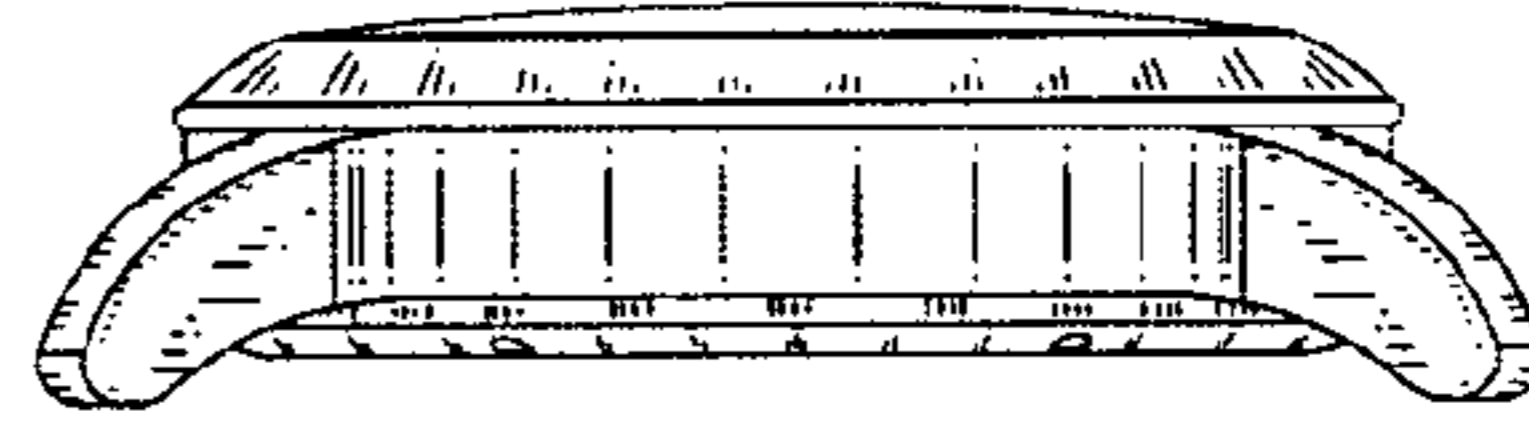

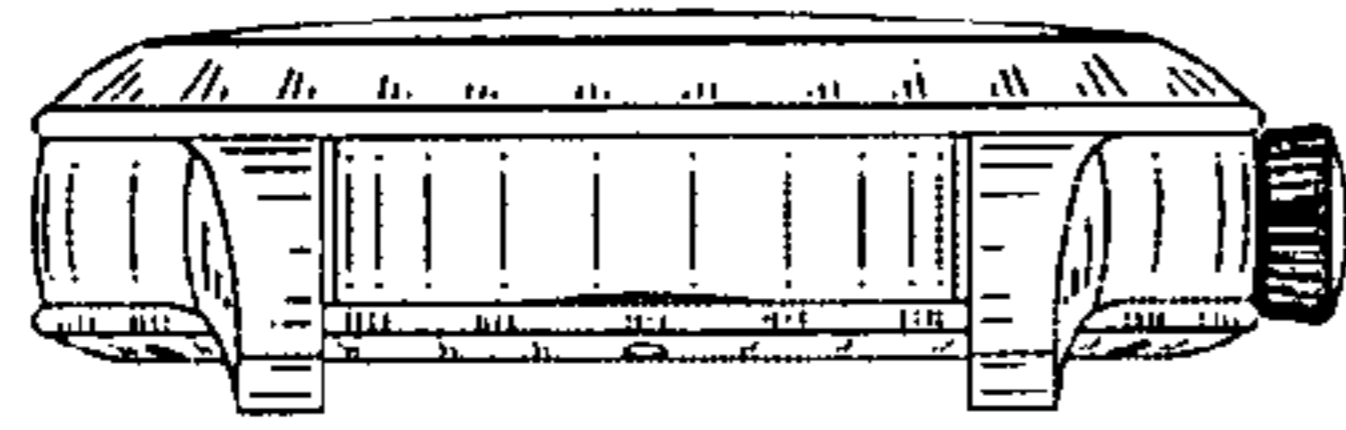

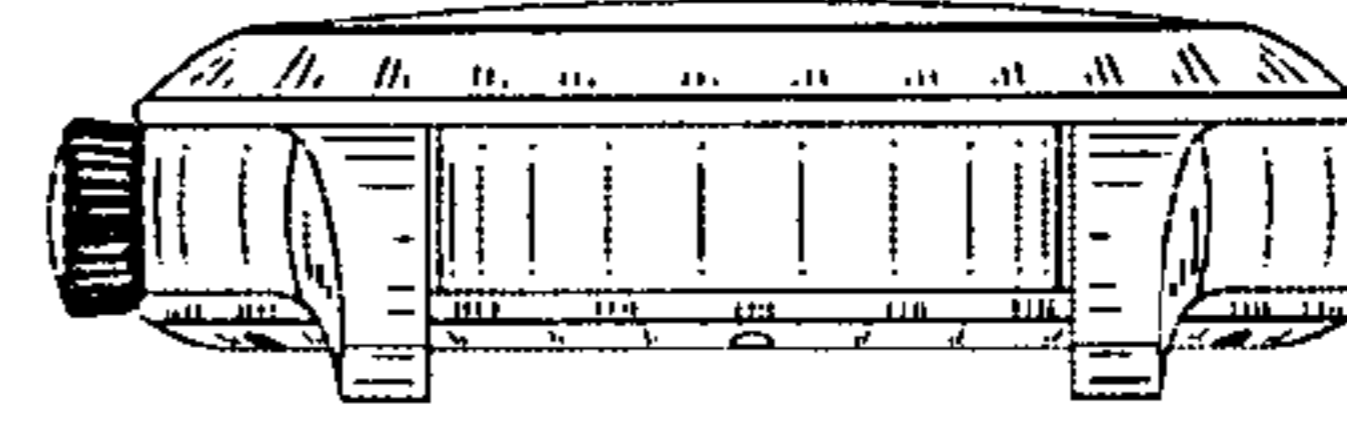

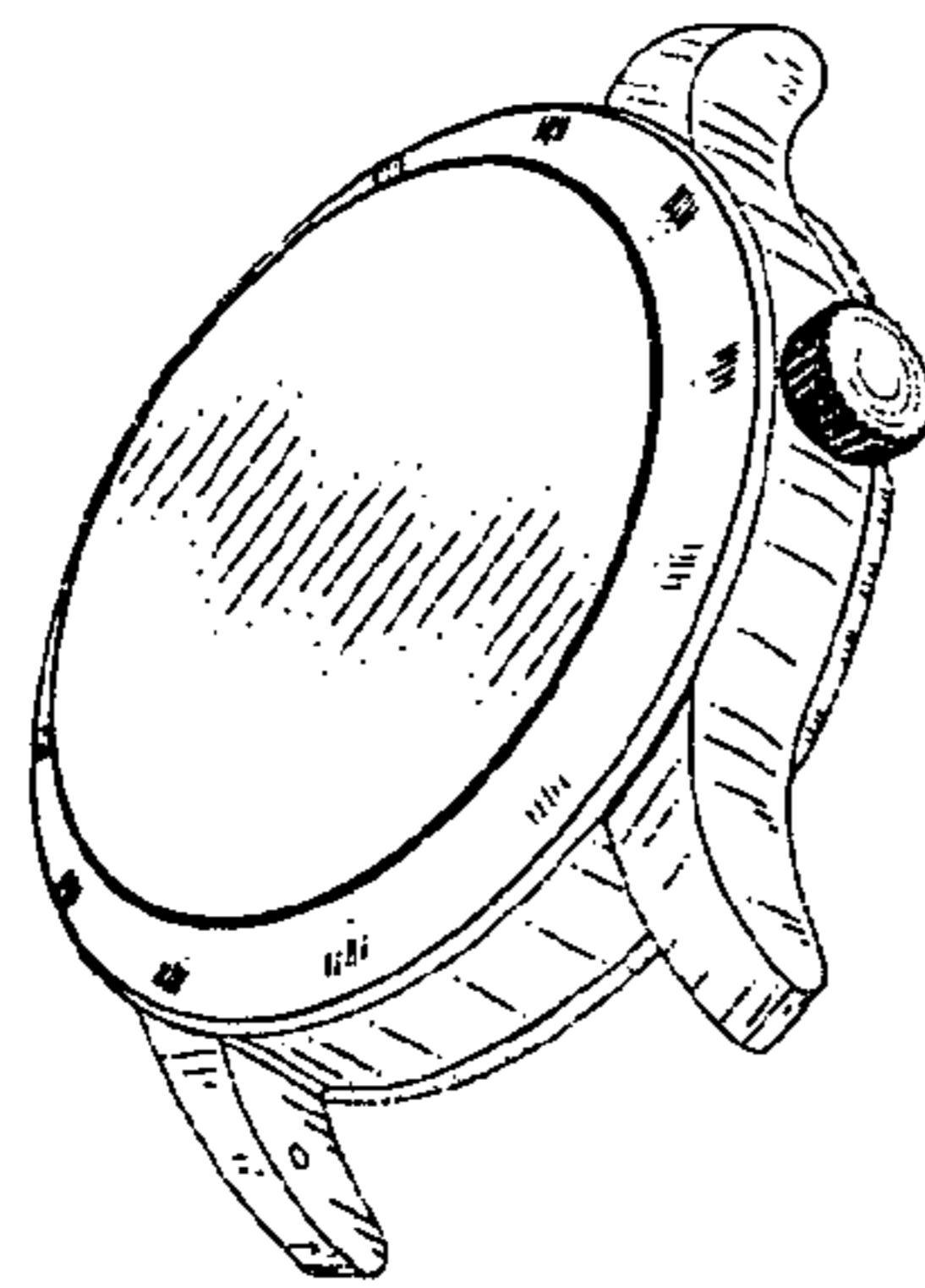
