FIG. 8 is a top plan view thereof.

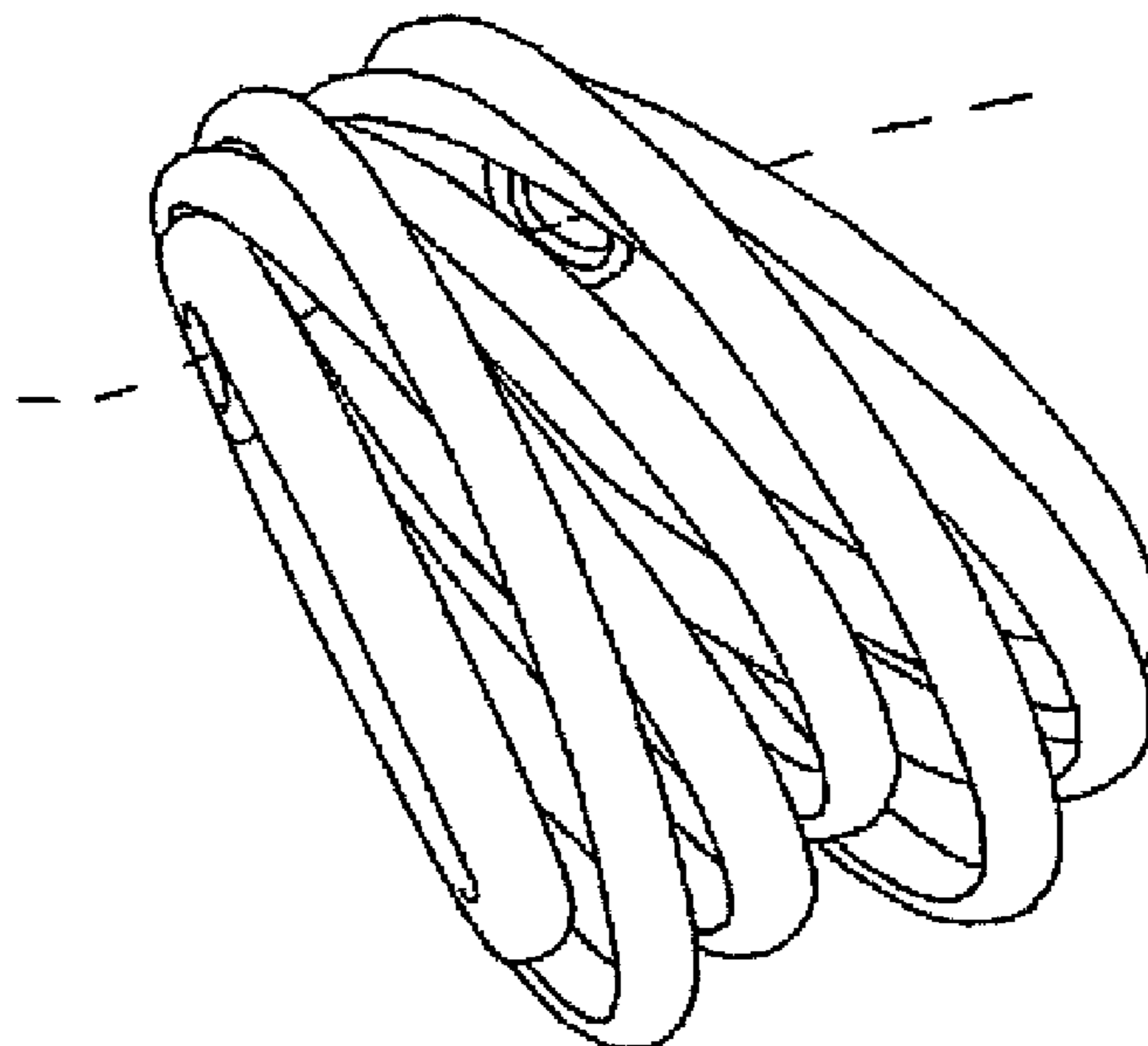
The broken lines depict environmental structure that forms no part of the claimed design.

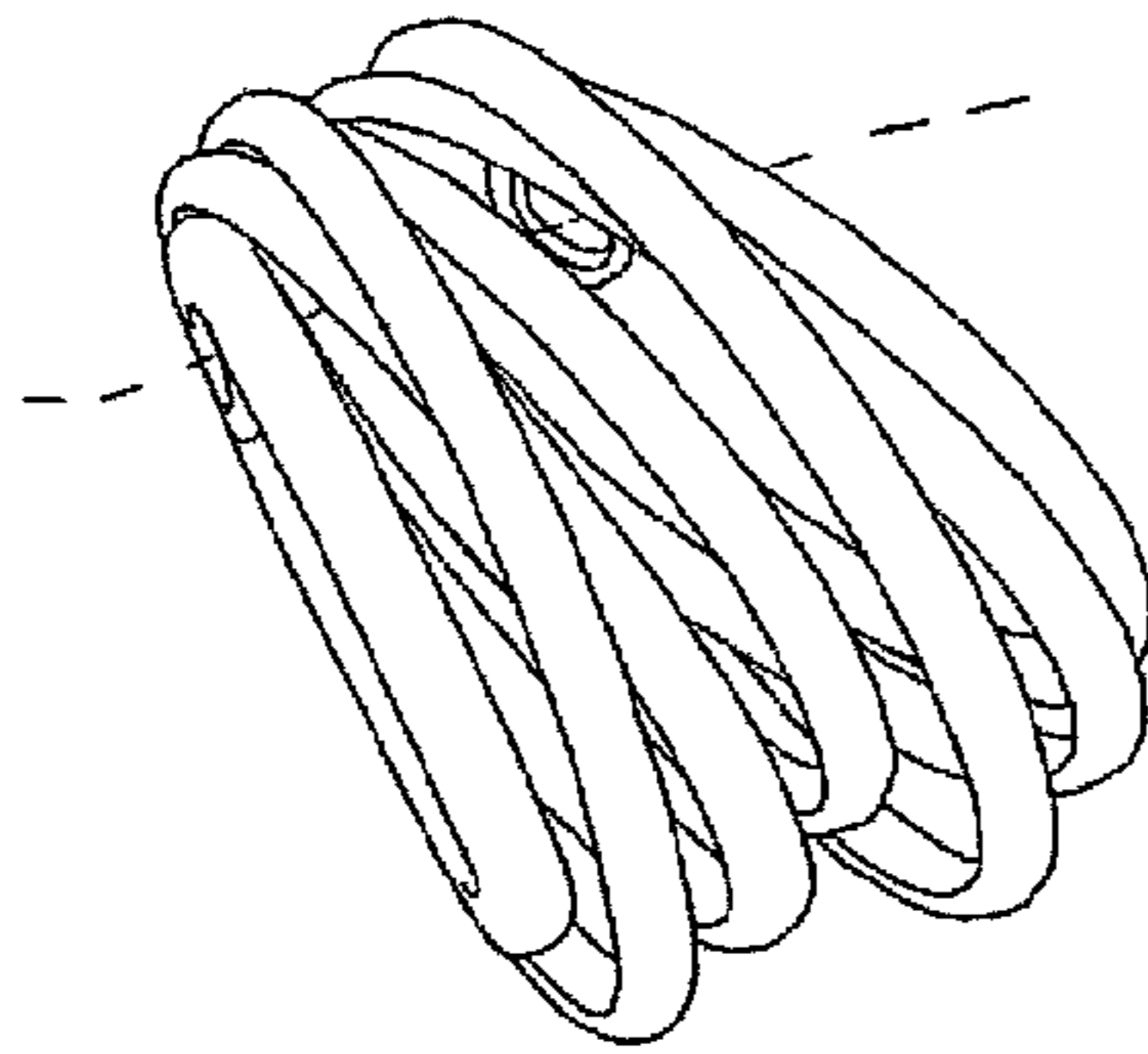

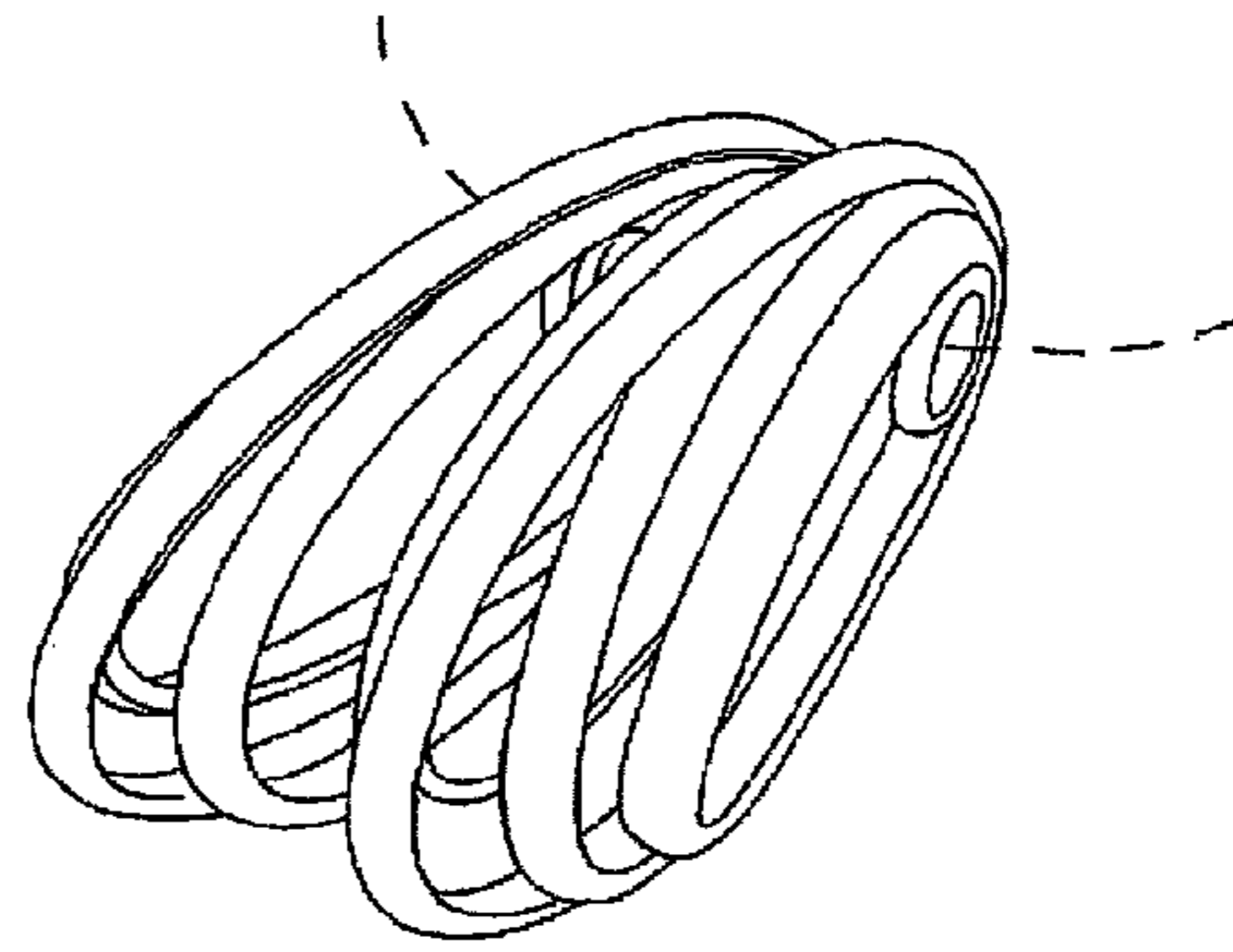

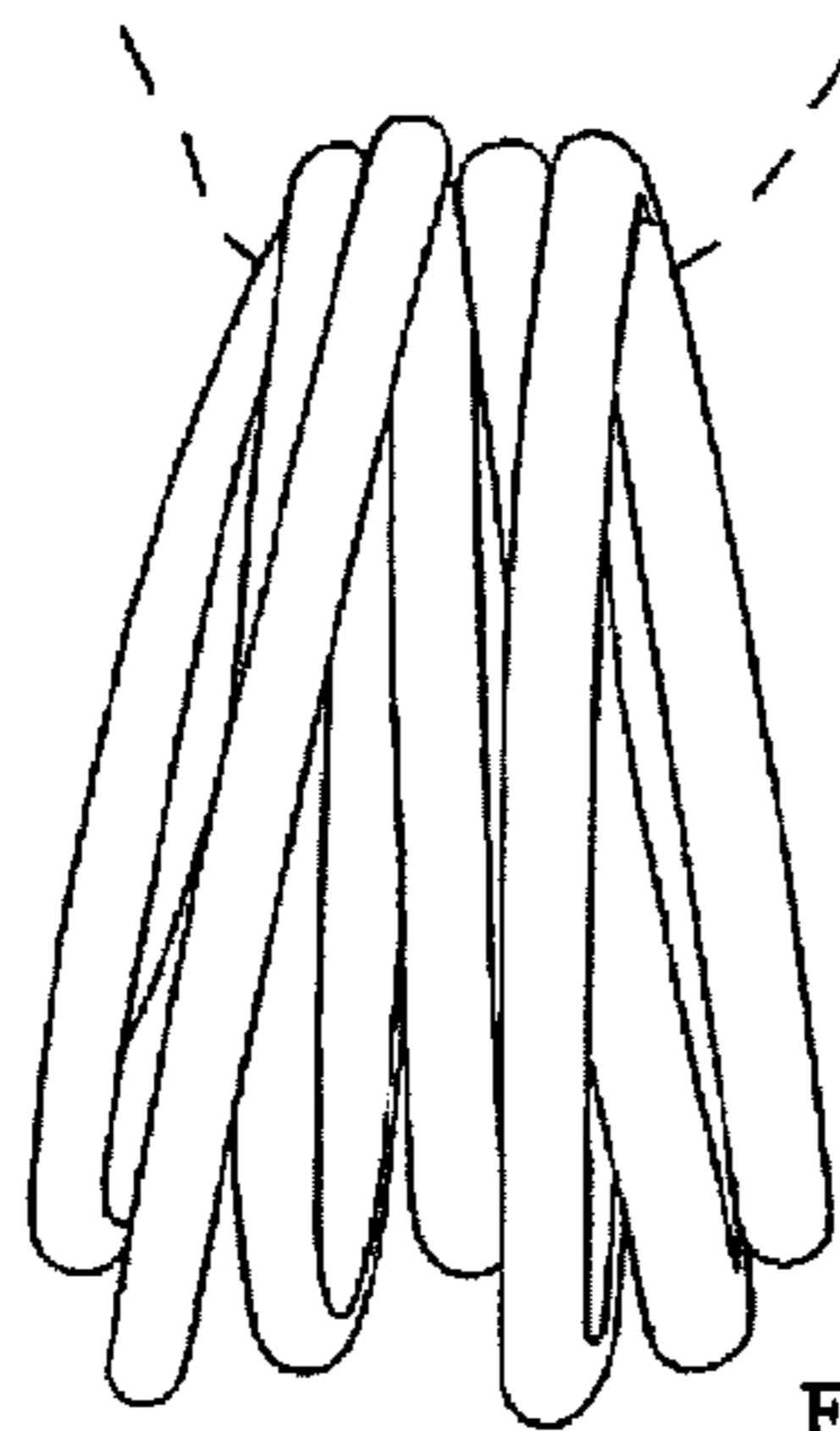

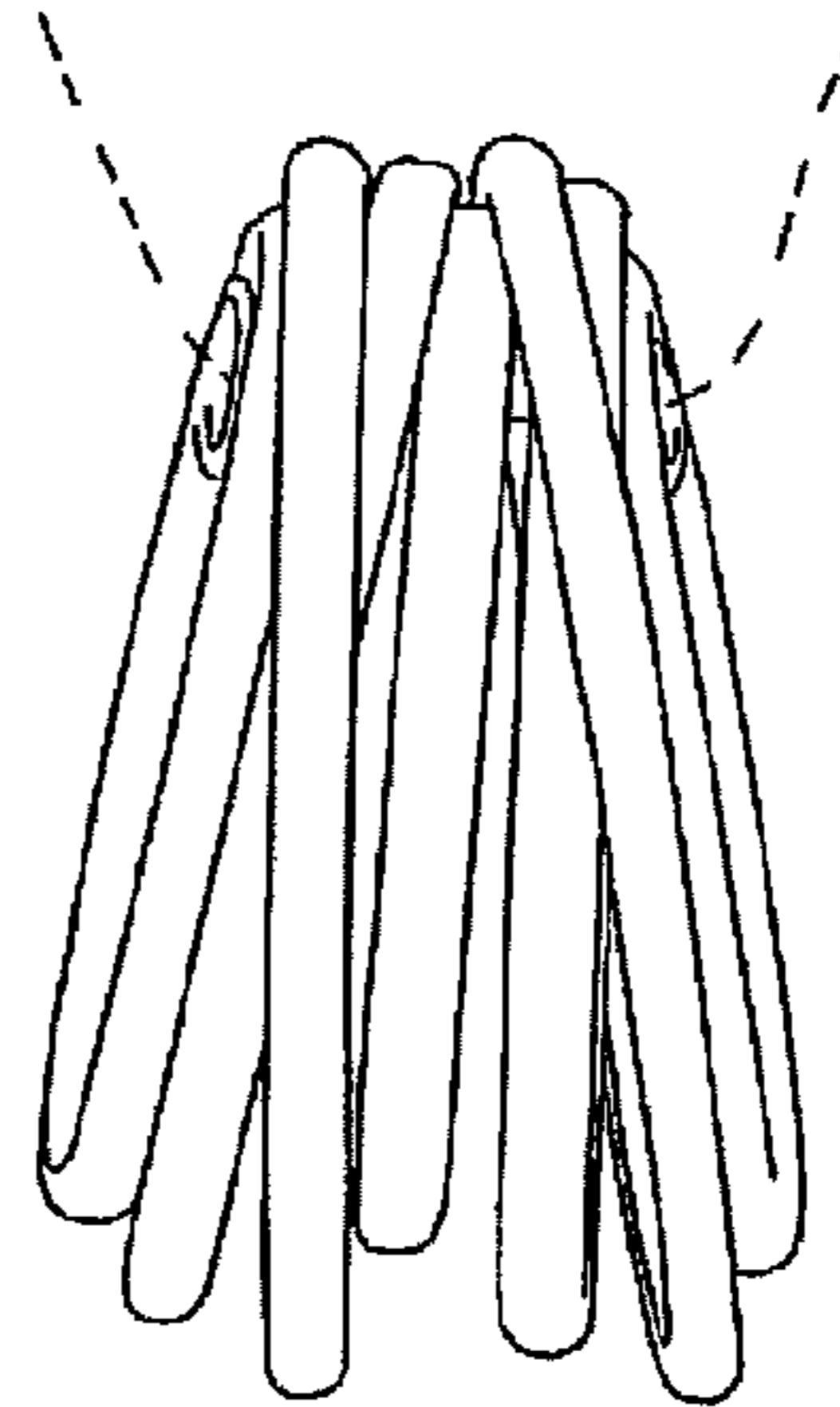

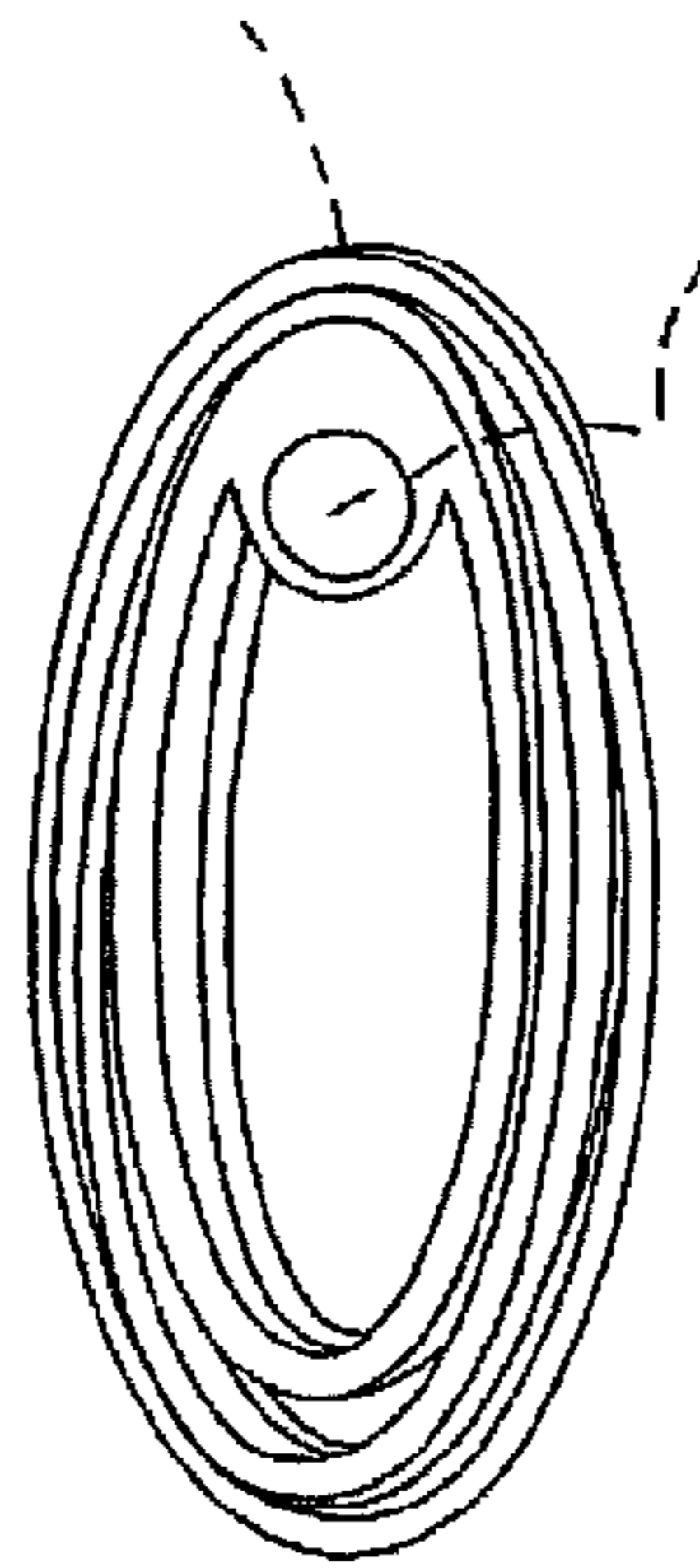

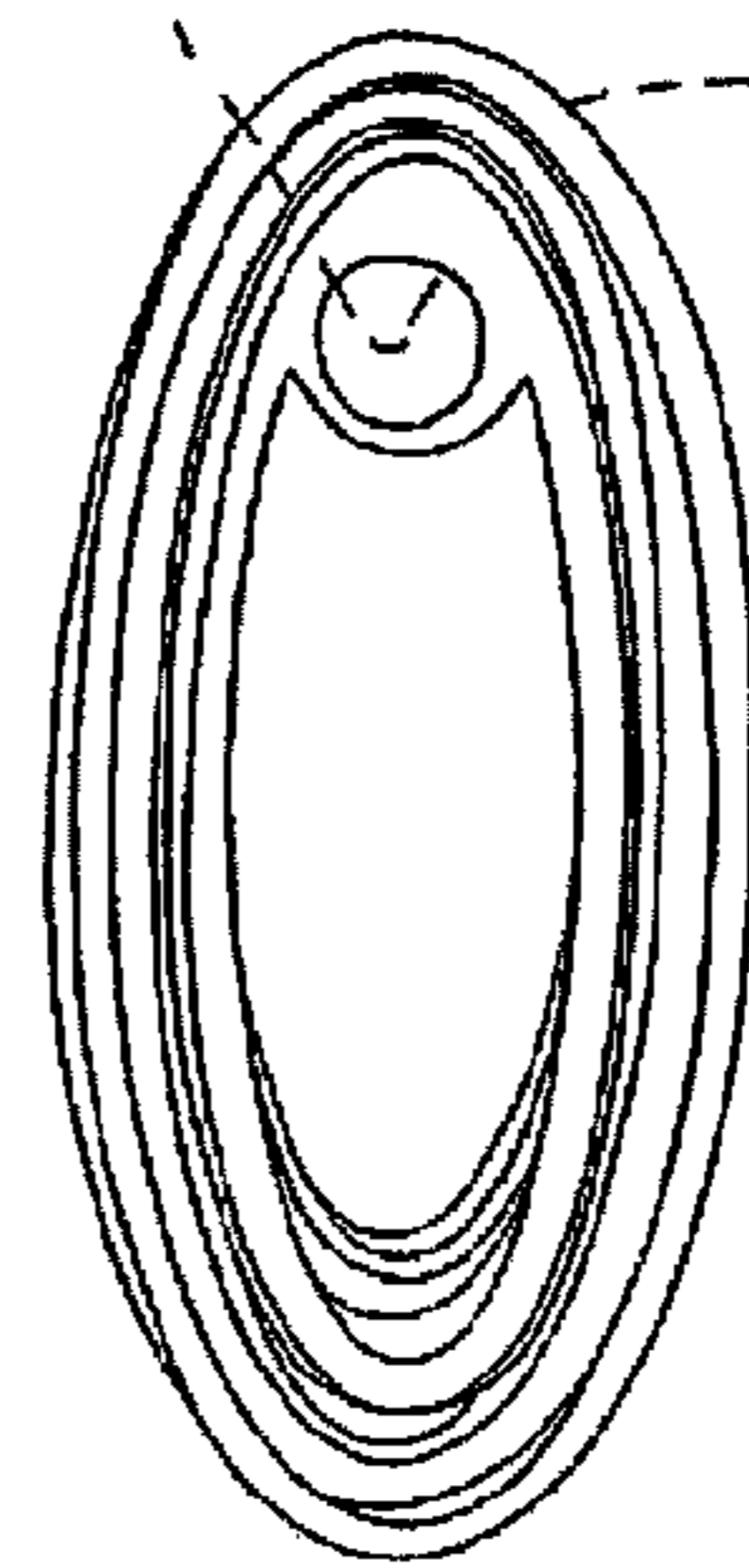

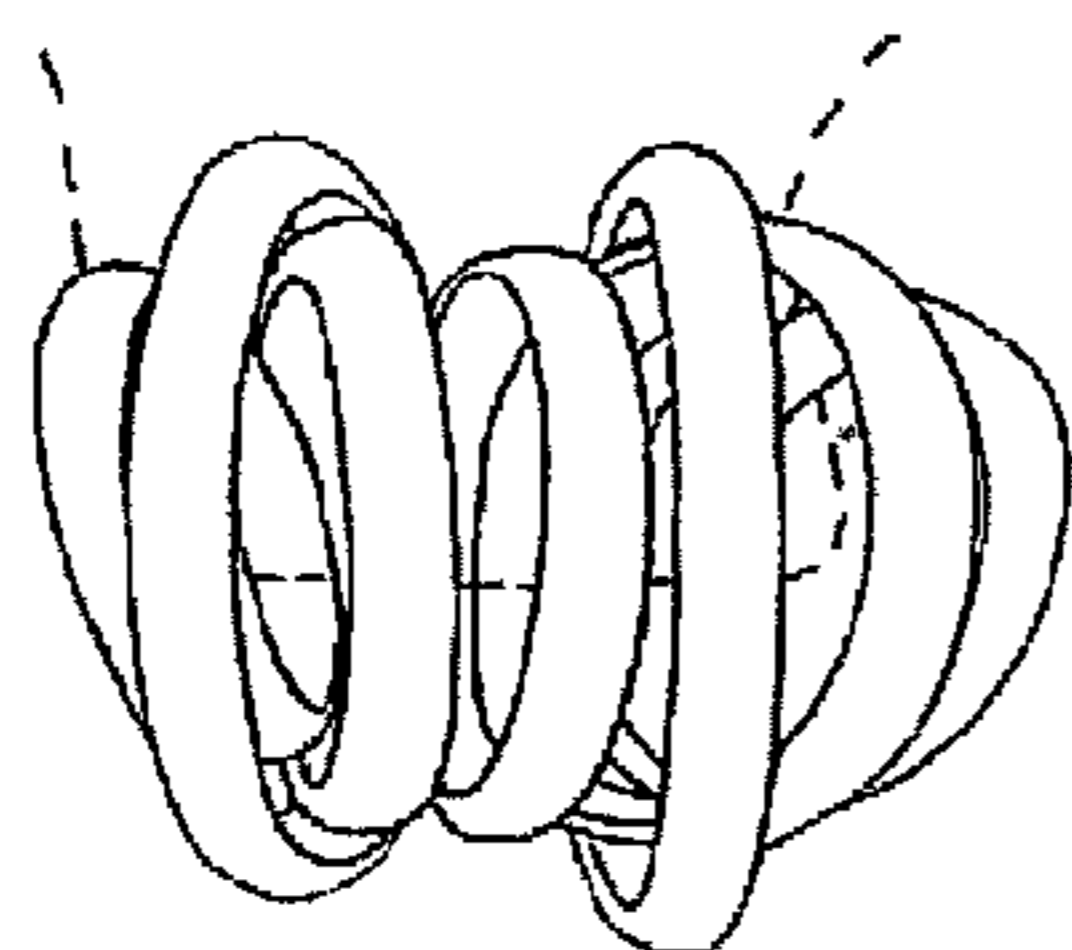

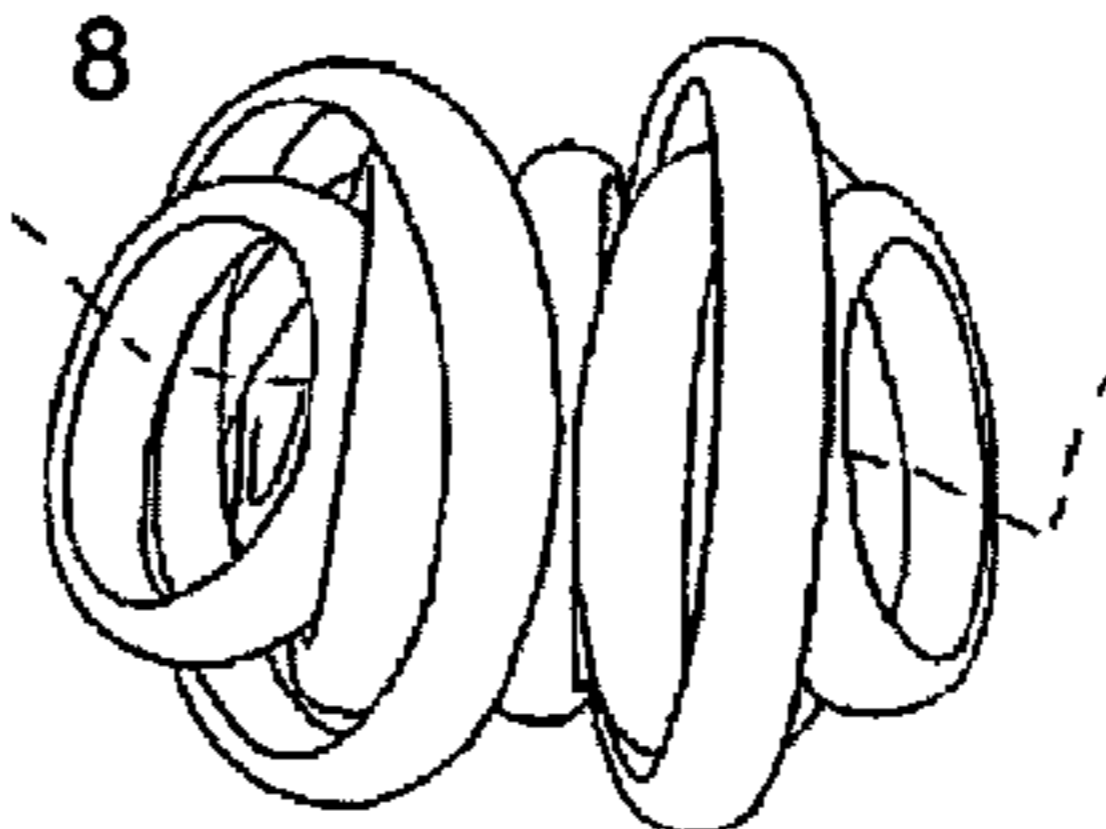
