FIG. 5 is a front perspective view of the cremains jewelry item;

FIG. 6 is a cross-sectional view of the cremains jewelry item taken along line 6—6 of FIG. 2;

FIG. 7 is a bottom view of the cremains jewelry item; and,

FIG. 8 is a rear elevation view of the cremains jewelry item.

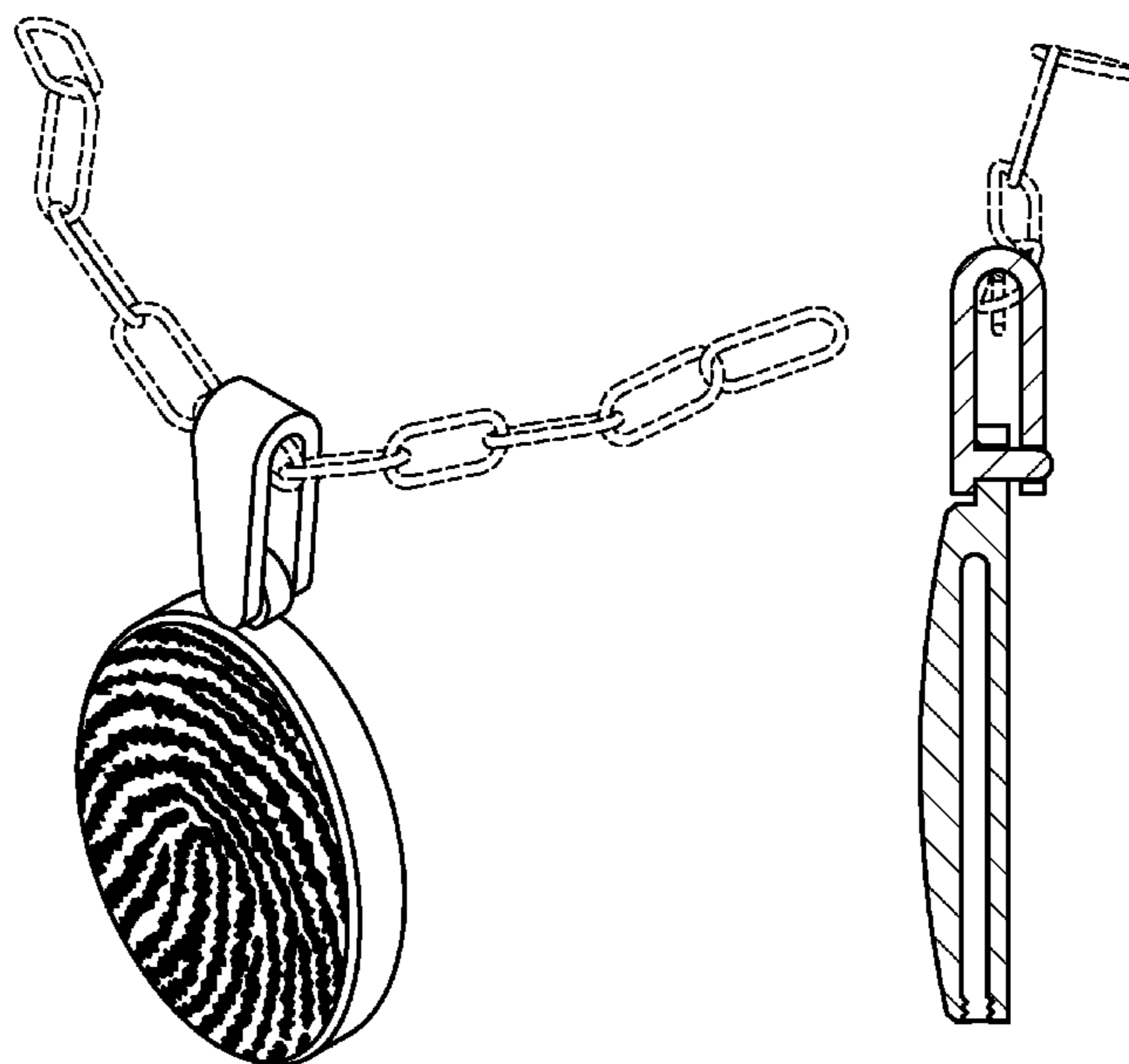

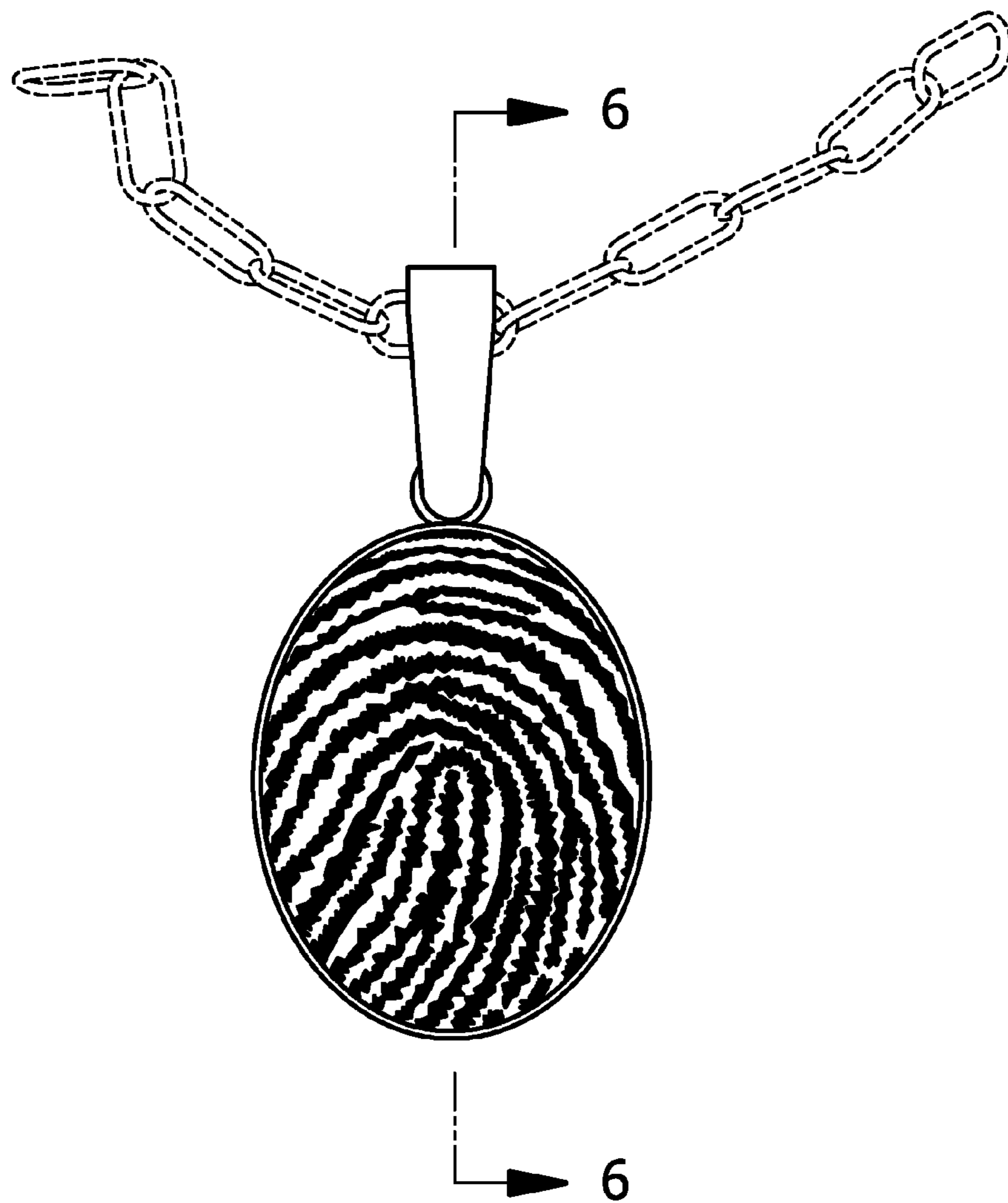

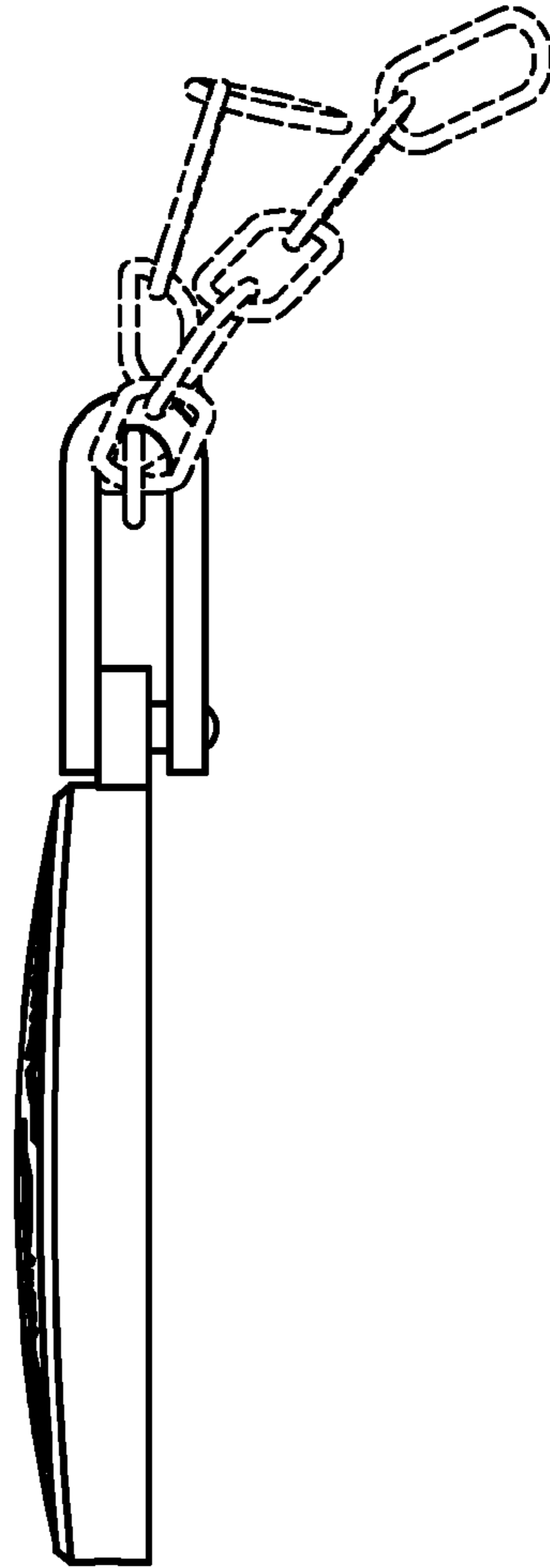

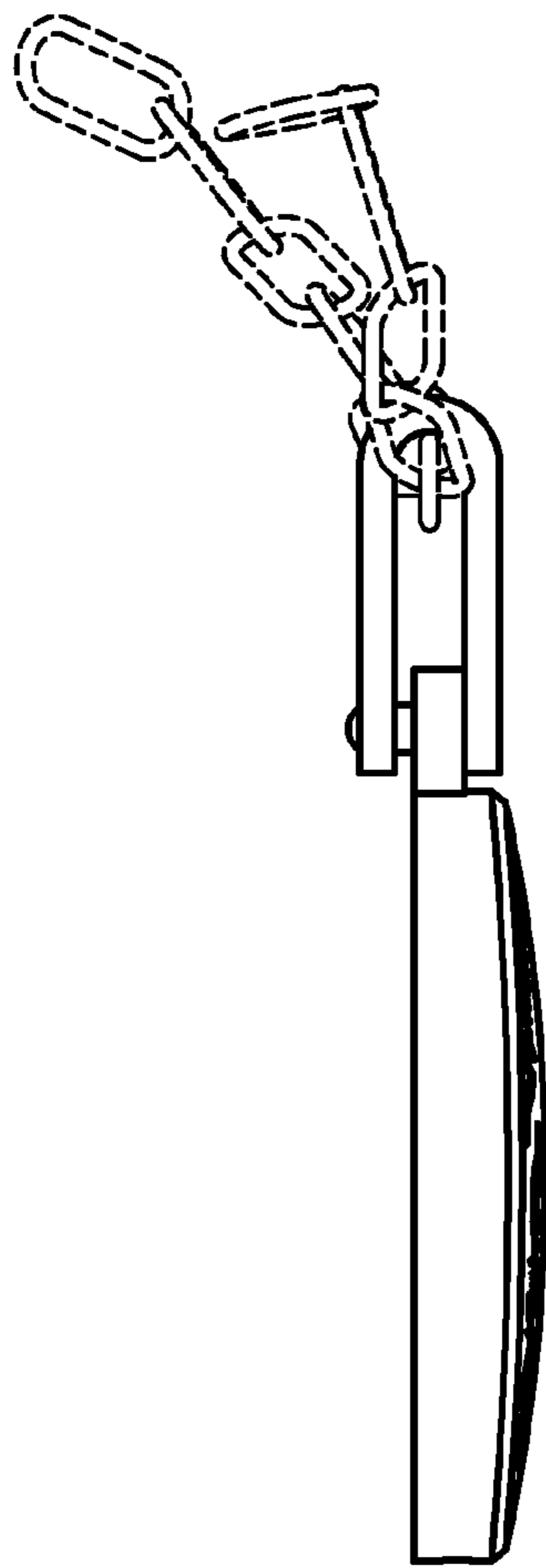

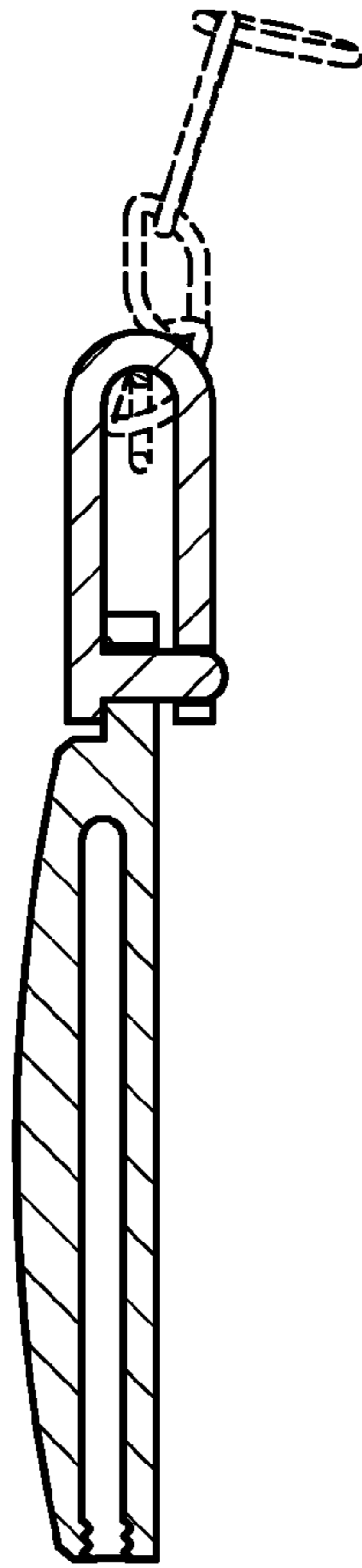

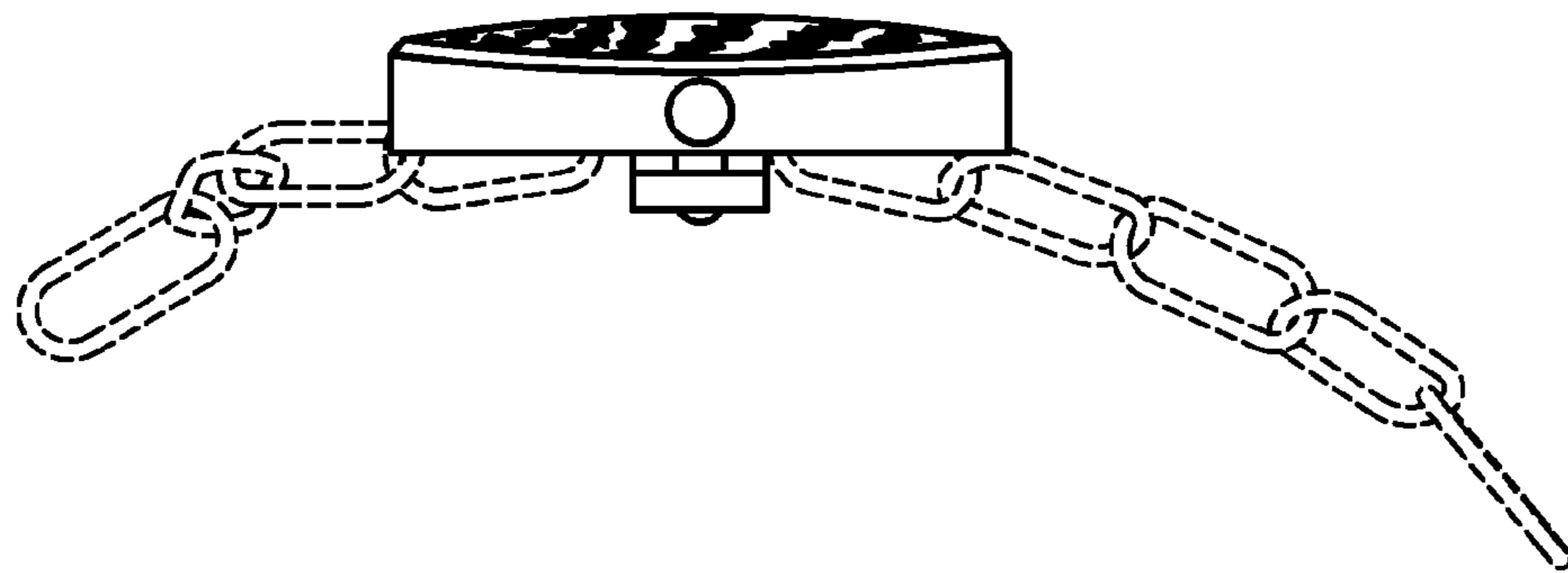
