(57) **CLAIM**

The ornamental design for a pull tab of slider for slide fastener, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the front, bottom and right side of a pull tab of slider for slide fastener showing our new design;

FIG. 2 is front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a right side view thereof, the left side view being mirror image thereof;

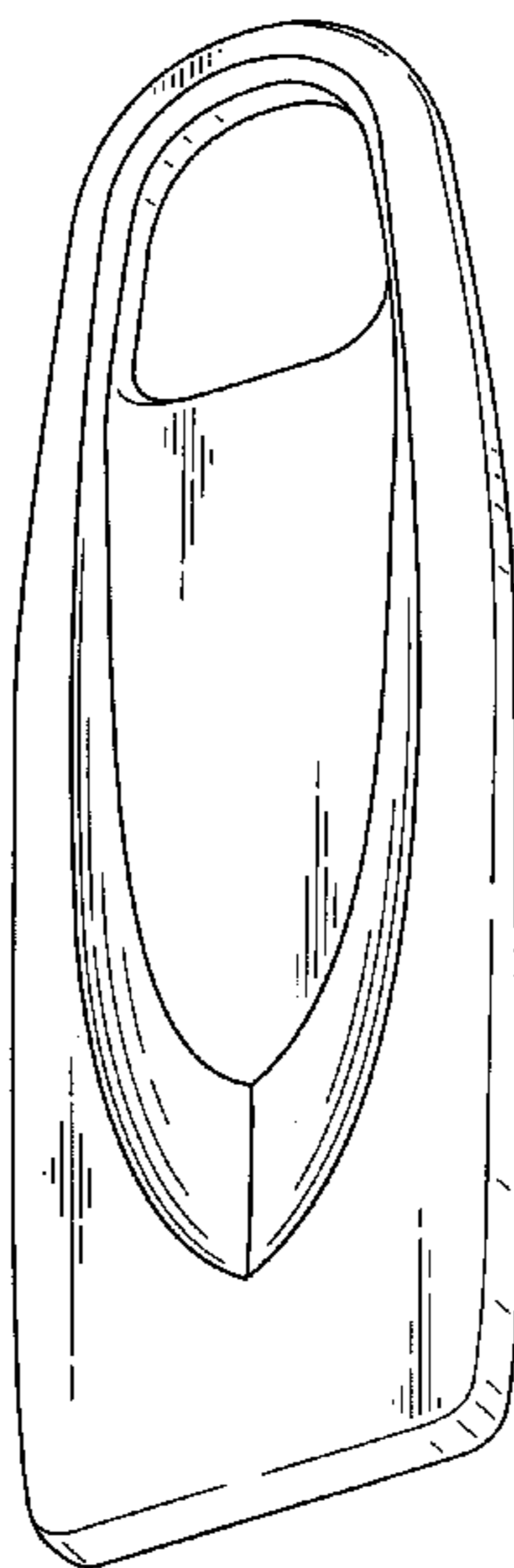
FIG. 5 is a top plan view thereof;

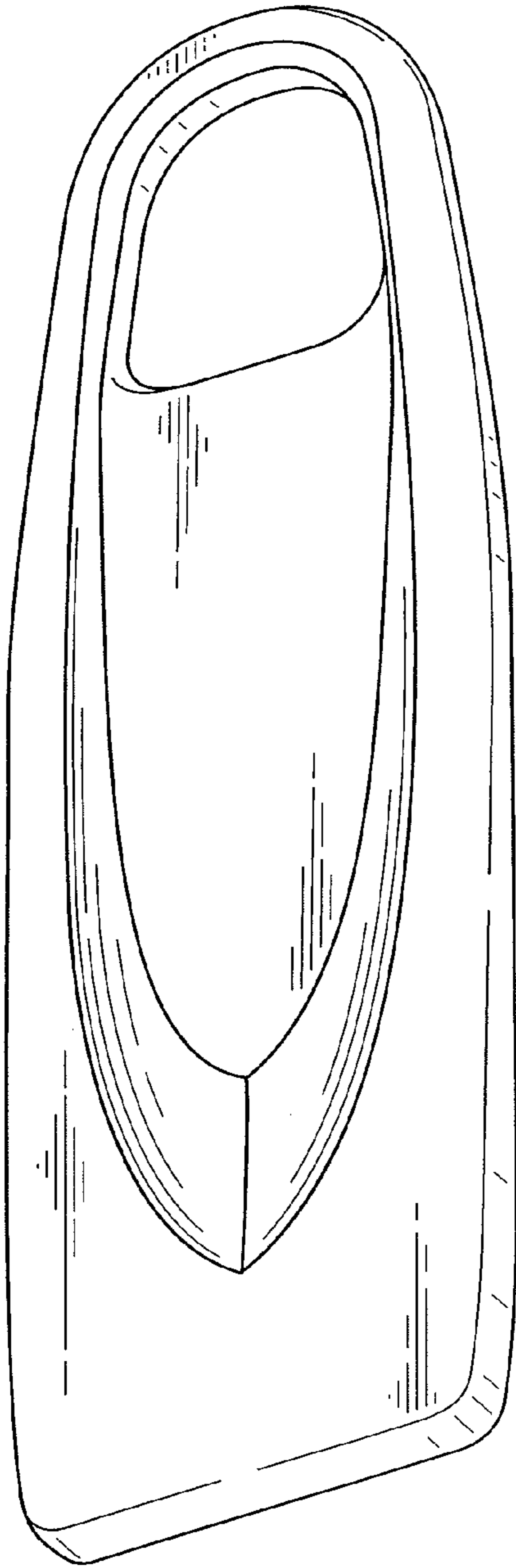
FIG. 6 is a bottom view thereof; and,

FIG. 7 is a front view of usage thereof.

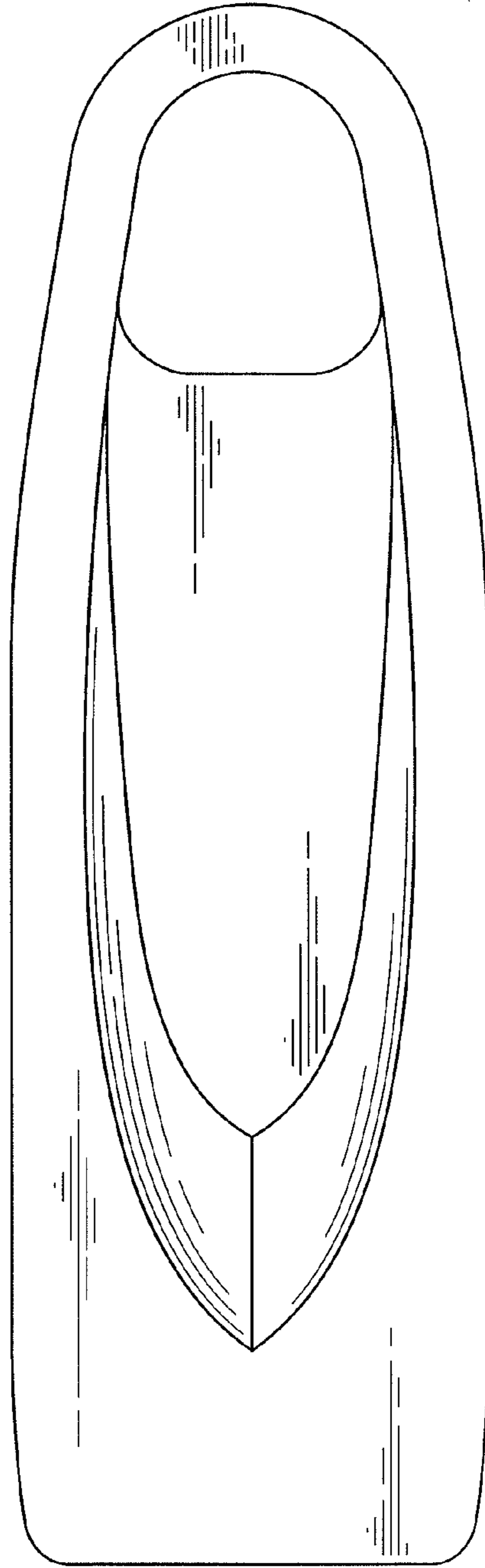

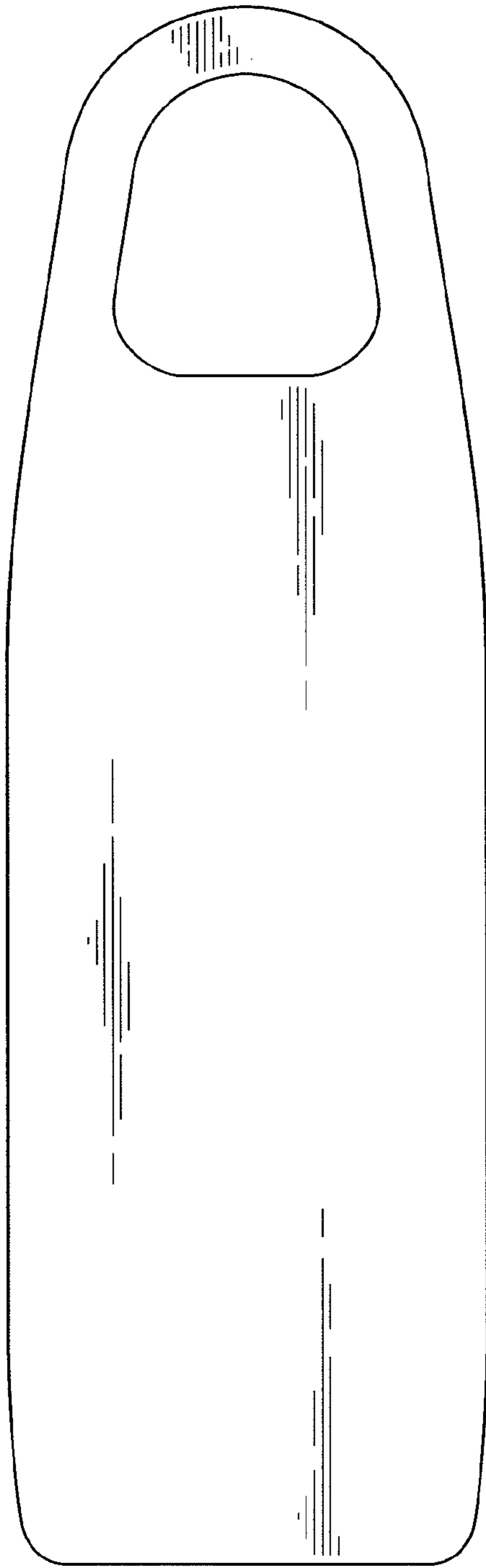

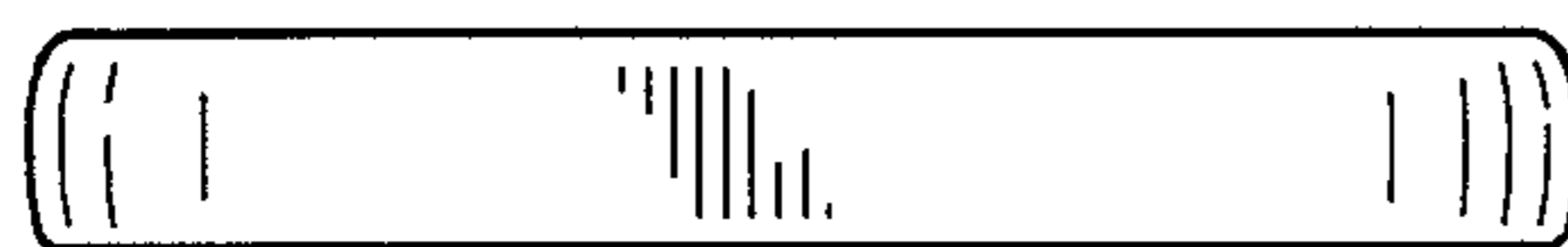

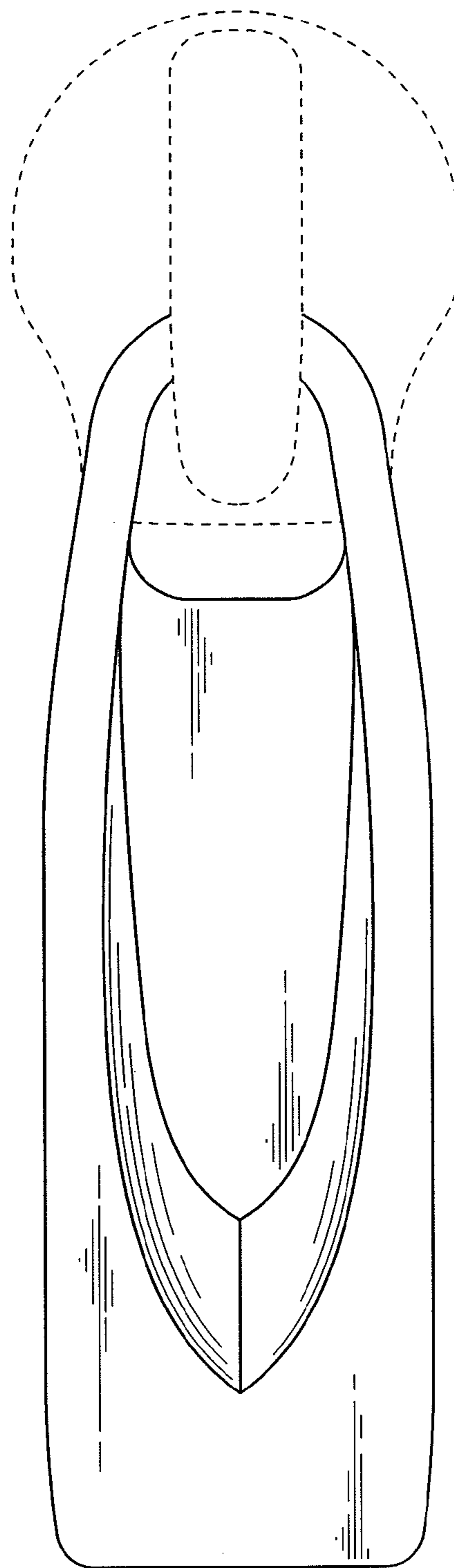
