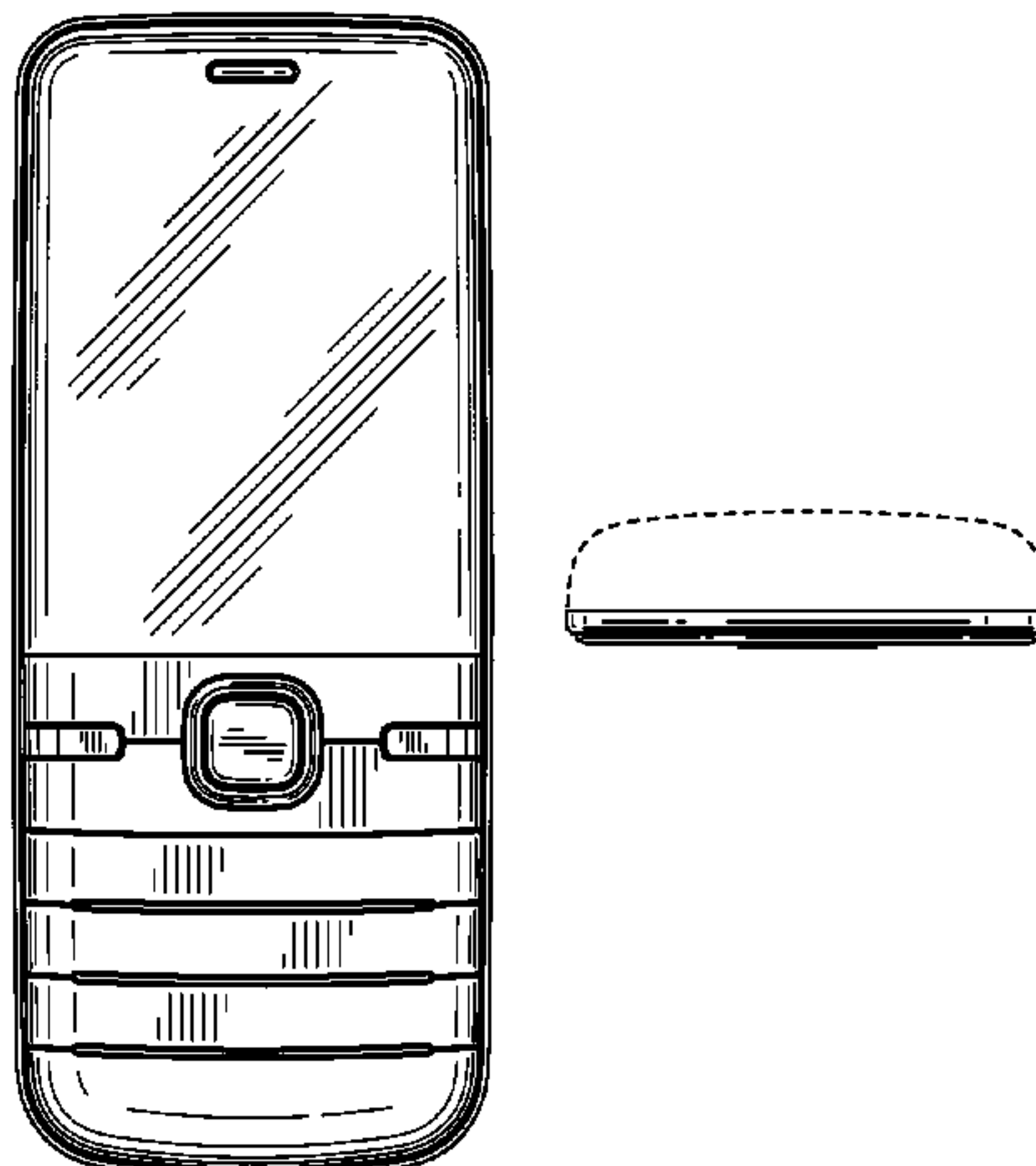
The ornamental design for a handset front cover, as shown and described.

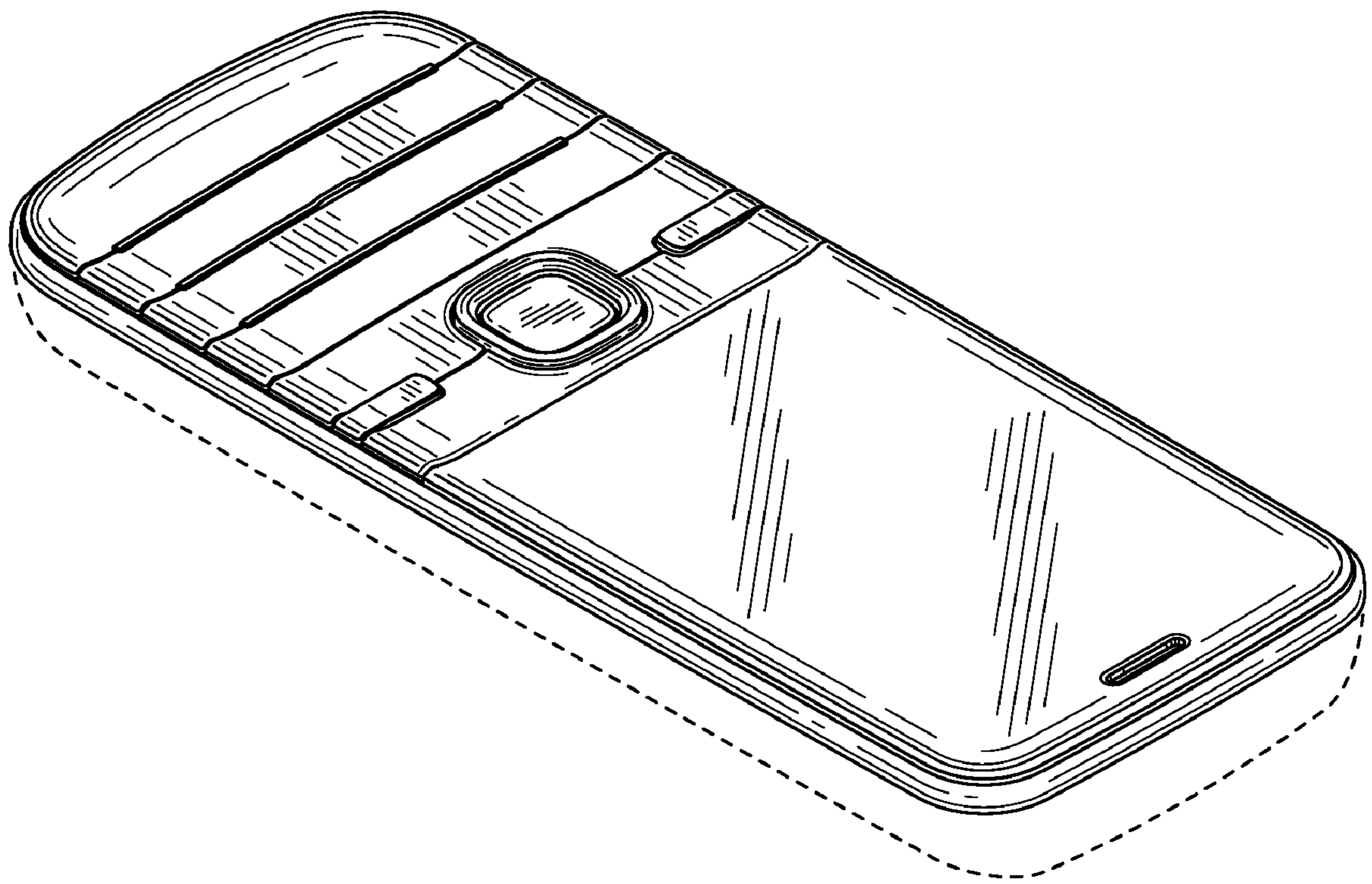

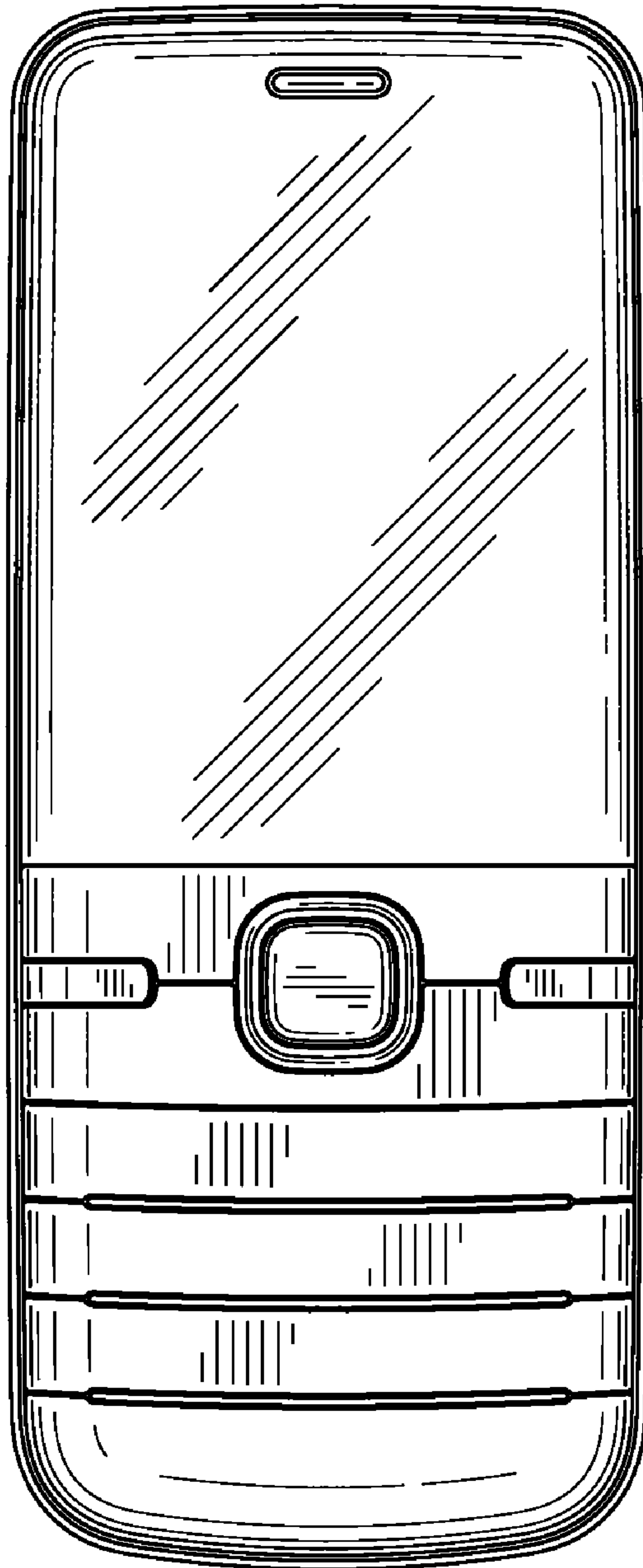

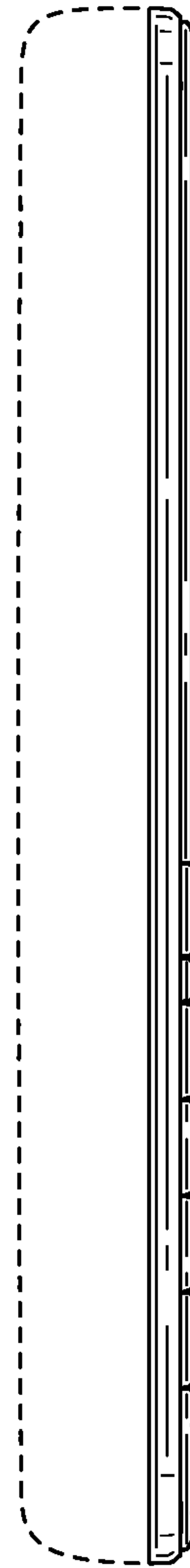

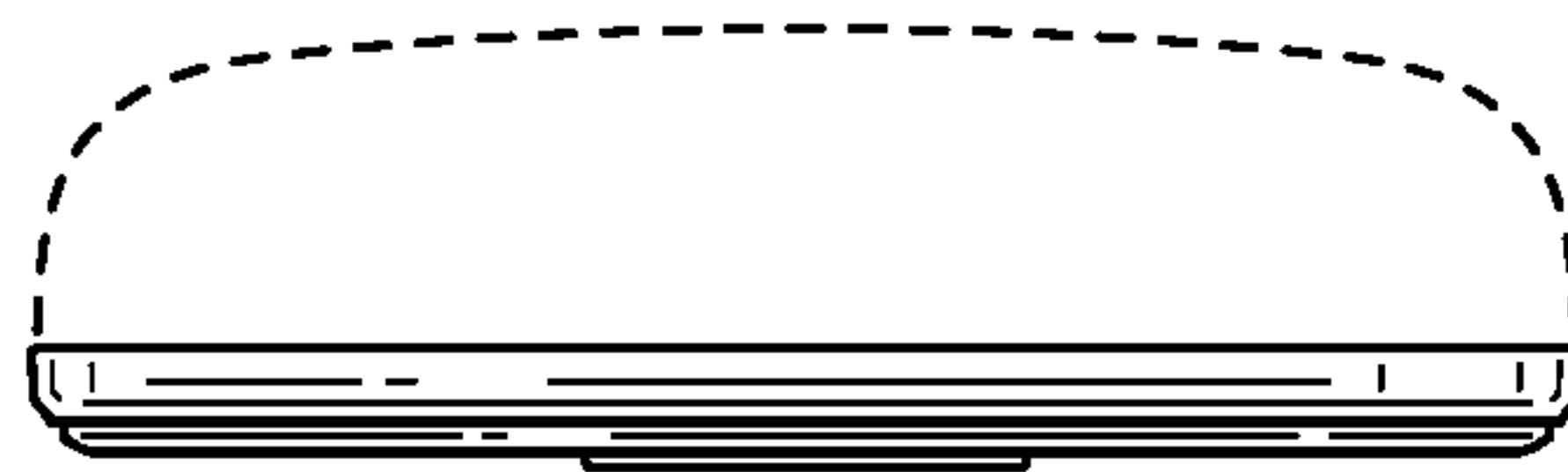

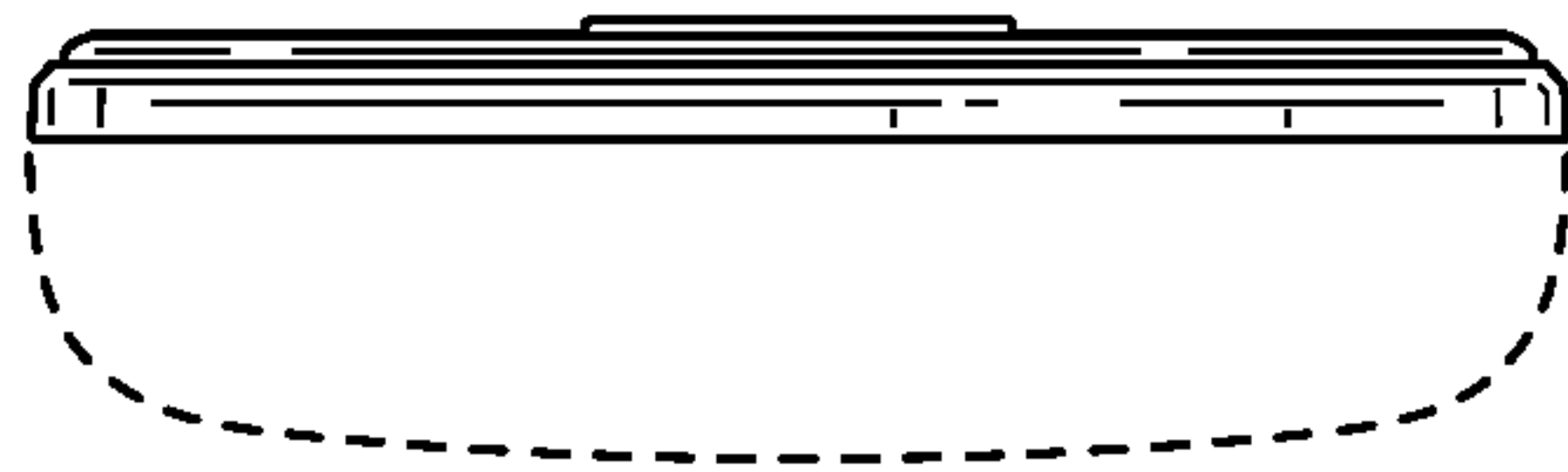
