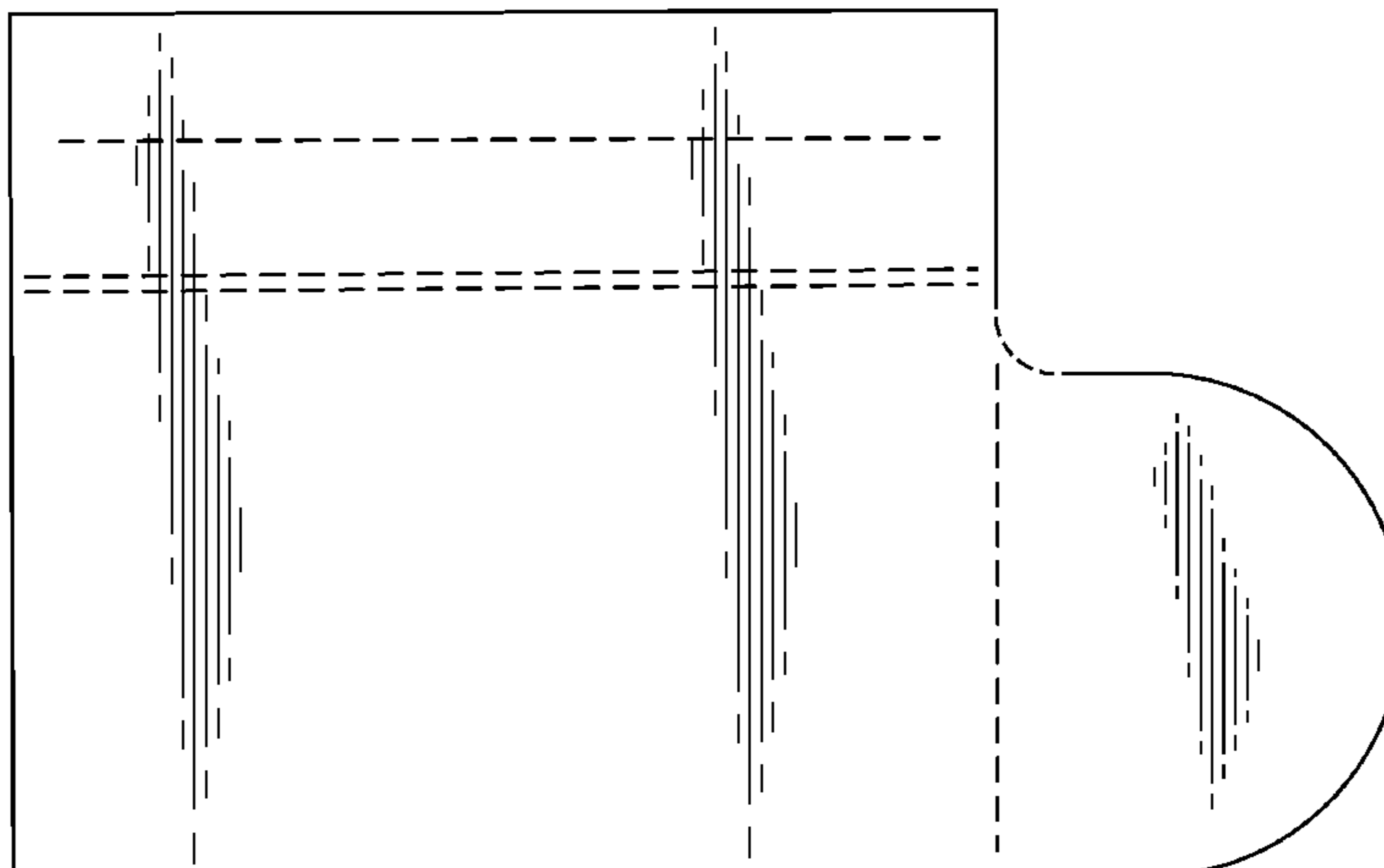
(57) **CLAIM**

The ornamental design for an in-store marketing sign, as shown and described.

DESCRIPTION

FIG. 1 is a front view of one embodiment of the in-store marketing sign.
 FIG. 2 is a back view of the in-store marketing sign embodiment of FIG. 1.
 FIG. 3 is a side view of the in-store marketing sign embodiment of FIG. 1.
 FIG. 4 is a front view of a second embodiment of the in-store marketing sign.
 FIG. 5 is a back view of the in-store marketing sign embodiment of FIG. 4; and,
 FIG. 6 is a side view of the in-store marketing sign embodiment of FIG. 4.
 The dashed lines in FIG. 1-2 and 4-5 do not form any part of the claimed design for the in-store marketing sign.

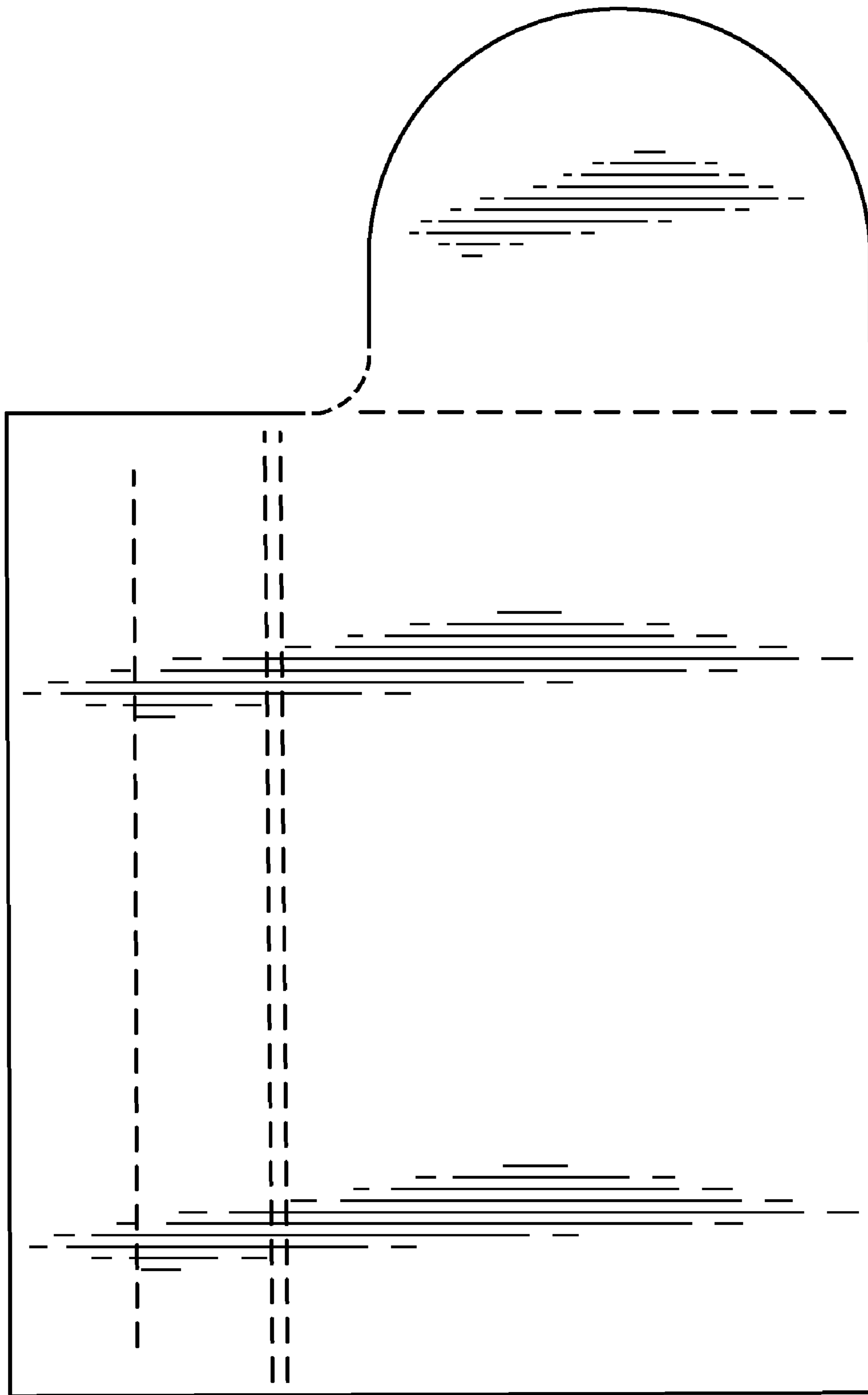

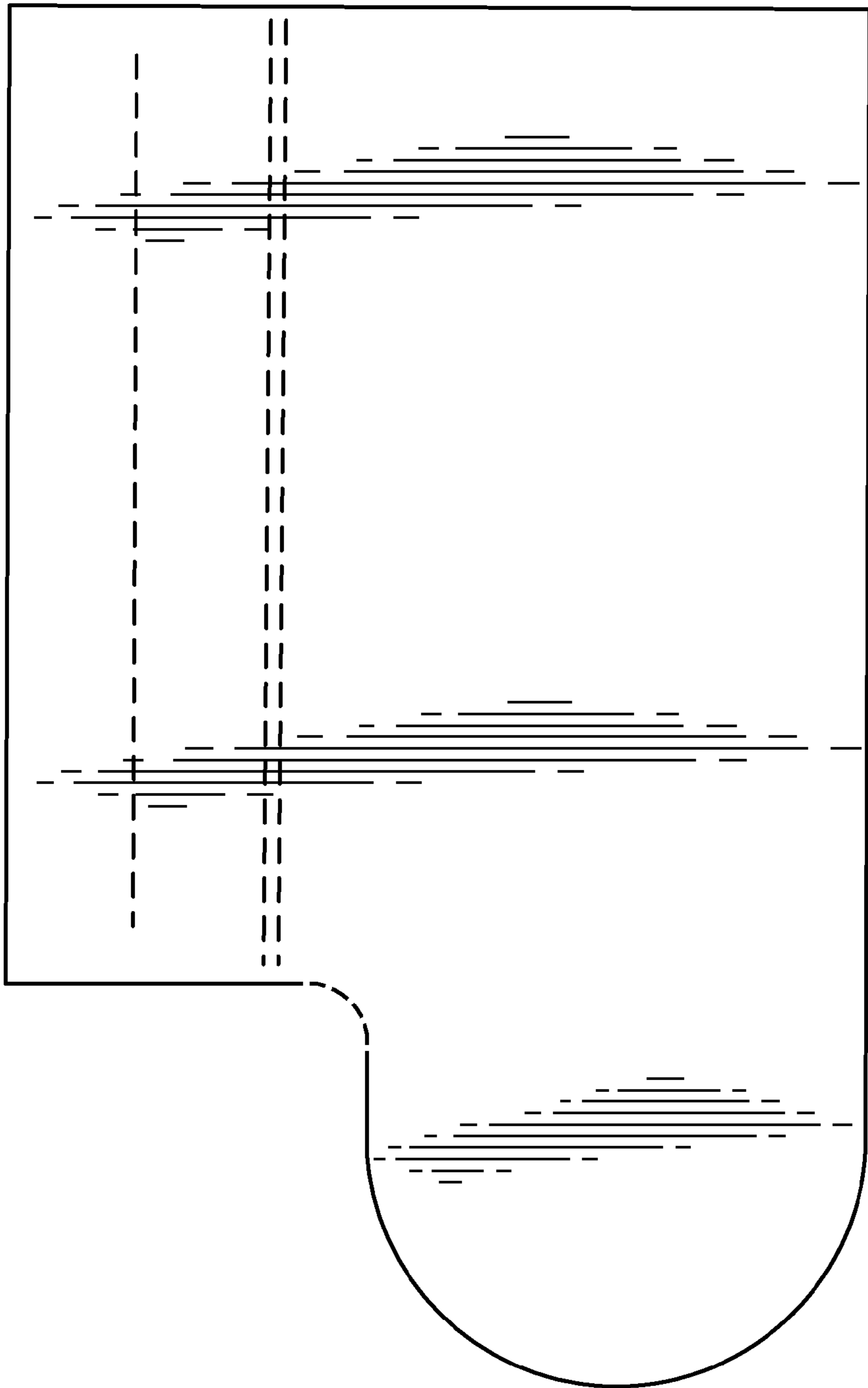

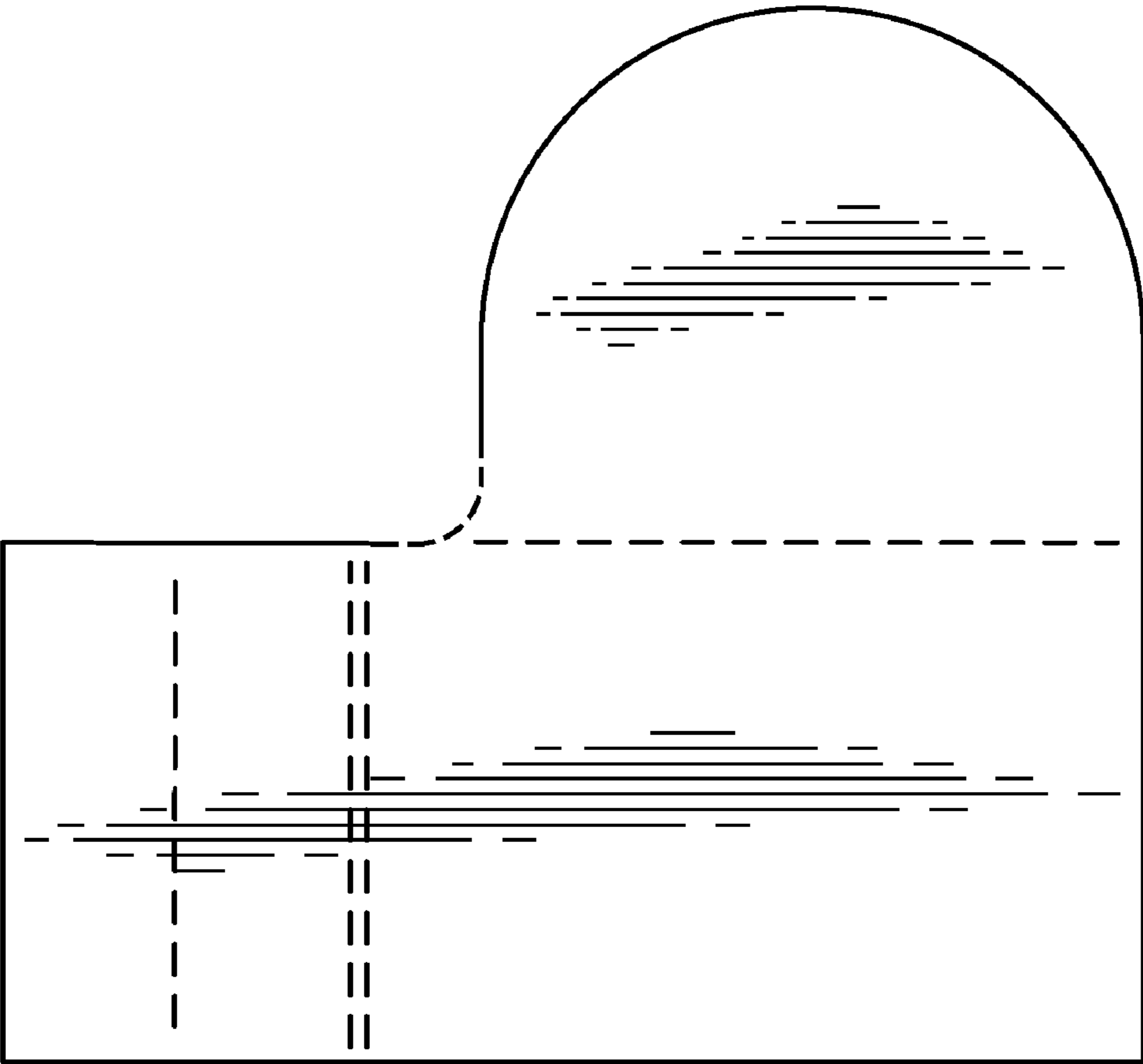

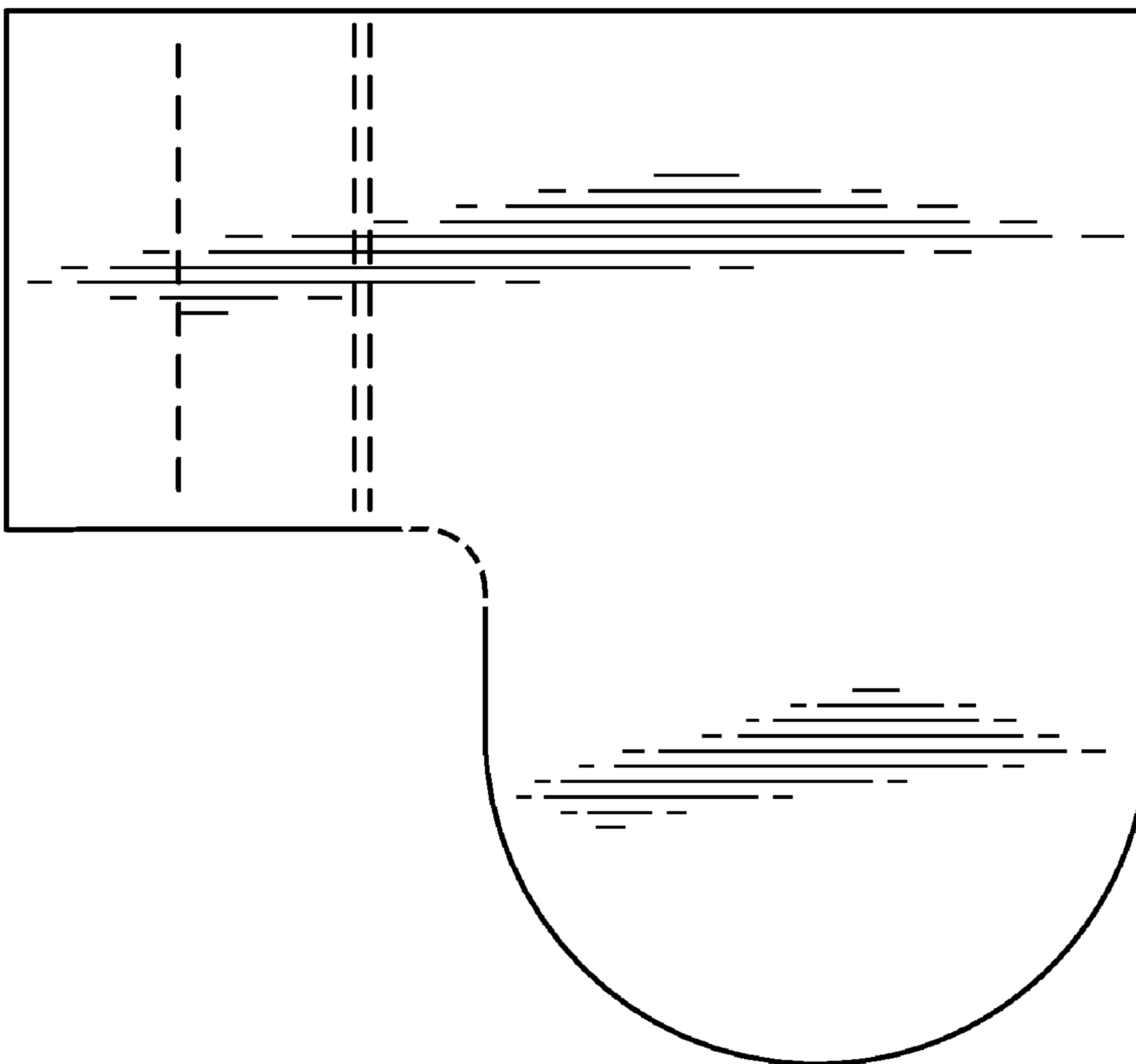
