DESCRIPTION

FIG. 1 is a perspective view of a spout of the new design;

FIG. 2 is a front elevational view of the spout of FIG. 1;

FIG. 3 is a rear elevational view of the spout of FIG. 1;

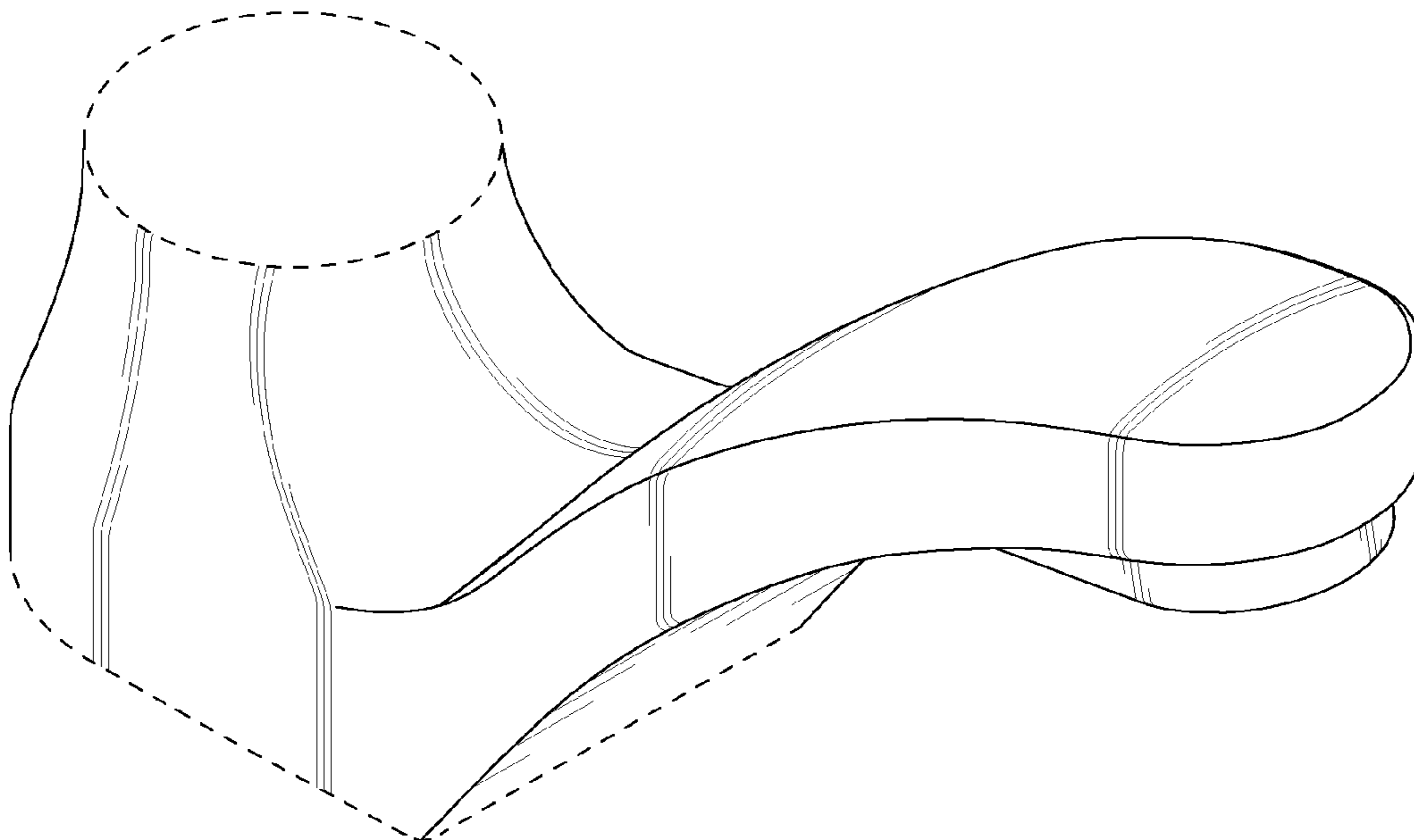
FIG. 4 is a left side elevational view of the spout of FIG. 1, the right side elevational view being a mirror image;

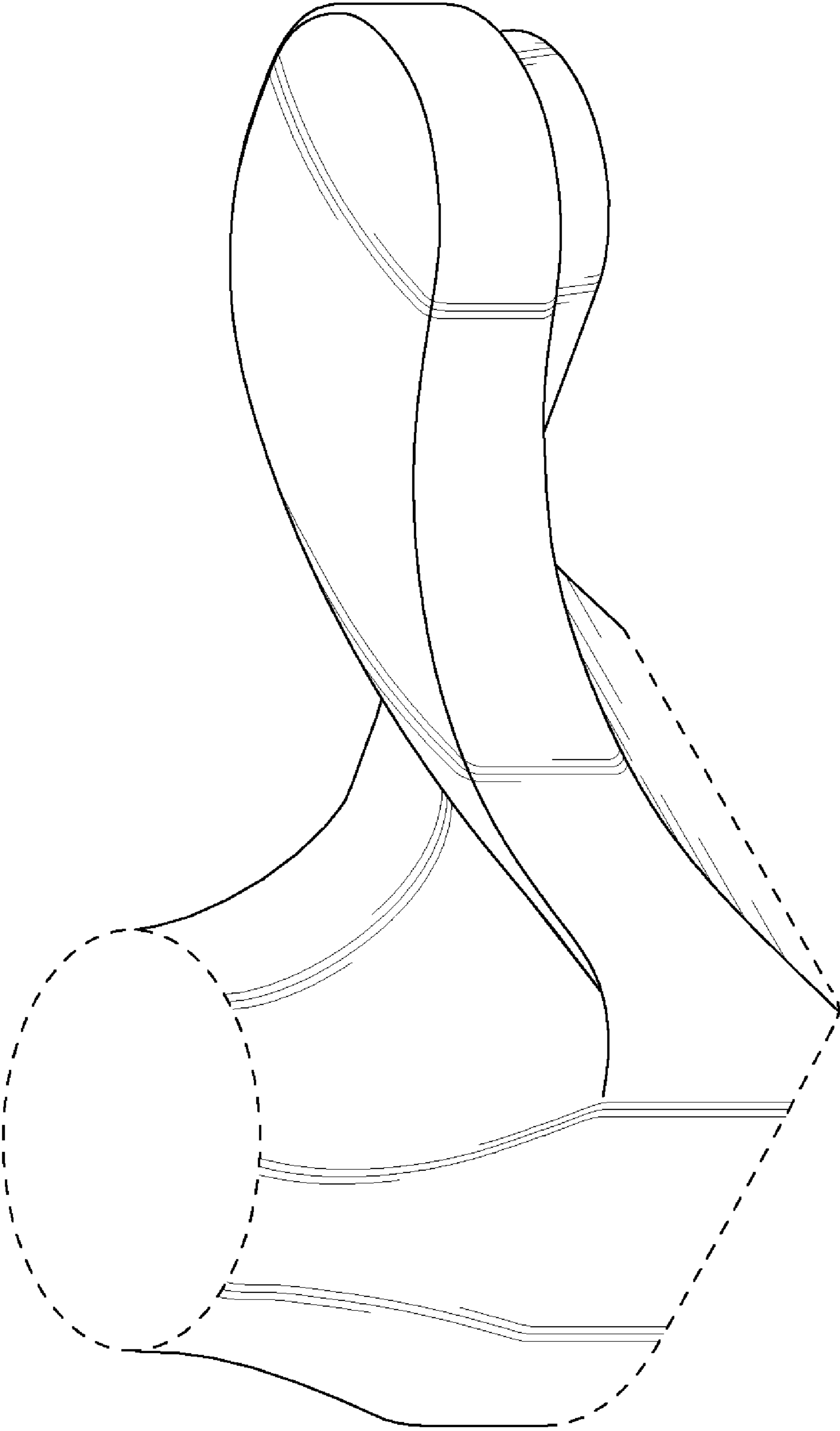

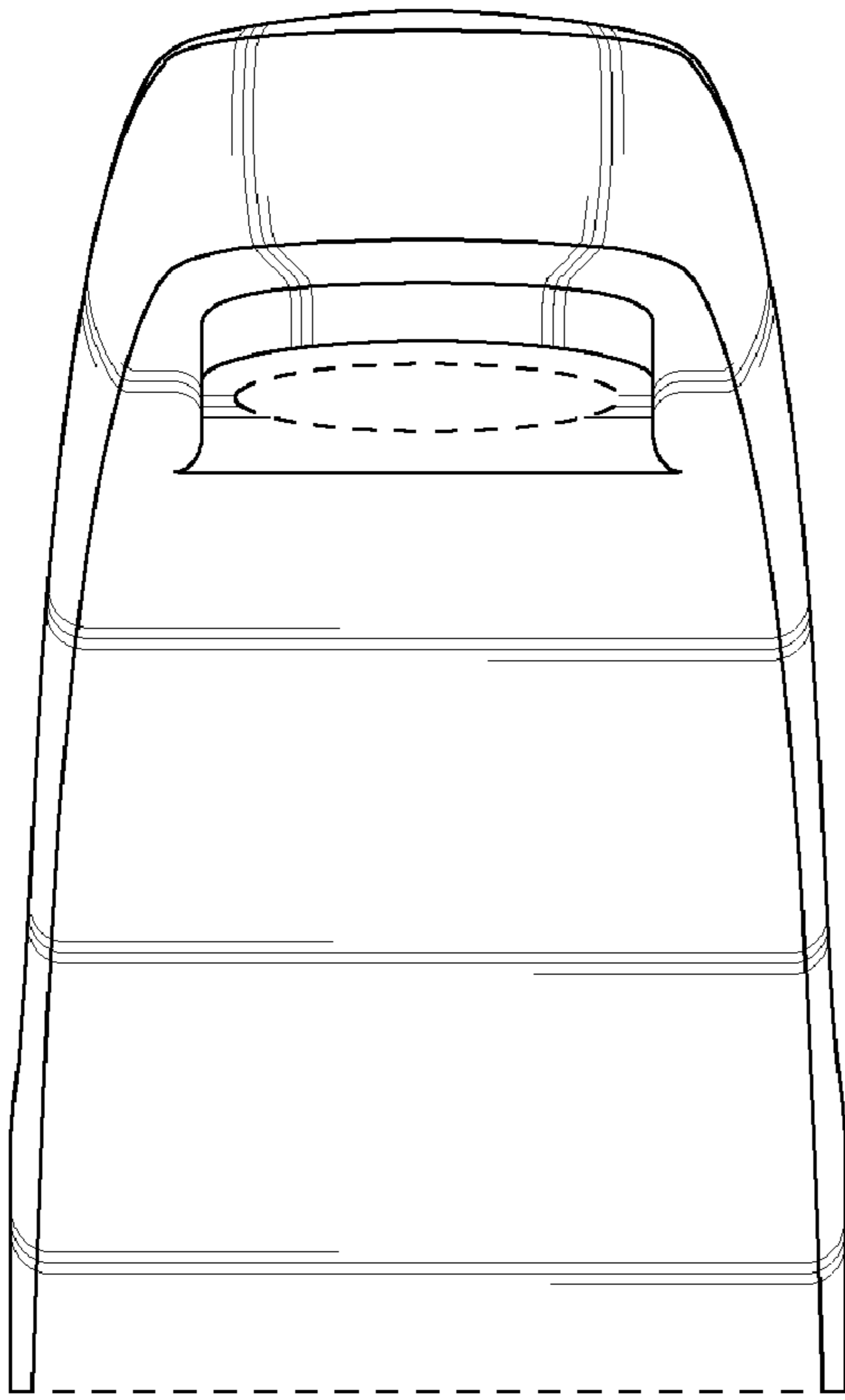

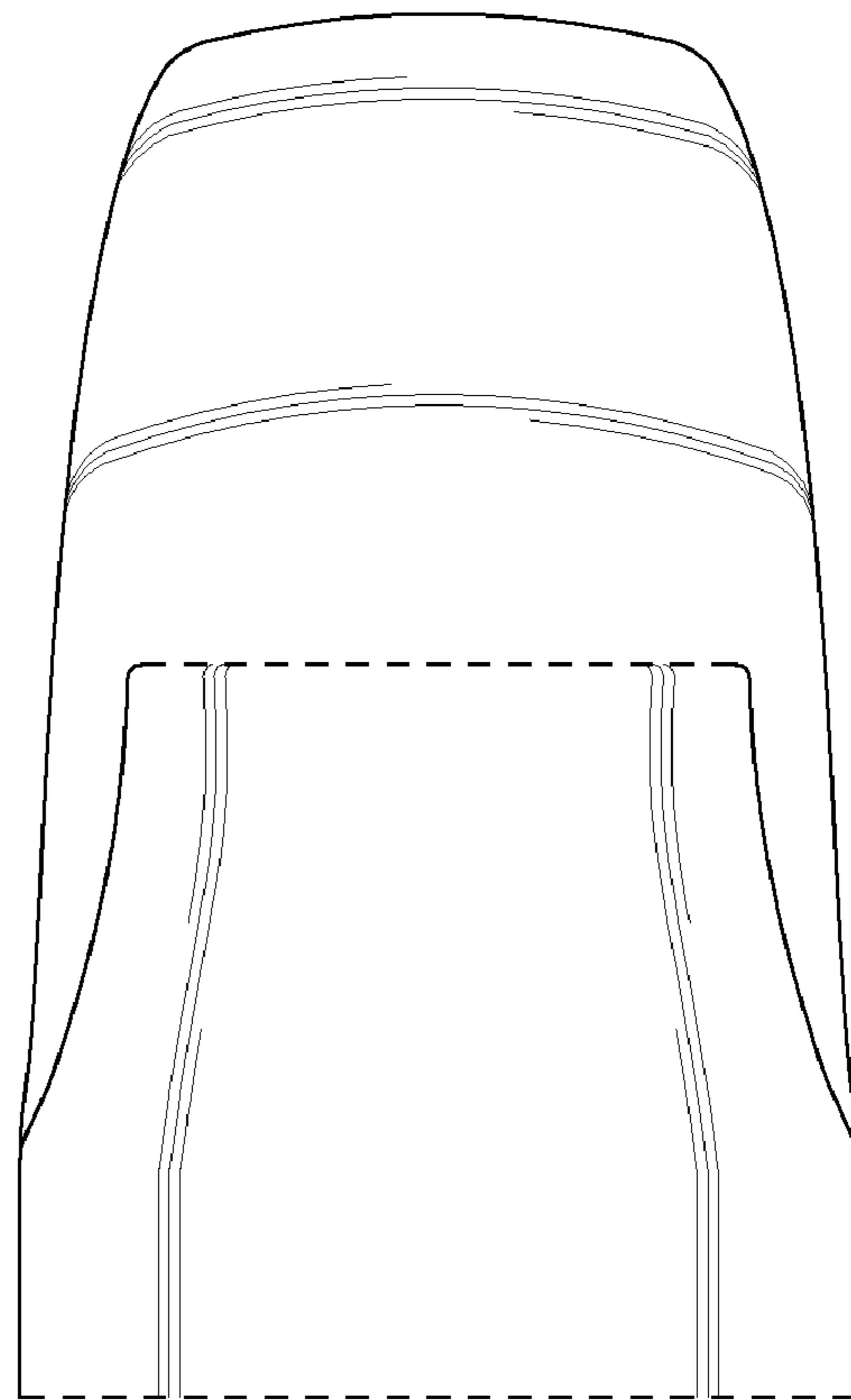

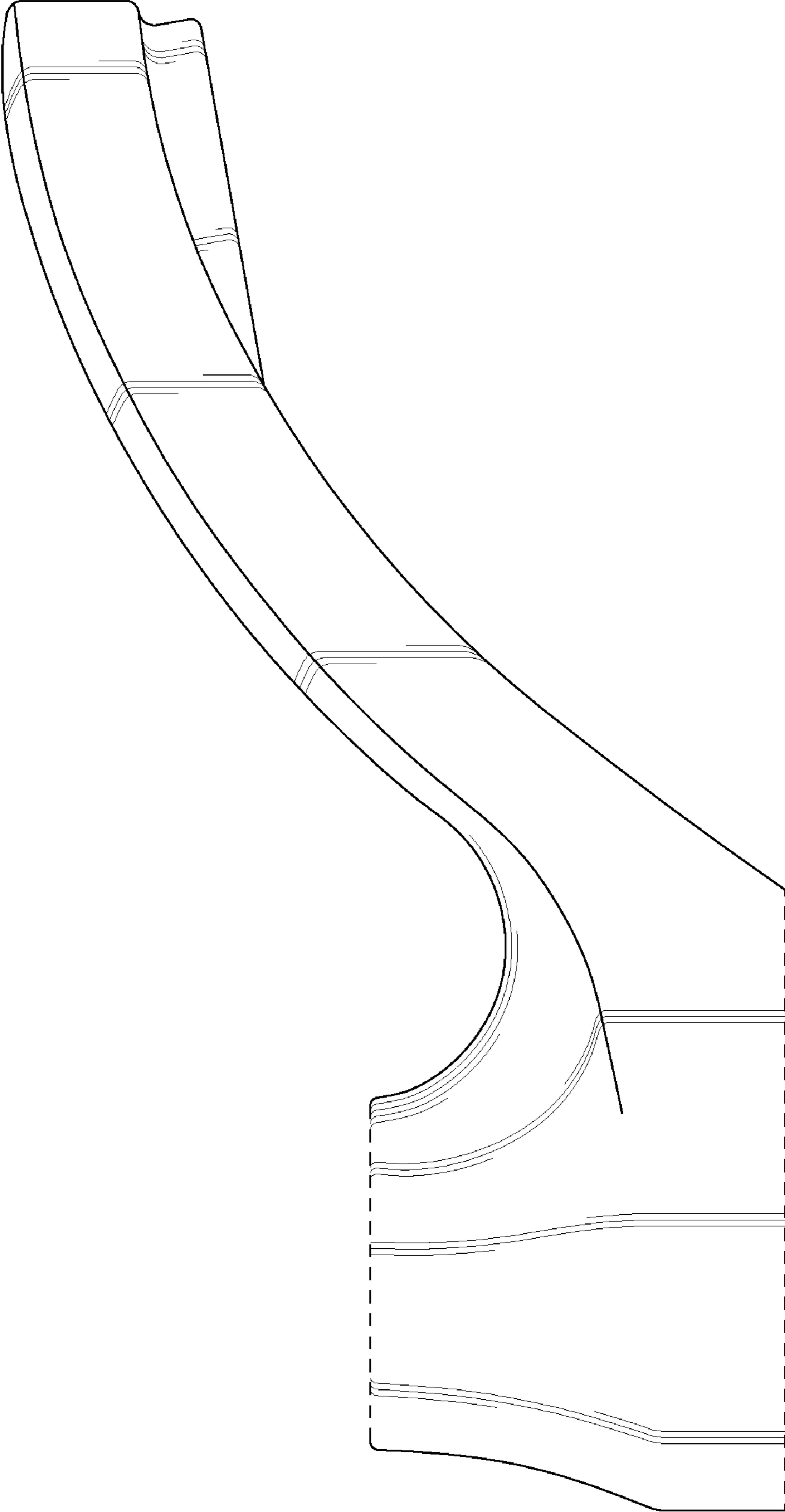

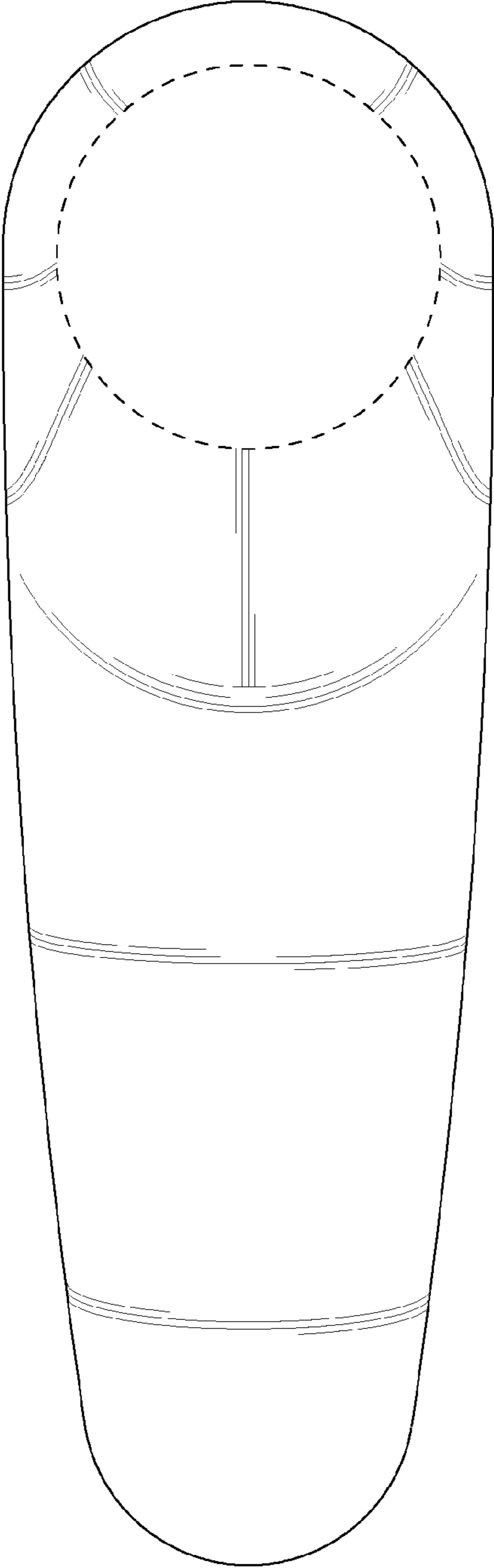

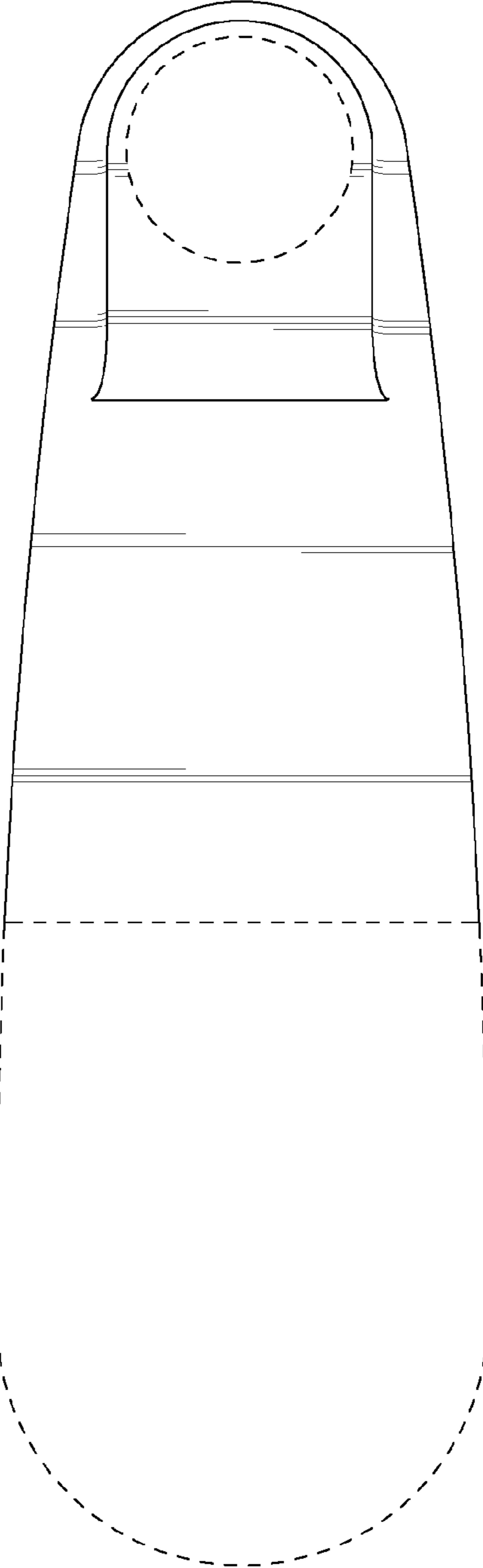
