(57) **CLAIM**

We claim the ornamental design for a grill for device for diffusing substances, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, right perspective view of a grill for a device for diffusing substances;

FIG. 2 is a front view of the grill of FIG. 1;

FIG. 3 is a top, right perspective view of another grill for a device for diffusing substances;

FIG. 4 is a front view of the grill of FIG. 3;

FIG. 5 is a top view of the grill of FIG. 3;

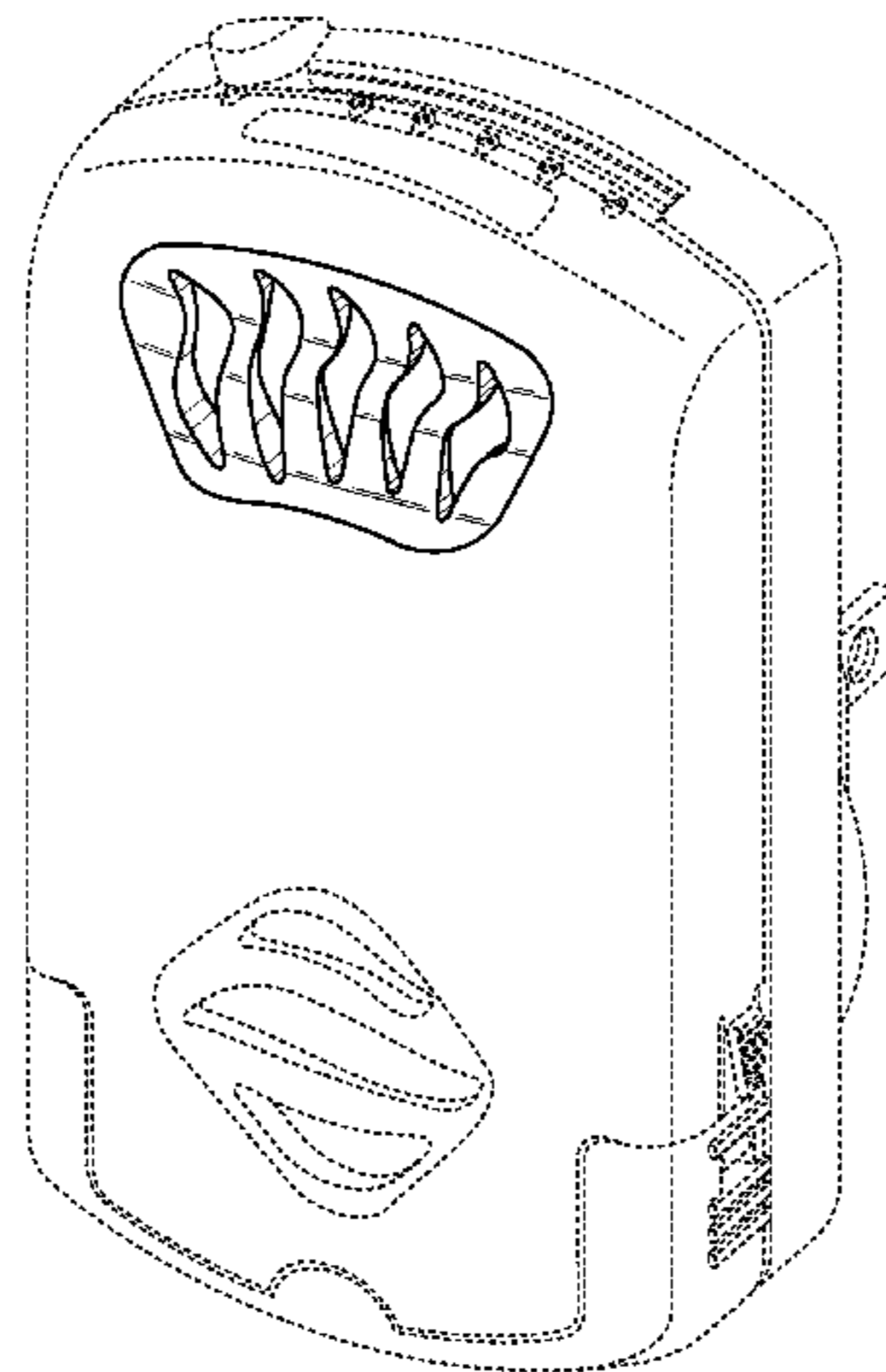
FIG. 6 is a front and right perspective view of the grill of FIG. 3;

FIG. 7 is a top and front perspective view of the grill of FIG. 3; and,

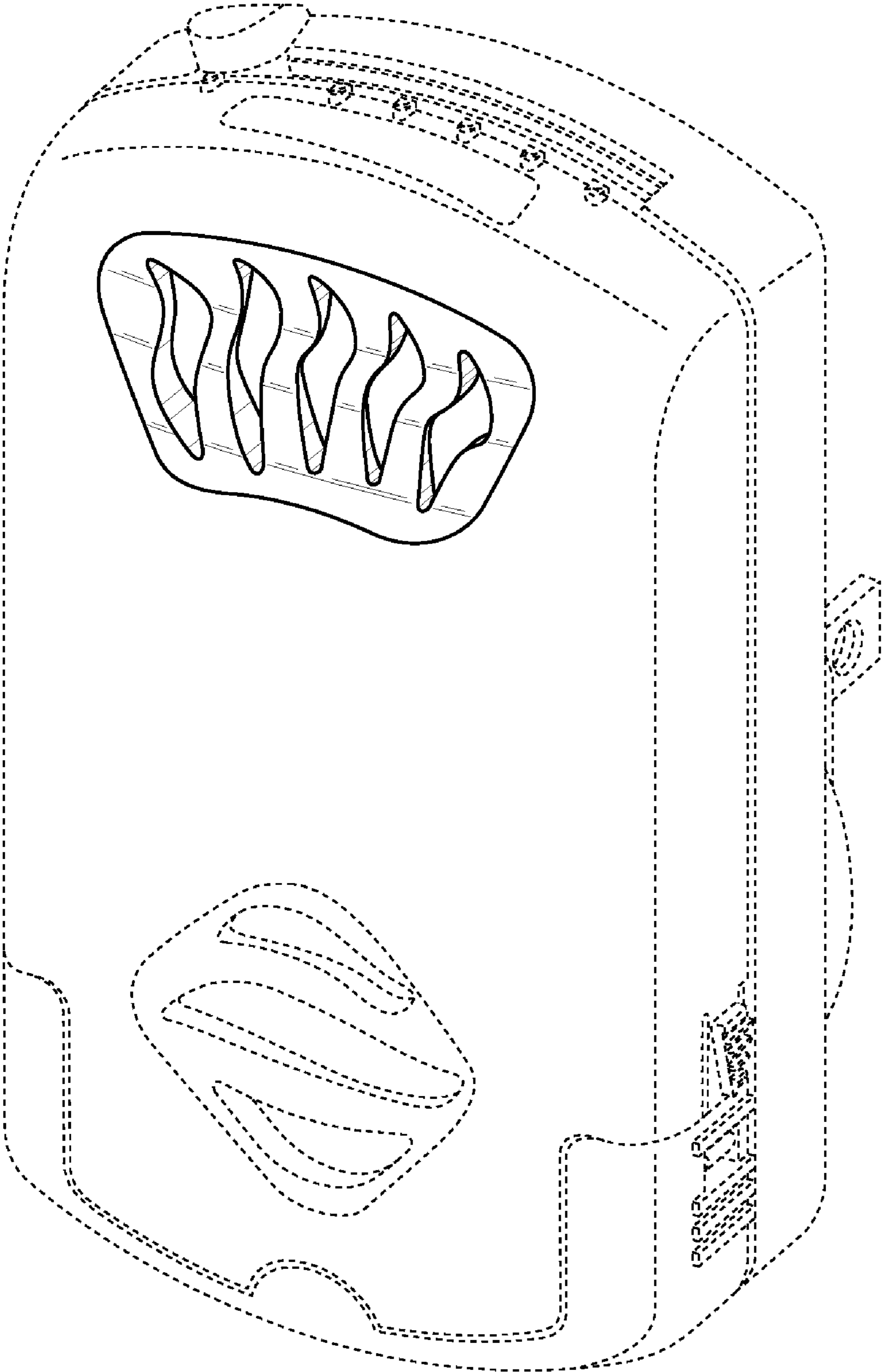

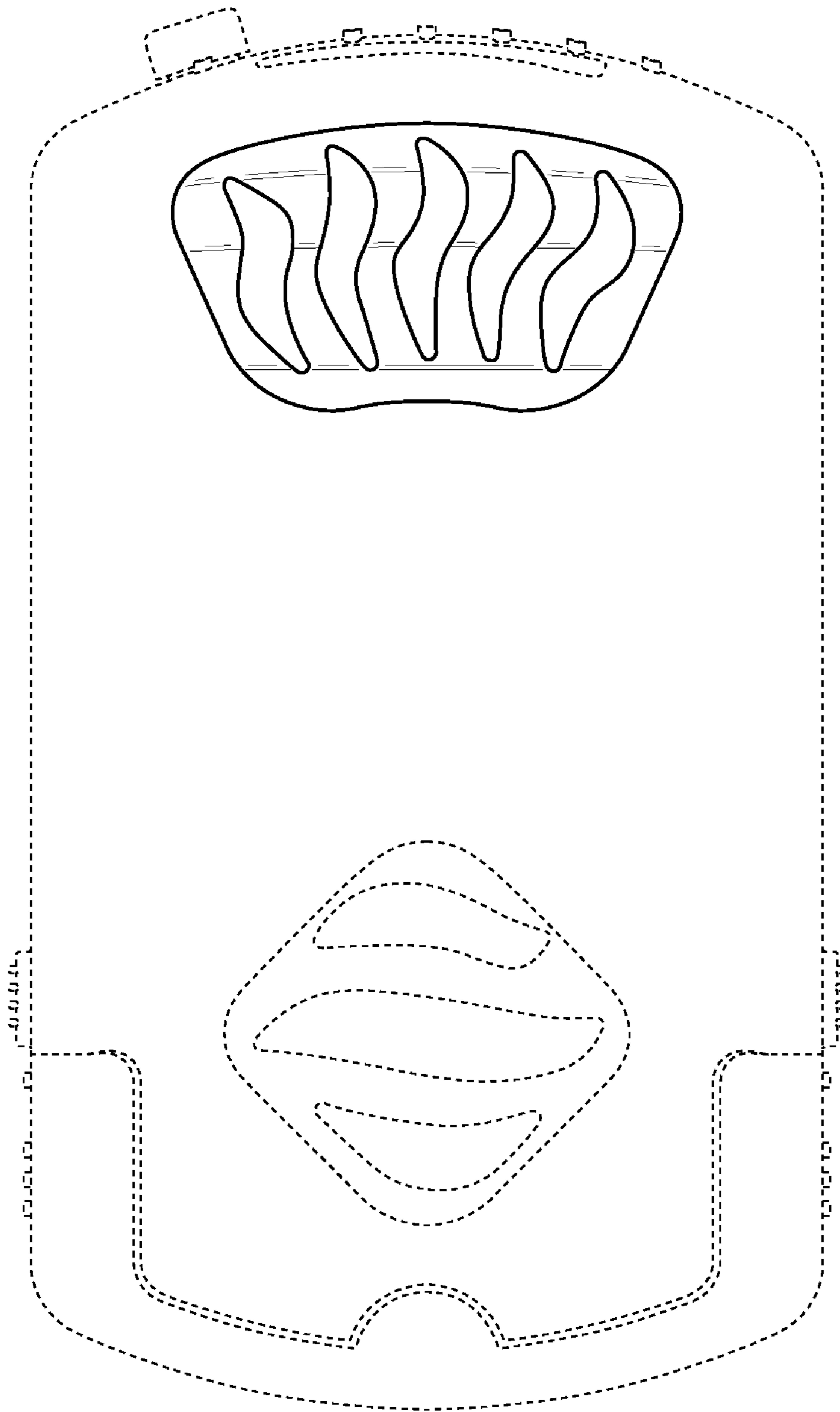

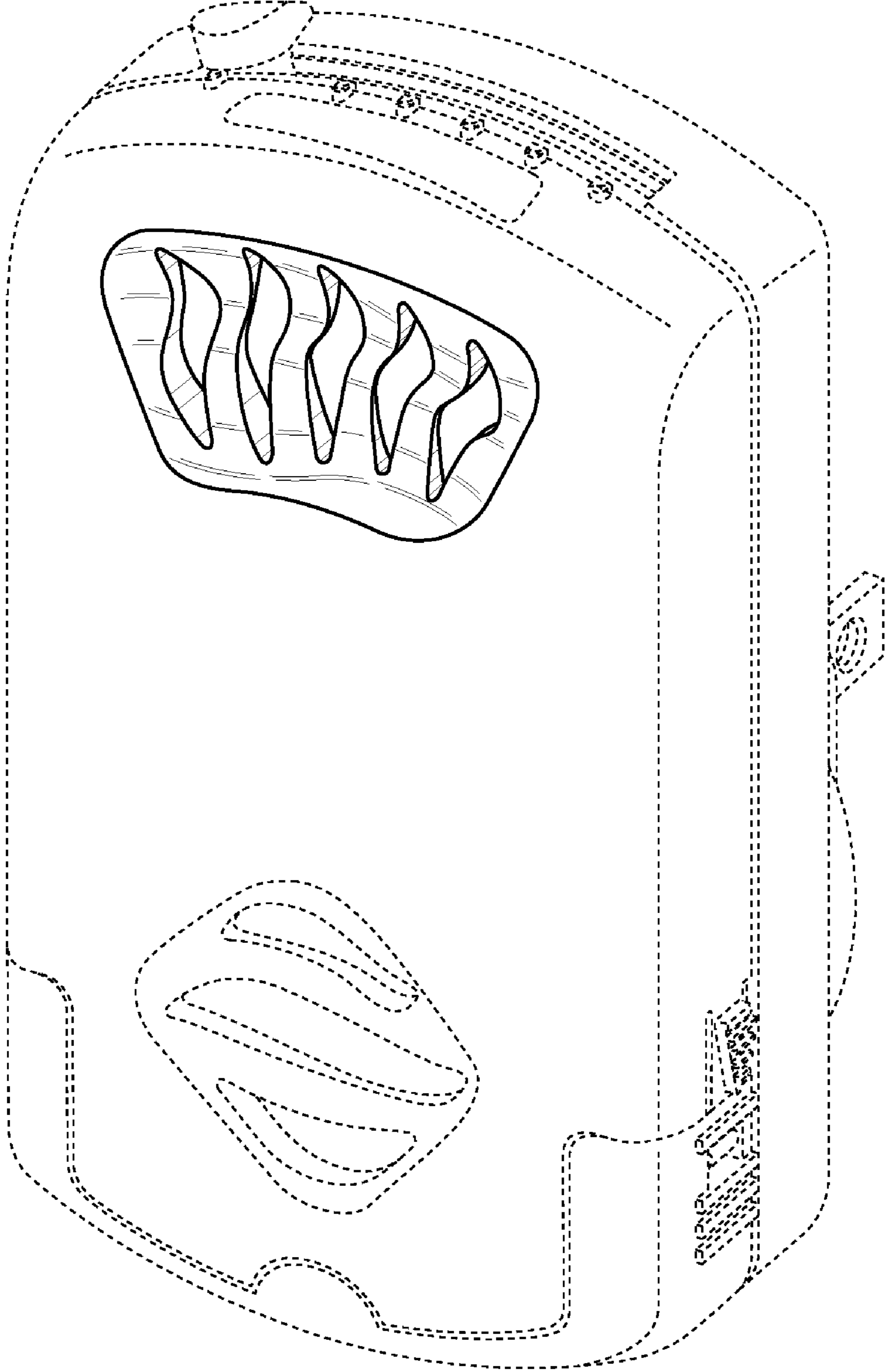

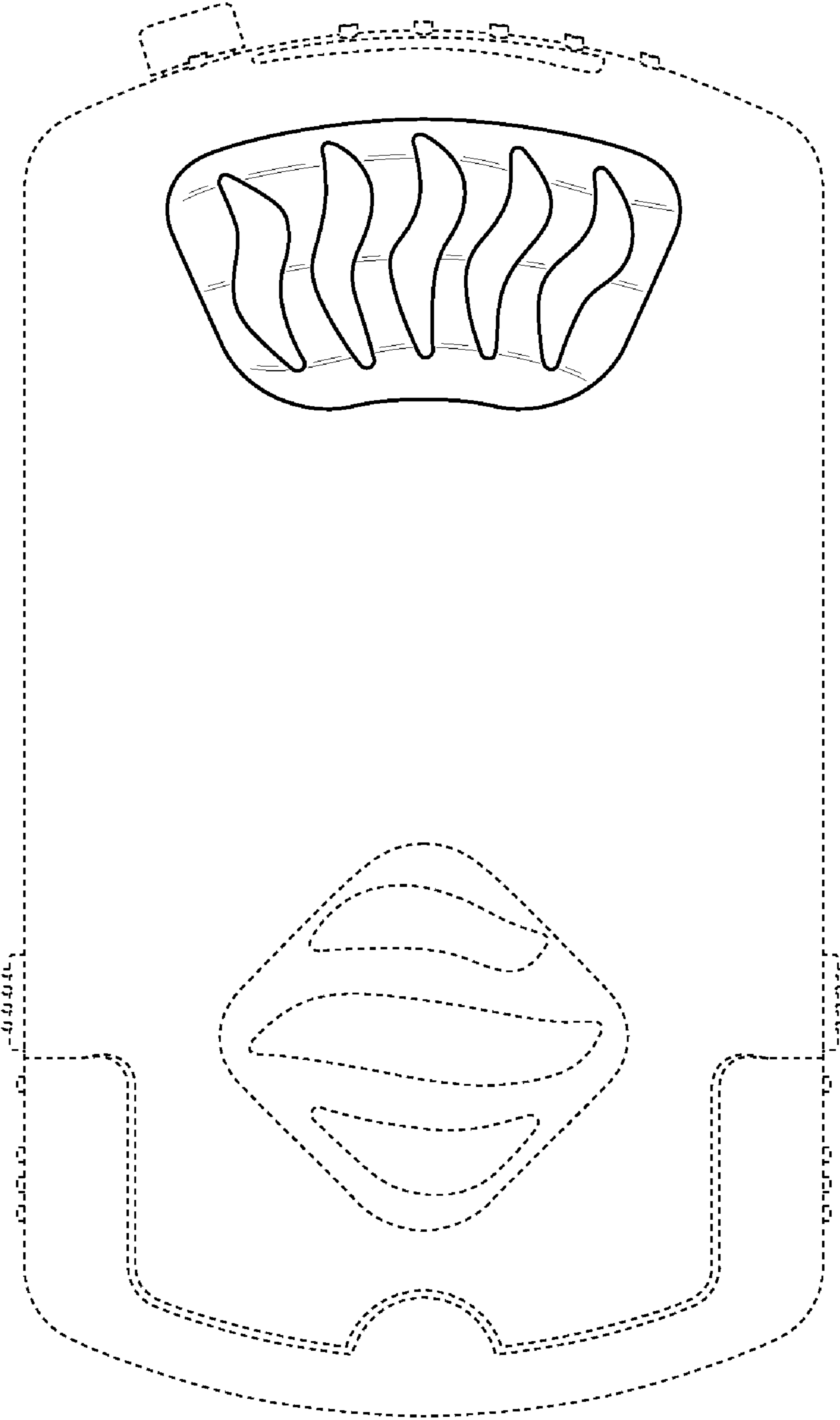

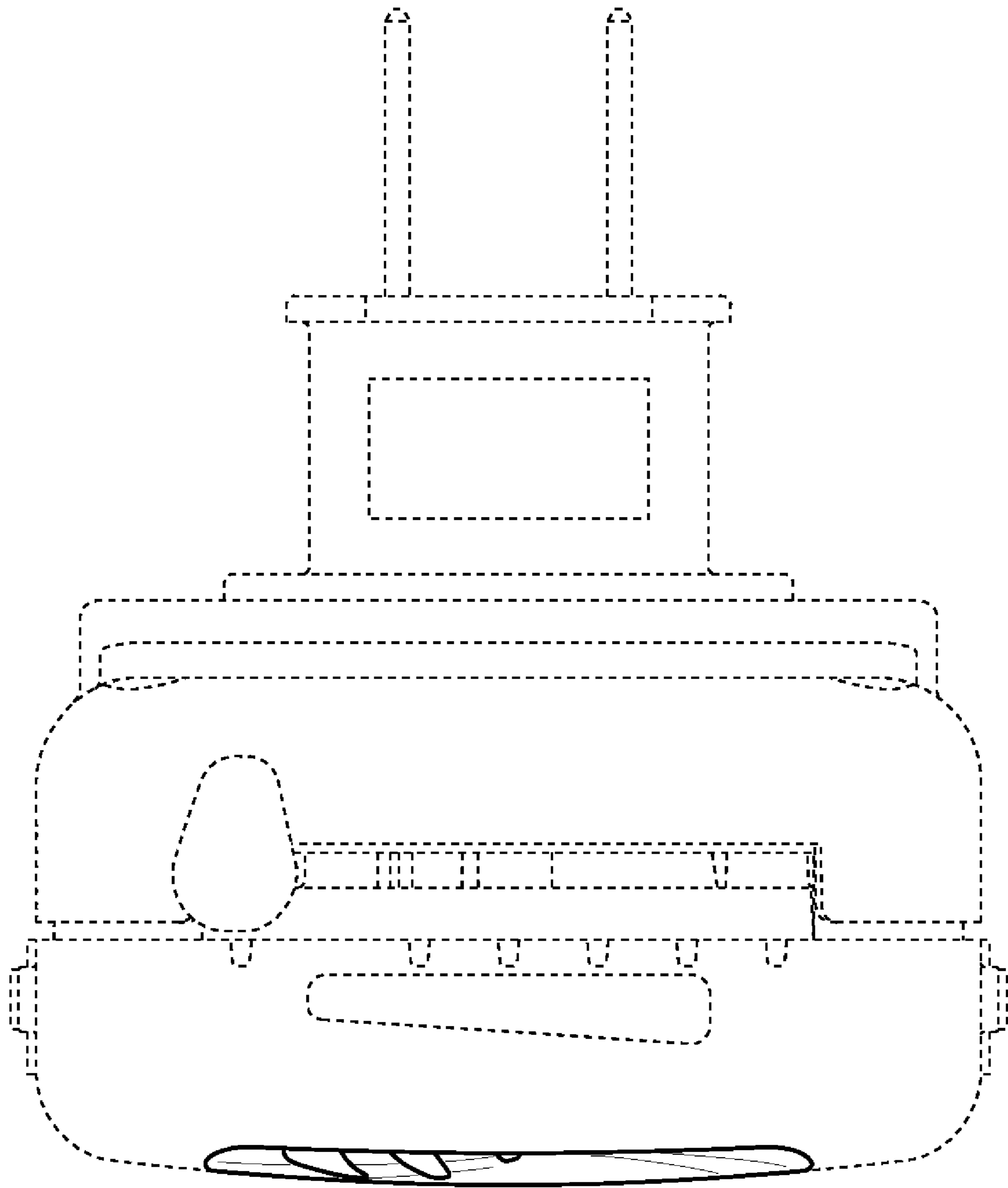

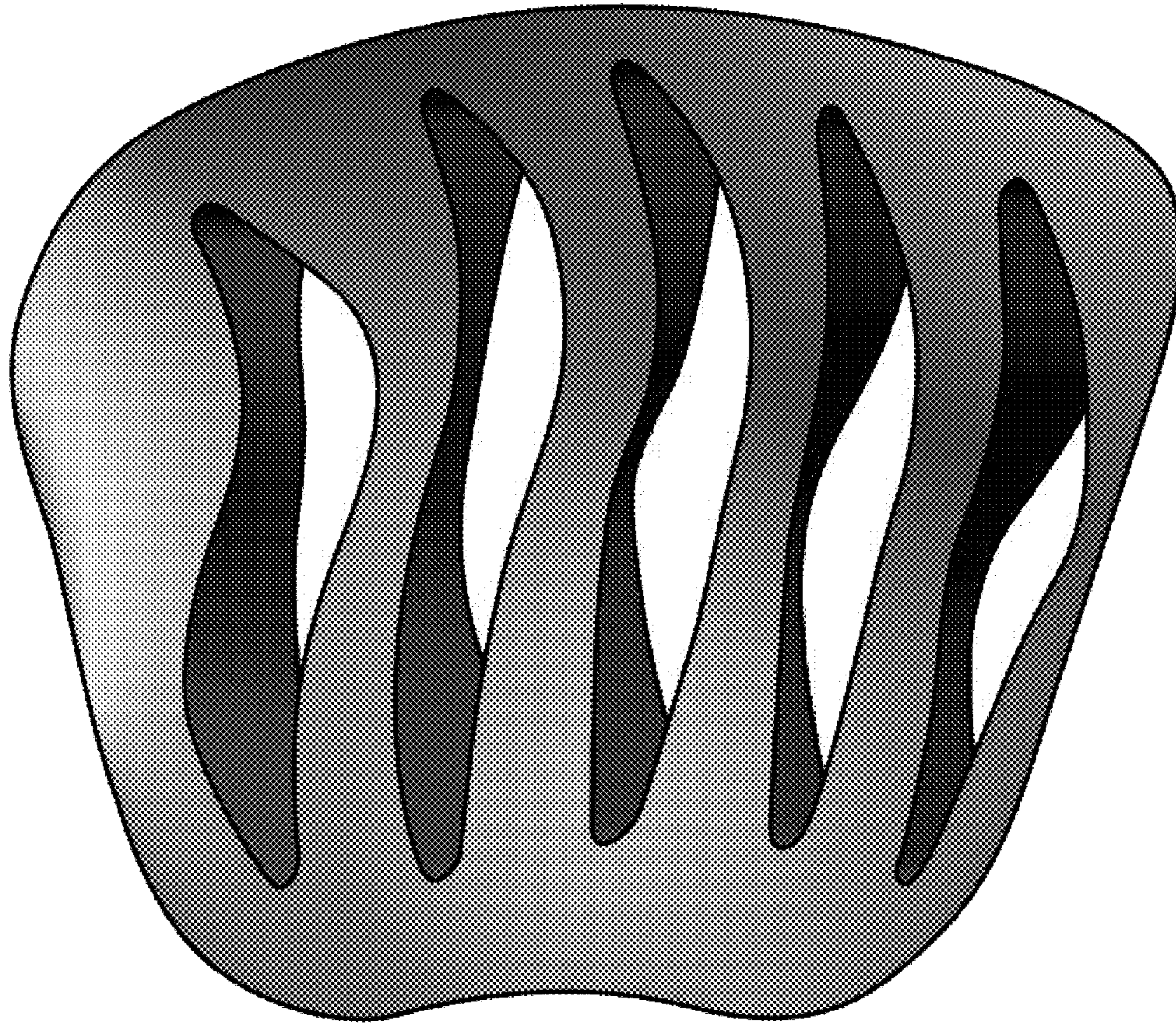

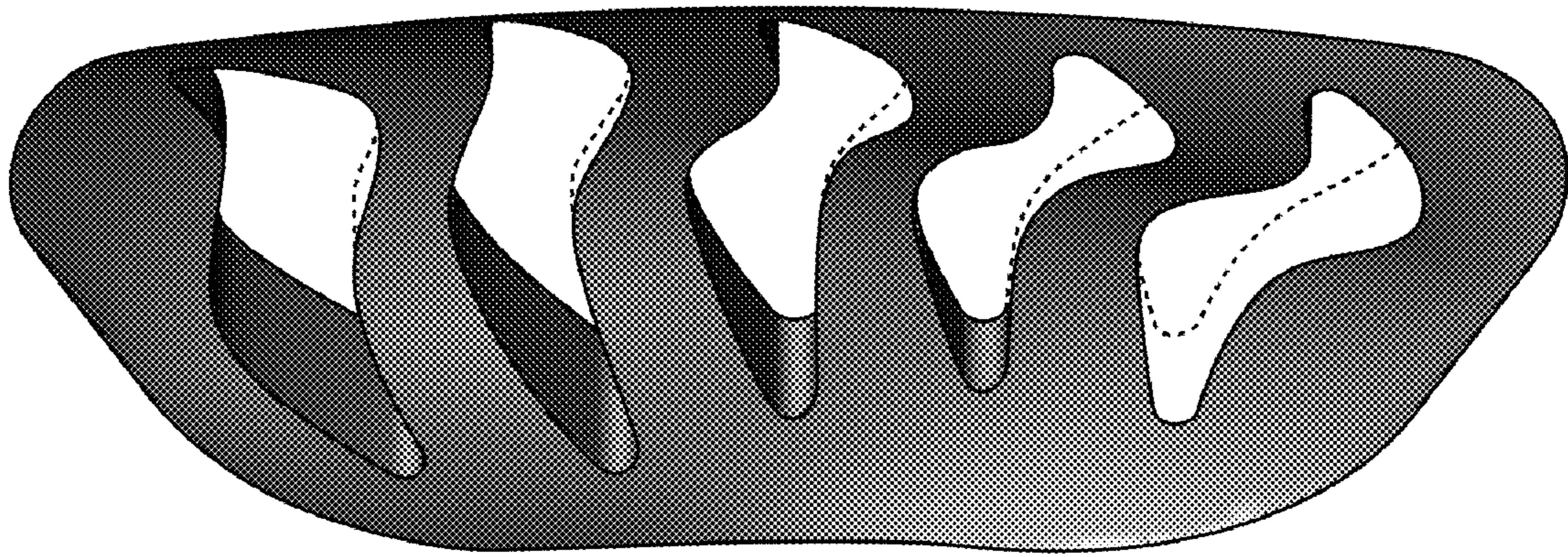

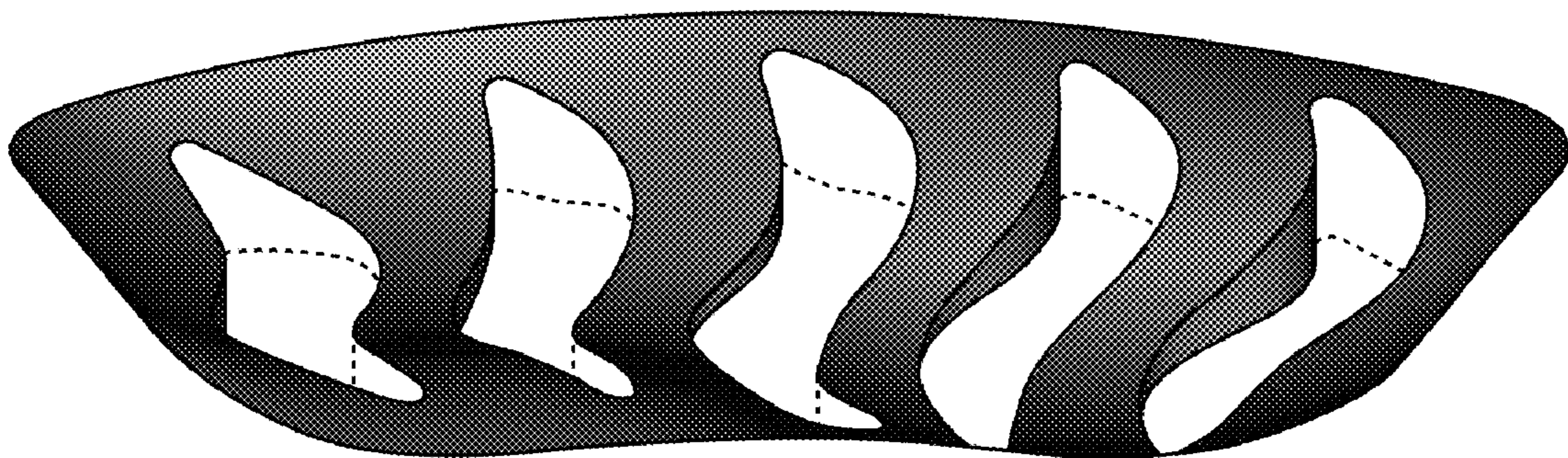
