FIG. 4 is a left side view of the garment of FIG. 1;

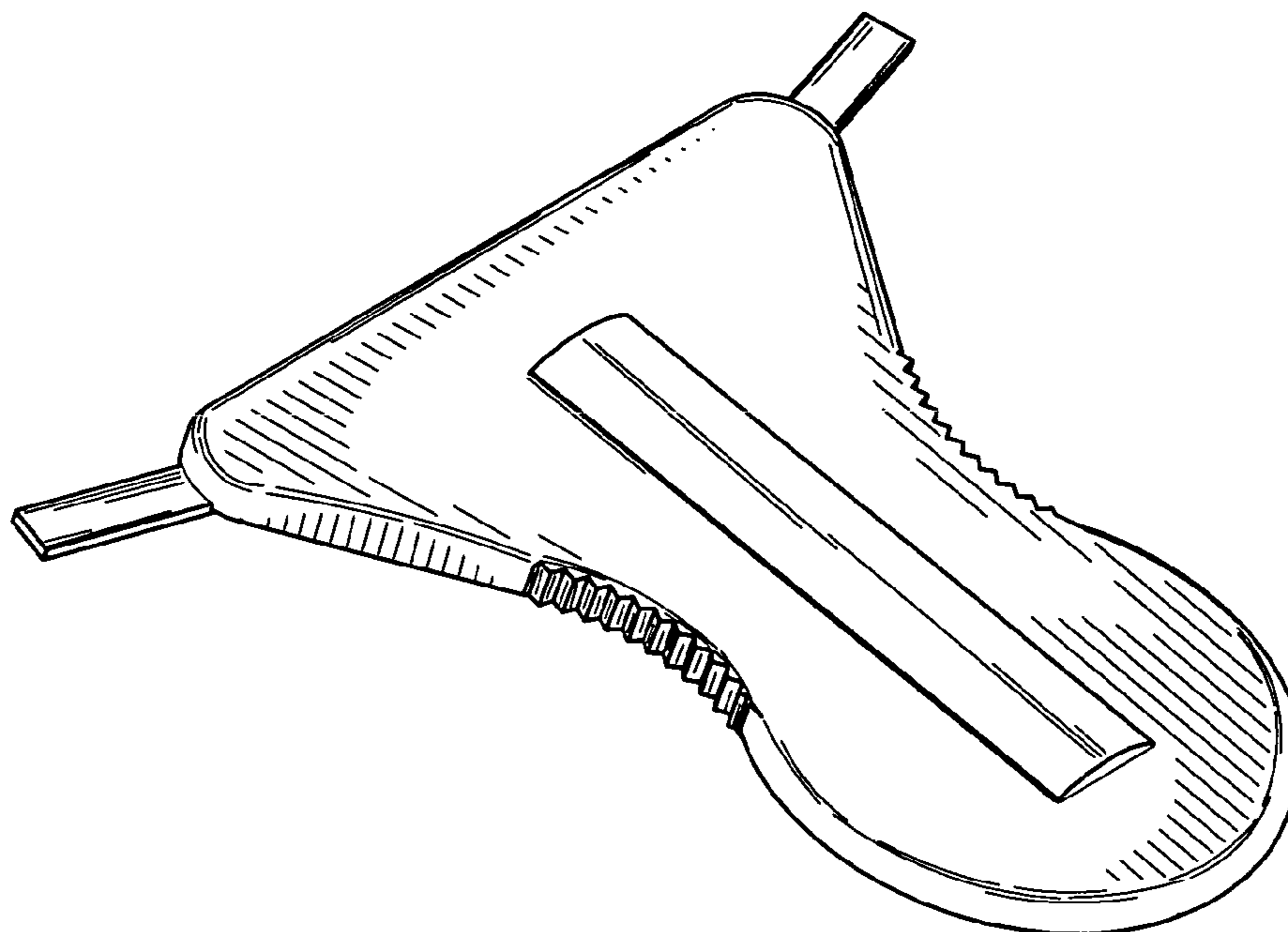
FIG. 5 is a front view of the garment of FIG. 1;

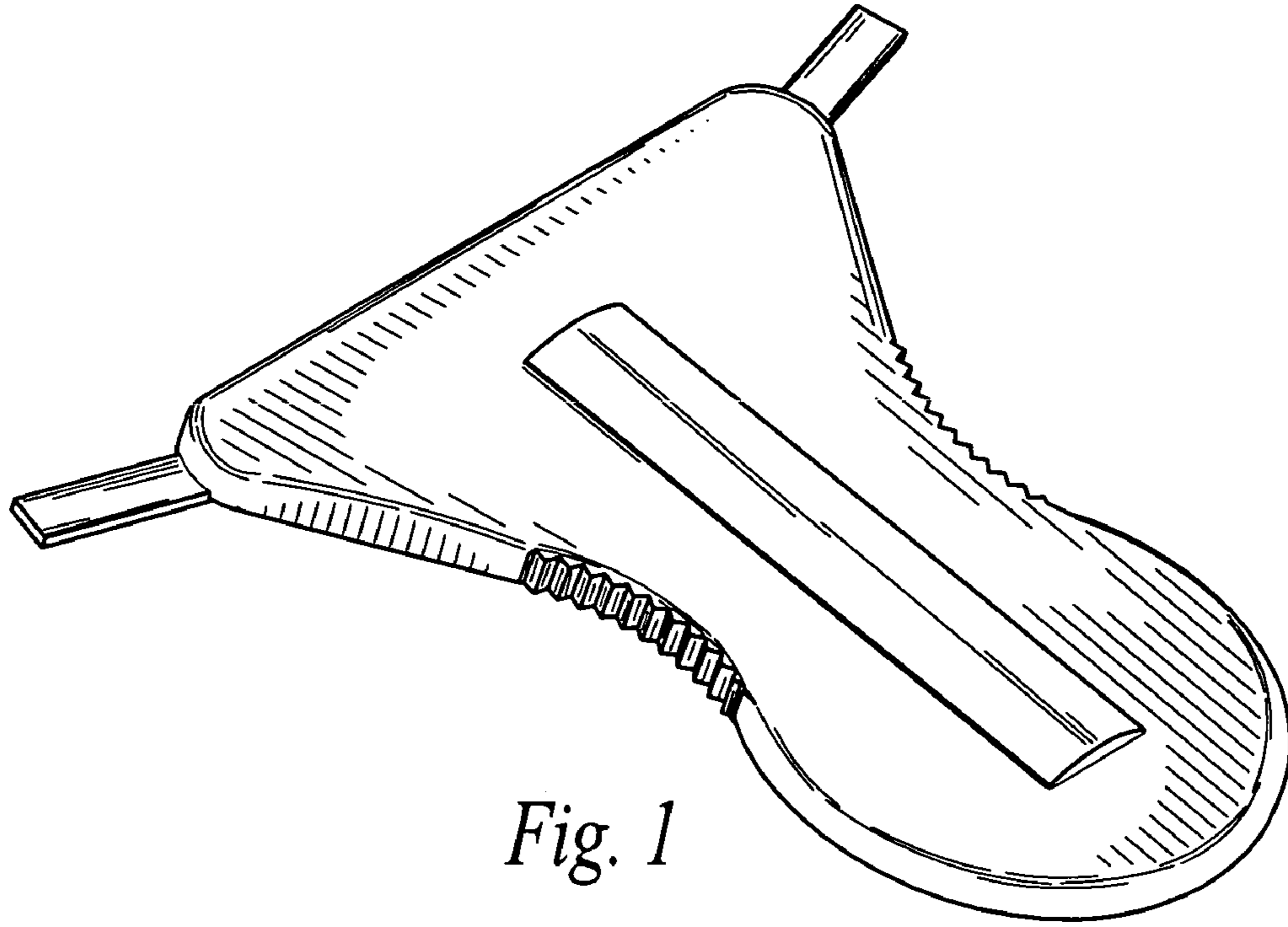

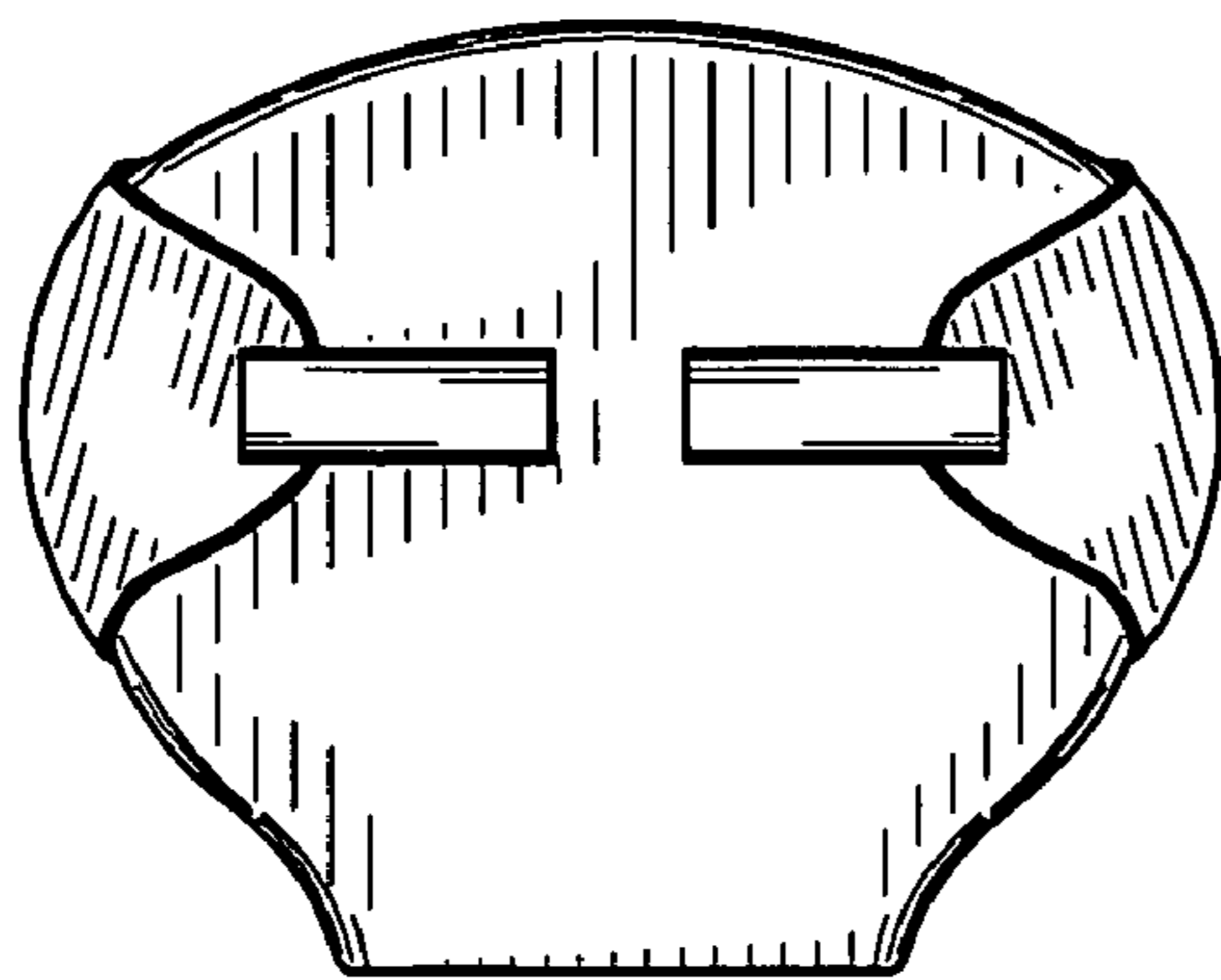

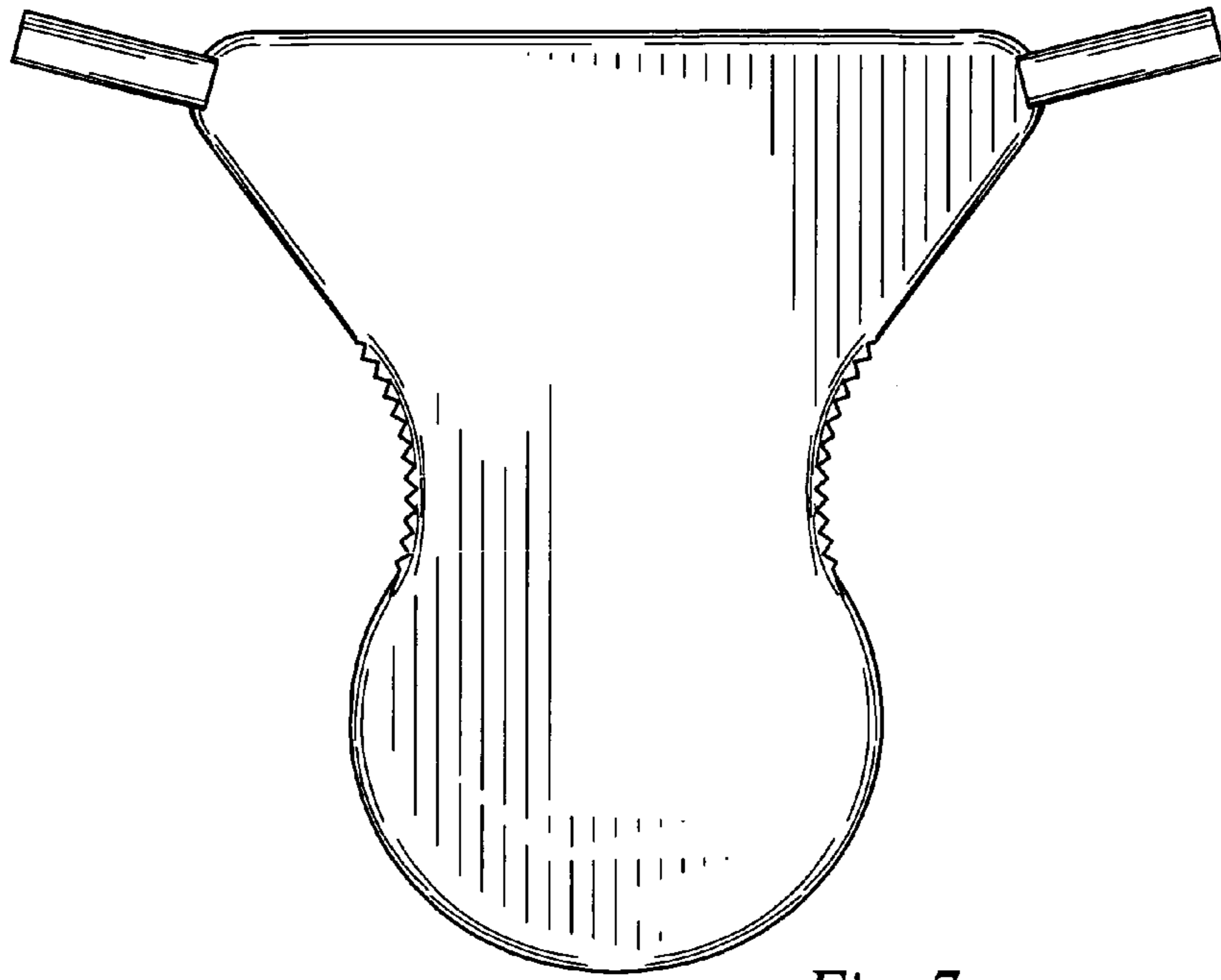

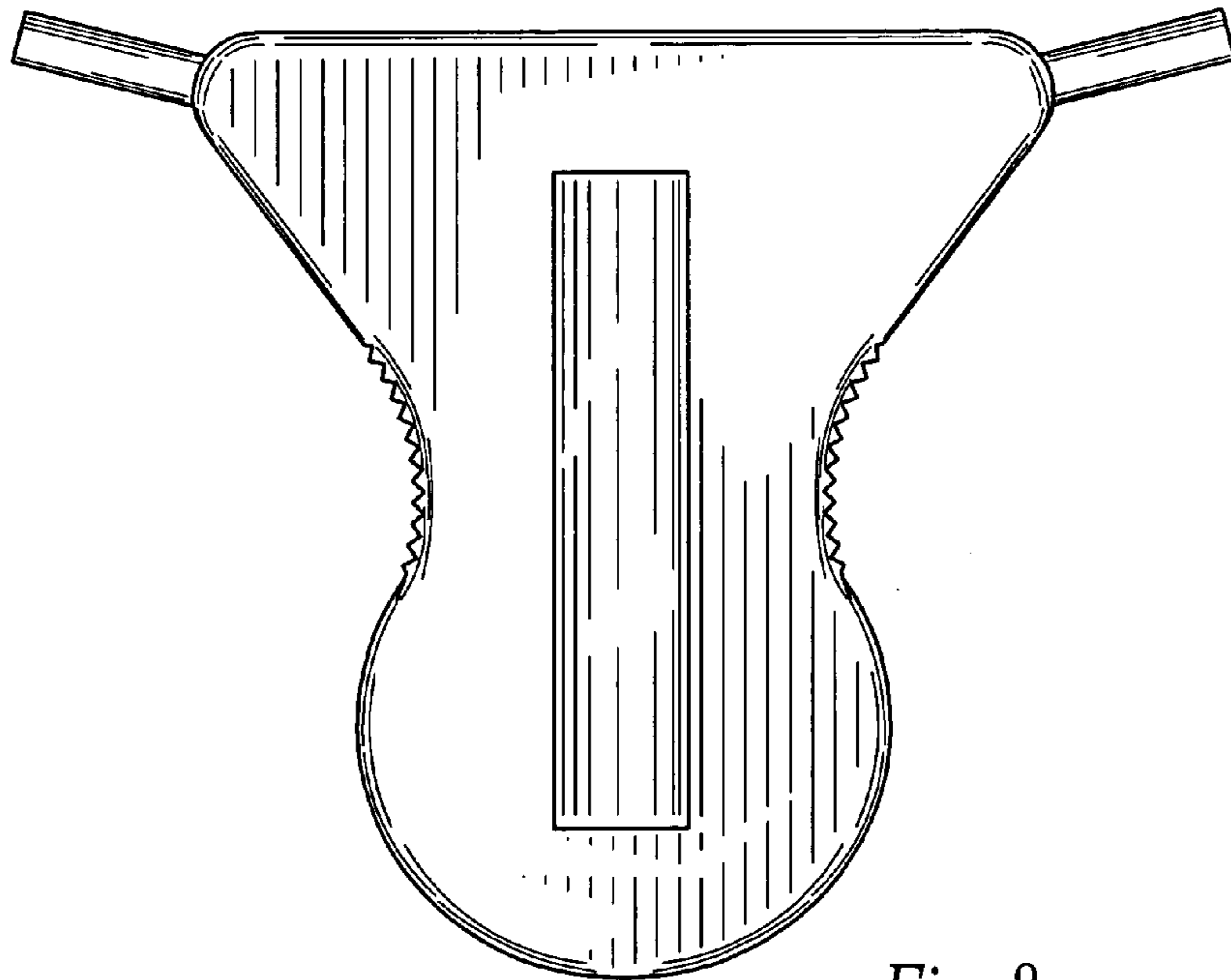
