(57) **CLAIM**

The ornamental design for a pedicure tub side wall, as shown
and described.

DESCRIPTION

FIG. 1 is a perspective view of a pedicure tub side wall,
namely the left side wall, showing our new design;

FIG. 2 is a front elevational view of the same;

FIG. 3 is a rear elevational view of the same;

FIG. 4 is a side elevational view of the same;

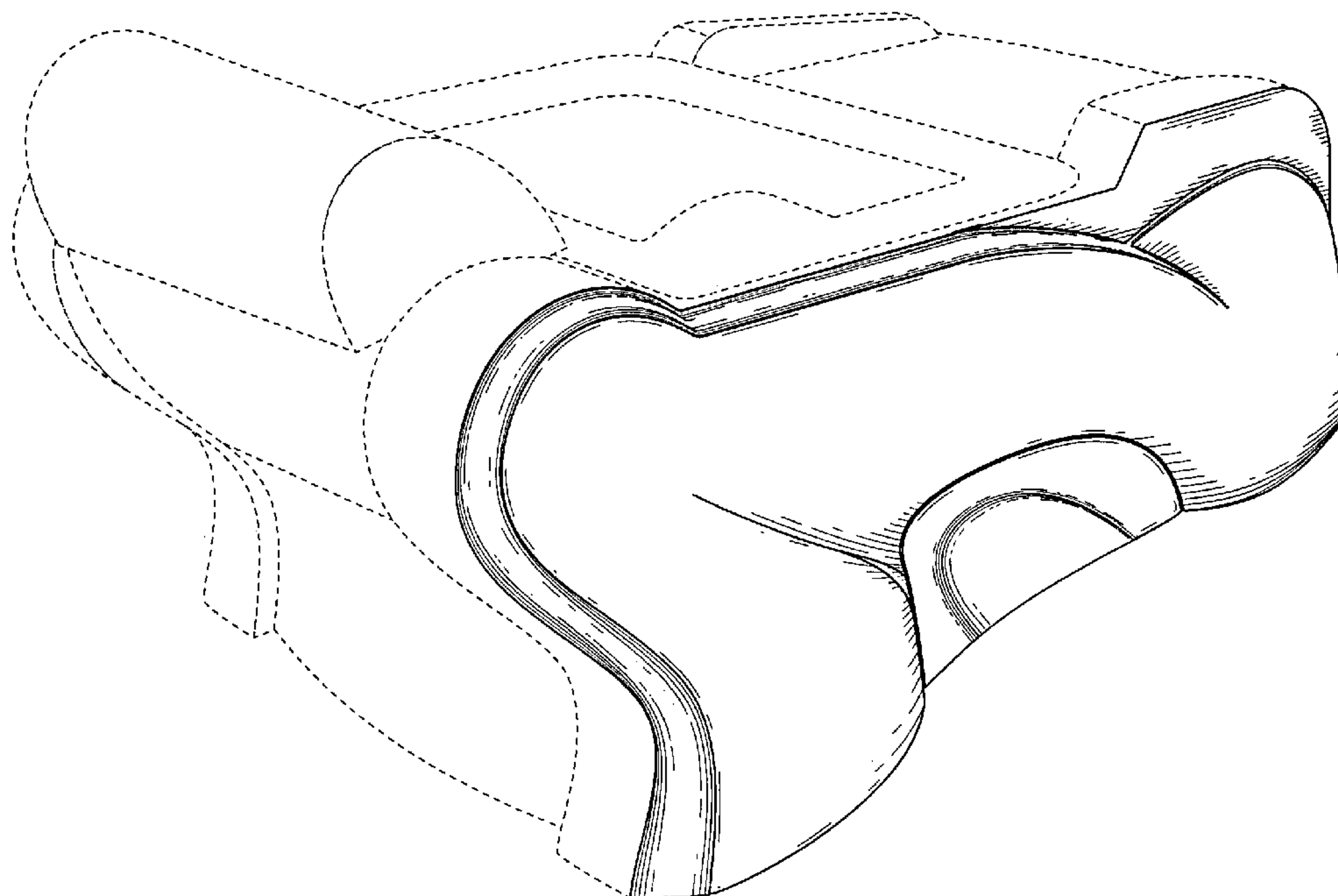
FIG. 5 is a top view of the same;

FIG. 6 is a bottom view of the same; and,

FIG. 7 is a back perspective view of the same.

For the purposes of this application, (1) the left and right sides
of the pedicure tub side wall are mirror images of one another;

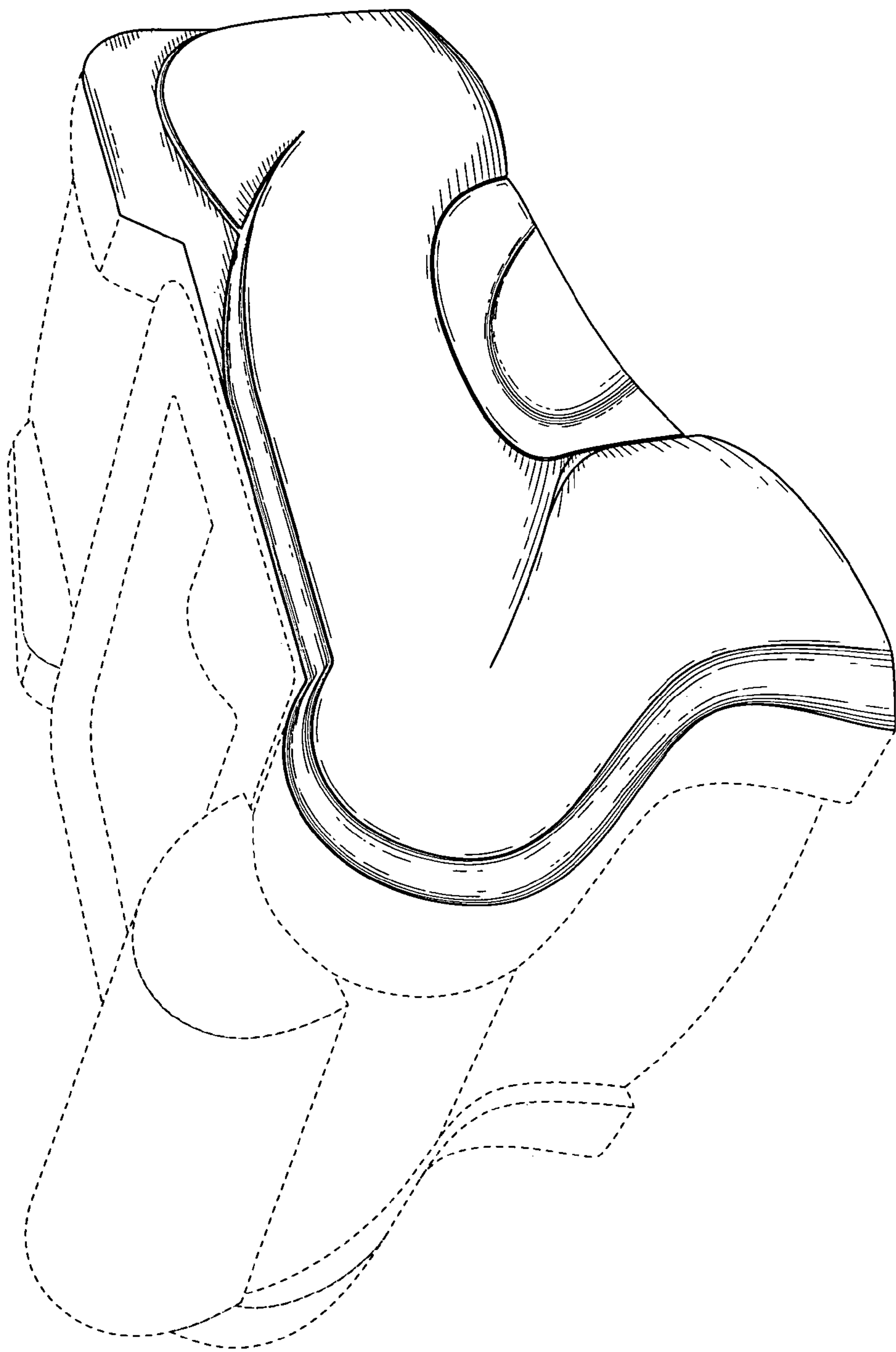

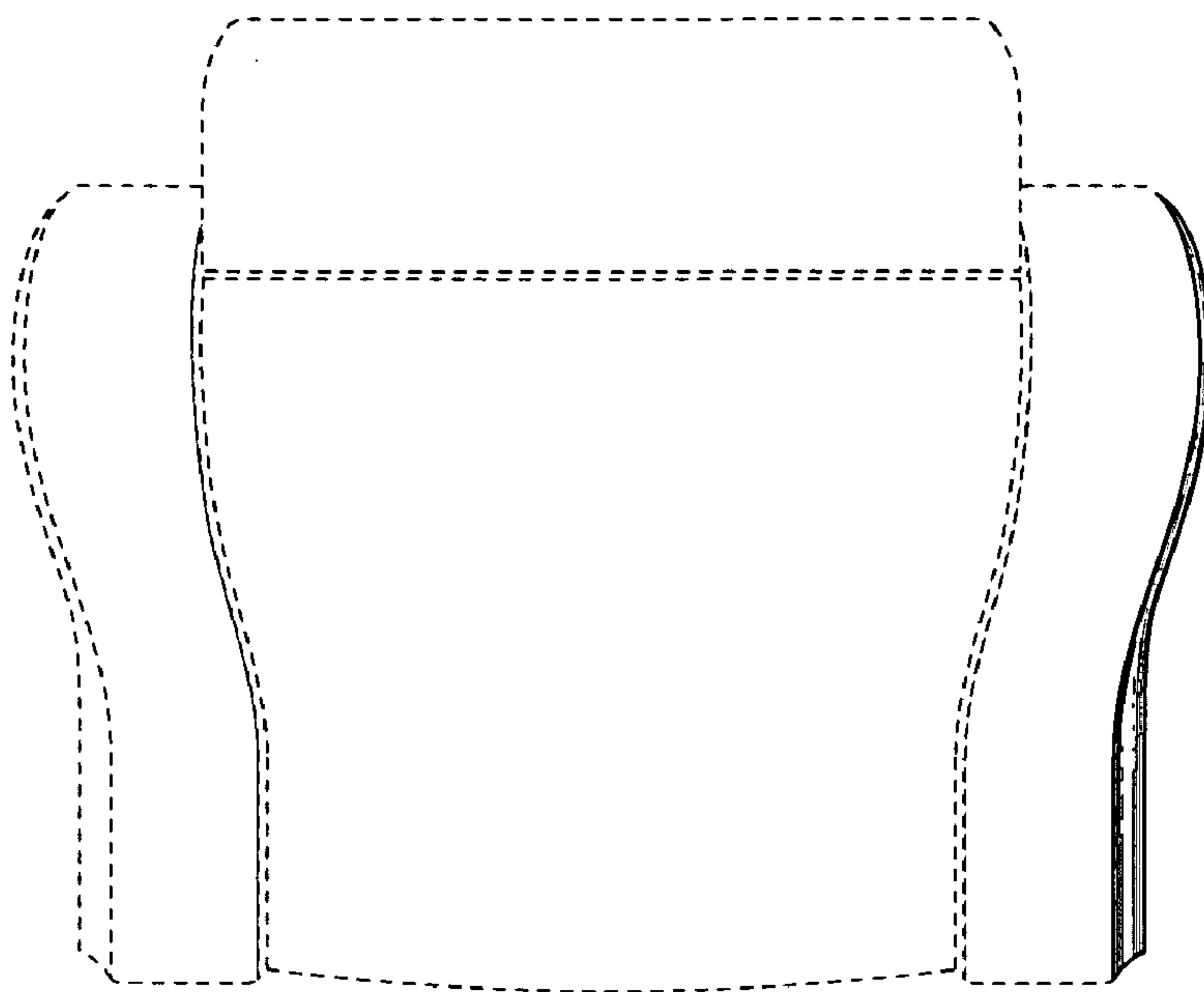

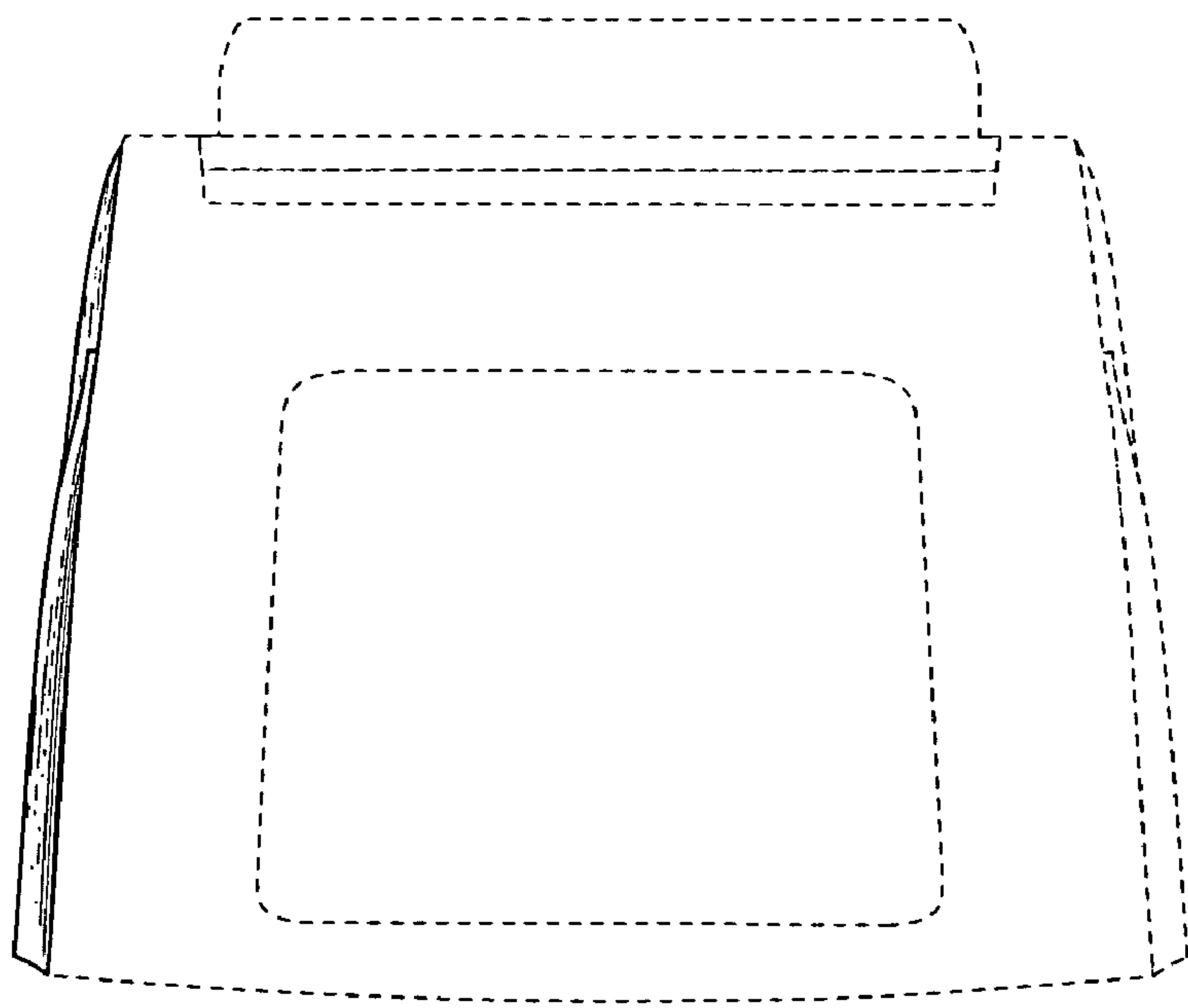

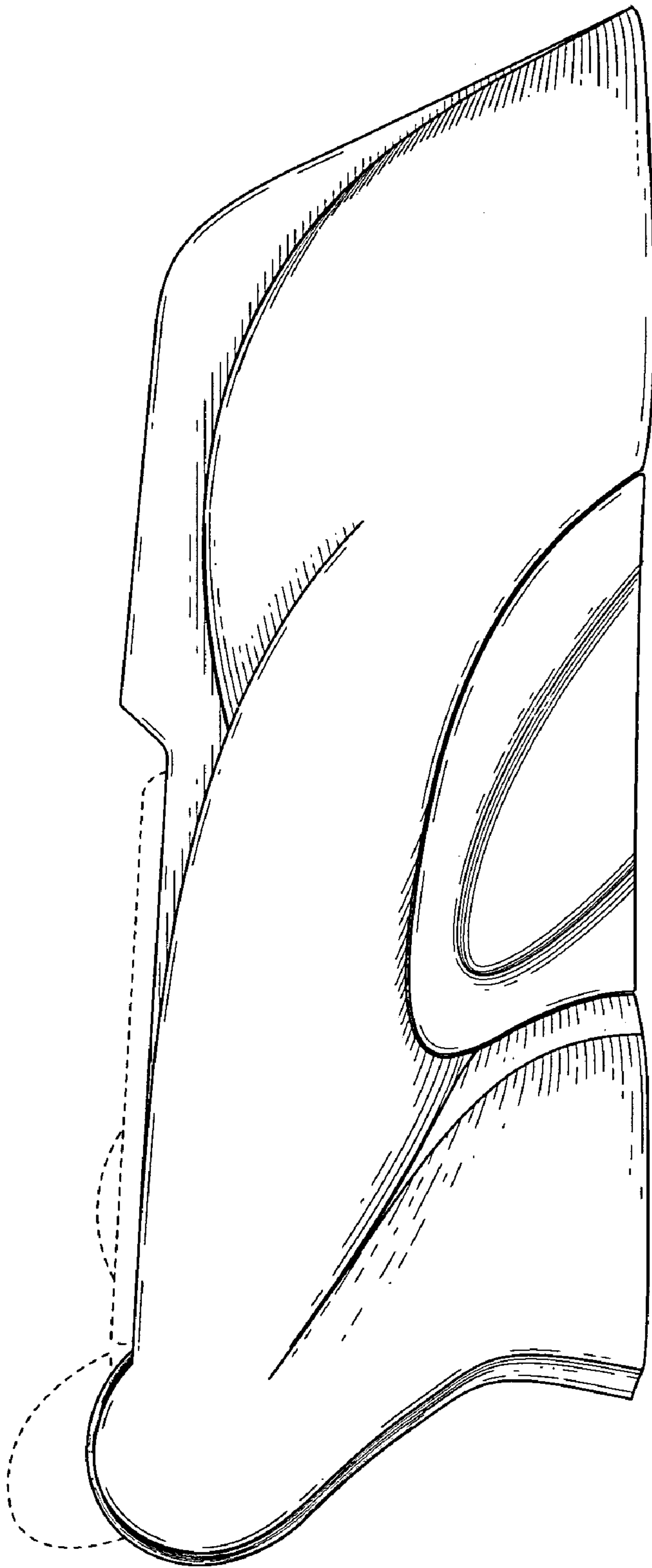

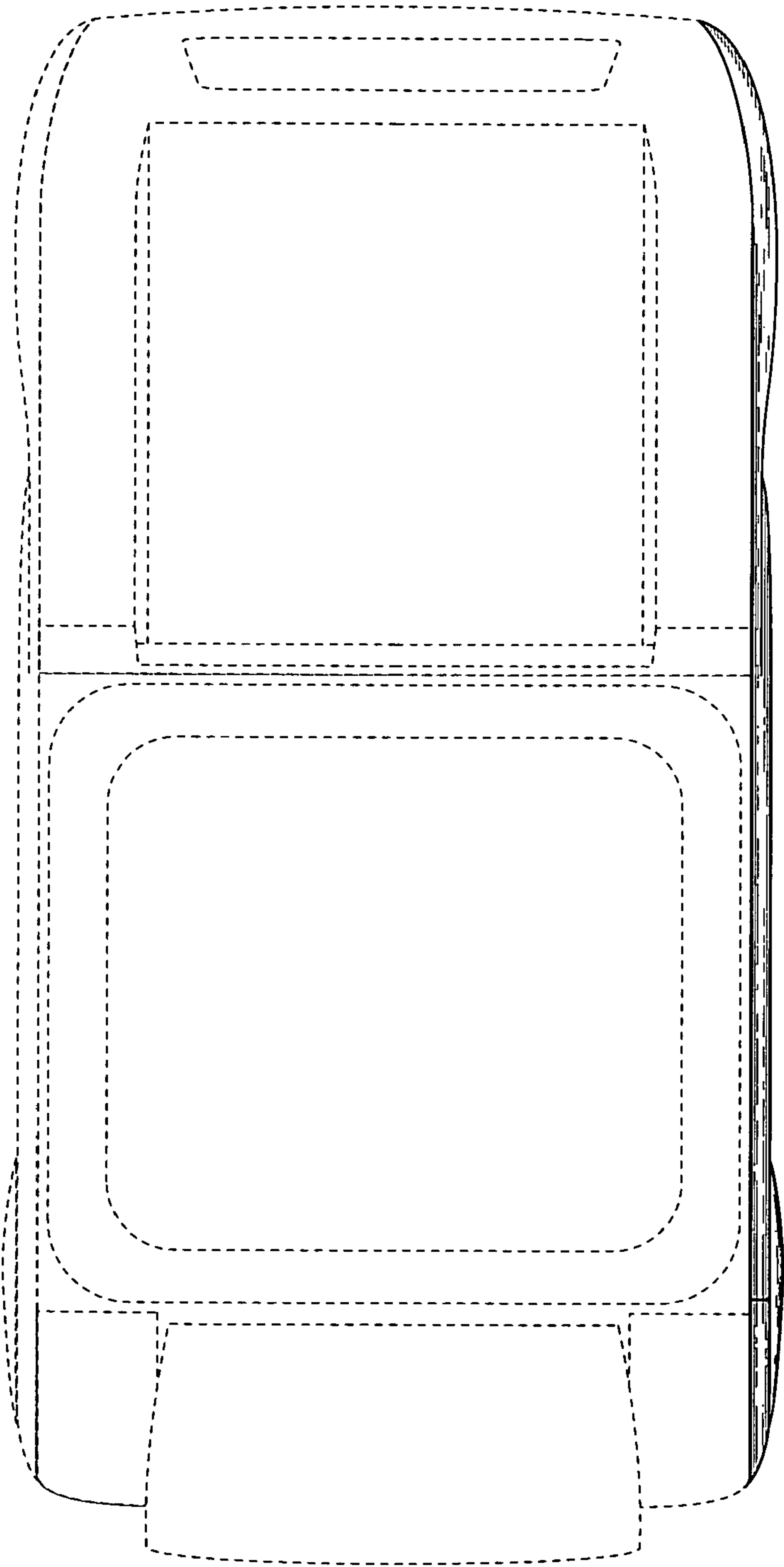

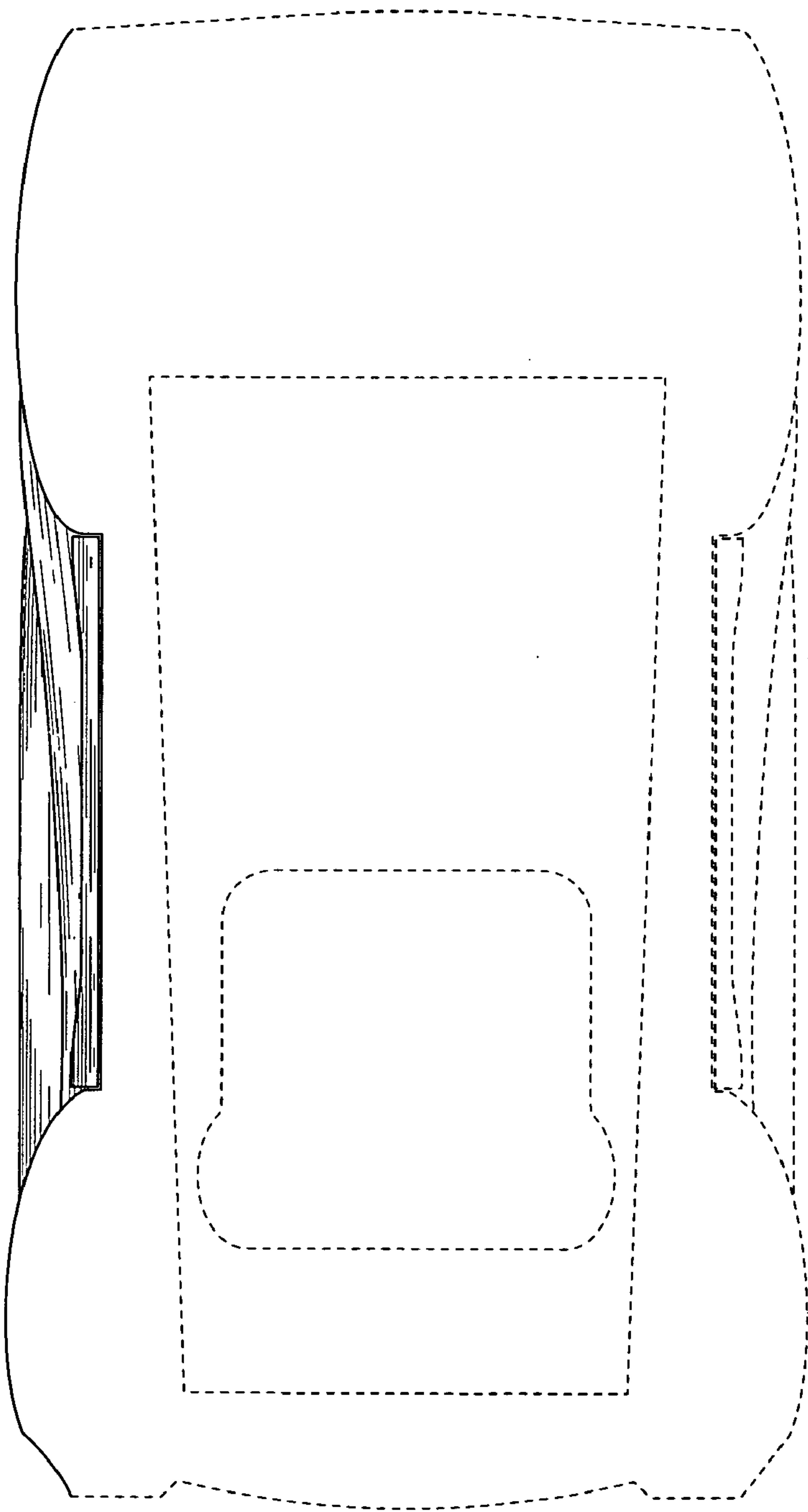

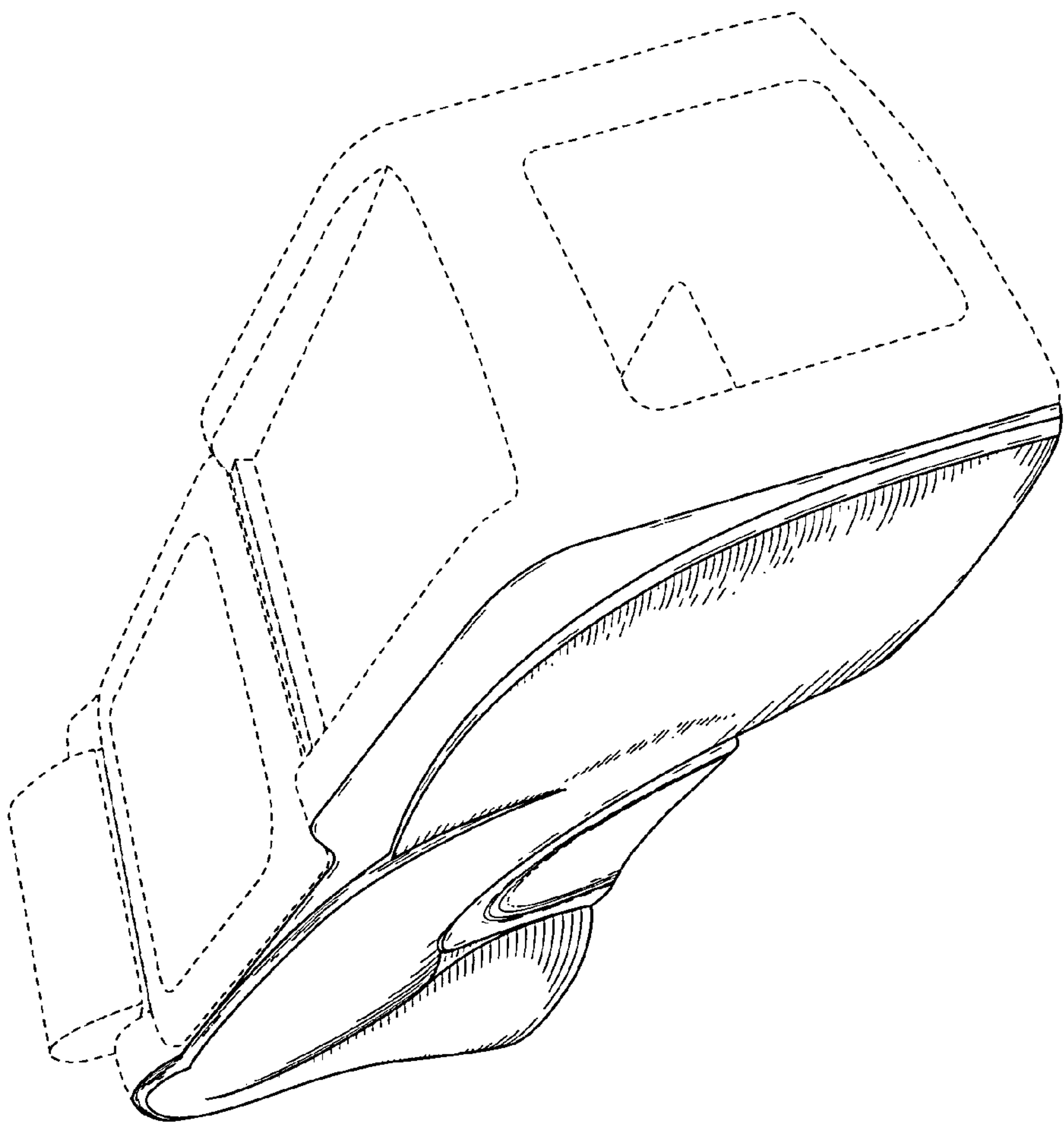
