The ornamental design for an orthodontic patient setup tray, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view showing the new design for an orthodontic patient setup tray;

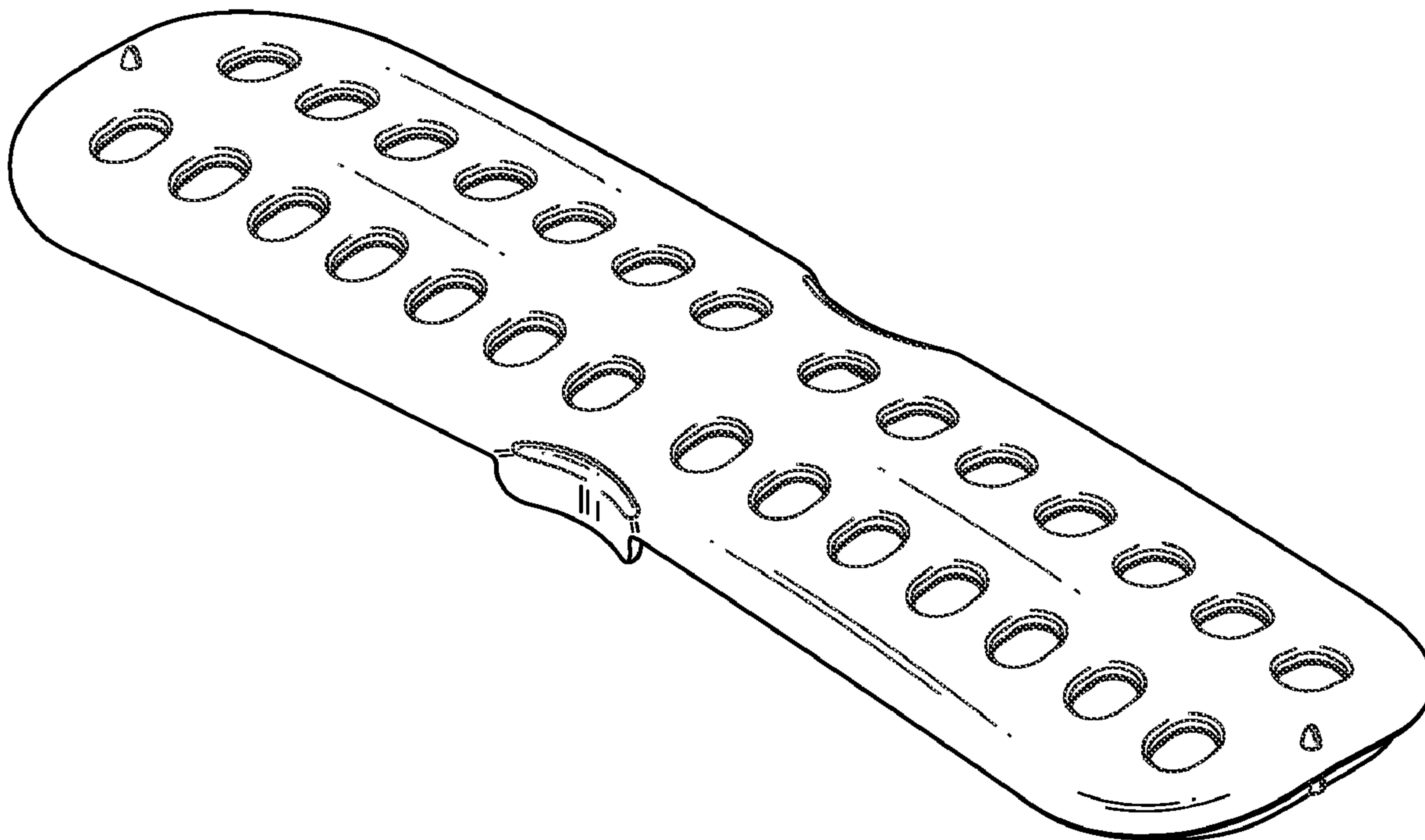
FIG. 2 is a top plan view thereof;

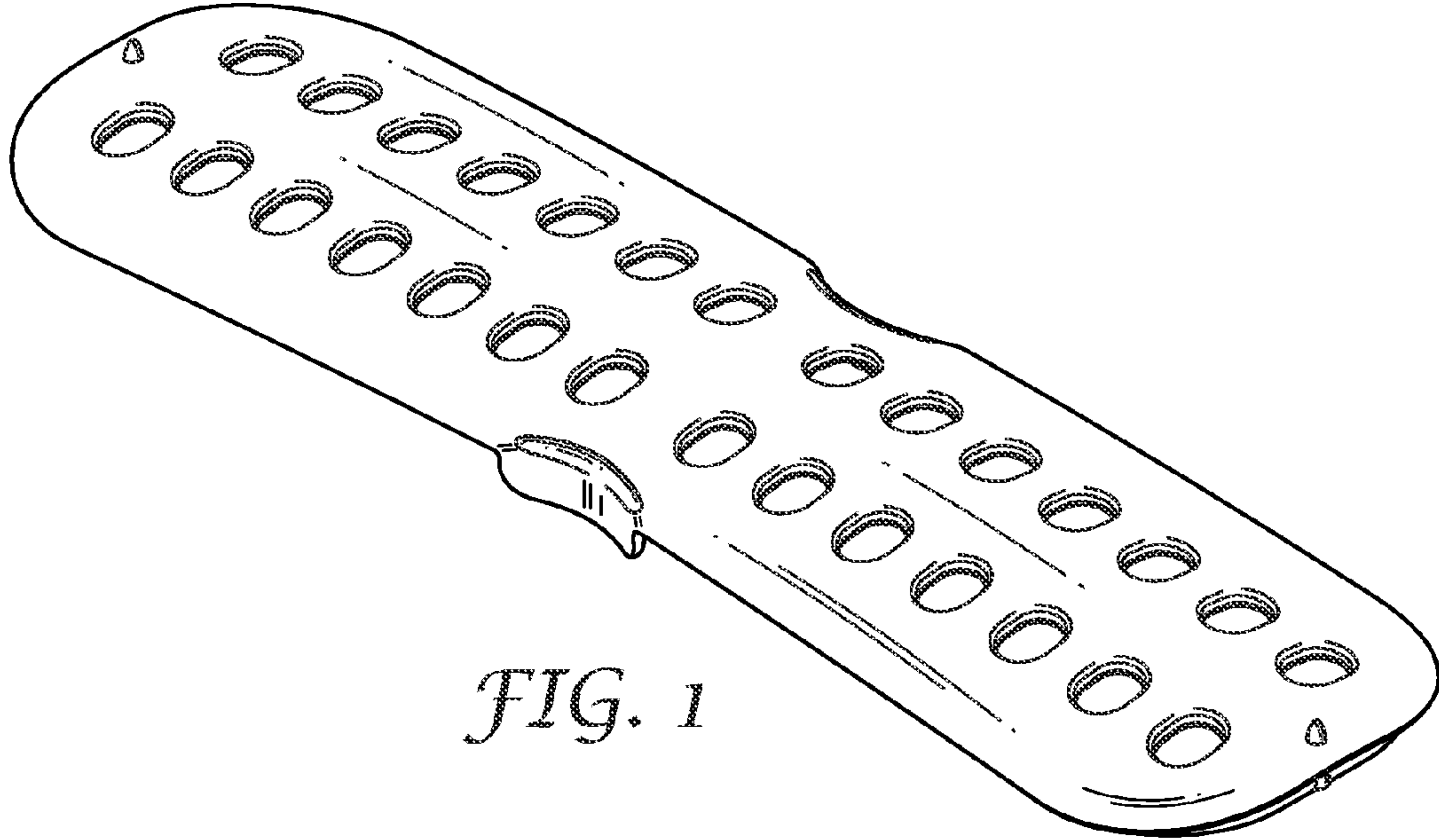

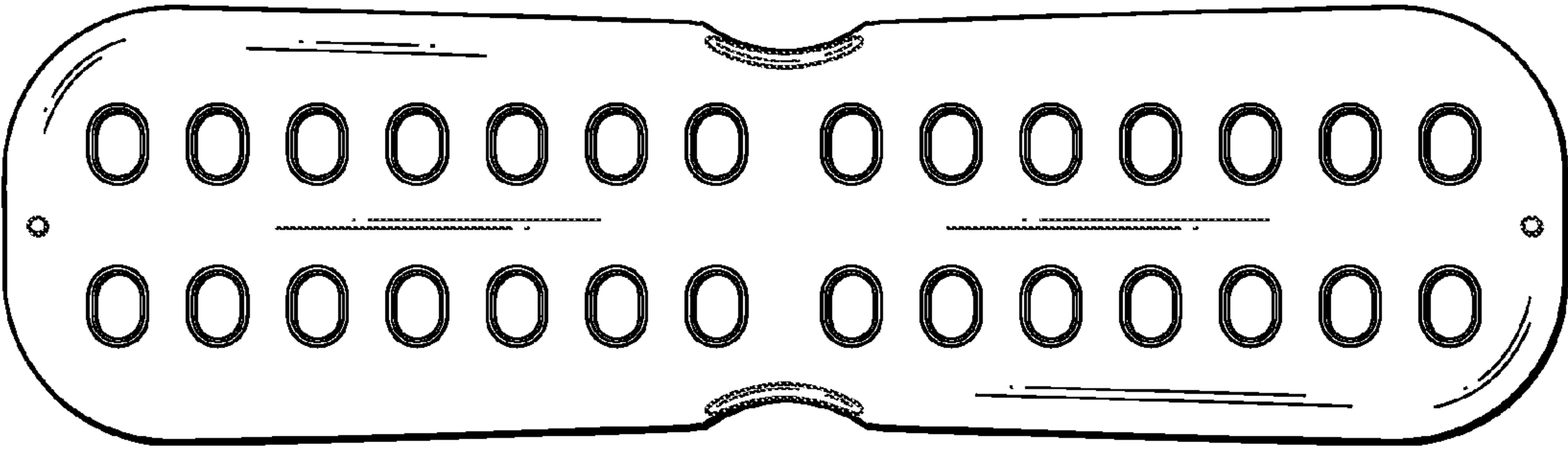

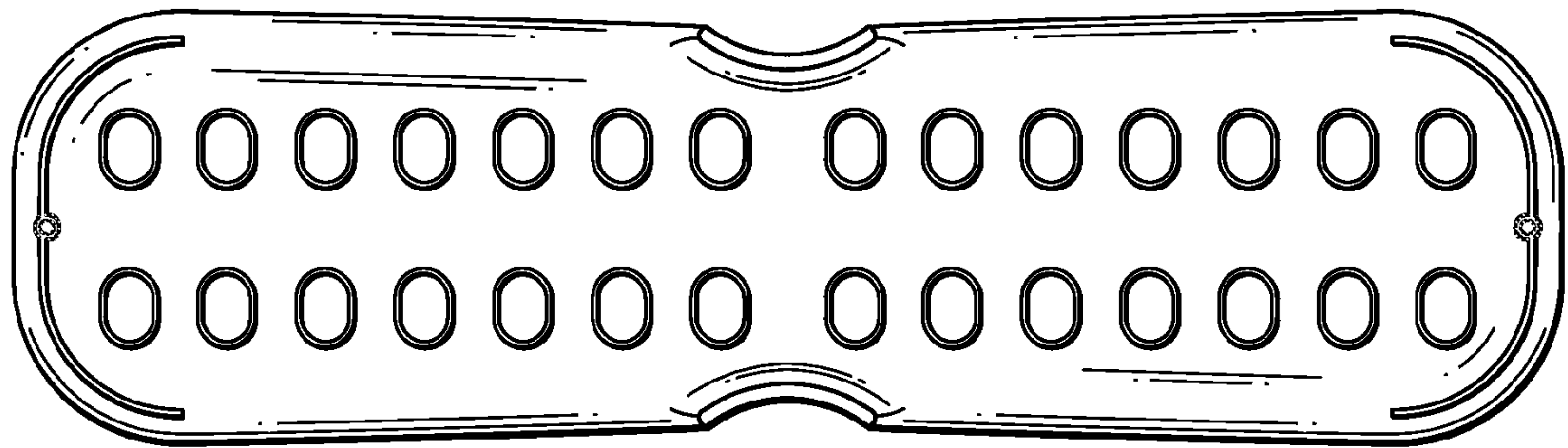

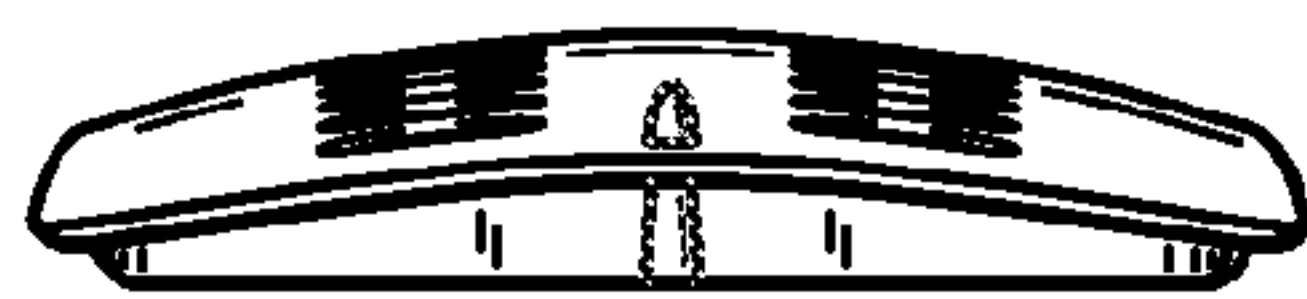
