FIG. 1 is a bottom view of the design for the moist snuff refill cartridge;

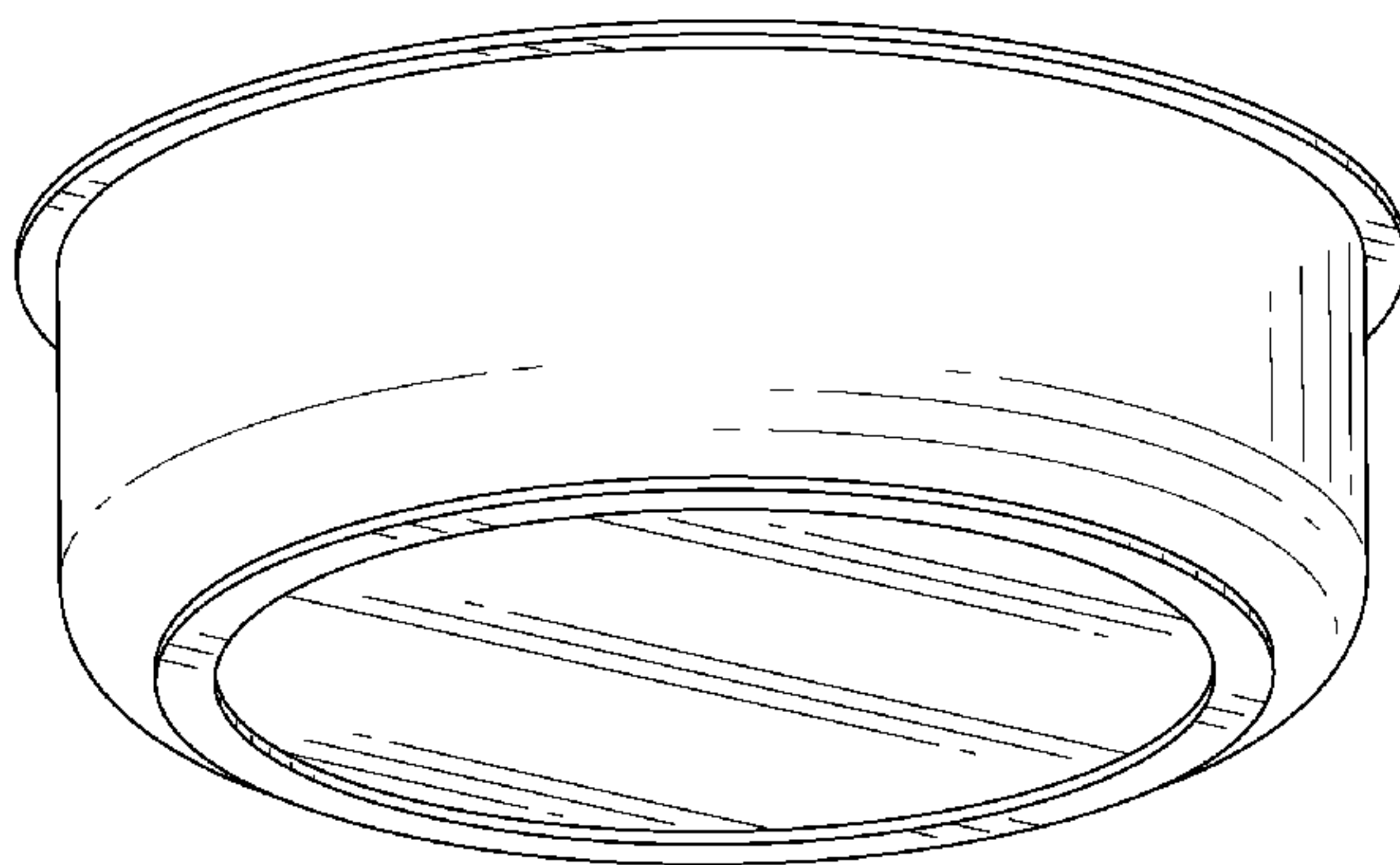
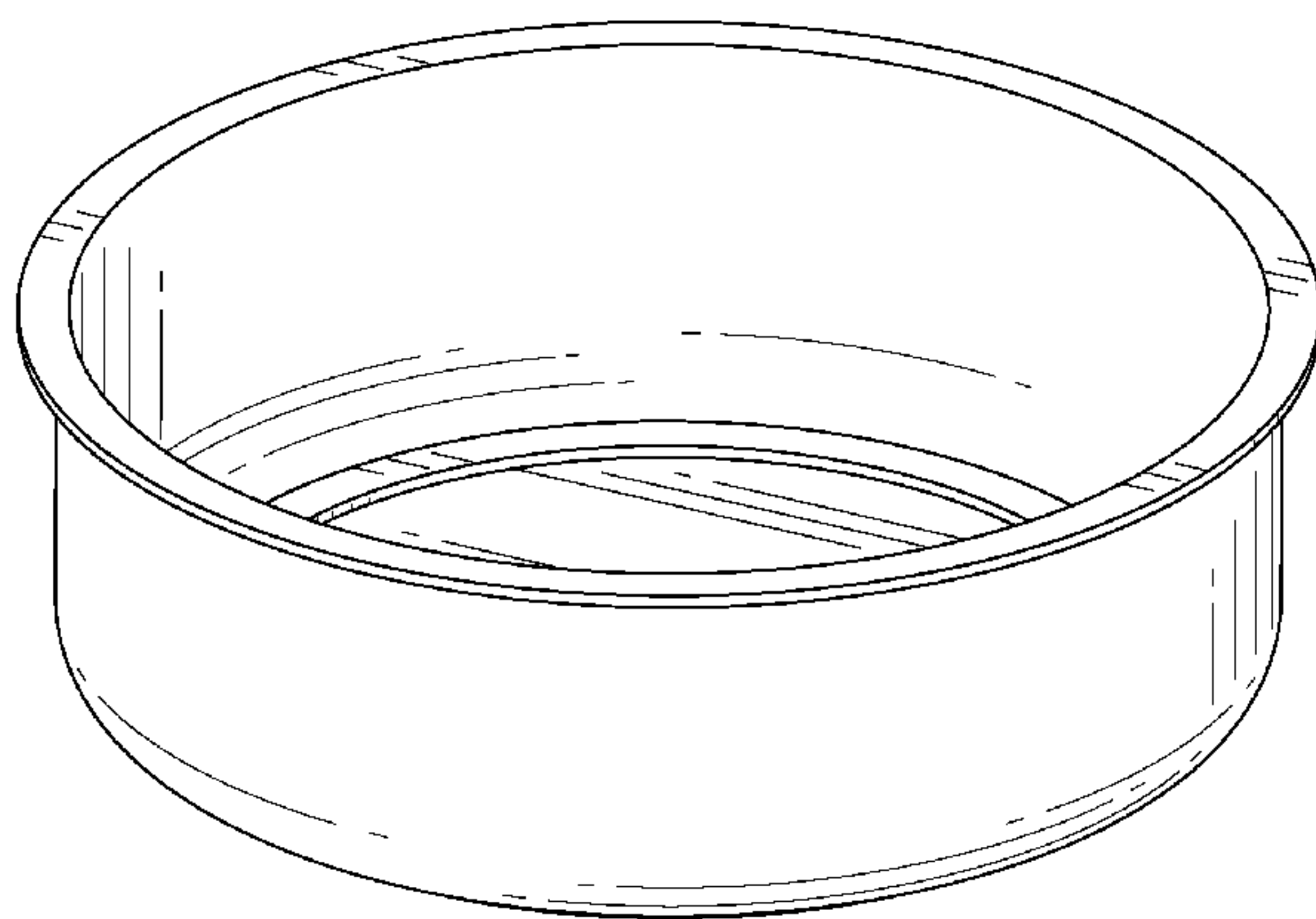
FIG. 2 is a top view of the design of the present invention;

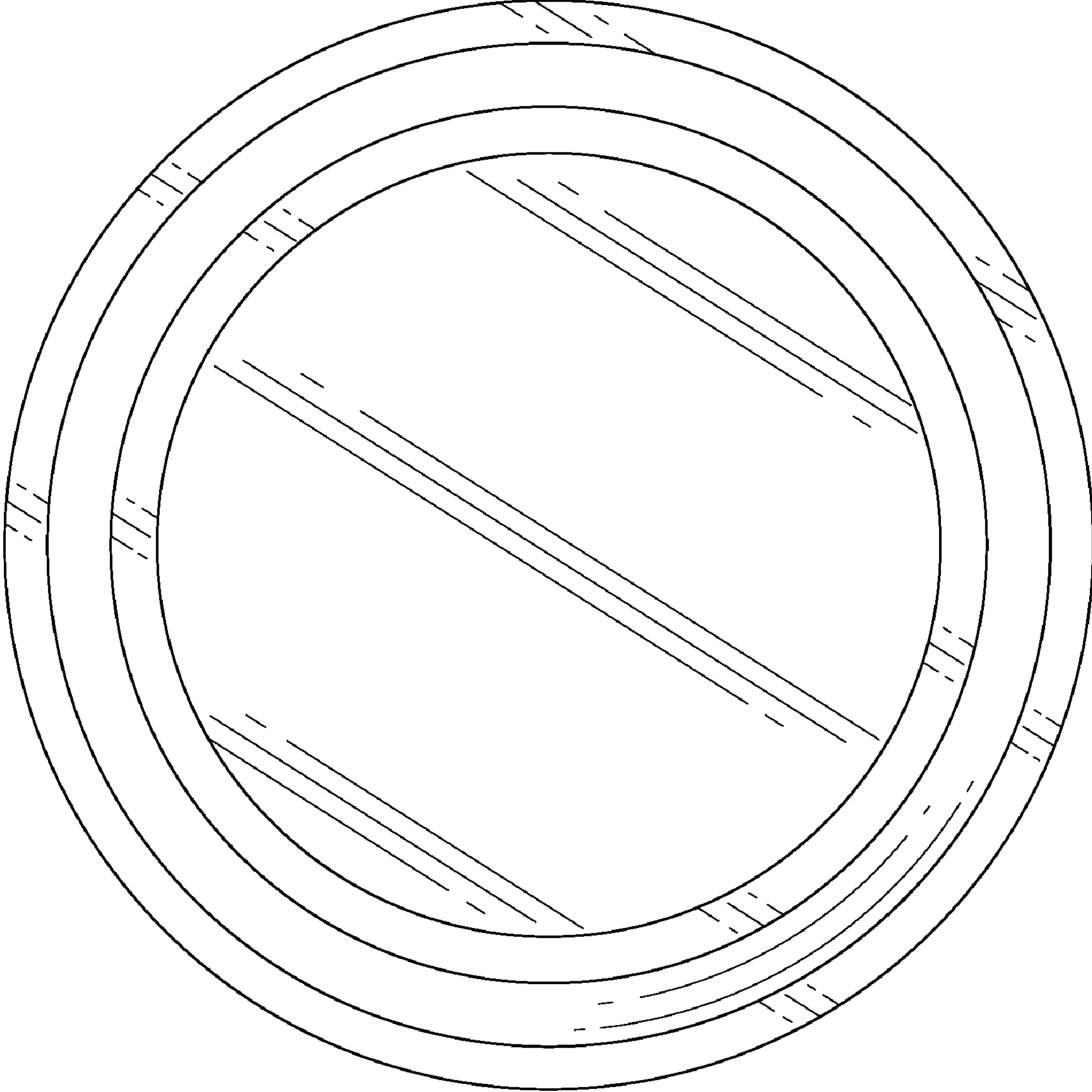

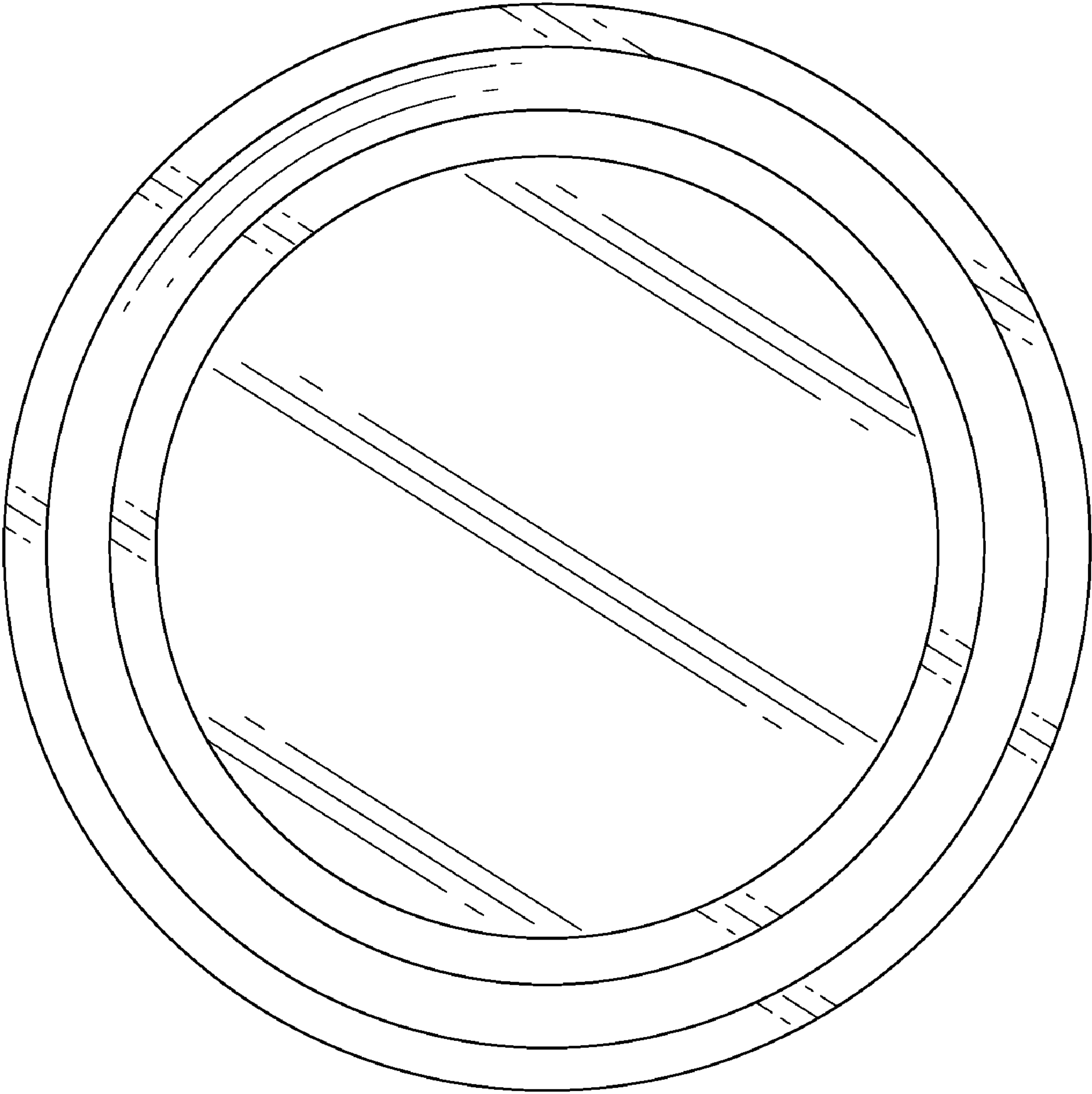

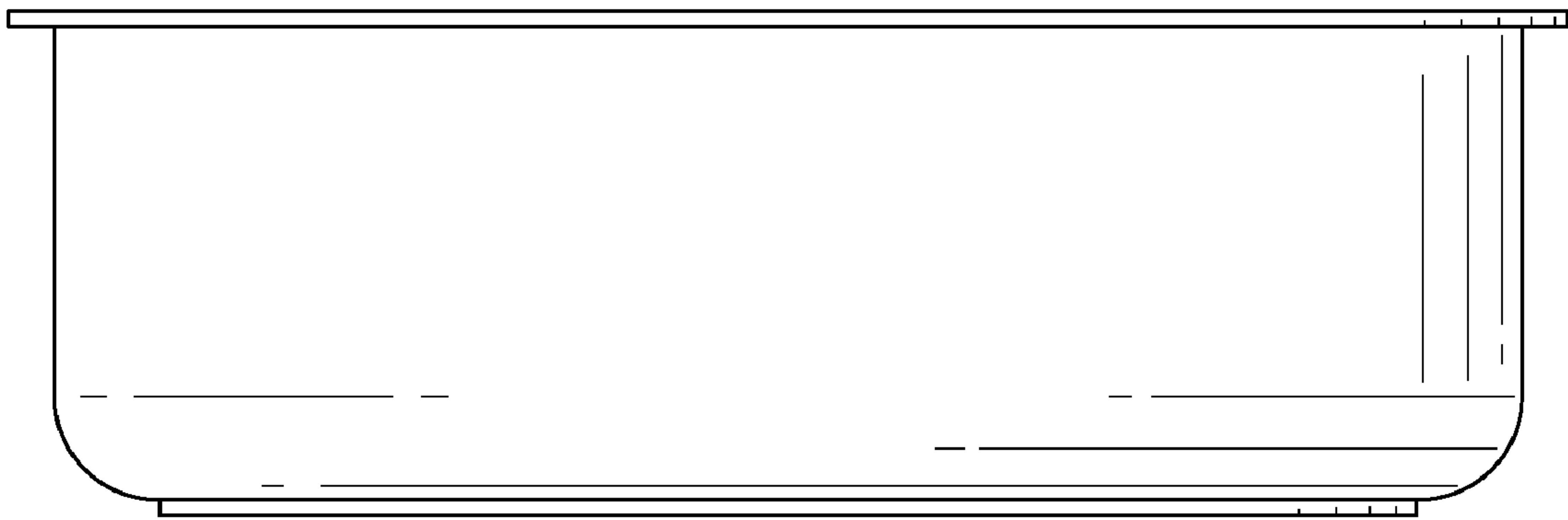

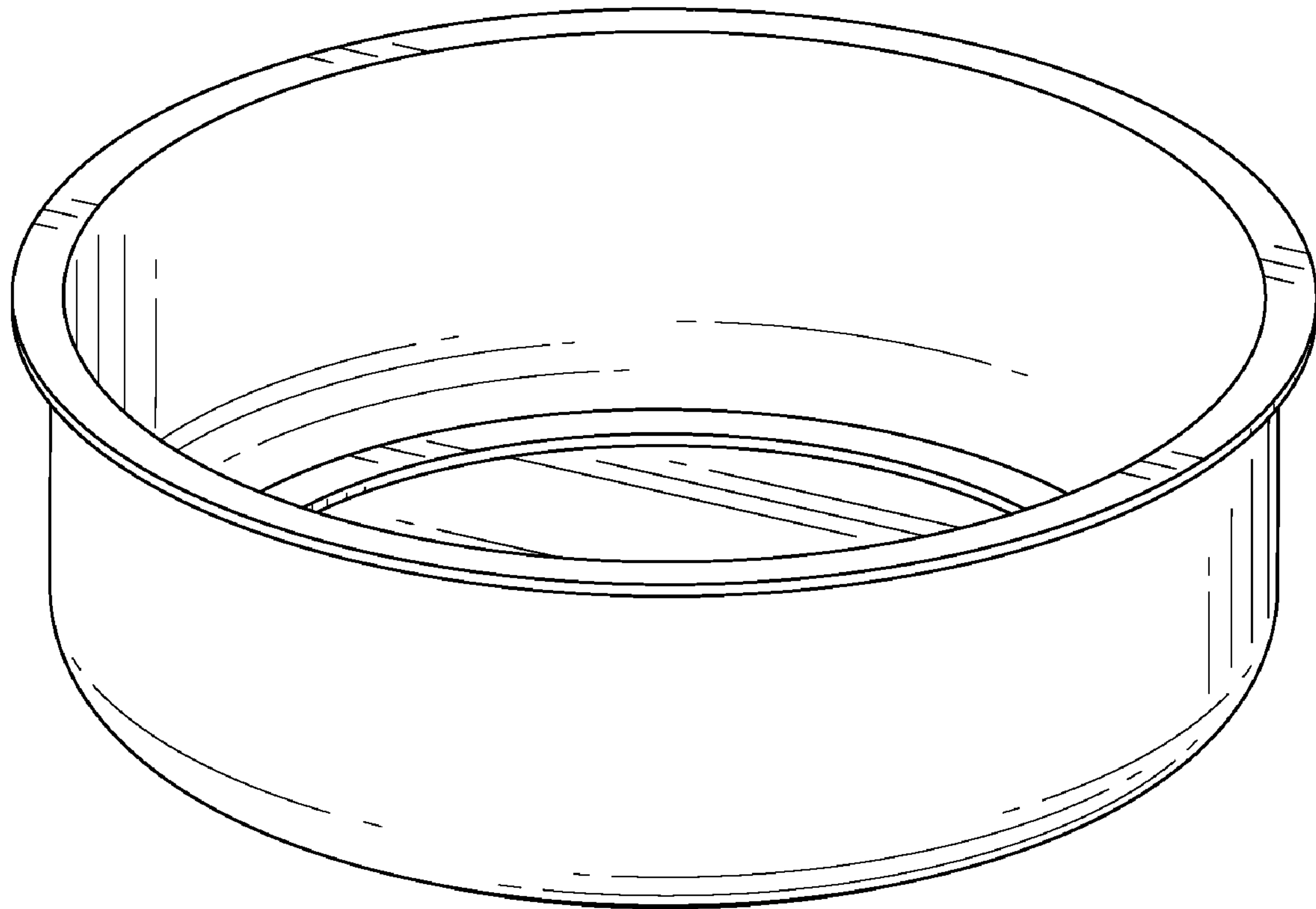

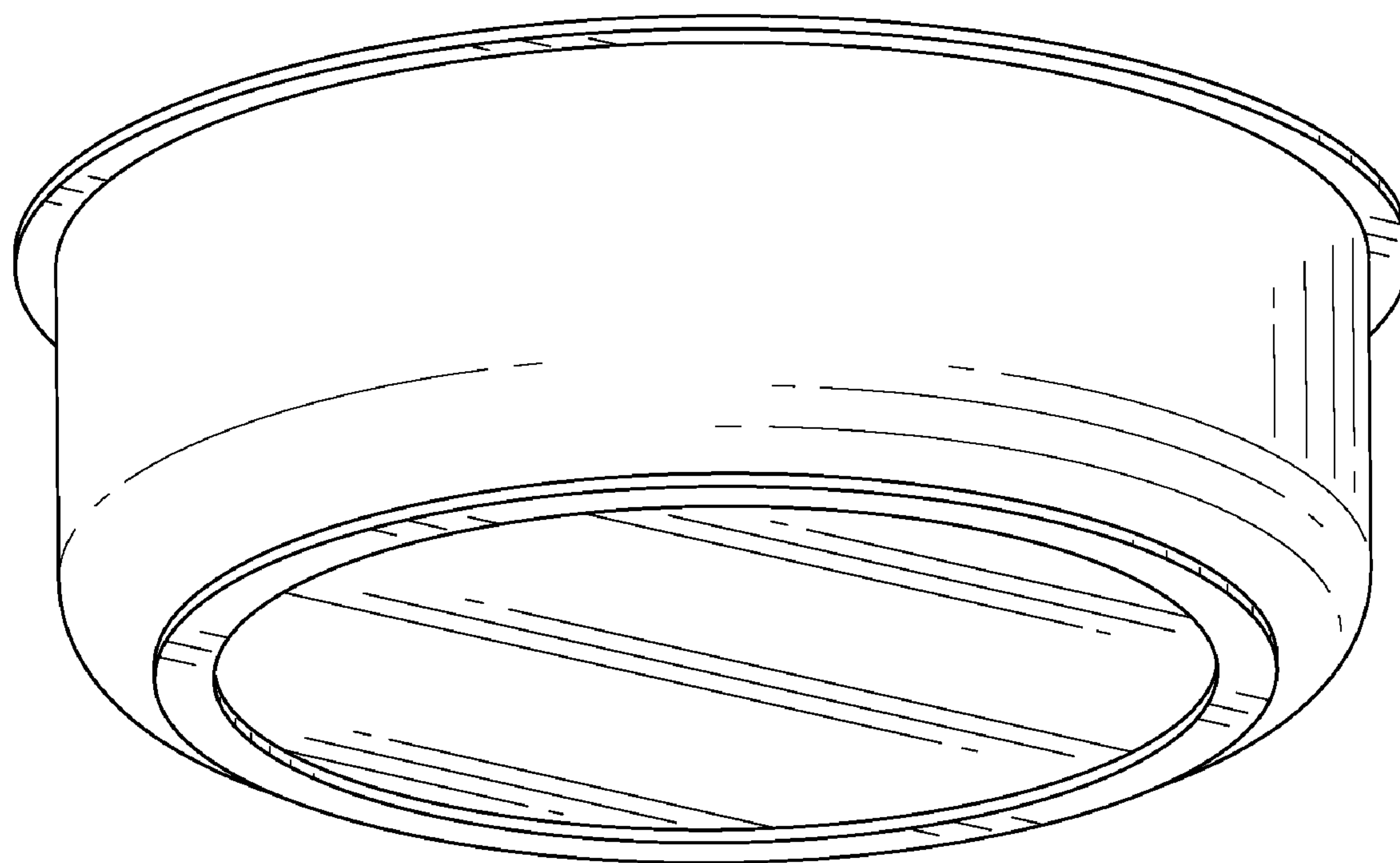
