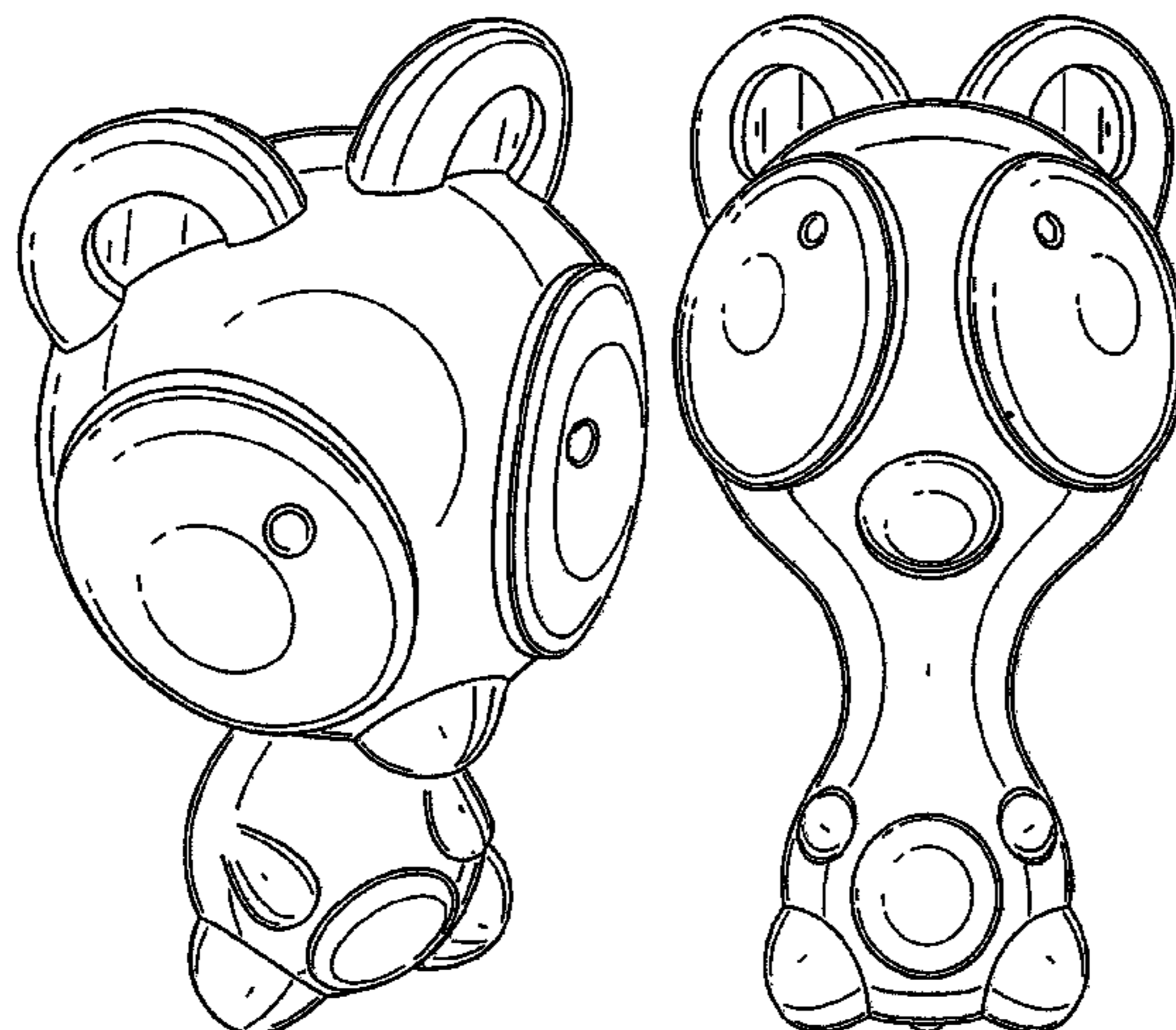
The ornamental design for a pet toy, as shown and described.

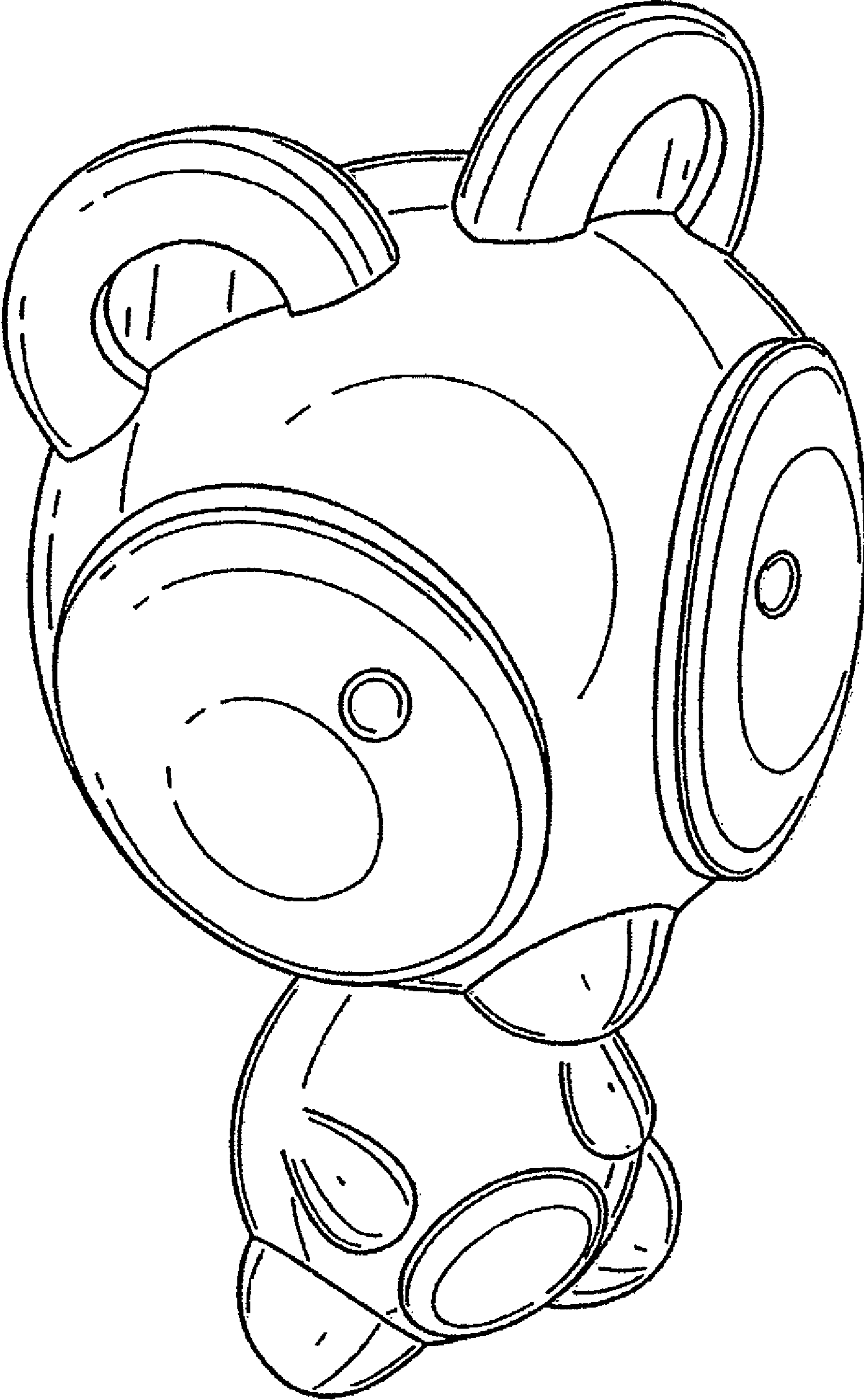

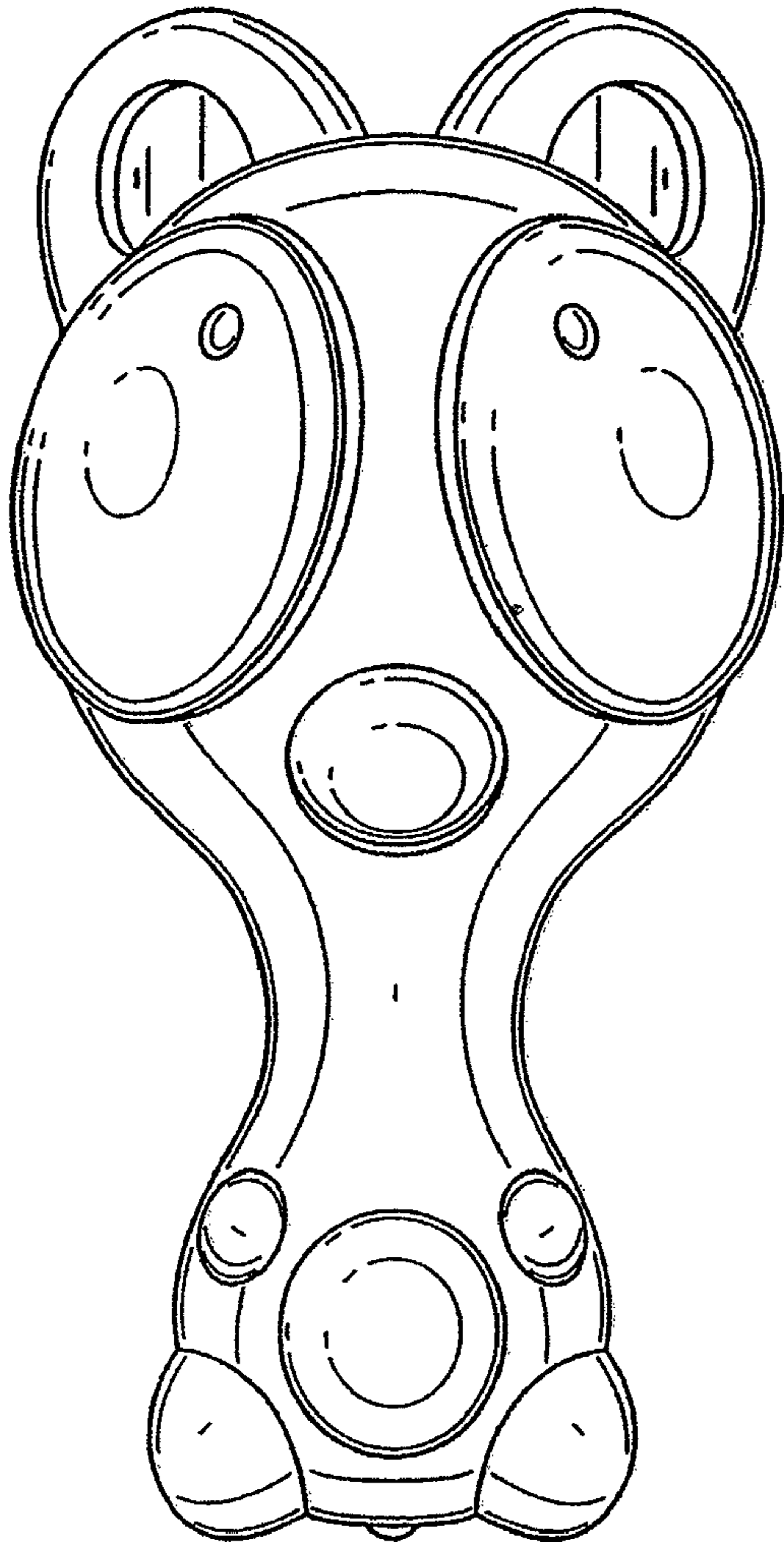

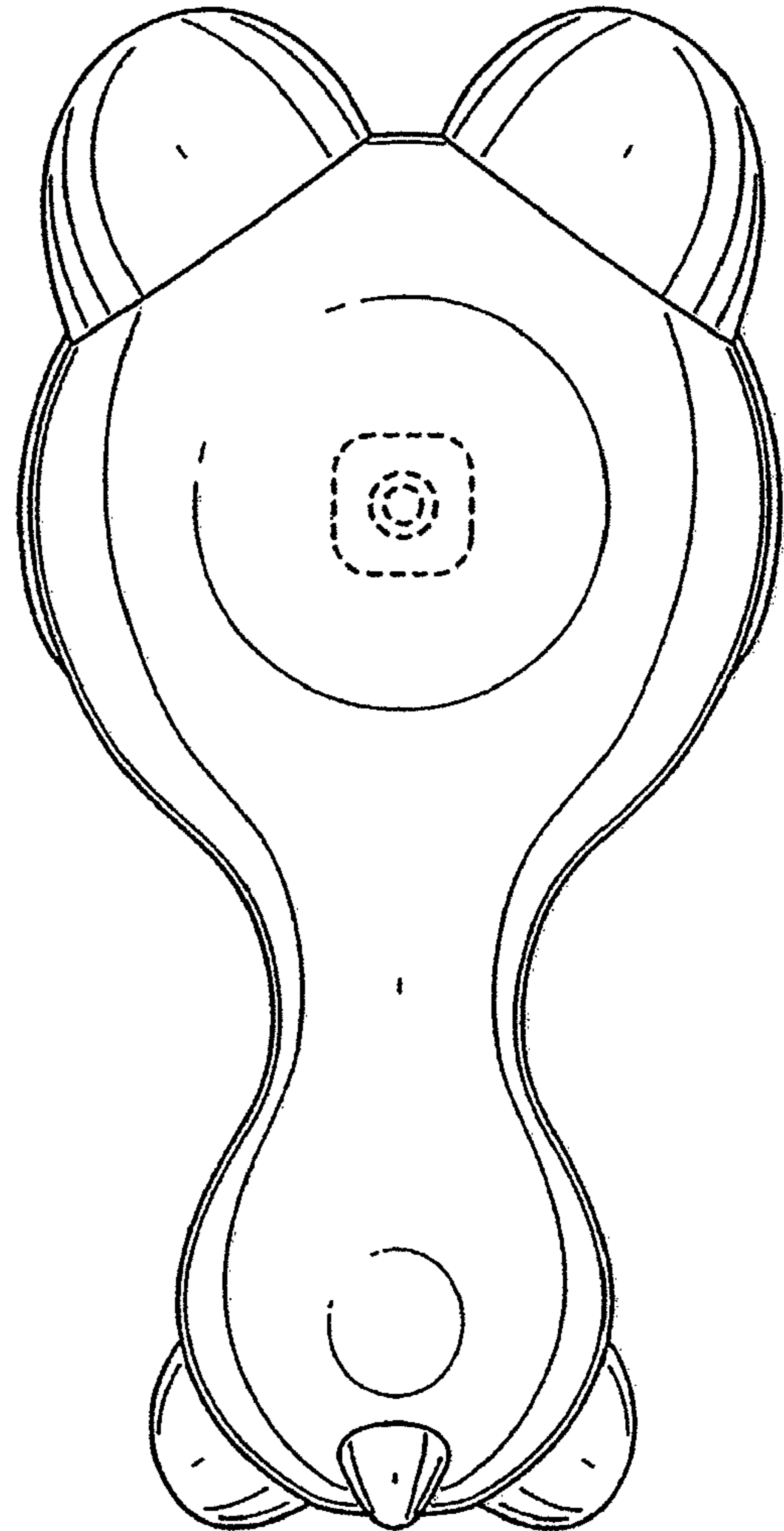

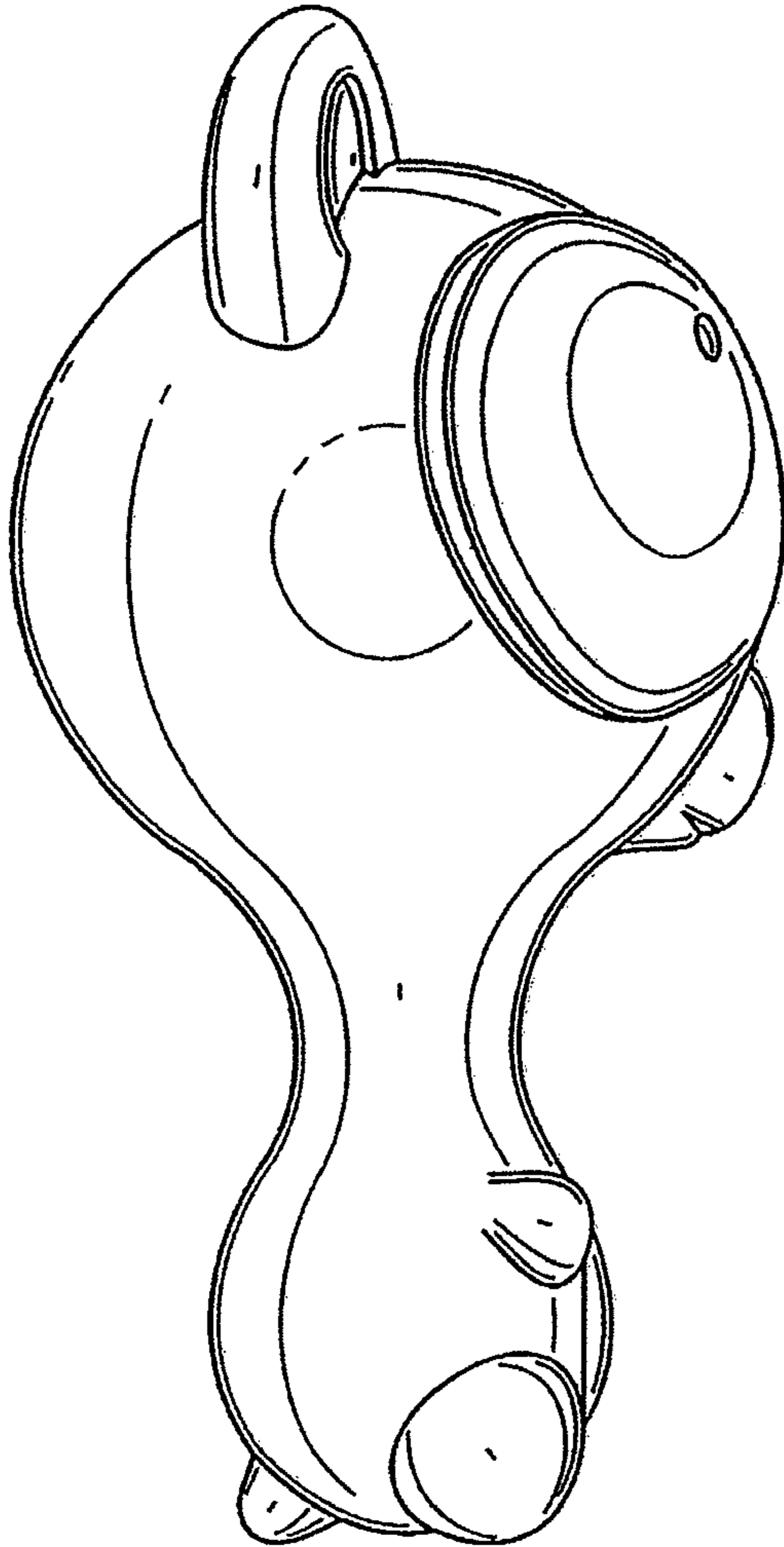

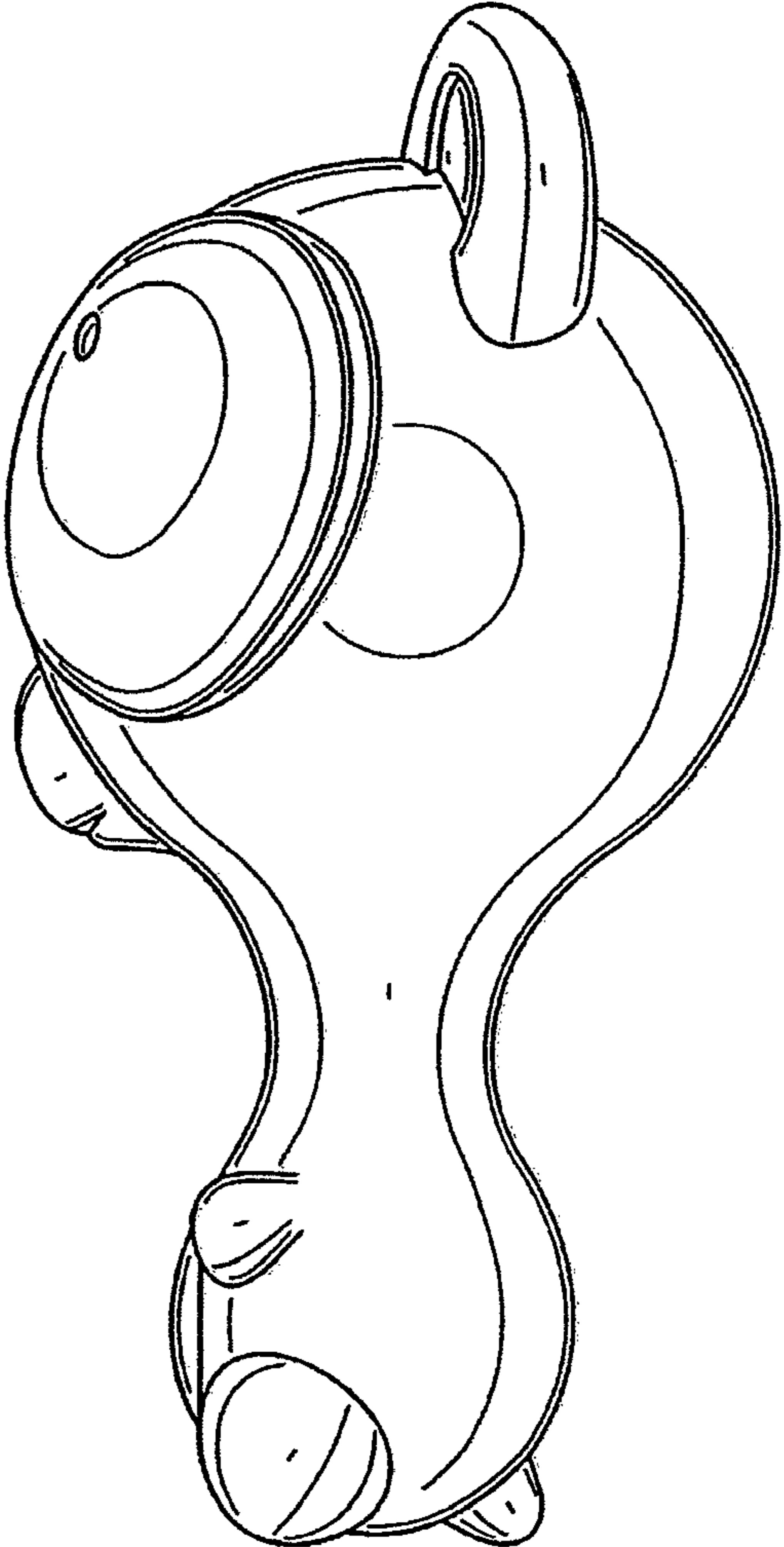

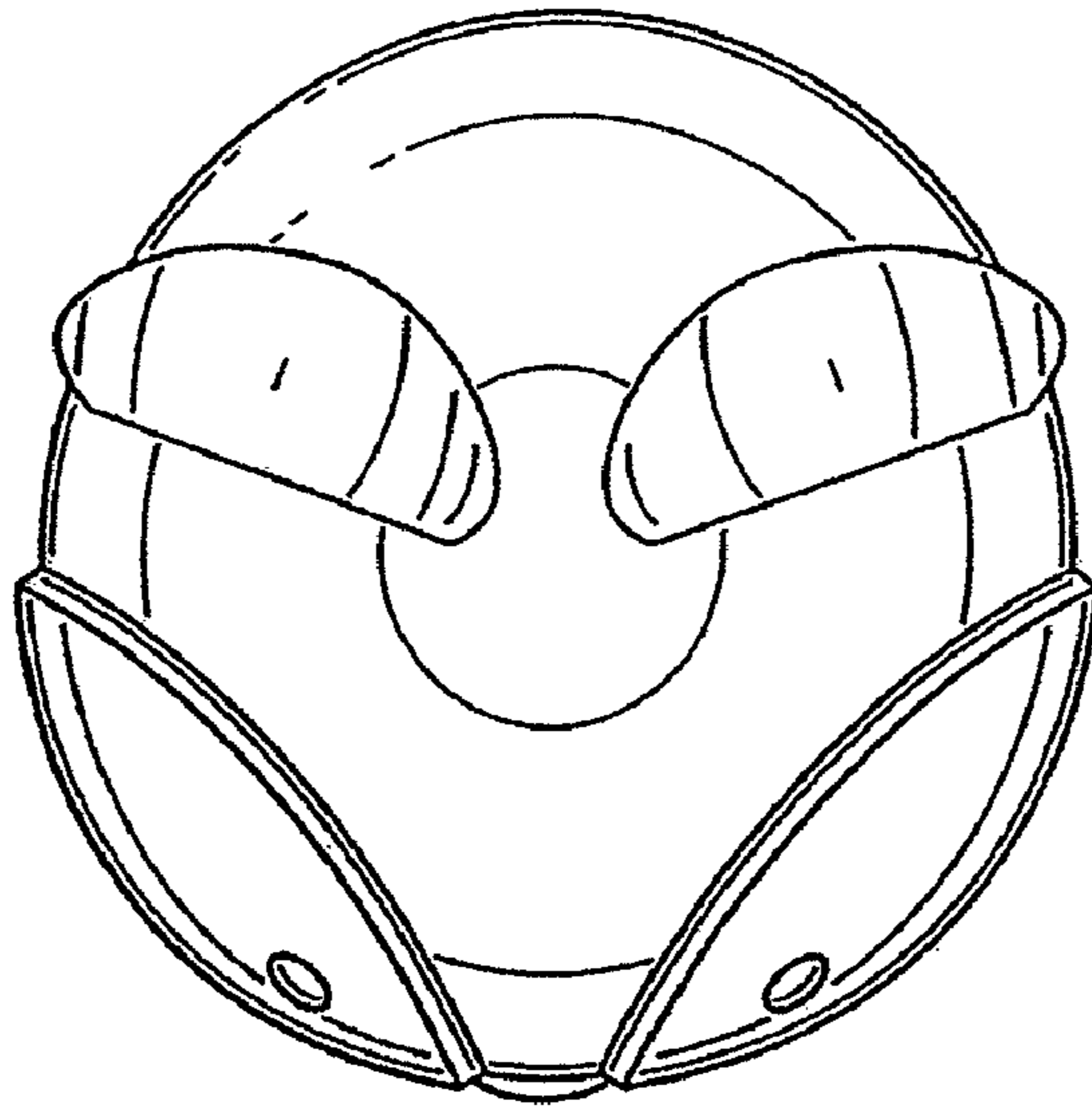

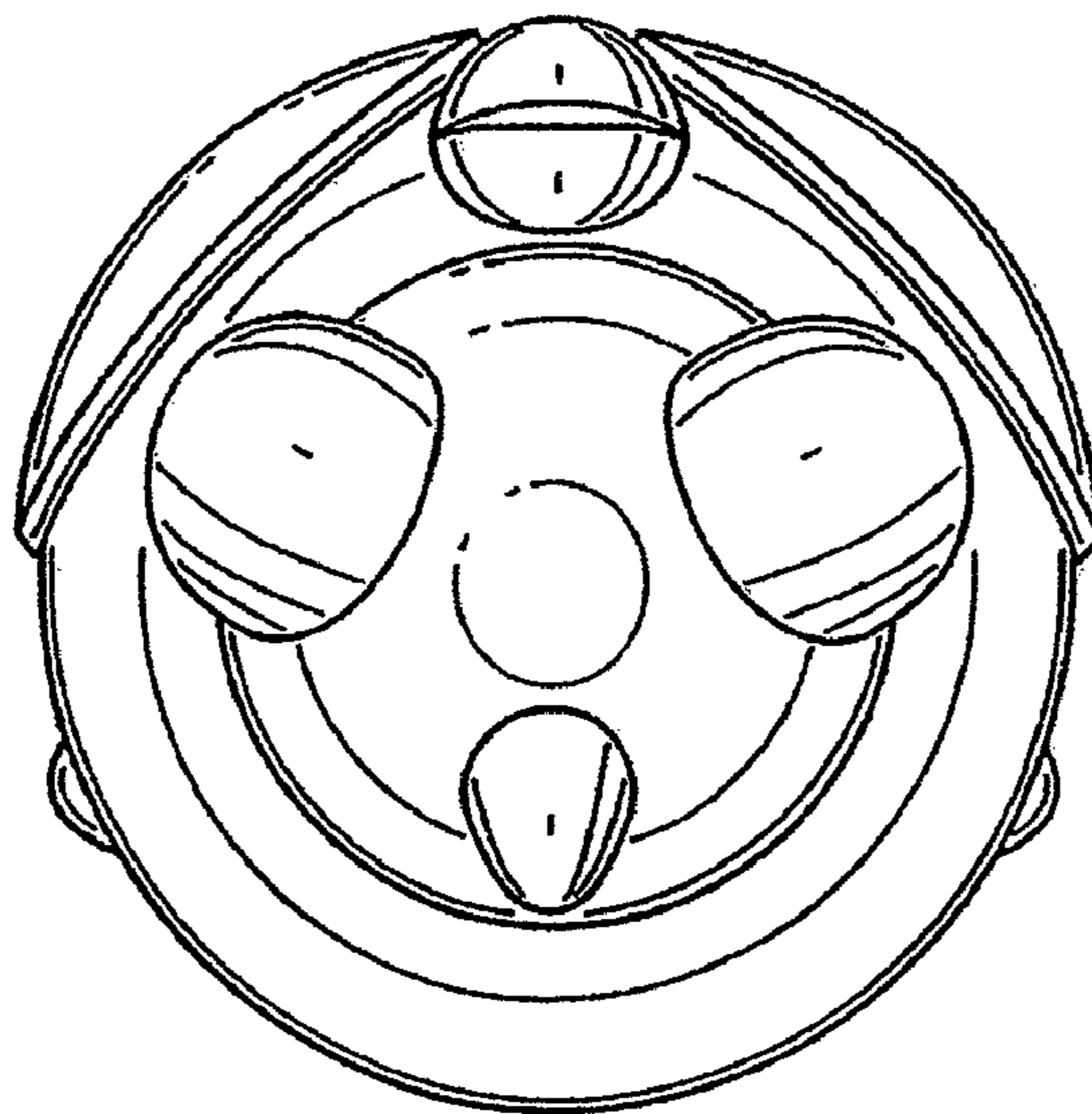
