We claim the ornamental design for a fluid reservoir, as shown and described.

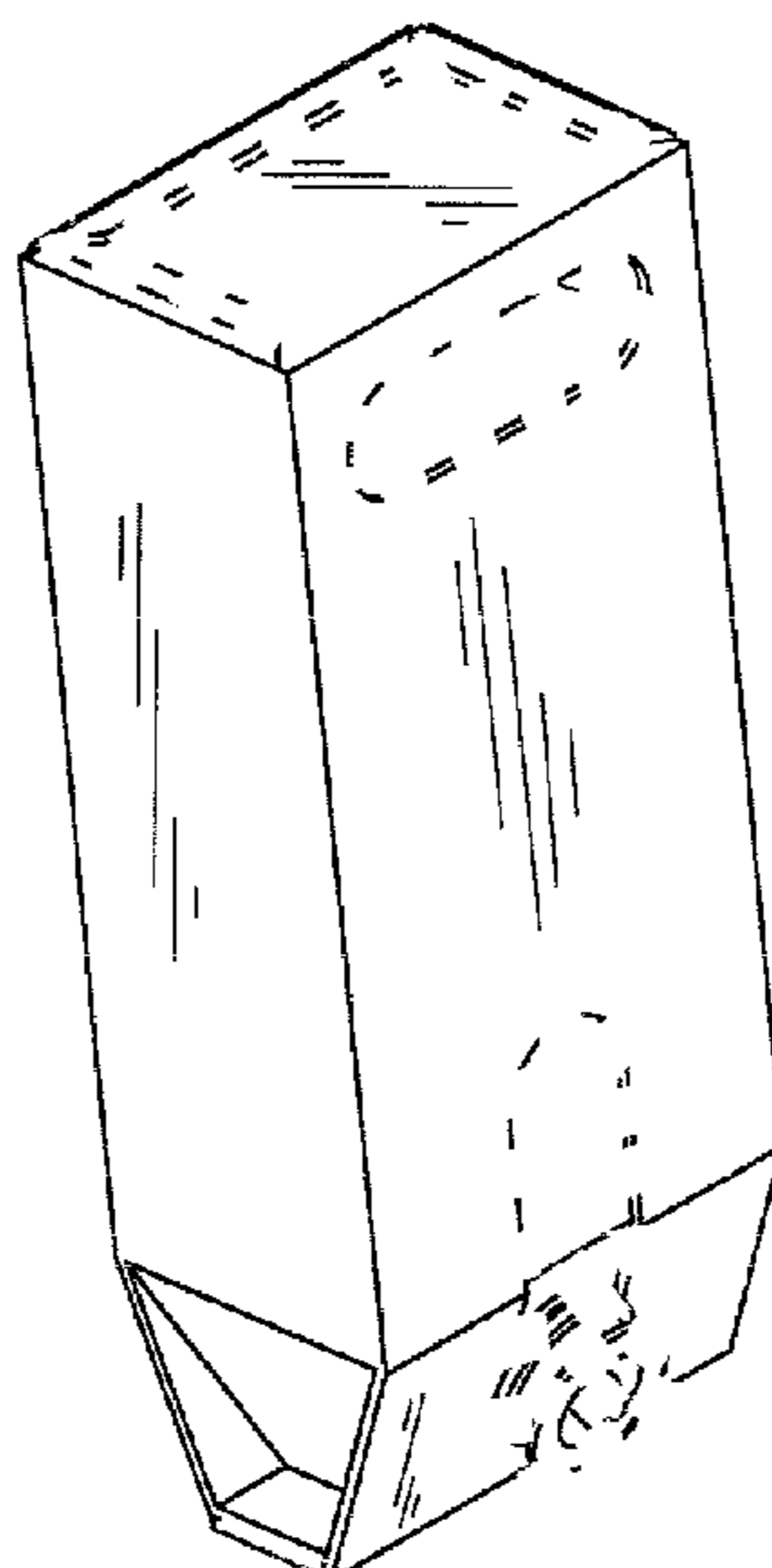
DESCRIPTION

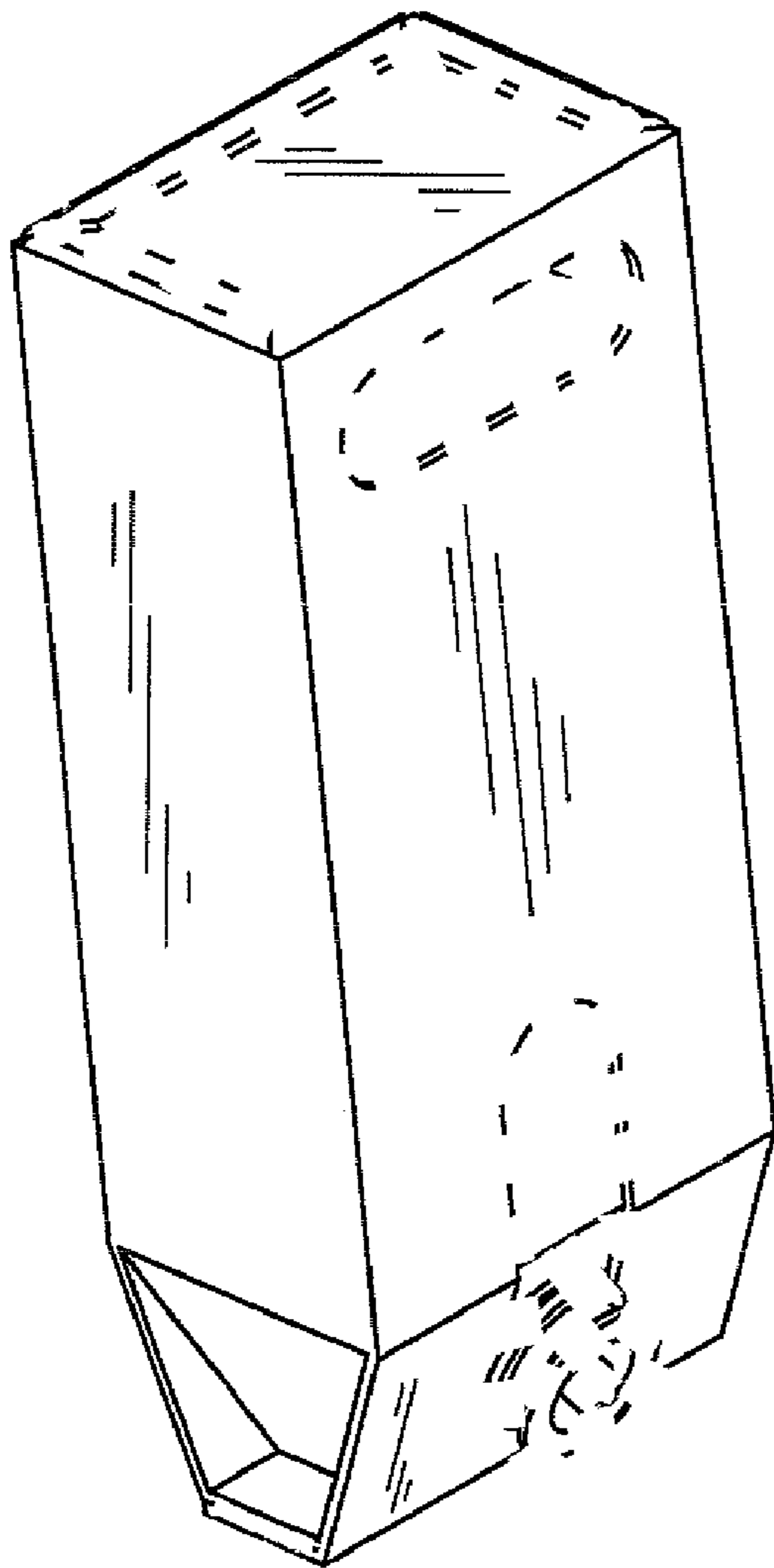

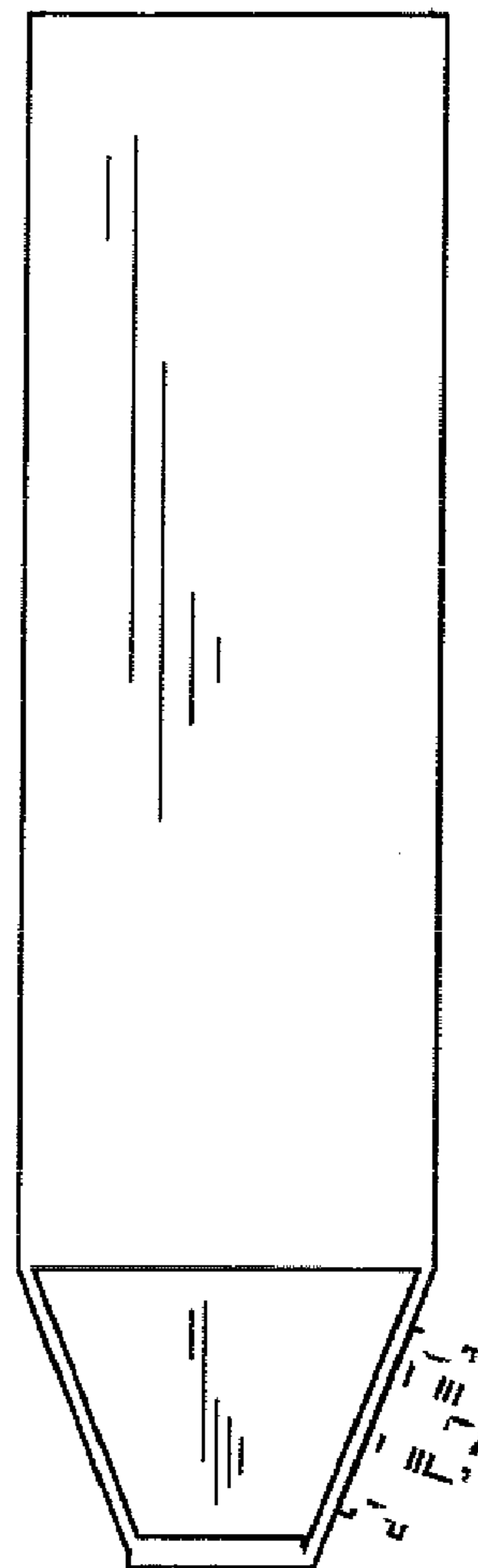
