(57) **CLAIM**

The ornamental design for a casket ornament, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of my new, original and ornamental design for a casket ornament;

FIG. 2 is a front view thereof;

FIG. 3 is a left side view thereof;

FIG. 4 is a right side view thereof;

FIG. 5 is a bottom view thereof;

FIG. 6 is a top view thereof; and

FIG. 7 is a back view thereof;

FIG. 8 is a front view of a second embodiment of my new, original and ornamental design for a casket ornament;

FIG. 9 is a left side view thereof;

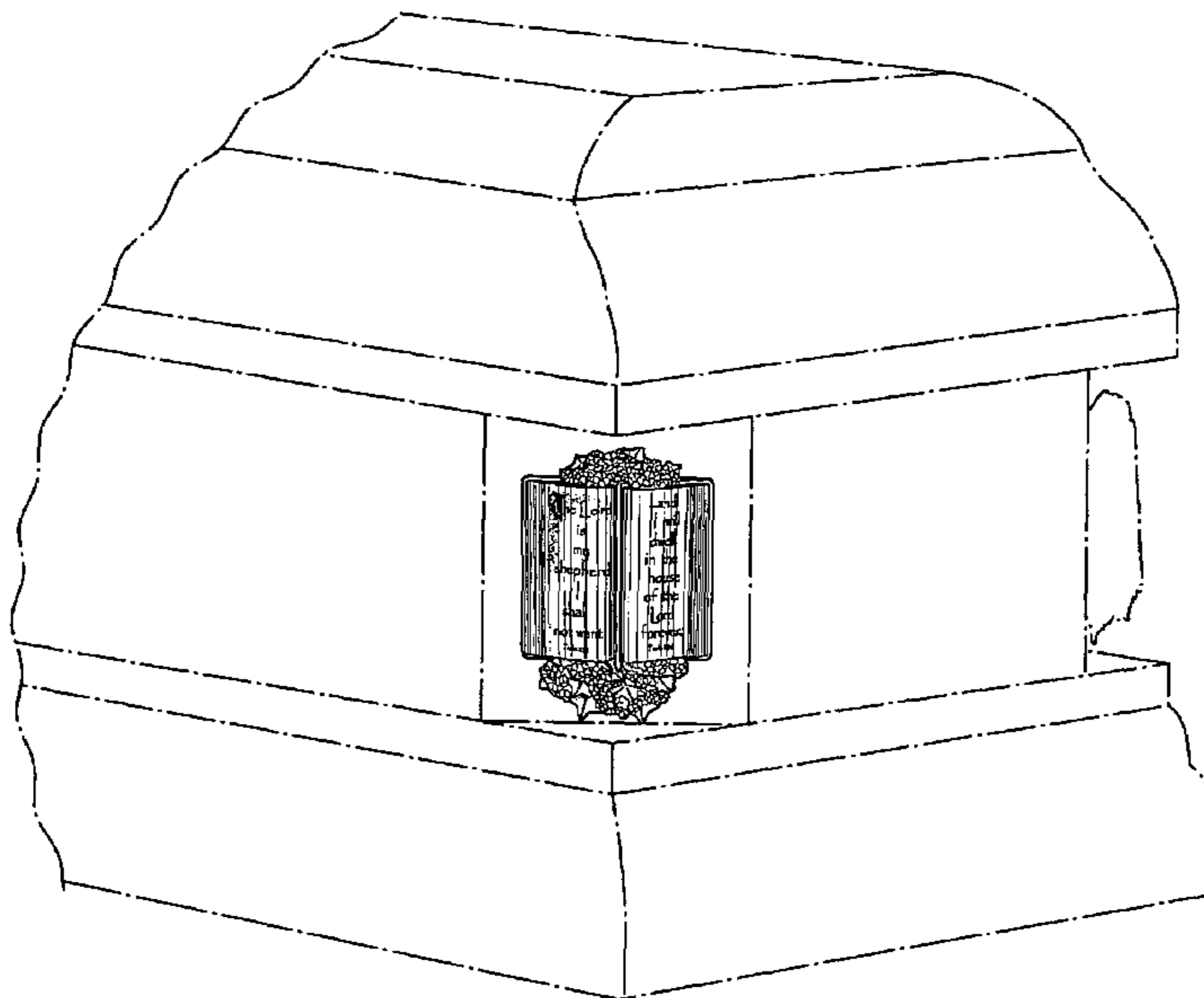
FIG. 10 is a right side view thereof; and,

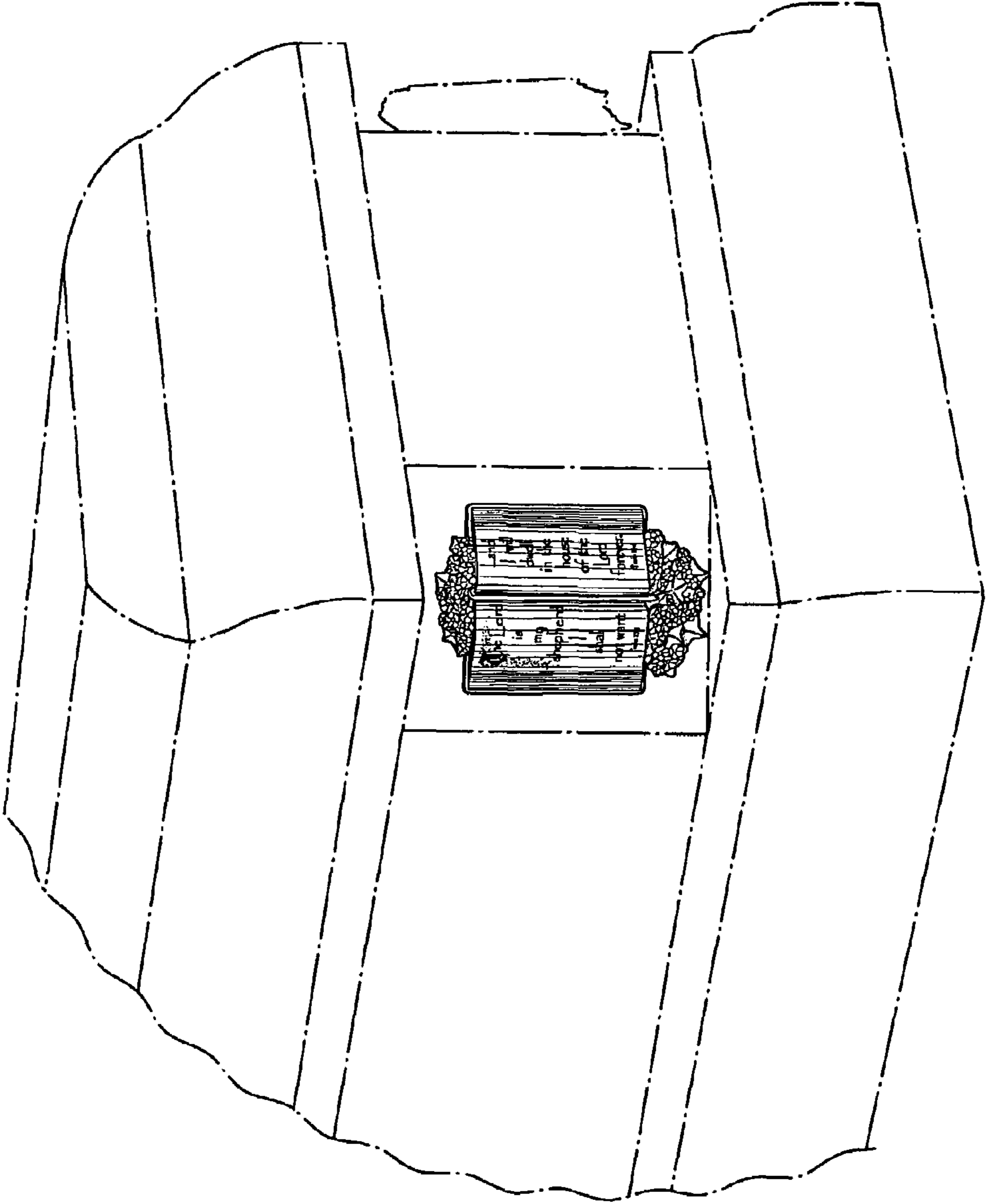

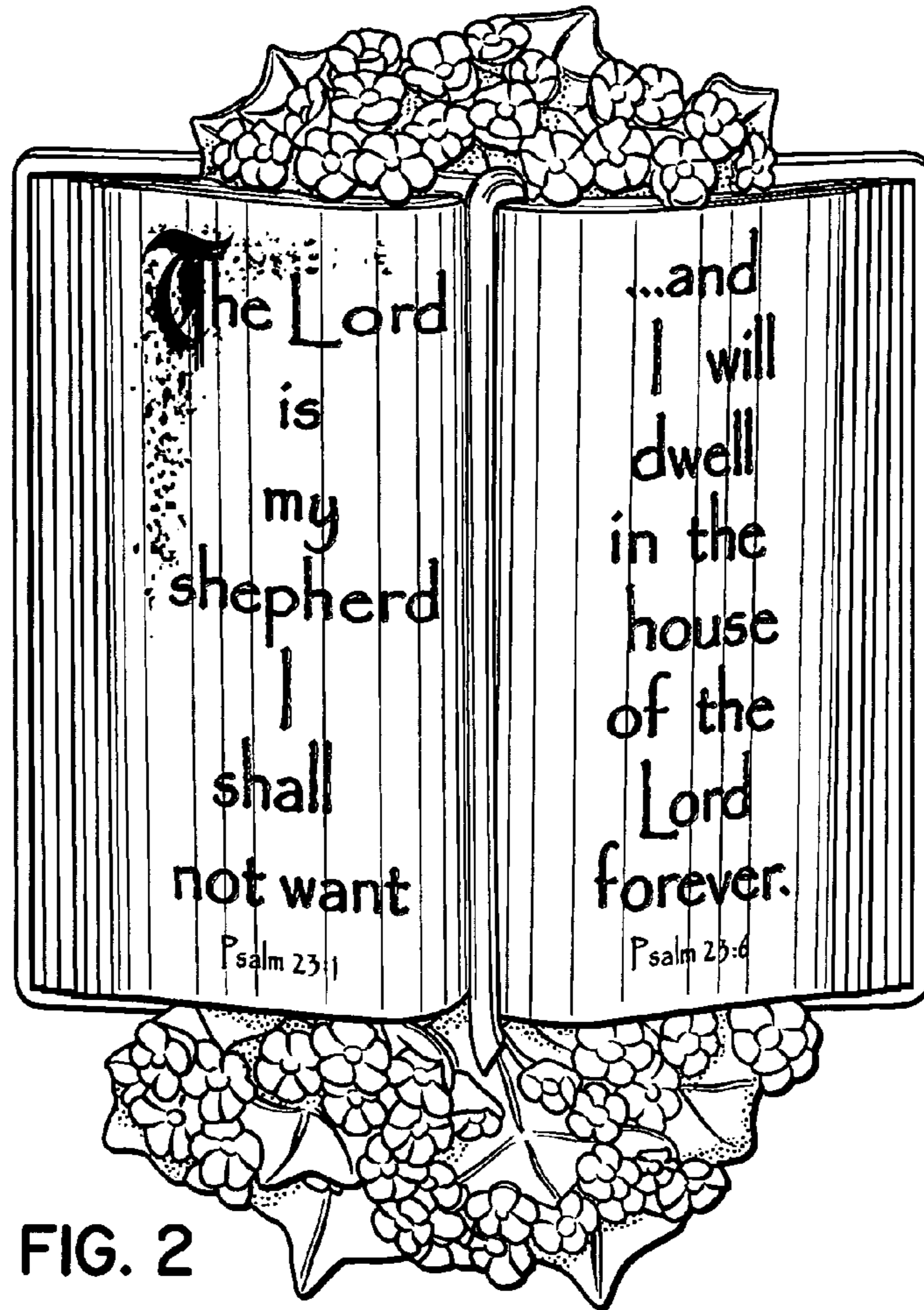

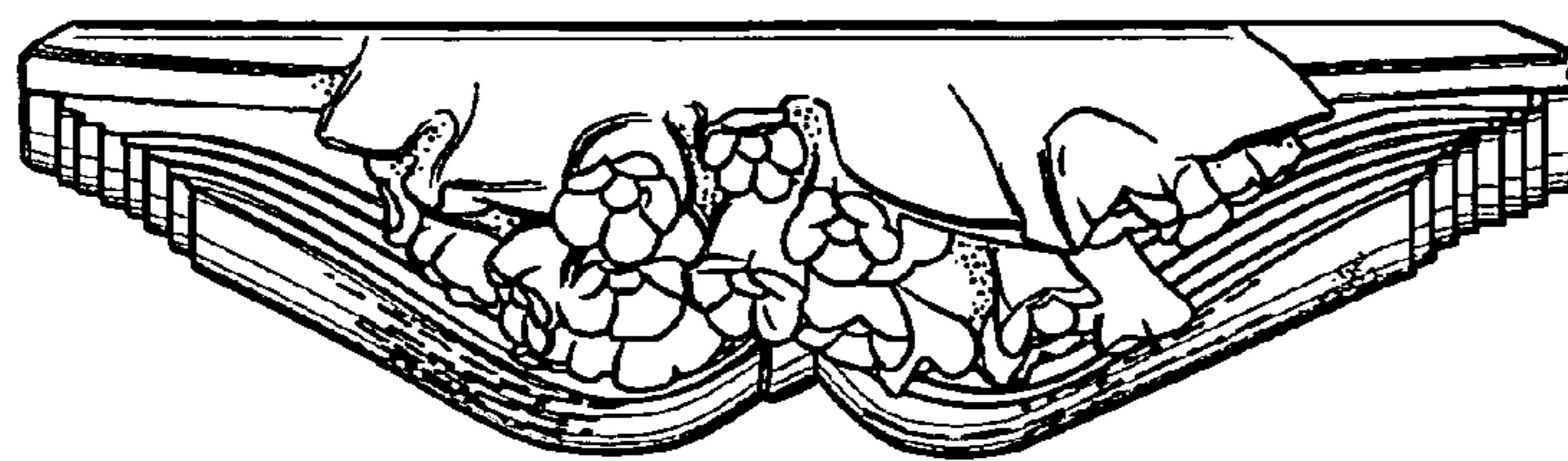

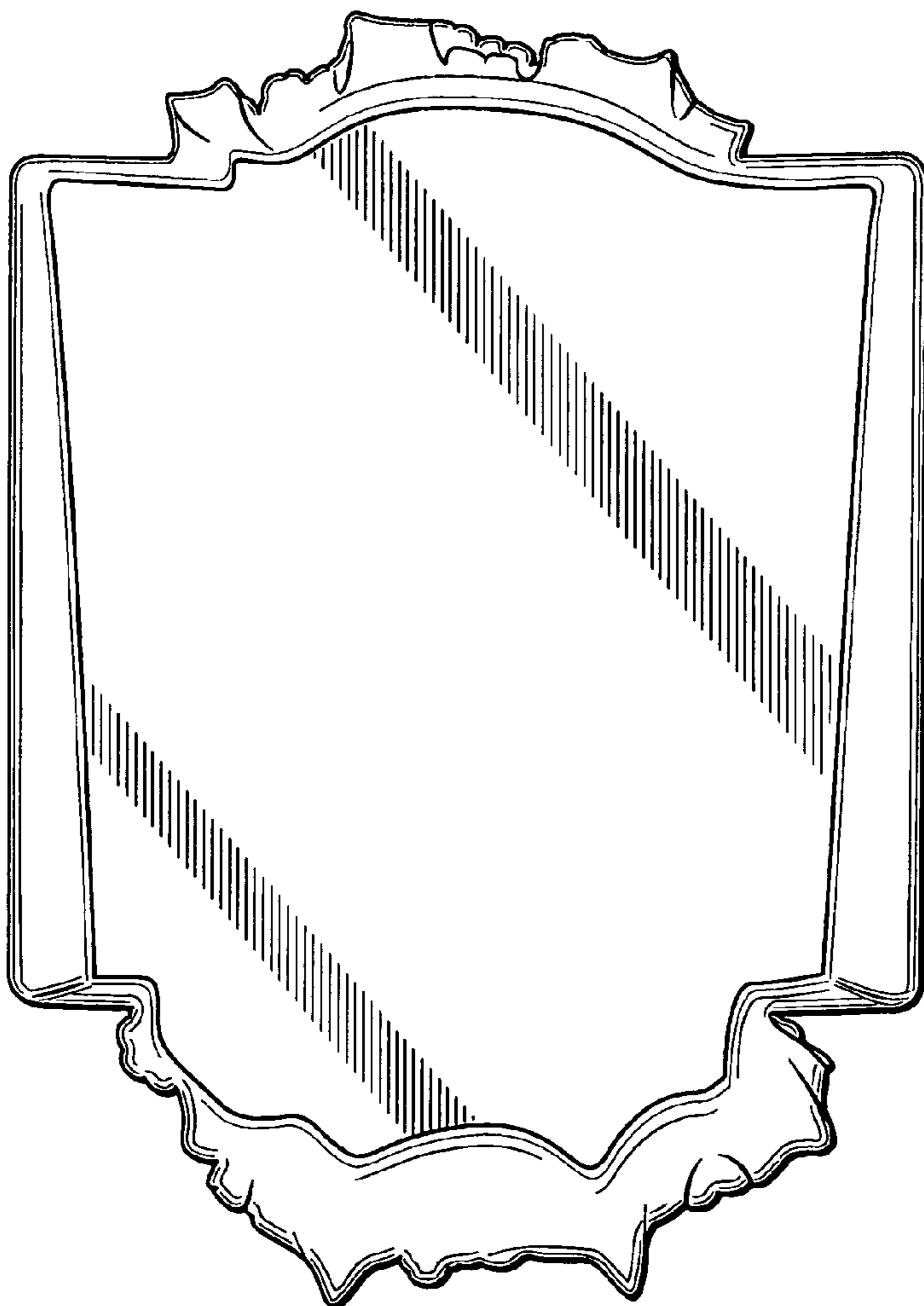

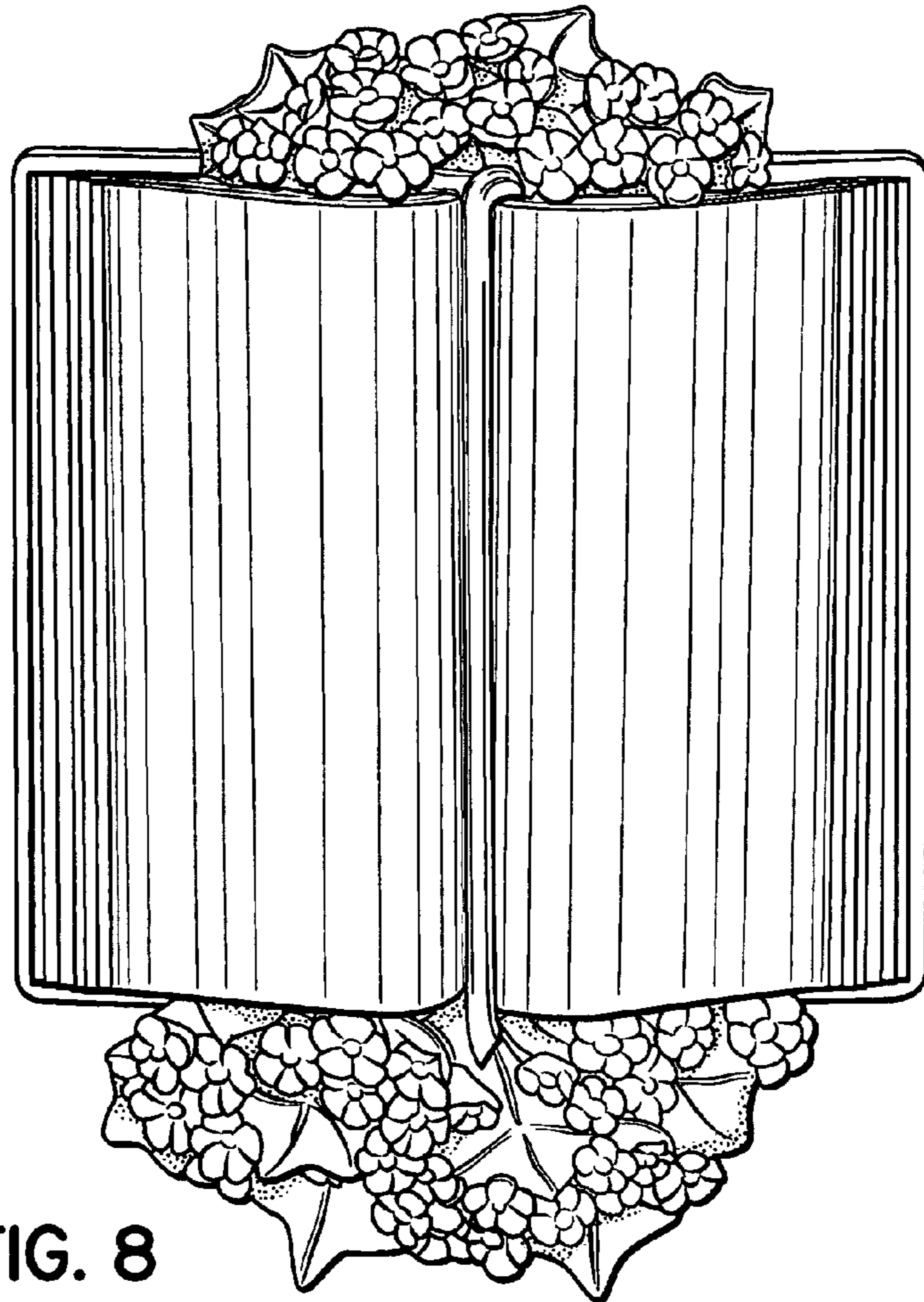

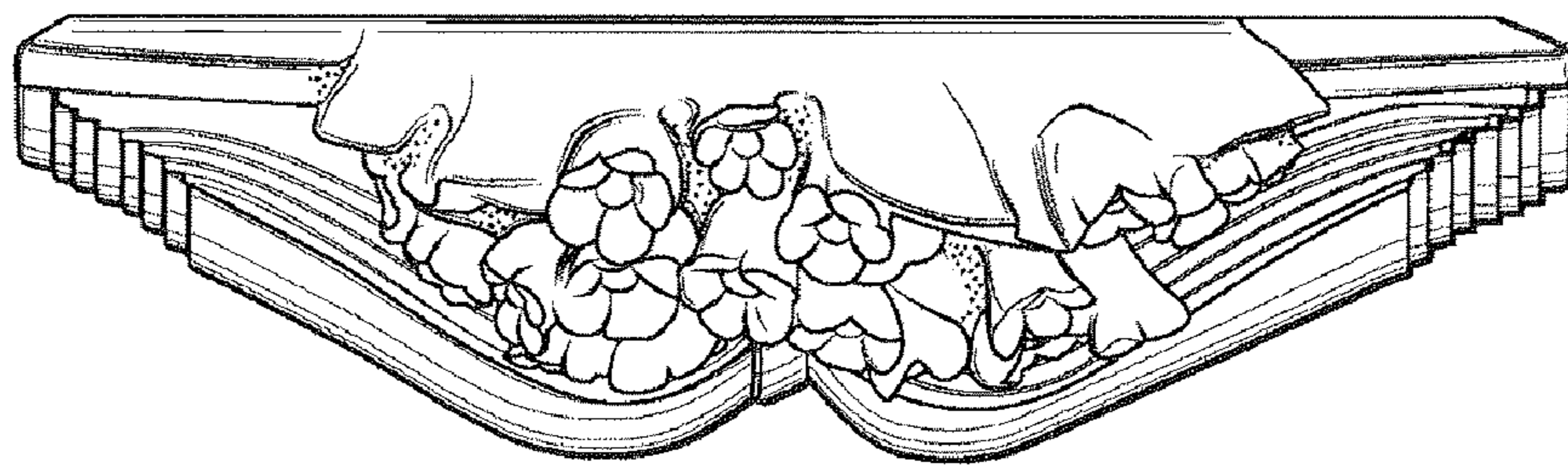
