FIG. 1 is a front view of an embodiment of a healthcare provider apron showing my new design;

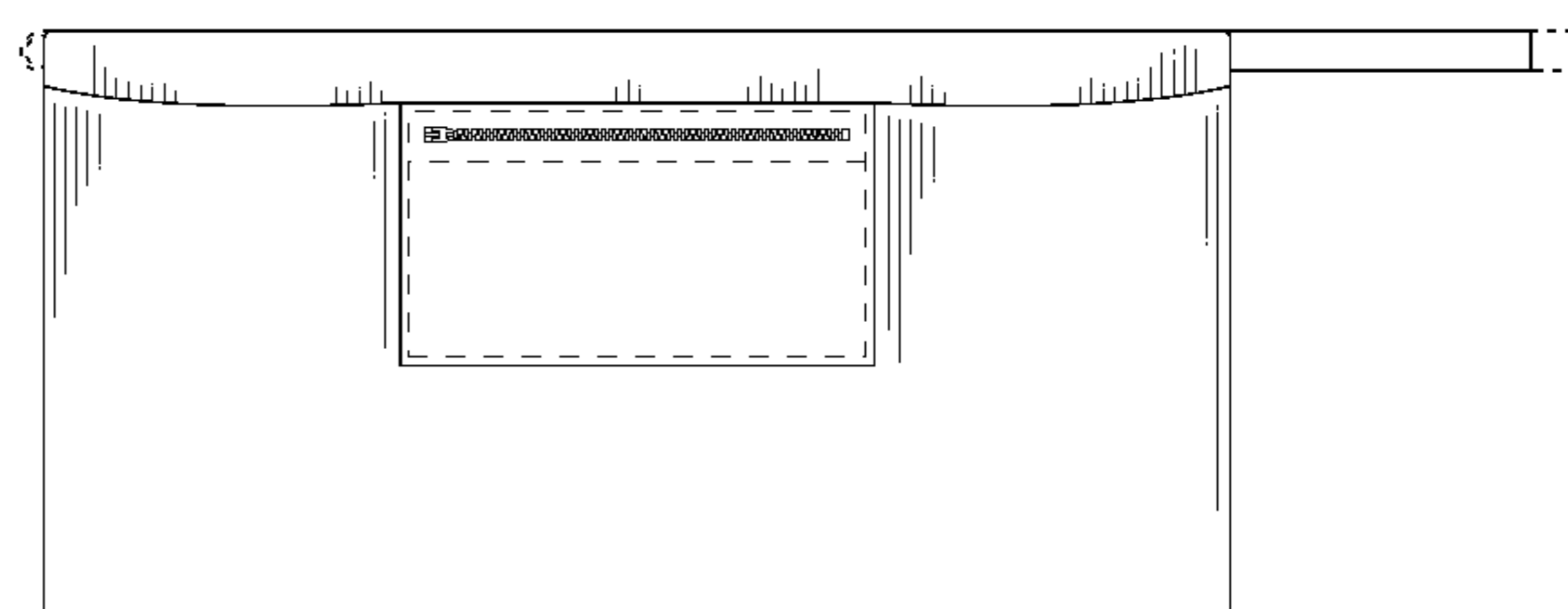
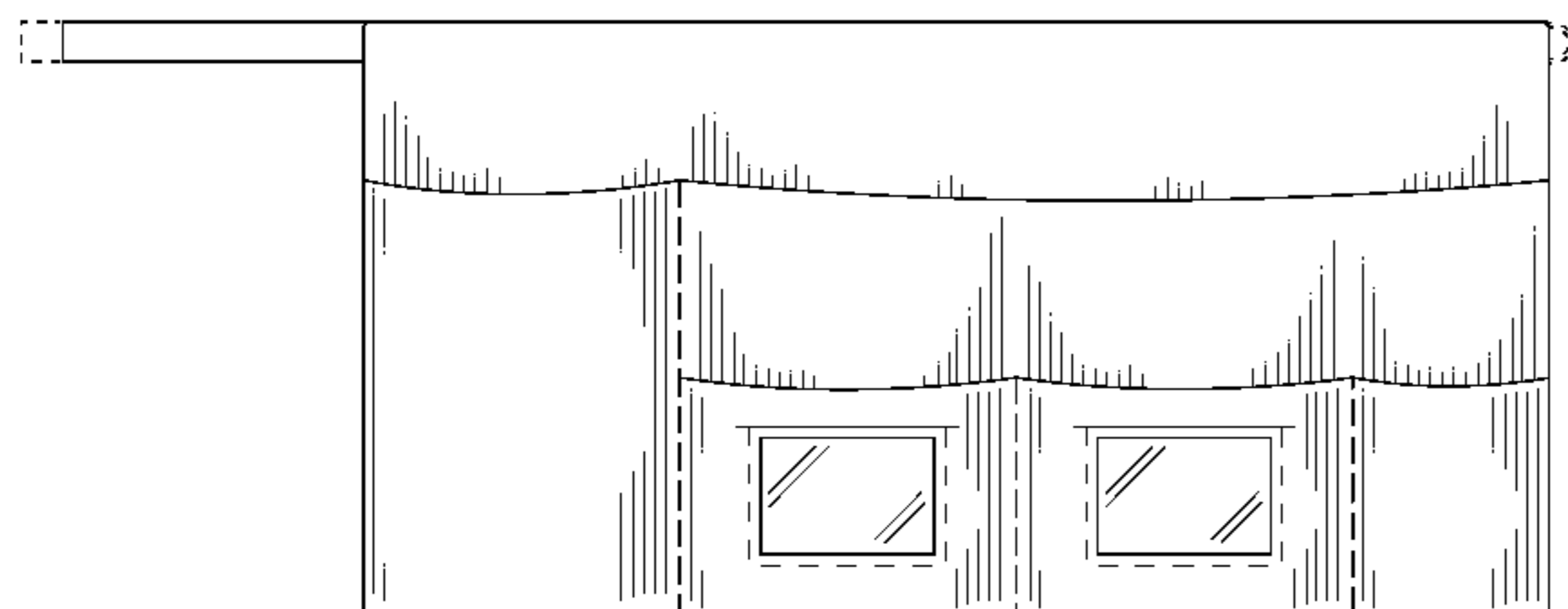
FIG. 2 is a rear view of the healthcare provider apron of FIG. 1;

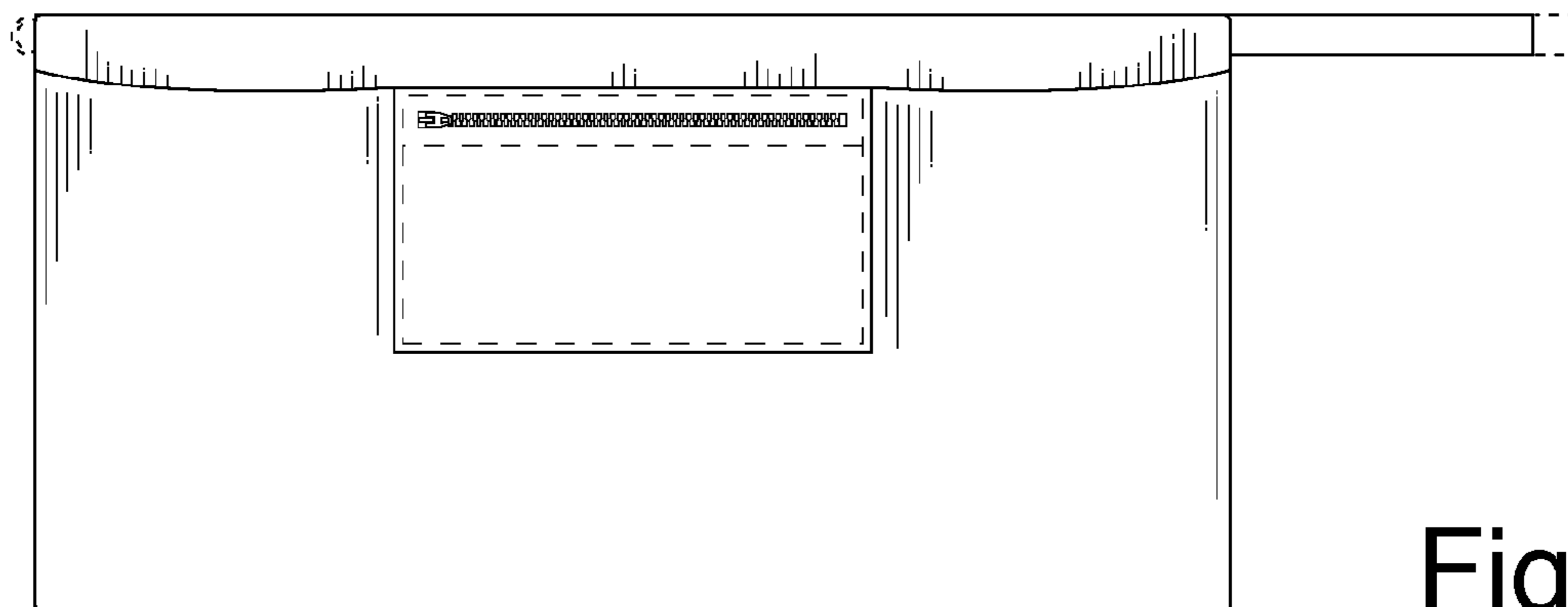
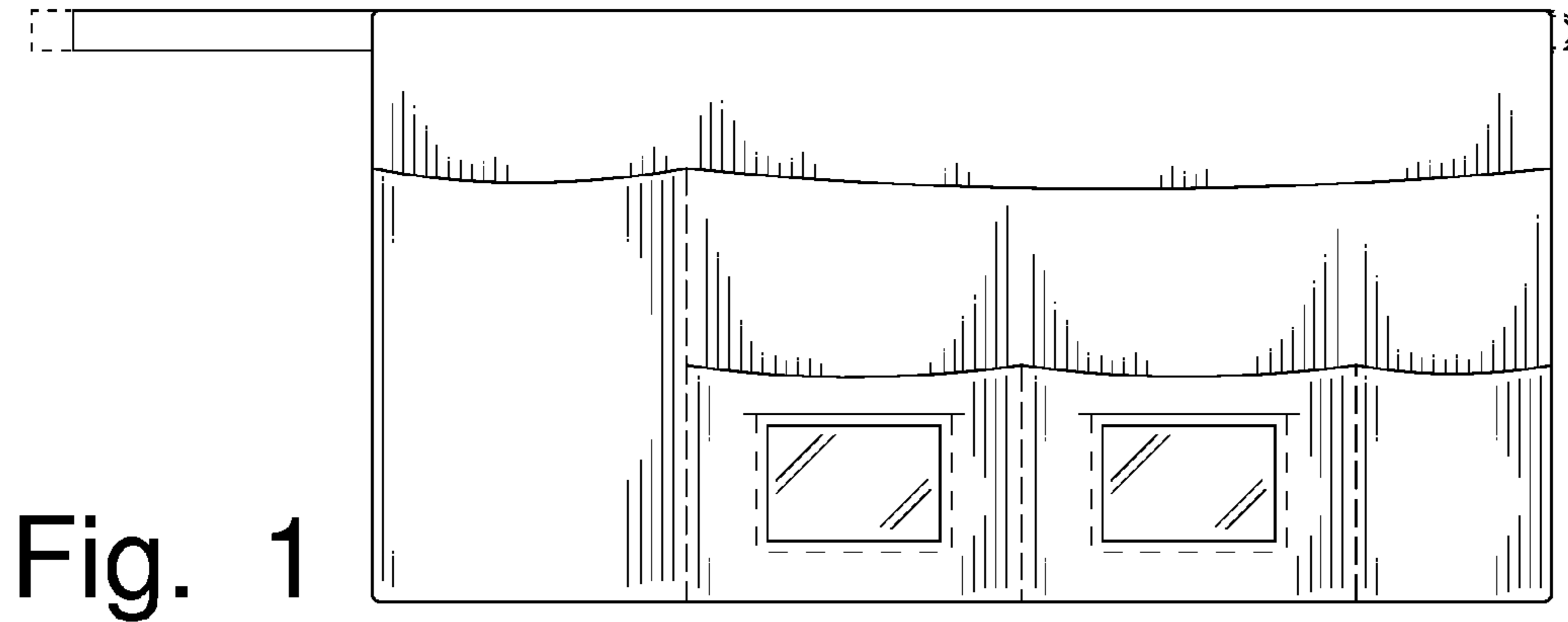
FIG. 3 is a front view of an alternate embodiment of a healthcare provider apron showing my new design; and,

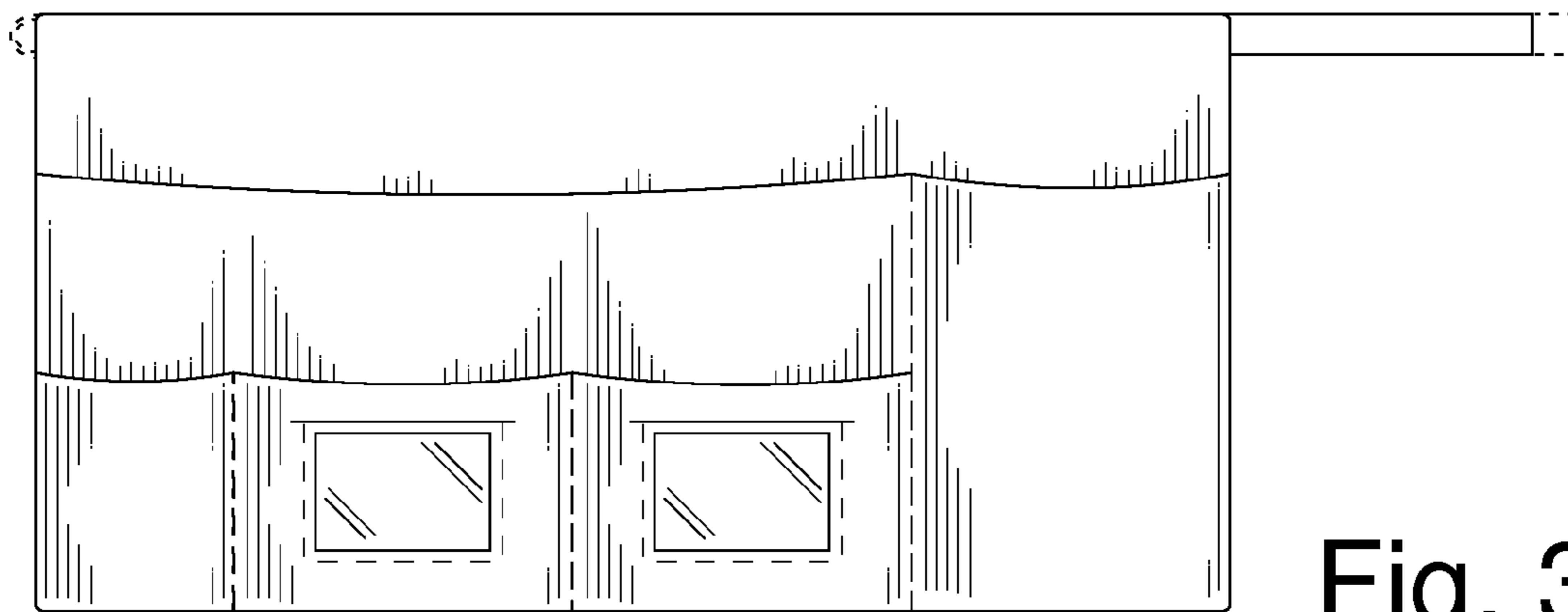

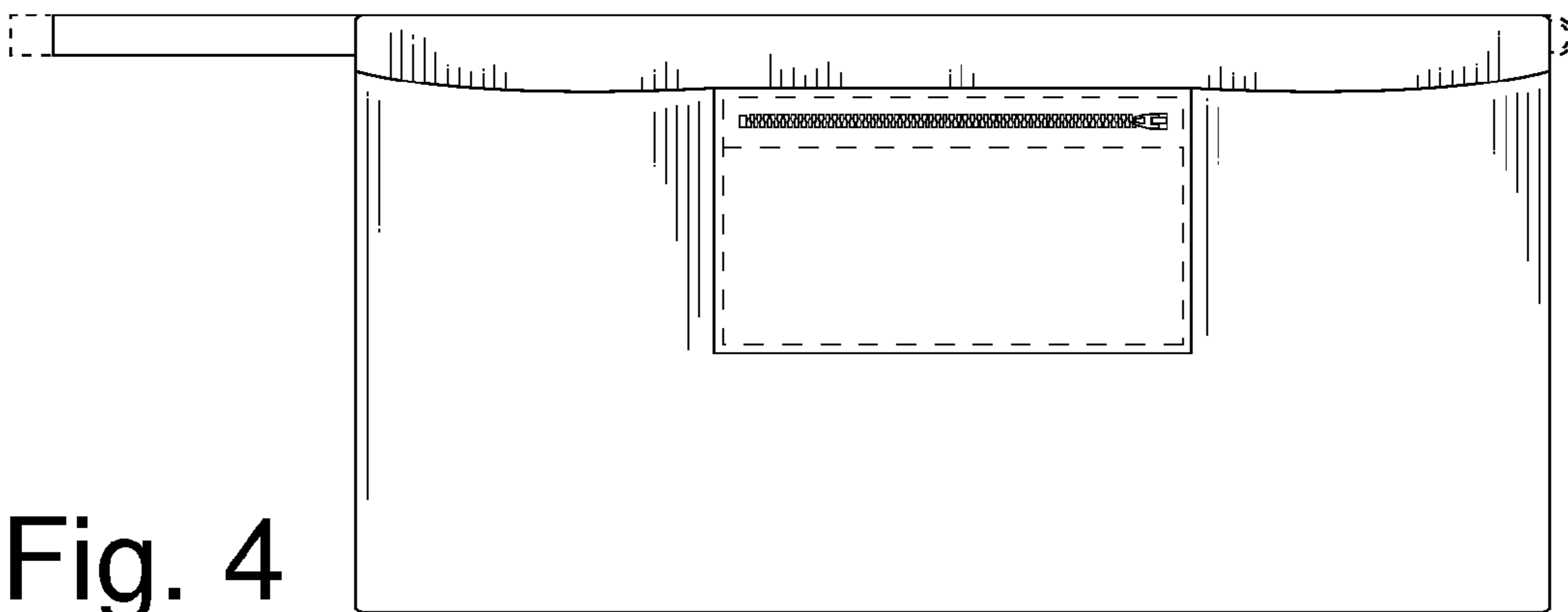
