(57) **CLAIM**

The ornamental design for a headwear piece with ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a front, right side and top perspective view of my design for a headwear piece with ornamentation;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a right side elevation view thereof; and,

FIG. 4 is a top plan view thereof.

The long/short broken line which defines the bounds of the claimed design forms no part thereof. The evenly spaced broken lines represent environmental matter and form no part of the claimed design.

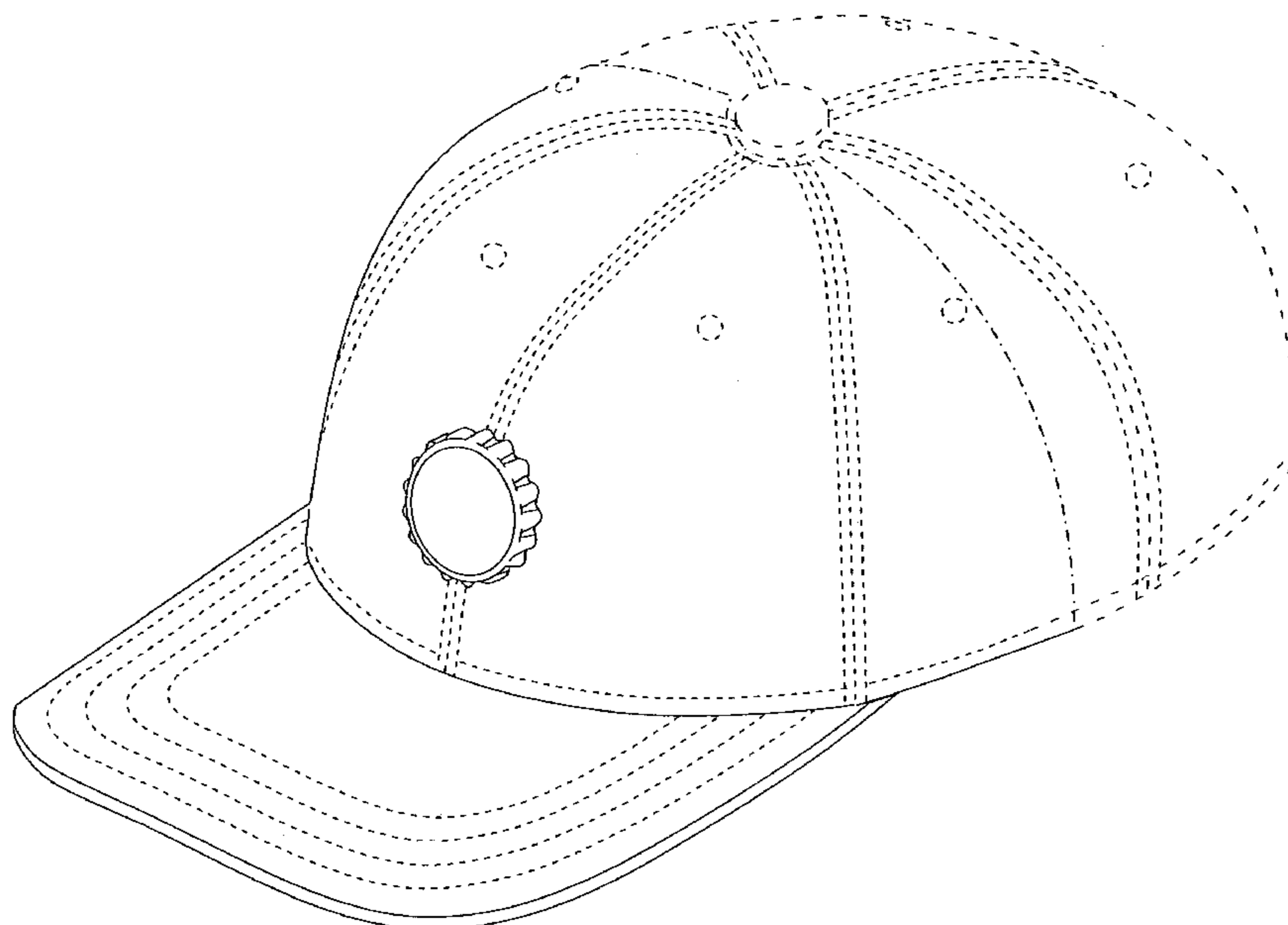
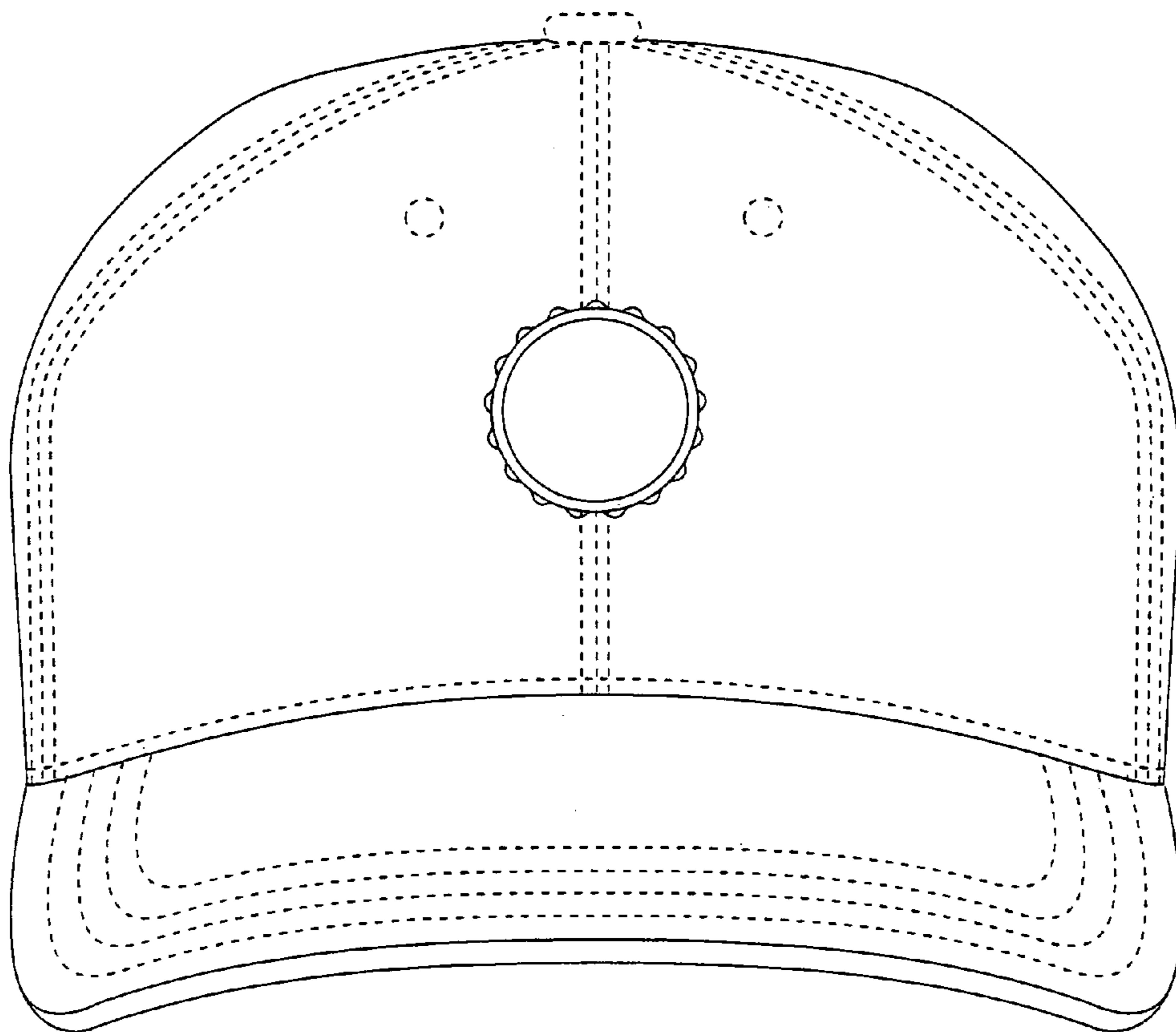

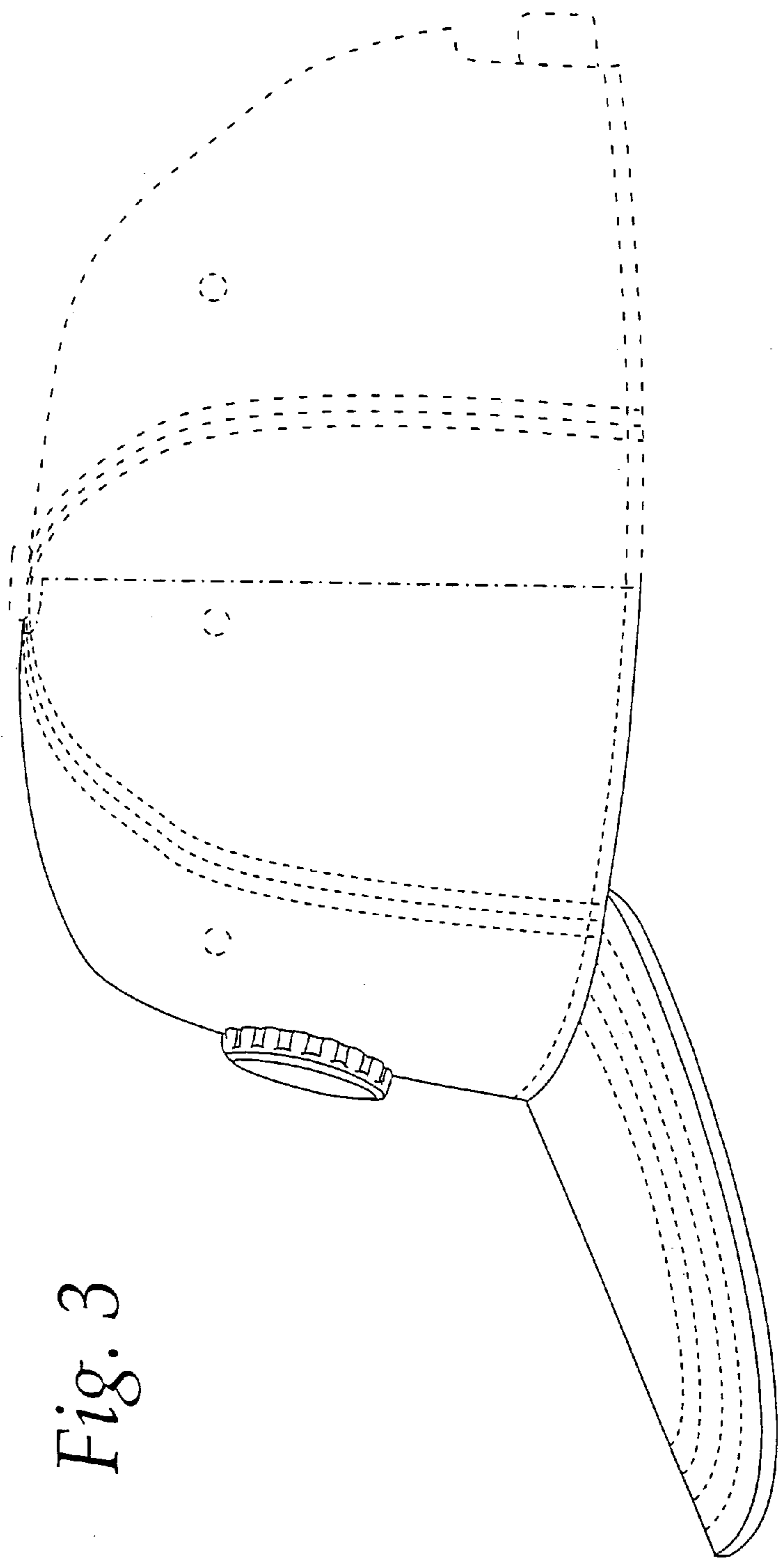
