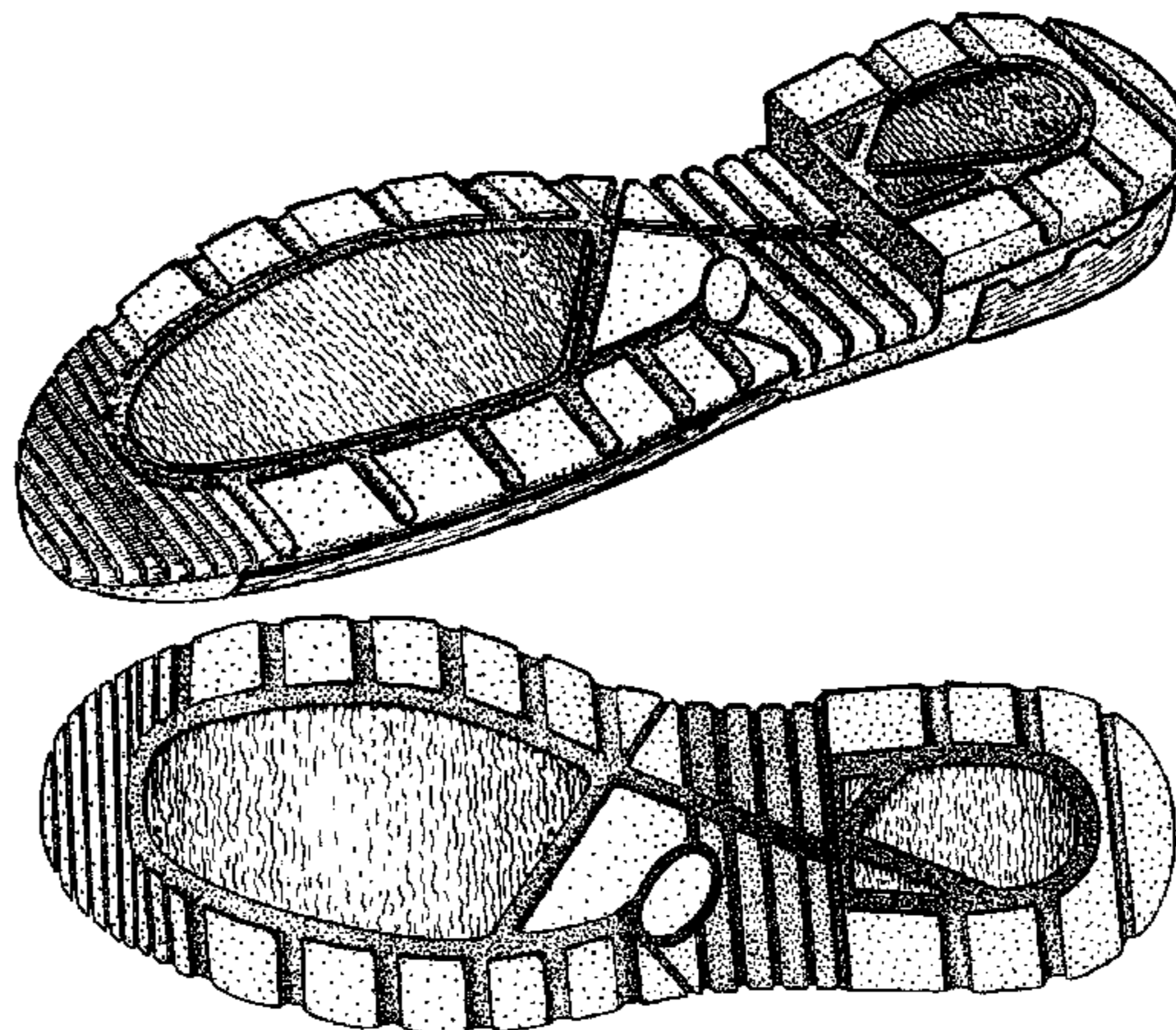
(57) **CLAIM**

What is claimed is the ornamental design for a sole for footwear, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view showing the sole for footwear;
FIG. 2 is a side elevation of the sole for footwear, both sides being identical;
FIG. 3 is a rear elevation of the sole for footwear; and,
FIG. 4 is a bottom view of the sole for footwear.

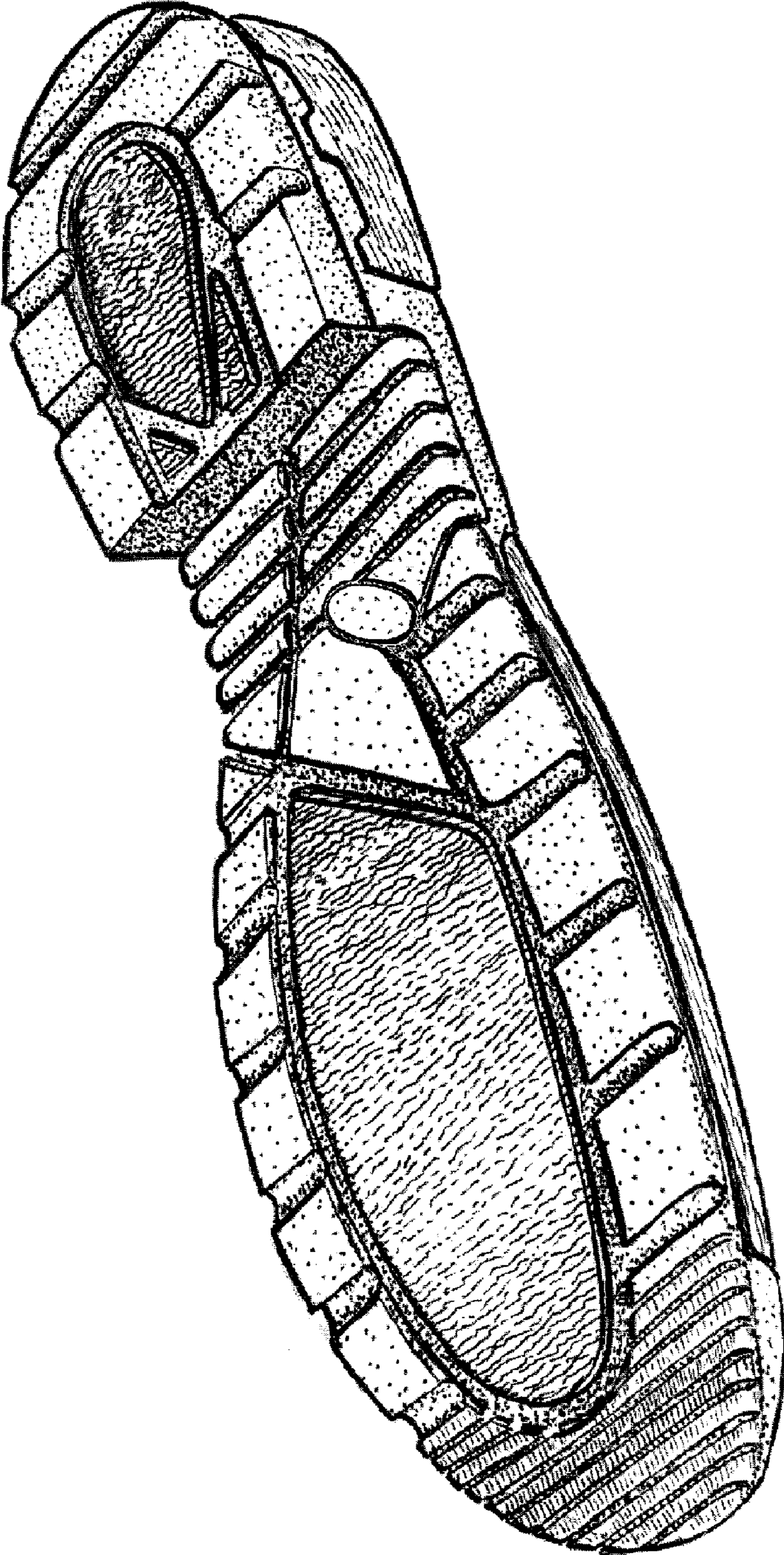

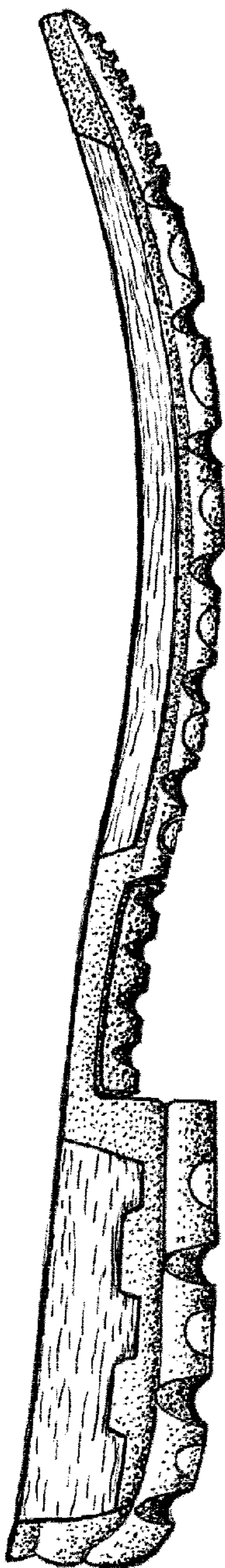

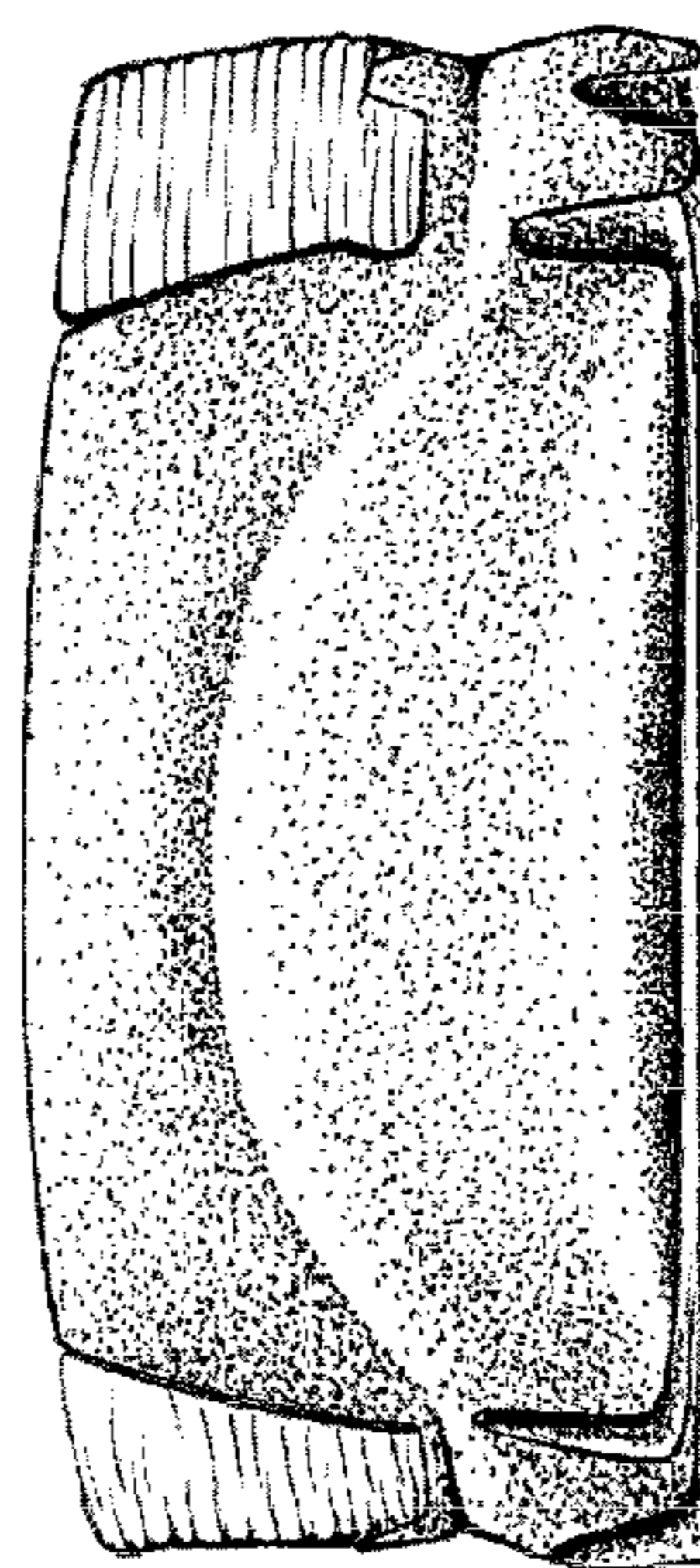

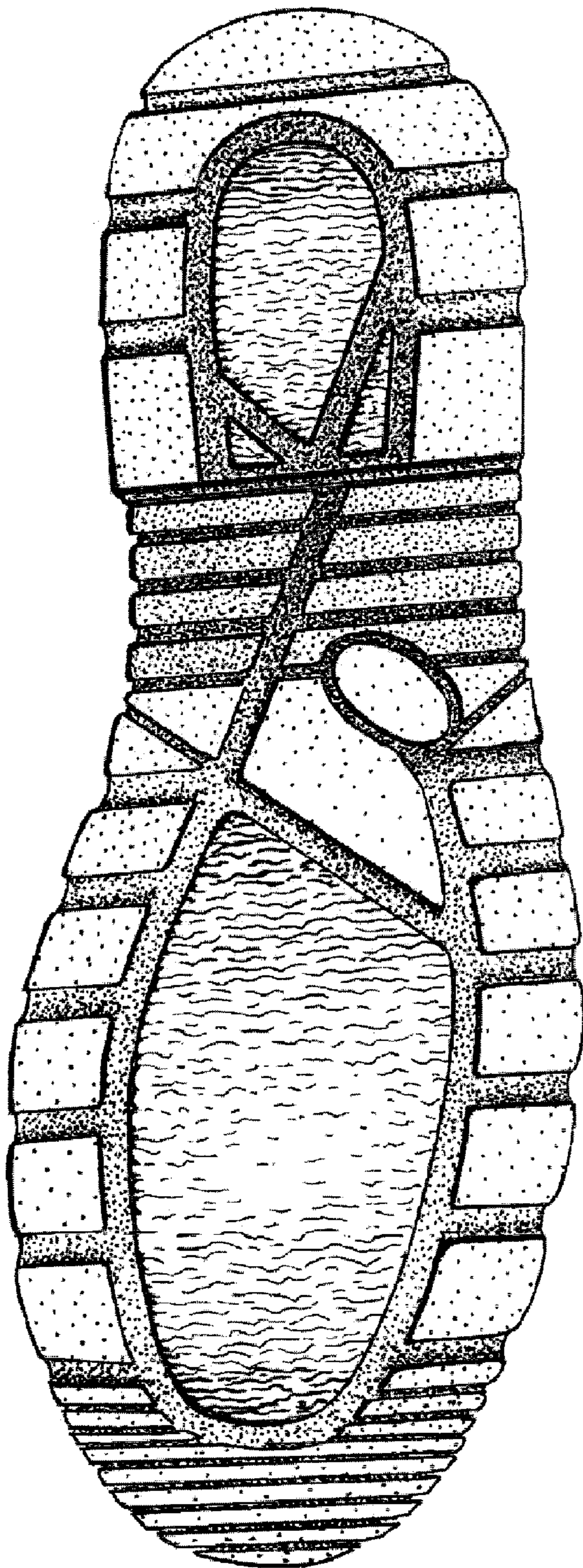
