The ornamental design for a shower hook with ball, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the shower hook with ball according to the invention;

FIG. 2 is a top view of the shower hook with ball as shown in FIG. 1;

FIG. 3 is a front view of the shower hook with ball as shown in FIG. 1;

FIG. 4 is a side view of the shower hook with ball as shown in FIG. 1, which is identical to the other side view;

FIG. 5 is a rear view of the shower hook with ball as shown in FIG. 1; and,

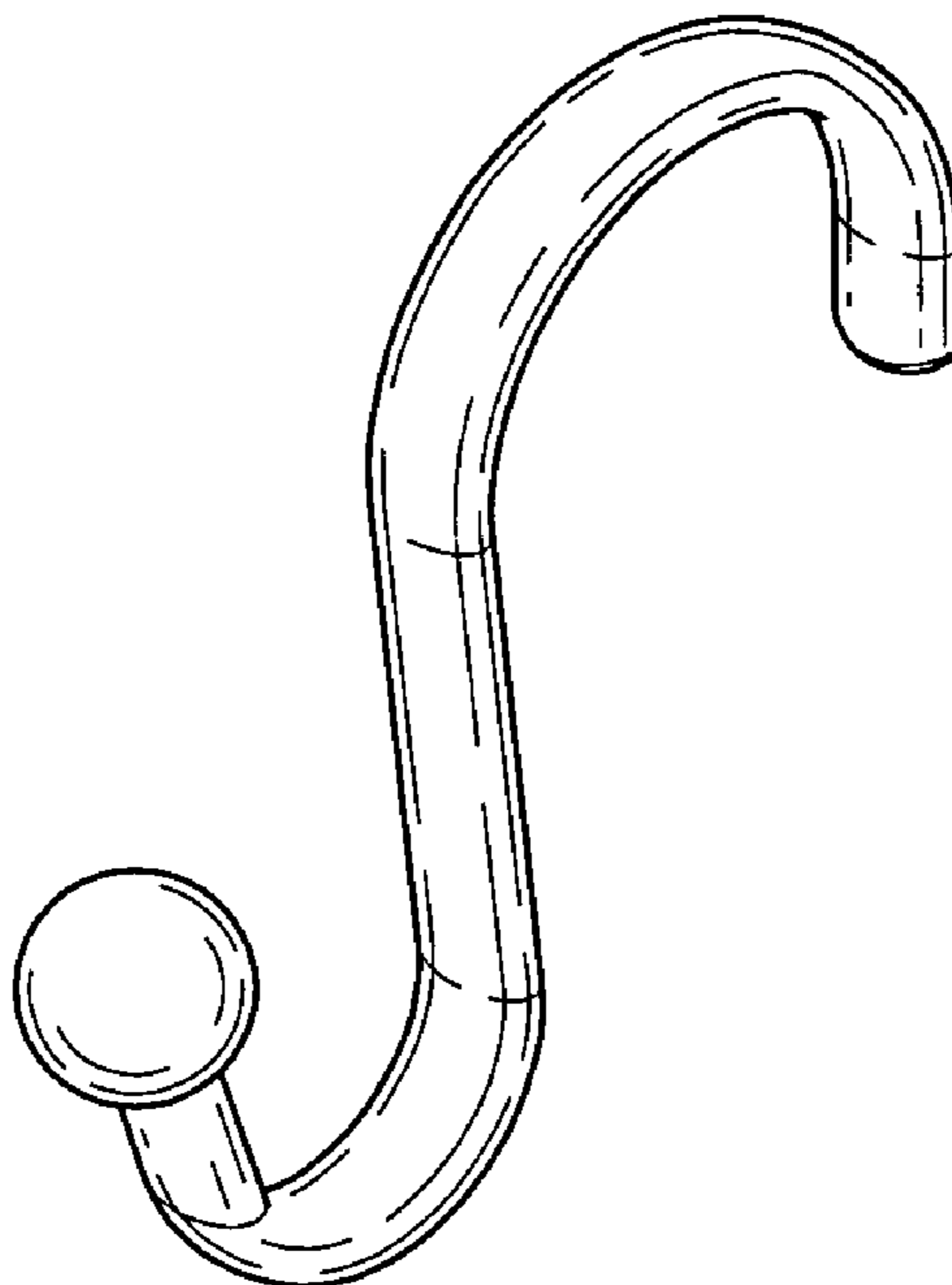
FIG. 6 is a bottom view of the shower hook with ball as shown in FIG. 1.

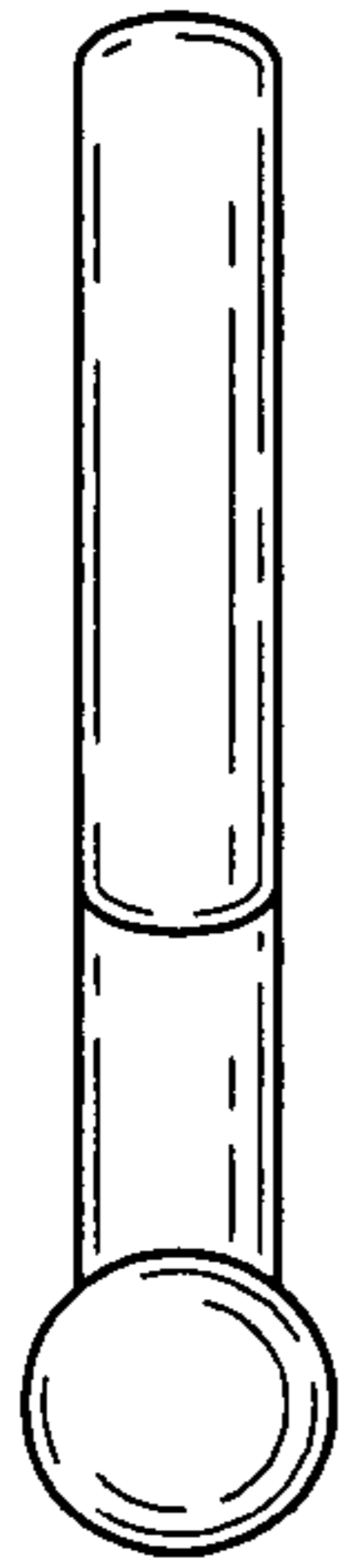

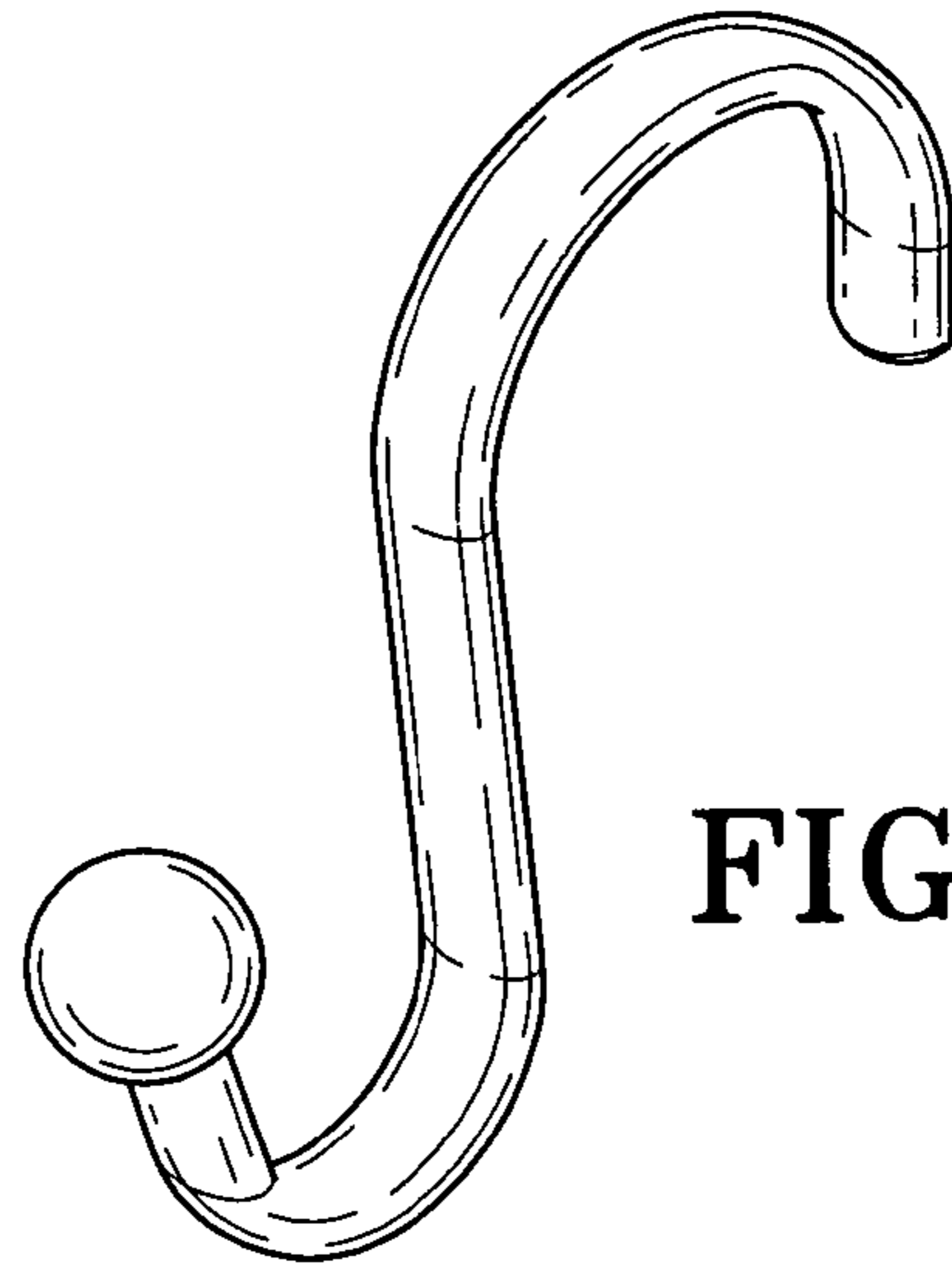

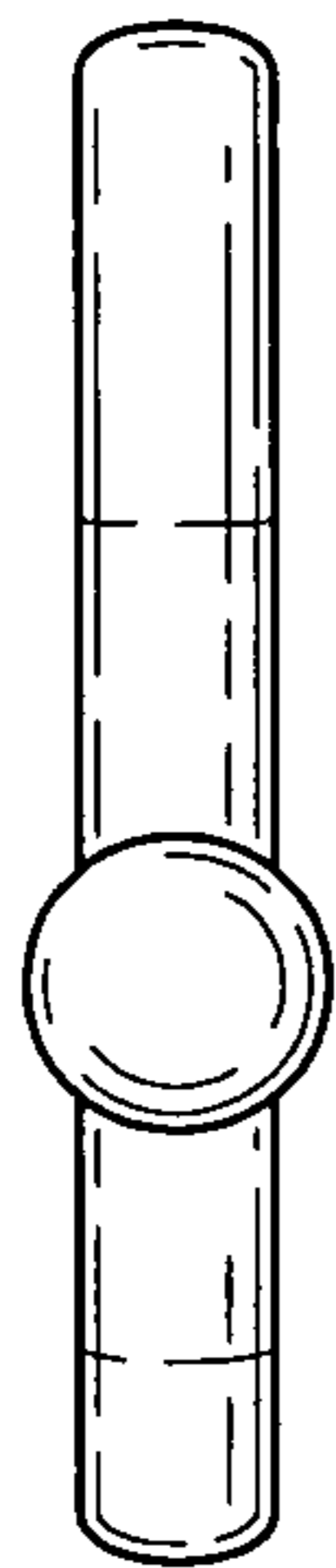

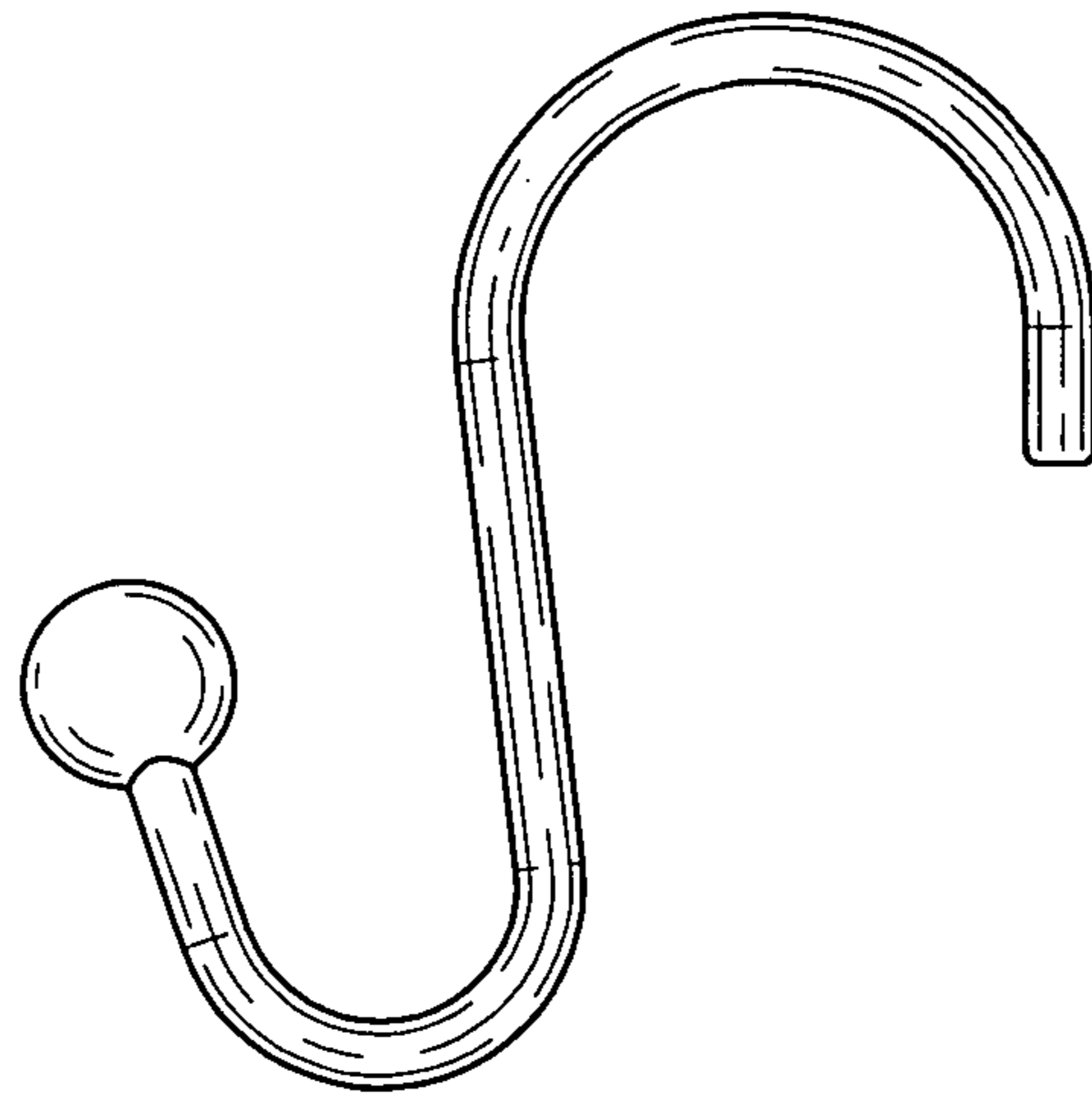

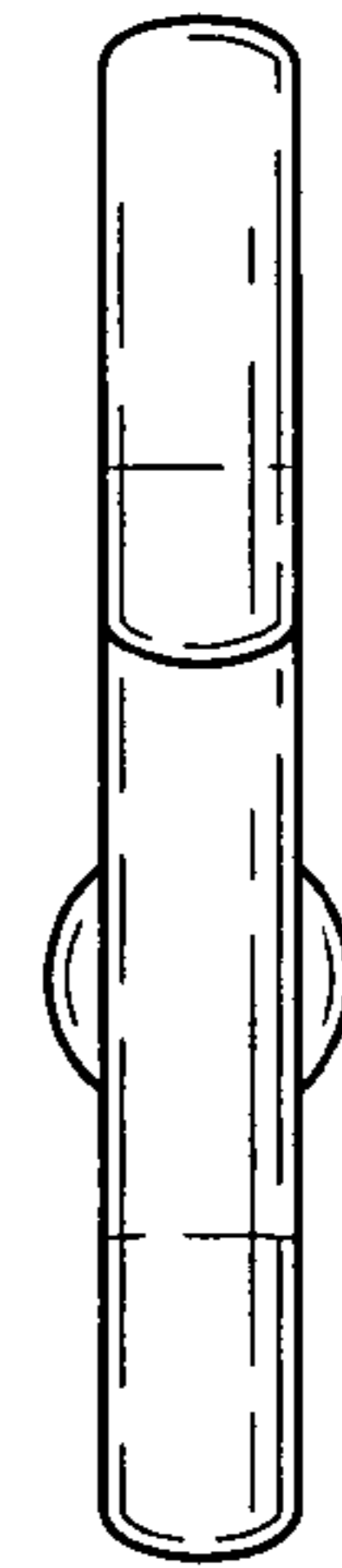

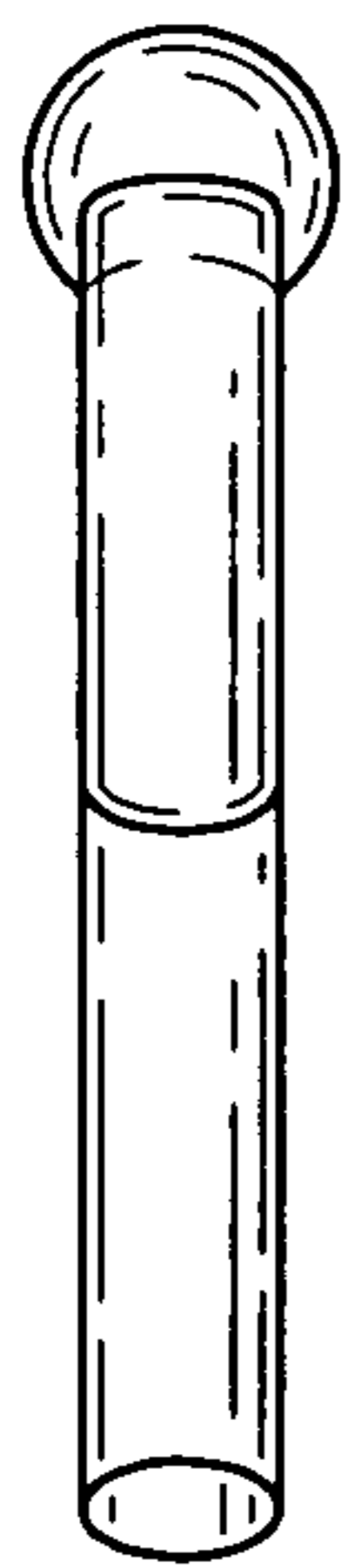
