The ornamental design for a clip member, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective illustration from the top of the clip member;

FIG. 2 is a side elevational view of the clip member of FIG. 1, taken from the left side thereof, the right side being a mirror image thereof;

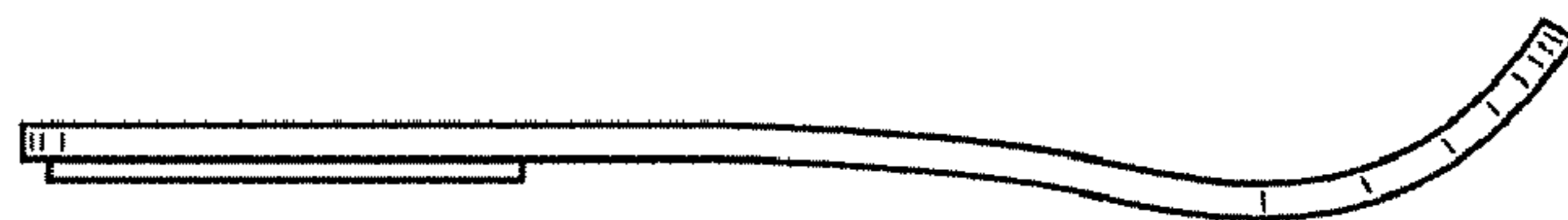
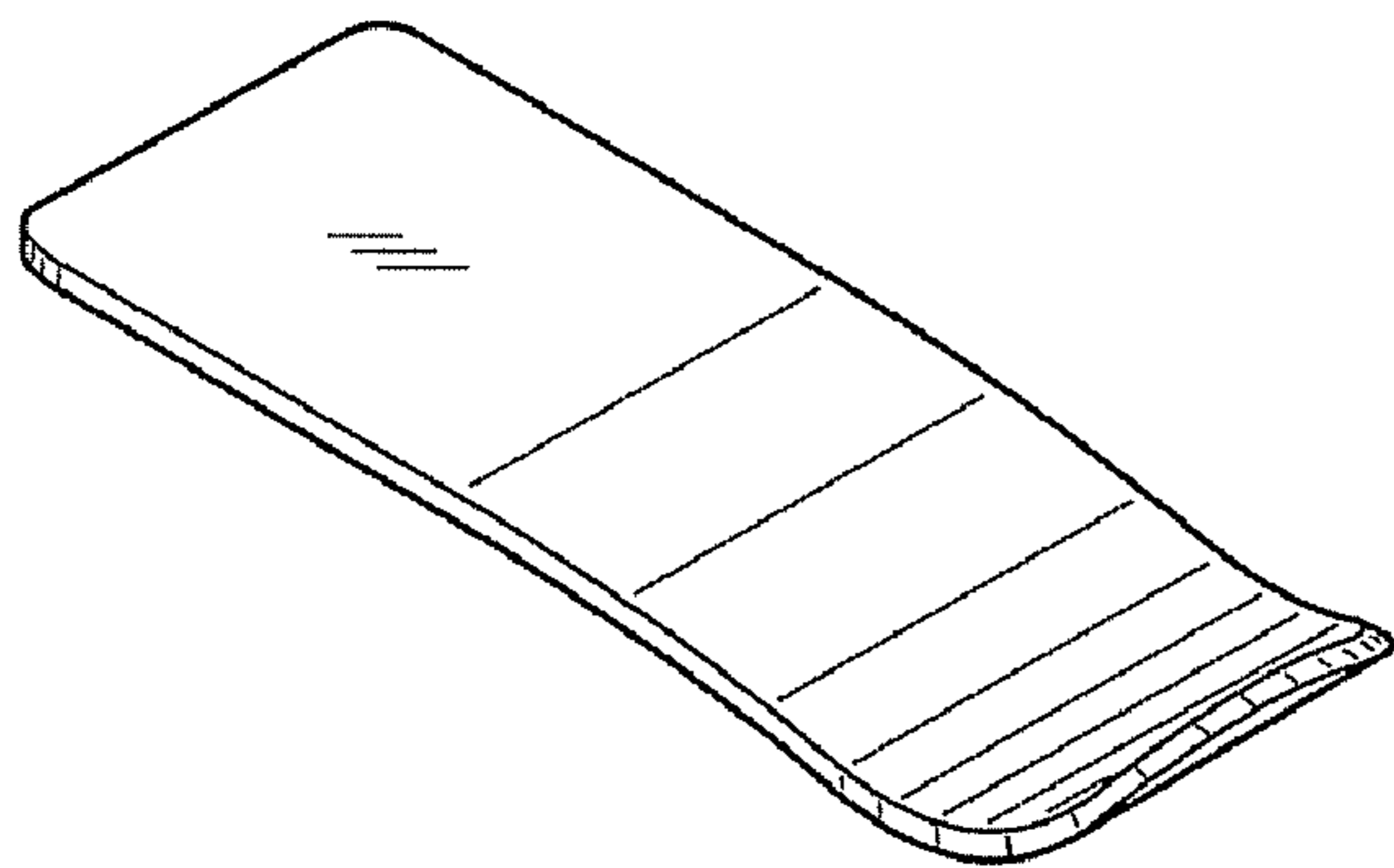
FIG. 3 is a top plan view of the clip member of FIG. 1;

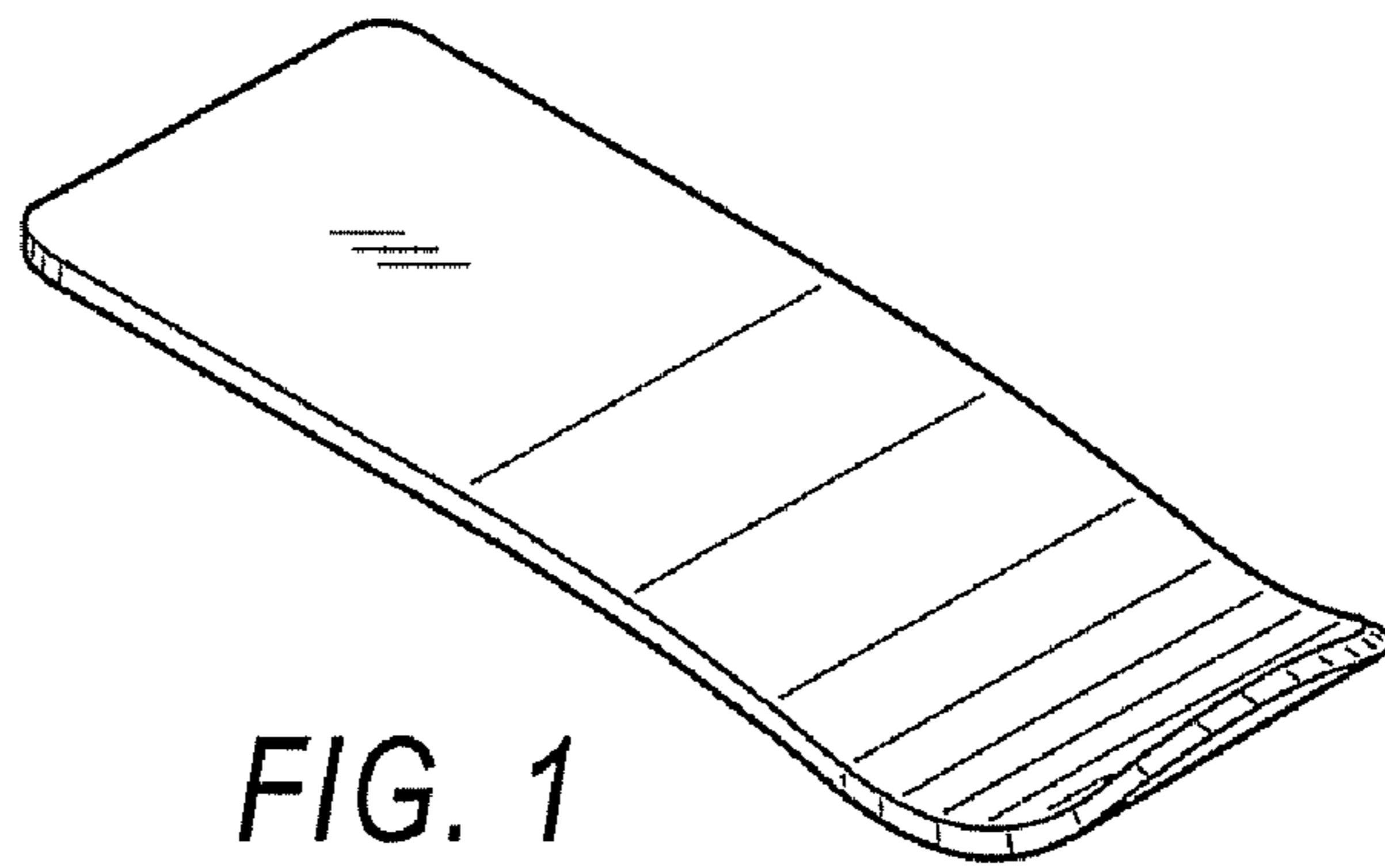

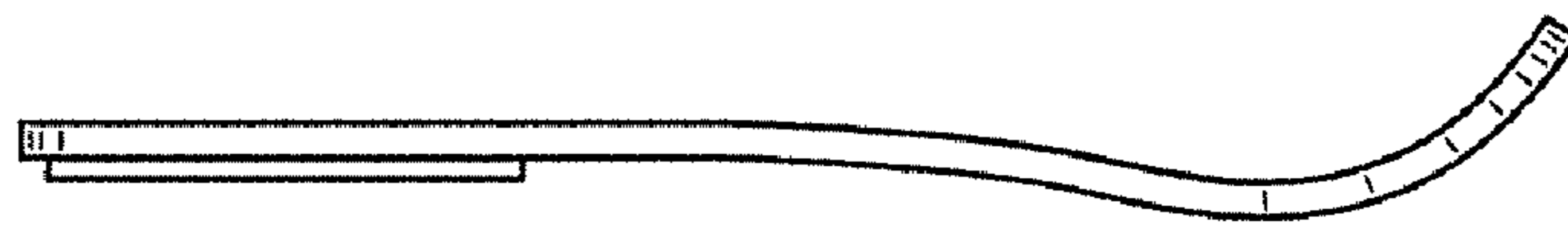

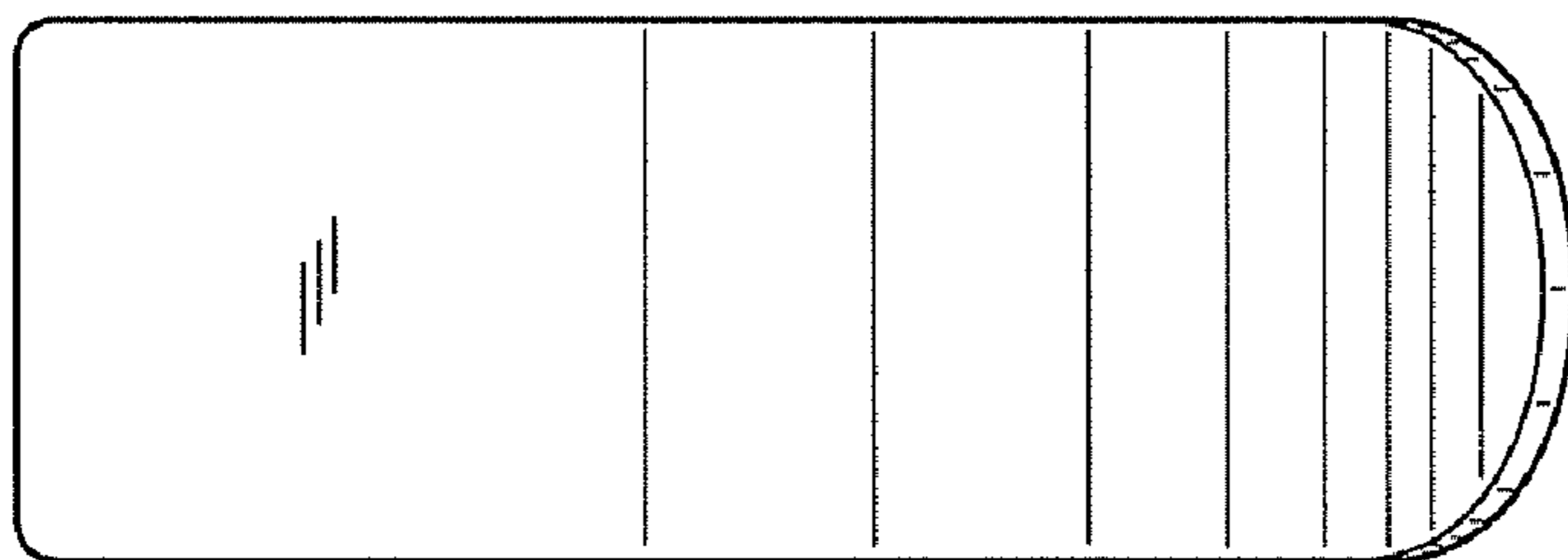

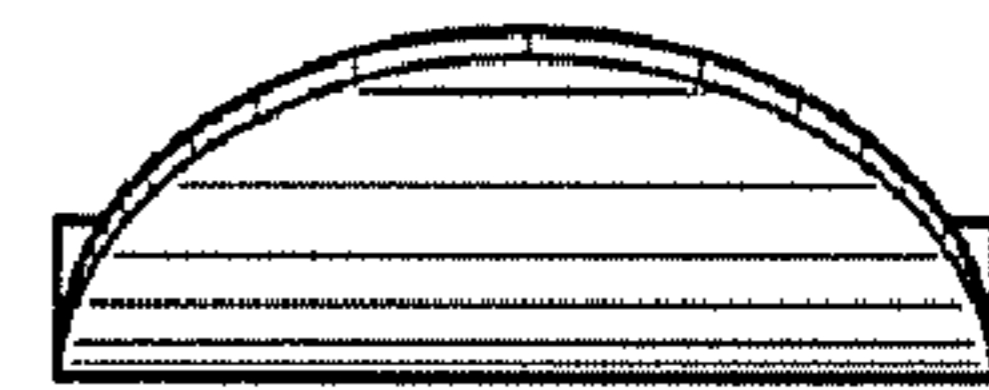

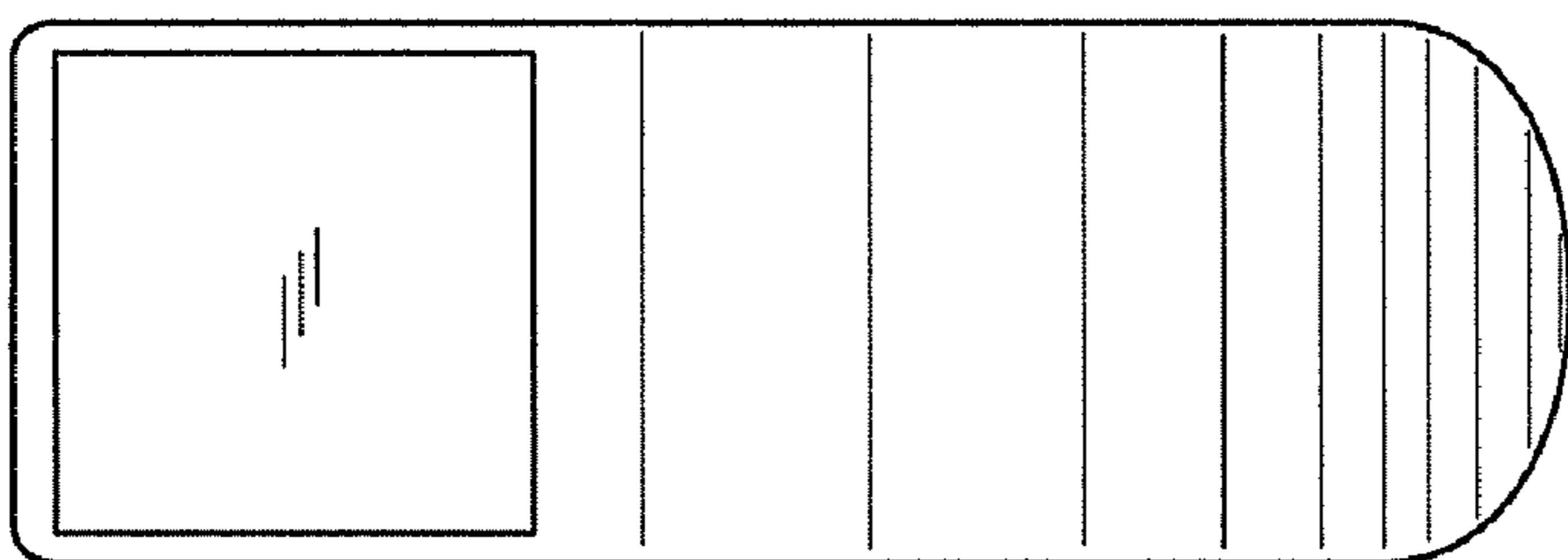

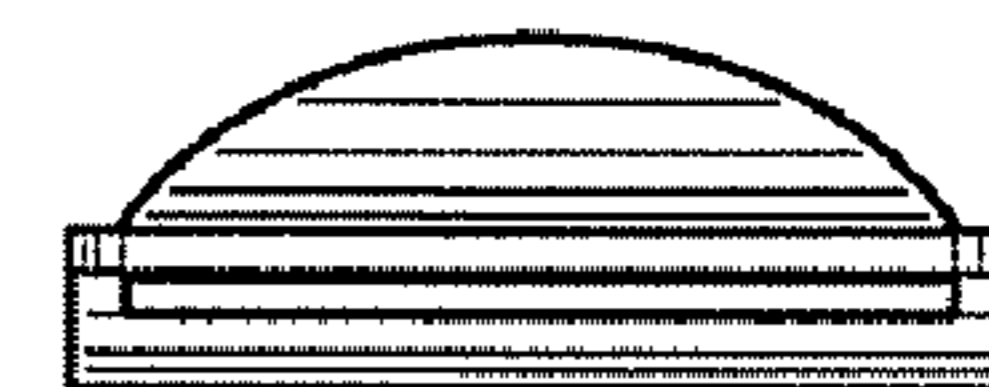
