(57) **CLAIM**

The ornamental design for a medicinal container with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a medicinal container with surface ornamentation showing our new design;

FIG. 2 is a front elevation view thereof;

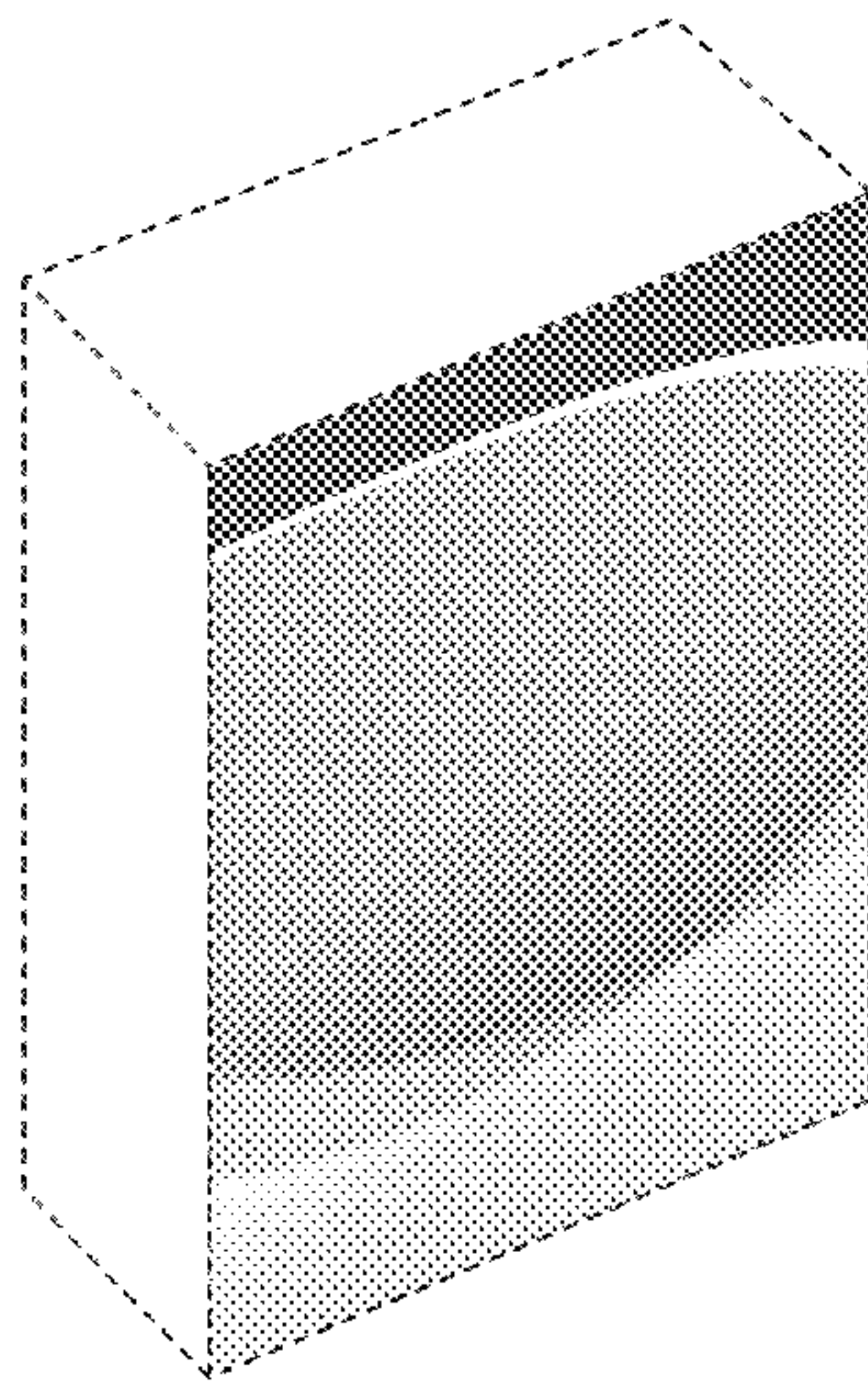
FIG. 3 is bottom plan view thereof;

FIG. 4 is a right side view thereof, the opposing left side view being a mirror image thereof; and,

FIG. 5 is a rear view thereof.

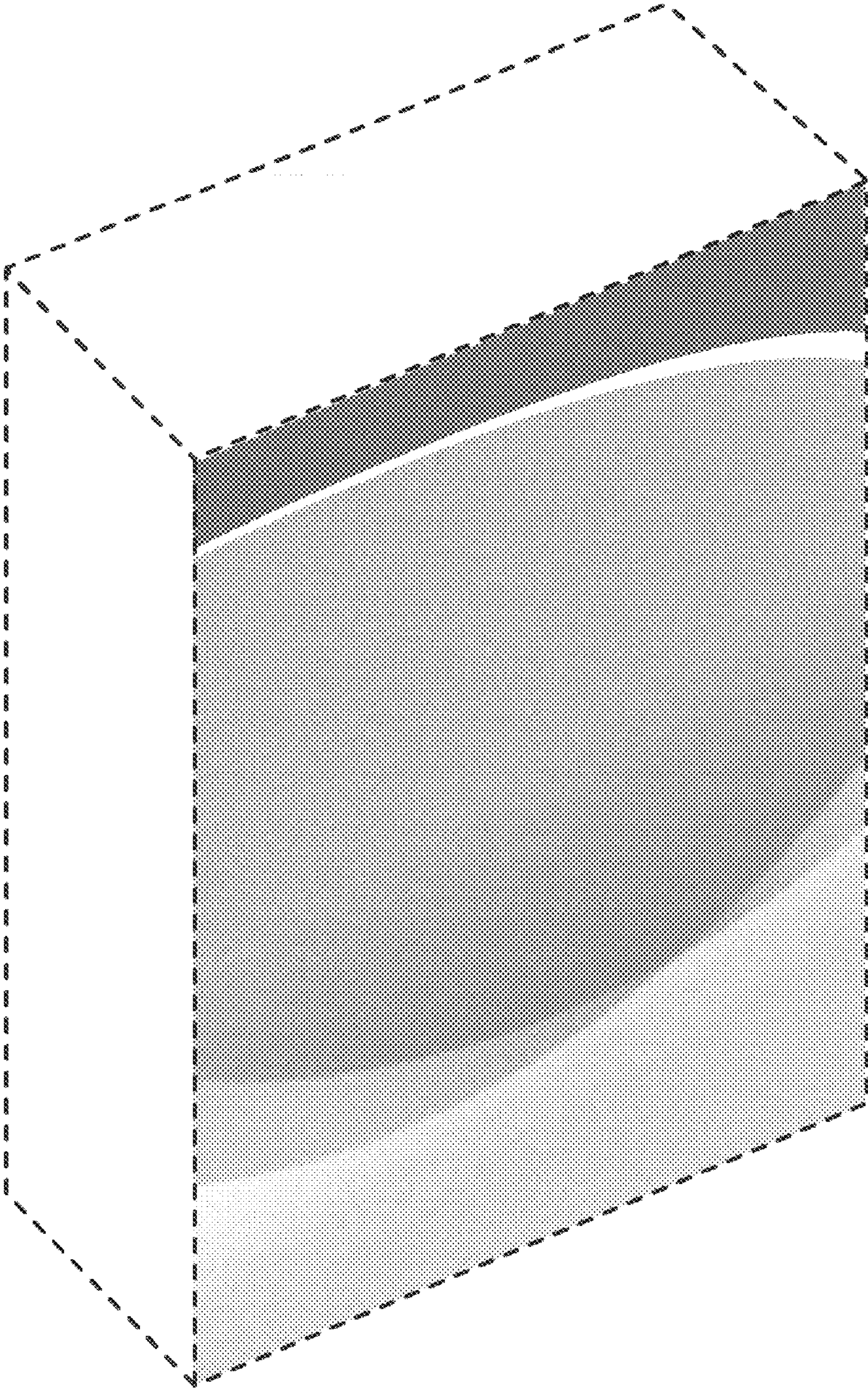

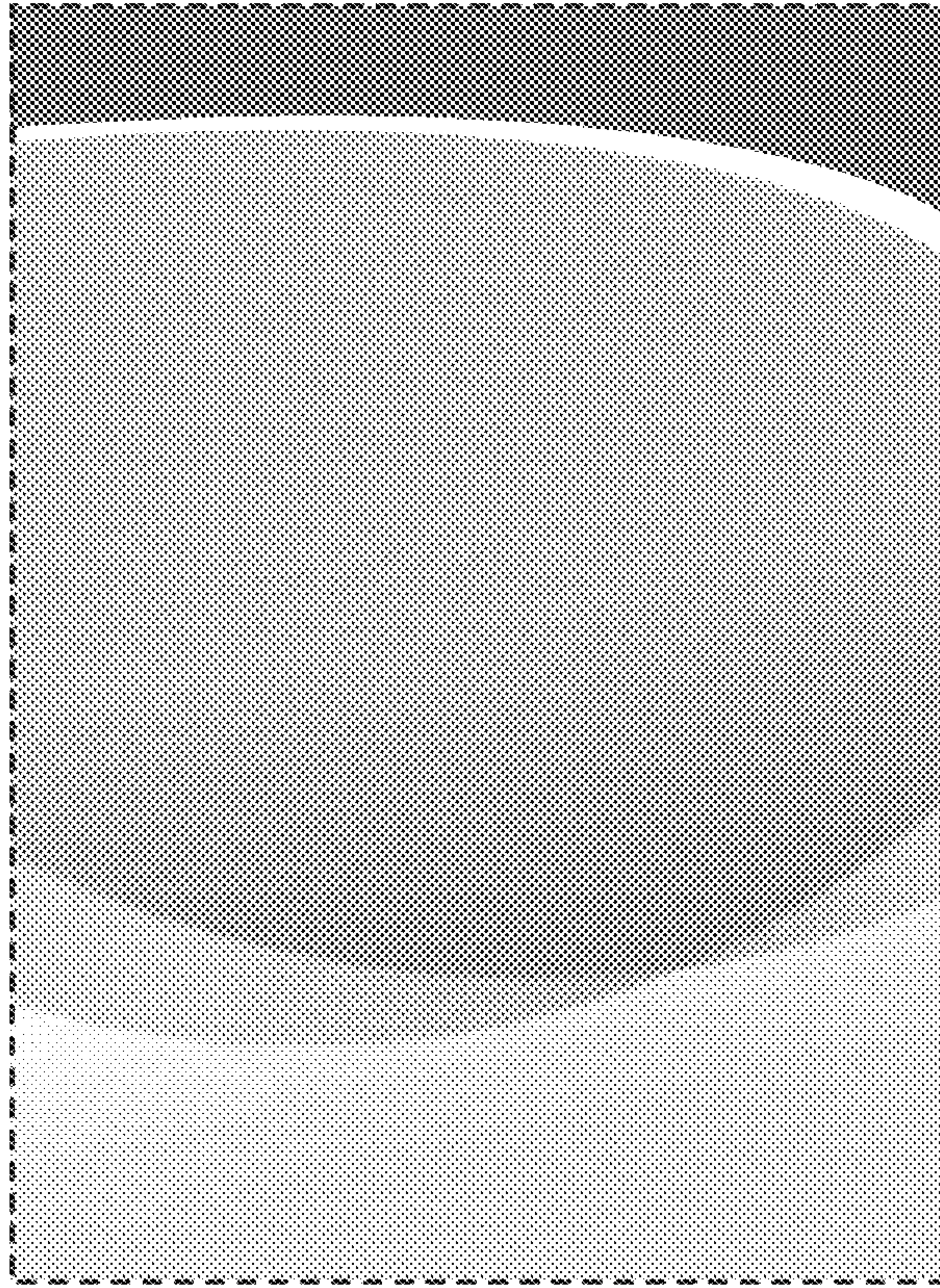

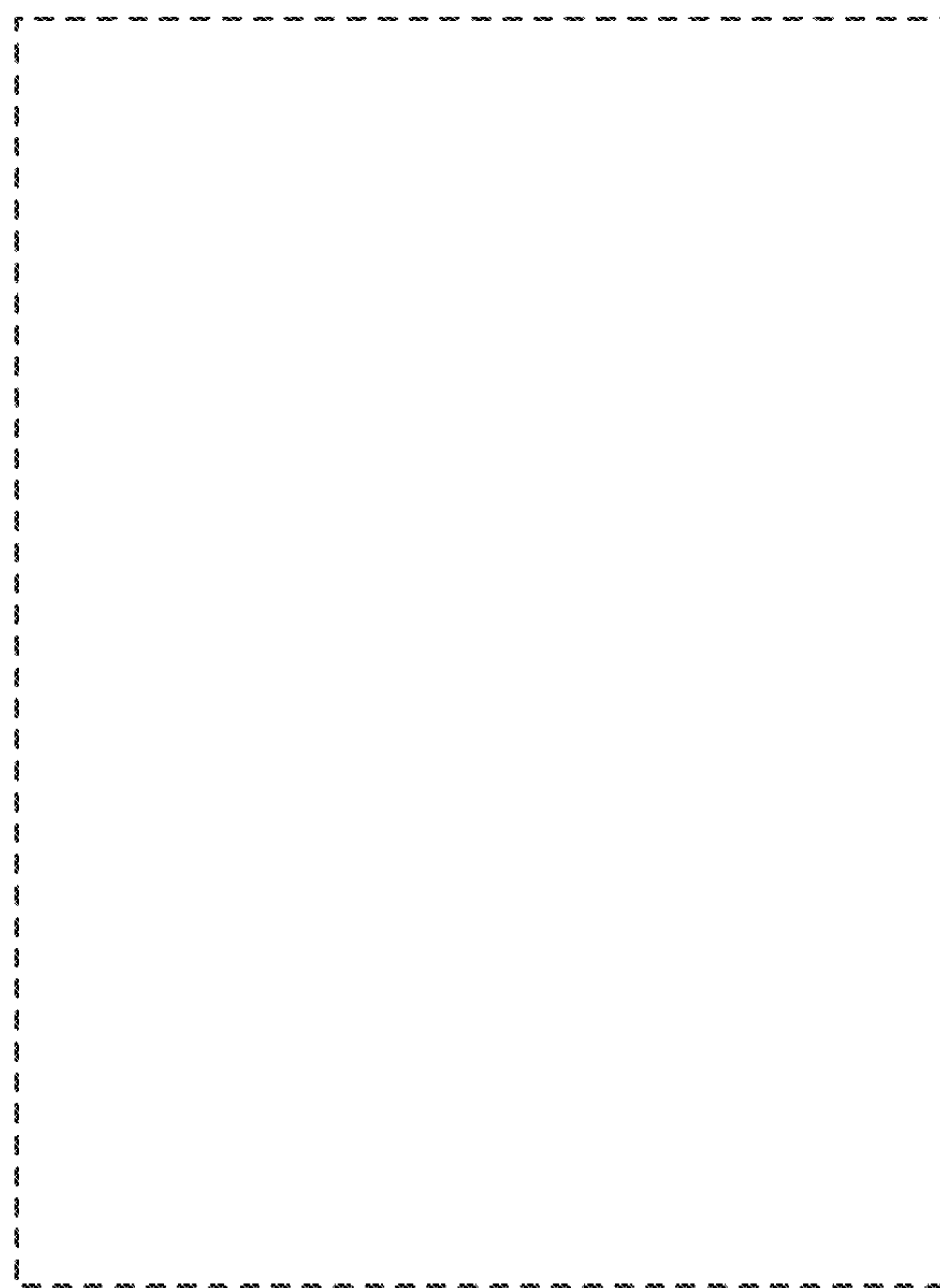

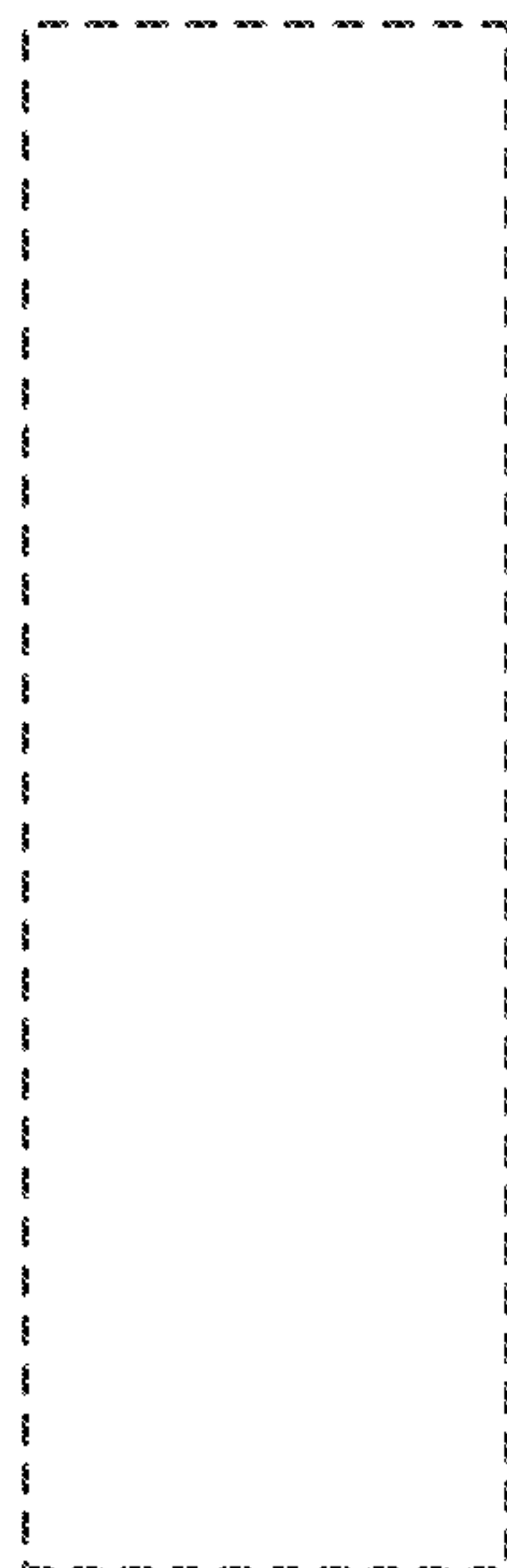
