The ornamental design for a rear portion of a vehicle, toy replica and/or other replicas, as shown and described.

DESCRIPTION

This application contains subject matter related to the following co-pending U.S. applications:

FIG. 1 is a left, front perspective view of a rear portion of a vehicle, toy replica and/or other replicas according to my novel design, the right, front perspective view being mirror symmetrical;

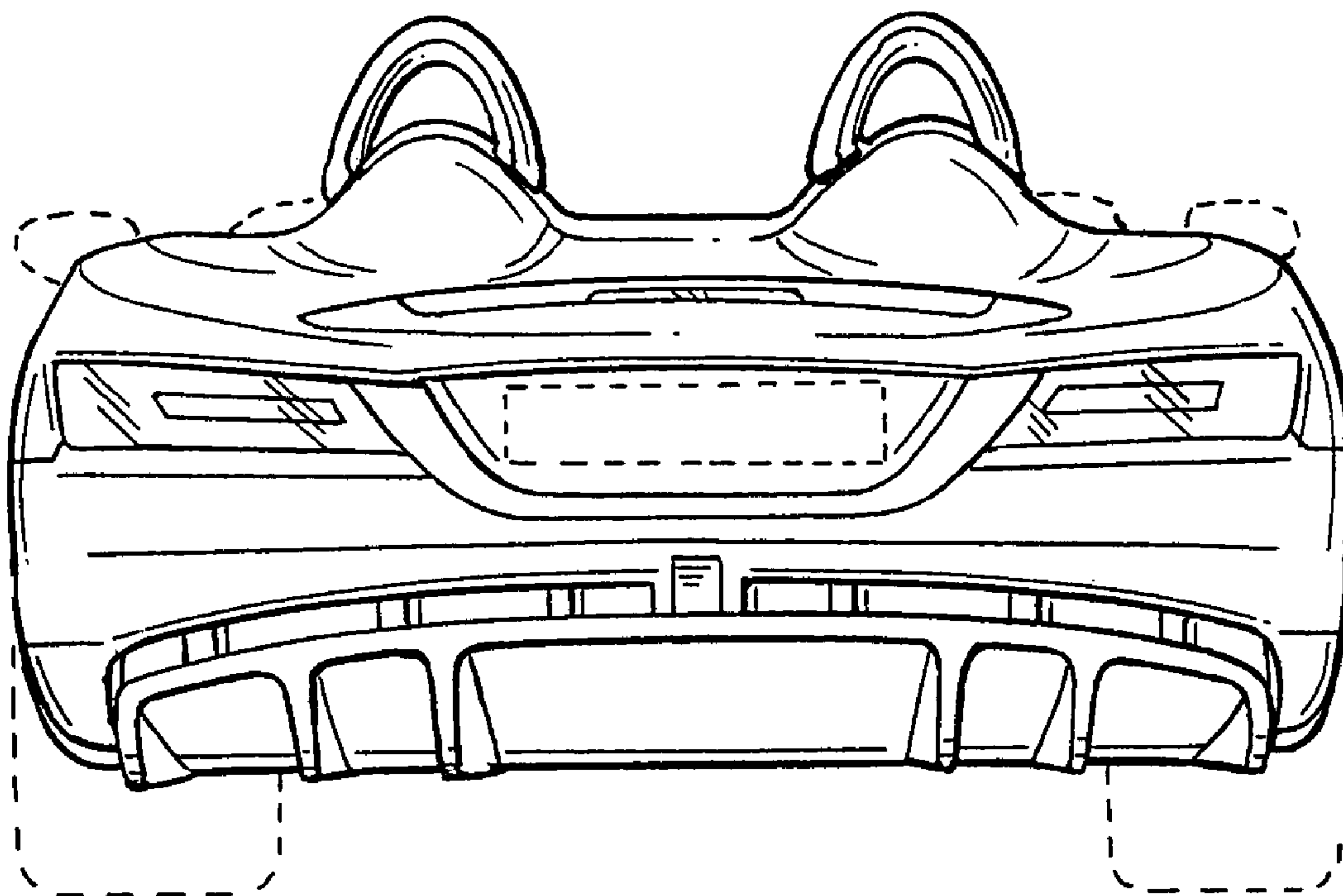
FIG. 2 is a front view thereof;

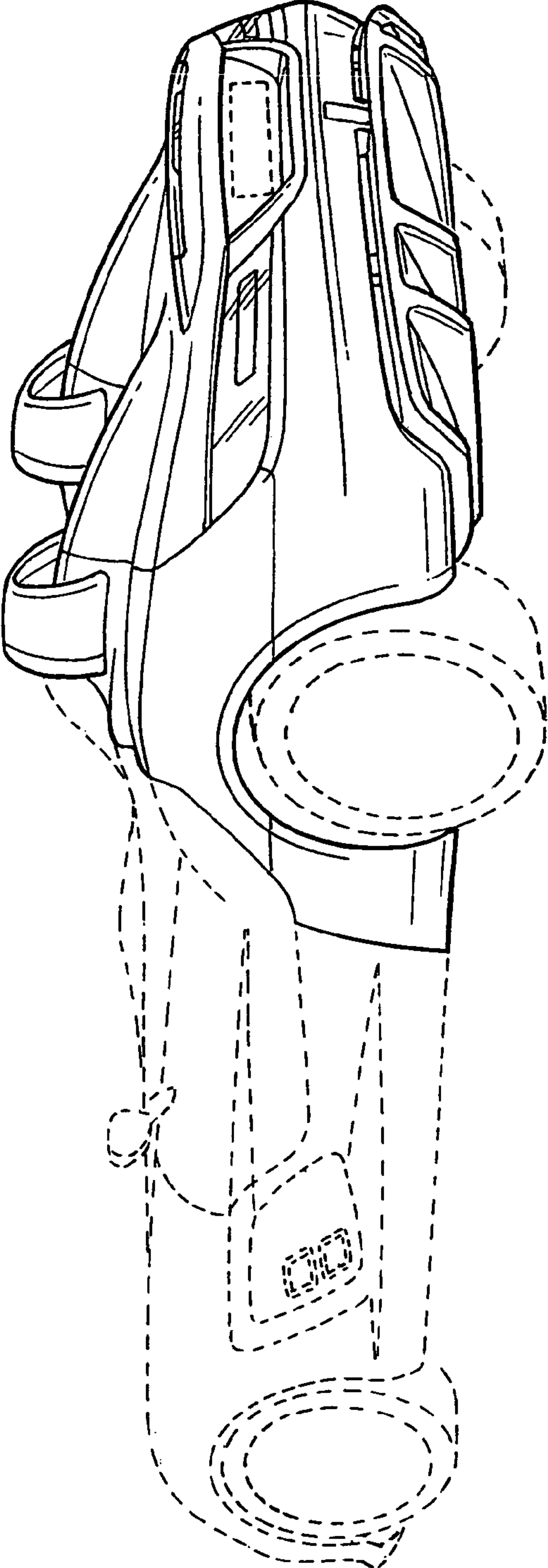

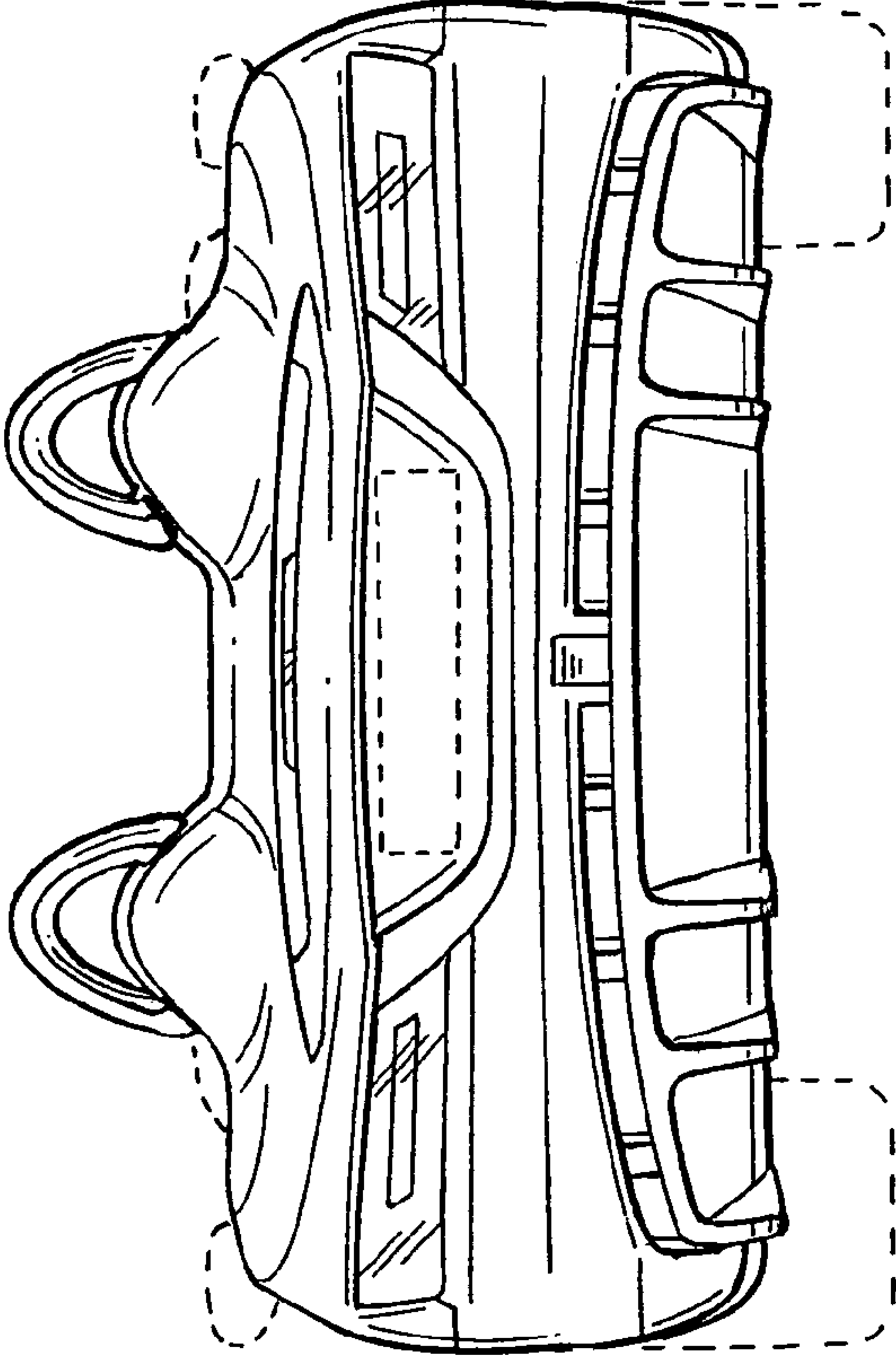

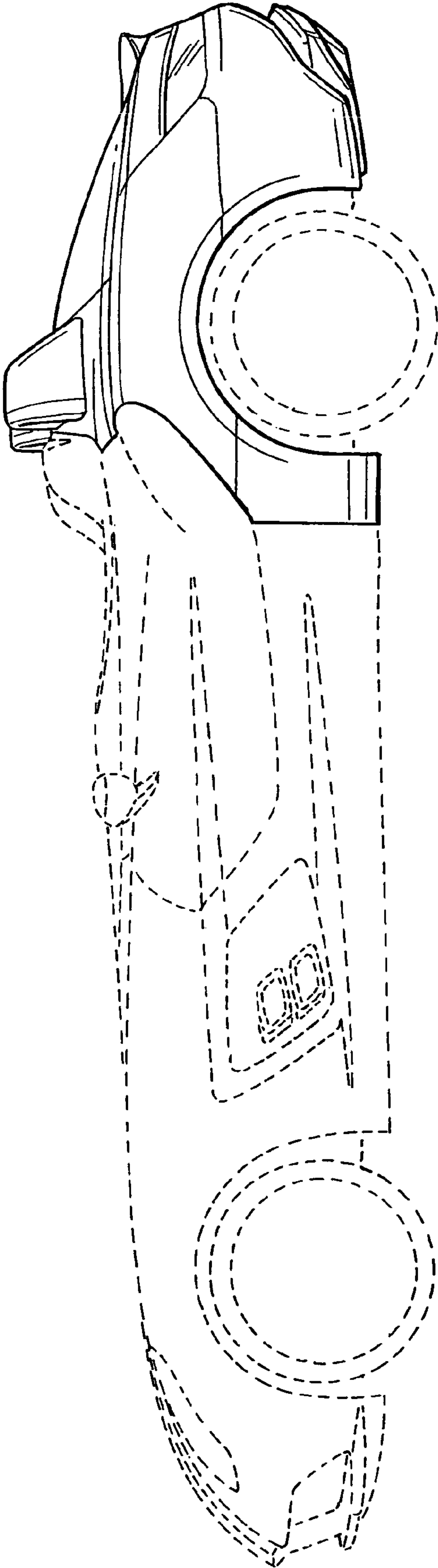

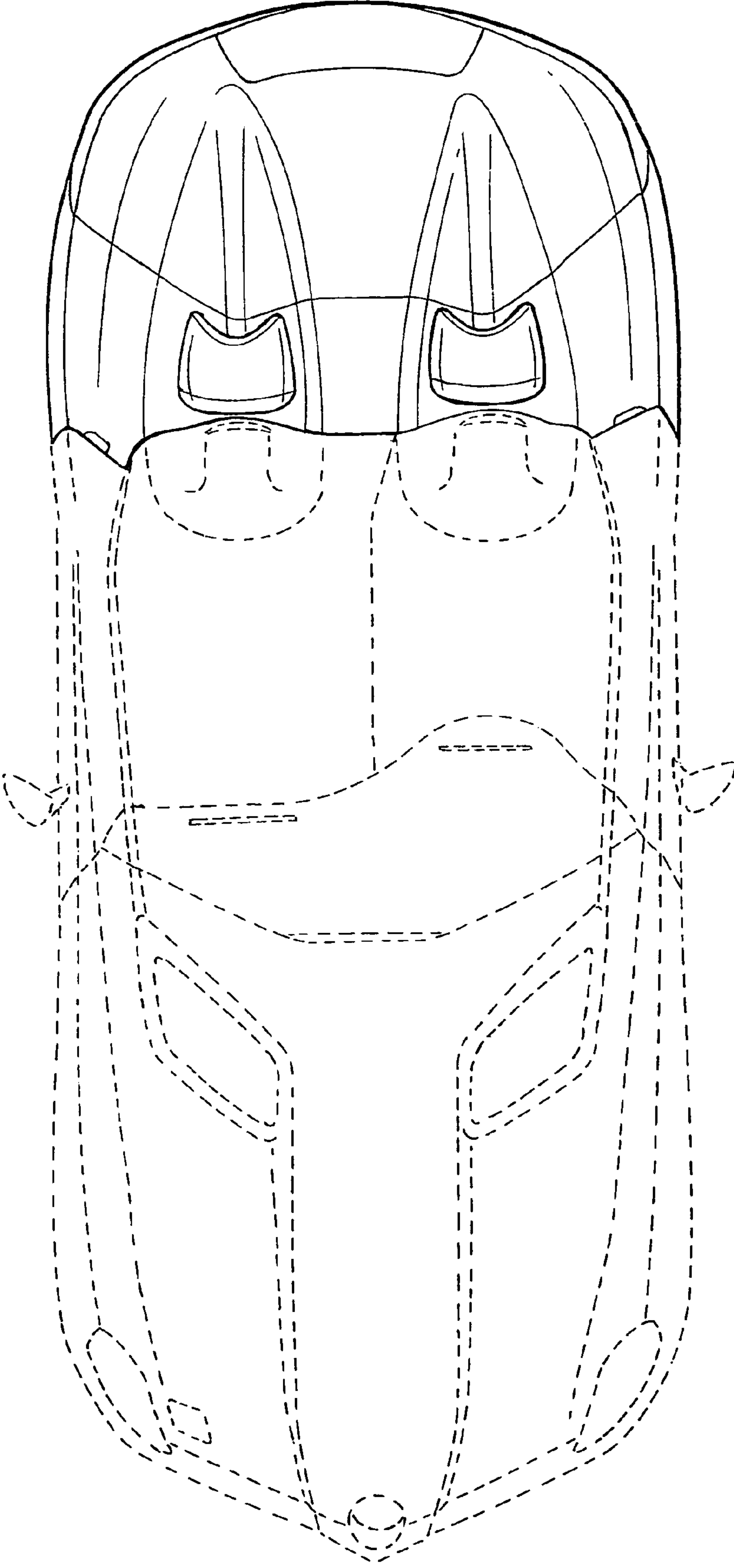
