FIG. 3 is a left side view of the first embodiment;

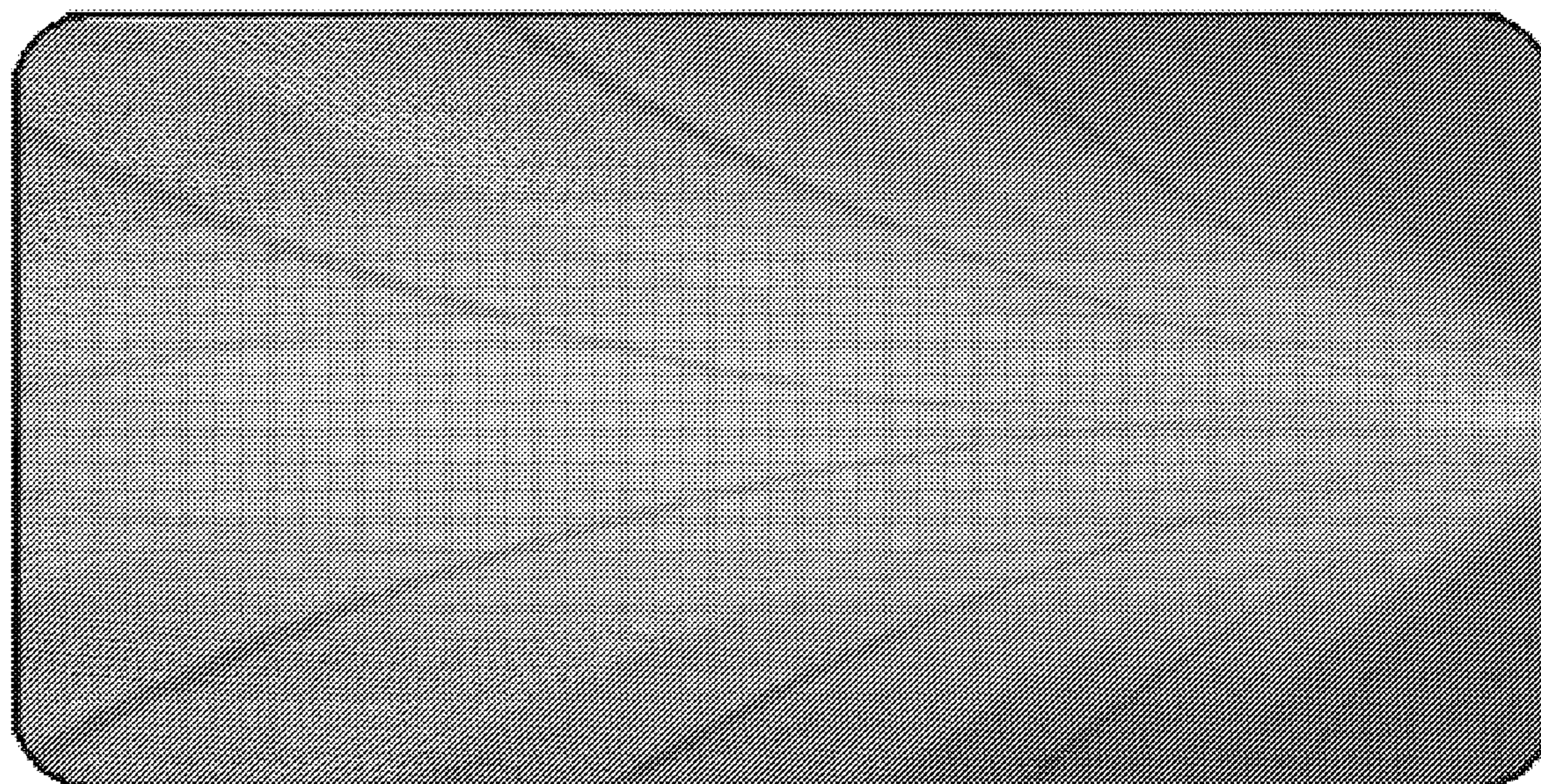
FIG. 4 is a perspective view of back cover for electronic

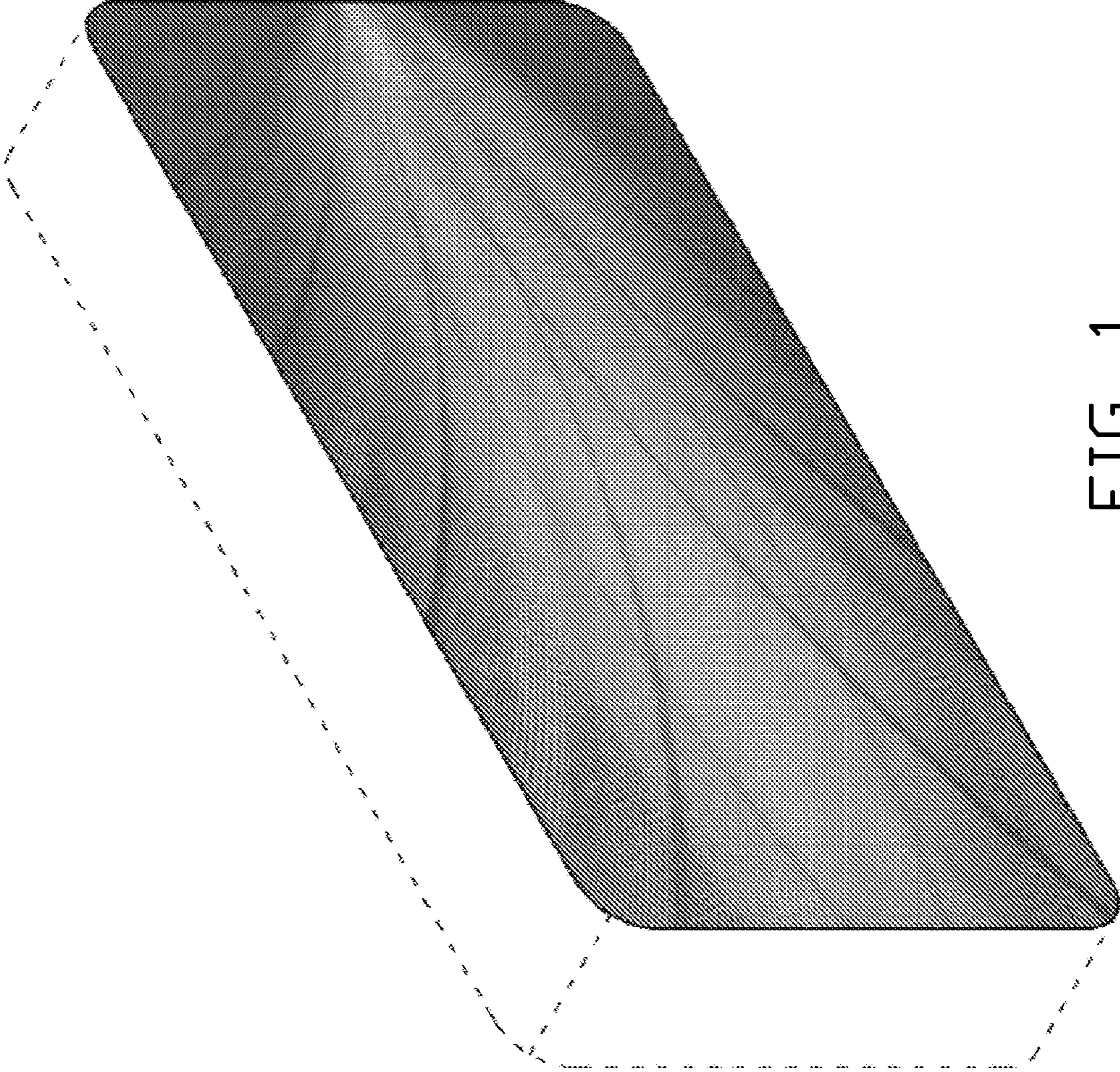

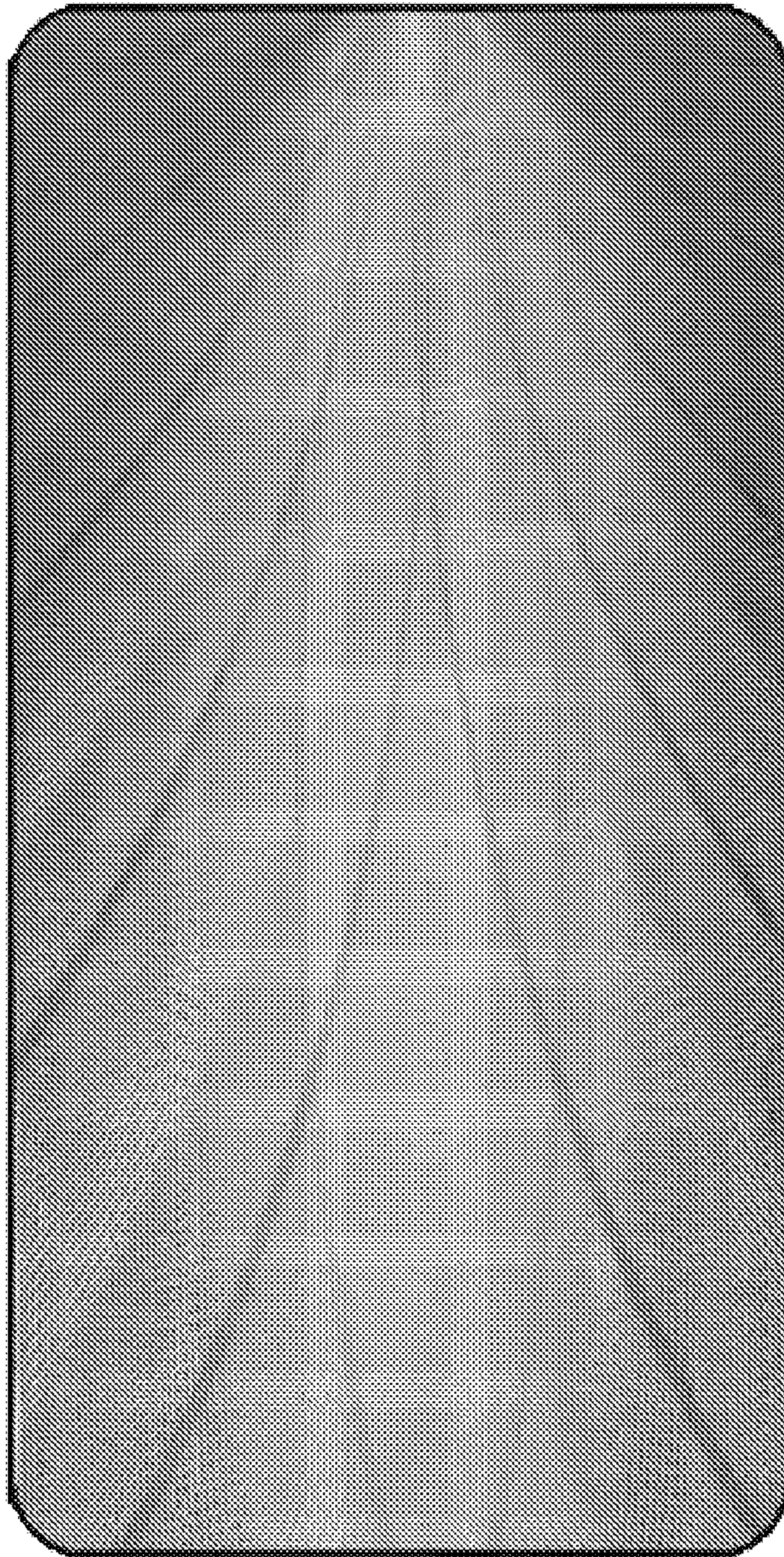

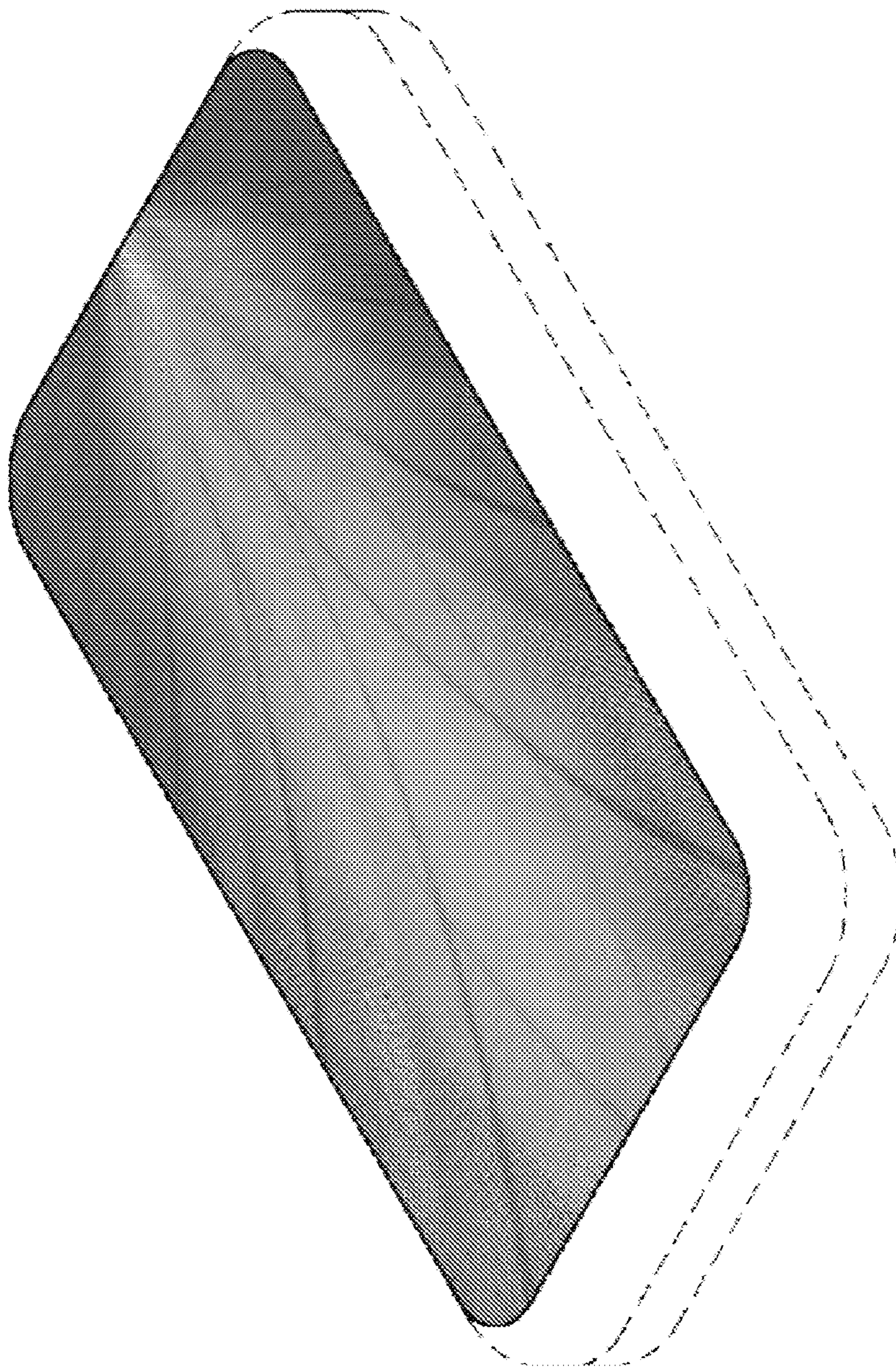

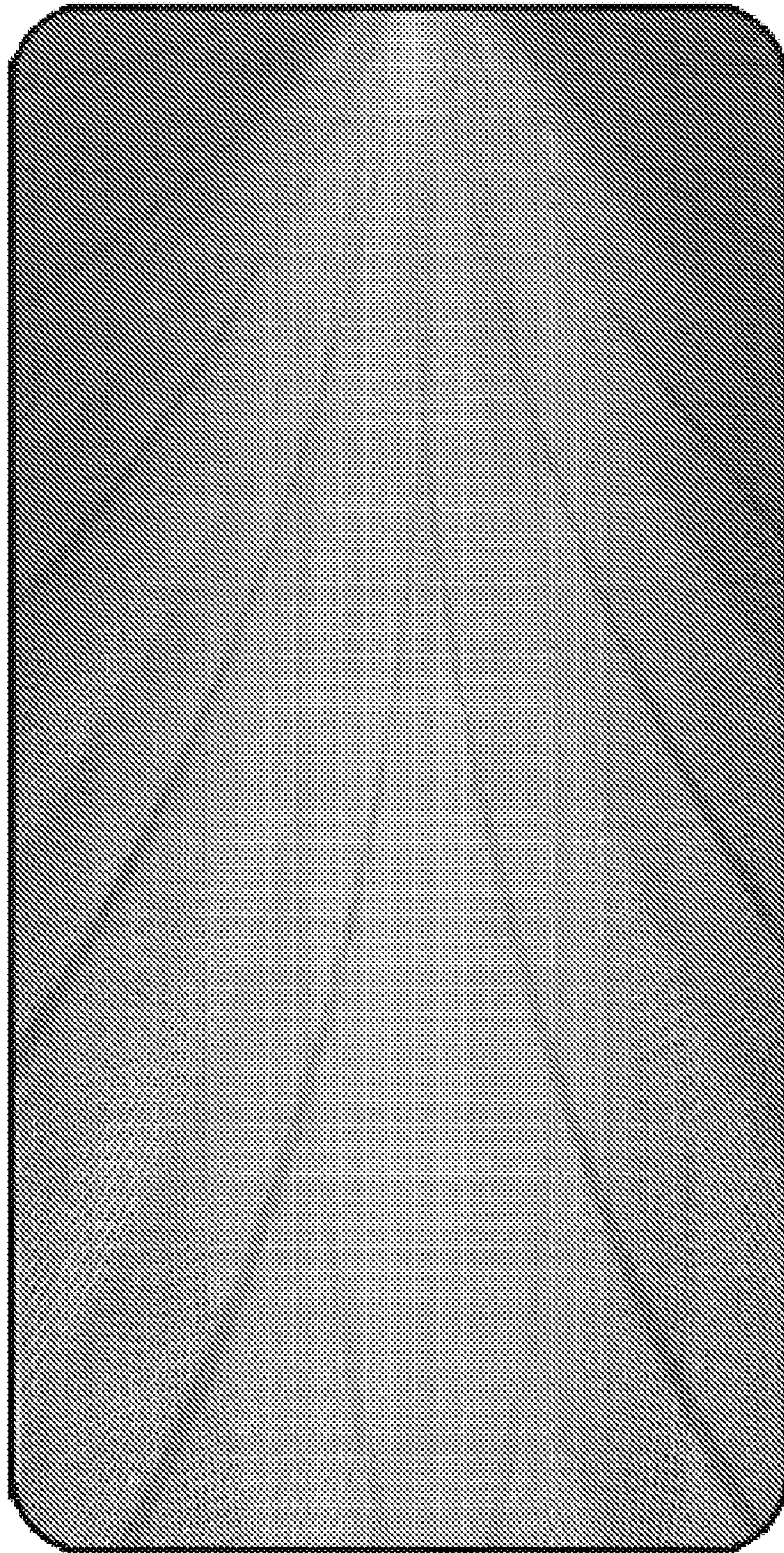

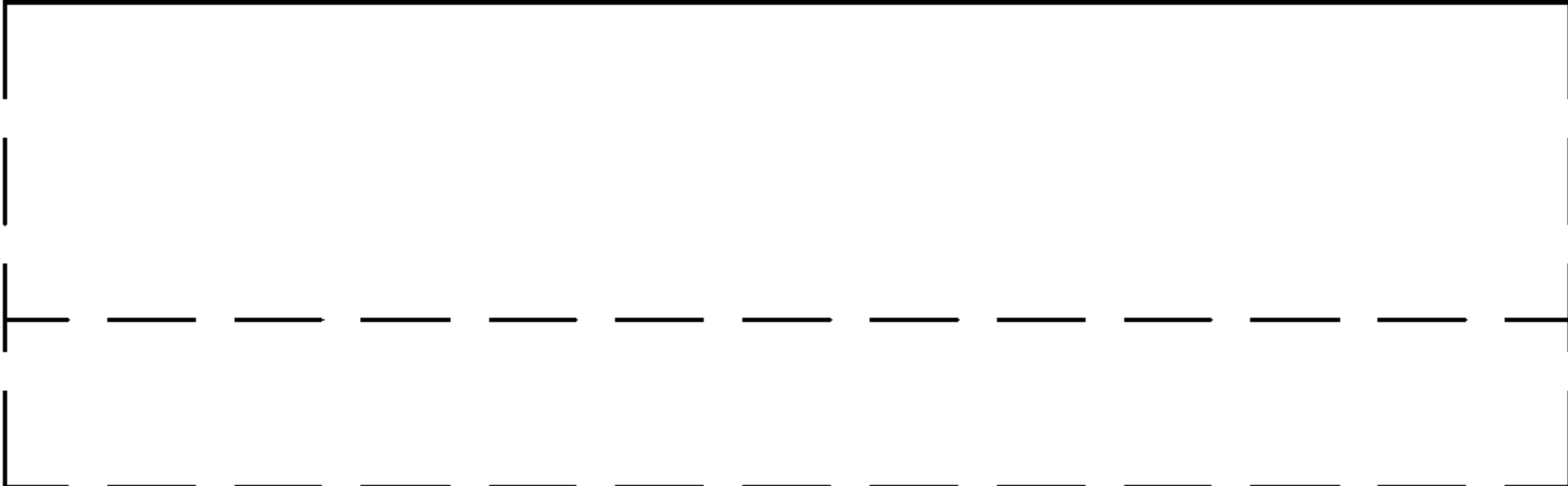
