The ornamental design for an optical disc drive, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of an optical disc drive showing our new design;

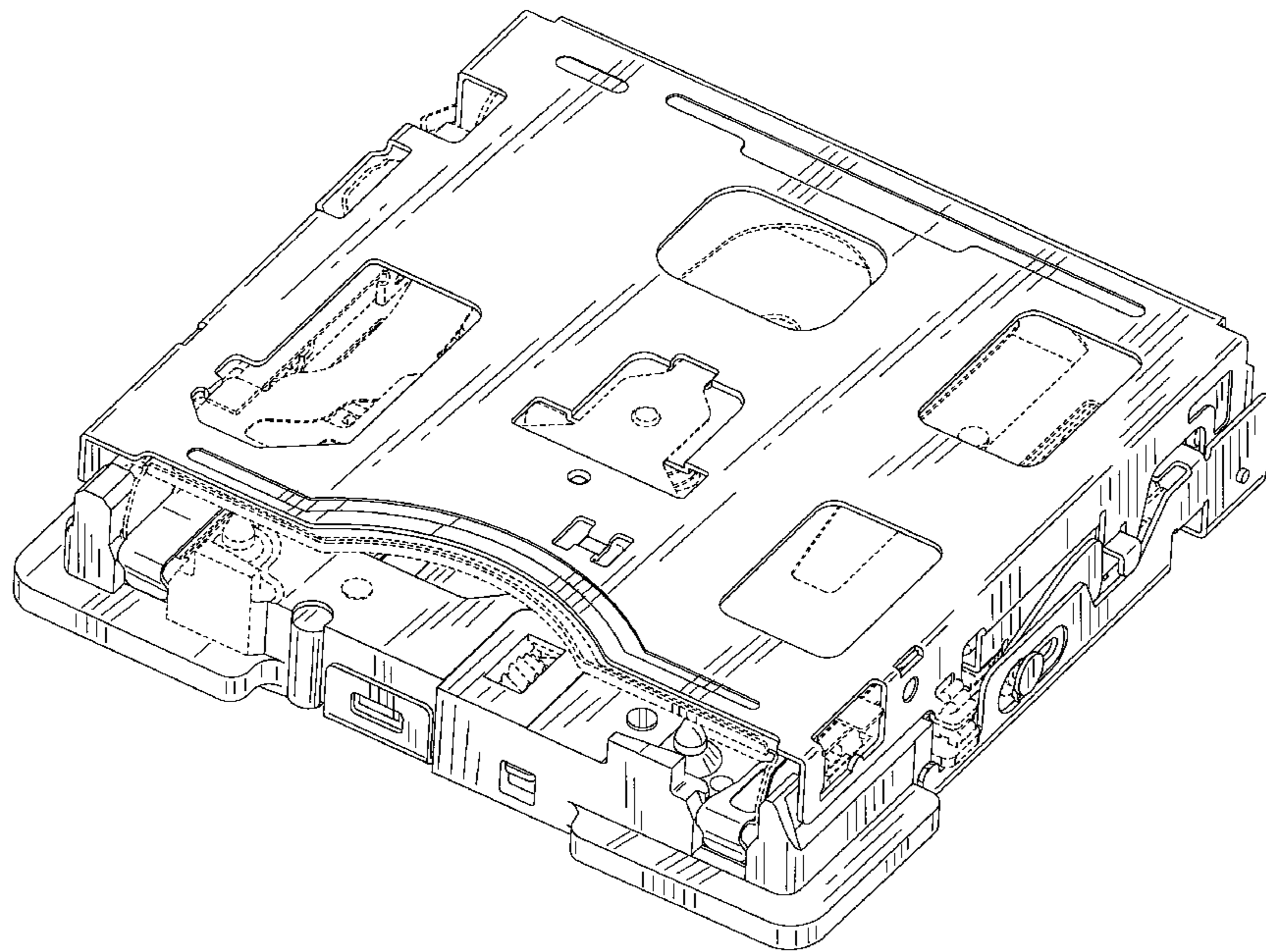

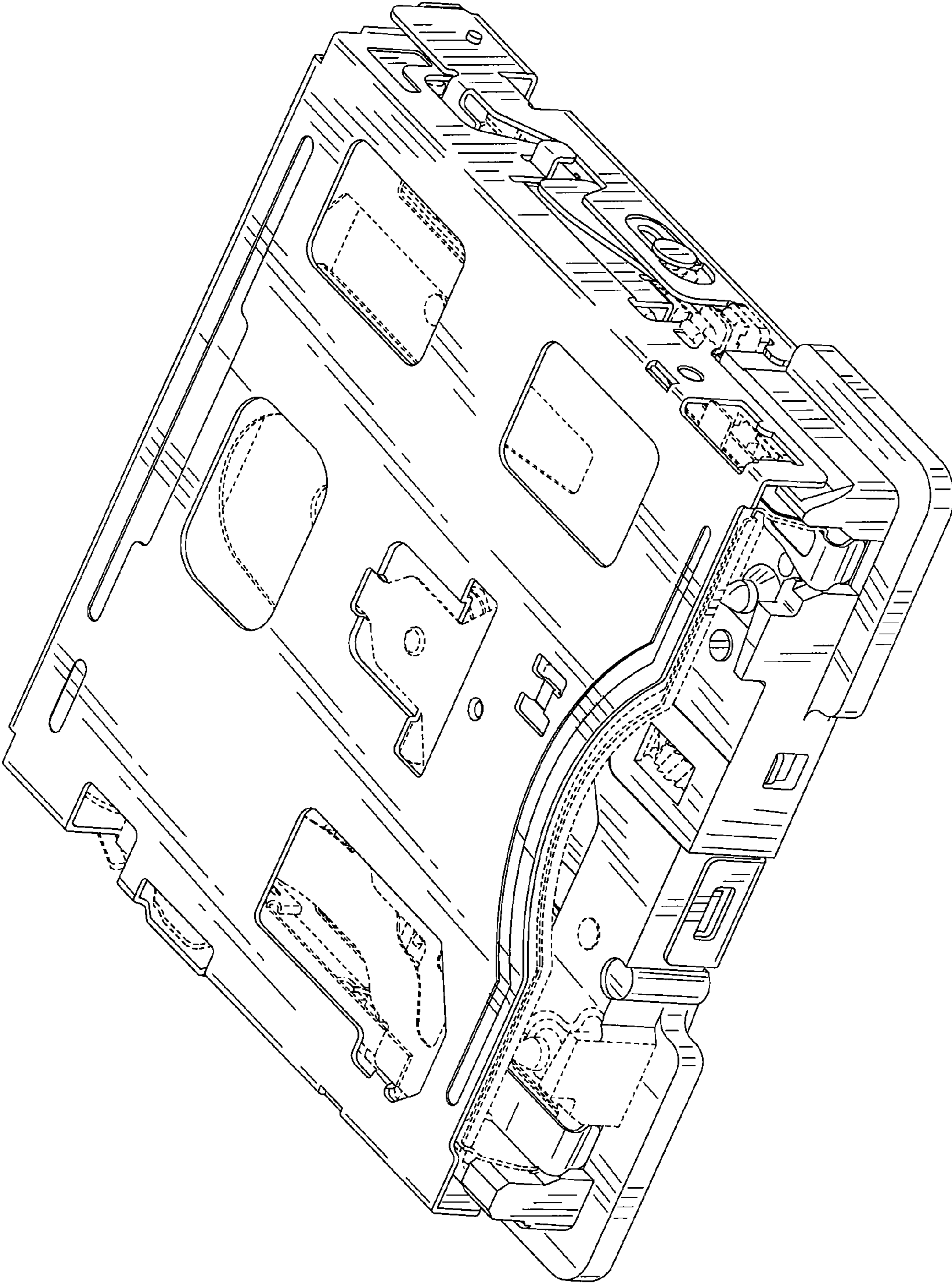

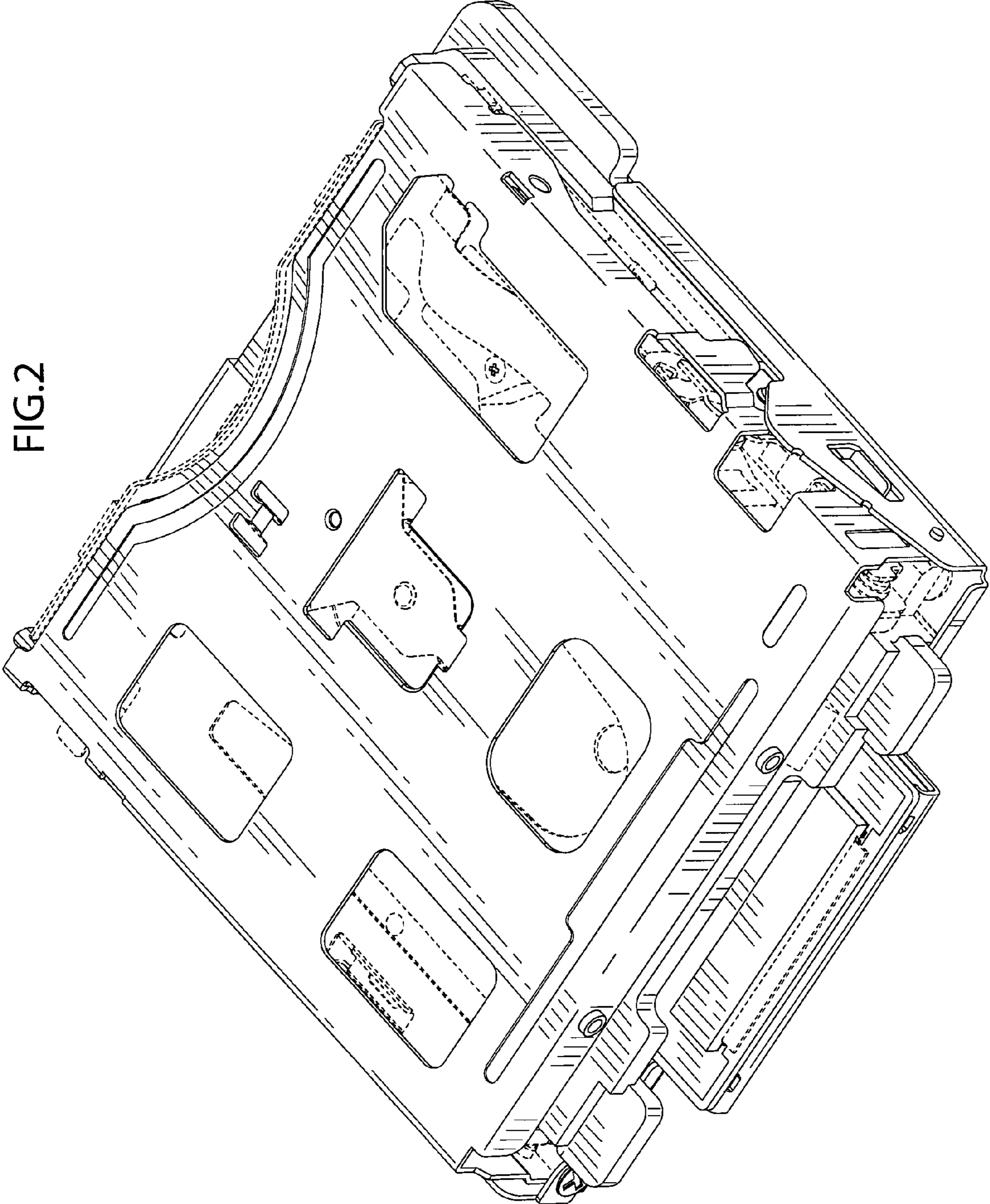

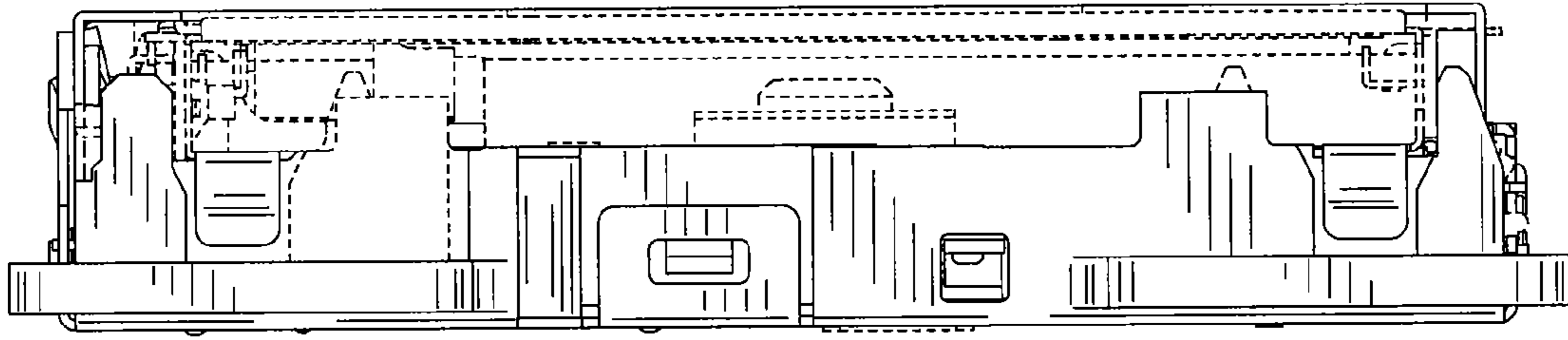

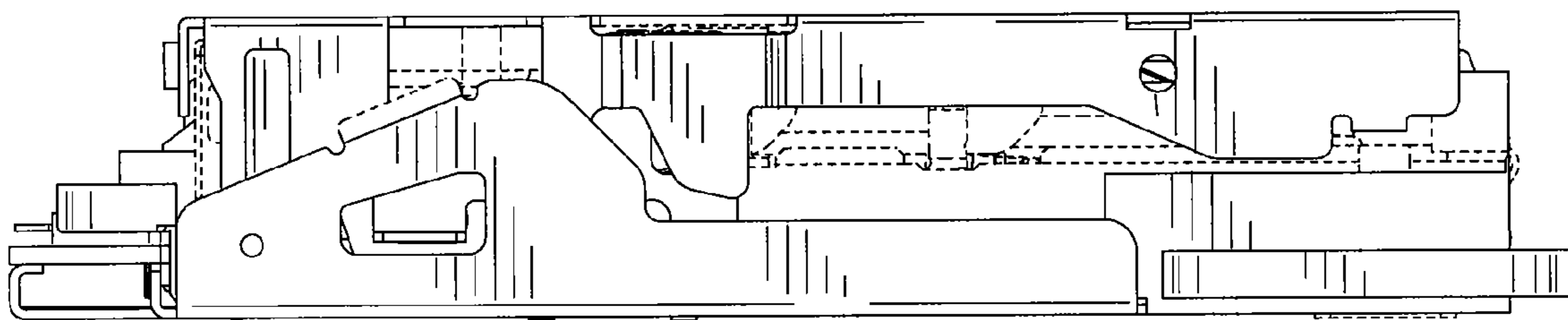

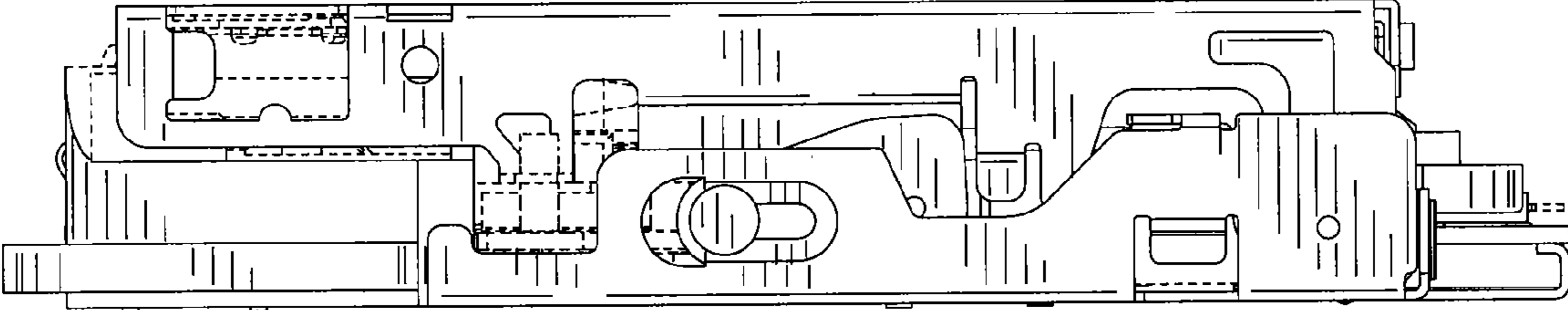

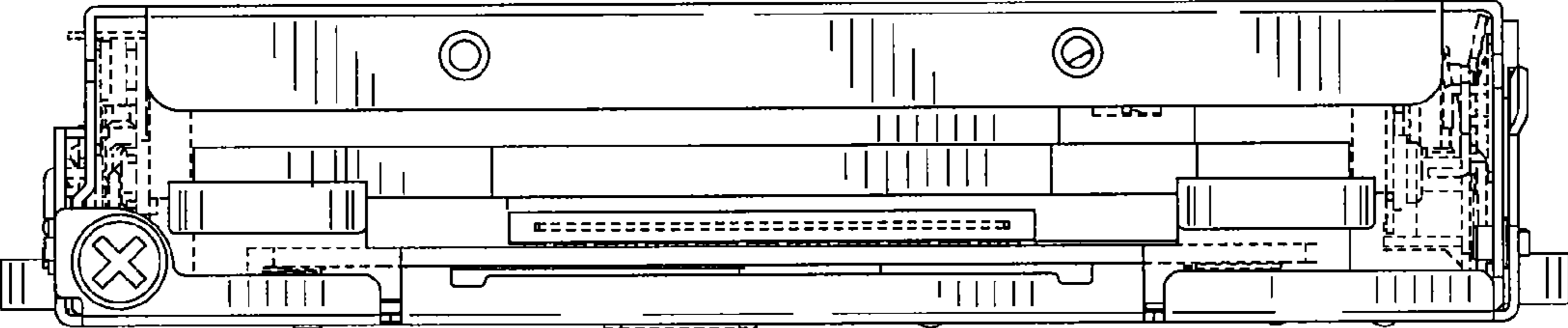

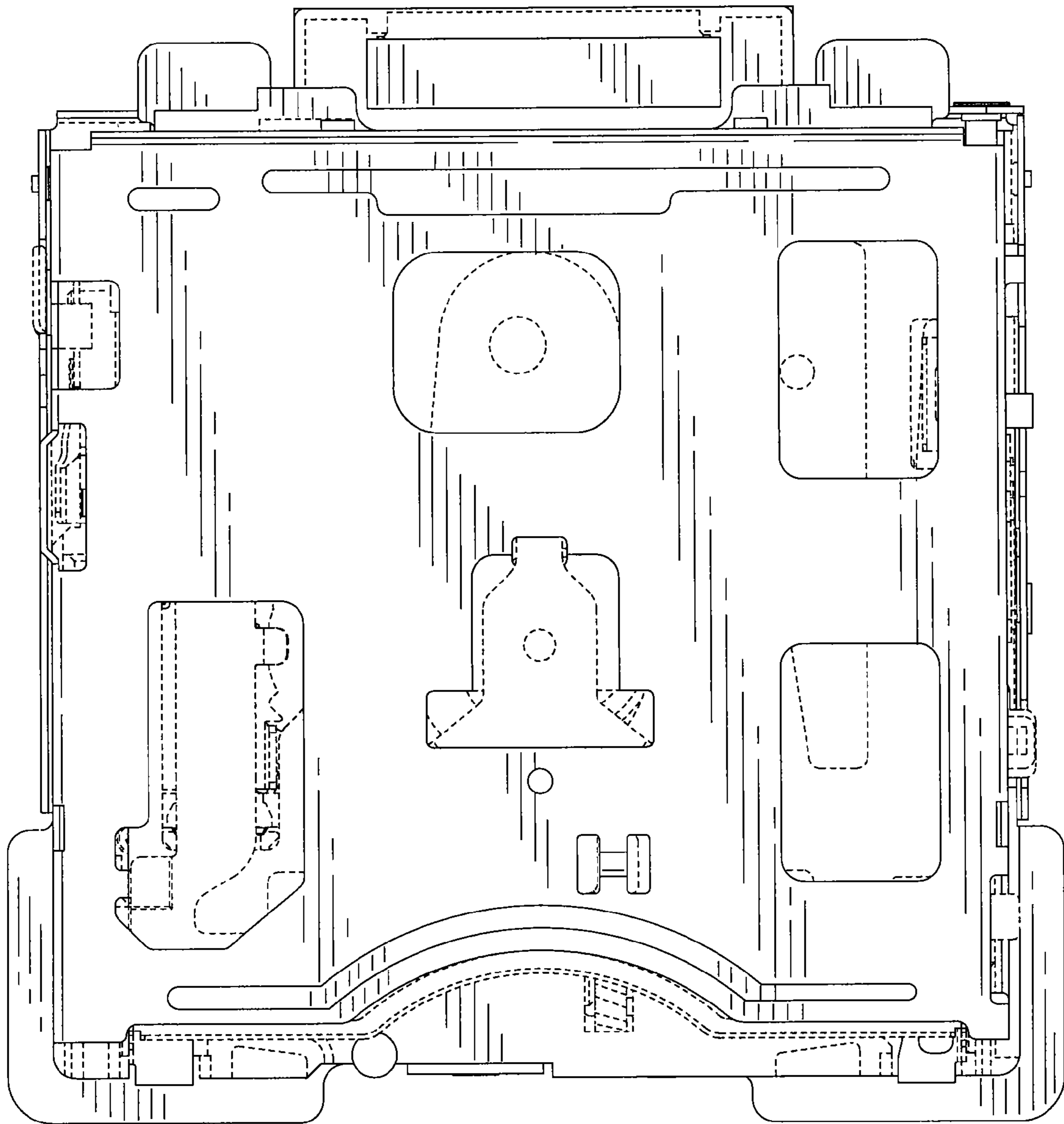
