(57) **CLAIM**

The ornamental design for a portion of a display panel with a computer icon image, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a portion of a display panel with a computer icon image embodying my new design; FIG. 2 is a front elevational view of a second embodiment thereof;

FIG. 3 is a front elevational view of a third embodiment thereof;

FIG. 4 is a front elevational view of a fourth embodiment thereof; and,

FIG. 5 is a front elevational view of a fifth embodiment thereof.

The broken line showing a portion of a display panel is for illustrating environmental structure and forms no part of the claimed design.

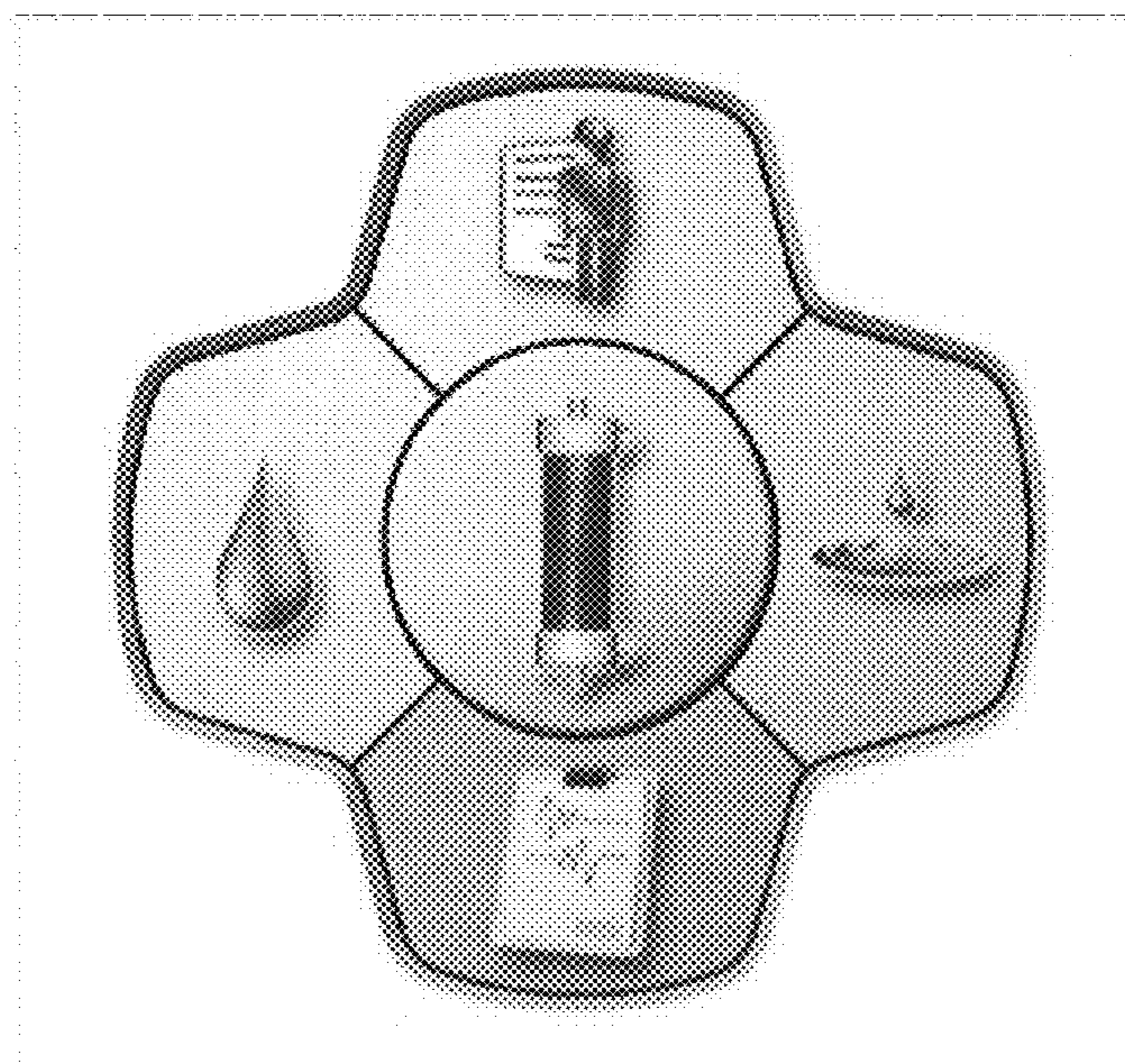

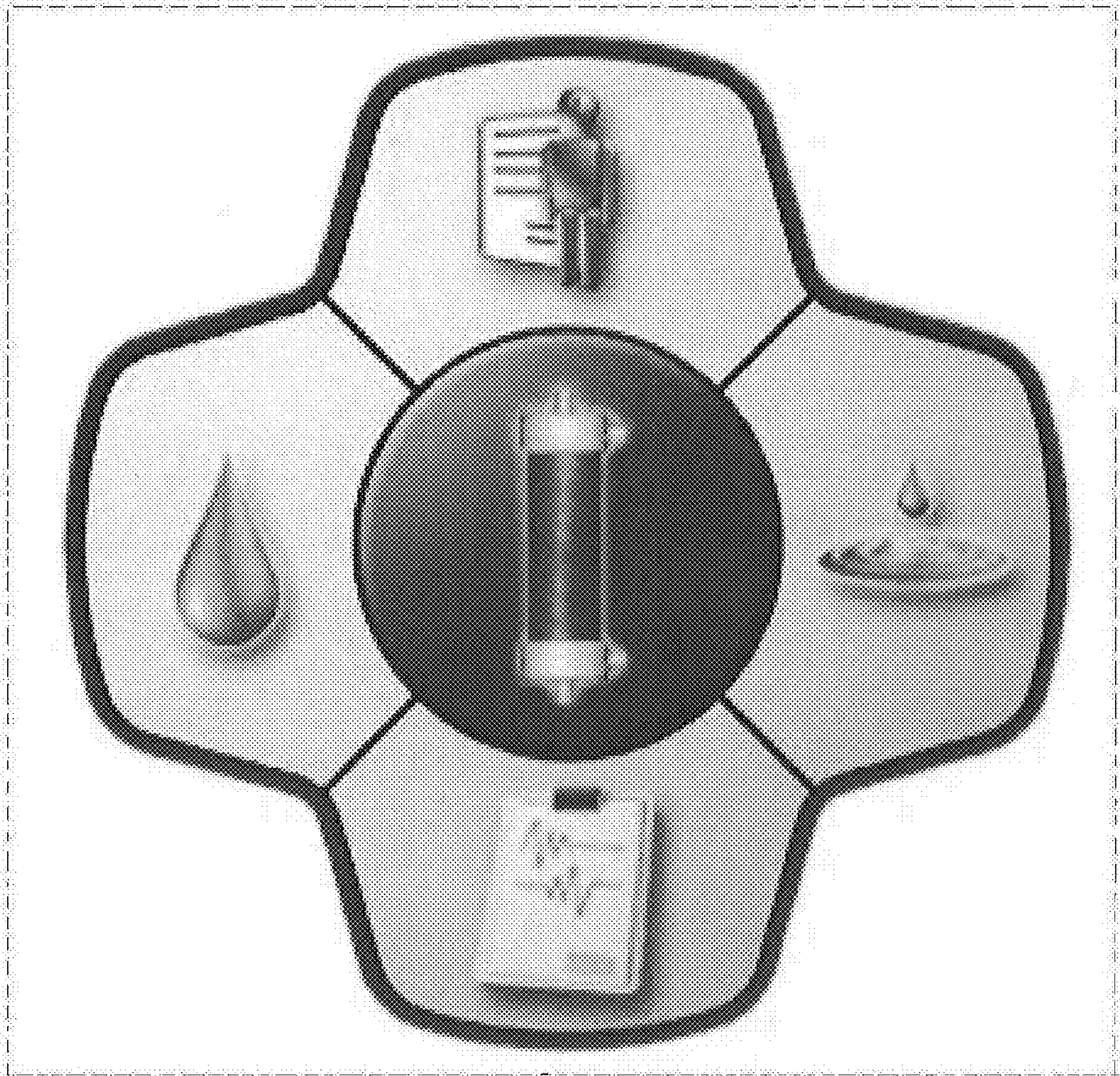

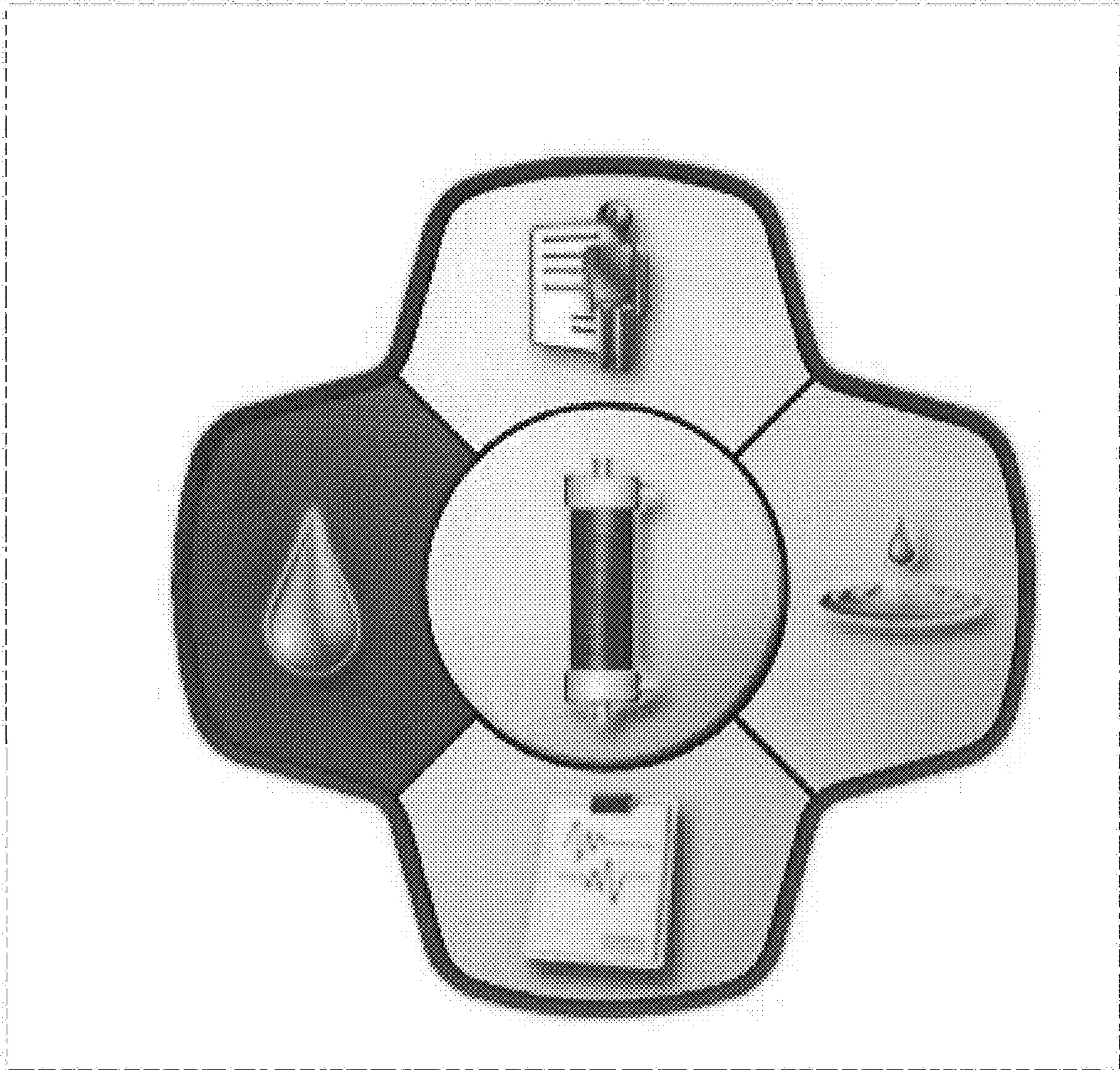

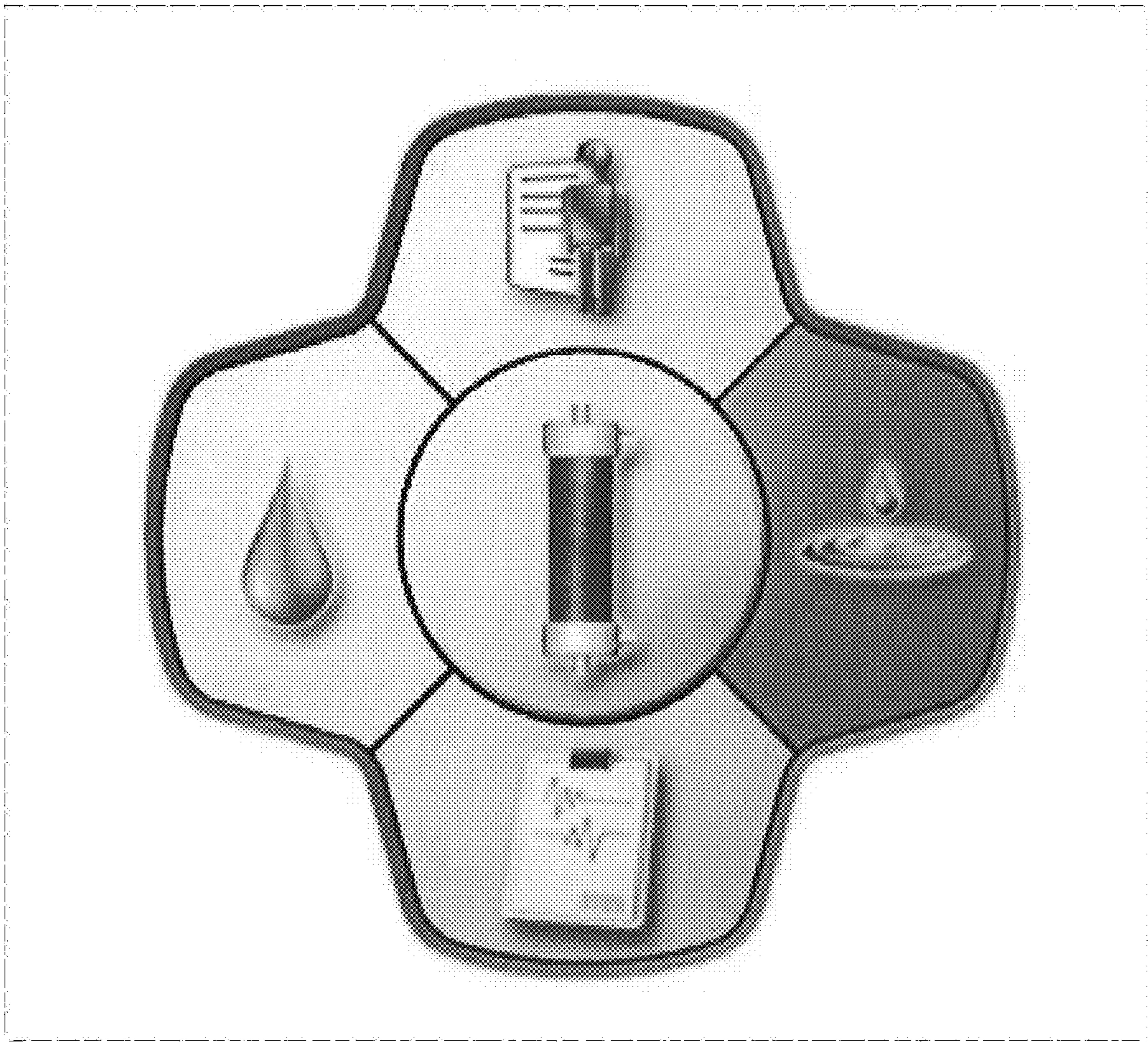

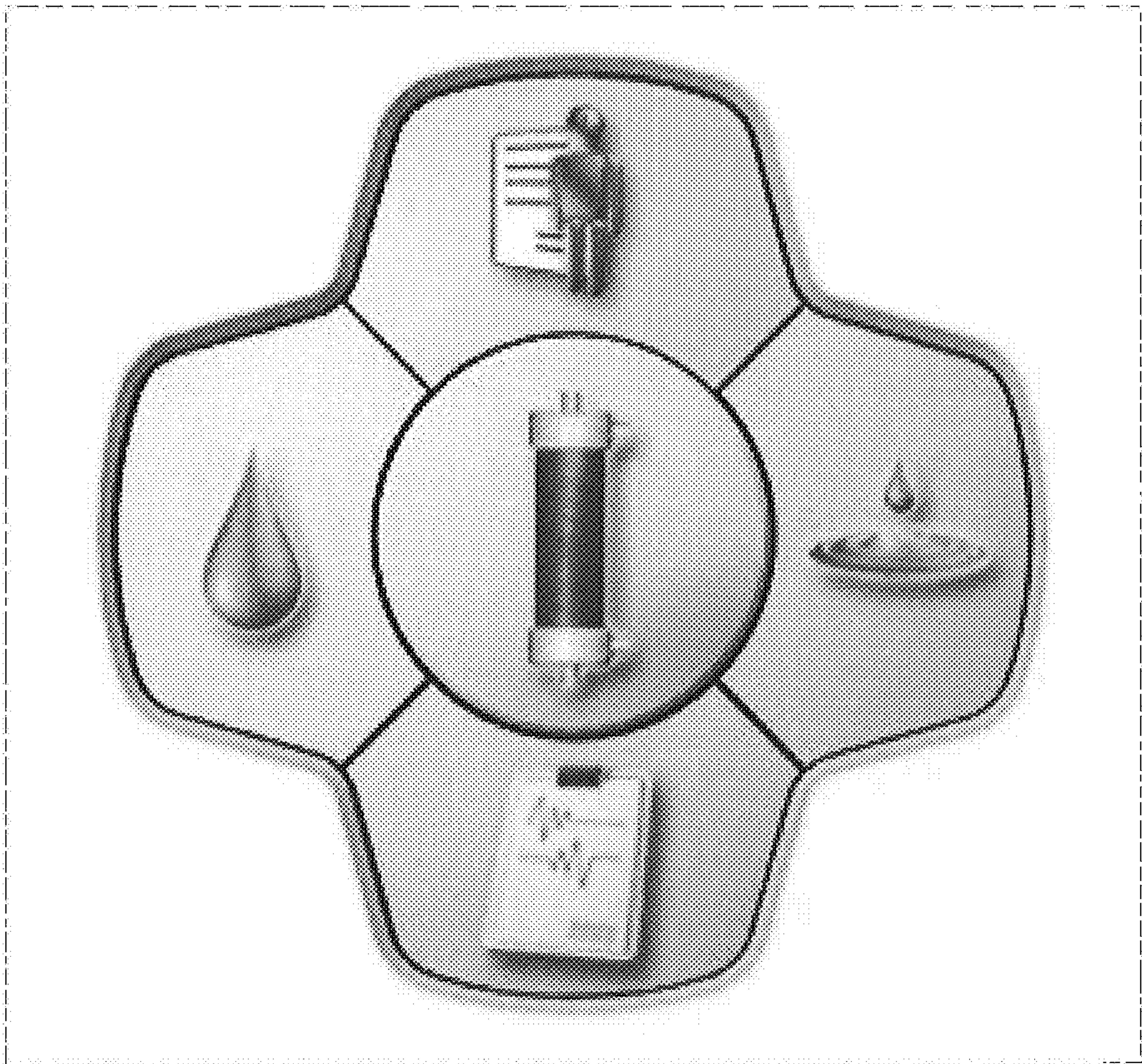
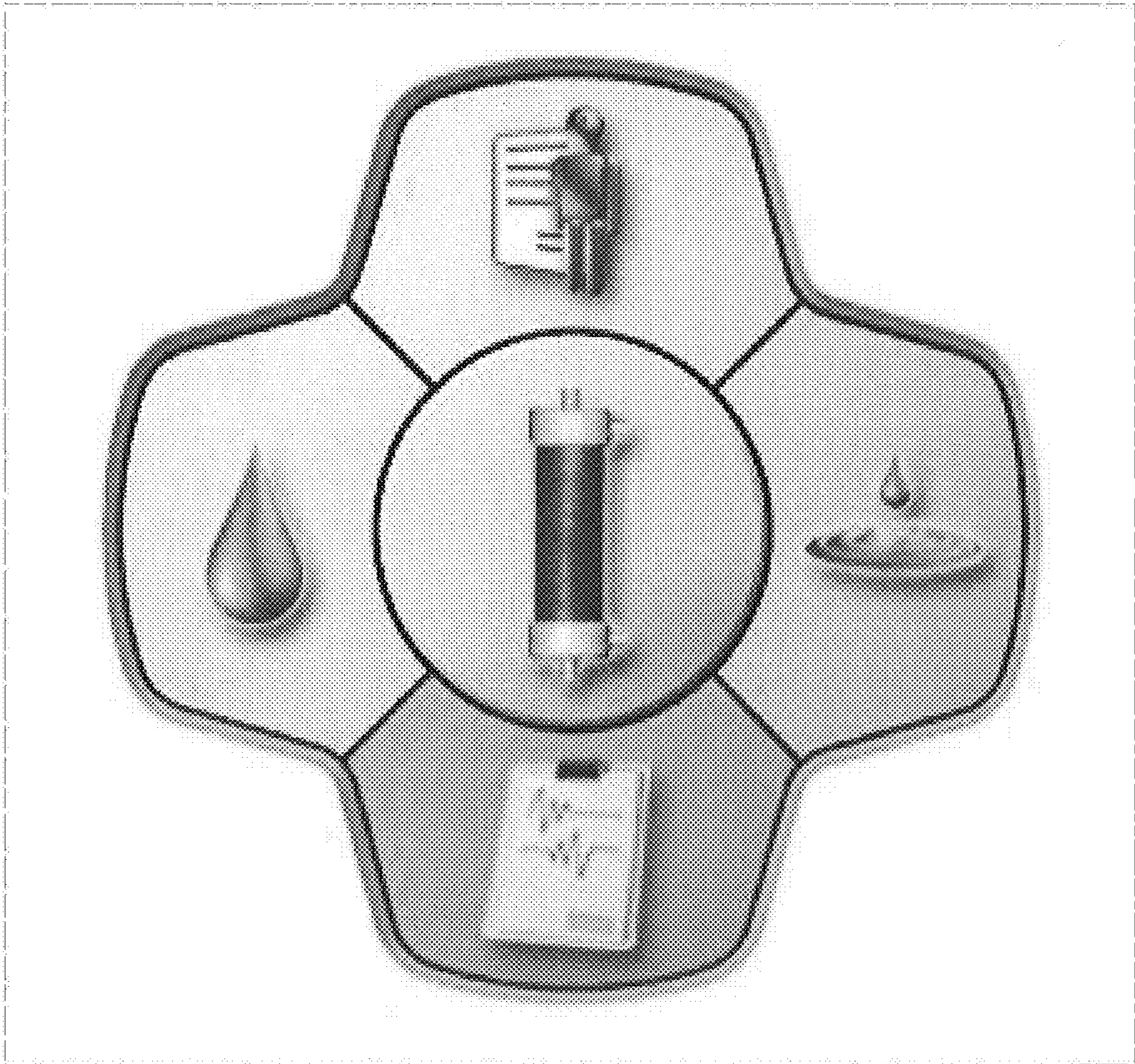
