The ornamental design for a marker, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a marker showing the new design;

FIG. 2 is a front elevational view thereof;

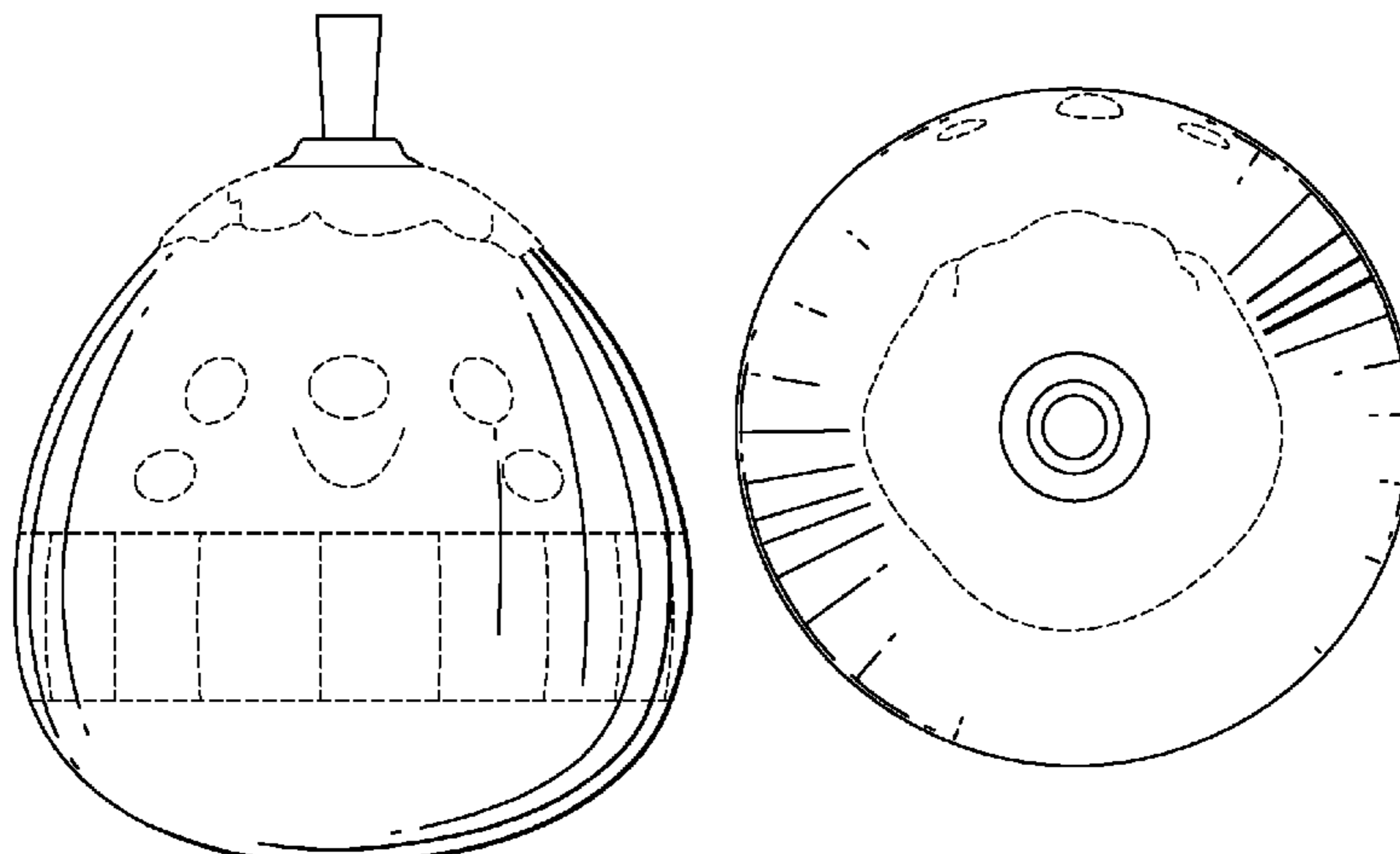
FIG. 3 is a right side elevational view thereof, a left side elevational view thereof being a mirror image thereof;

FIG. 4 is a rear elevational view thereof; and,

FIG. 5 is a top plan view thereof.

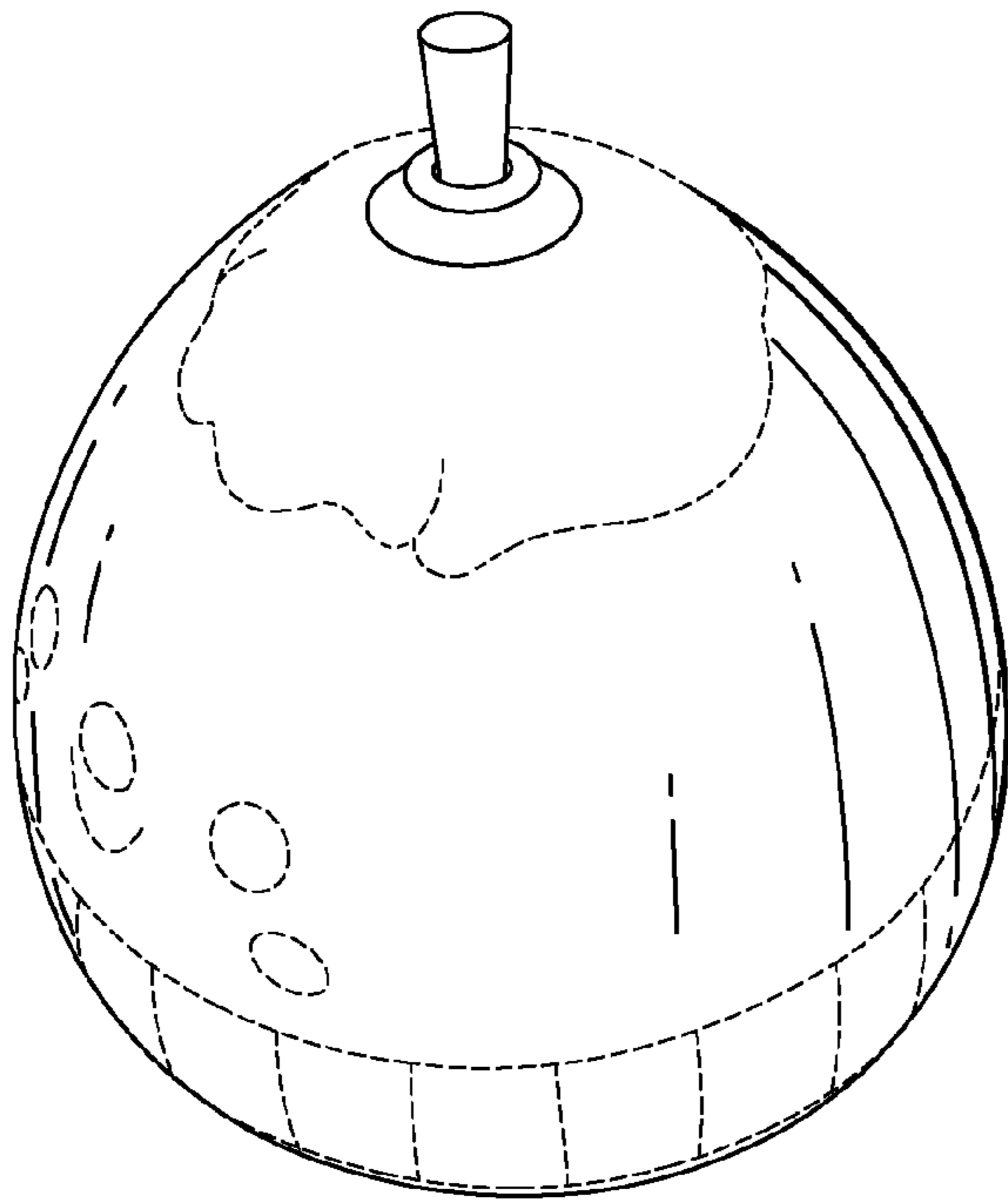

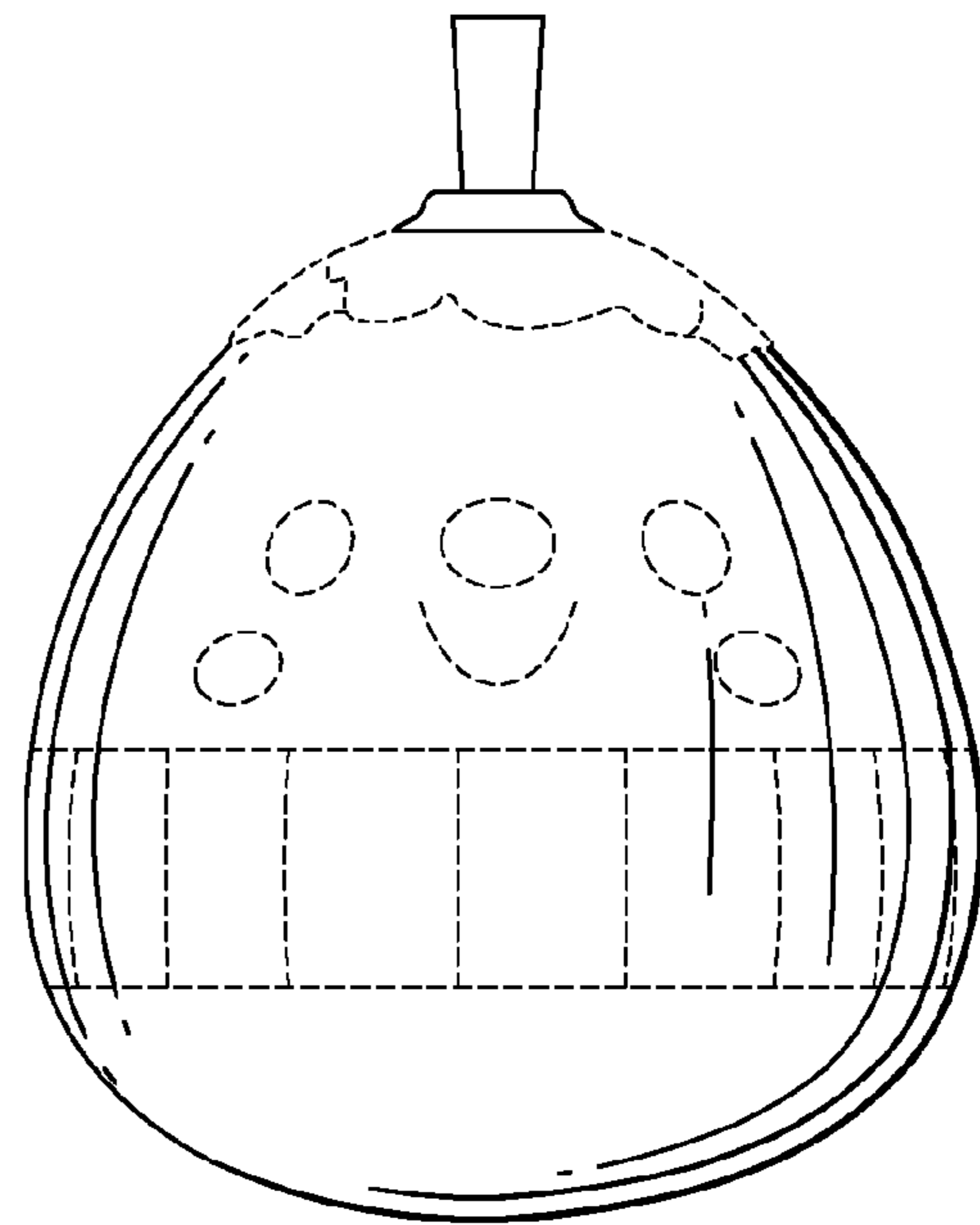

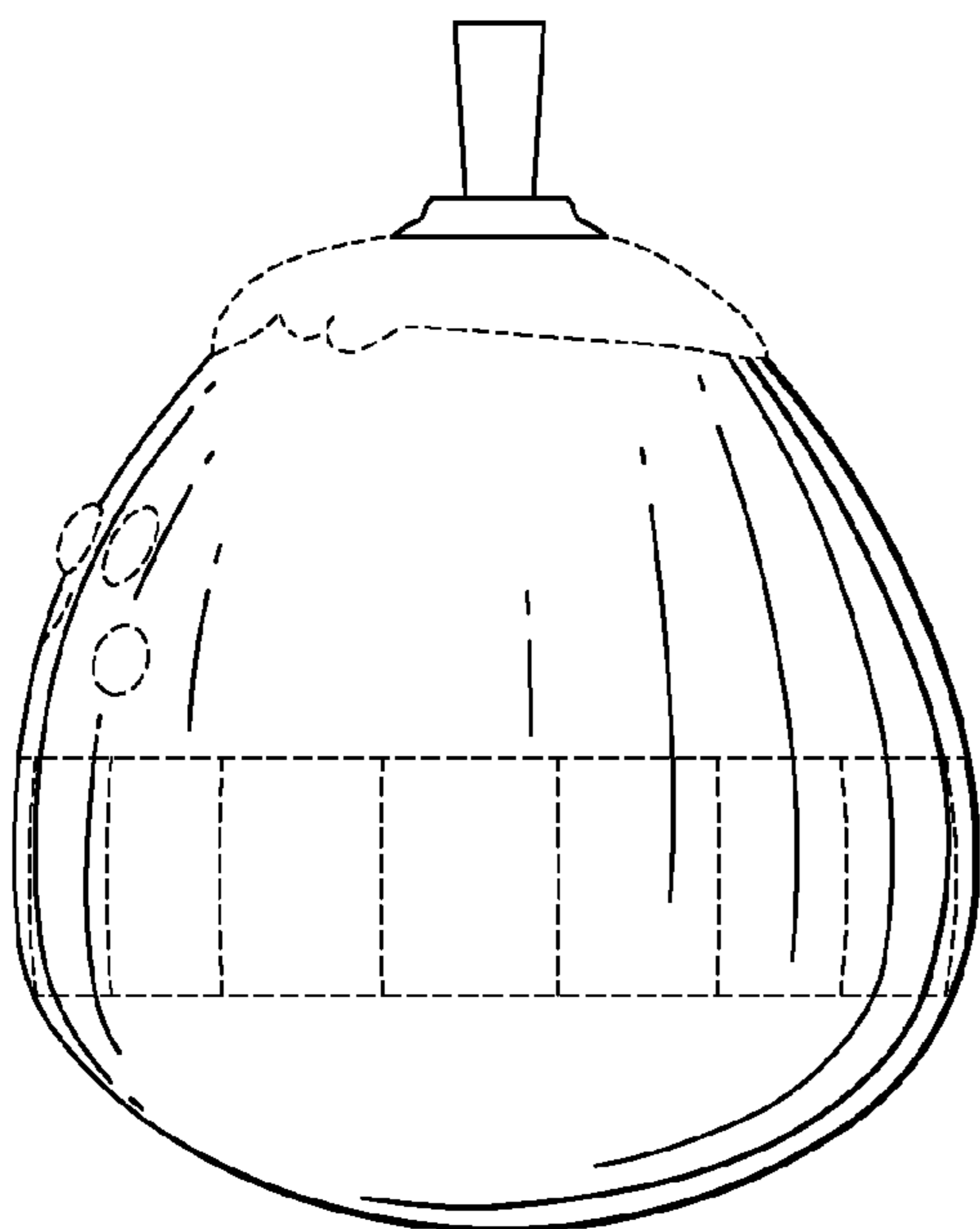

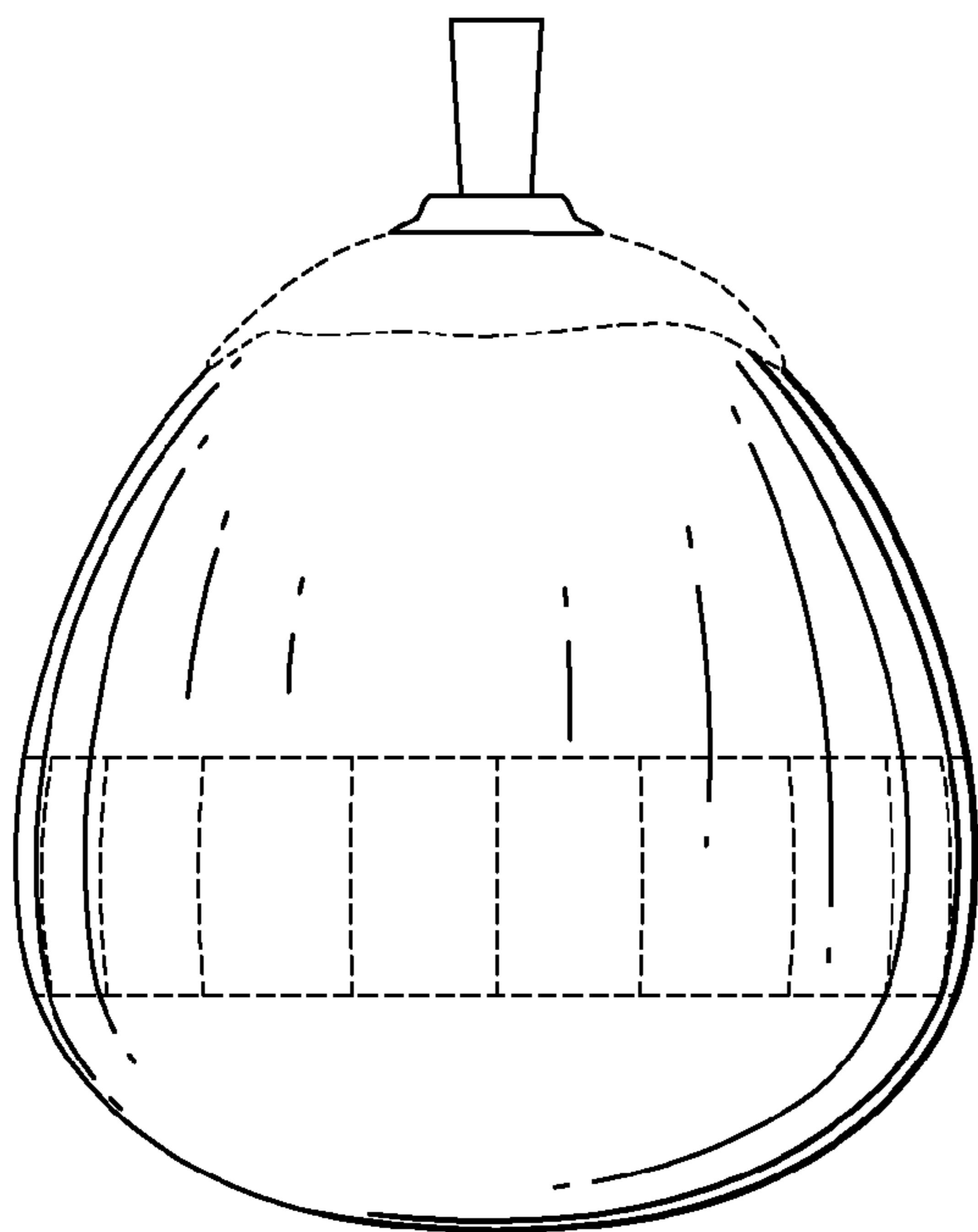

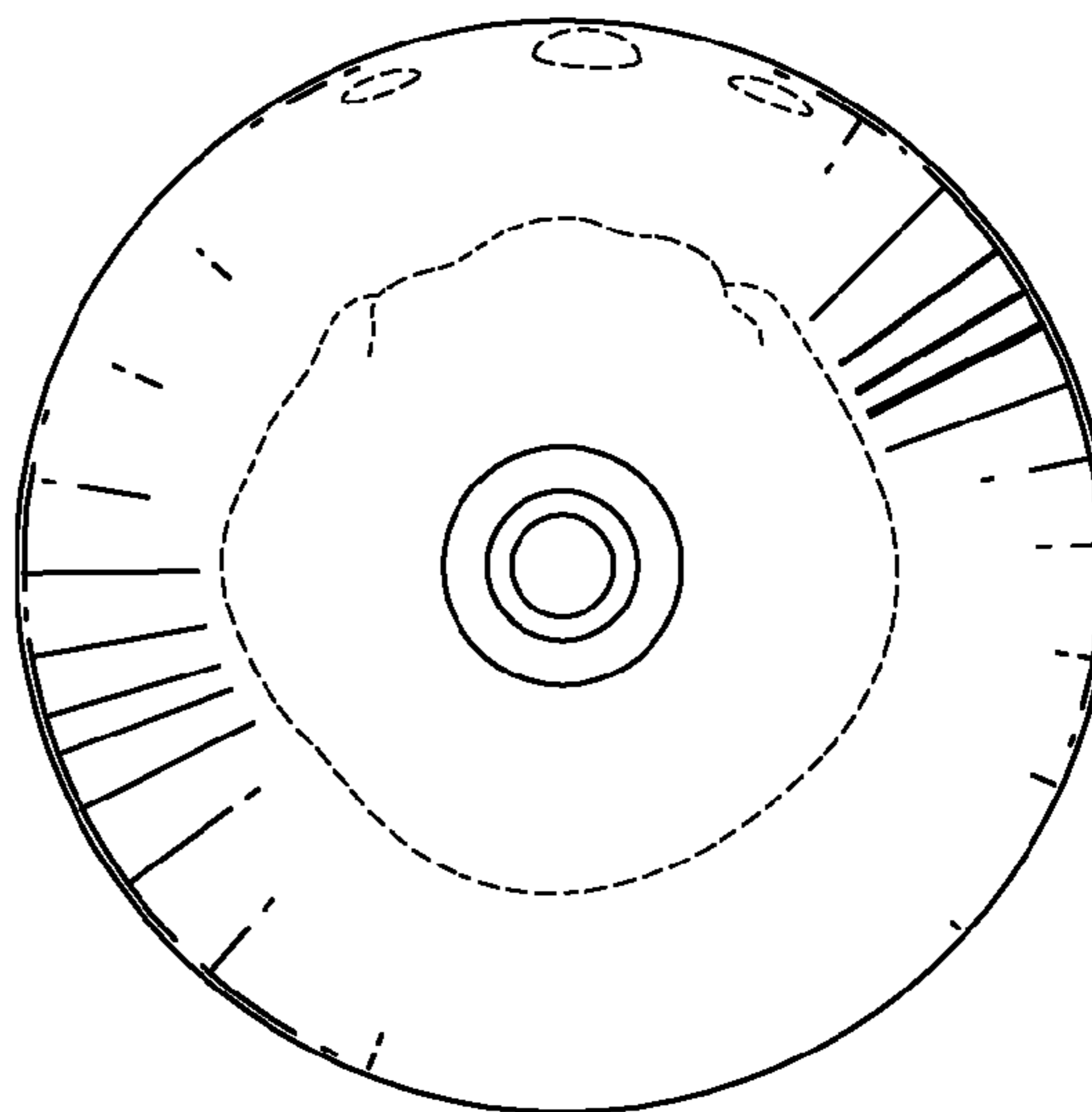
