FIG. 5 is a bottom view of the material corner shaper in FIG. 1;

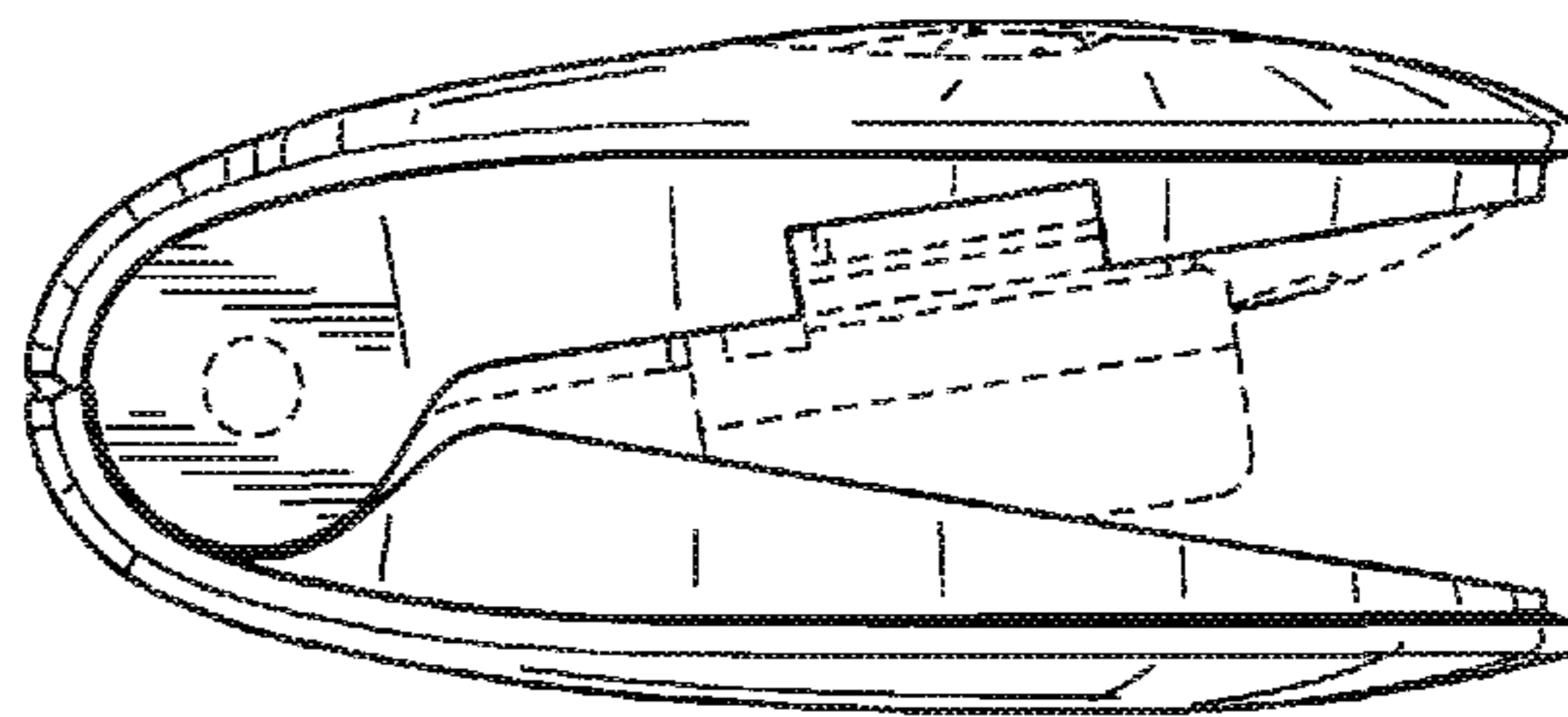
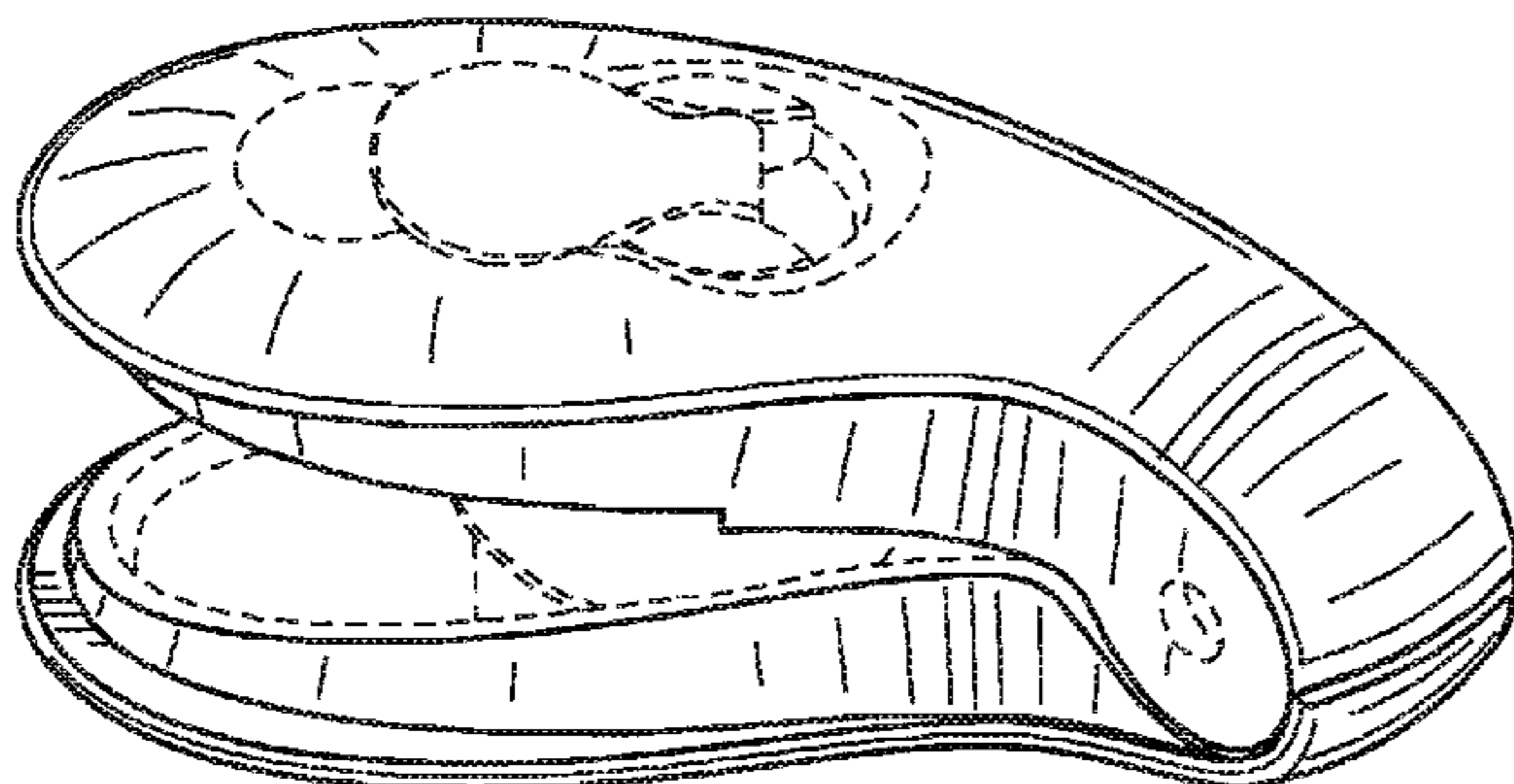
FIG. 6 is a left side view of the material corner shaper in FIG. 1; and,

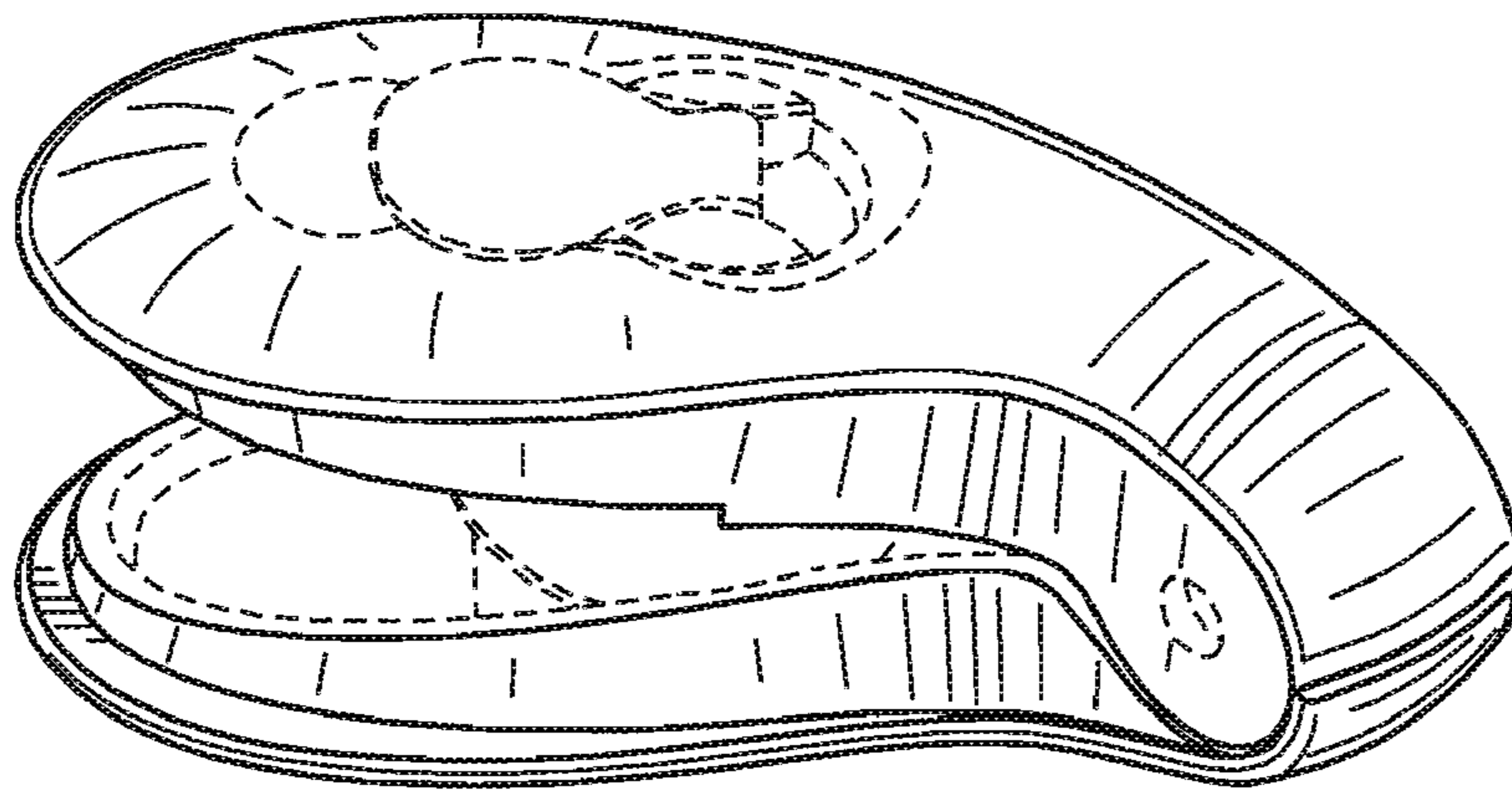

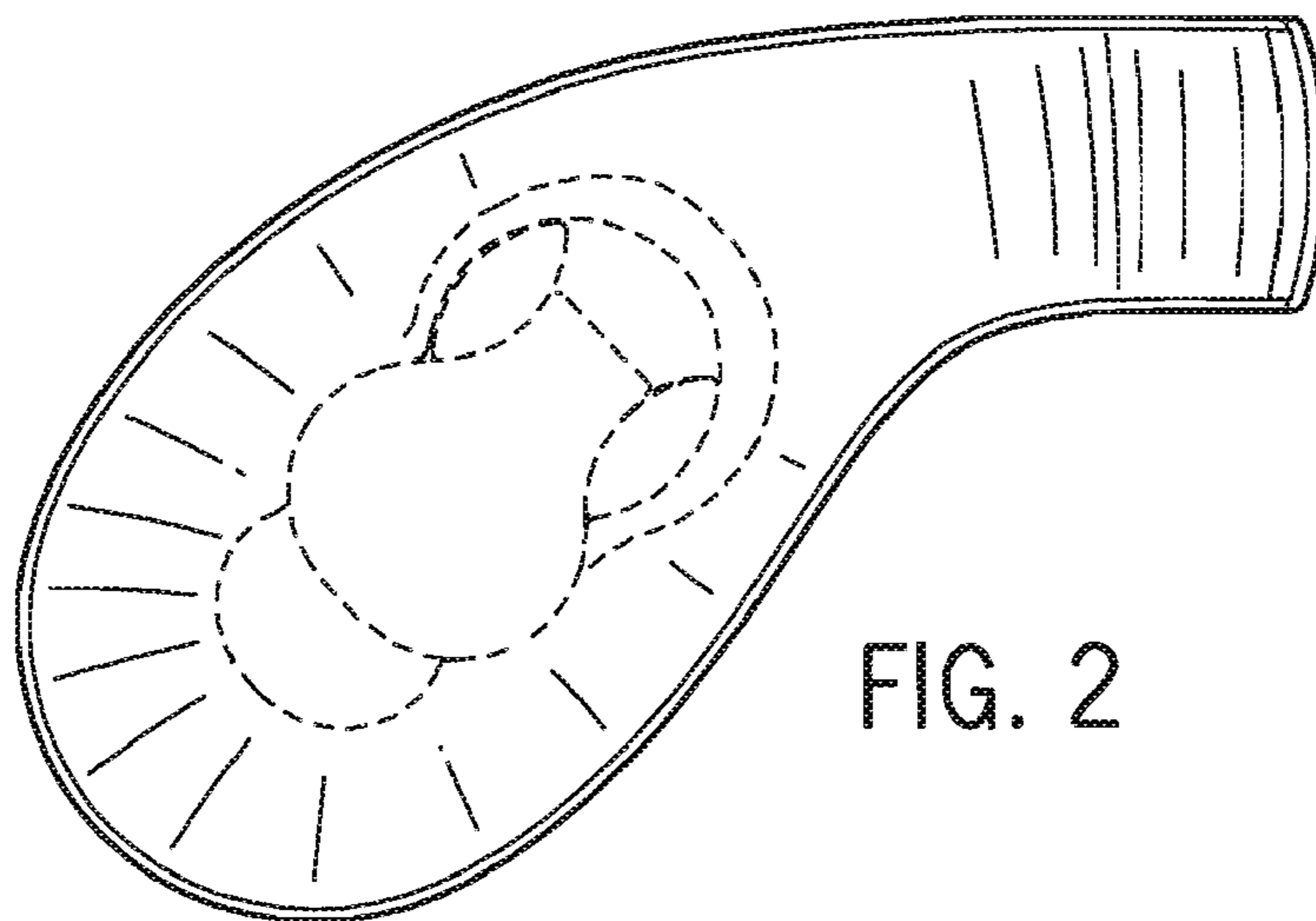

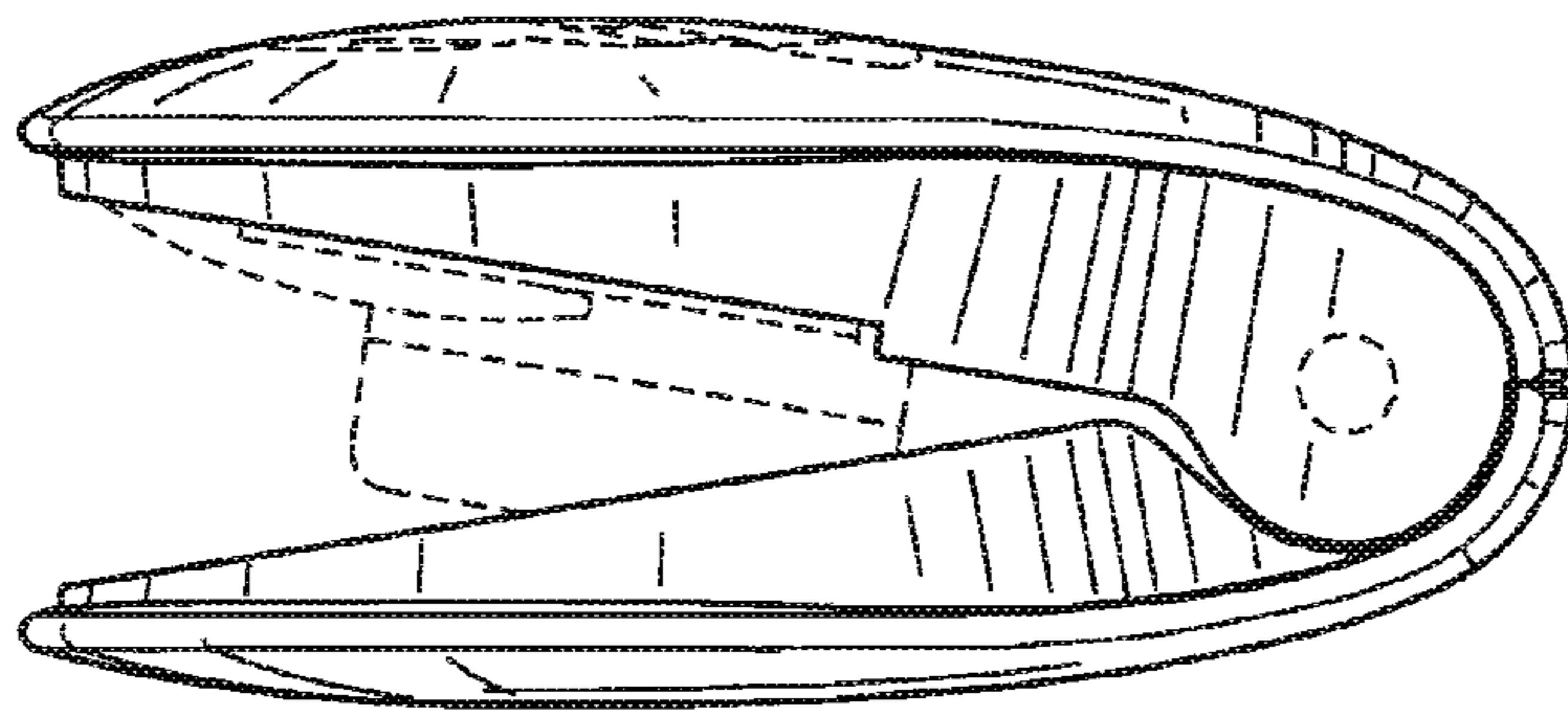

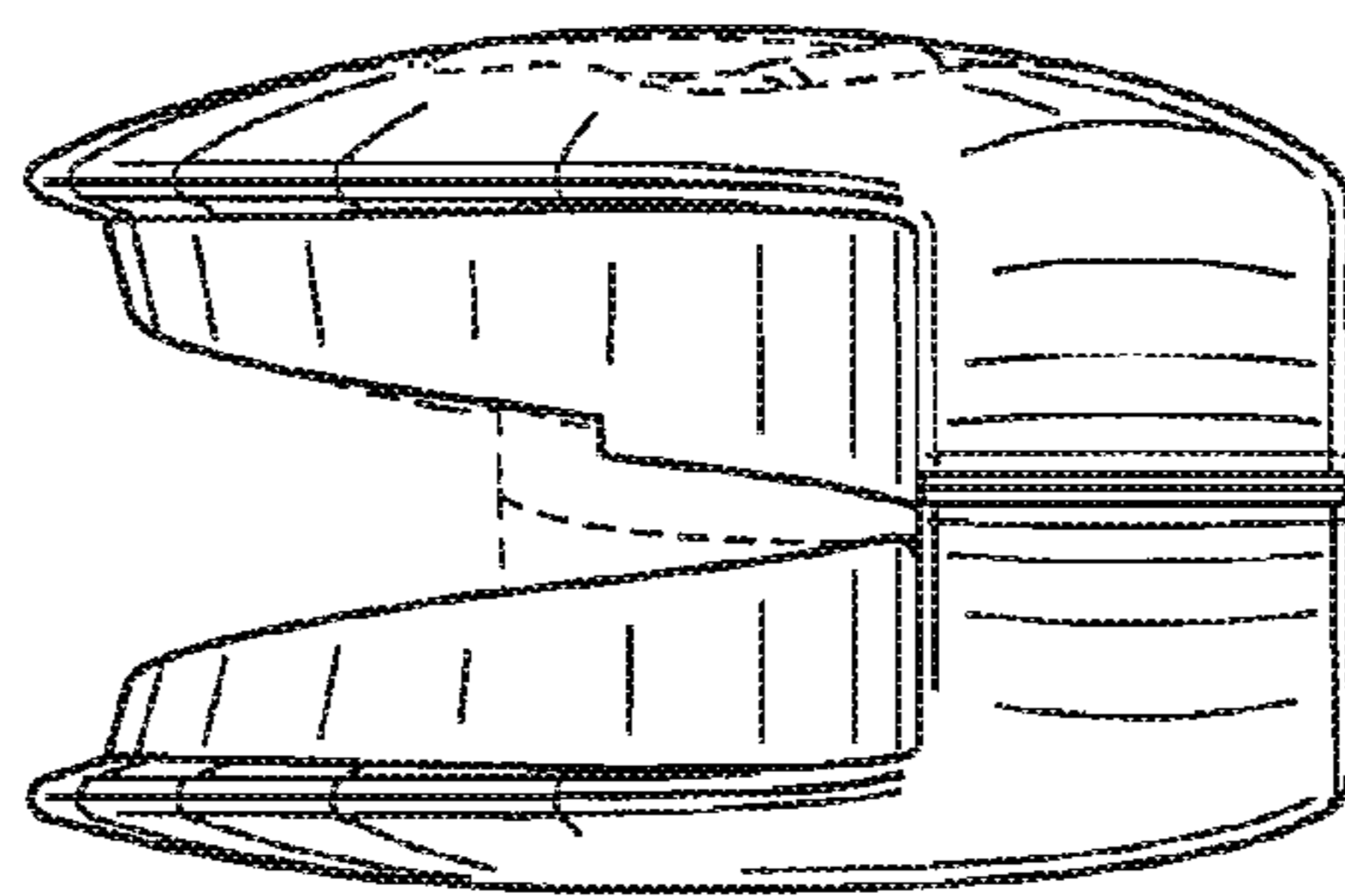

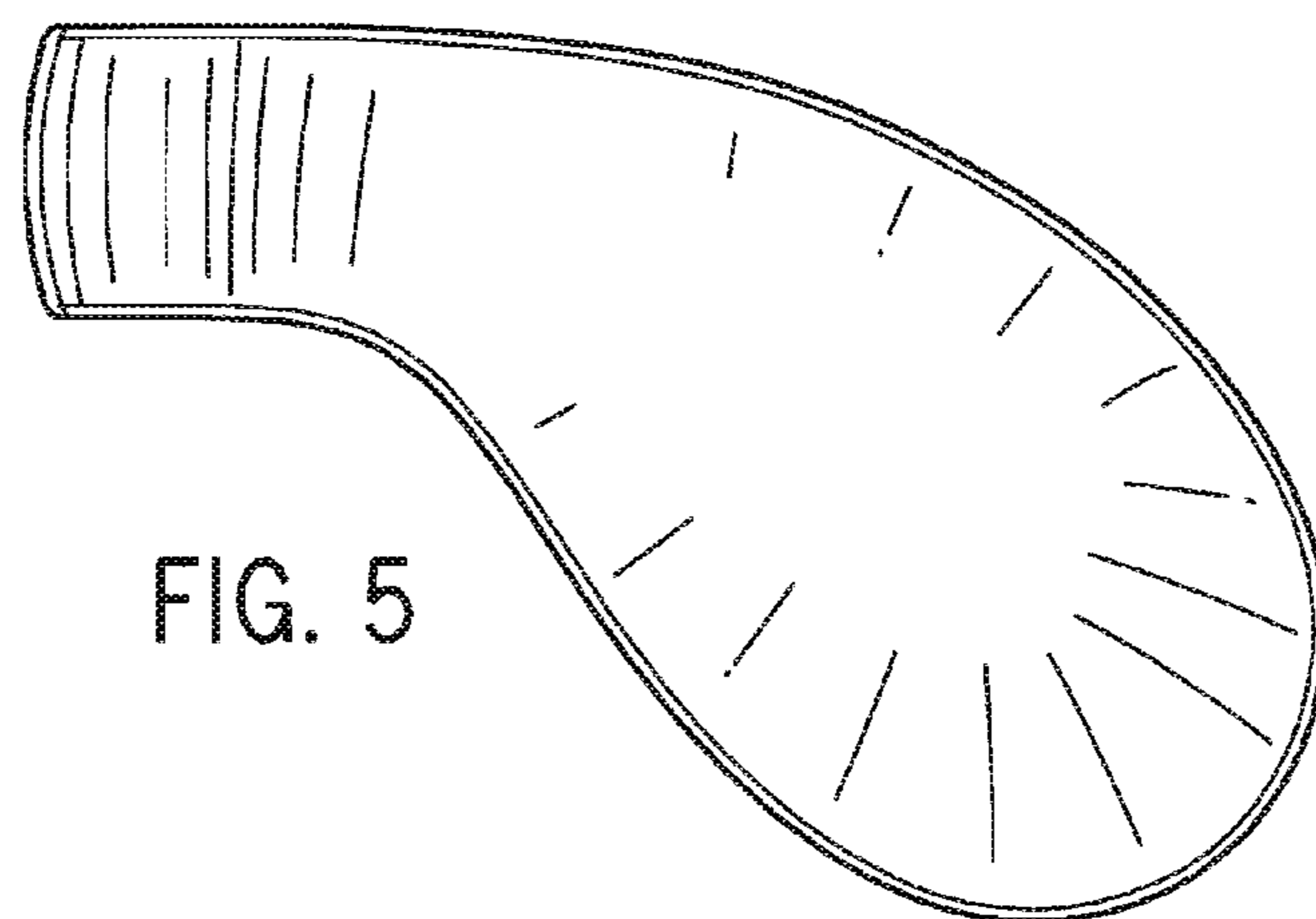

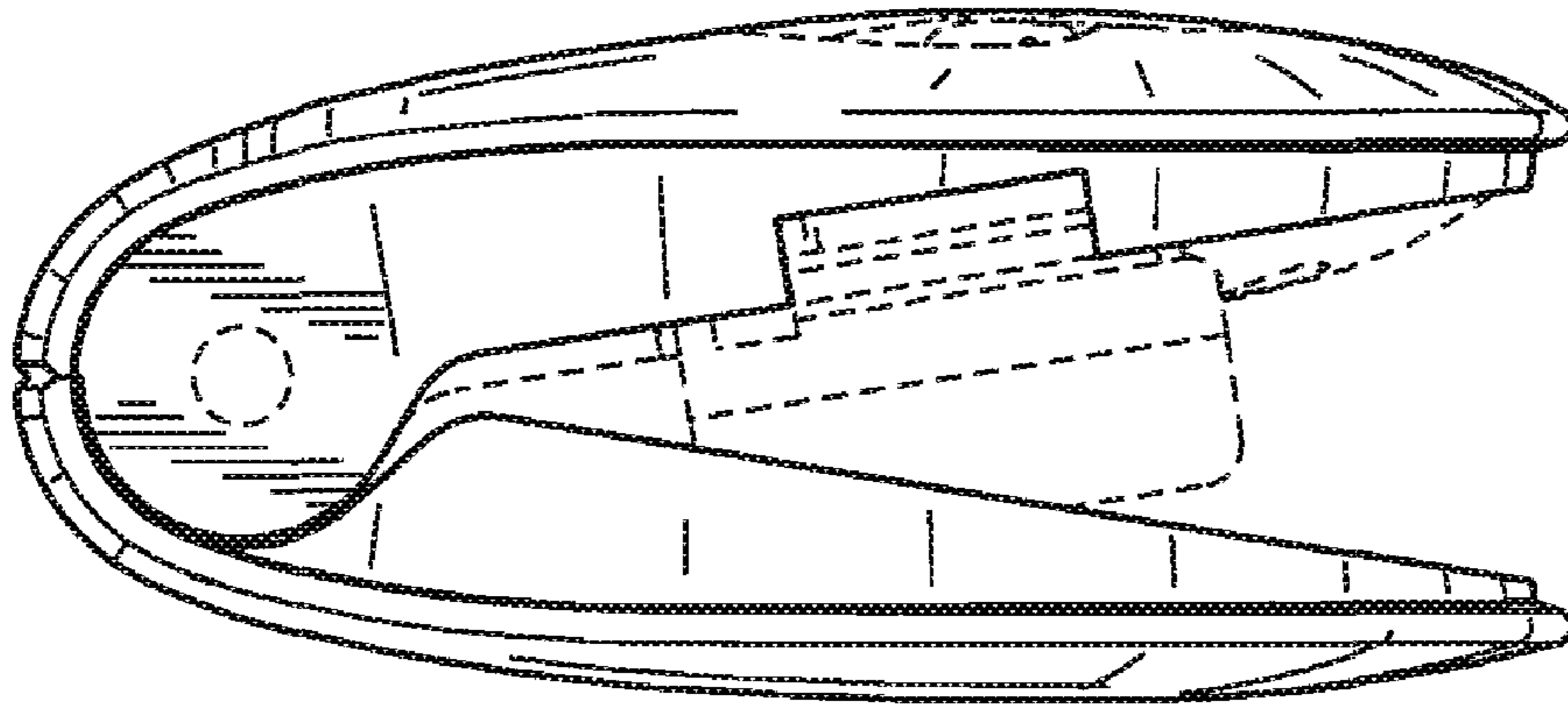

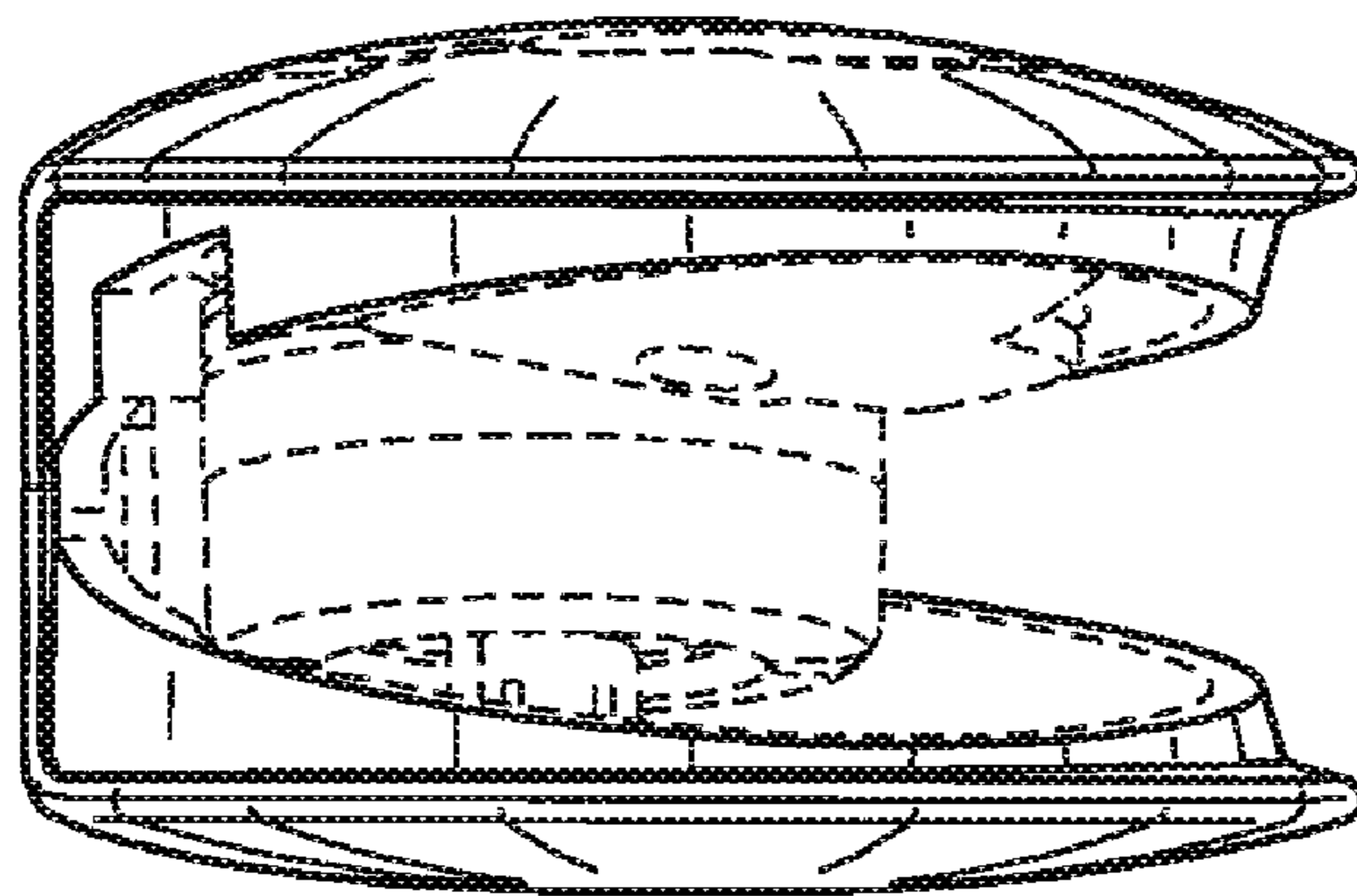
