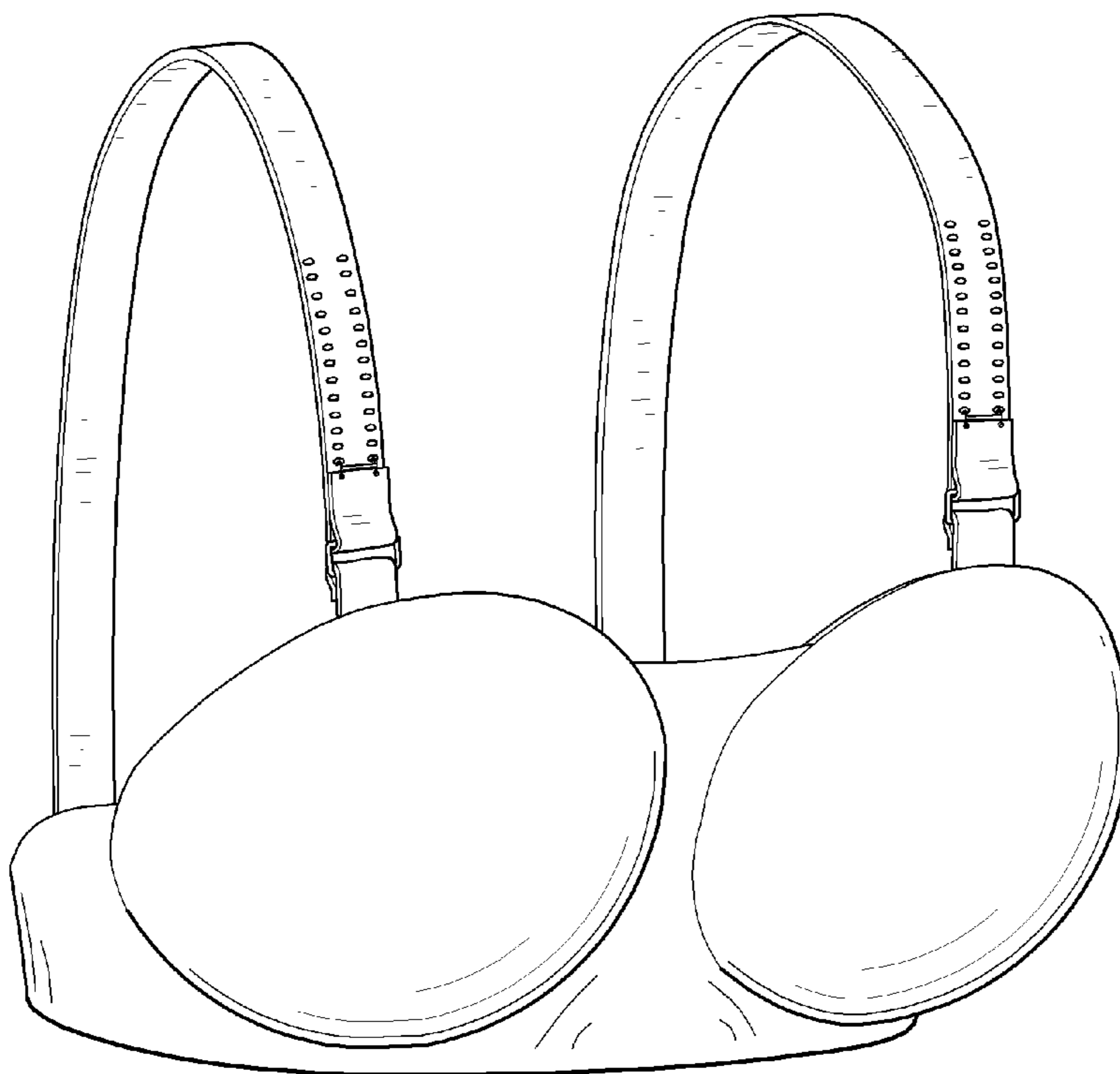

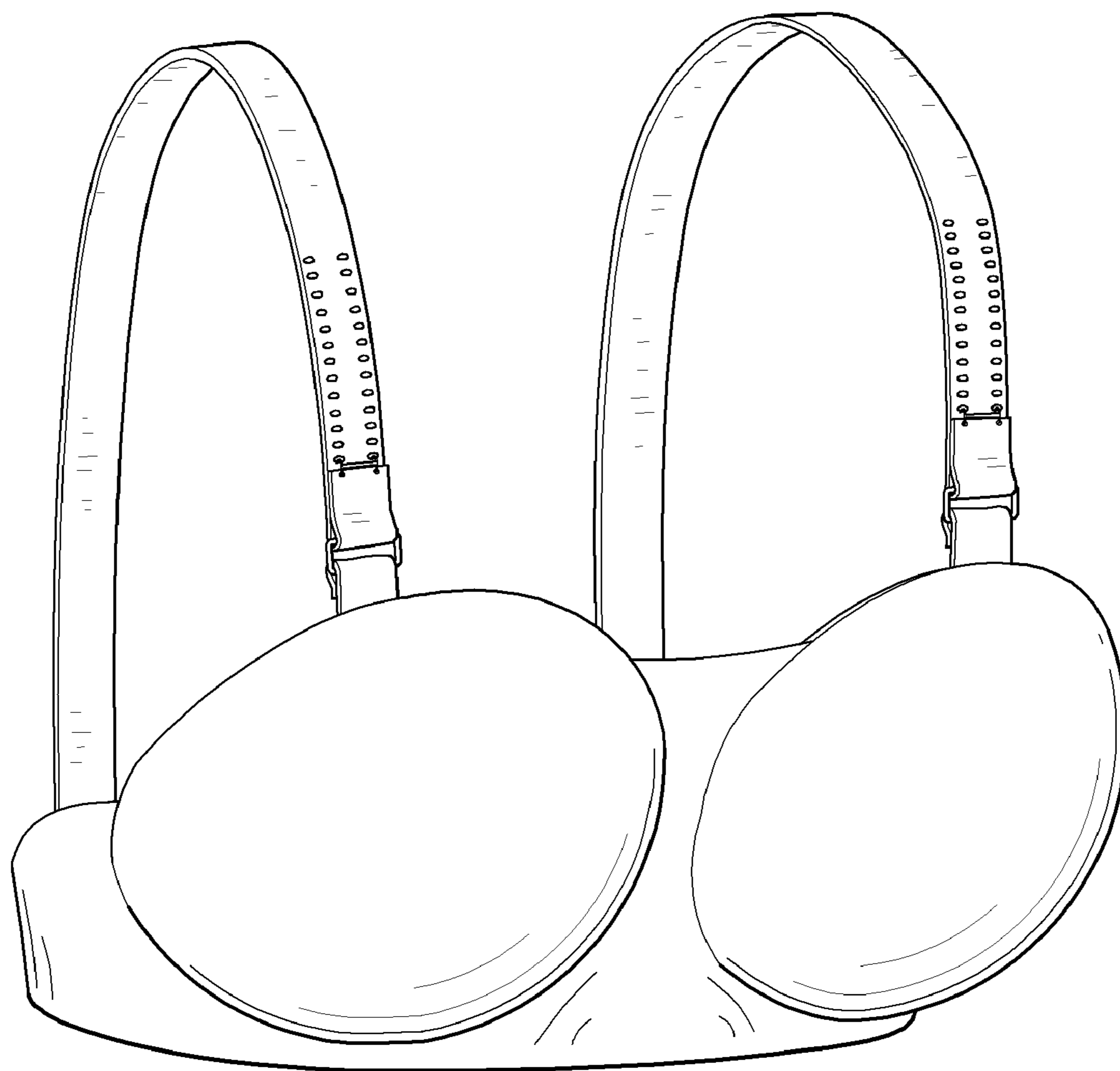
The ornamental design for a bra, as shown and described.

**DESCRIPTION**

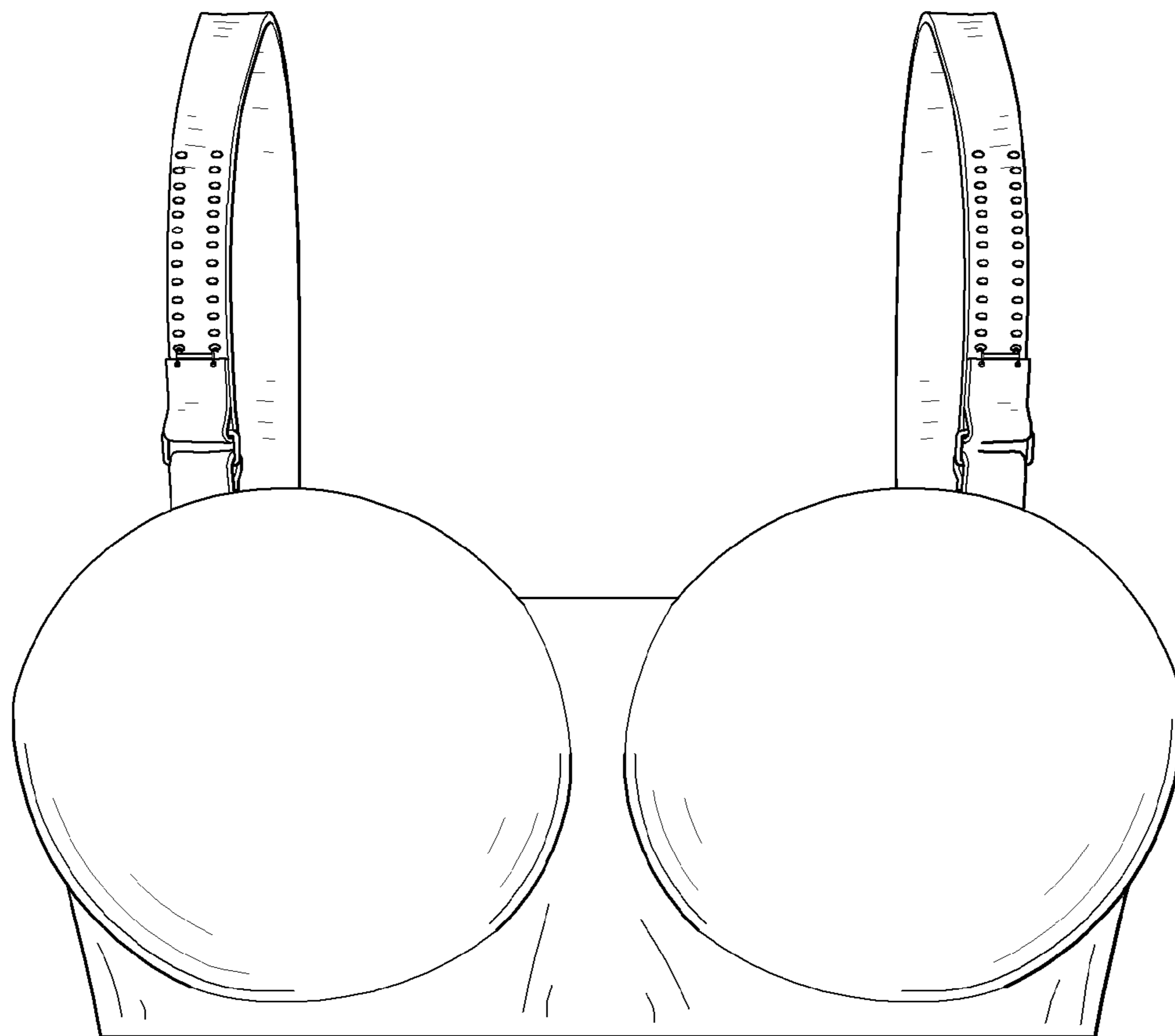

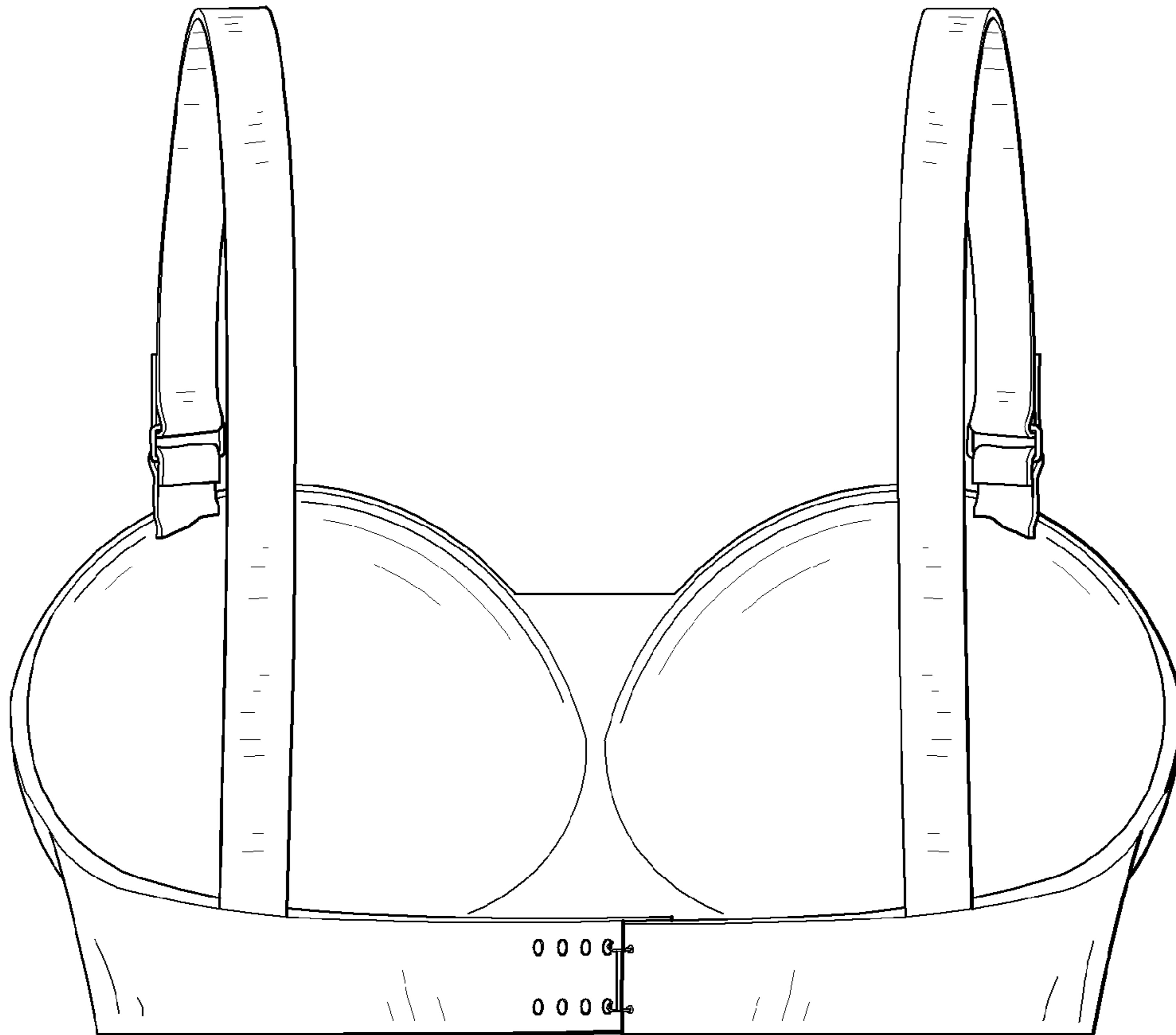




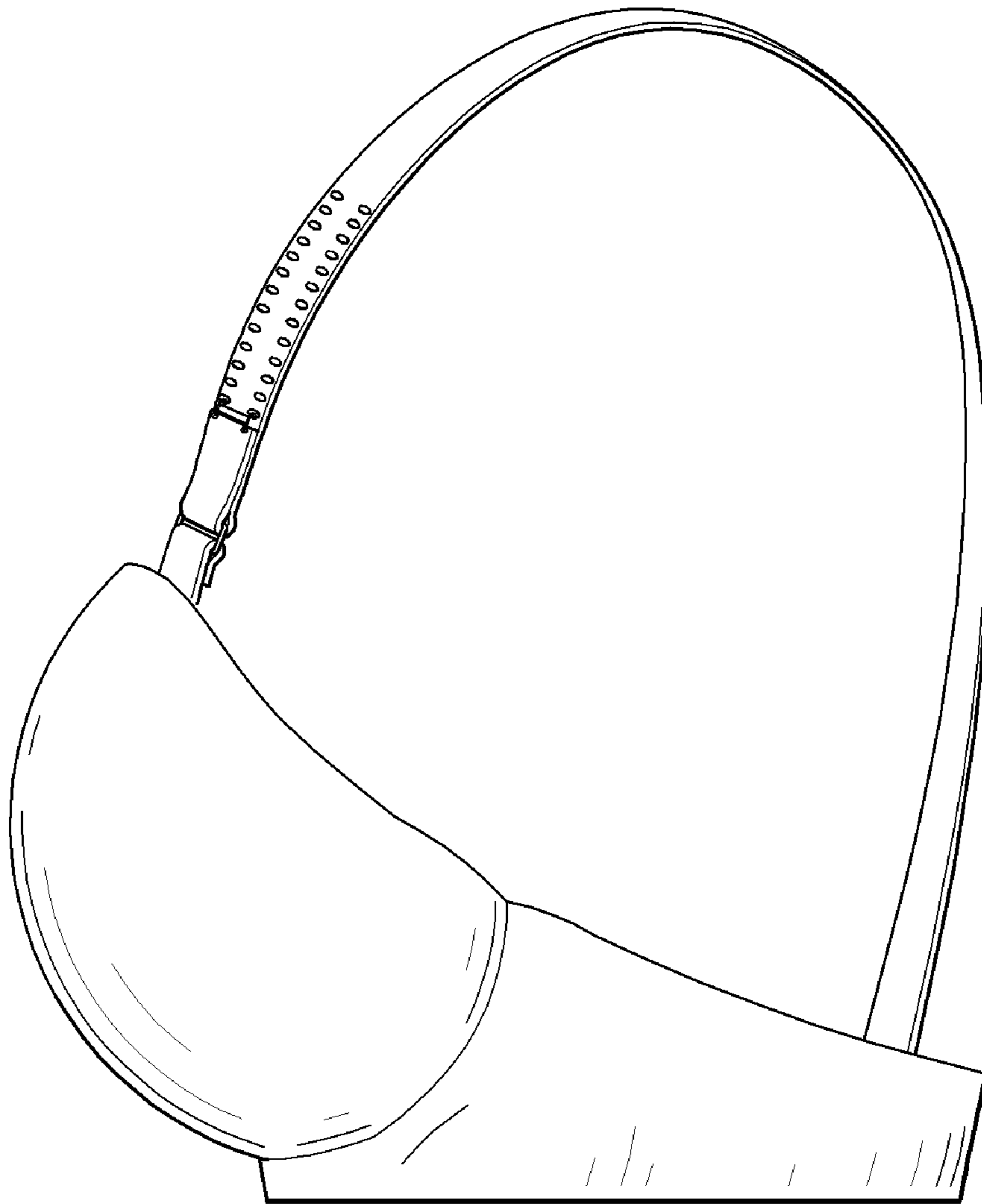

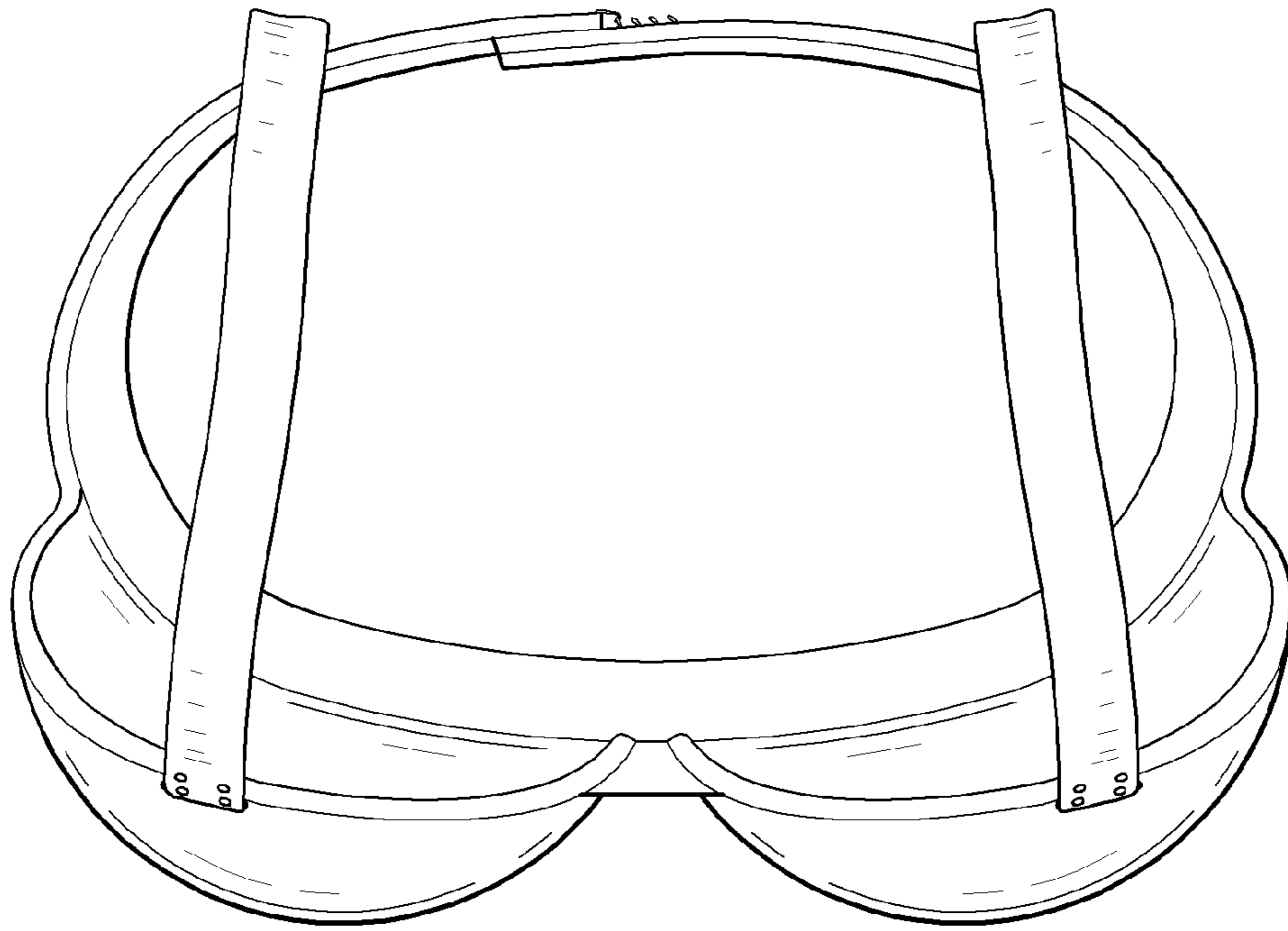

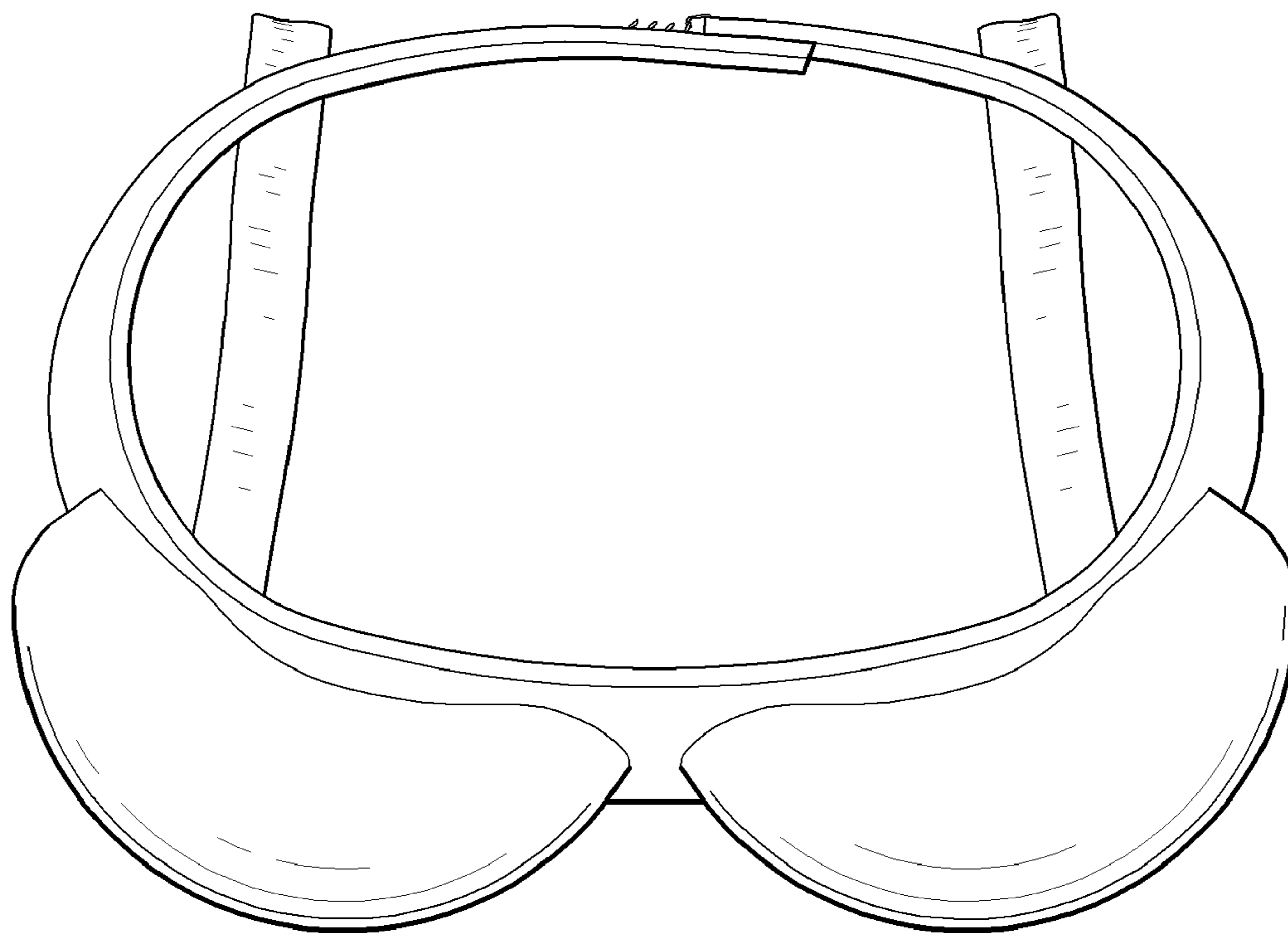
