The ornamental design for a sports suit, as shown and described.

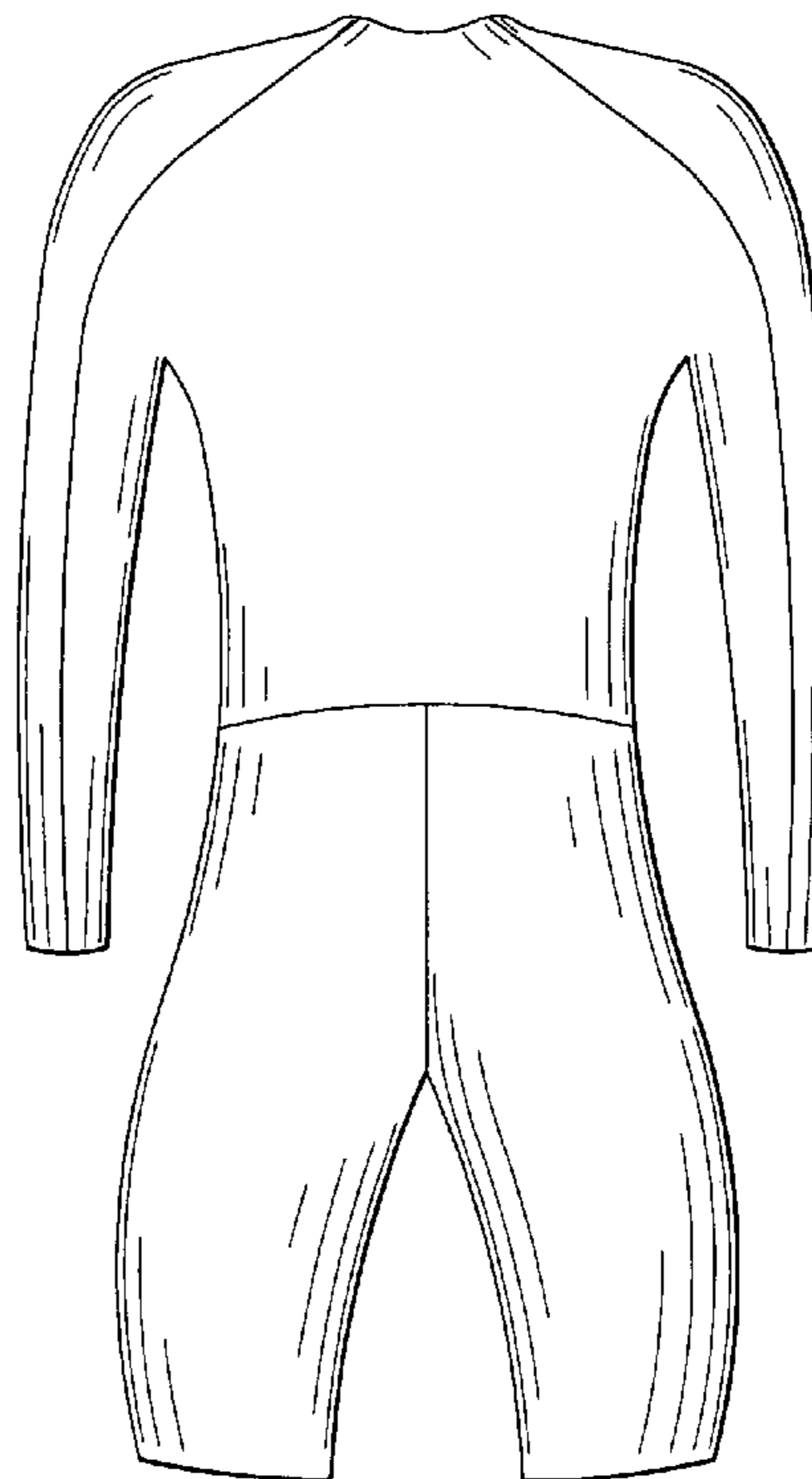
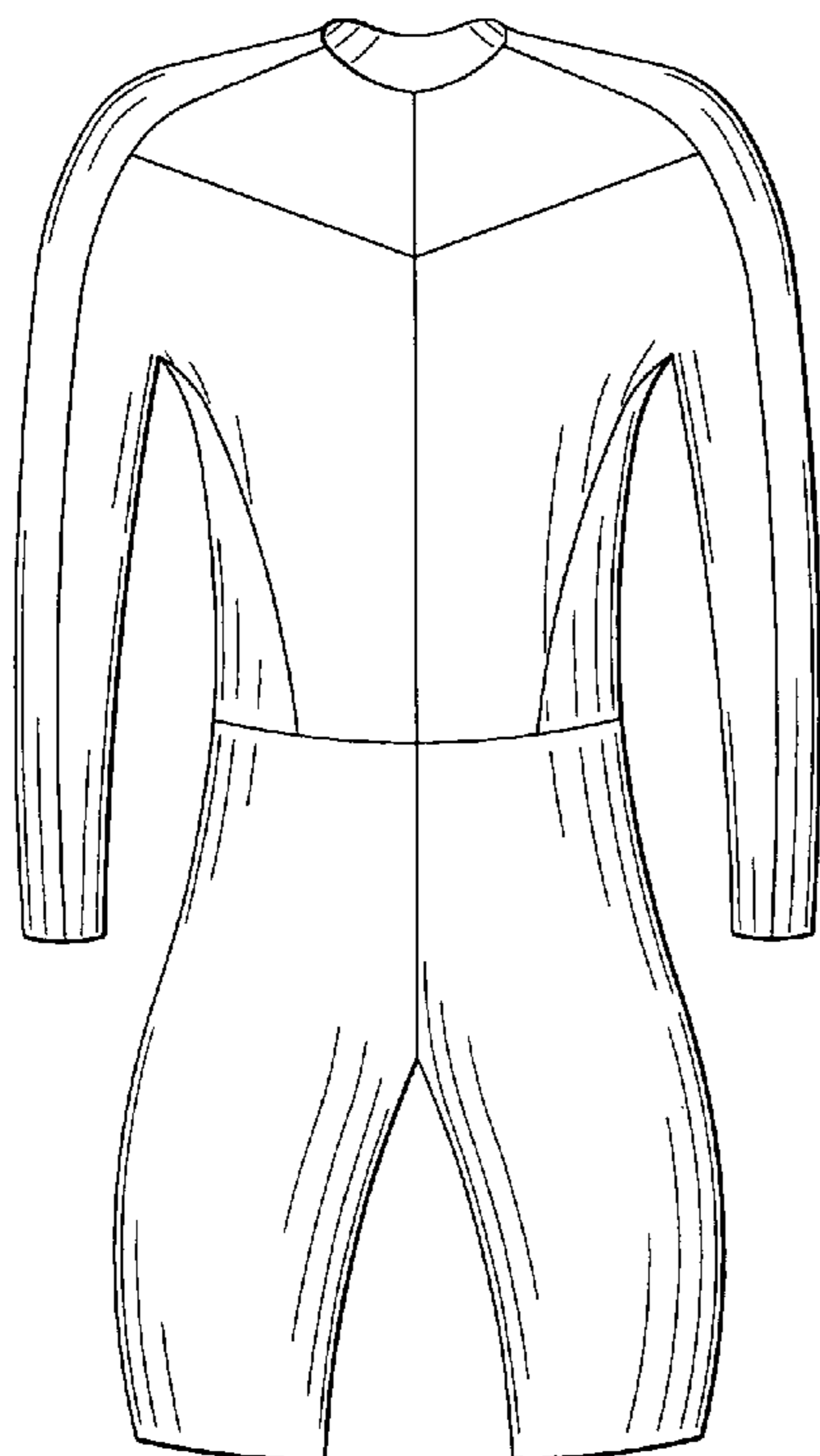
**DESCRIPTION**

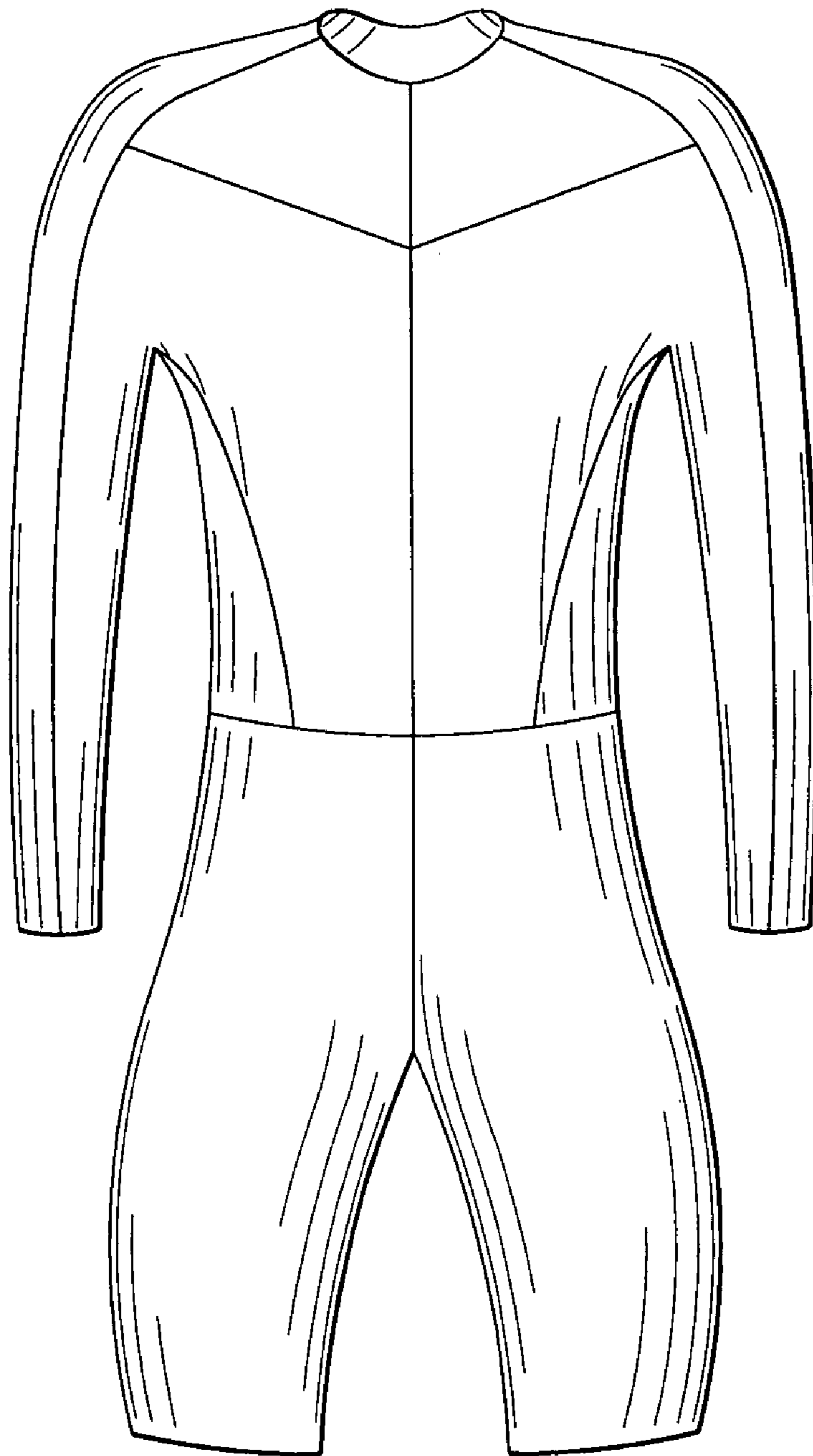

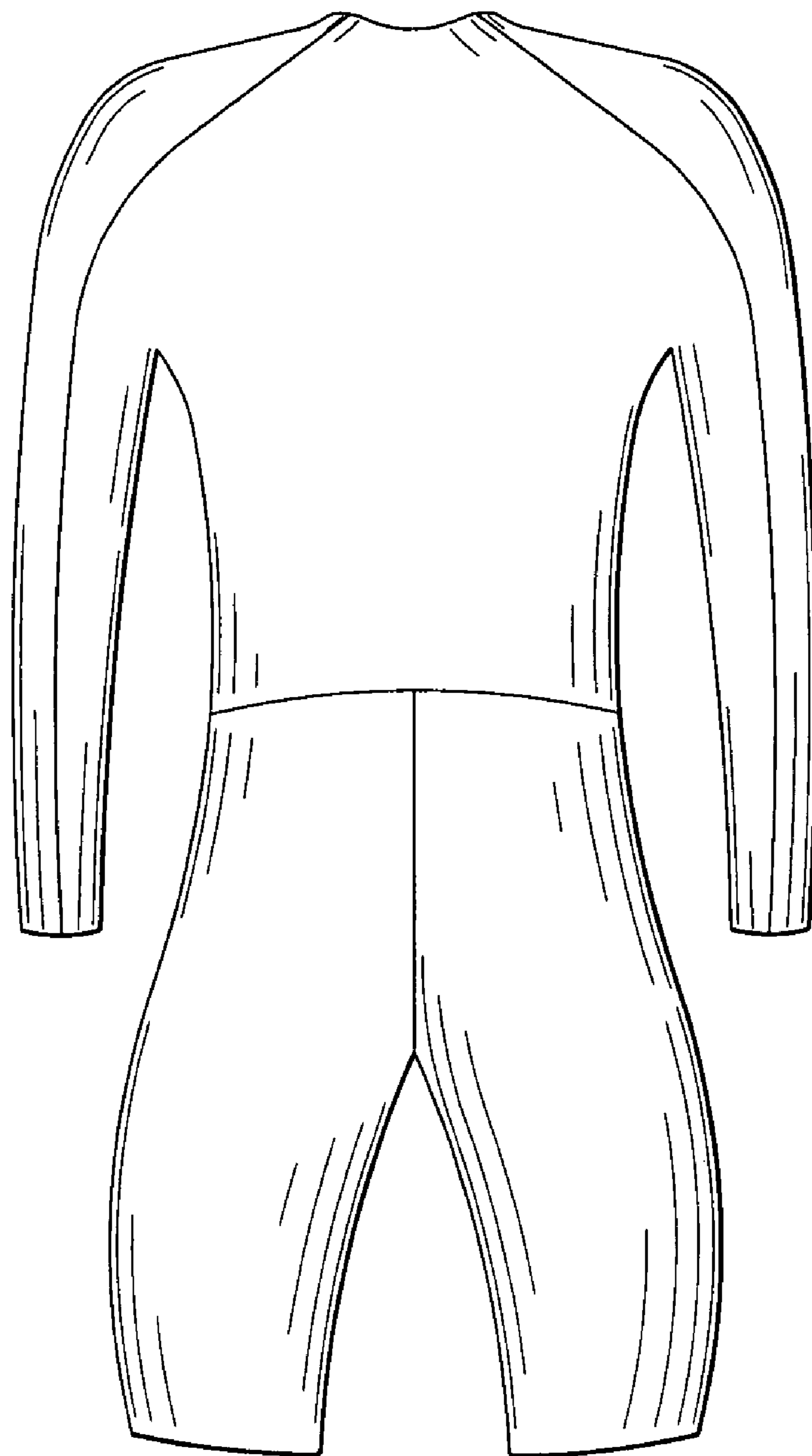
