**DESCRIPTION**

FIG. 11 is a left elevational view thereof;

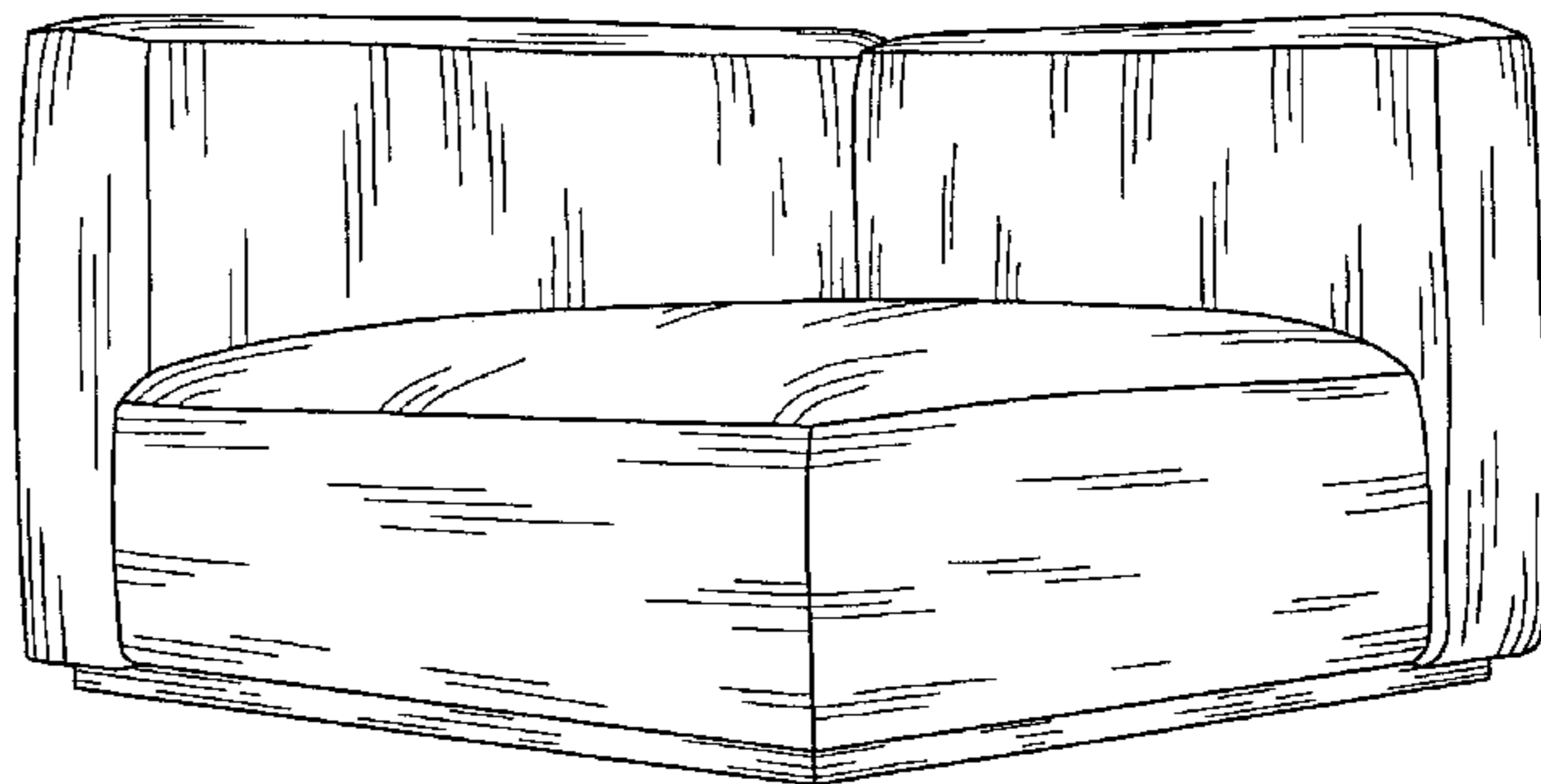
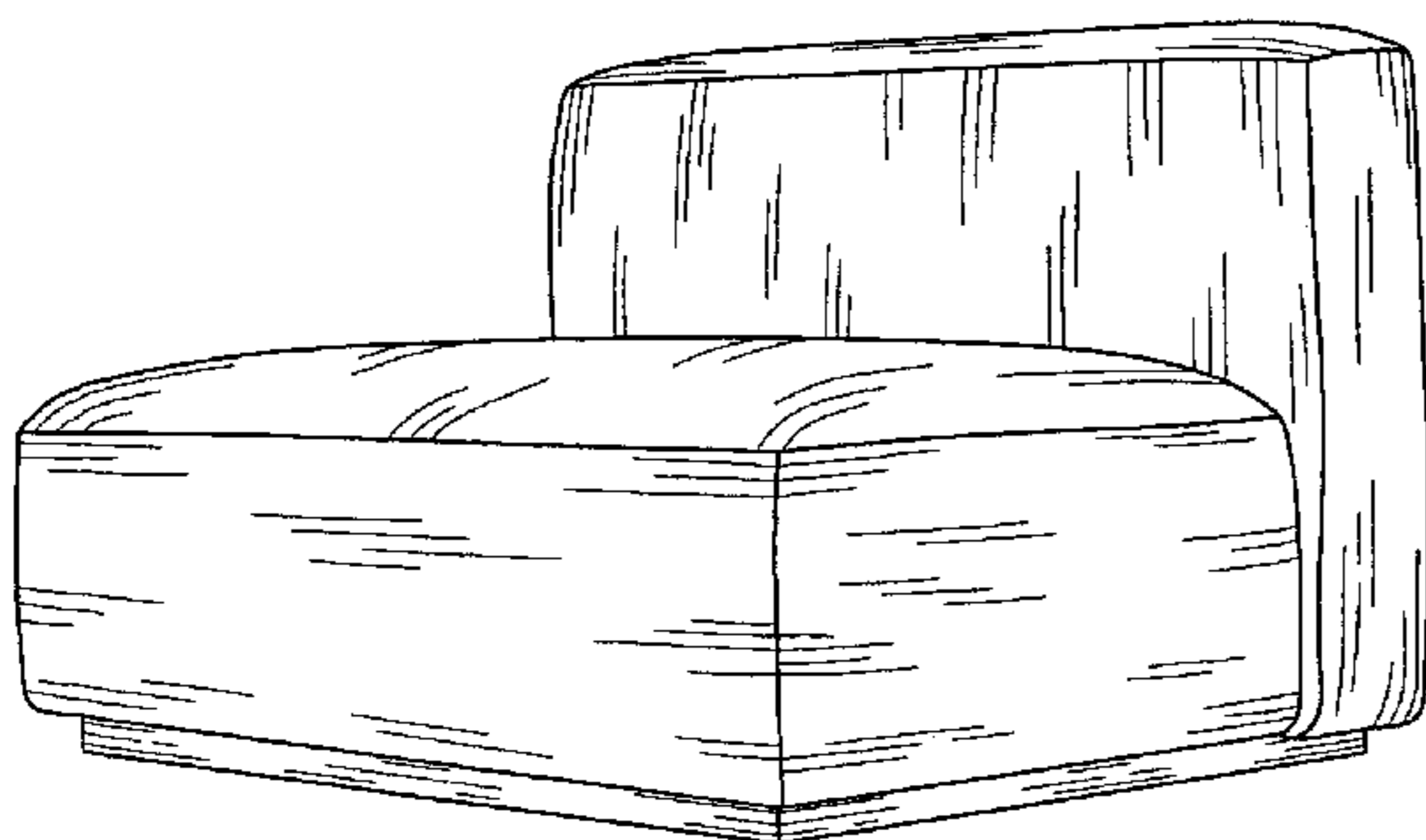
FIG. 12 is a top plan view thereof;

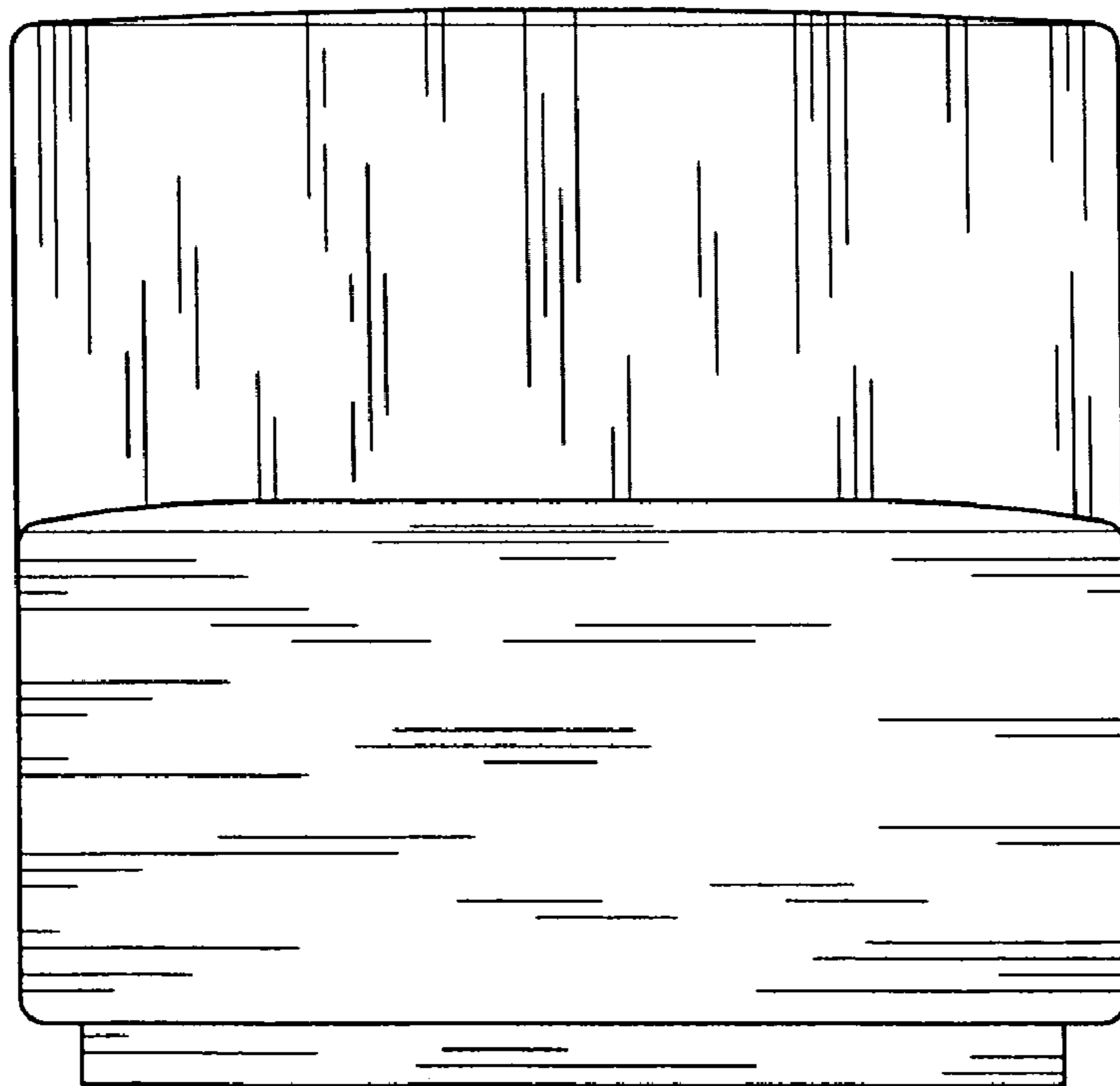

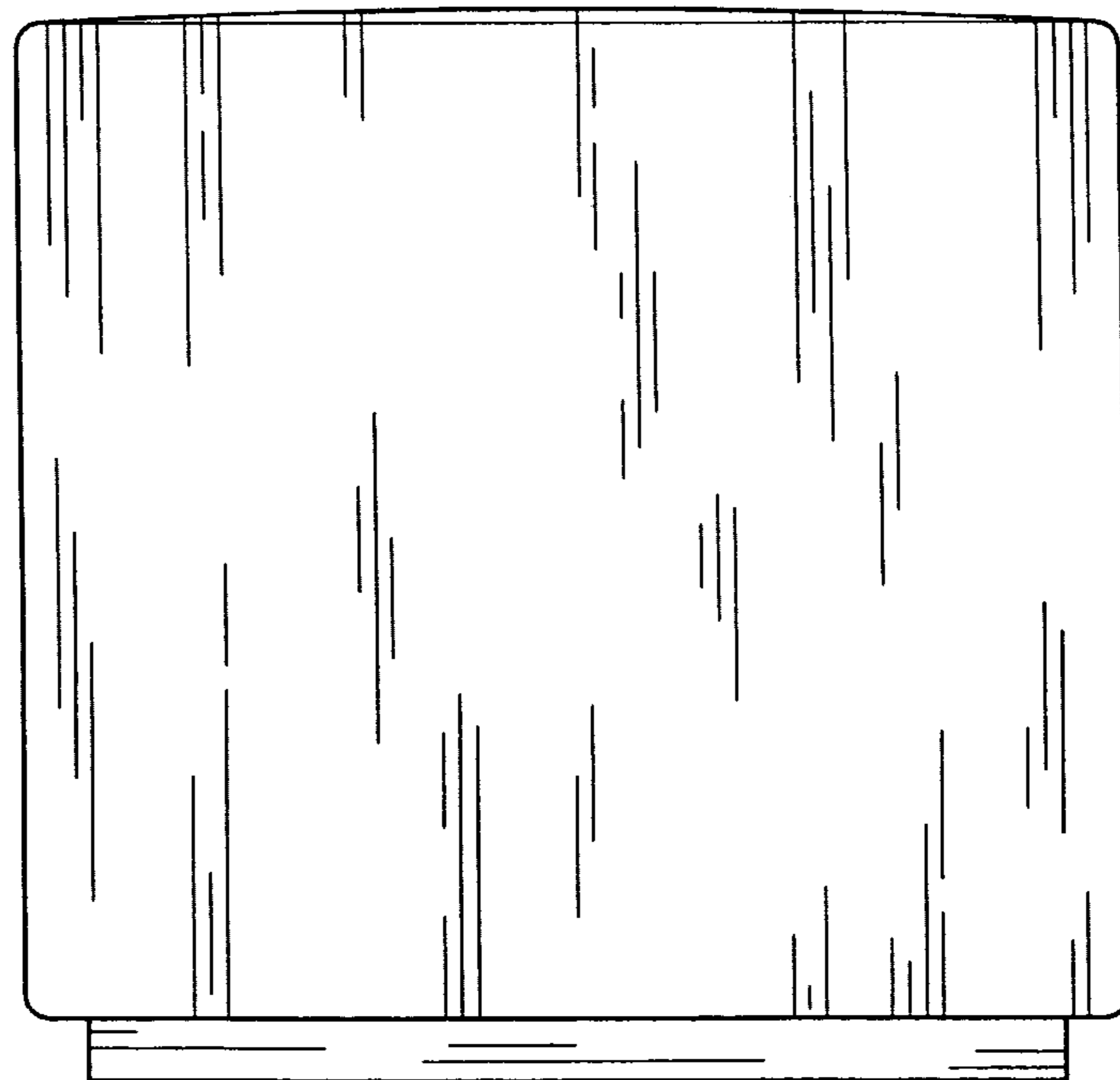

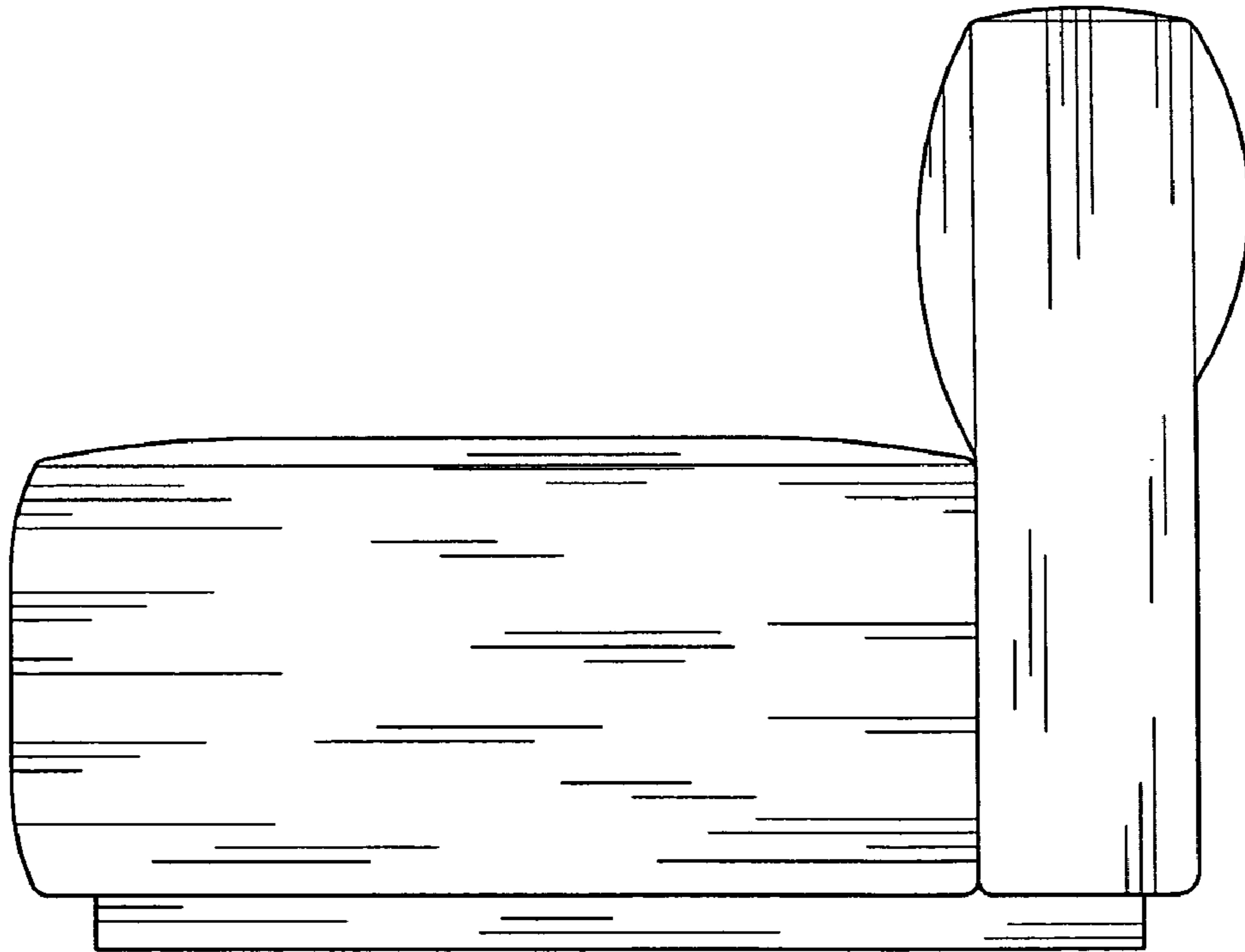

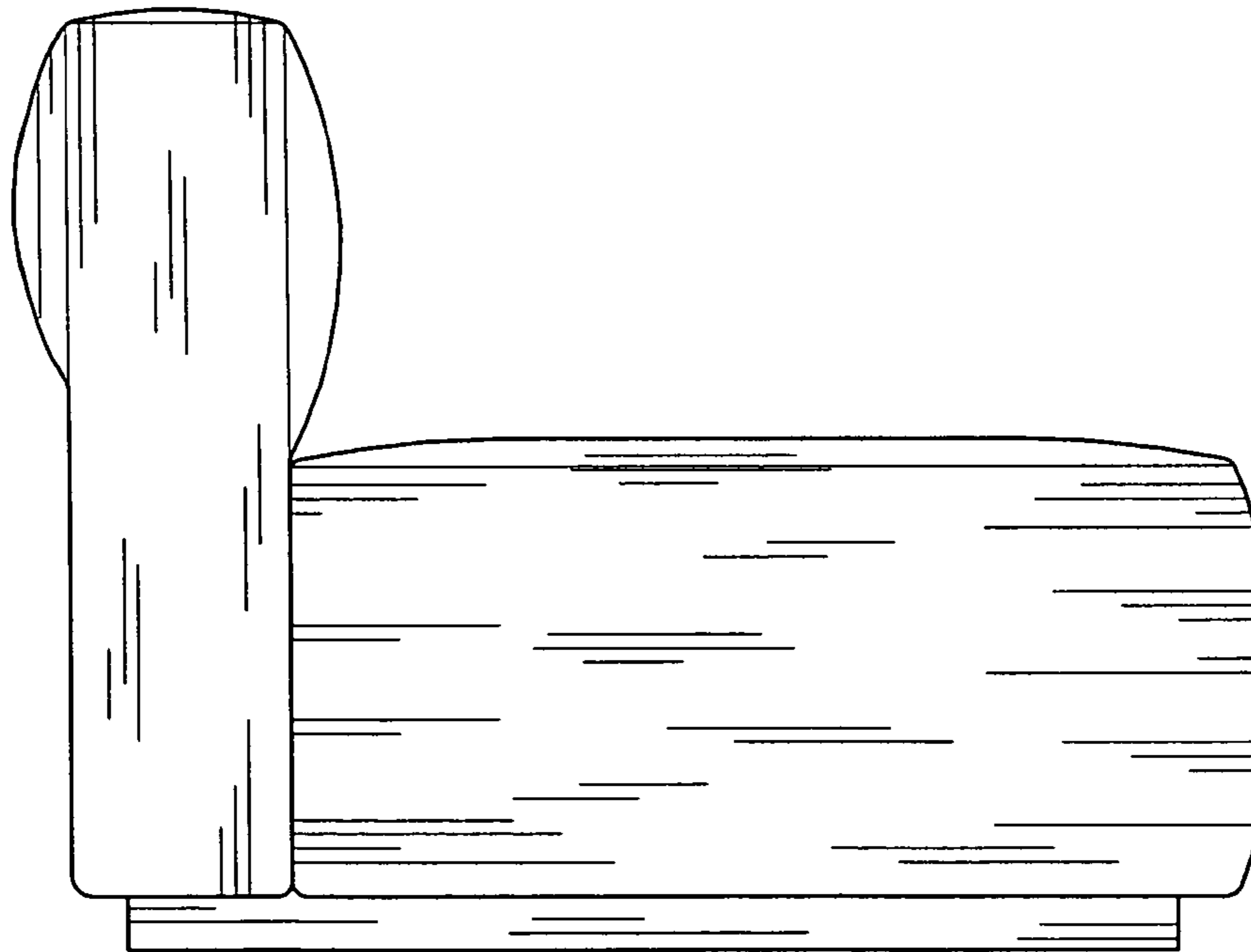

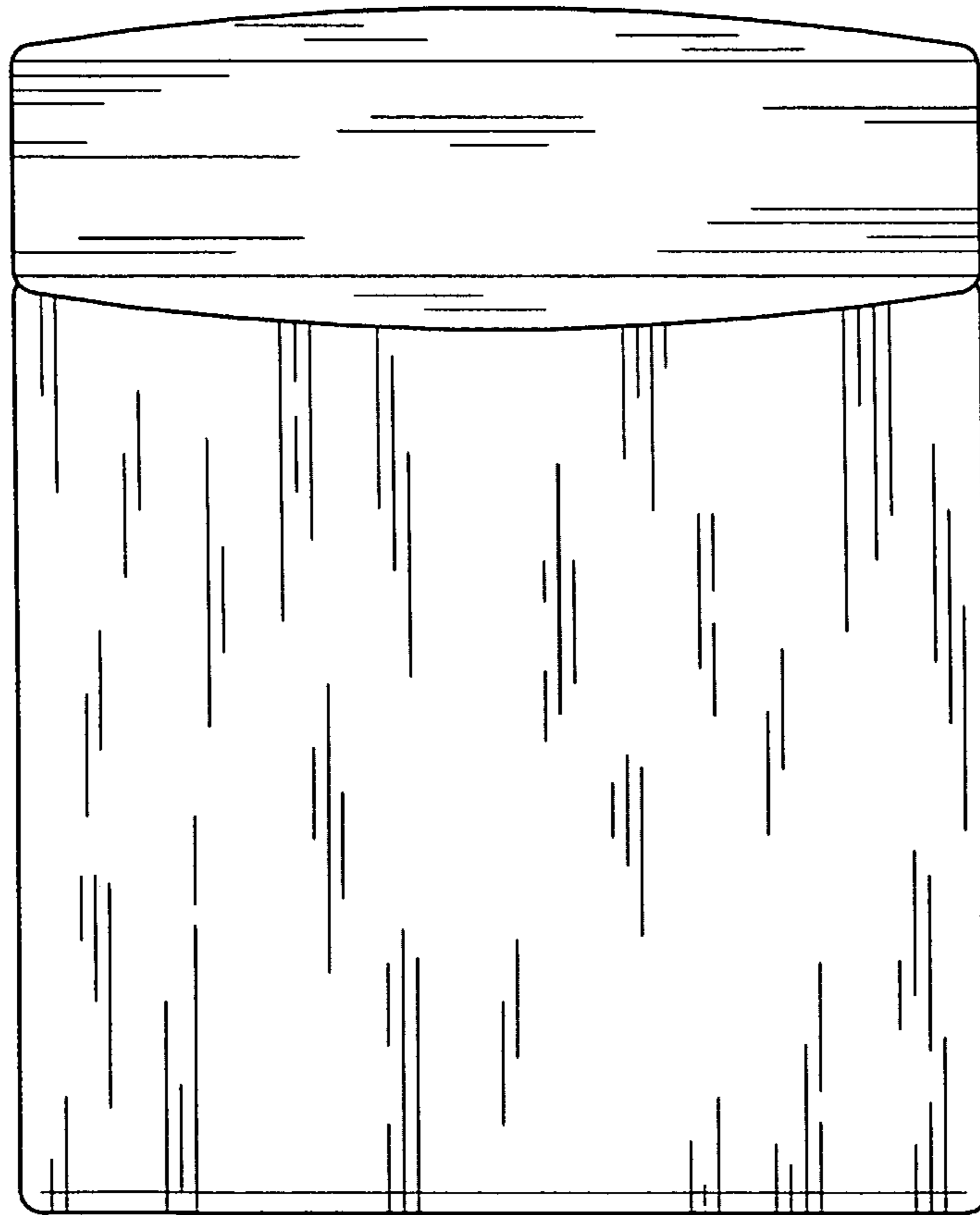

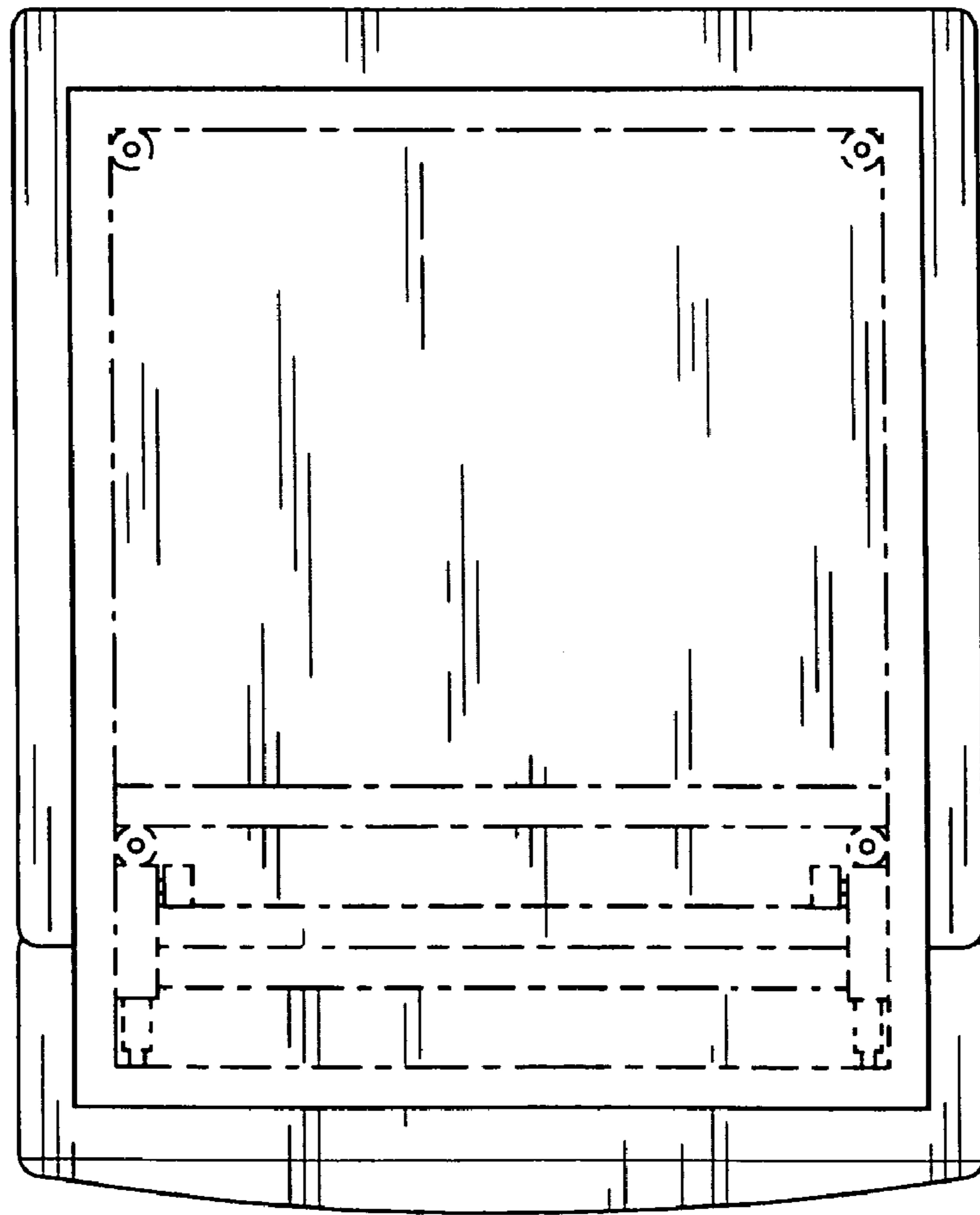

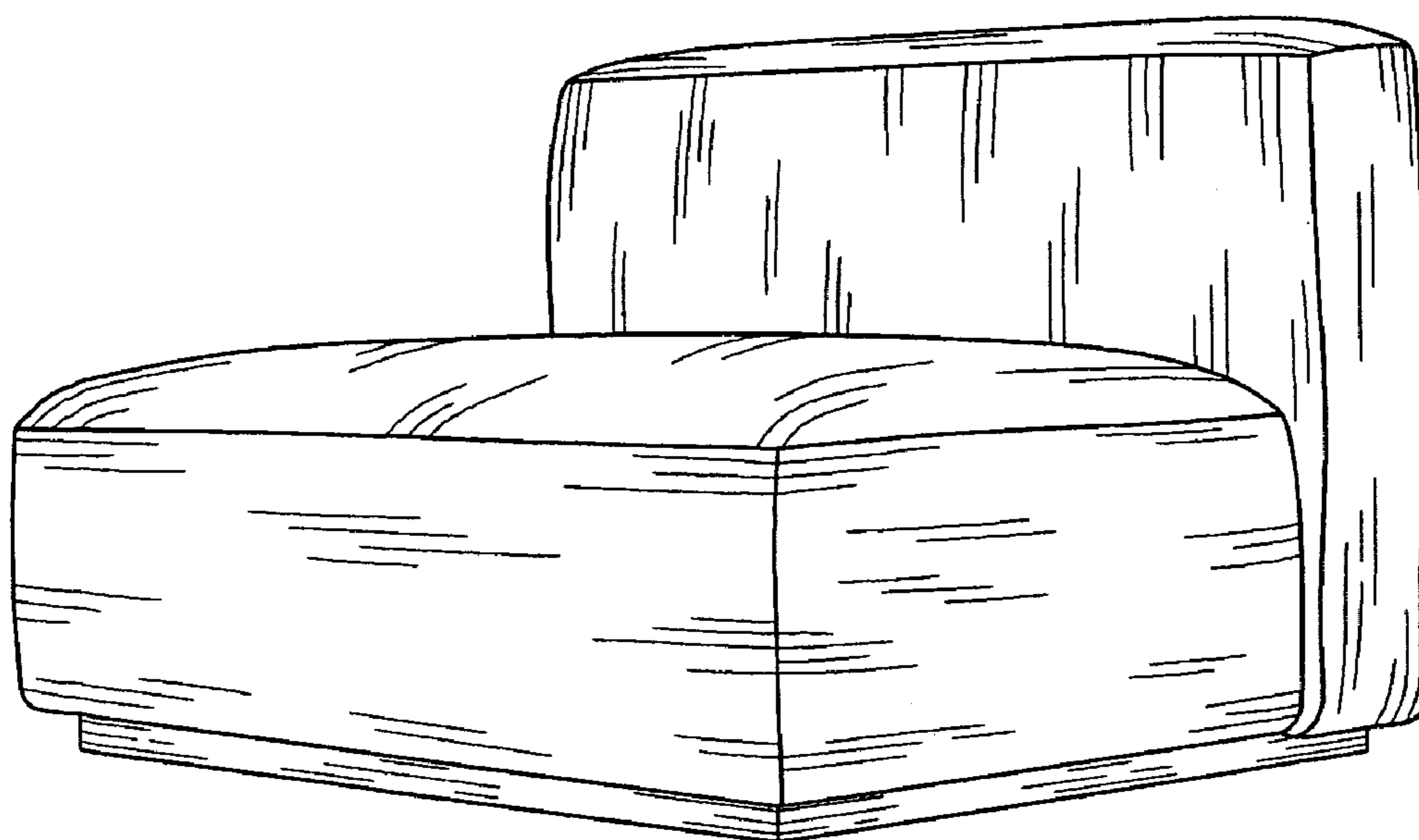

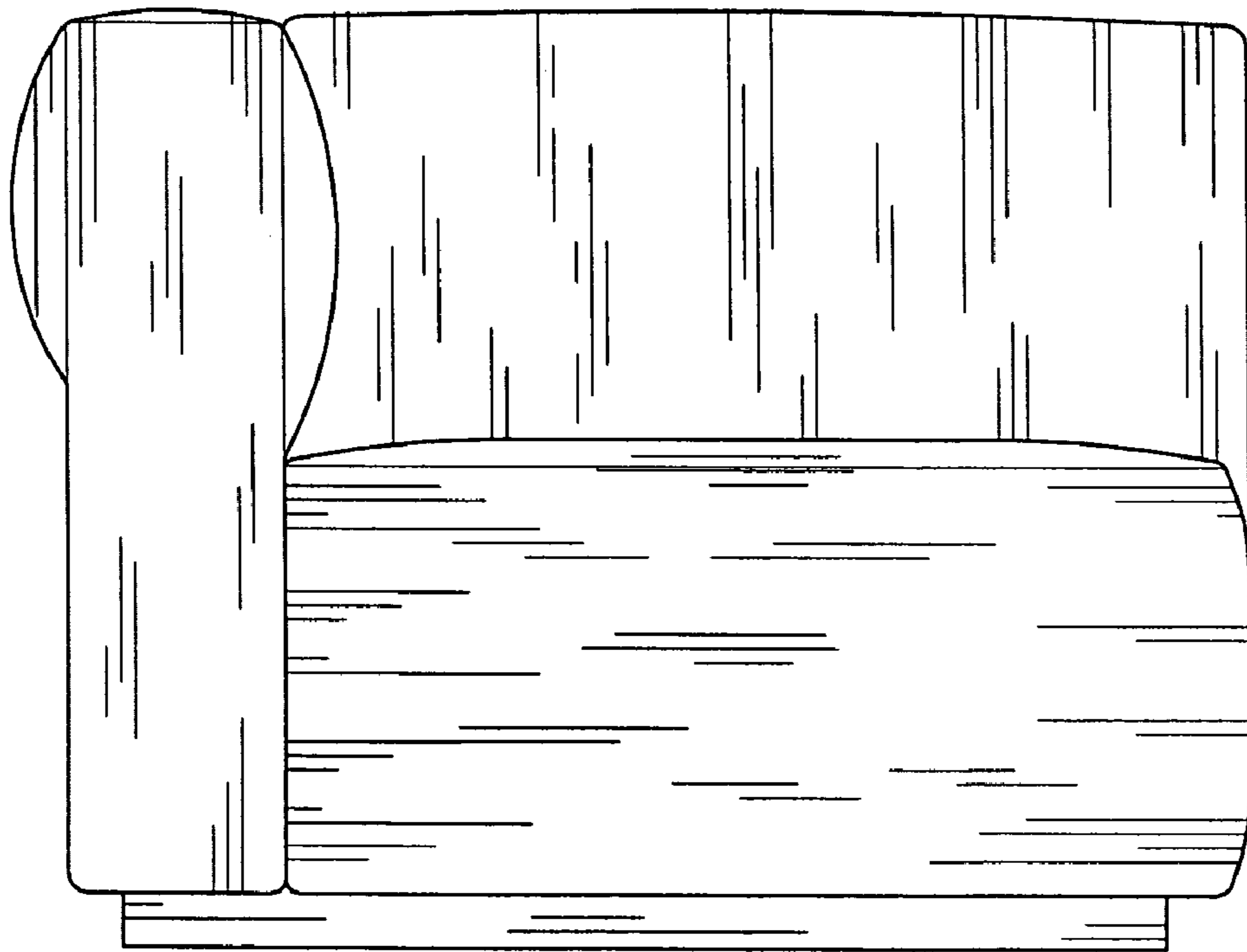

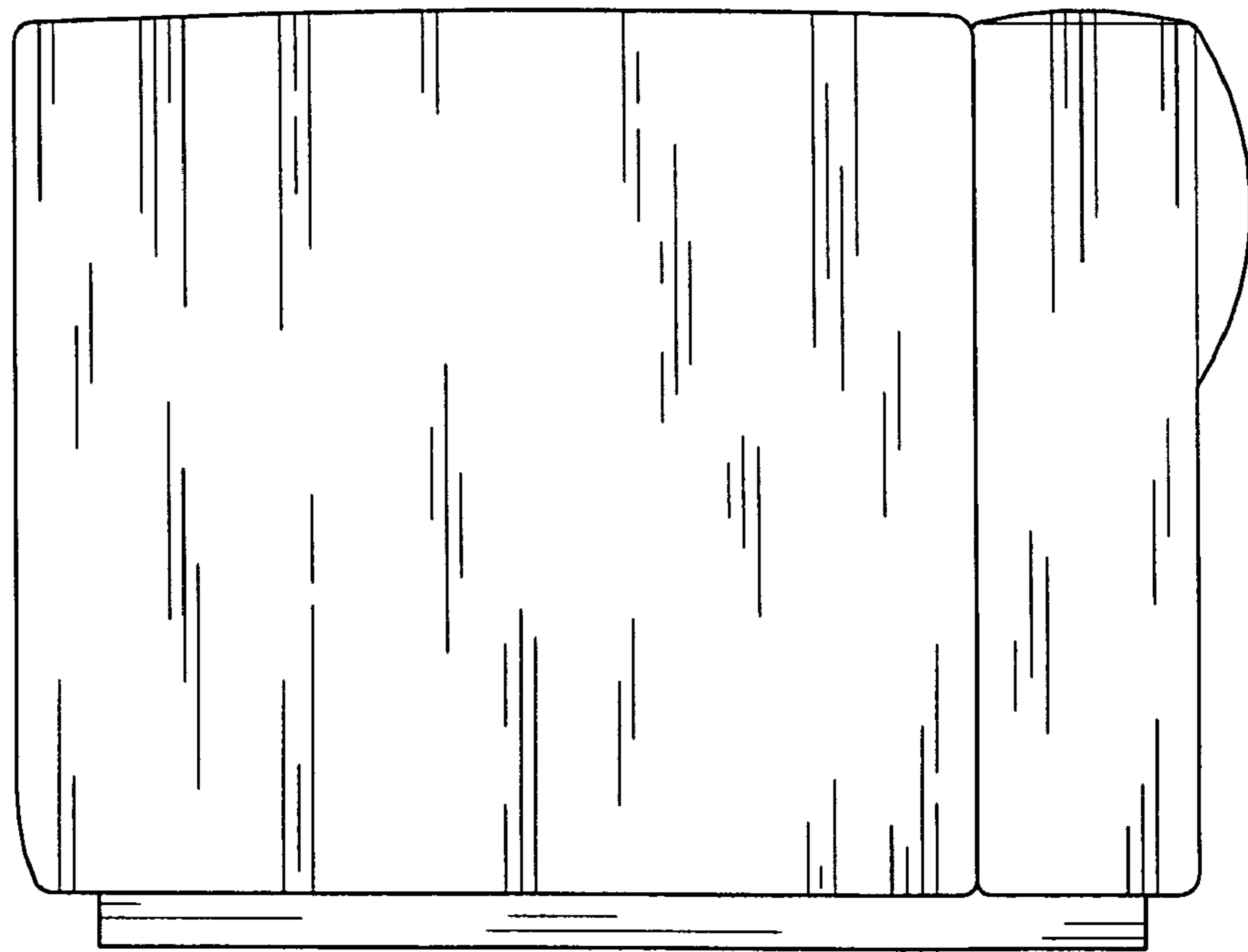

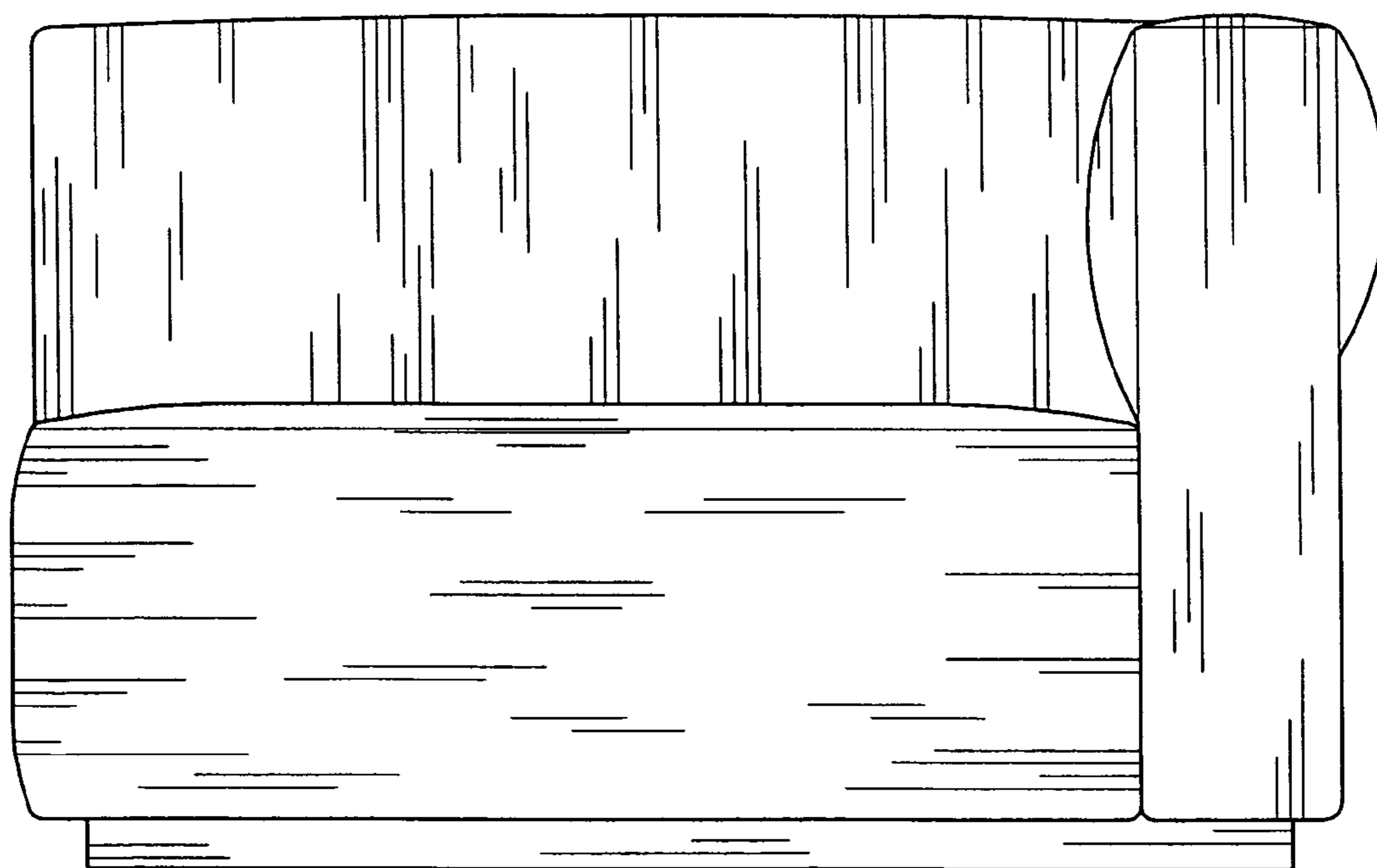

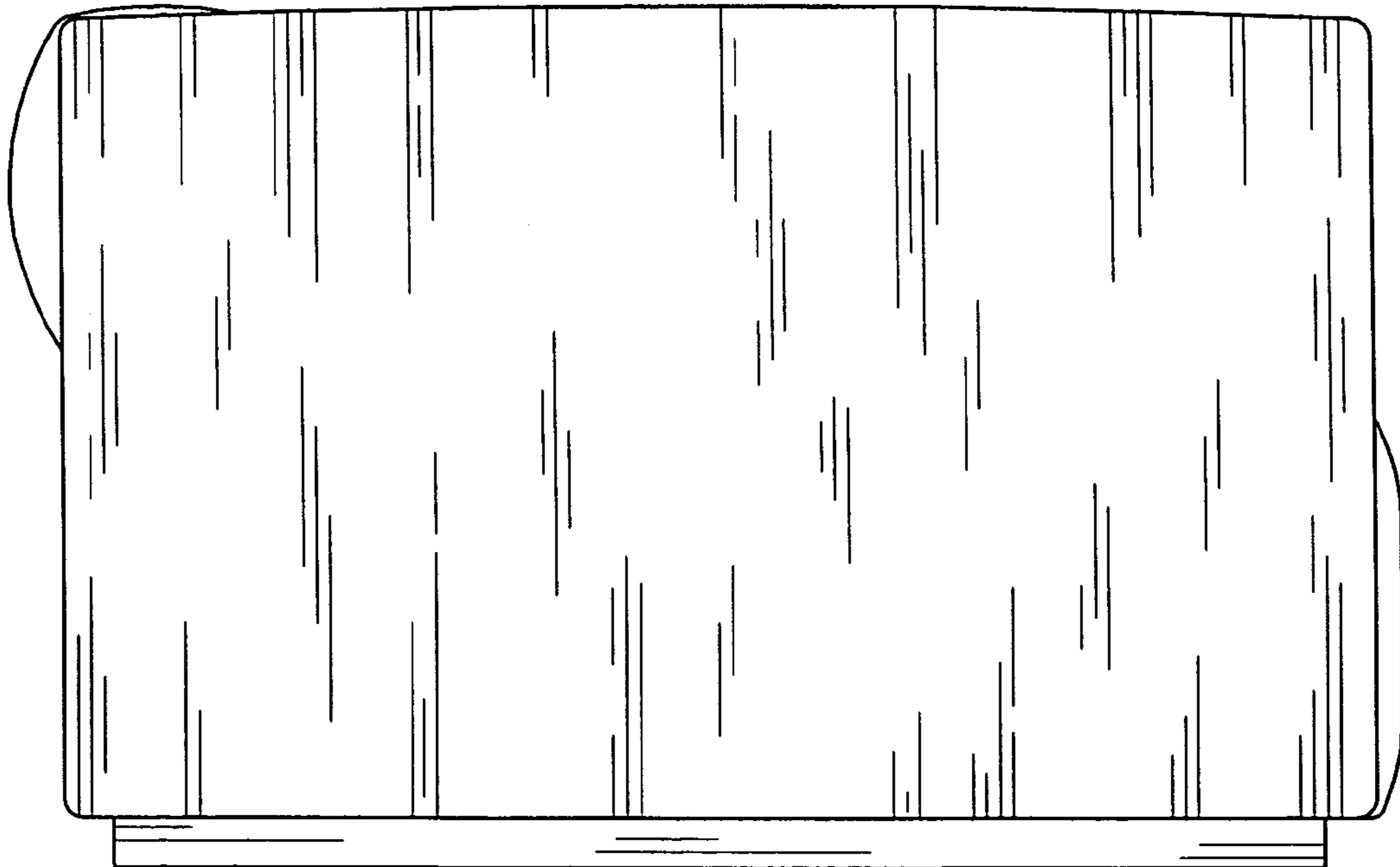

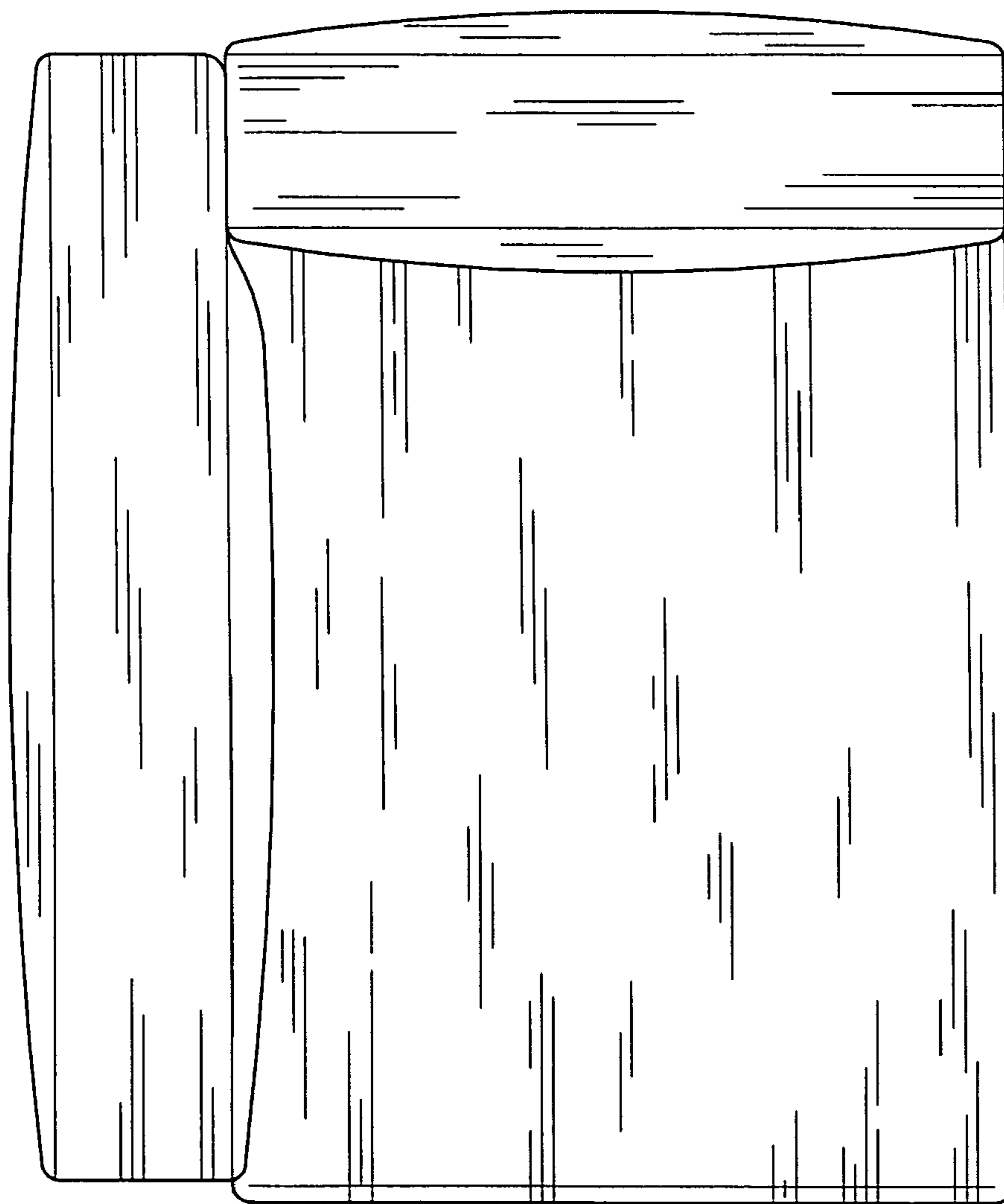

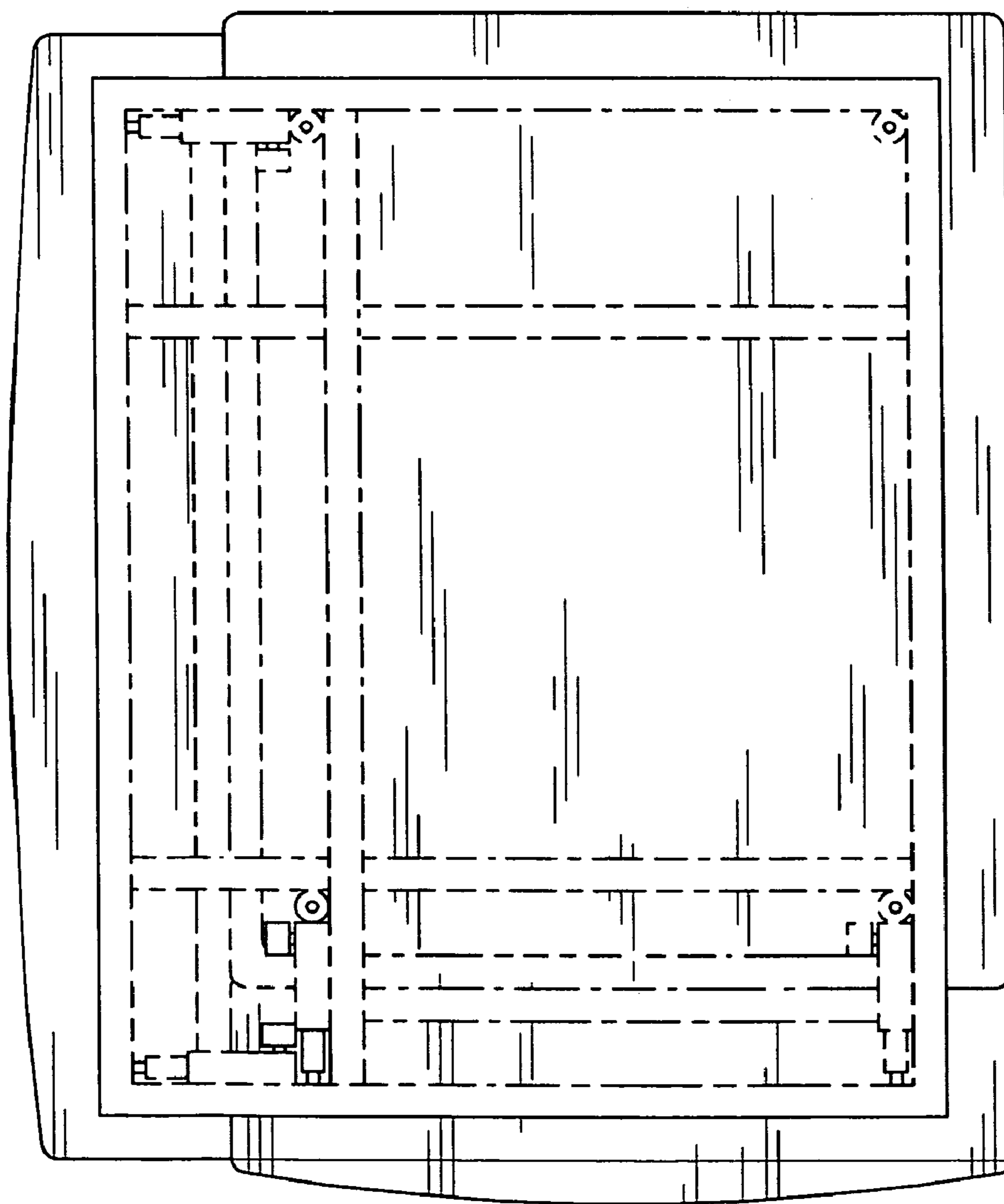

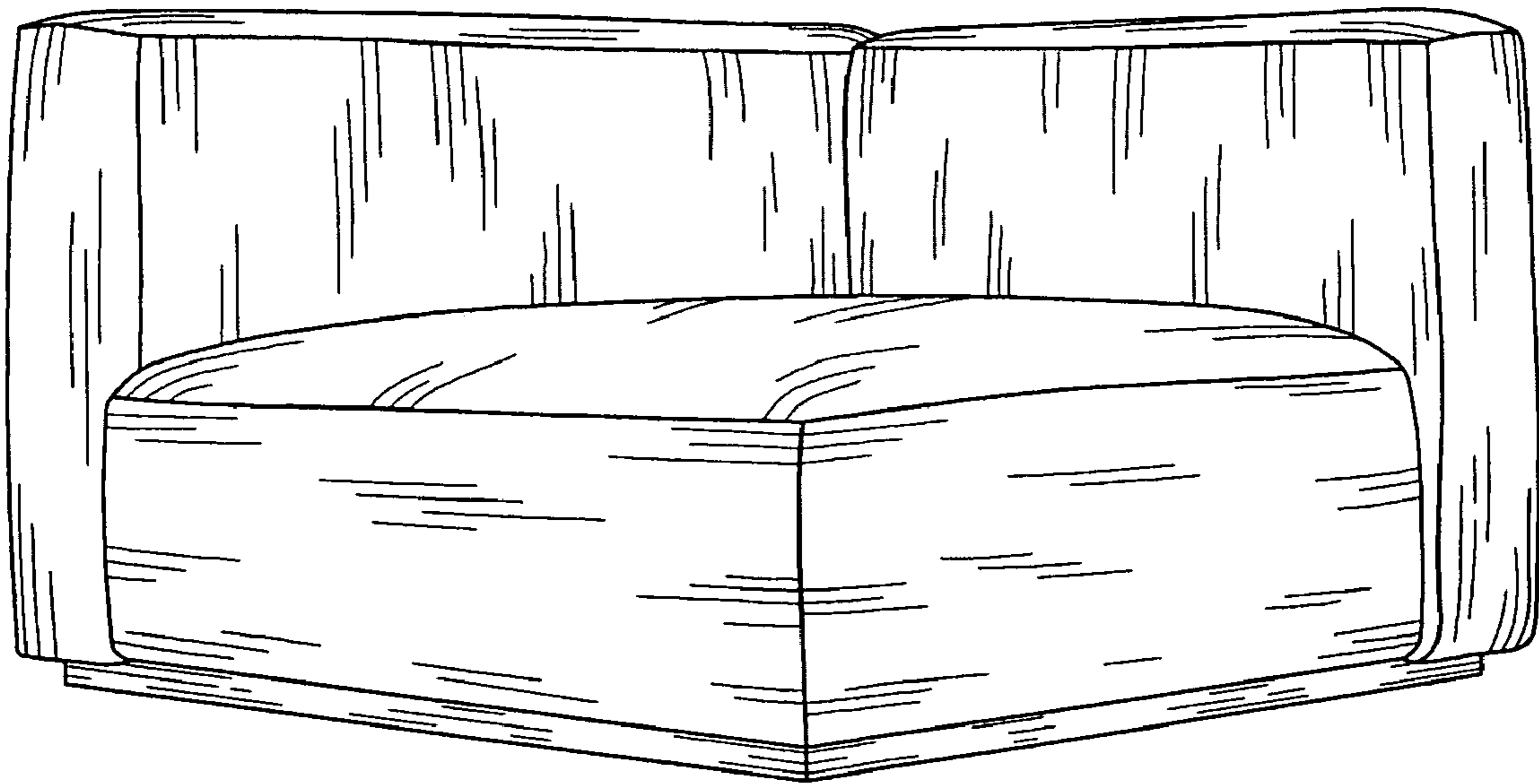
