(57) **CLAIM**

I claim the ornamental design for an angle grinder, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side view of the ornamental appearance of the angle grinder;

FIG. 2 is a right side view of the angle grinder shown in FIG. 1;

FIG. 3 is a front view of the angle grinder shown in FIG. 1;

FIG. 4 is a rear view of the angle grinder shown in FIG. 1;

FIG. 5 is a top view of the angle grinder shown in FIG. 1;

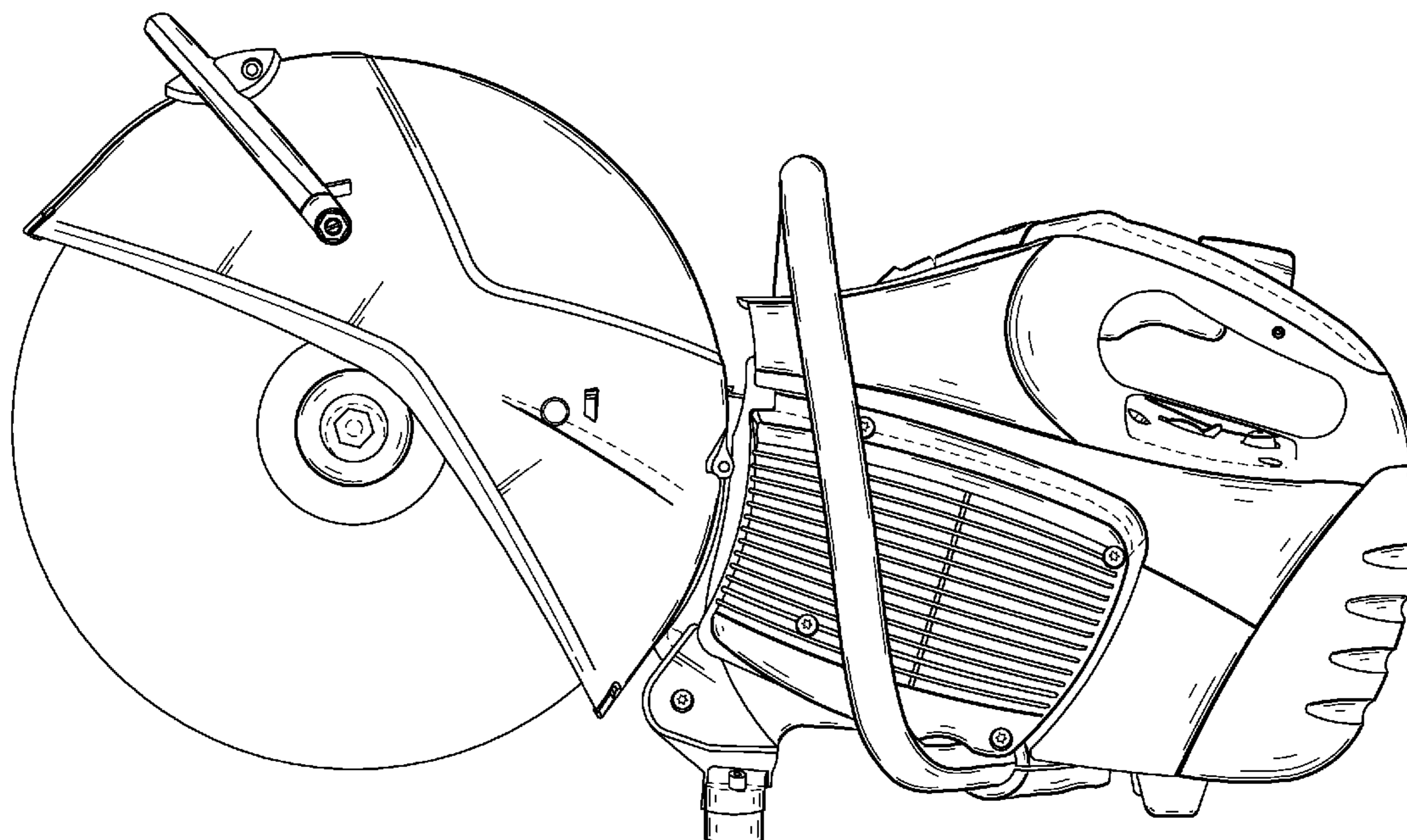
FIG. 6 is a front left perspective view of the angle grinder shown in FIG. 1; and,

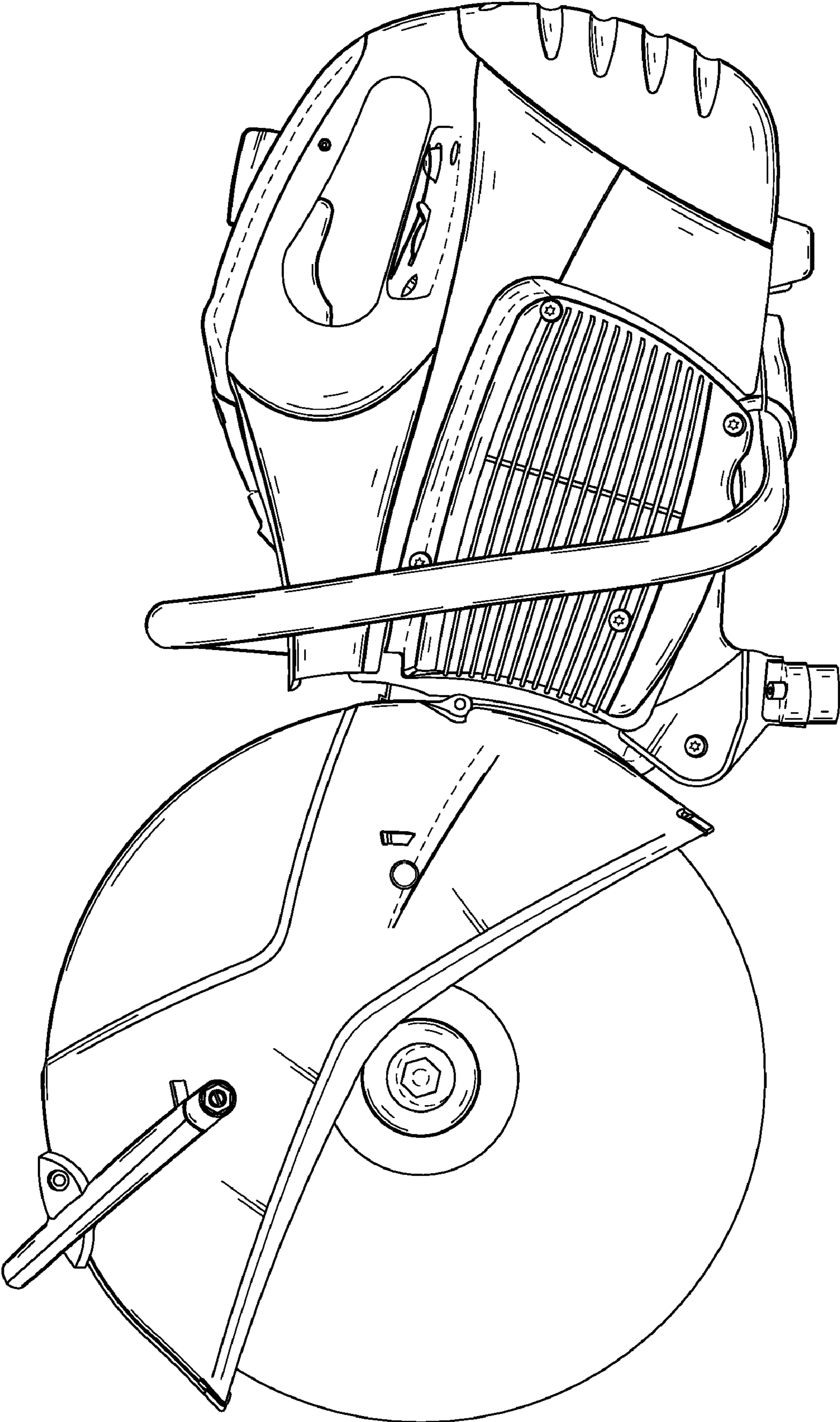
FIG. 7 is a rear right perspective view of the angle grinder shown in FIG. 1.

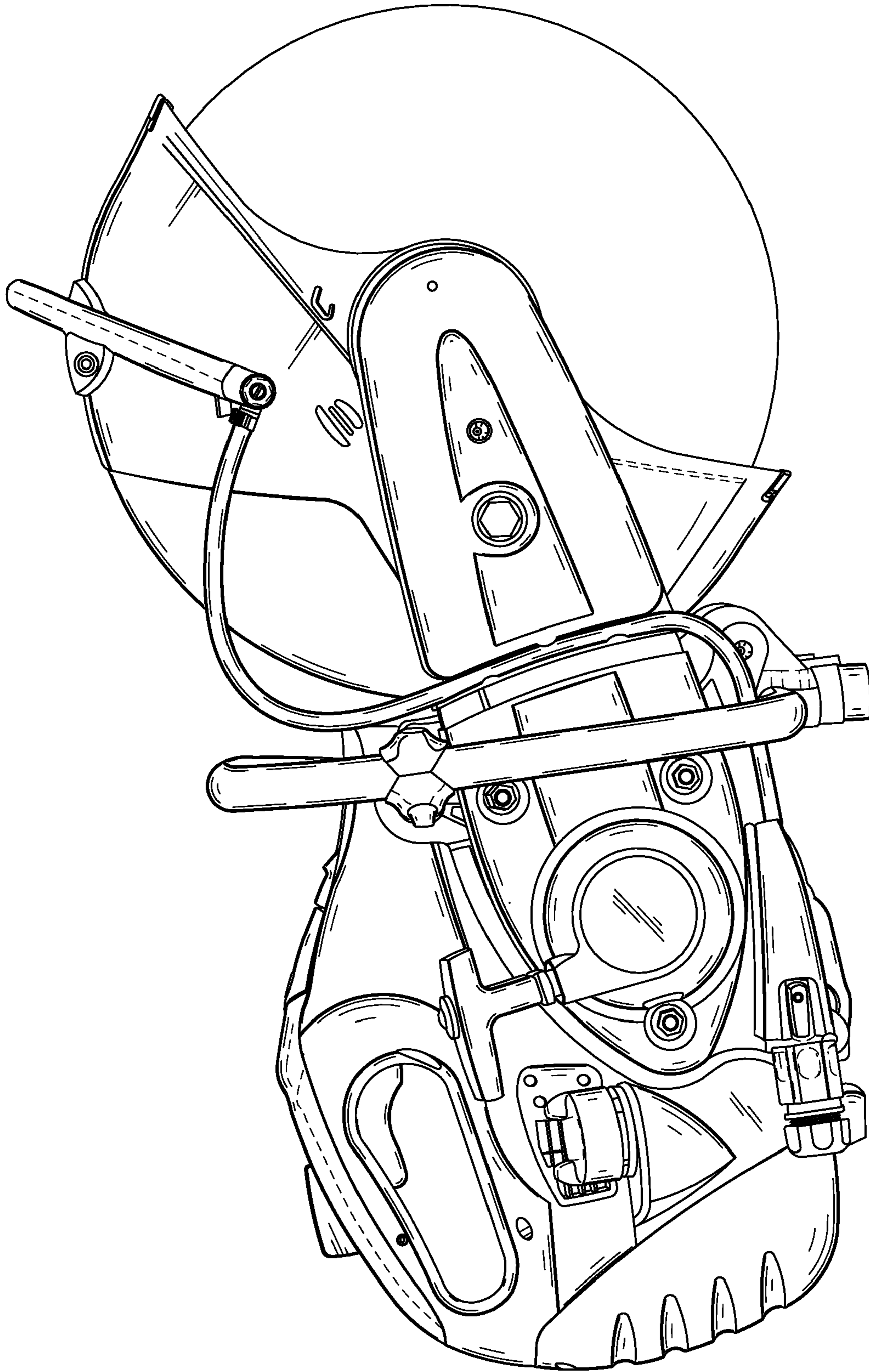
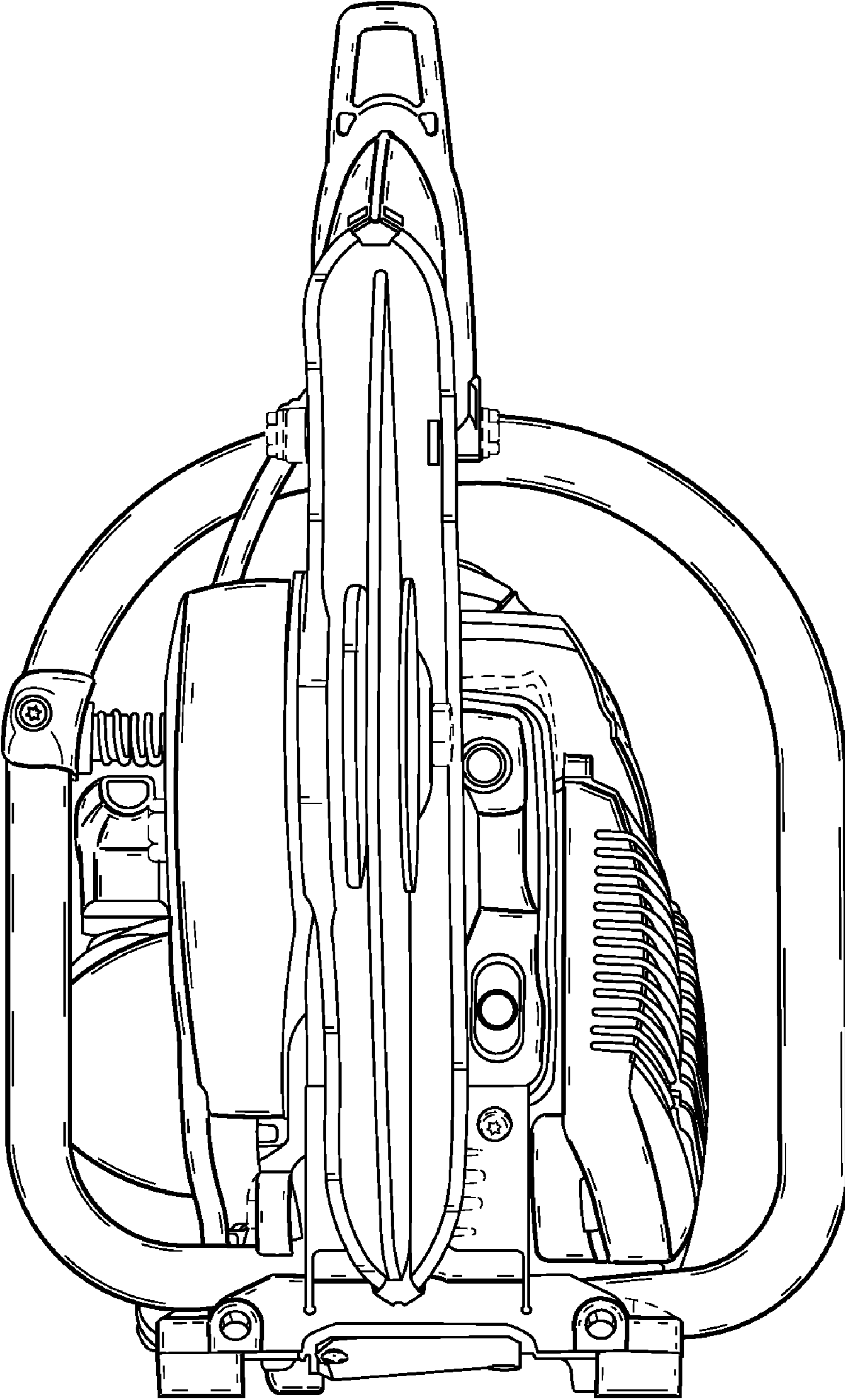
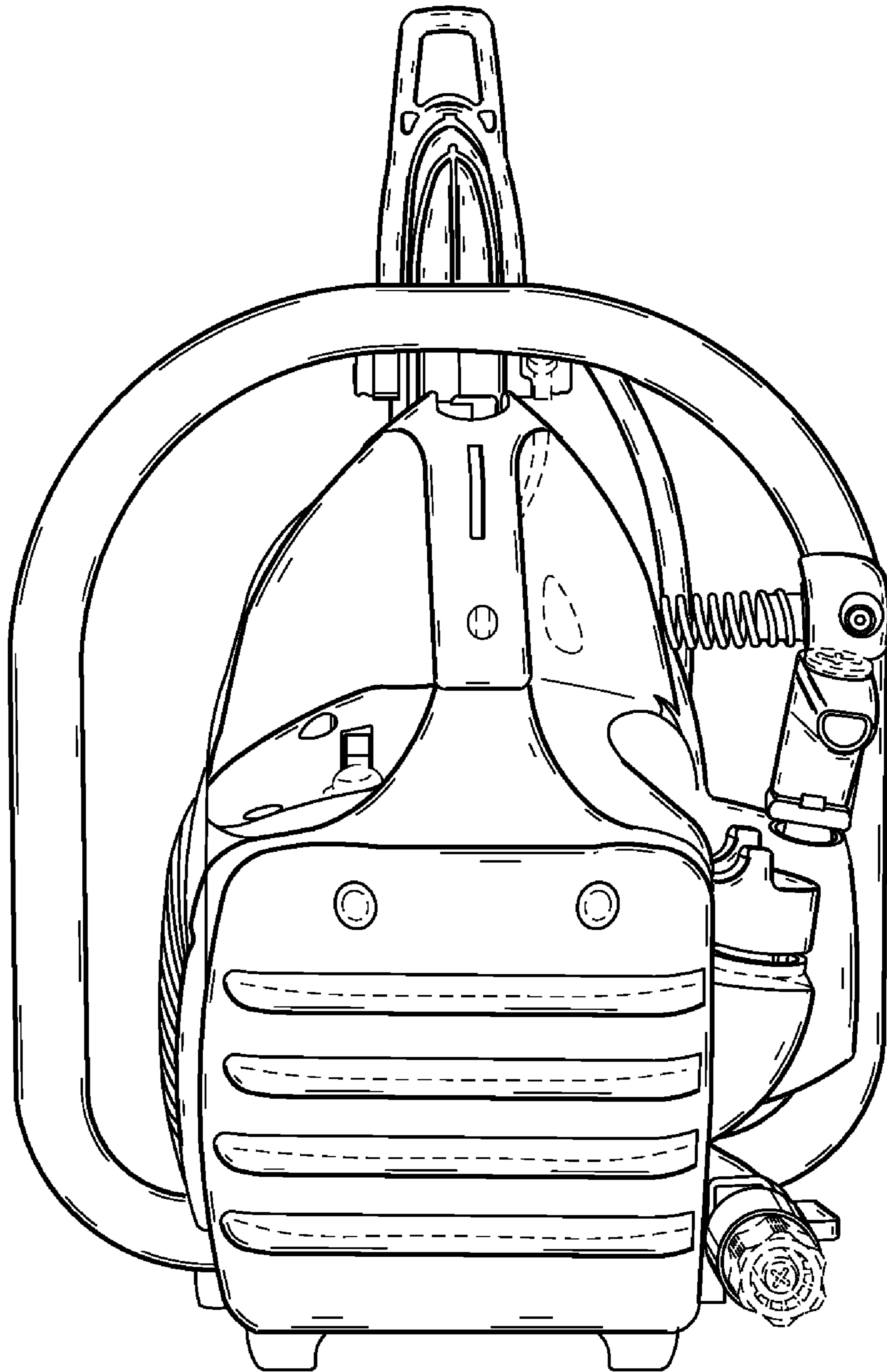


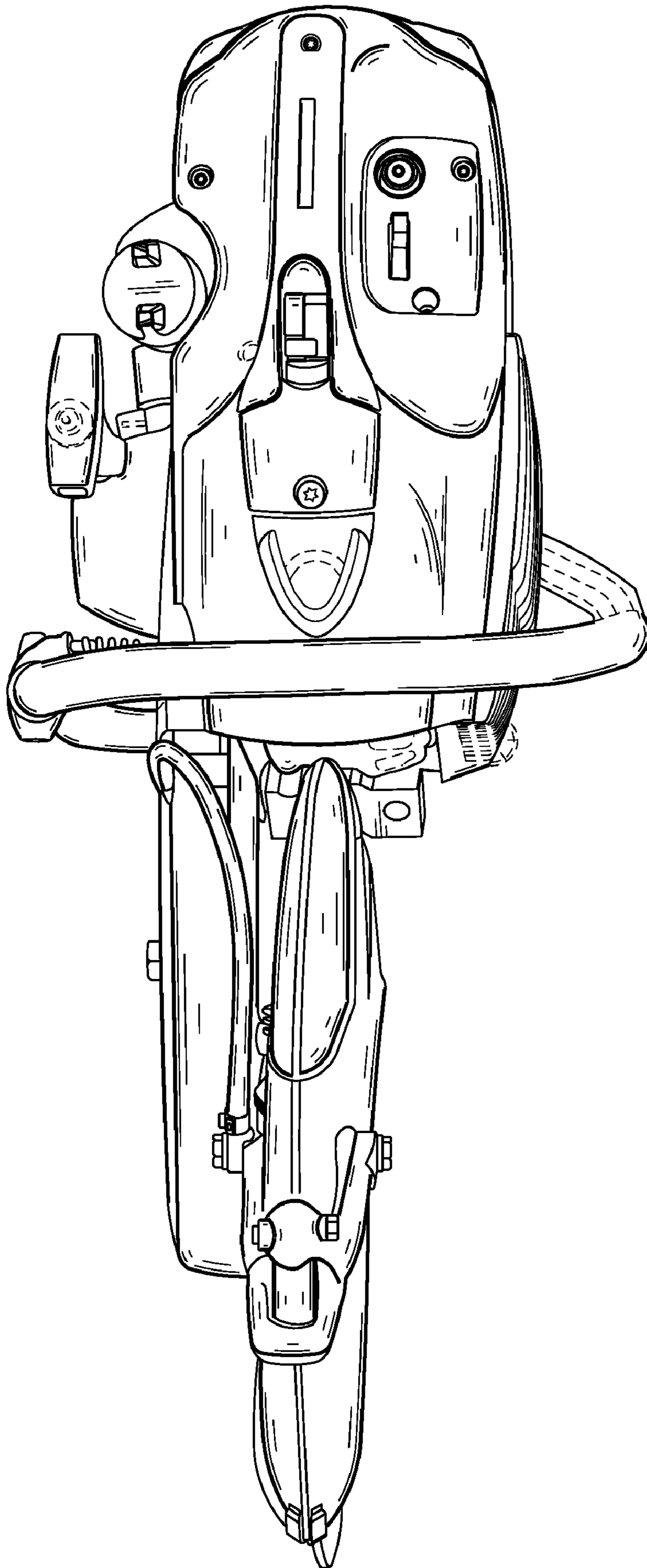

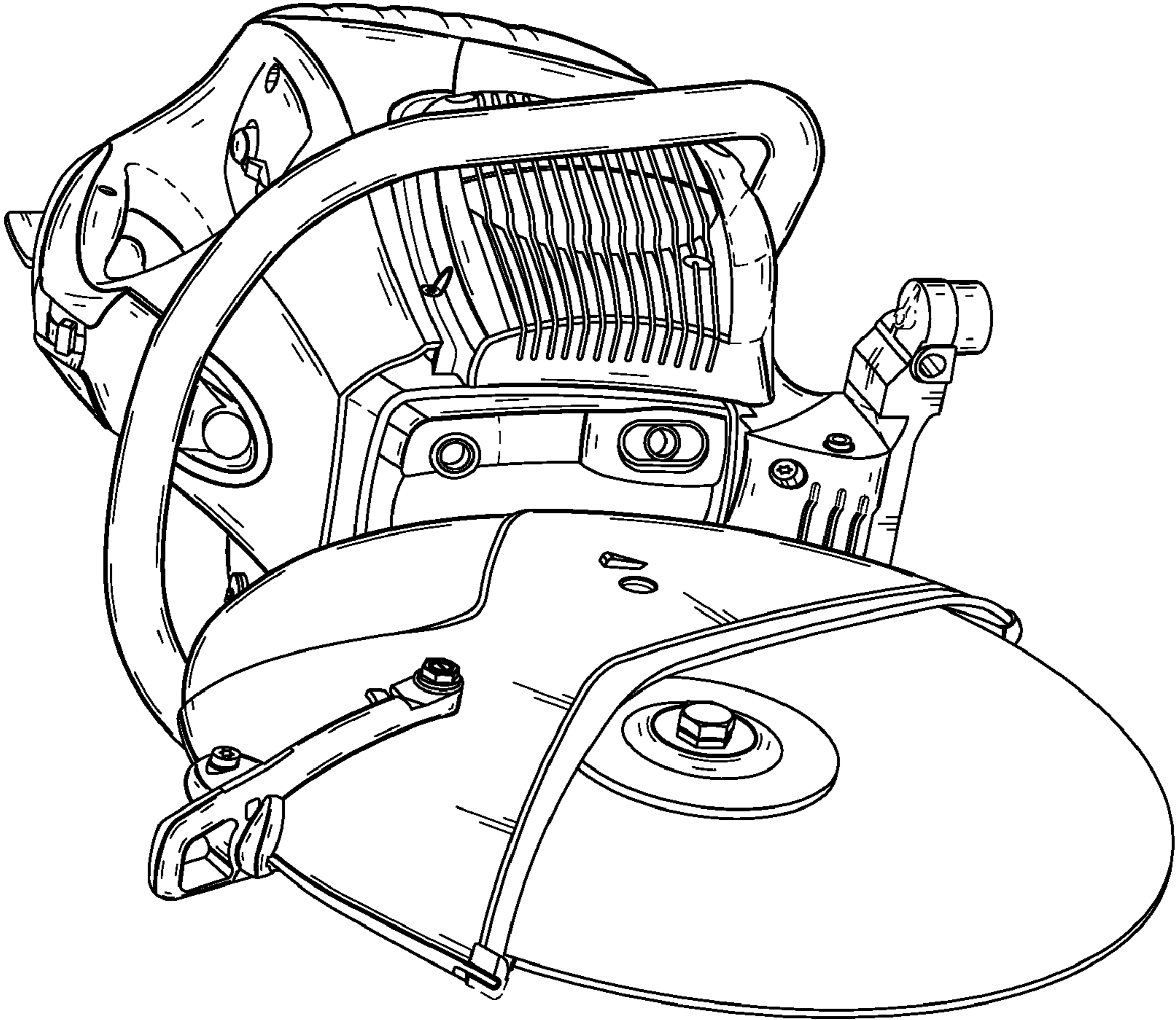
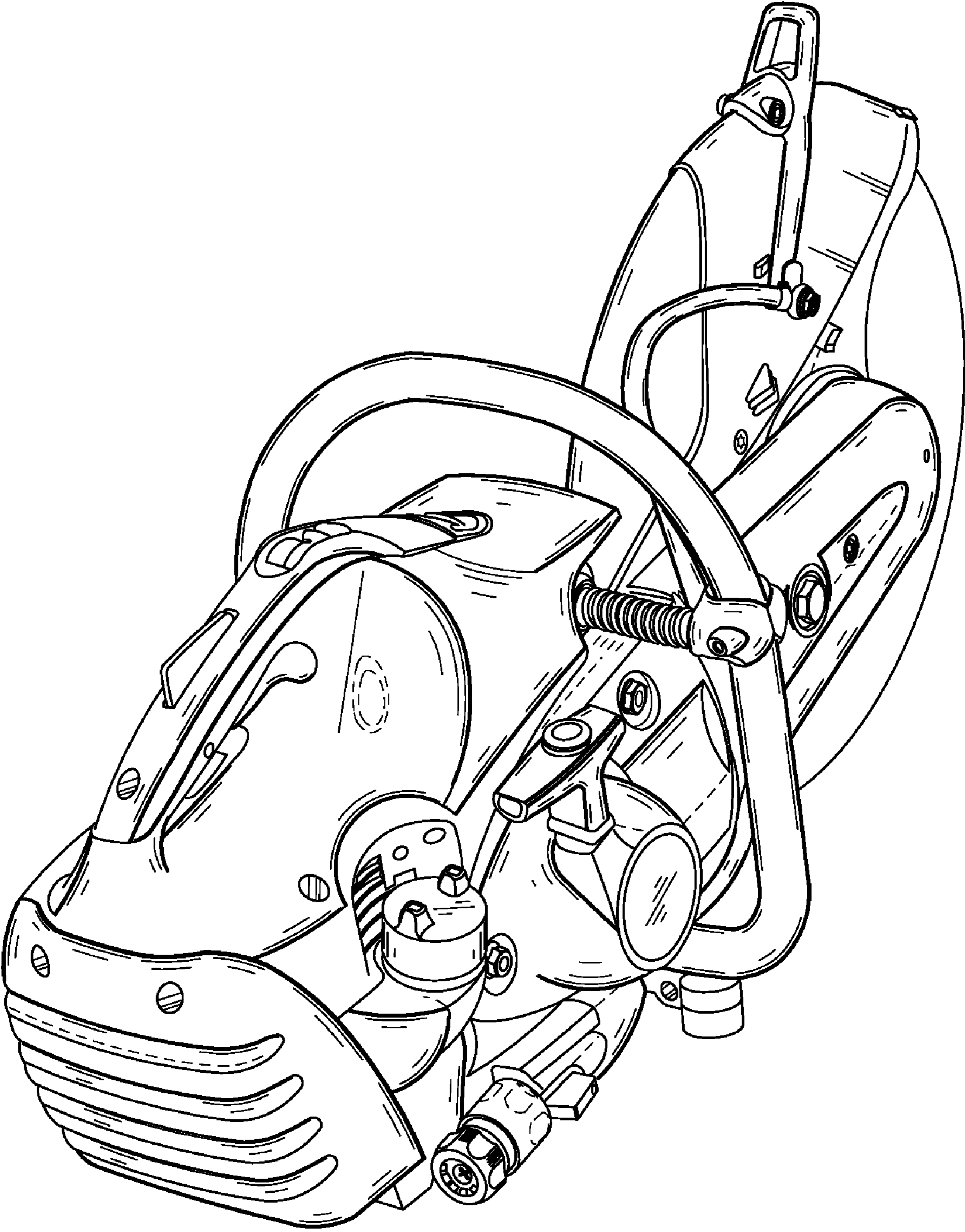
