We claim the ornamental design for a decorated c-shaped clip, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of our new decorated c-shaped clip design;

FIG. 2 is a rear perspective view of the decorated c-shaped clip design;

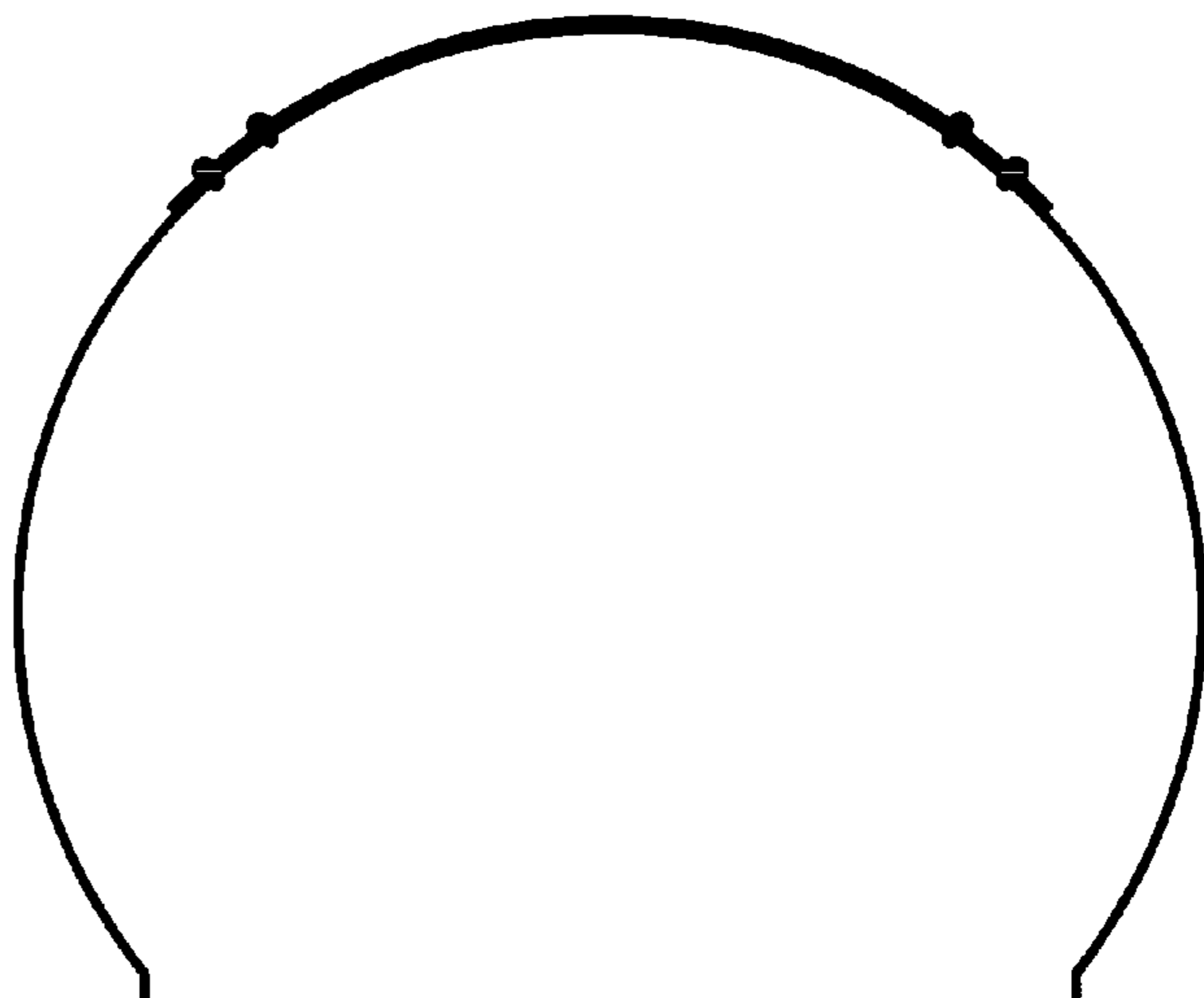
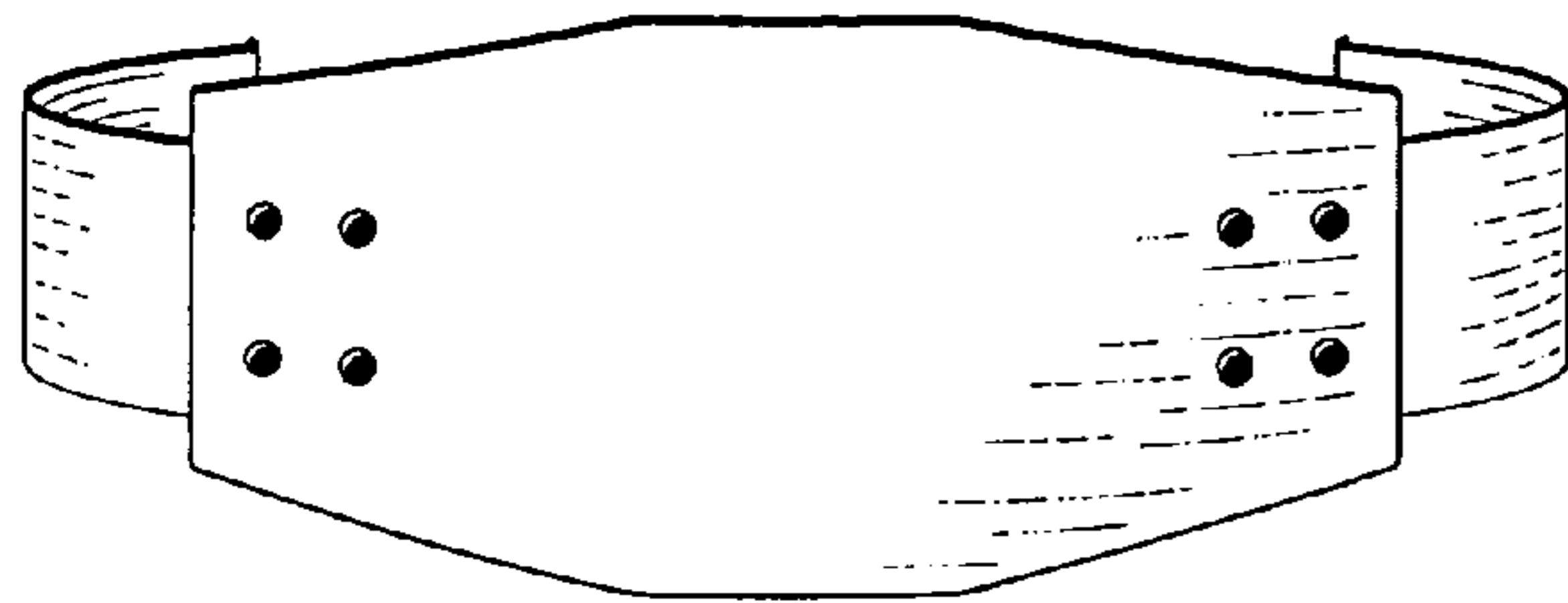
FIG. 3 is a left side orthogonal view of the decorated c-shaped clip design; the right side orthogonal view is a mirror image of the left side view;

FIG. 4 is a top orthogonal view of the decorated c-shaped clip design; the bottom orthogonal view is identical to the top view;

FIG. 5 is a front orthogonal view of the decorated c-shaped clip design; and,

FIG. 6 is a rear orthogonal view of the decorated c-shaped clip design.

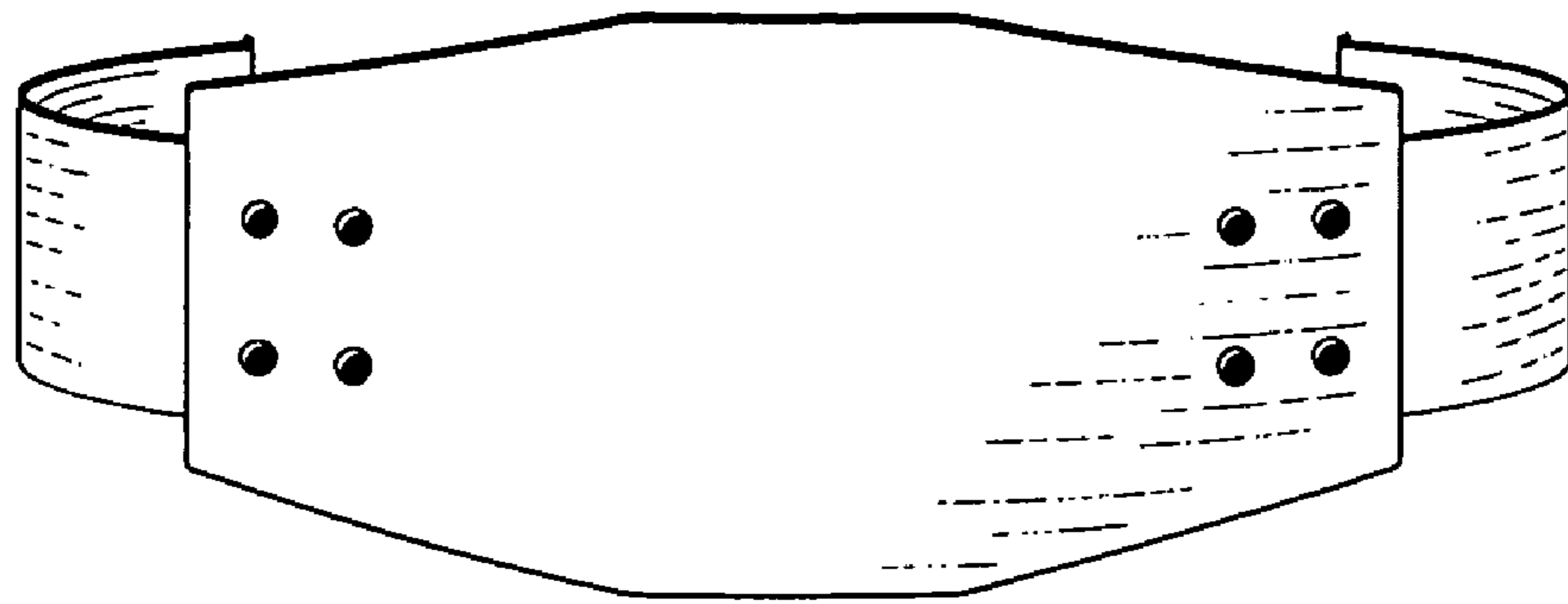

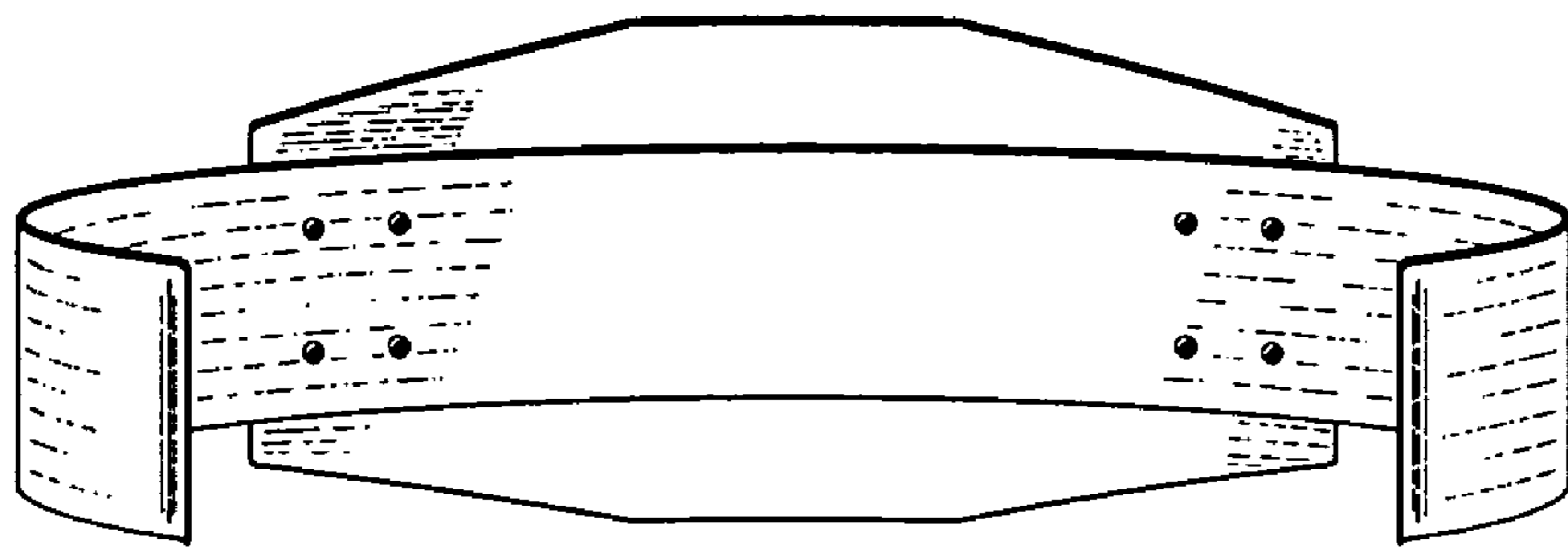

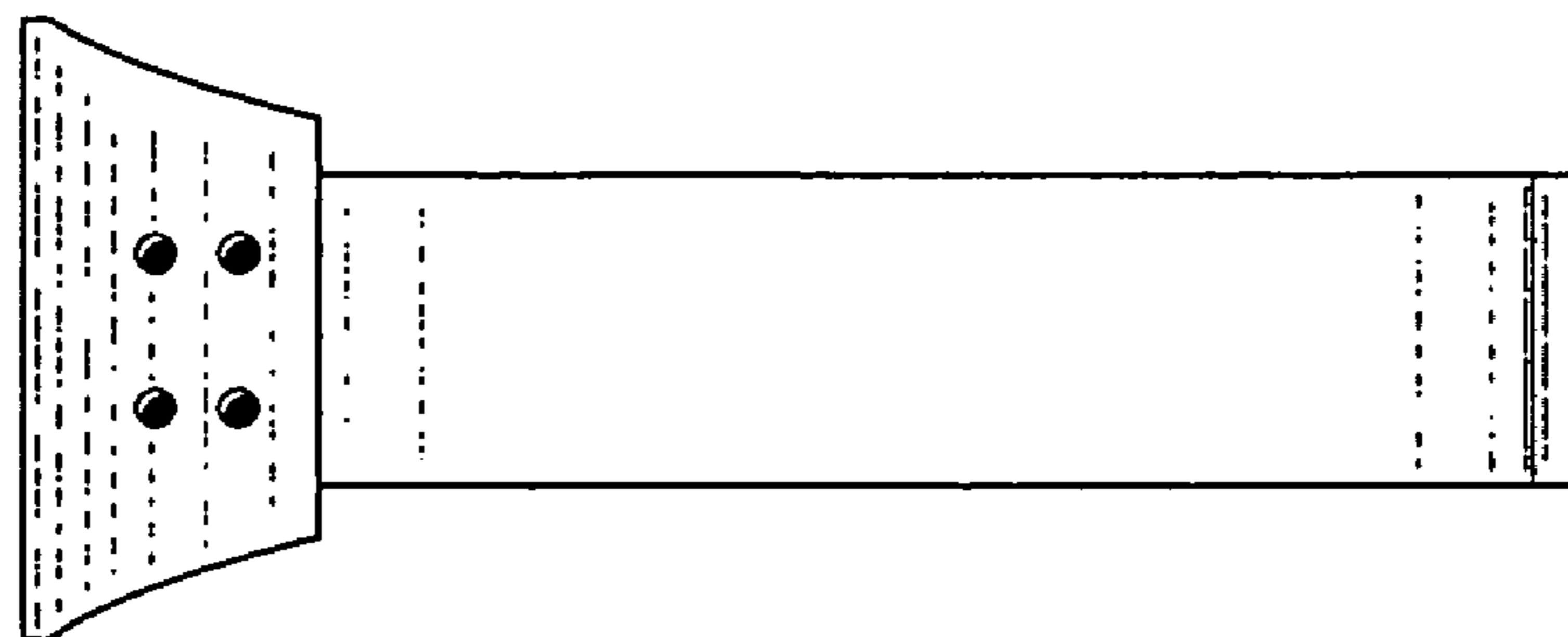

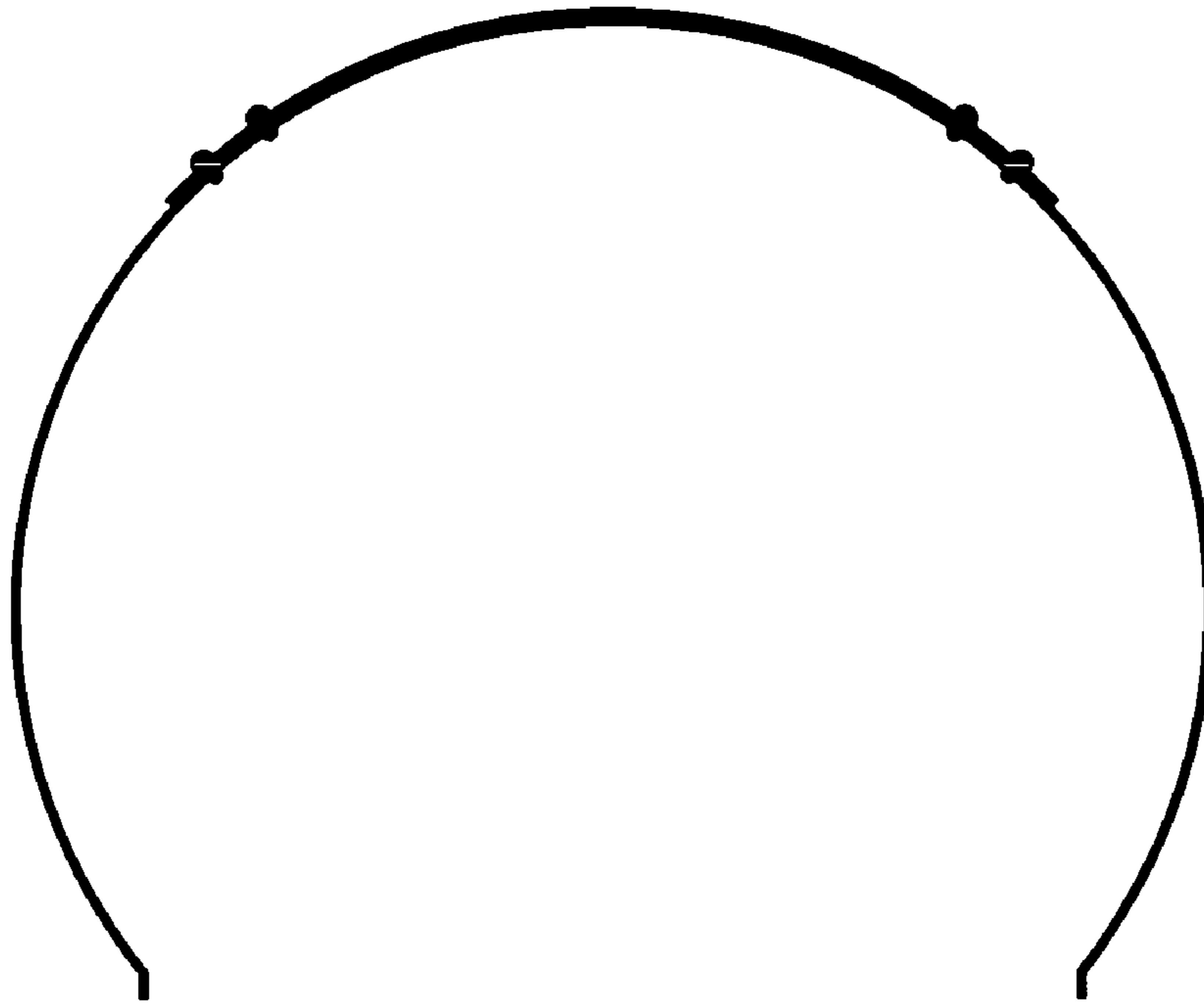

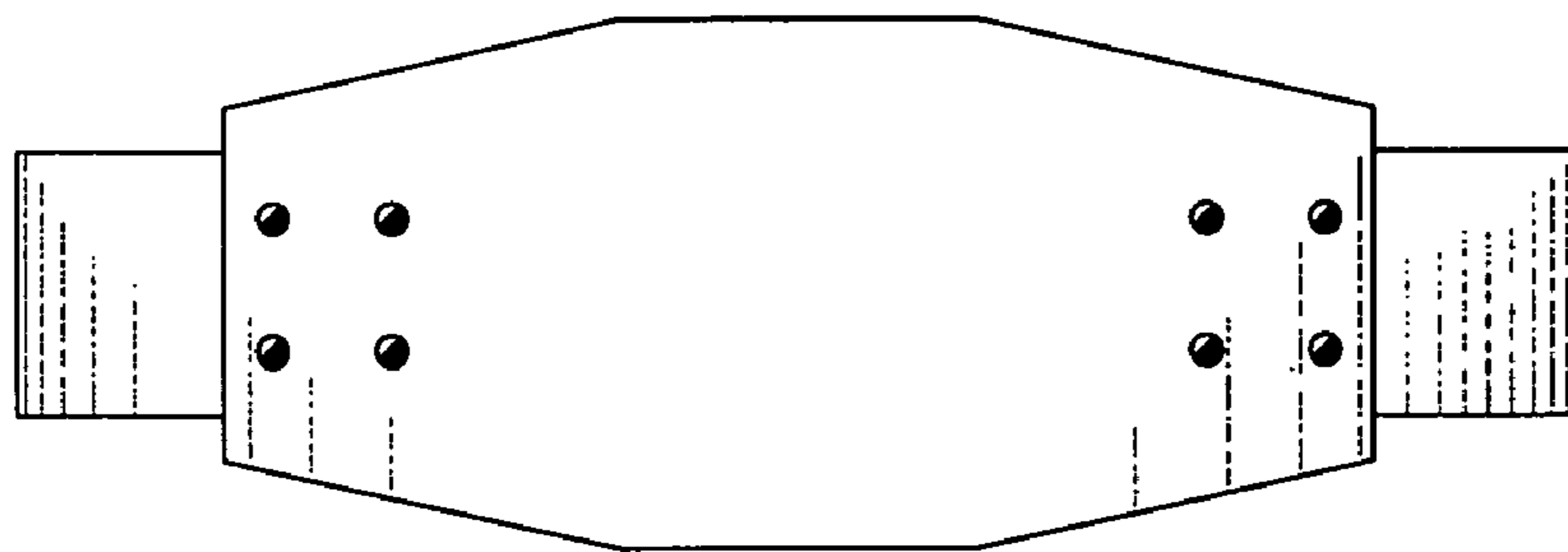

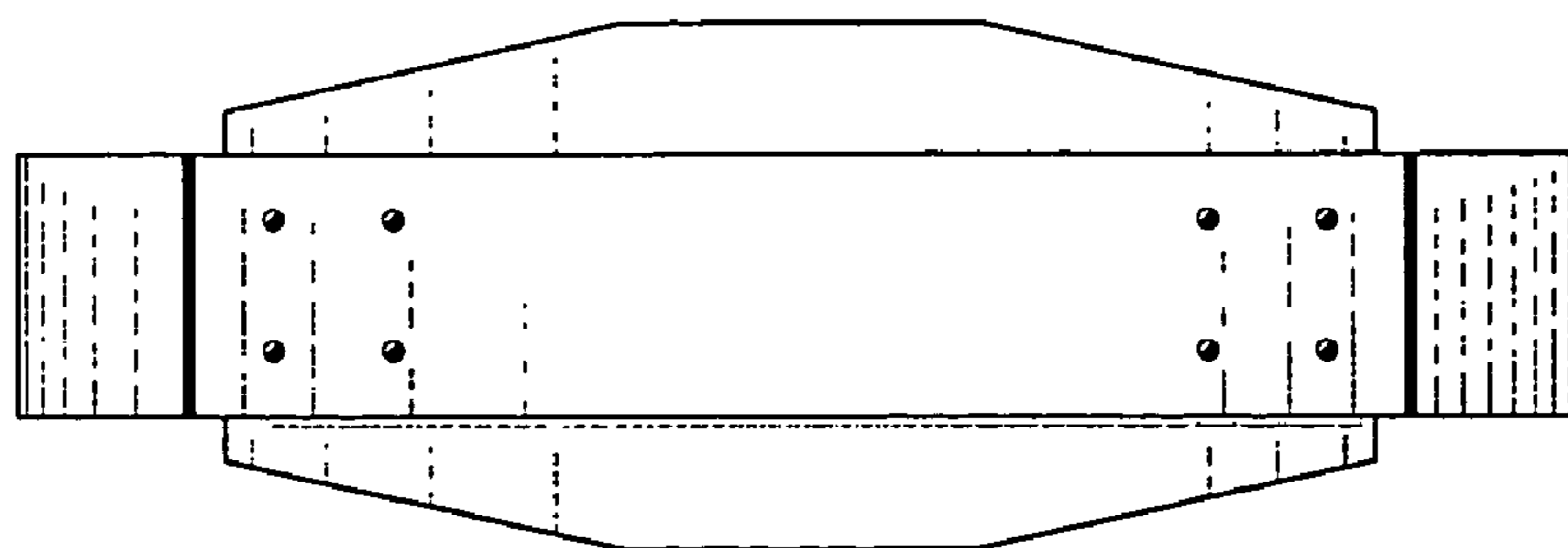
