The ornamental design for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a container showing my new design;

FIG. 2 is a right side elevation view thereof;

FIG. 3 is a left side elevation view thereof;

FIG. 4 is a front elevation view thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 is an exploded top, perspective view of the container of FIG. 1 shown in the open position;

FIG. 9 is a rear elevation view thereof, shown with the closure portion removed;

FIG. 10 is a front elevation view thereof;

FIG. 11 is a right side elevation view thereof;

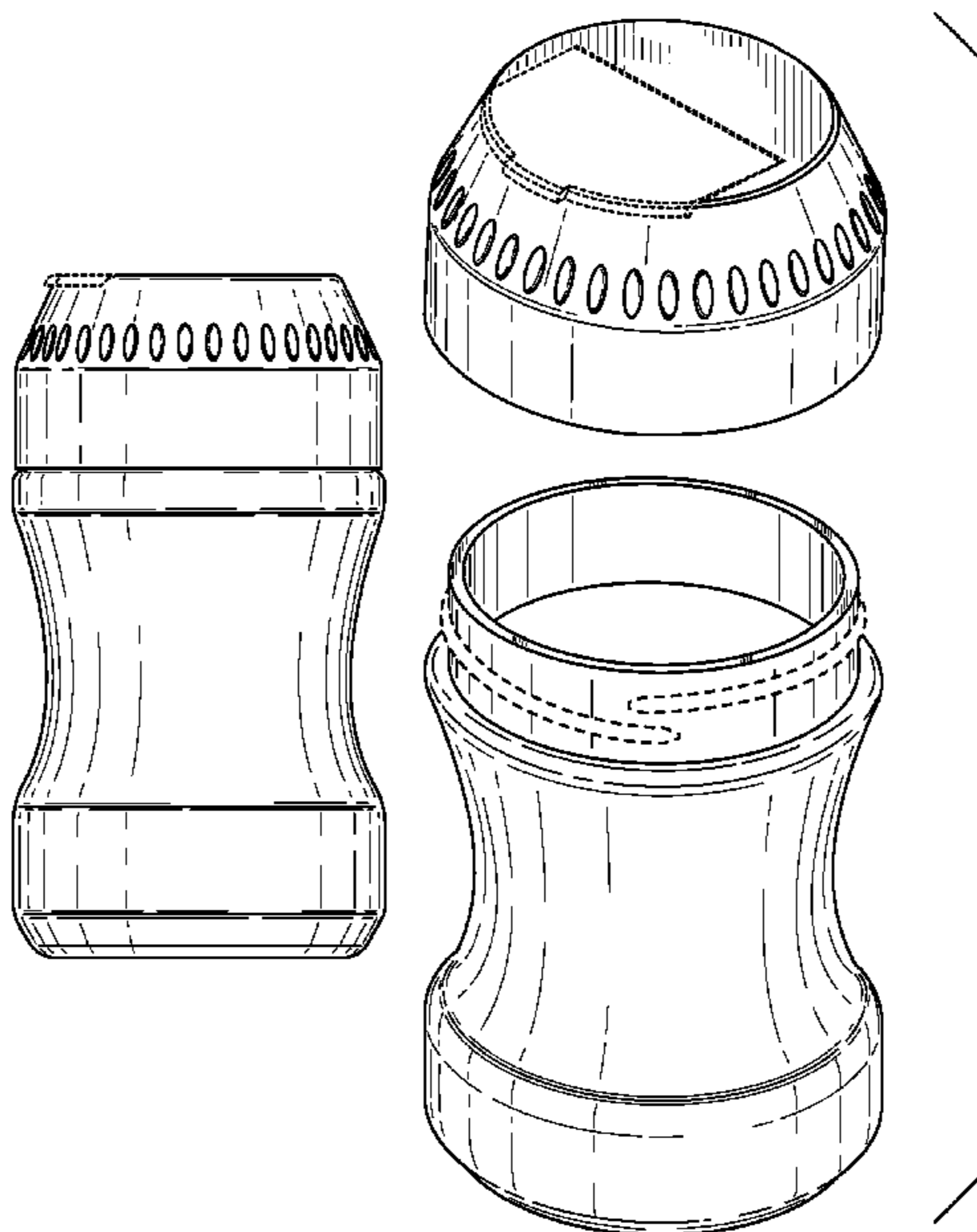
FIG. 12 is a left side elevation view thereof;

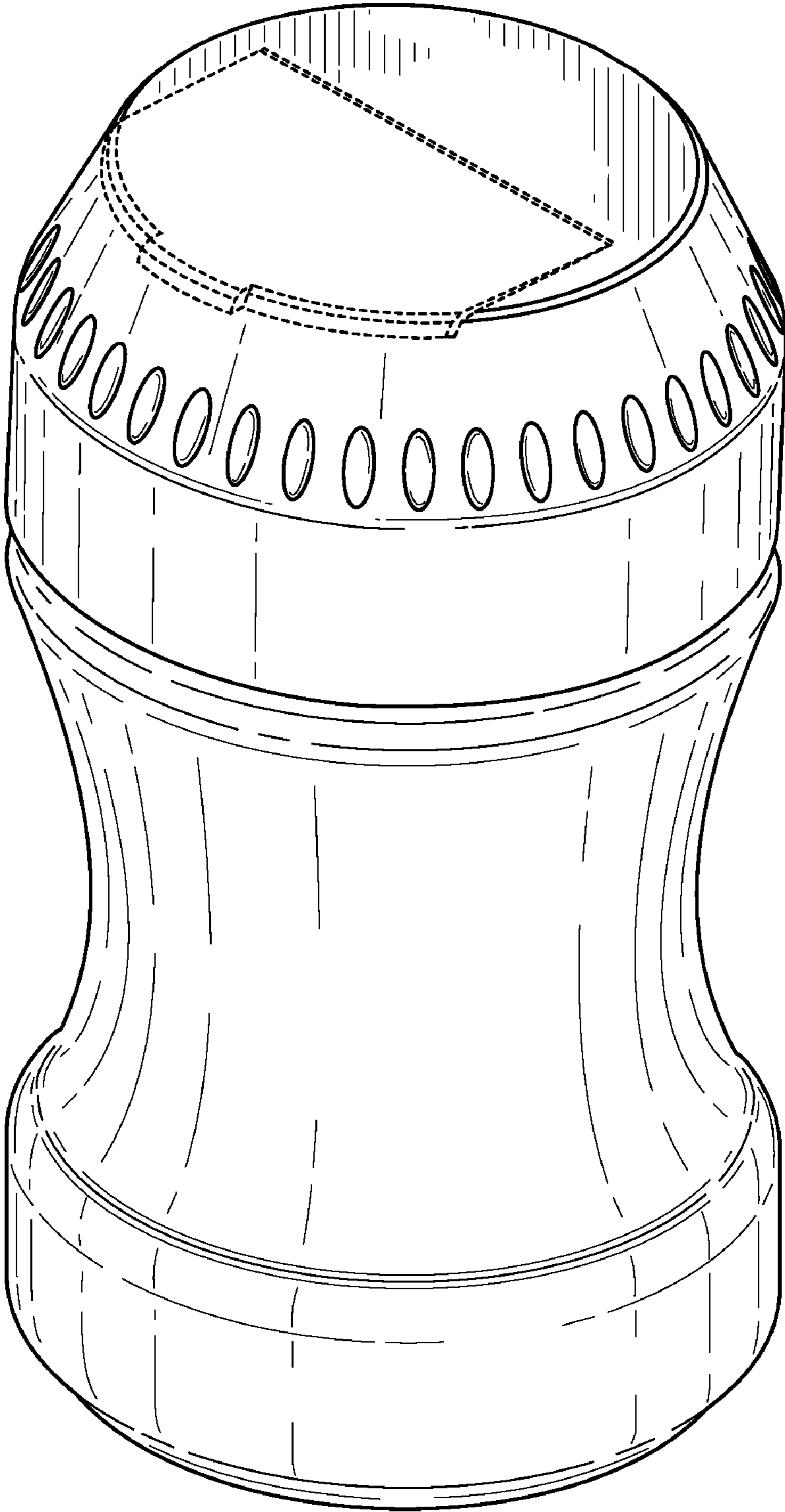

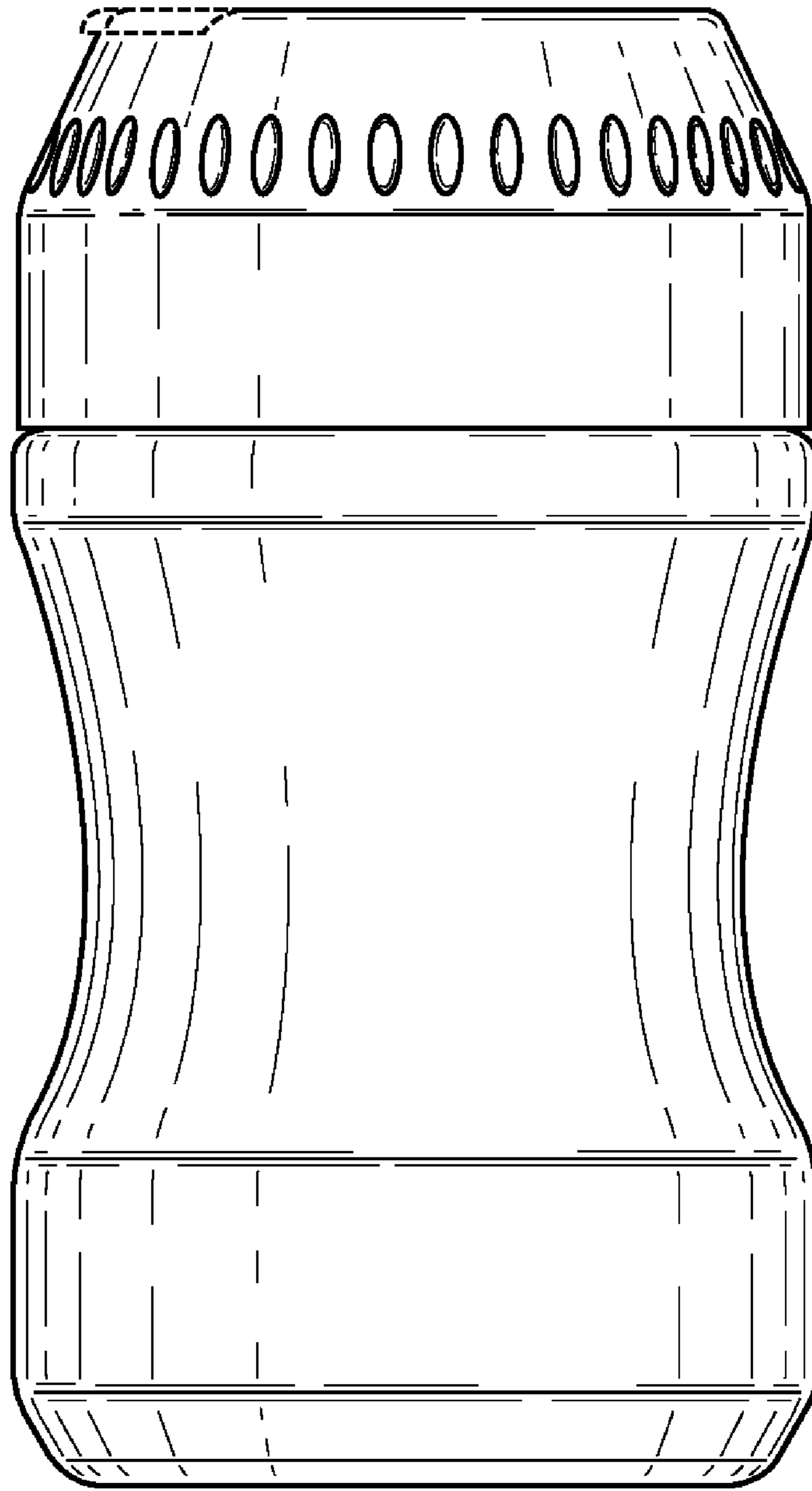

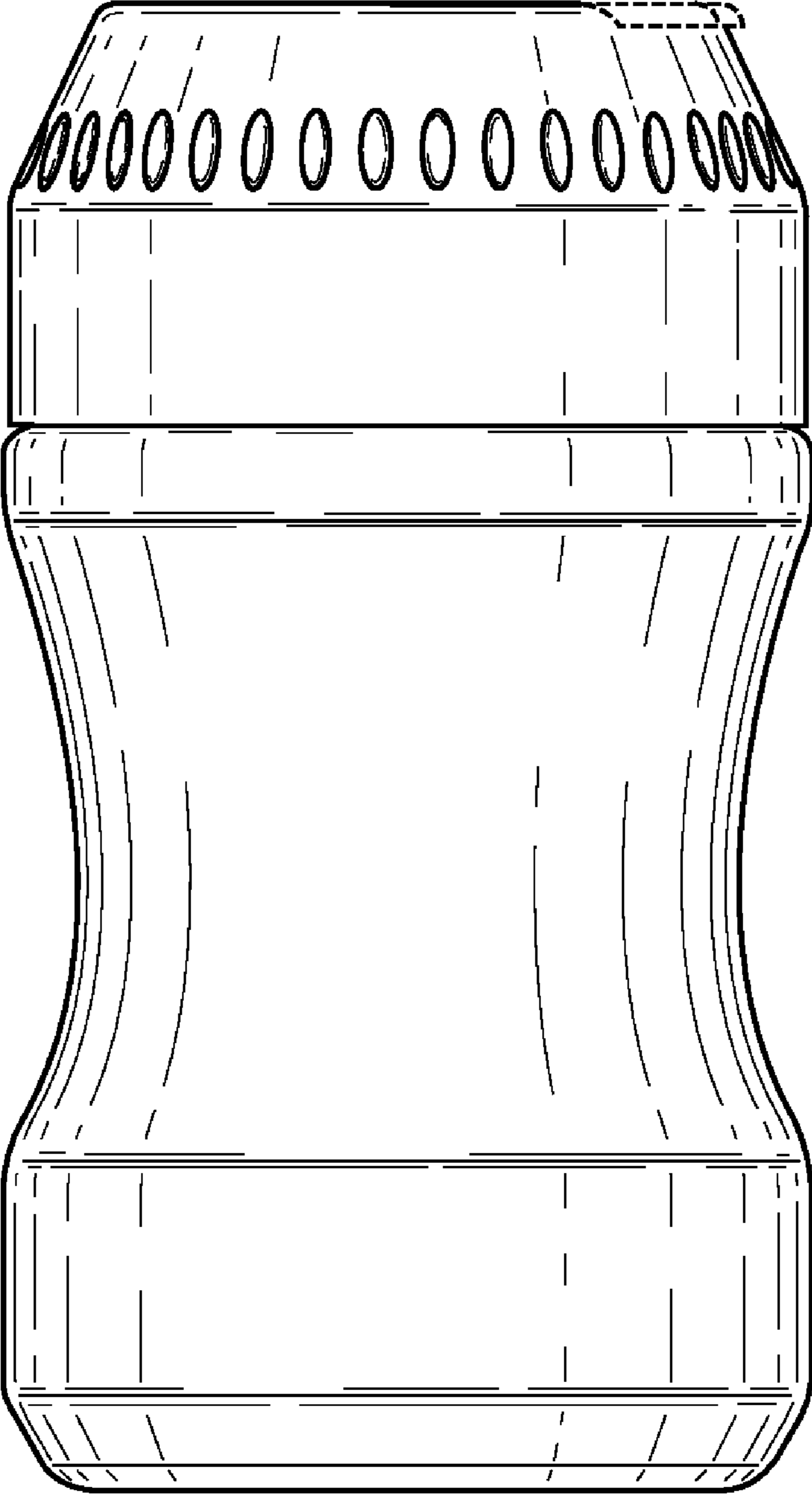

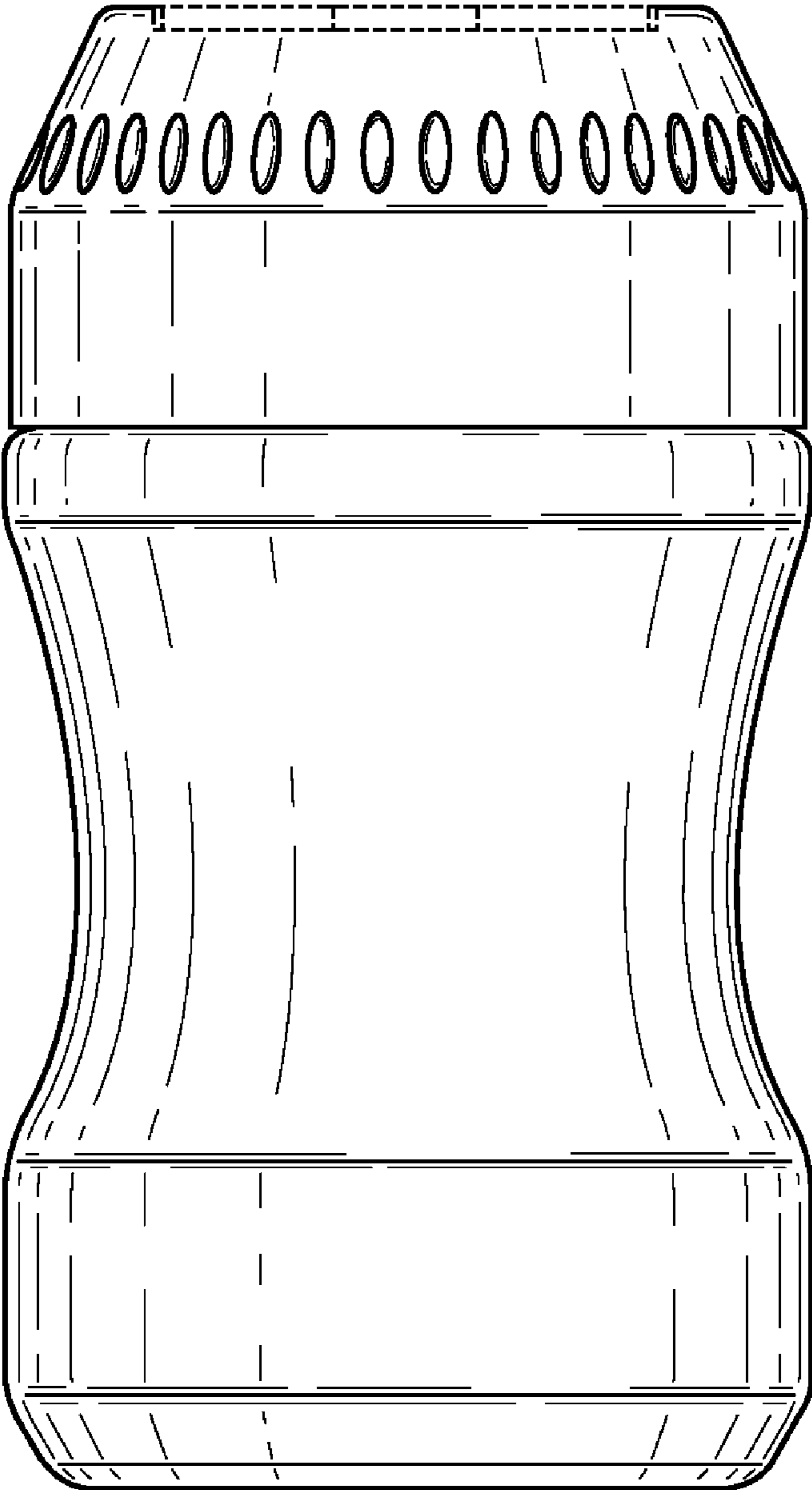

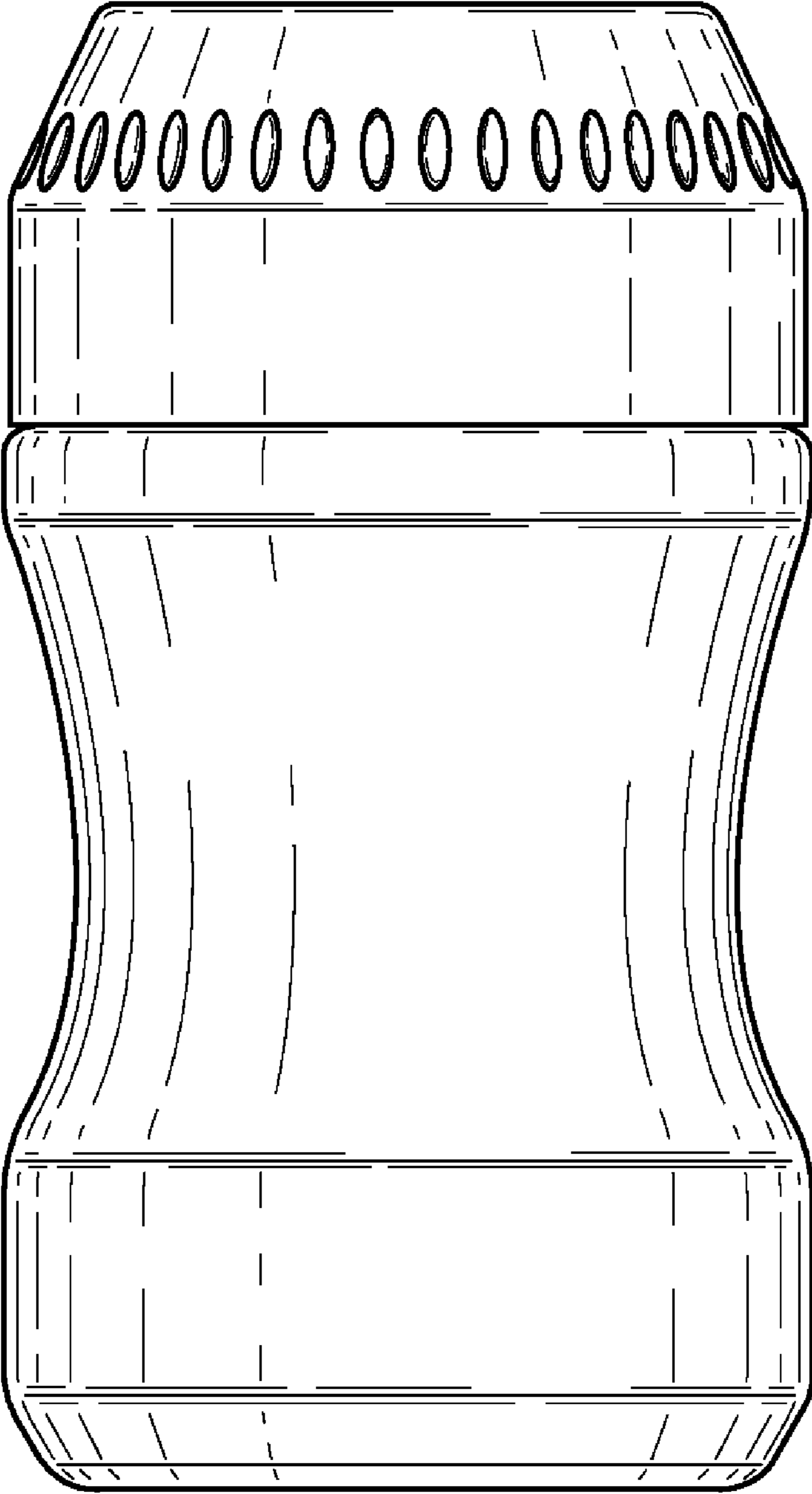

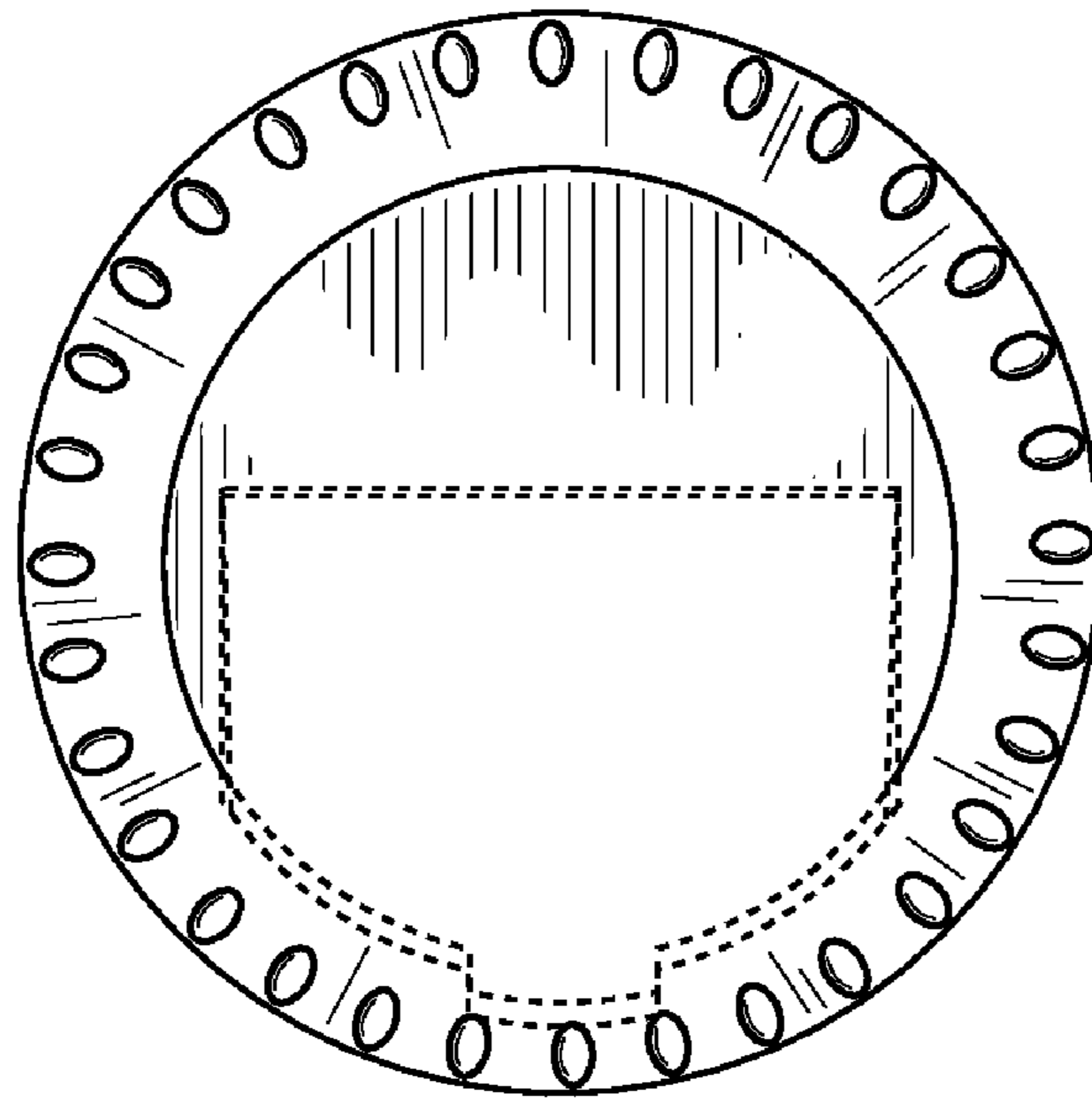

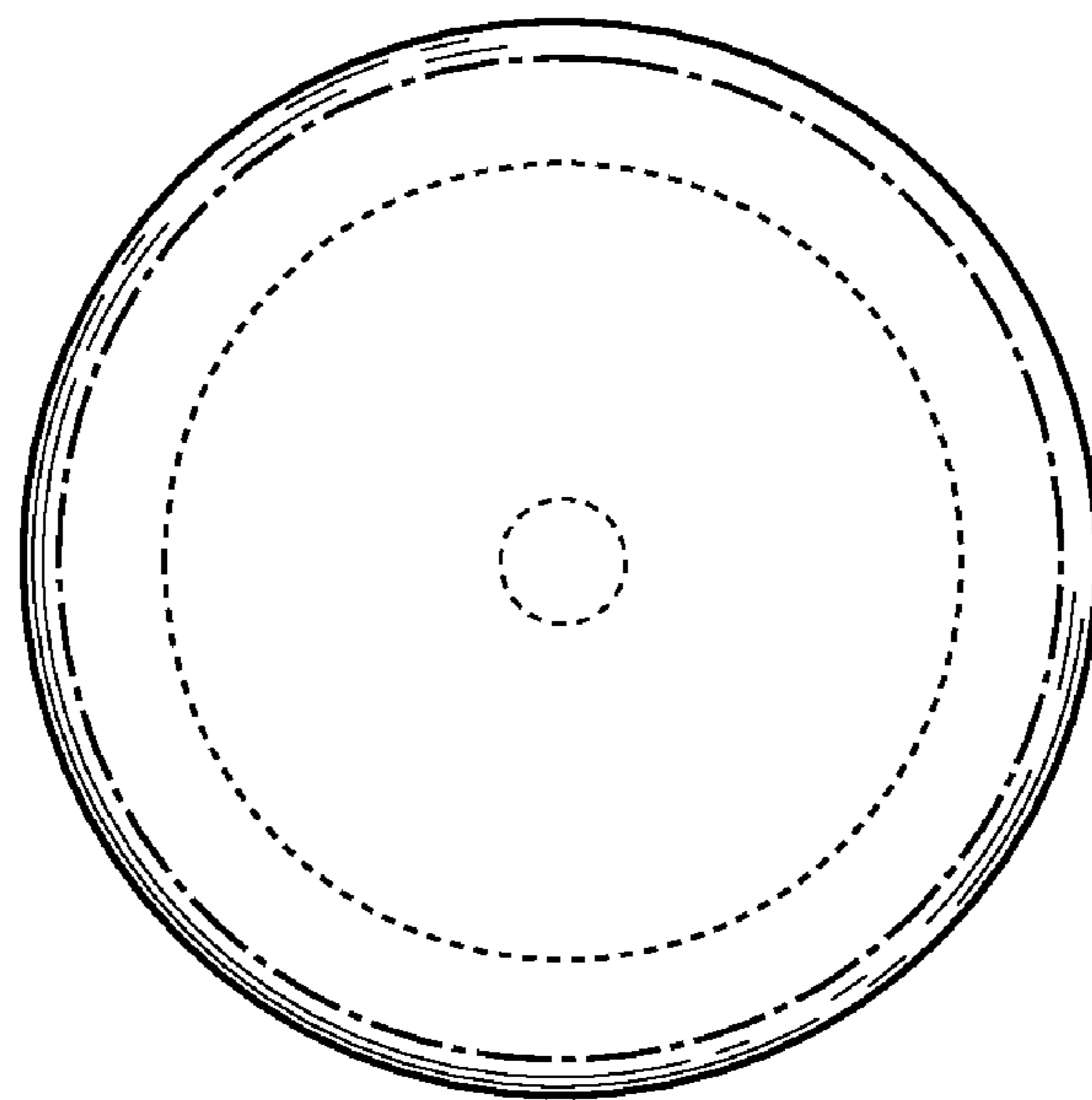

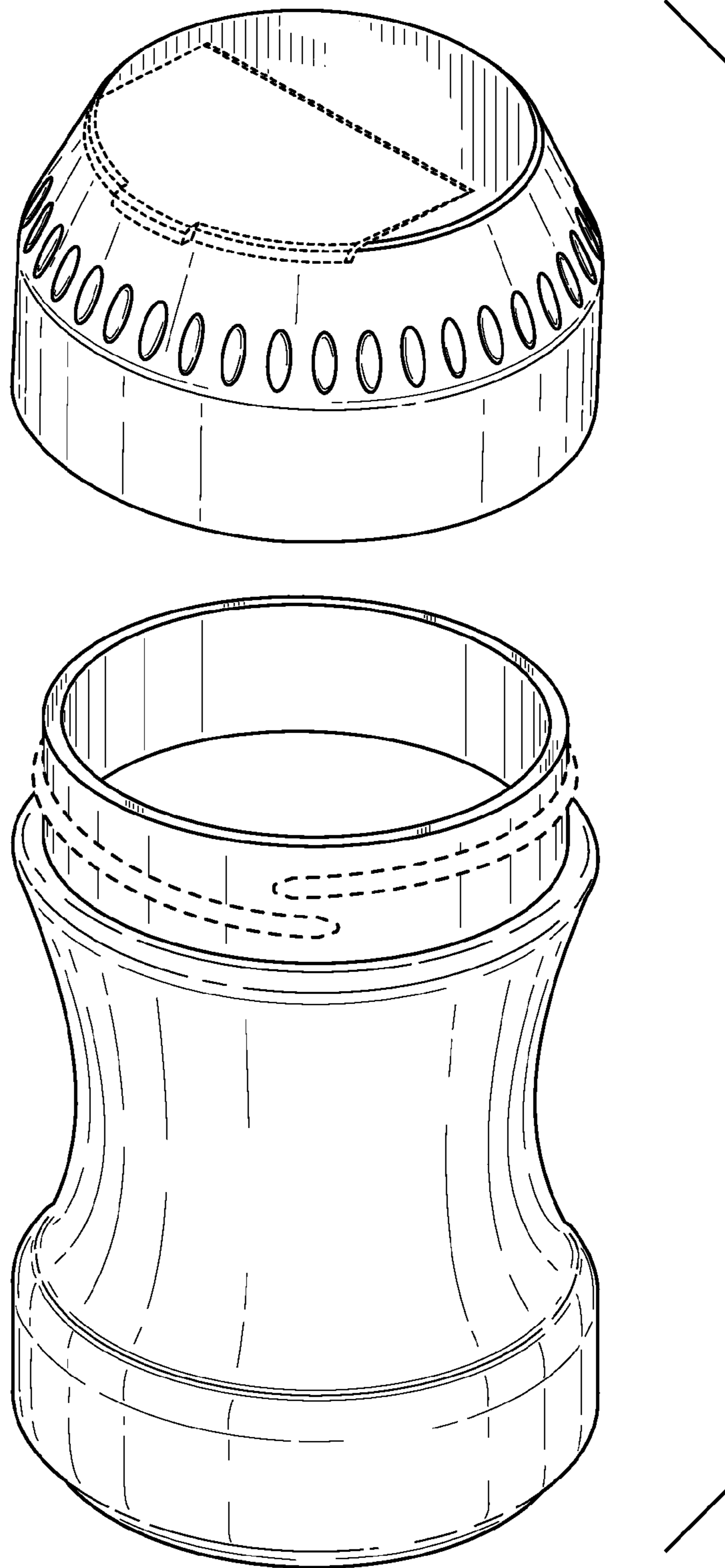

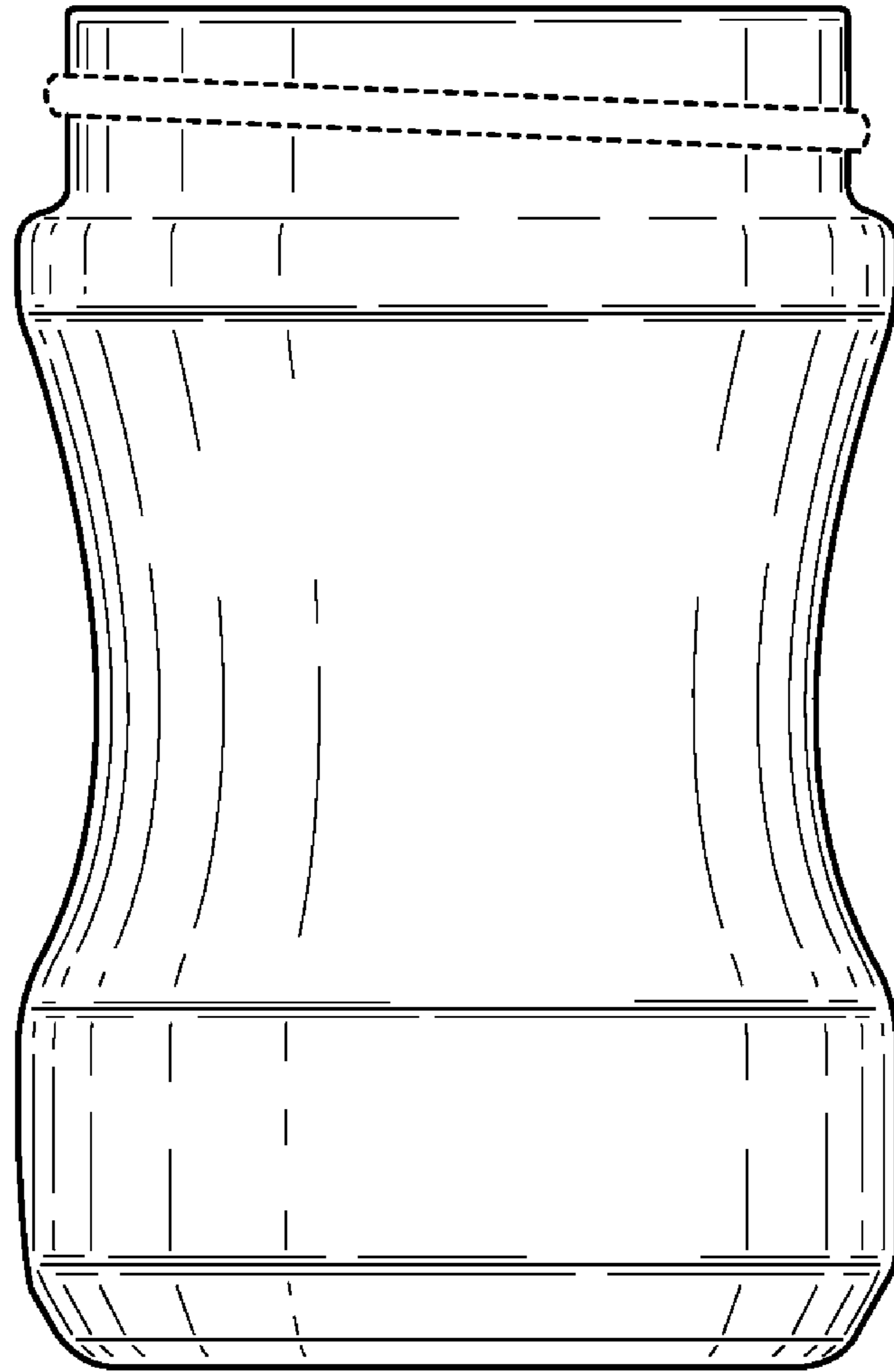

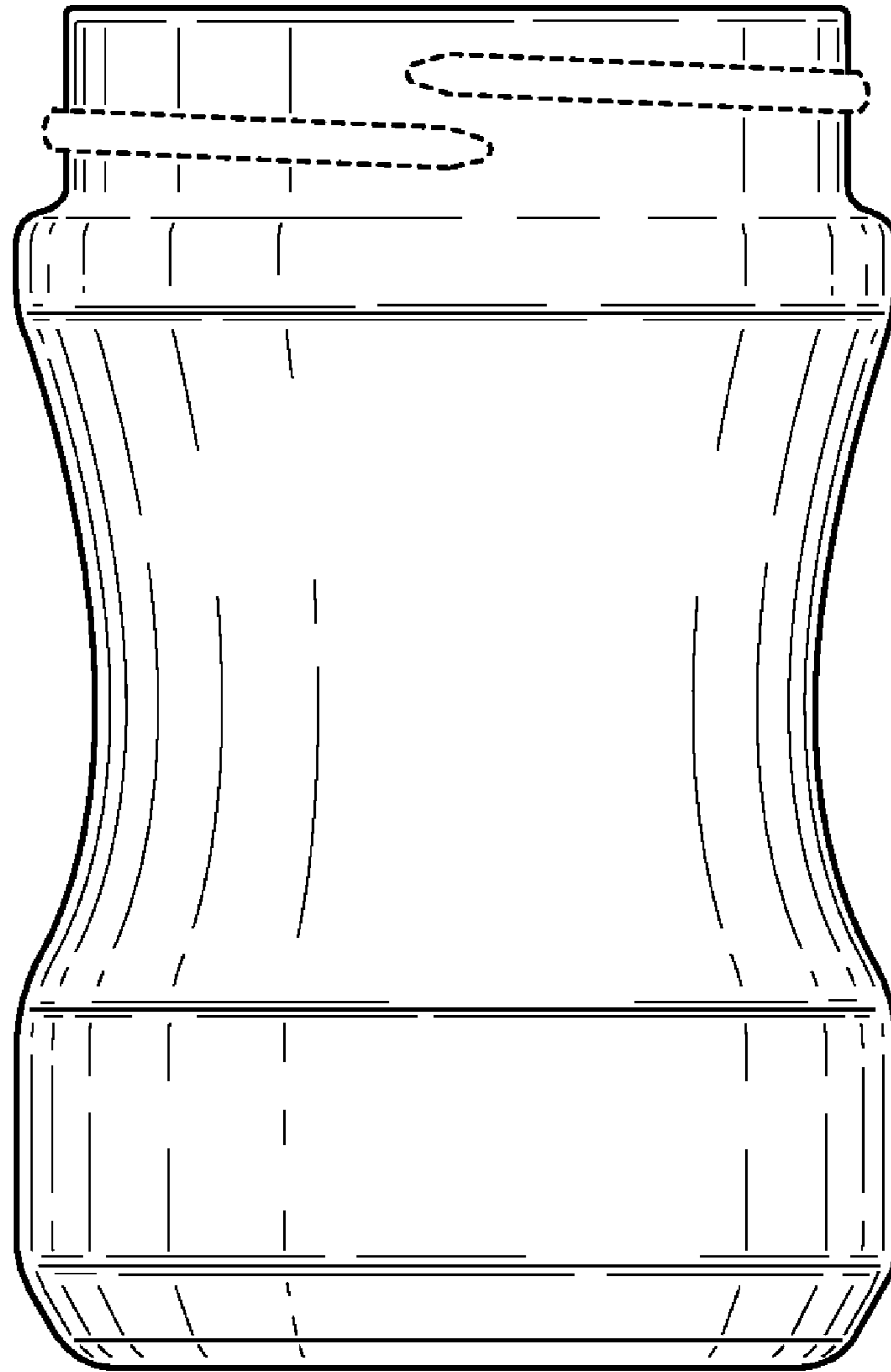

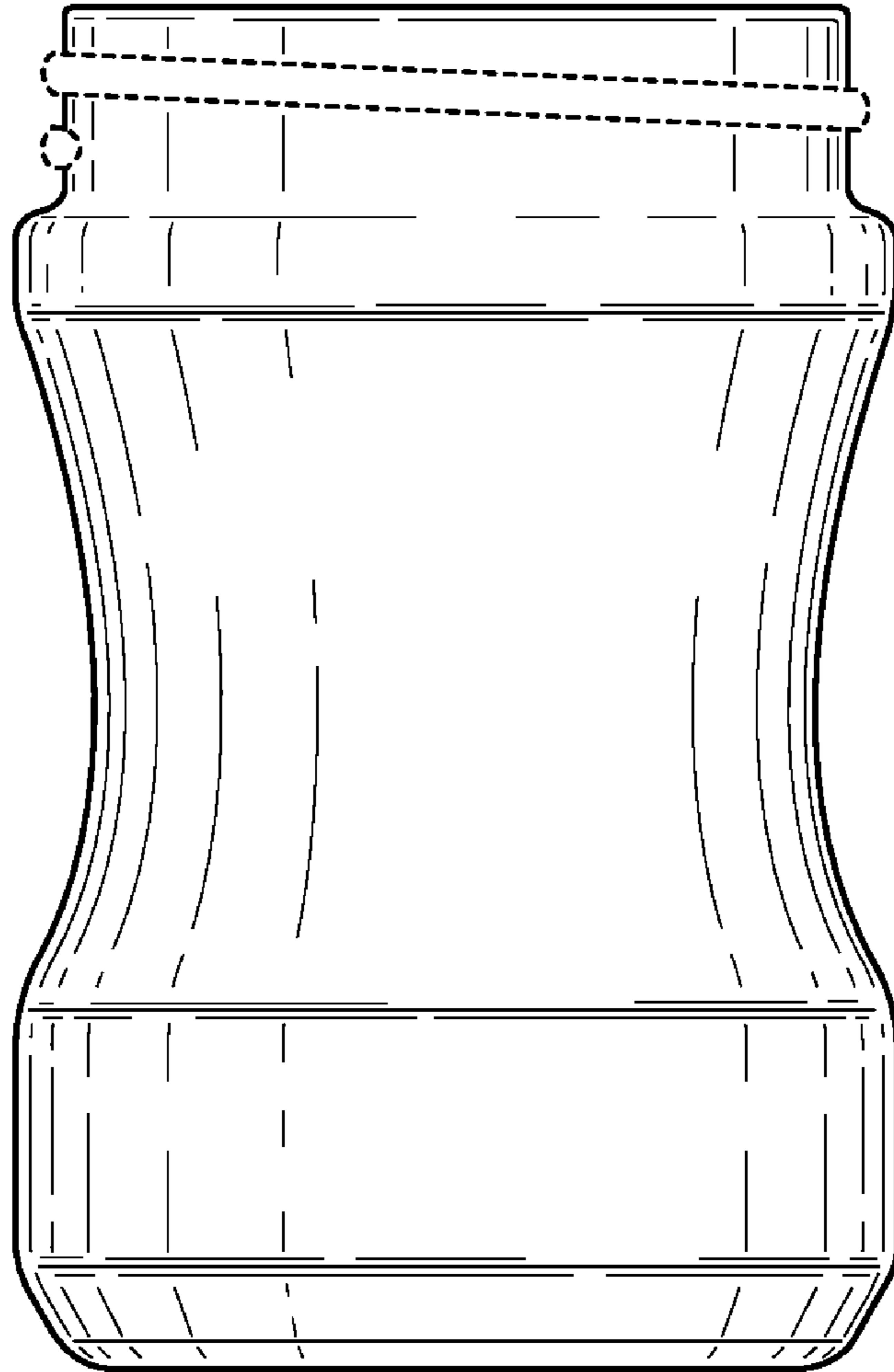

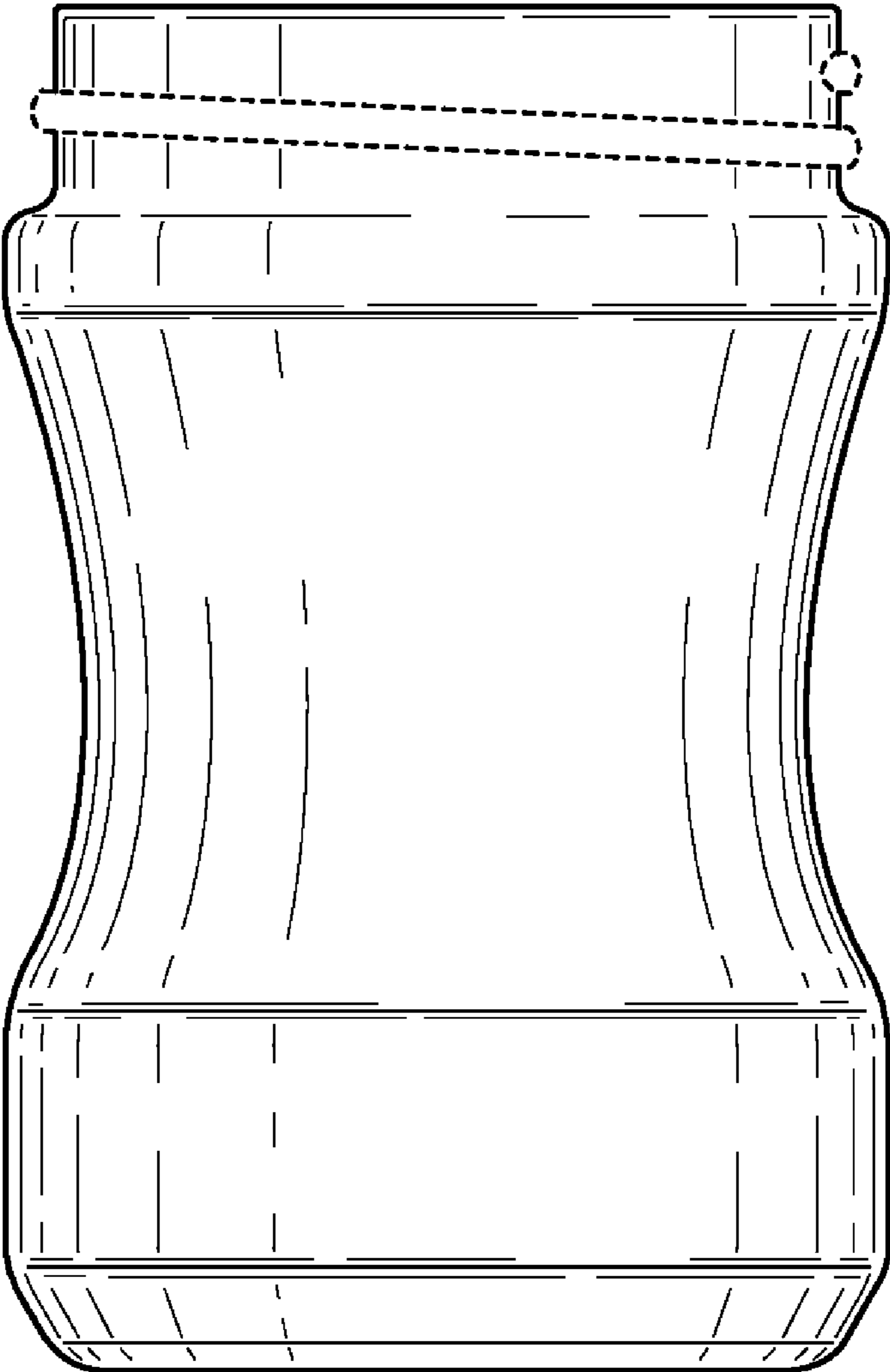

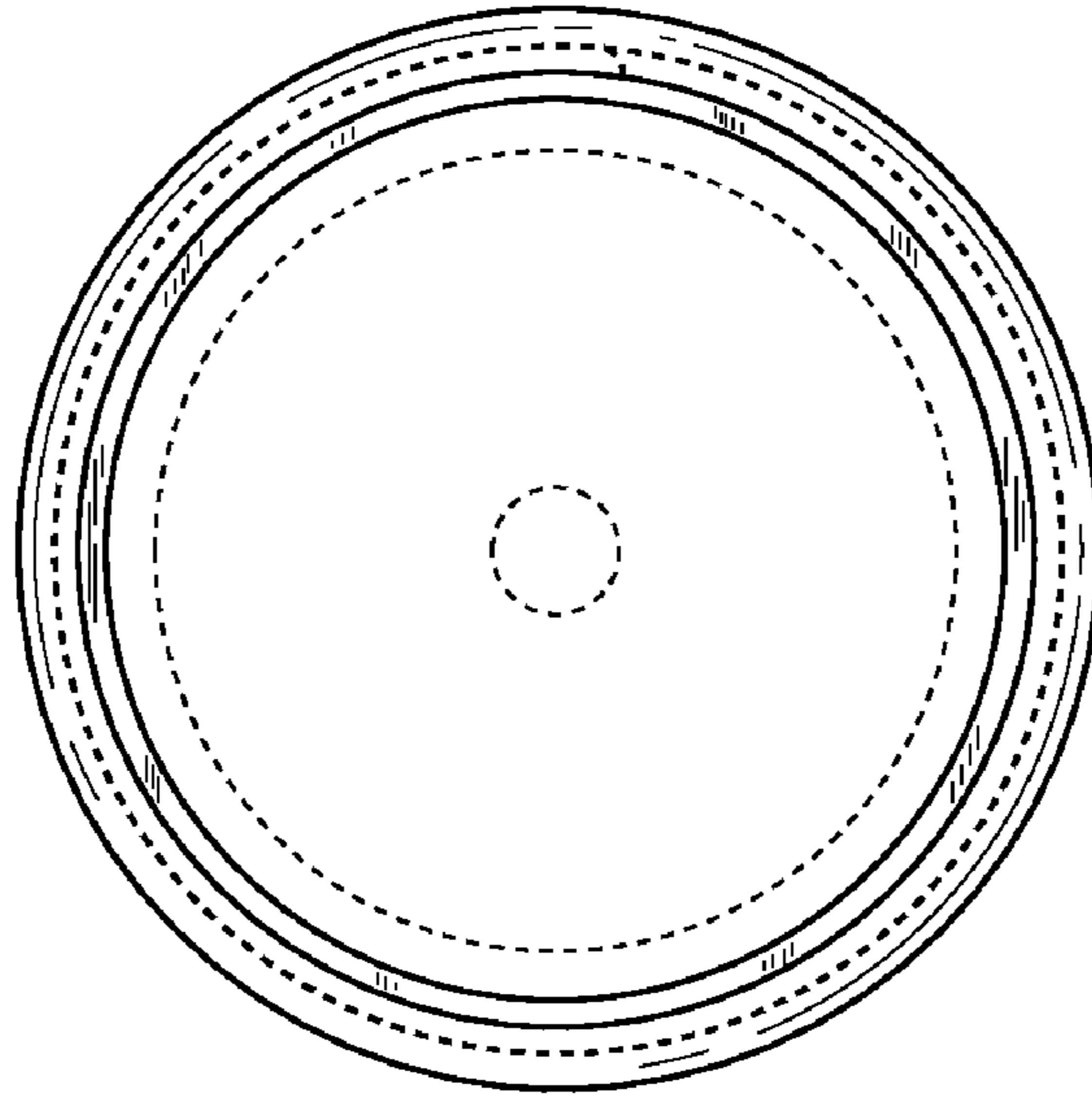

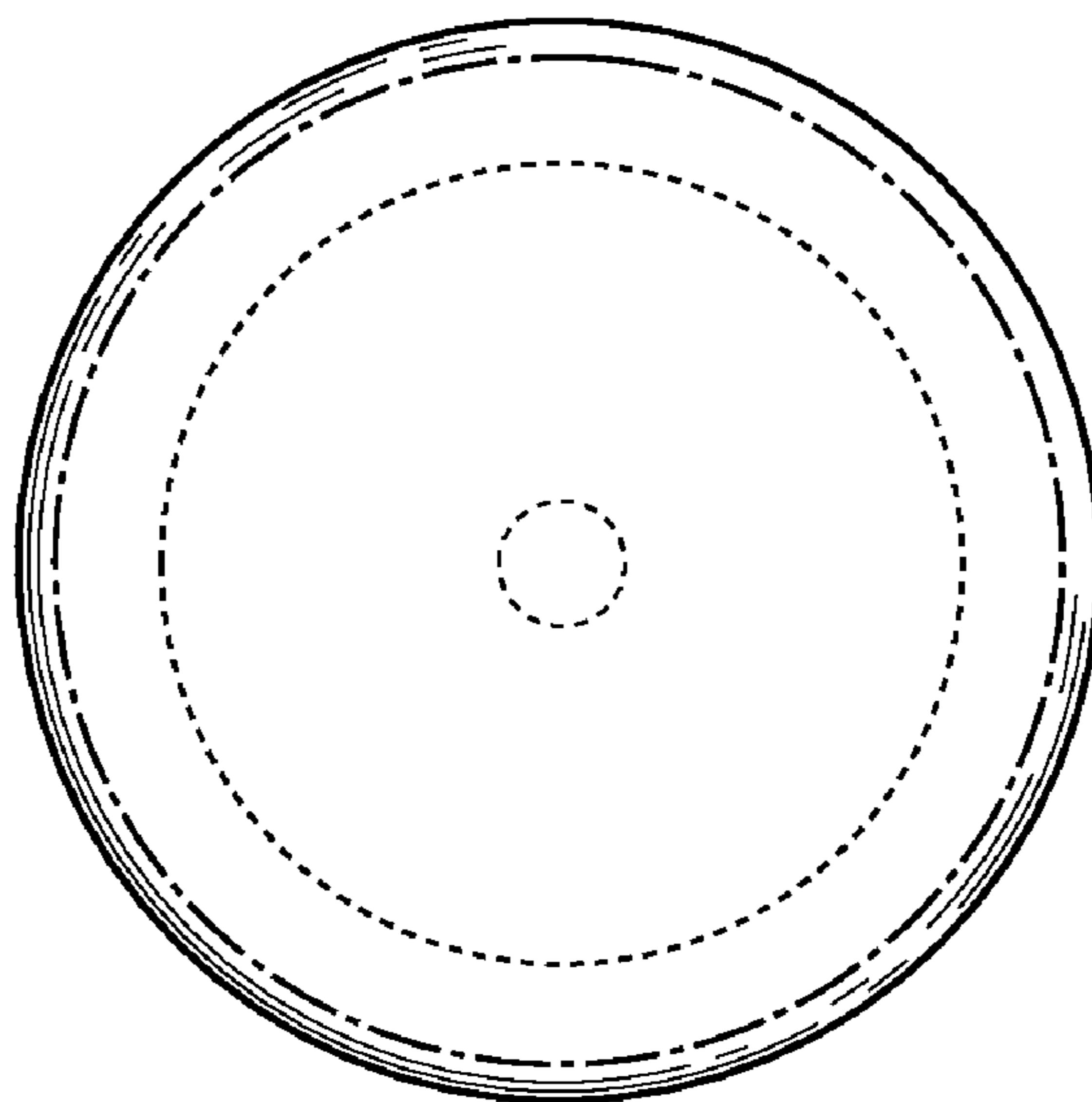
