The ornamental design for a part of a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a part of a container of the claimed design;

FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

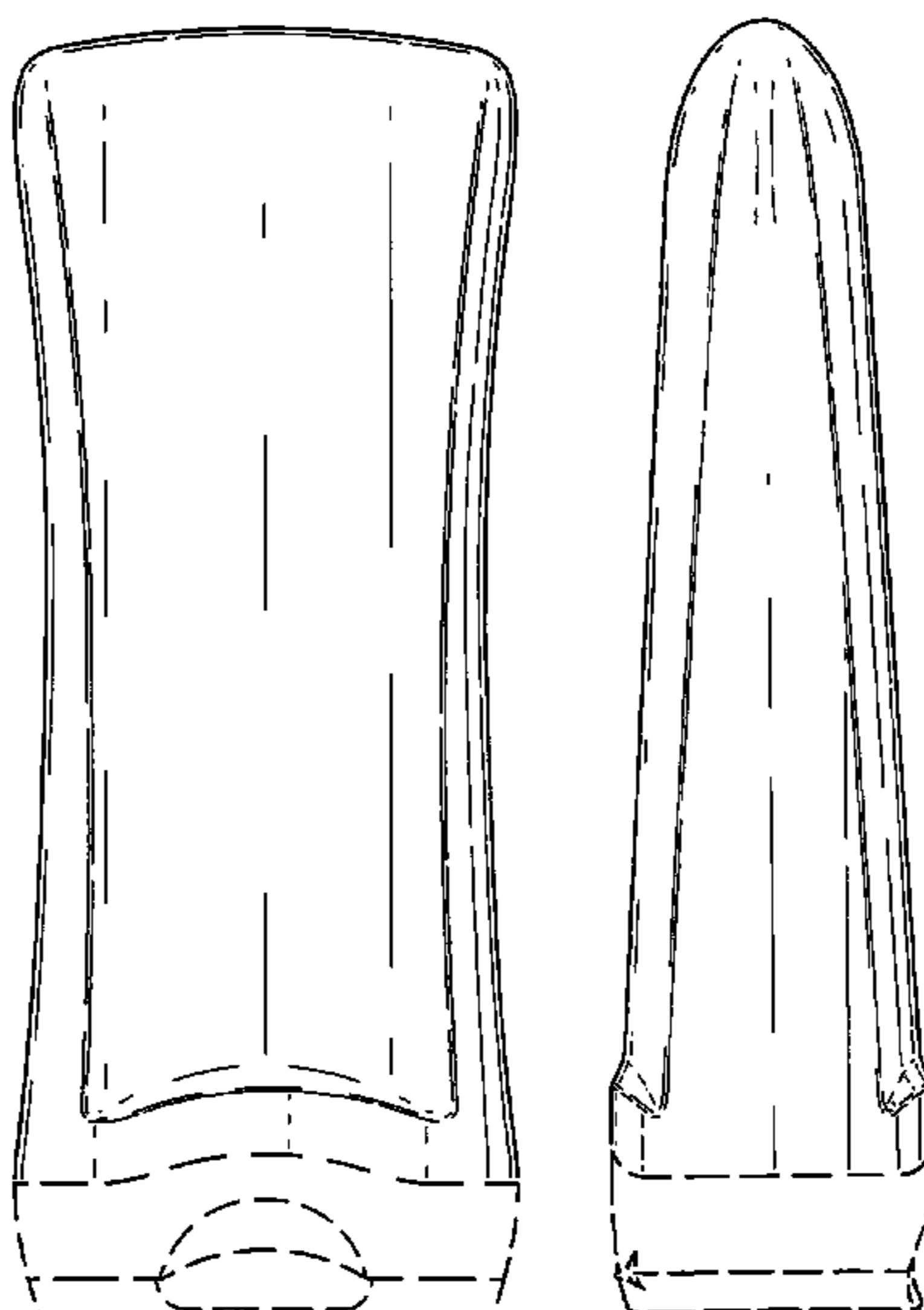
FIG. 5 is a right side elevational view thereof;

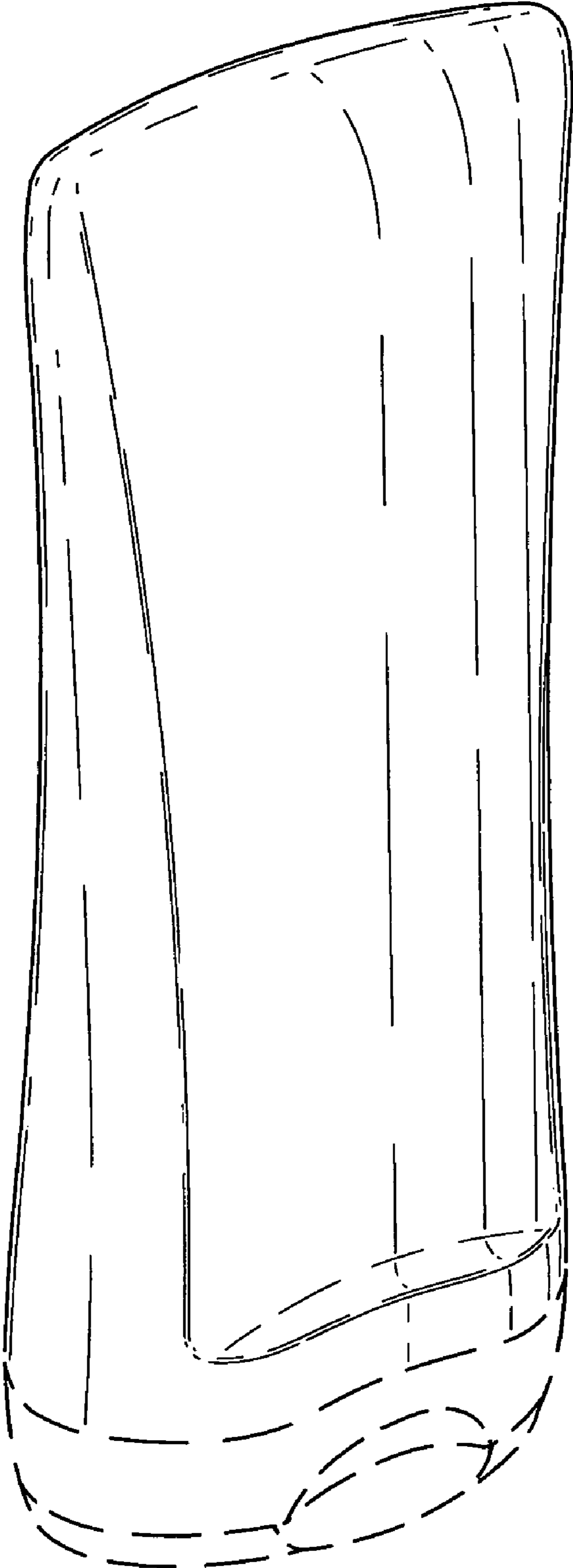

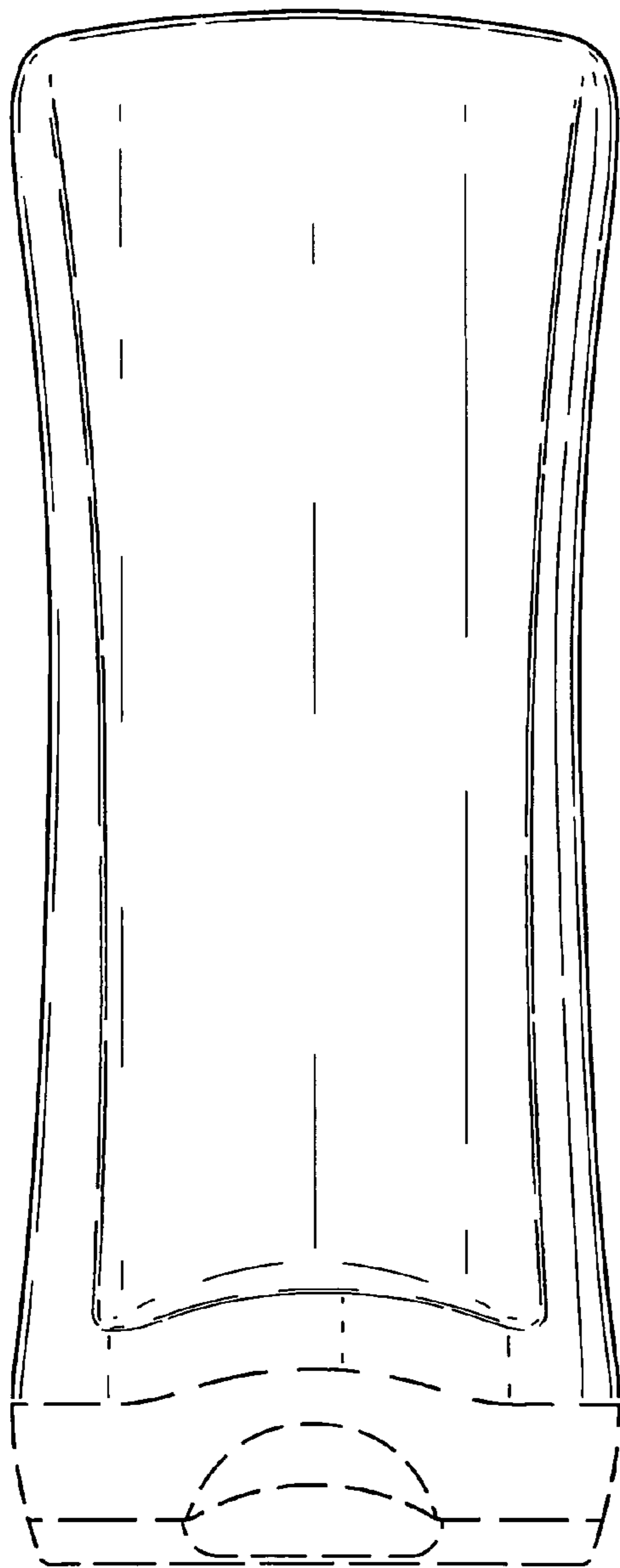

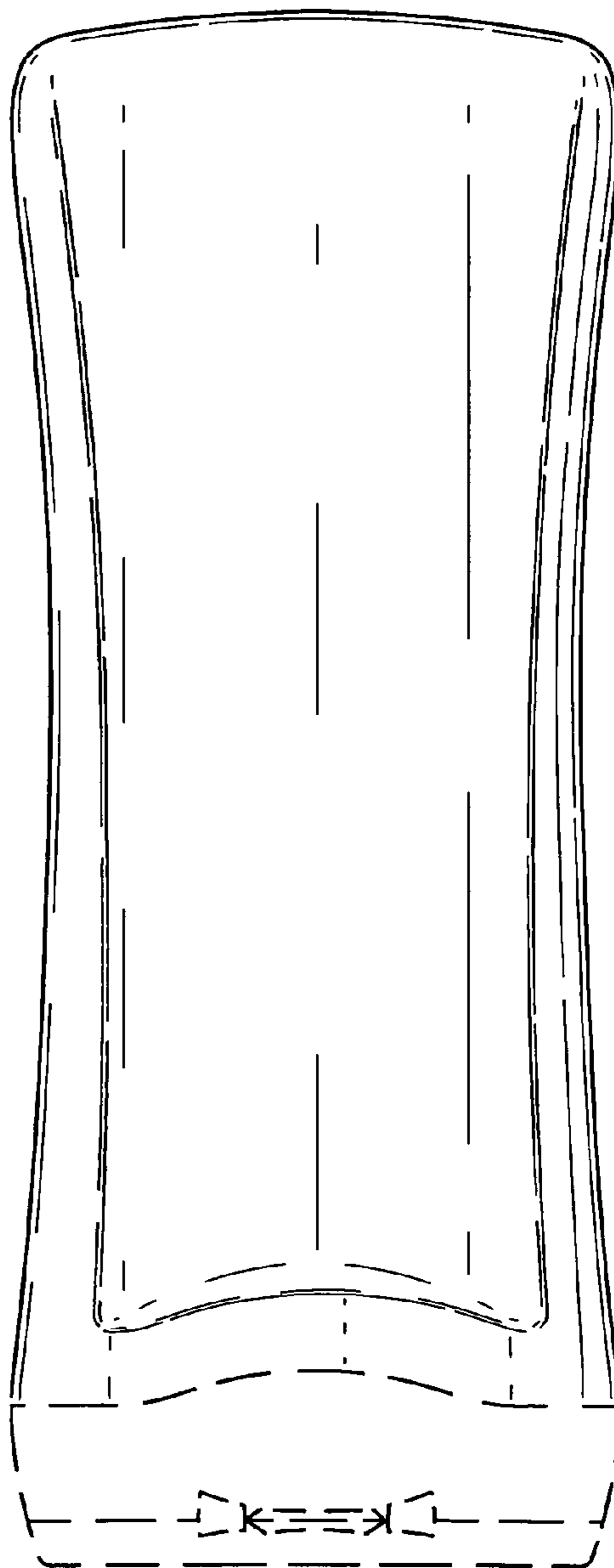

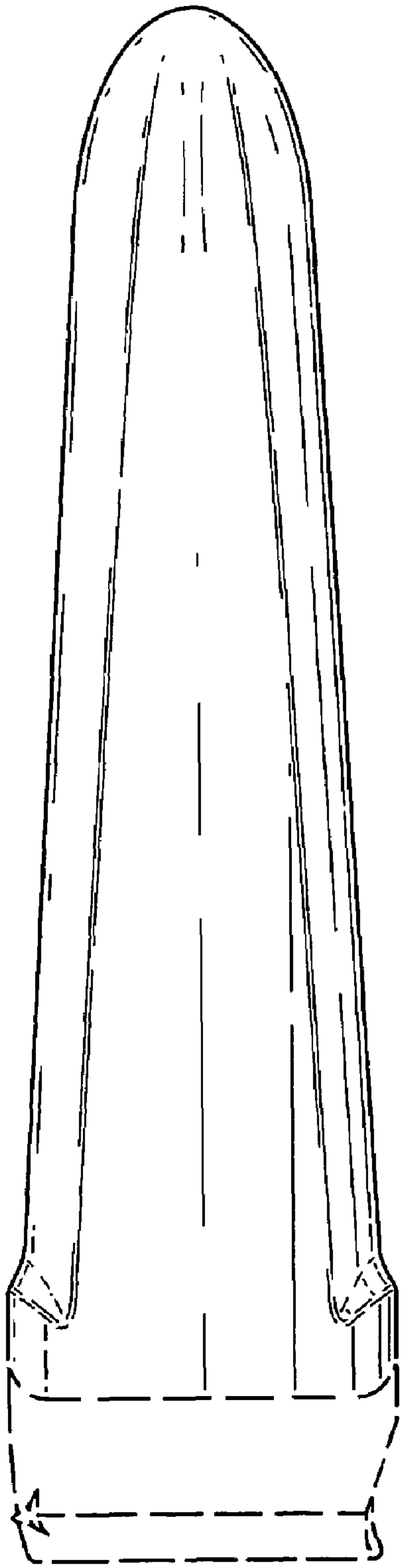

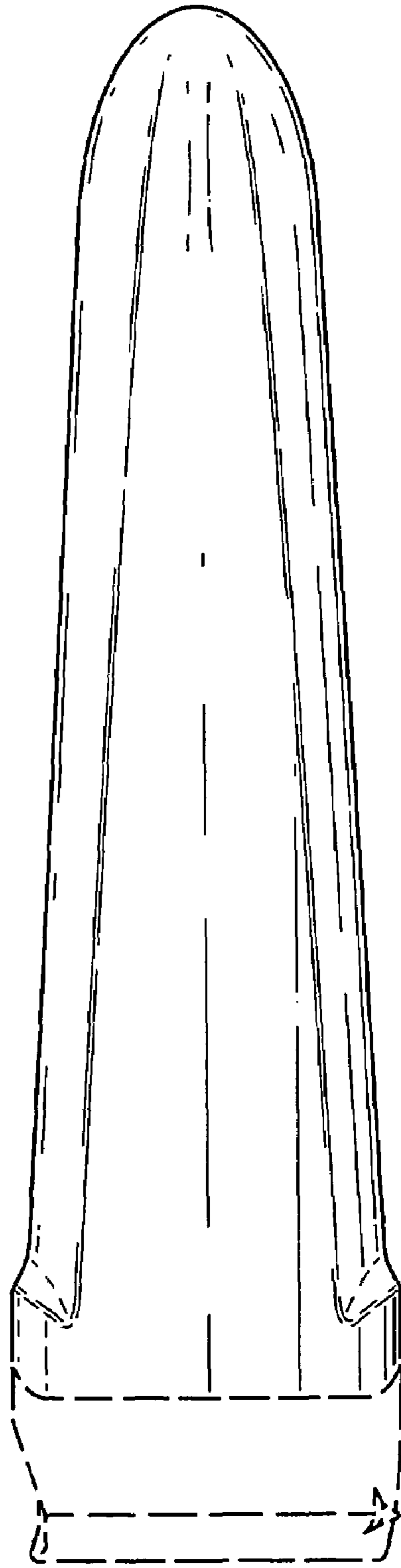

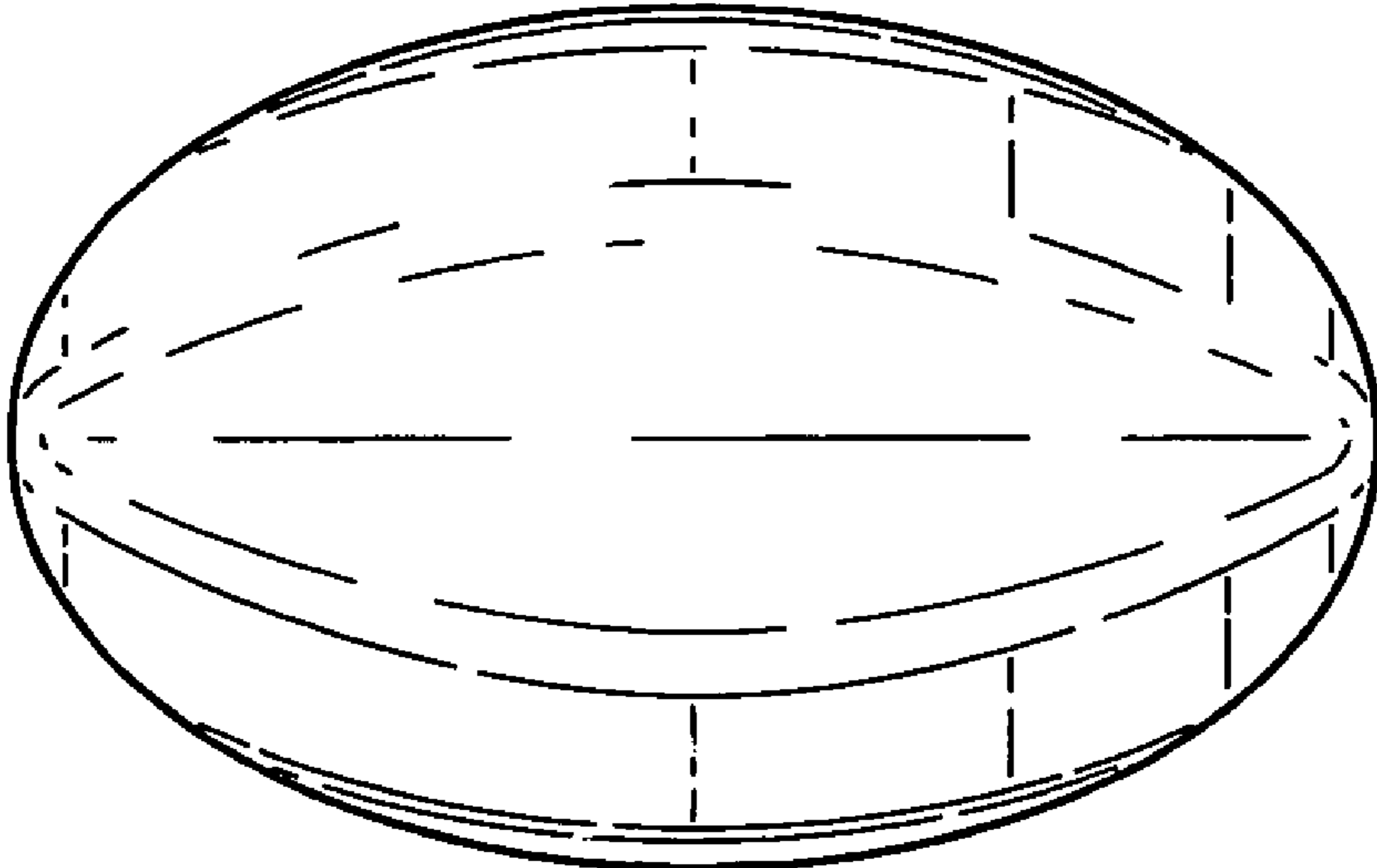

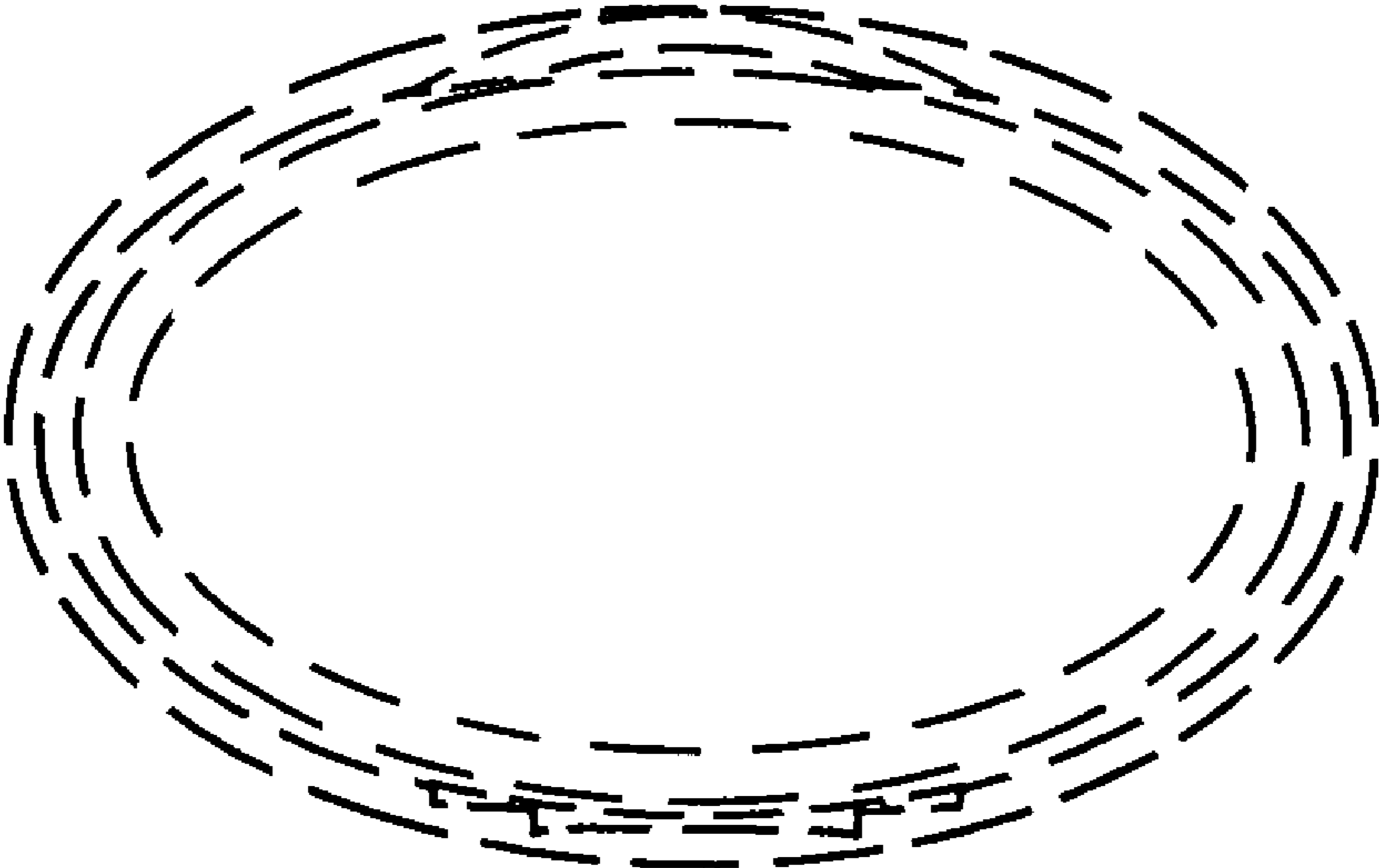
