**DESCRIPTION**

FIG. 1 is Perspective view of a pouch showing my new design;

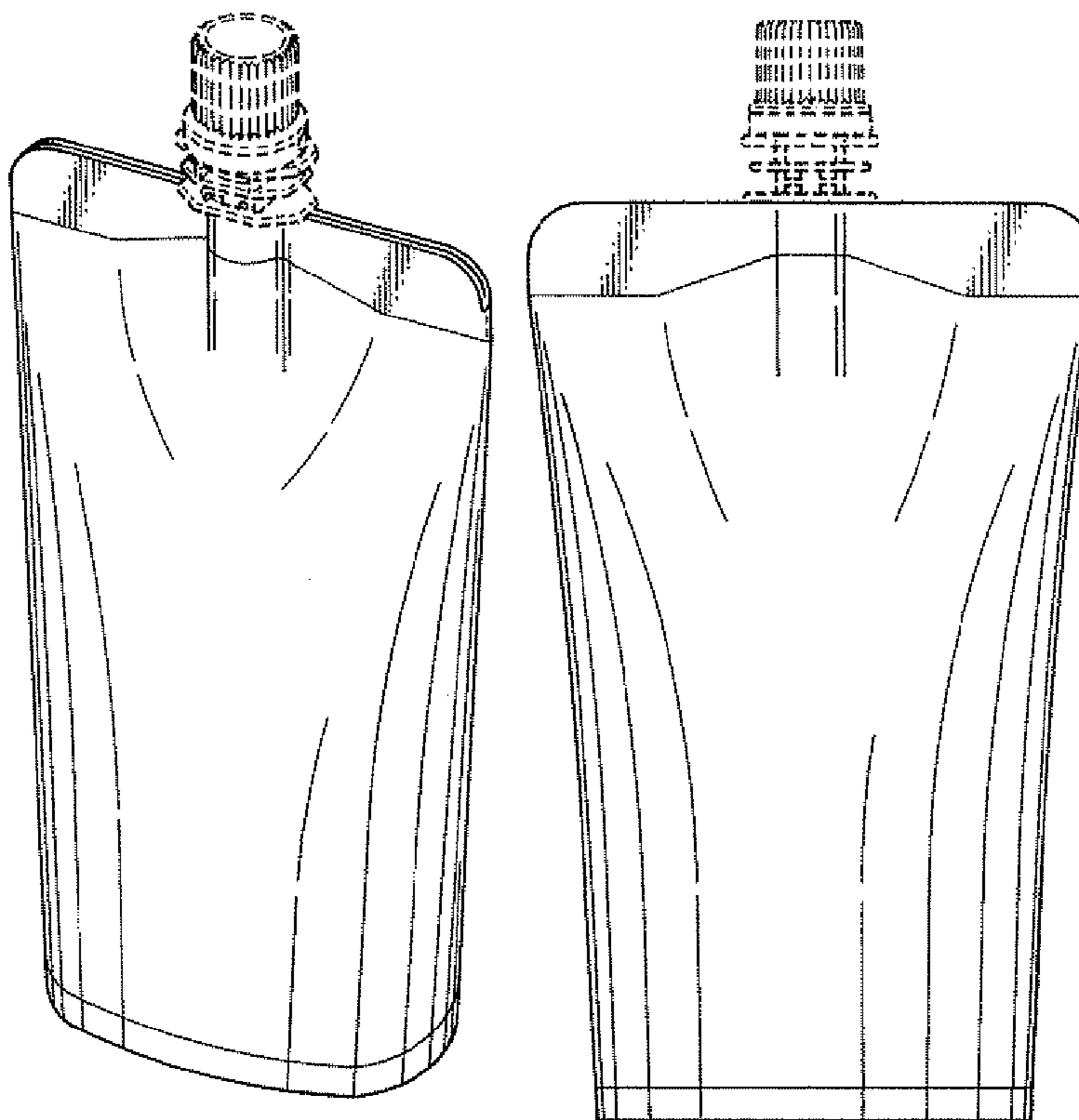

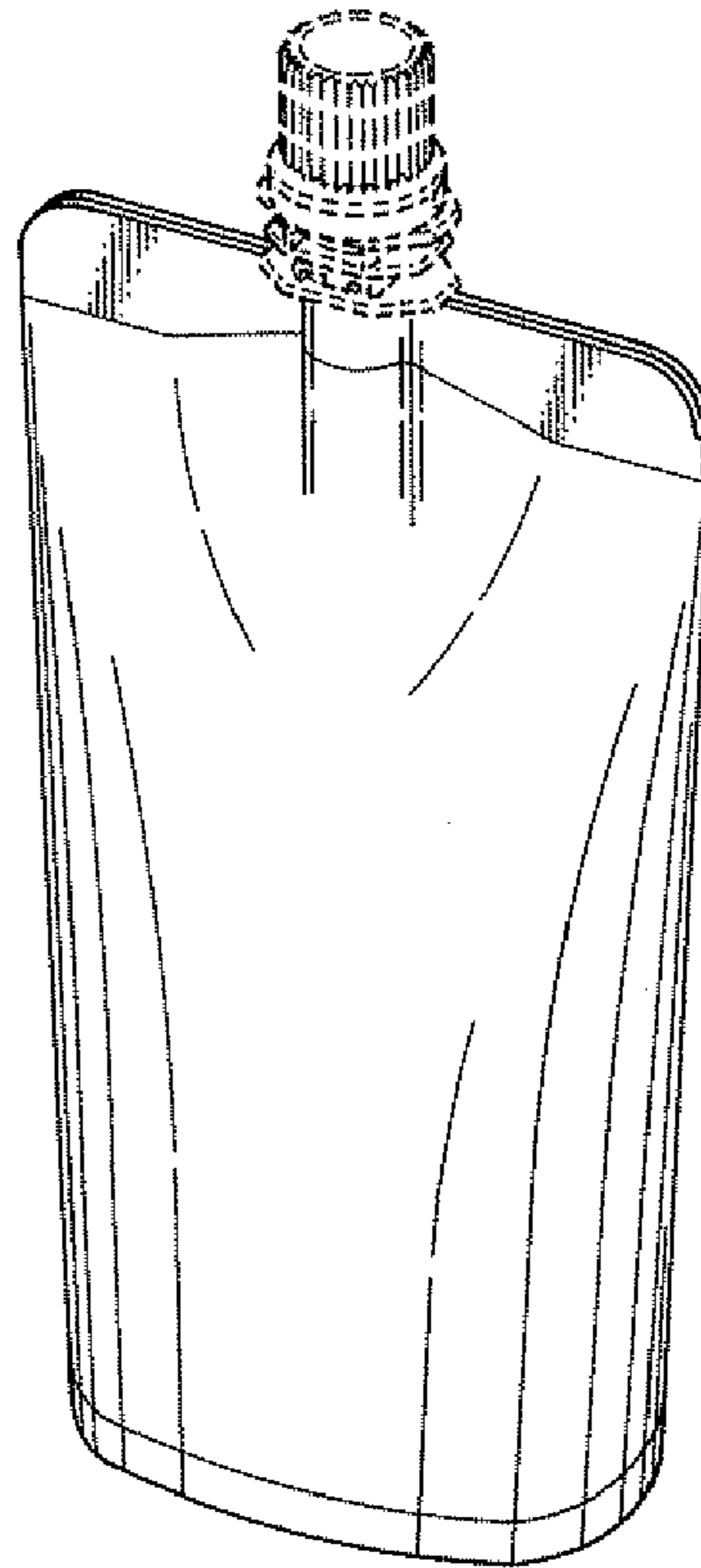

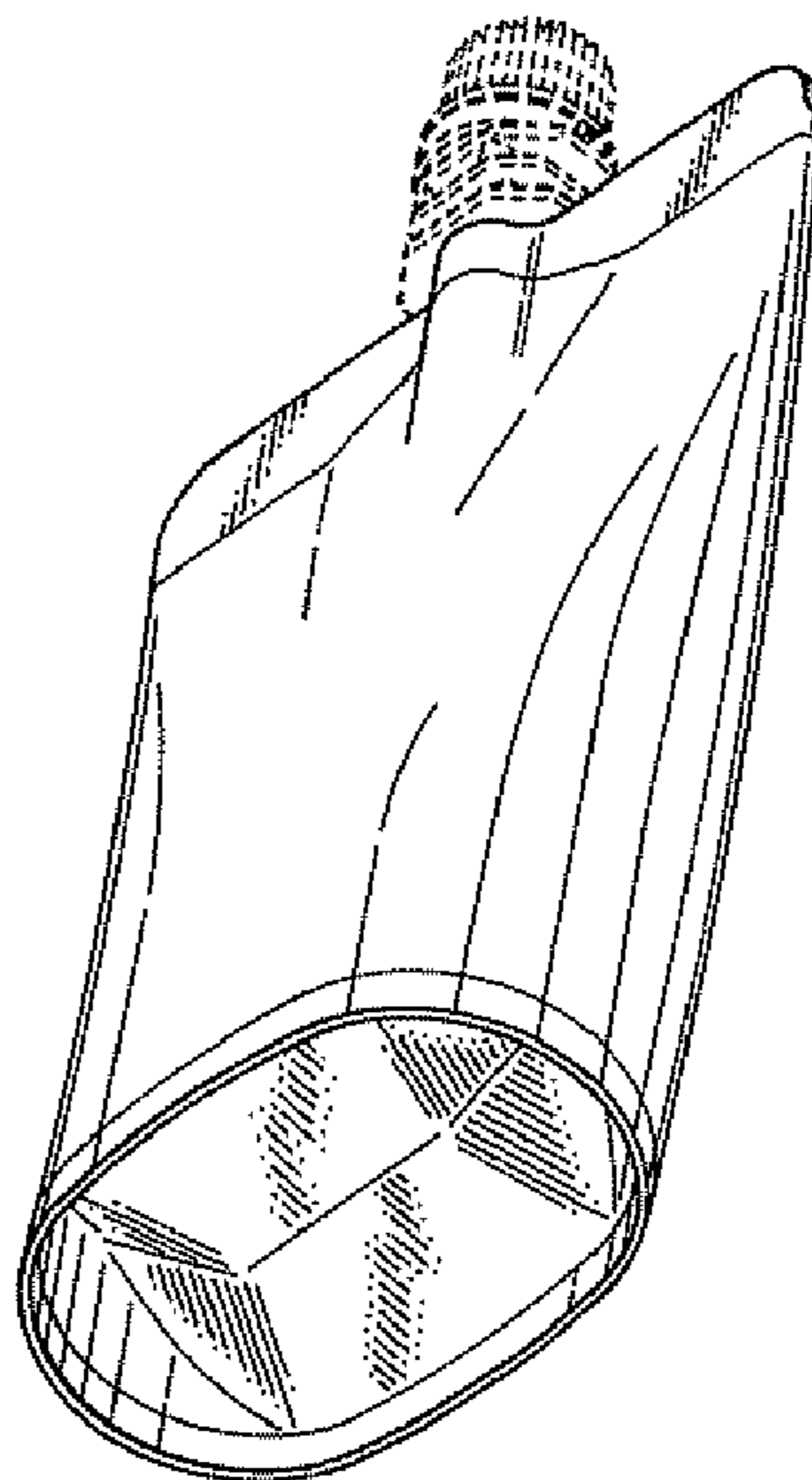

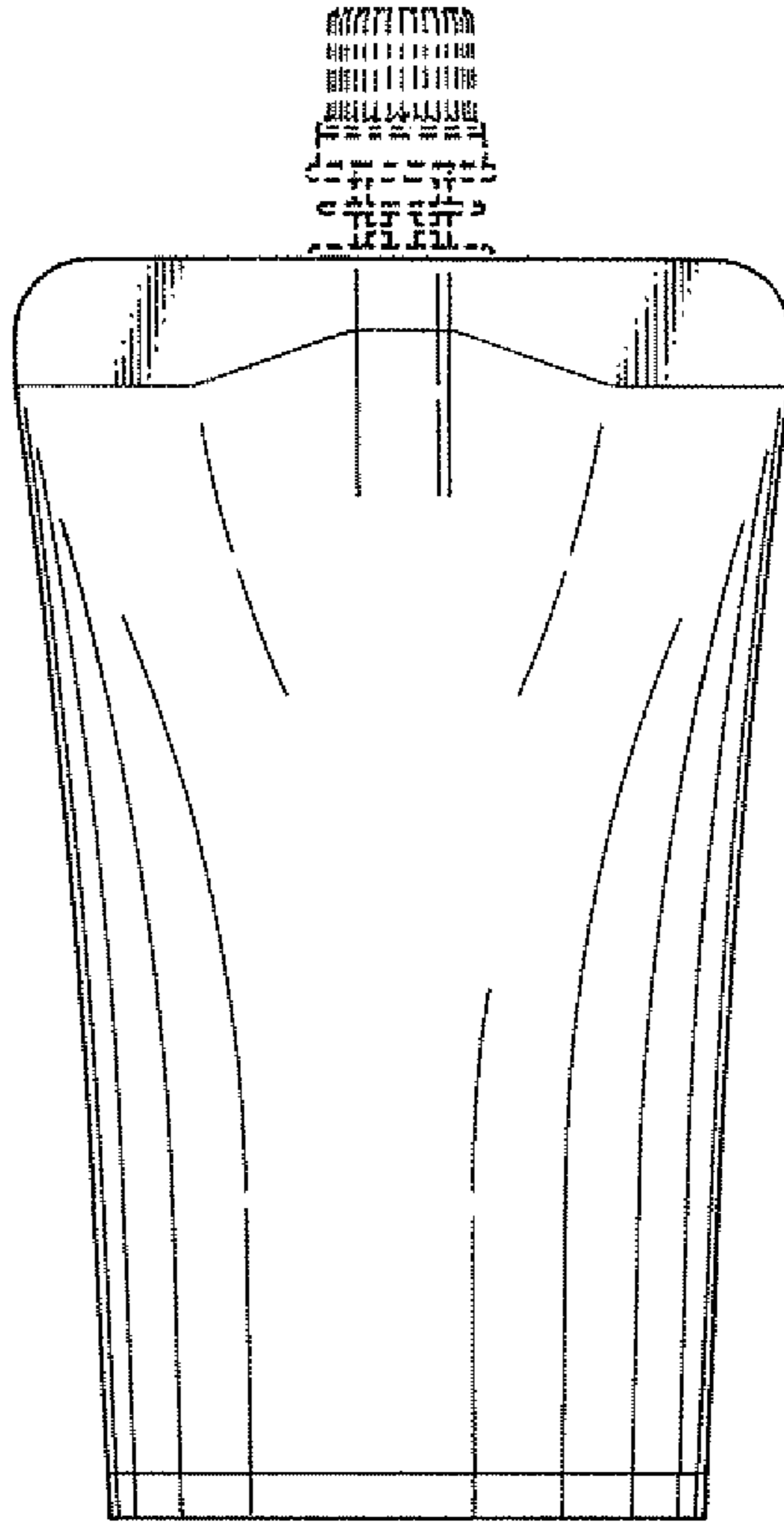

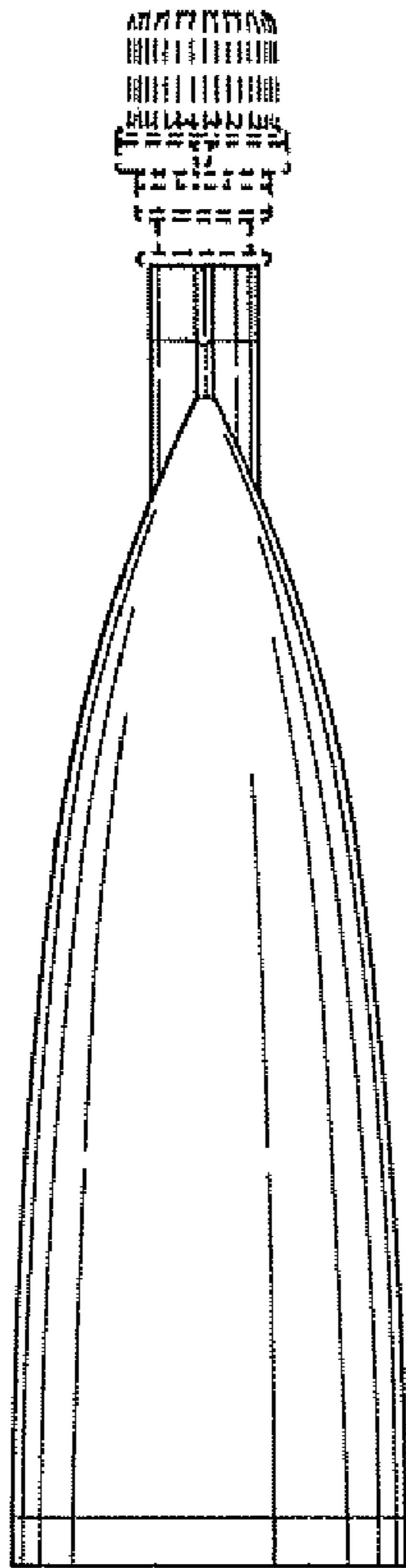

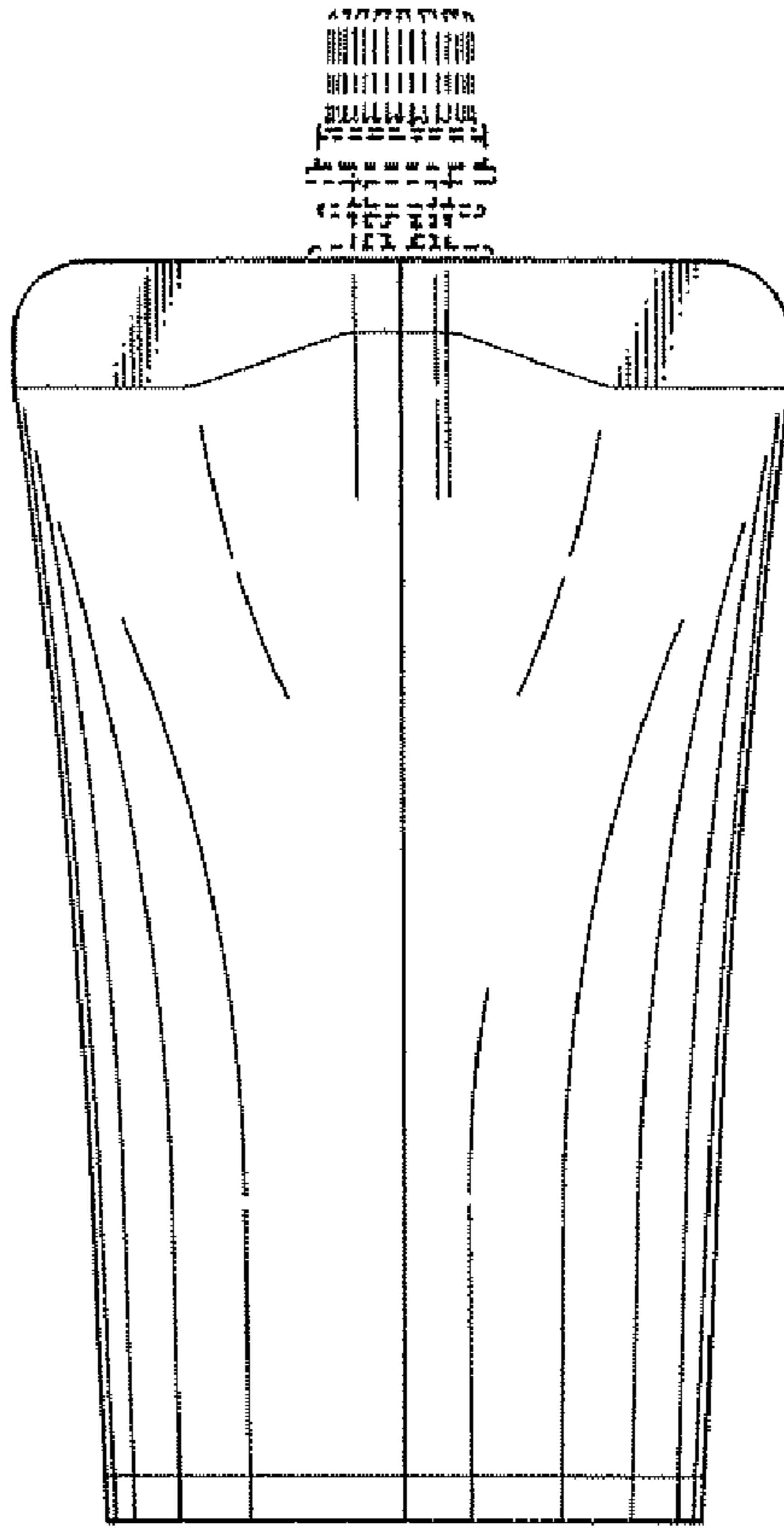

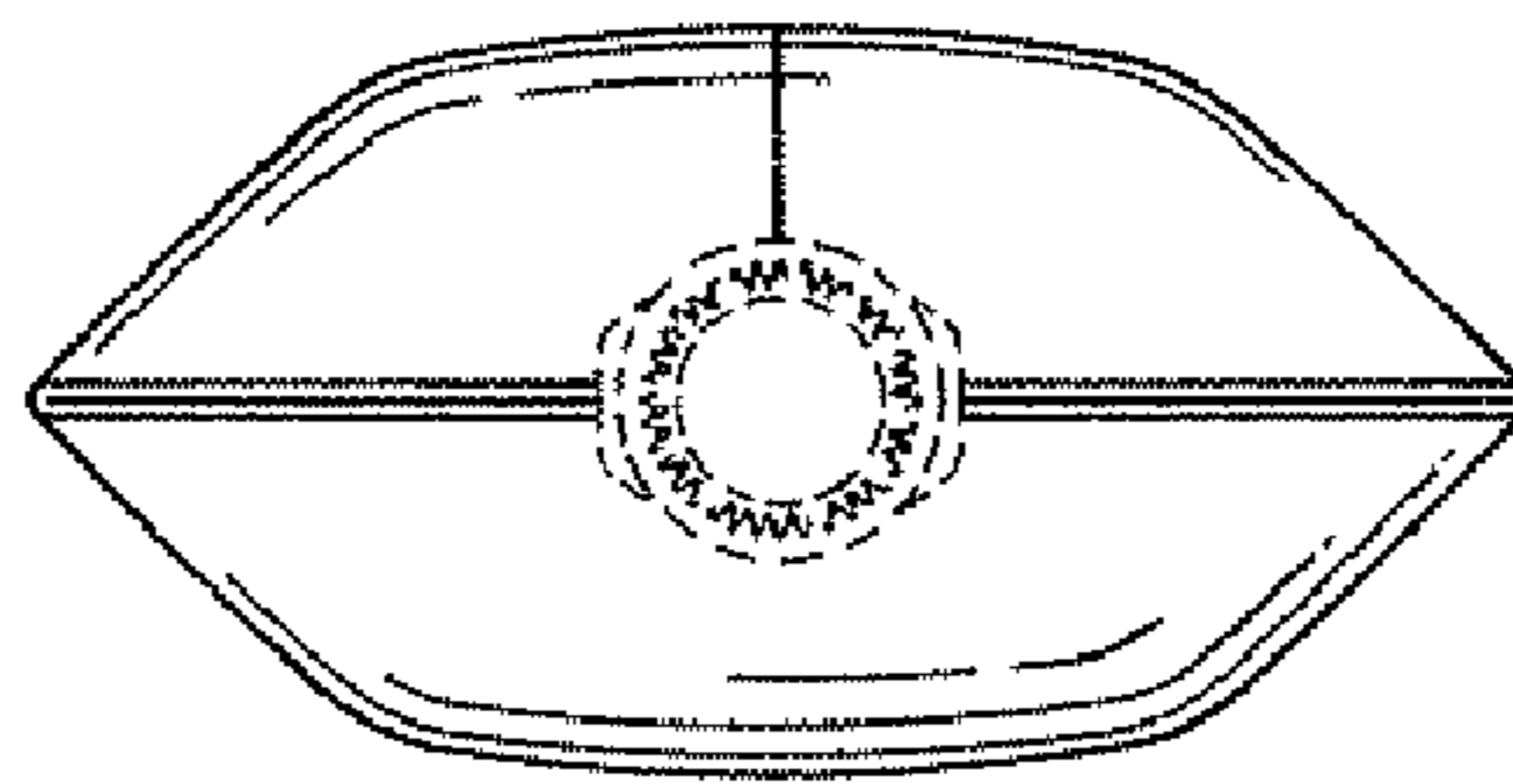
