(57) **CLAIM**

The ornamental design for ties arranged in a box, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, and side perspective view of a first embodiment of ties arranged in a box showing my new design;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a bottom plan thereof;

FIG. 5 is a rear elevation view thereof;

FIG. 6 is a top, front and side perspective view of the second embodiment of the ties arranged in a box, the front, rear, bottom and side views being the same as FIGS. 3, 4 and 5;

FIG. 7 is a top, front and side perspective view of the ties arranged in a box, shown in an alternate environment;

FIG. 8 is a top, front and side perspective view of the third embodiment of the ties arranged in a box, the front, rear, bottom and side views being the same as FIGS. 3, 4 and 5;



FIG. 9 is a bottom plan view of ties arranged in a box according to my design of FIG. 8;


FIG. 10 is a front elevation view of ties arranged in a box according to my design of FIG. 8; and,

FIG. 11 is a rear elevation view of ties arranged in a box according to my design of FIG. 8.























