(57) **CLAIM**

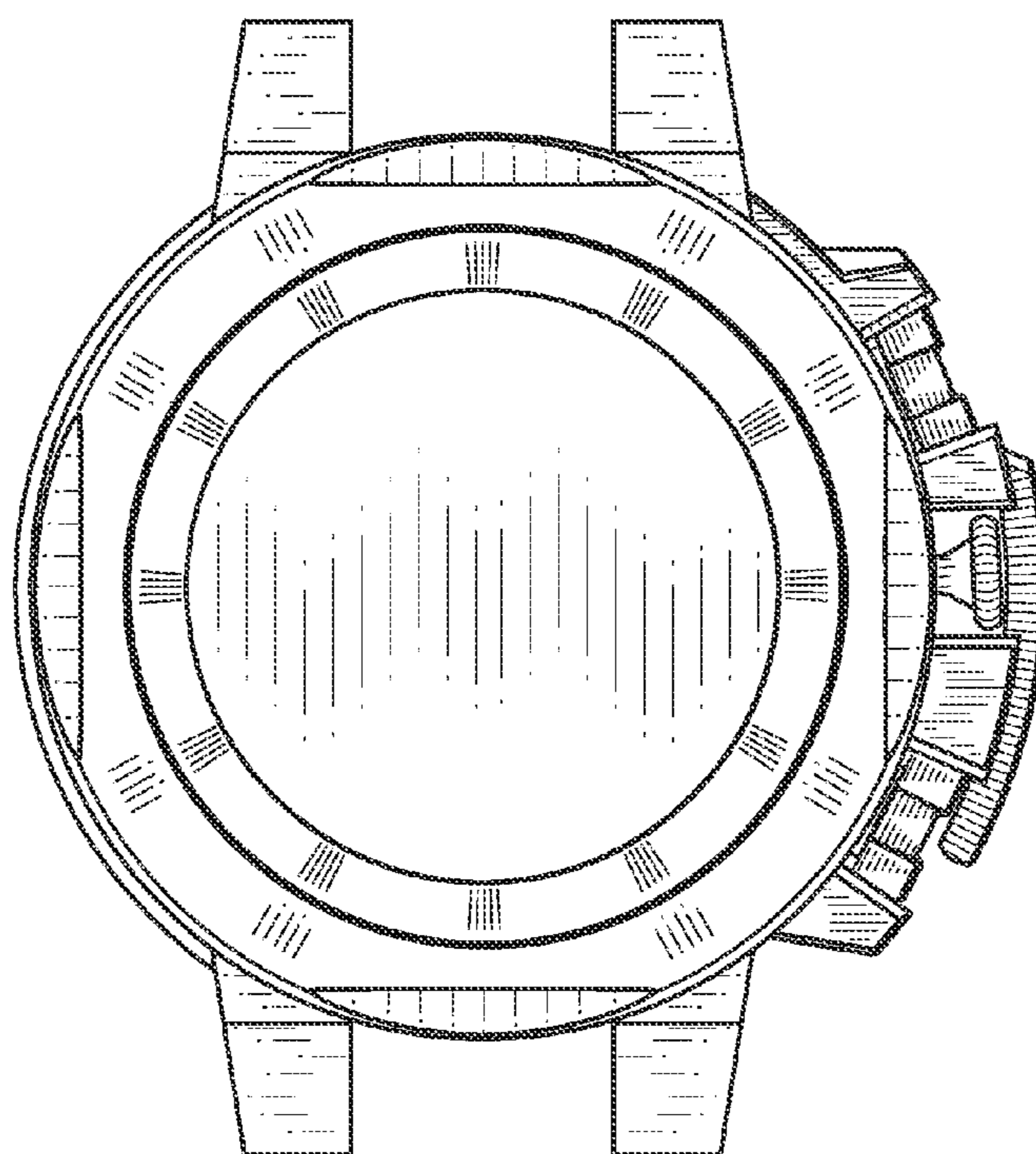
The ornamental design for a watch case, as shown and described.

**DESCRIPTION**

FIG. 1 is a top view of the watch case.  
 FIG. 2 is a bottom view of the watch case.

 FIG. 5 is a side view from the right of FIG. 1.  
 FIG. 6 is a side view from the left of FIG. 1; and,

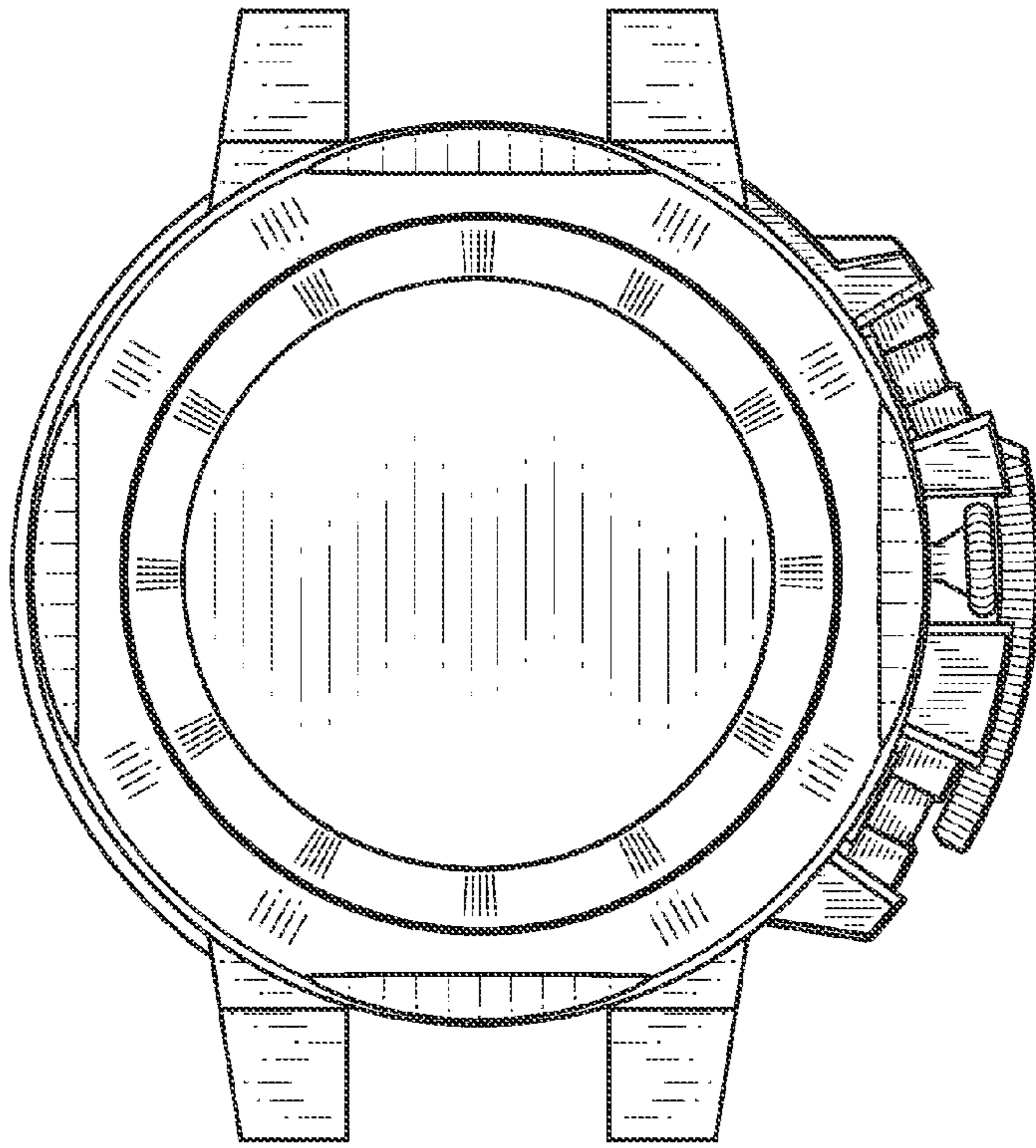

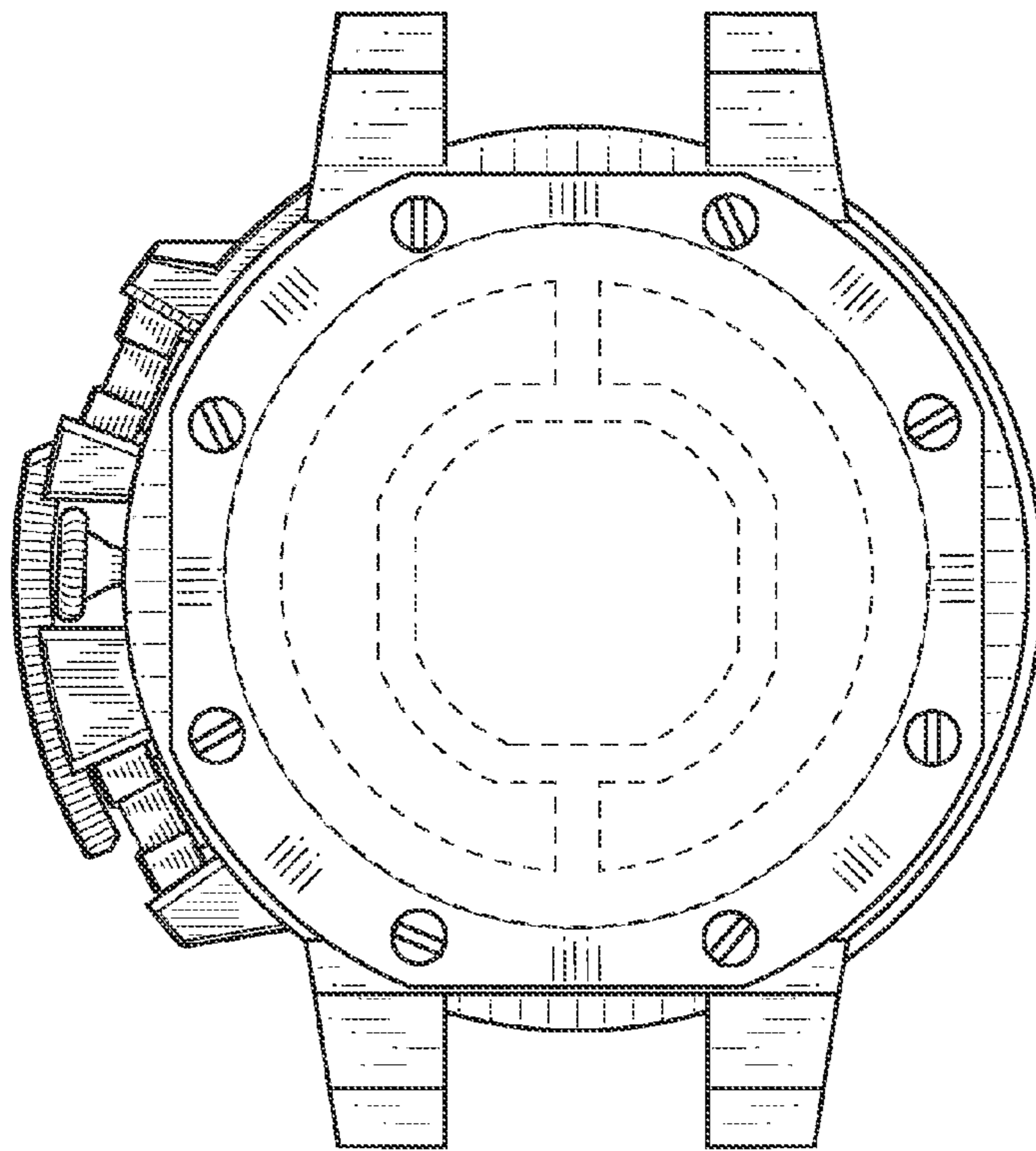

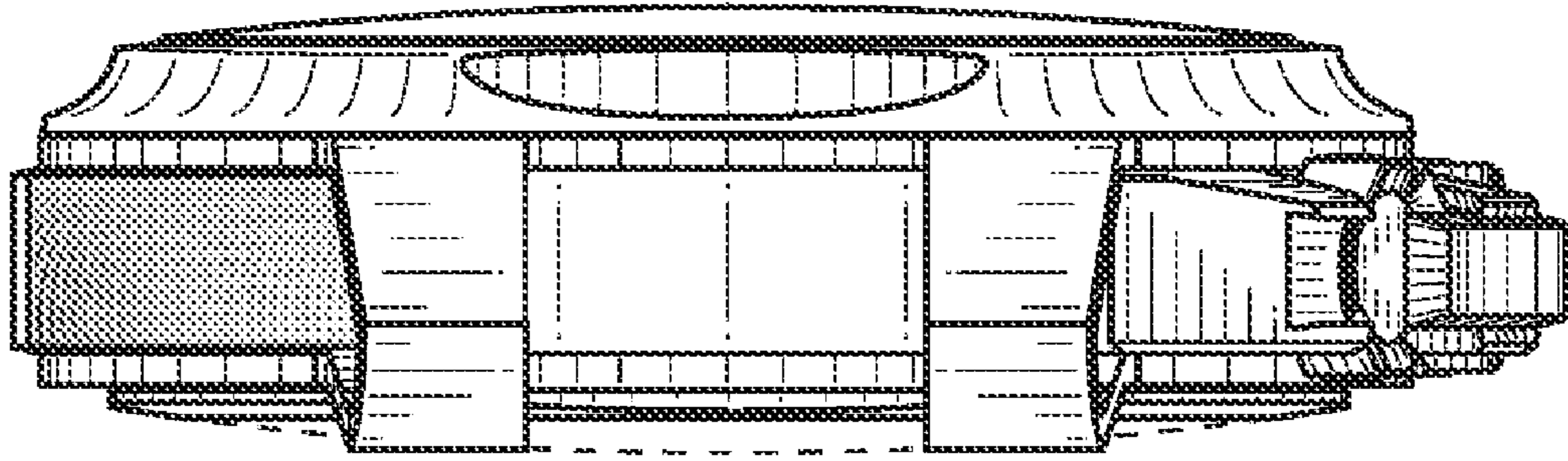

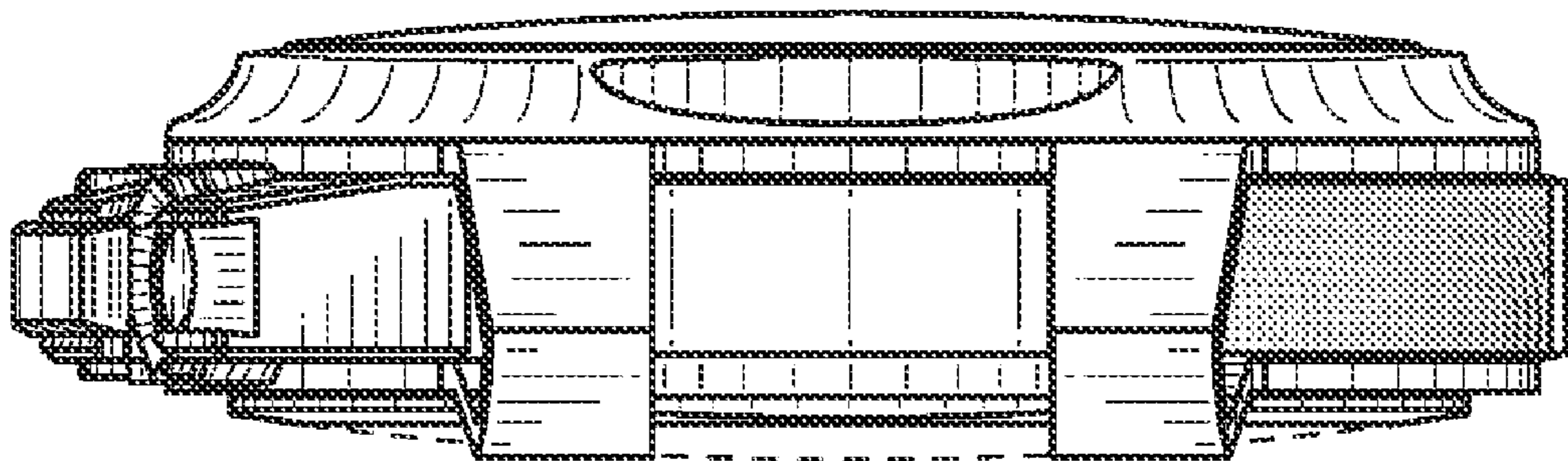

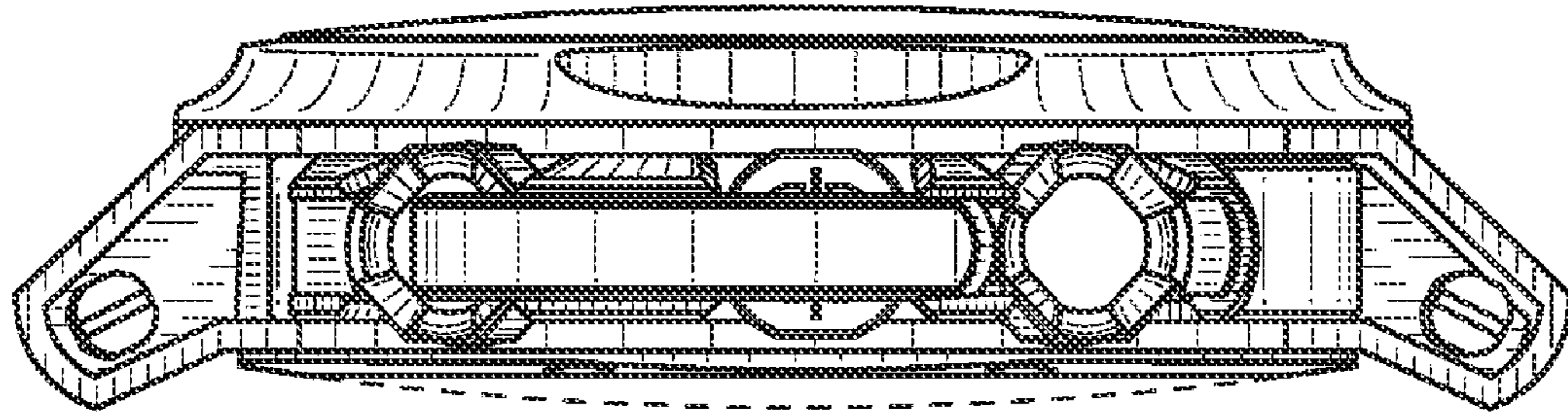

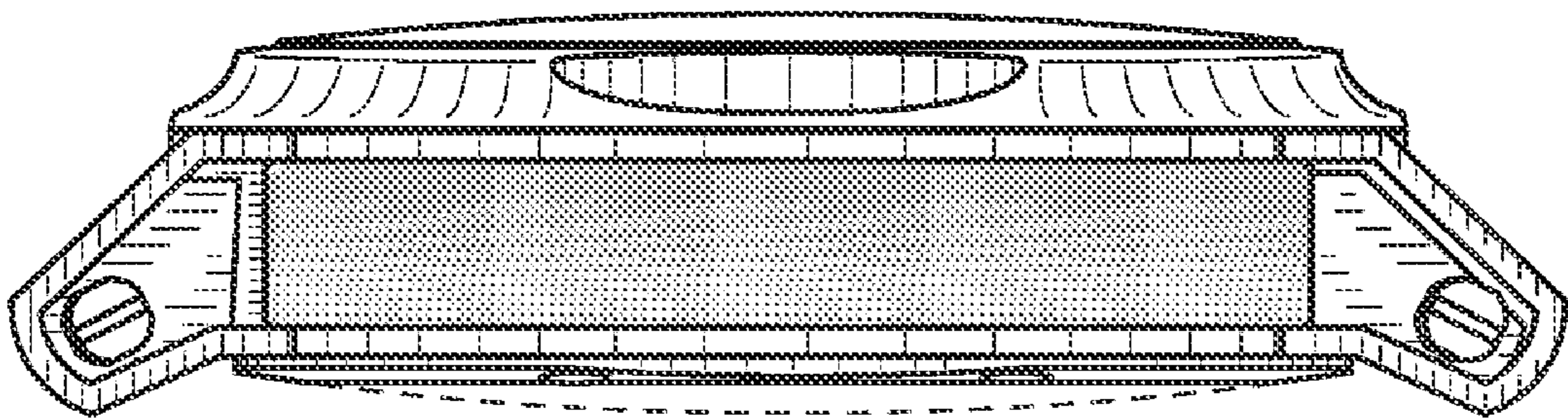

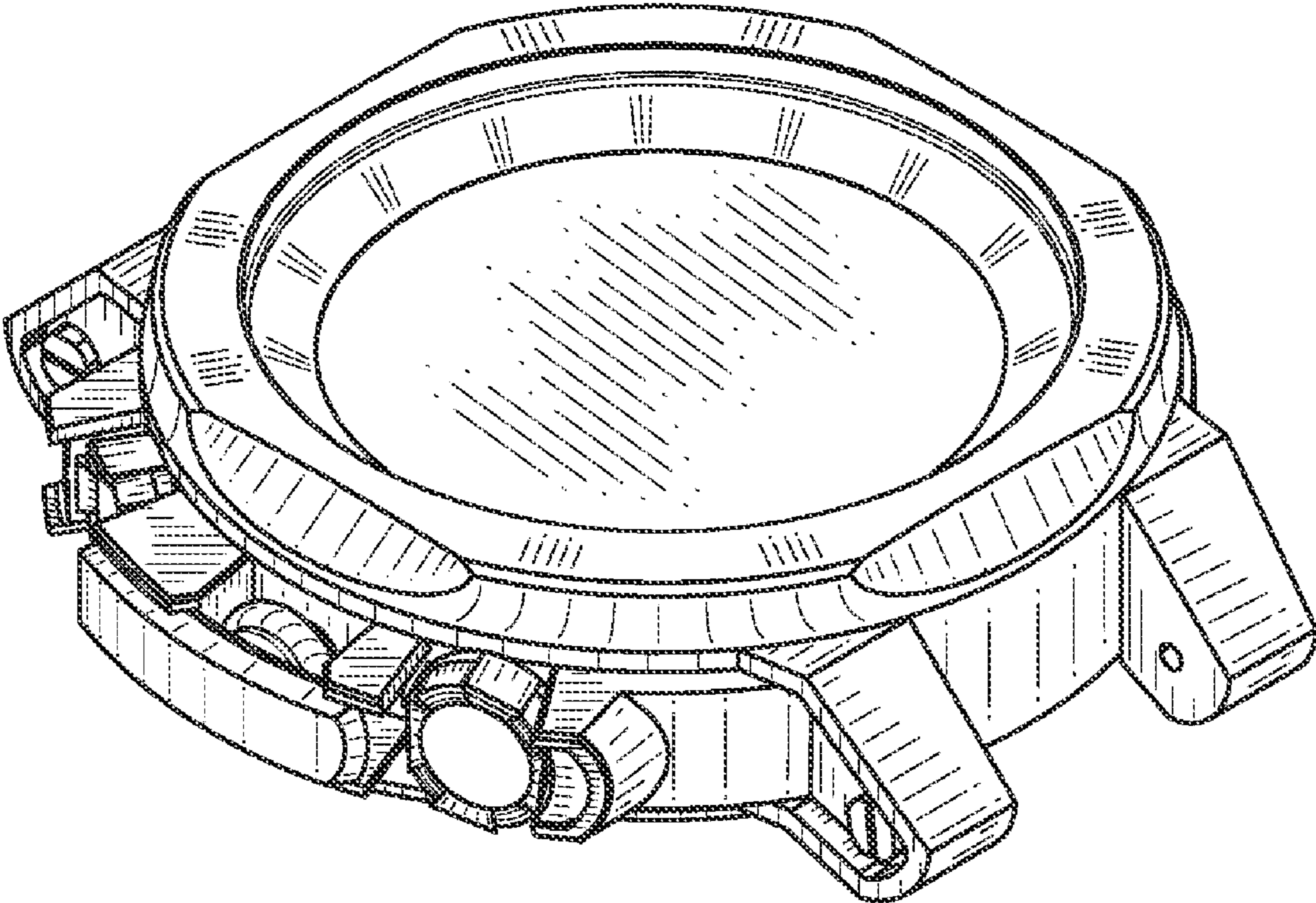
