DESCRIPTION

FIG. 1 is a perspective view of an MP3 player according to my new design;

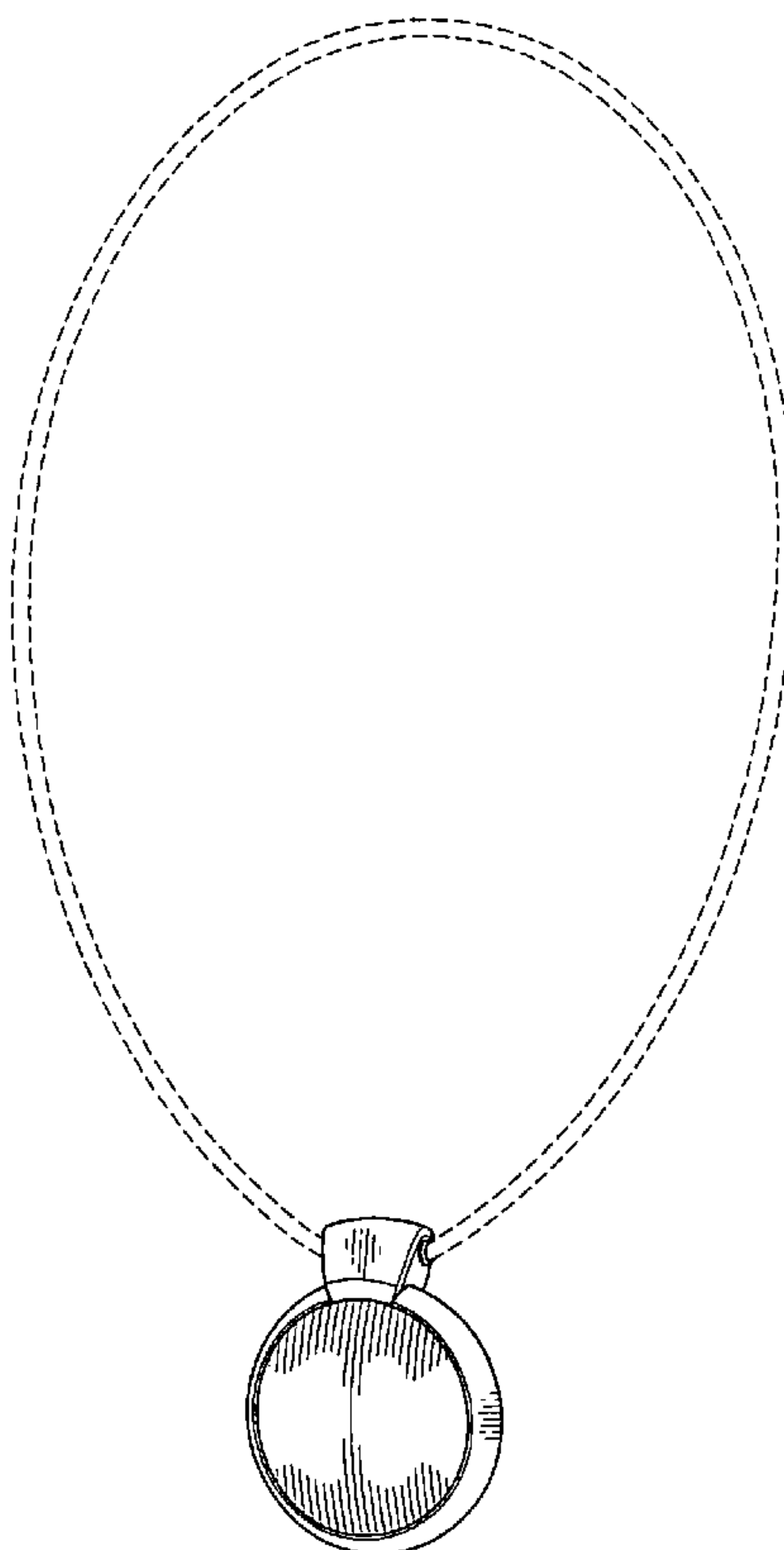

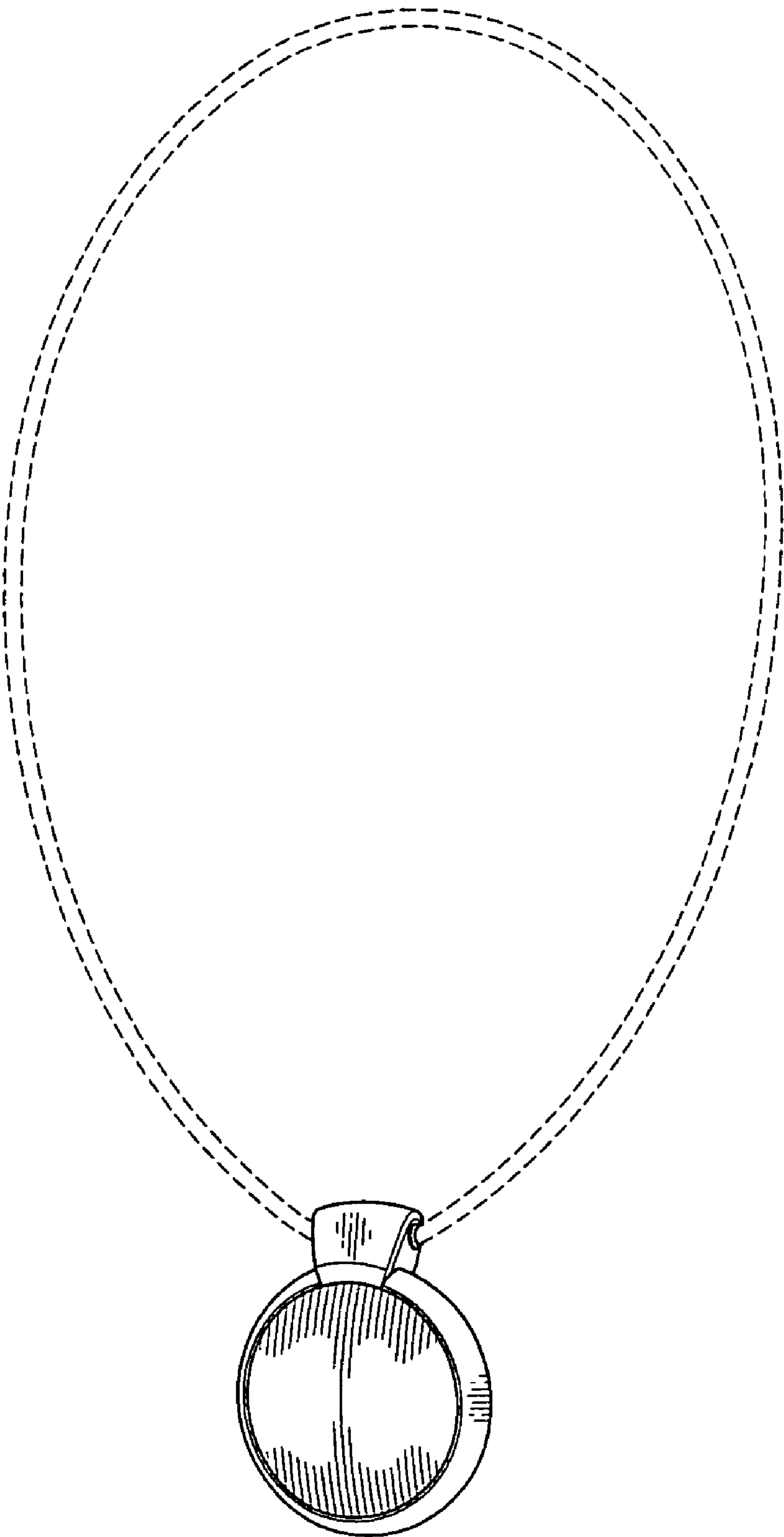

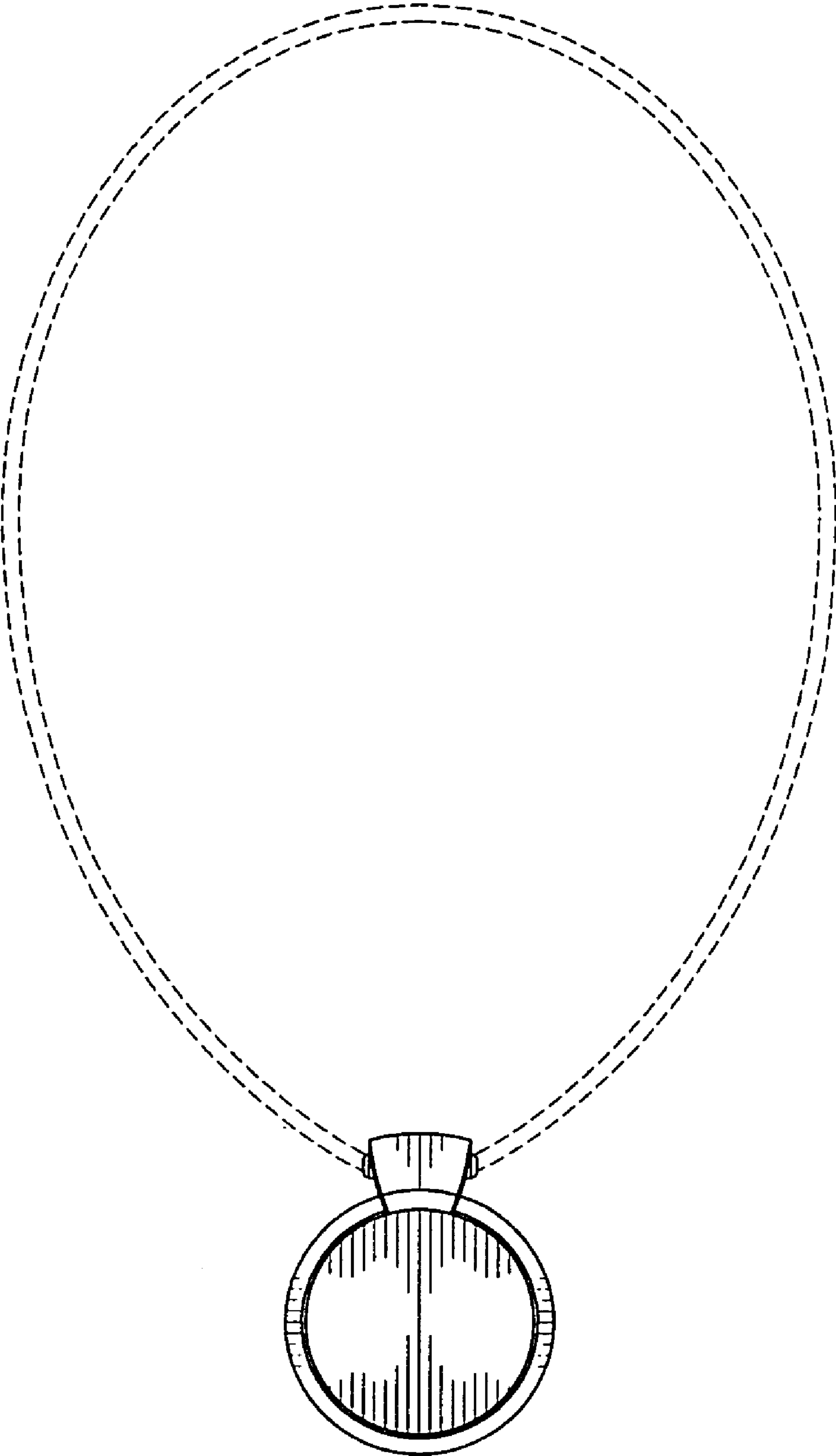

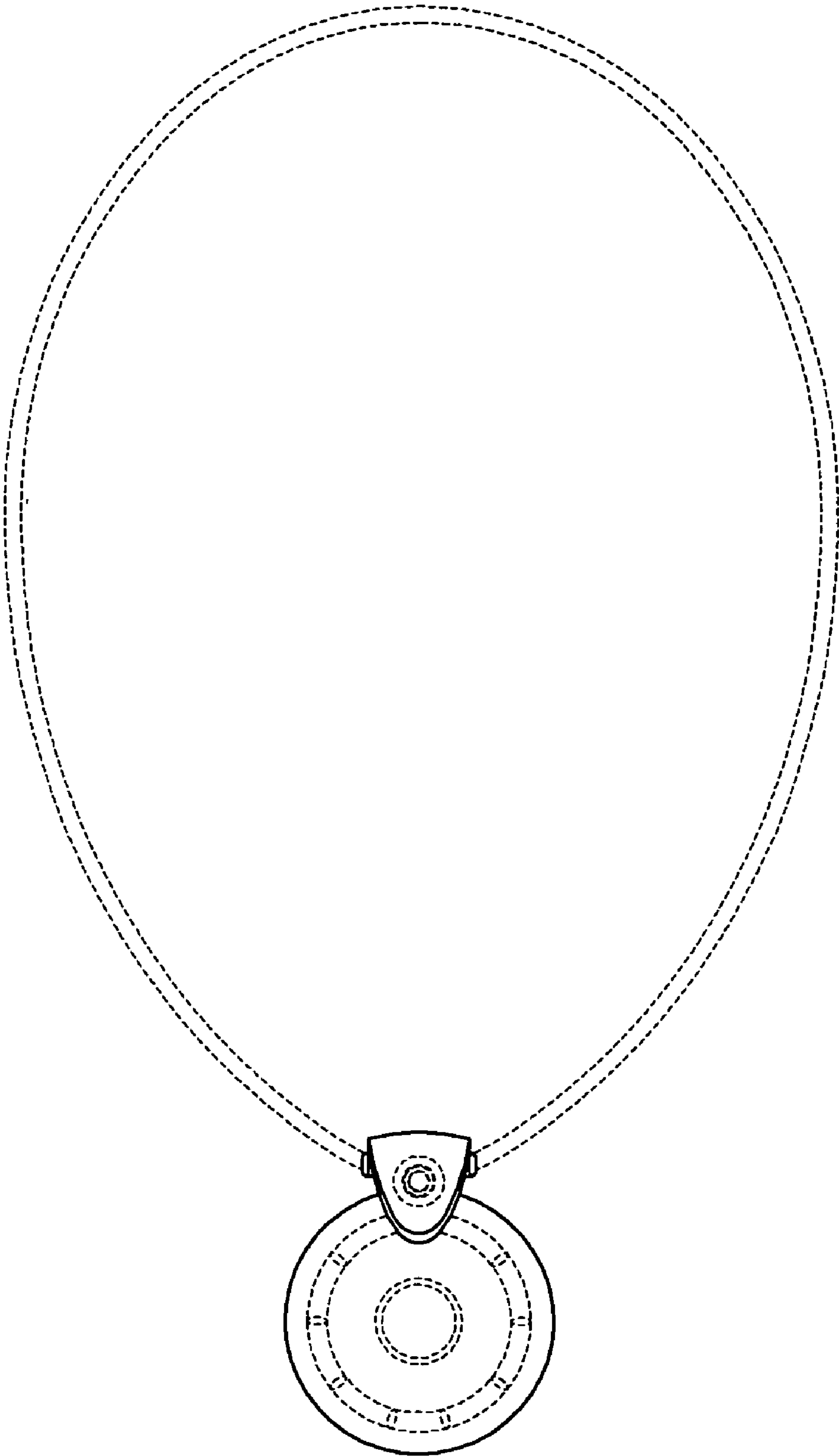

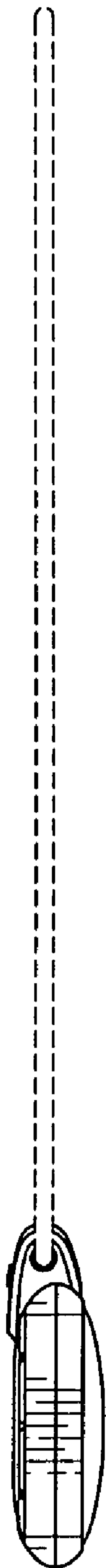

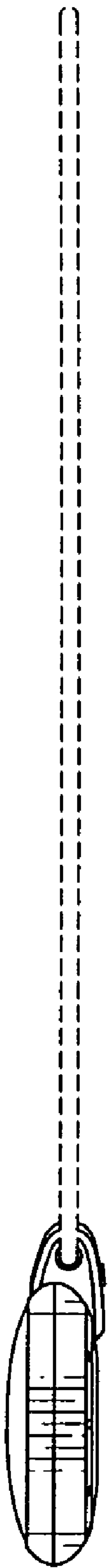
