DESCRIPTION

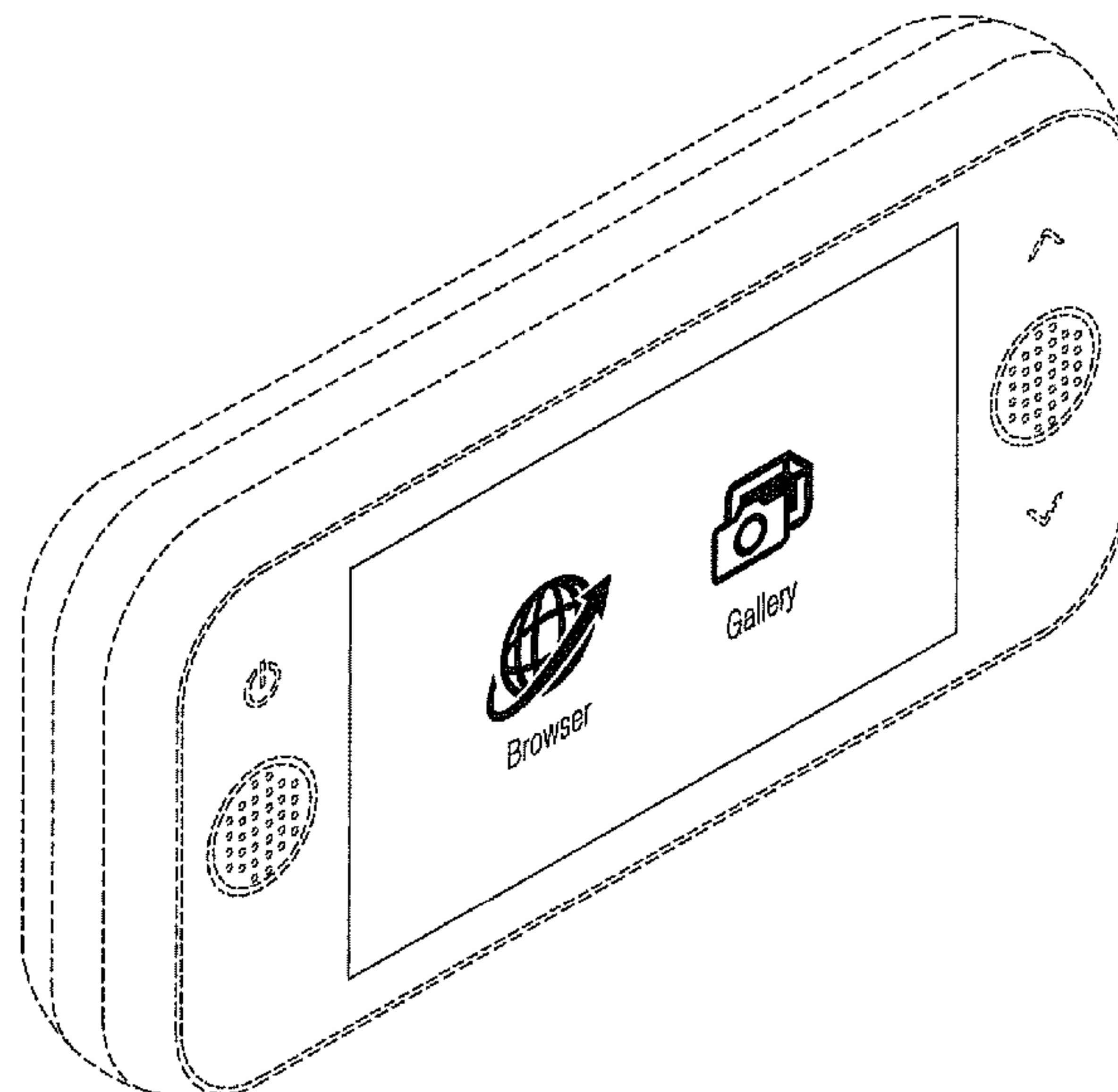
FIG. 1 is a front perspective view of video display image for navigator;

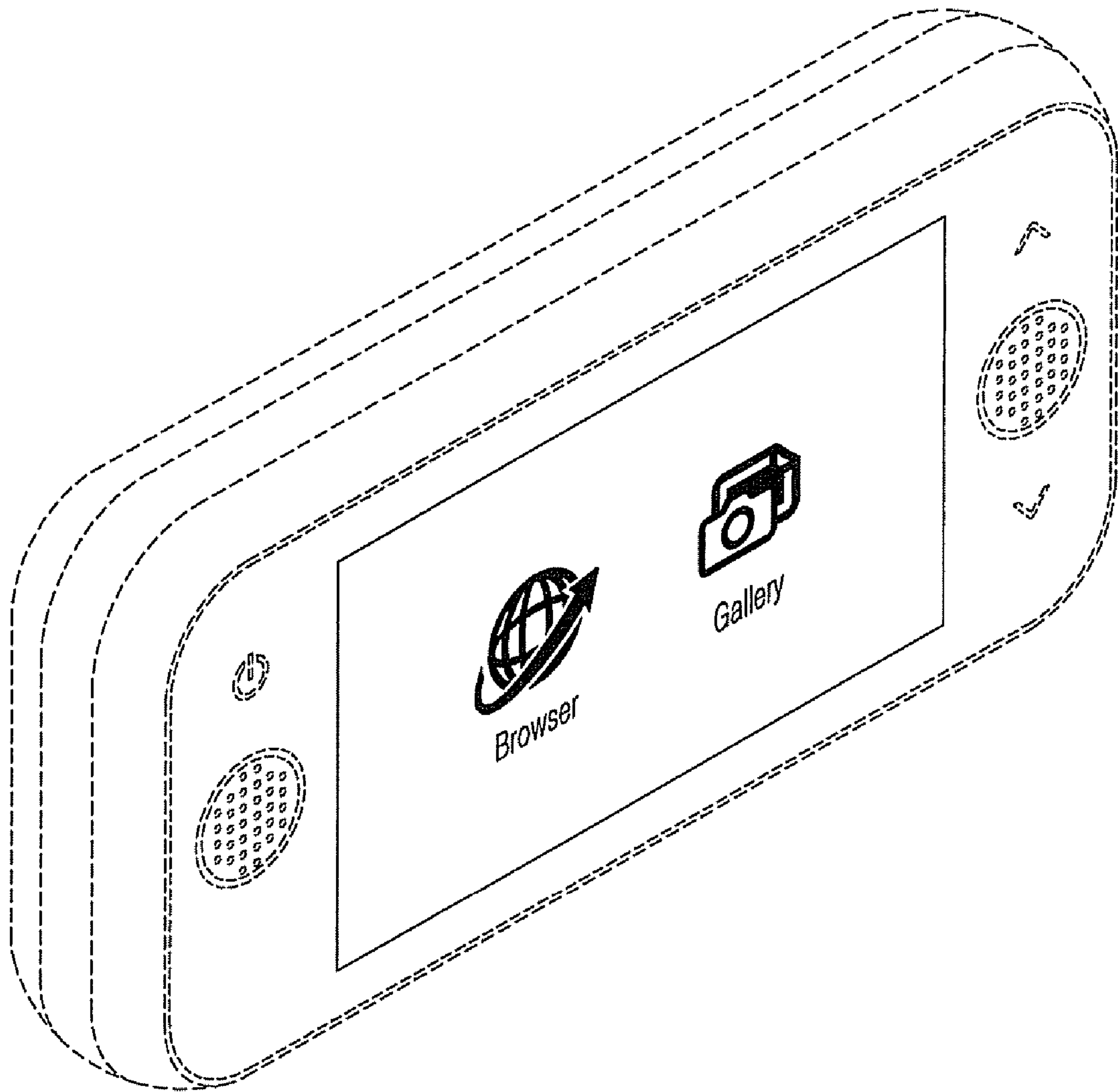

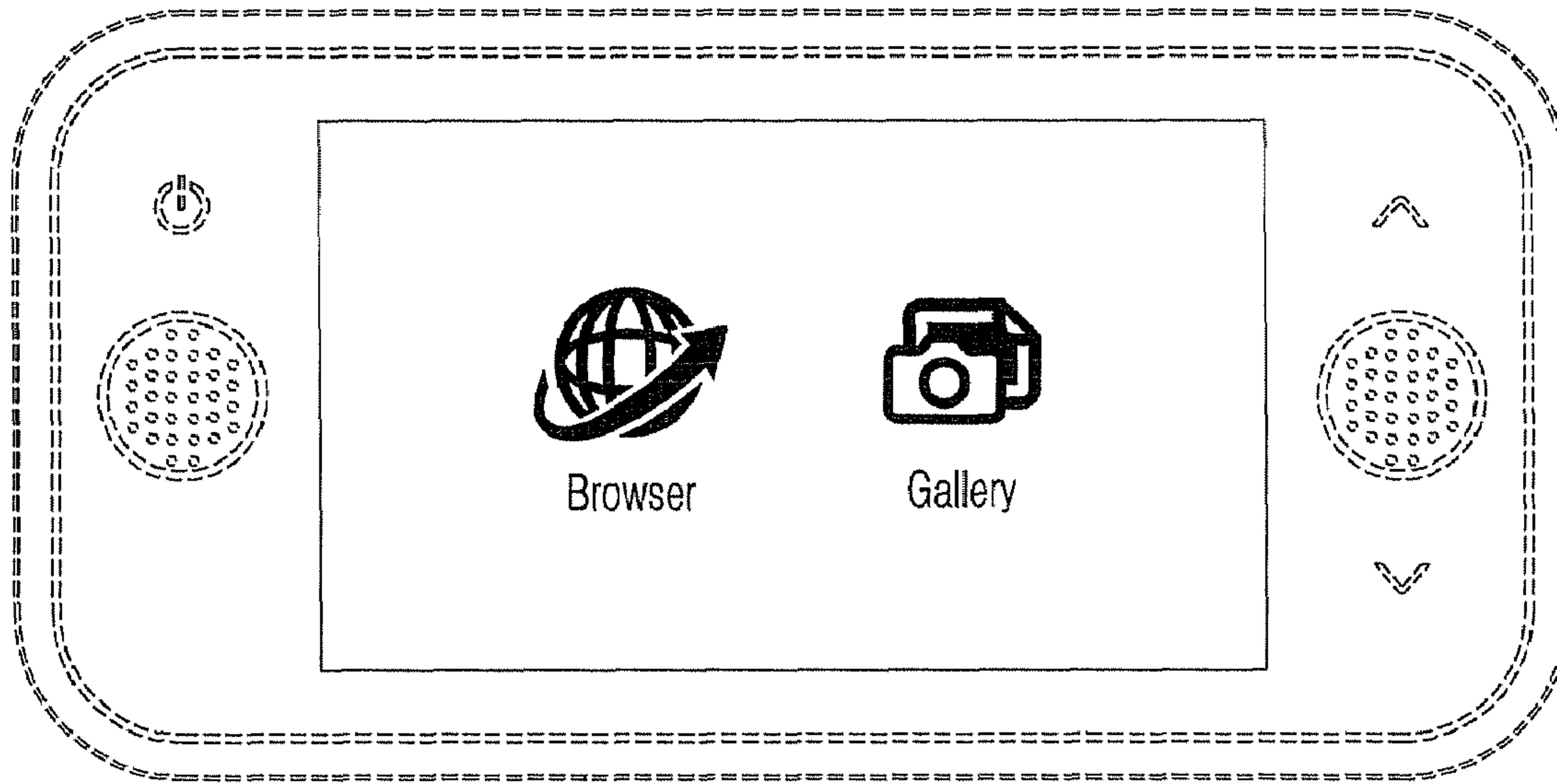
