DESCRIPTION

FIG. 1 is a front perspective view of a pit stop game showing our new design;

FIG. 2 is a front elevation view thereof;

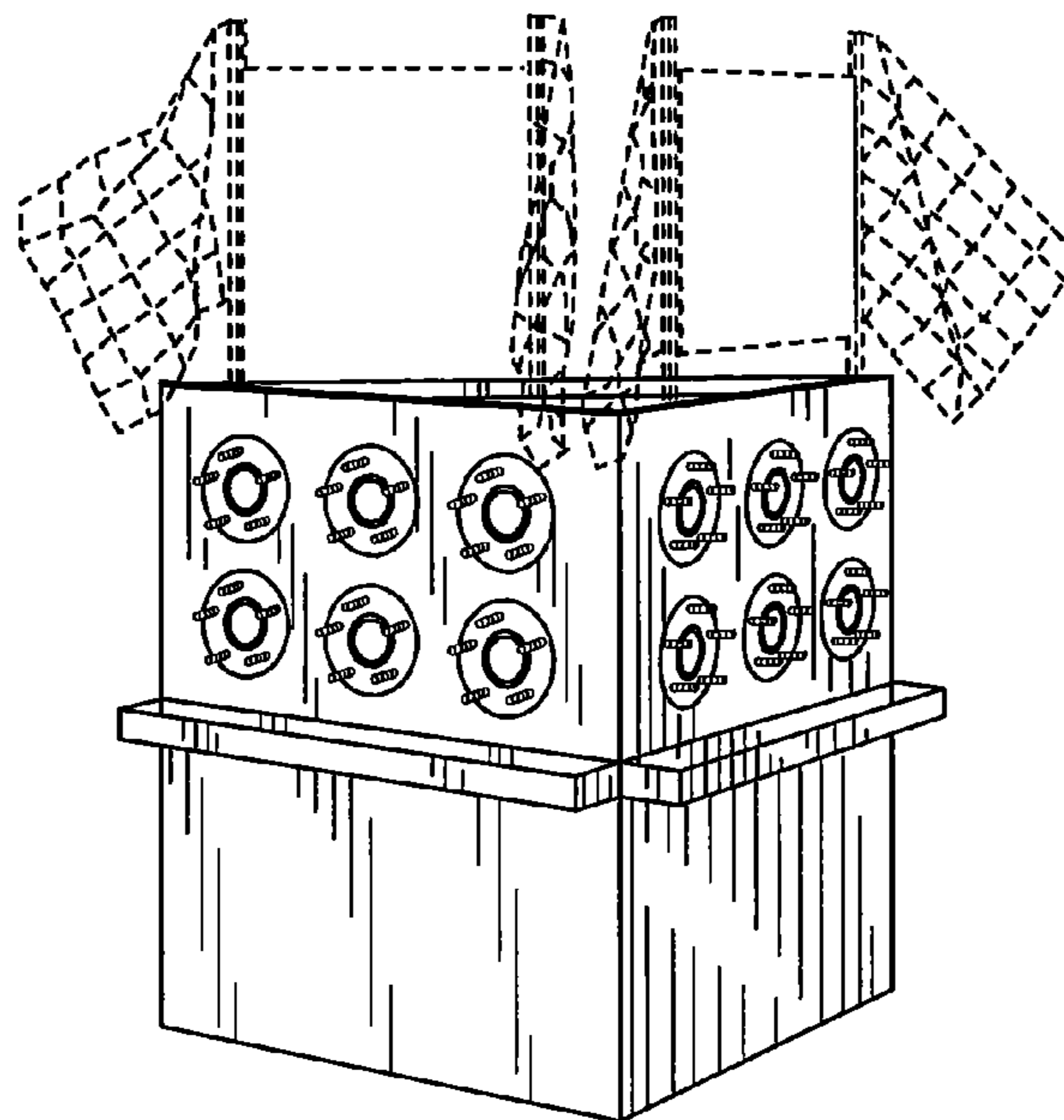

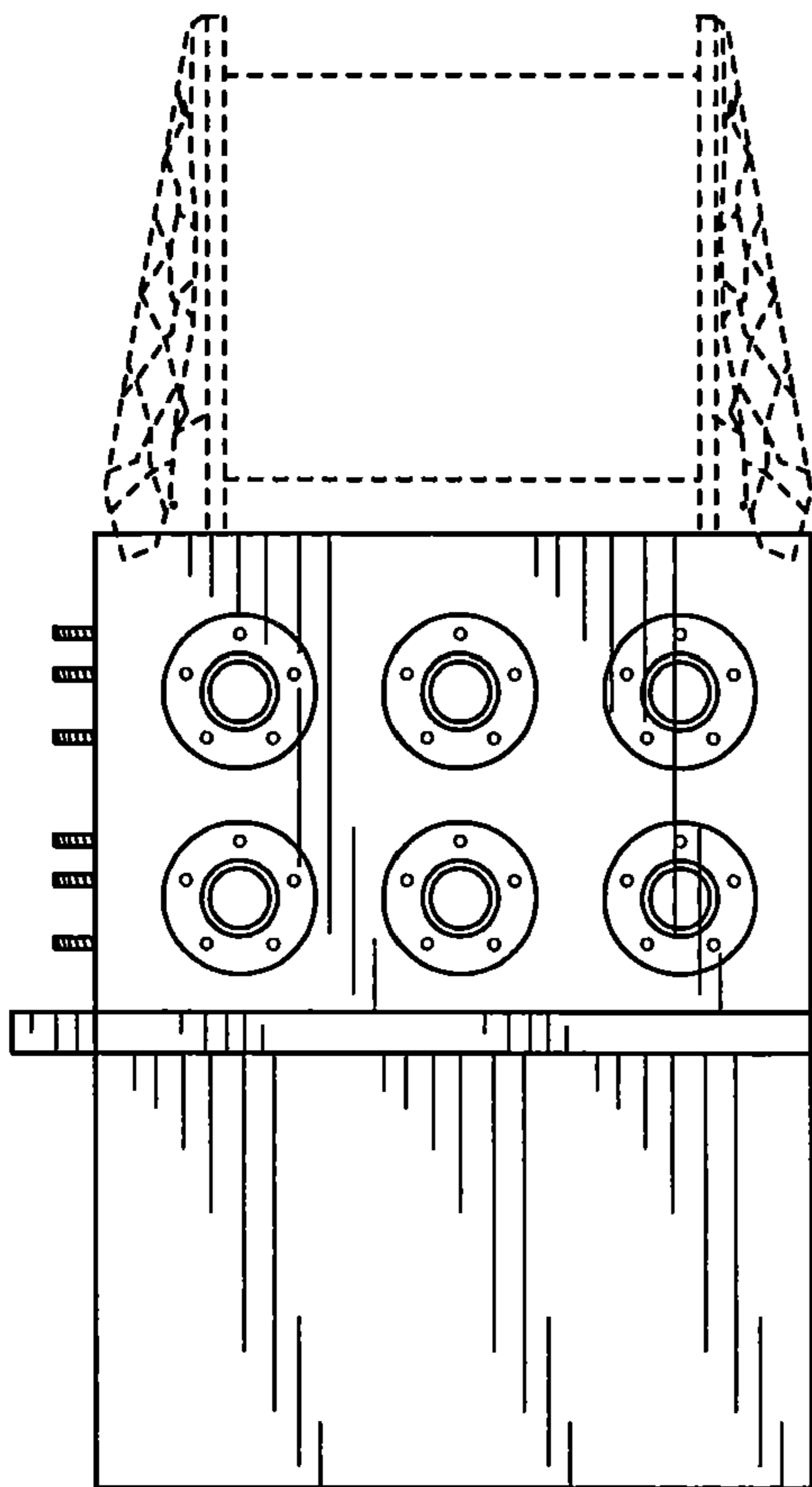
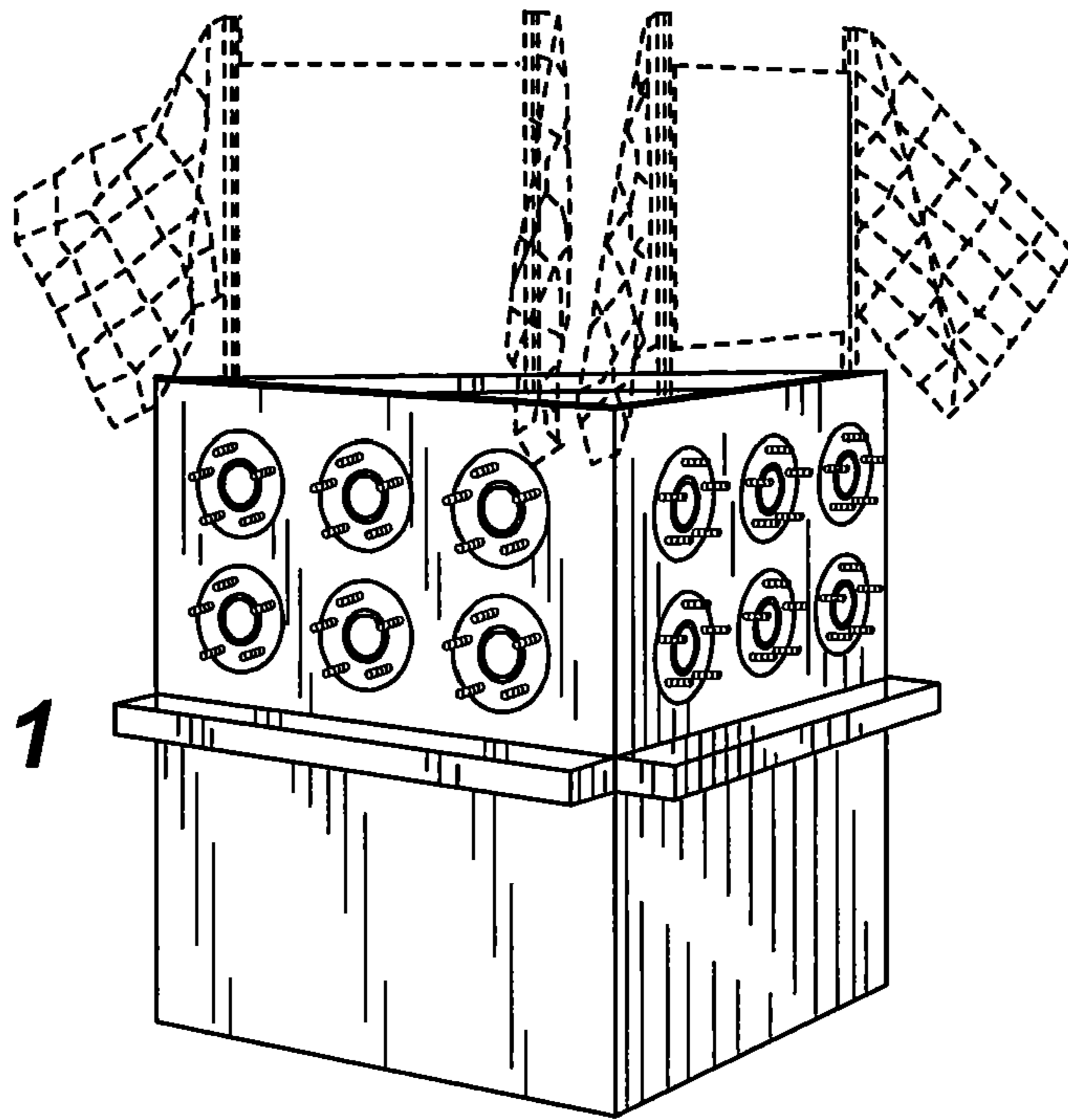

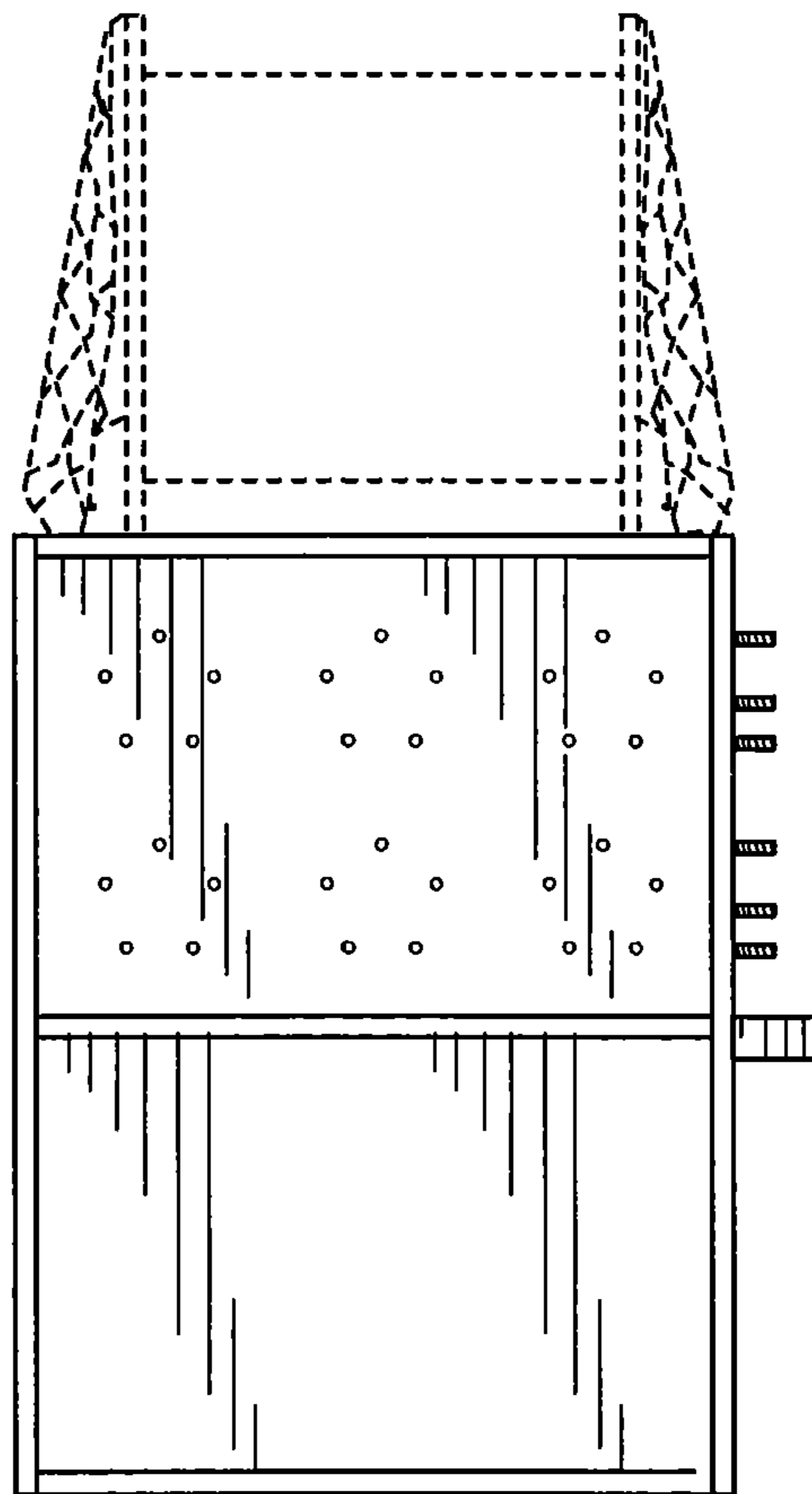

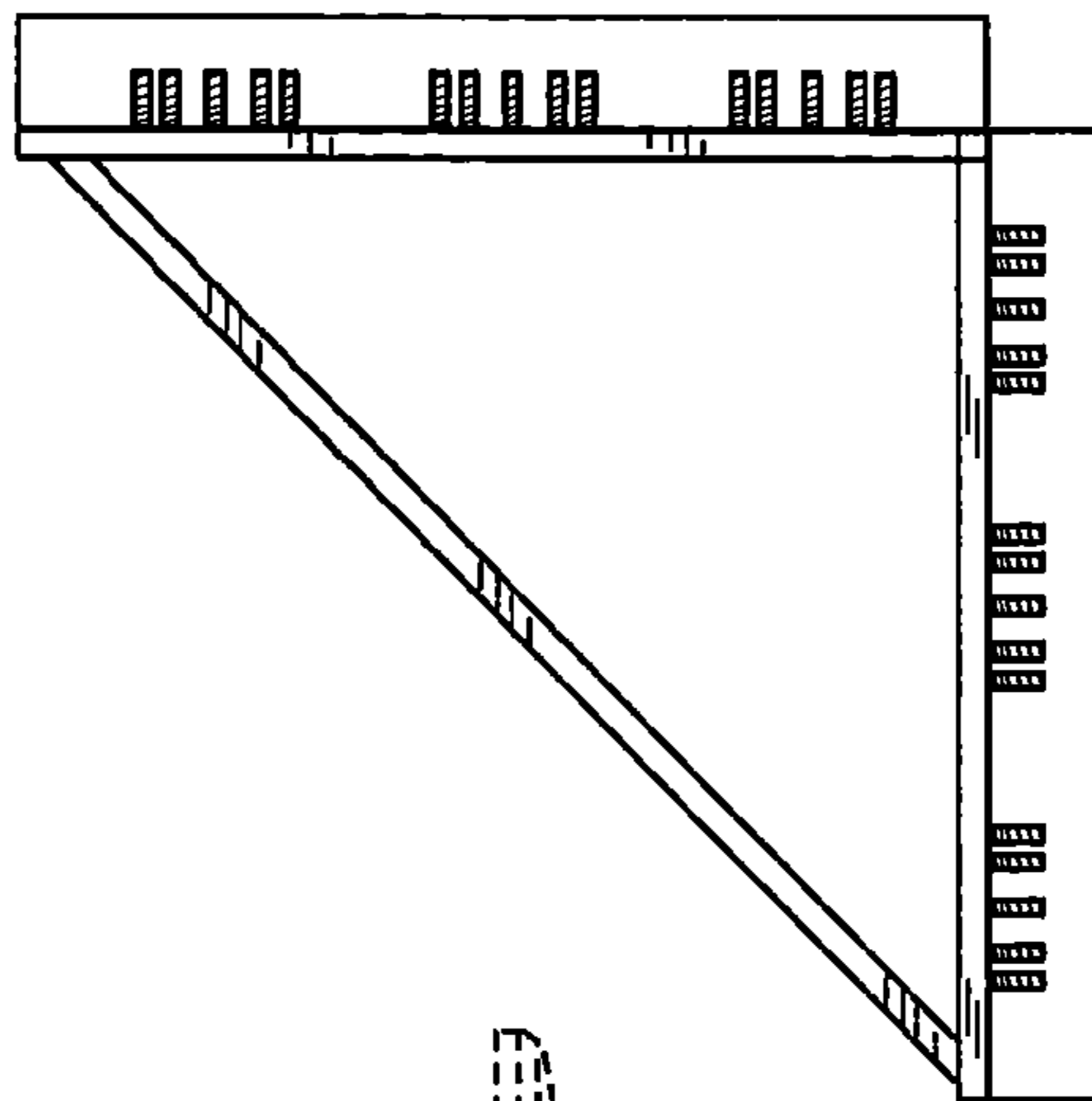

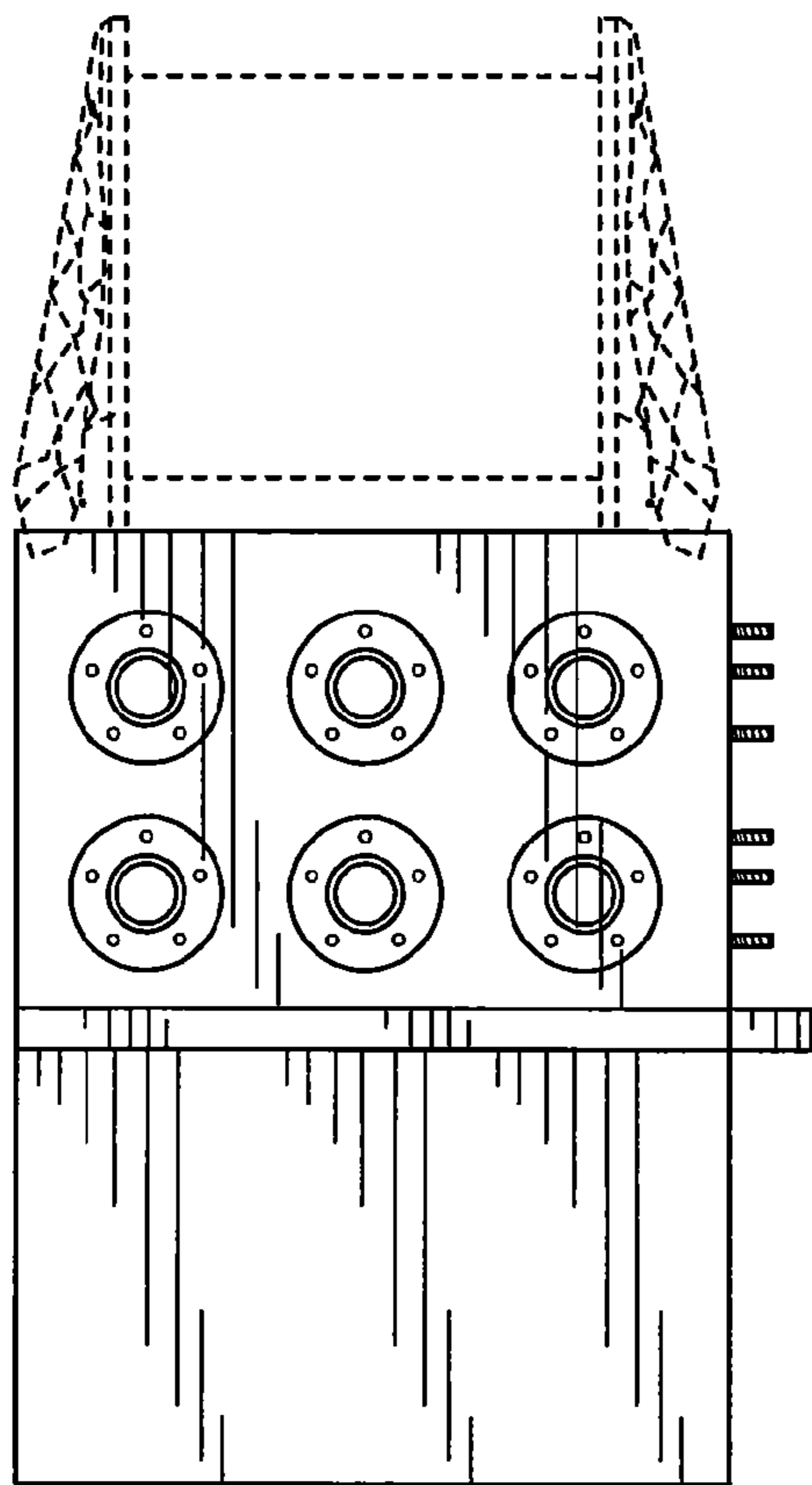

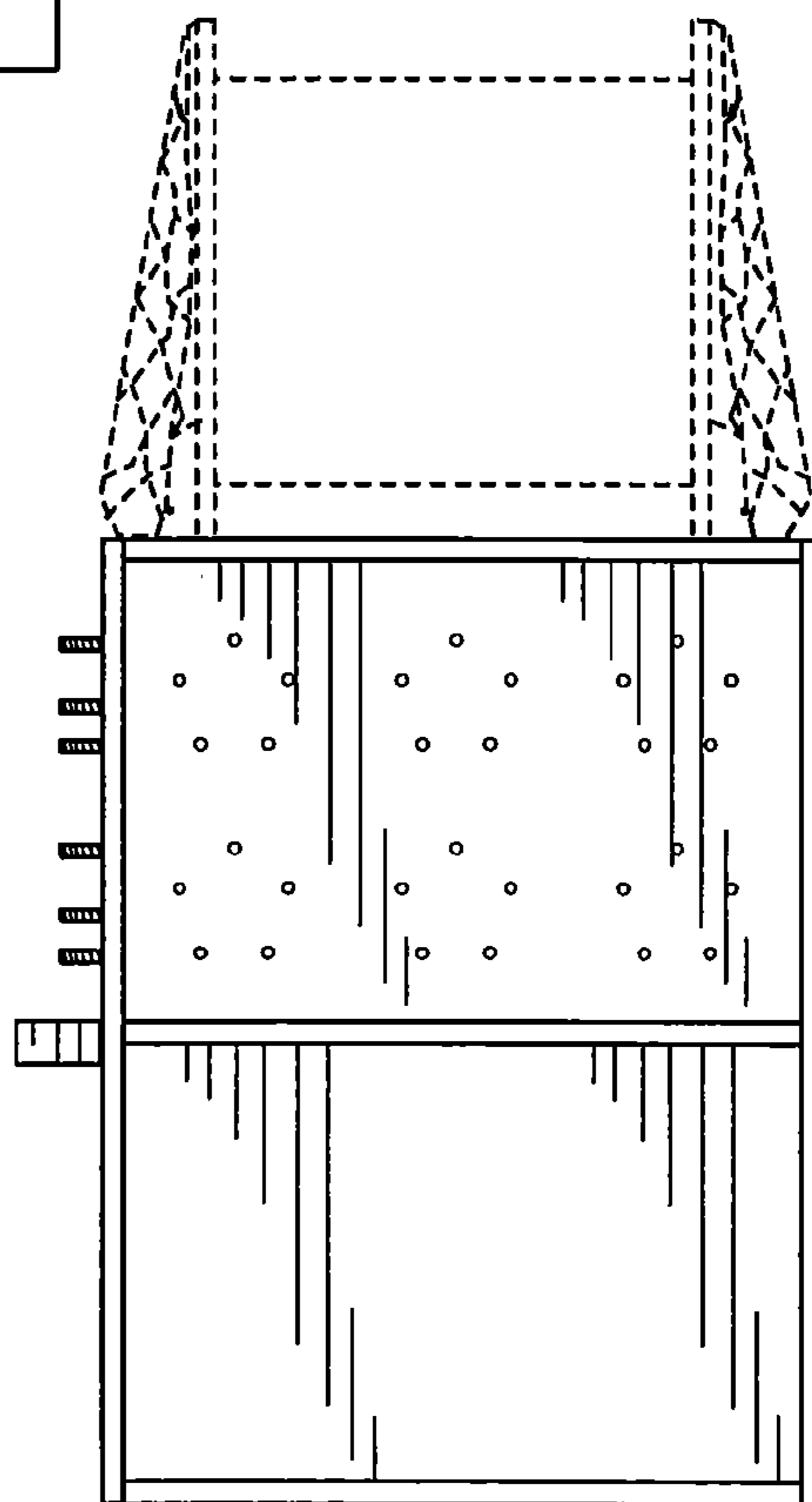

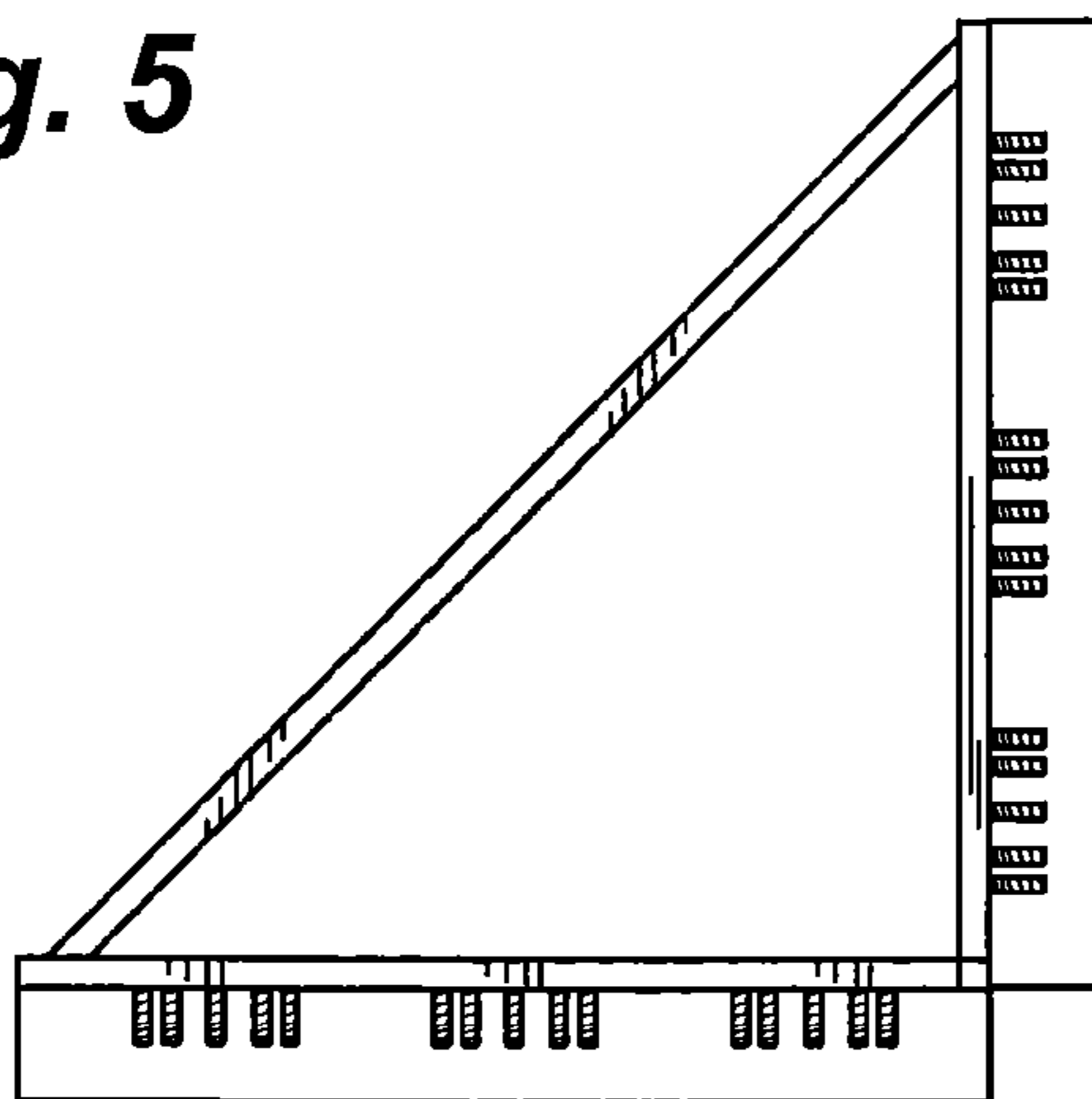
