FIG. 4 is an enlarged left side view thereof;

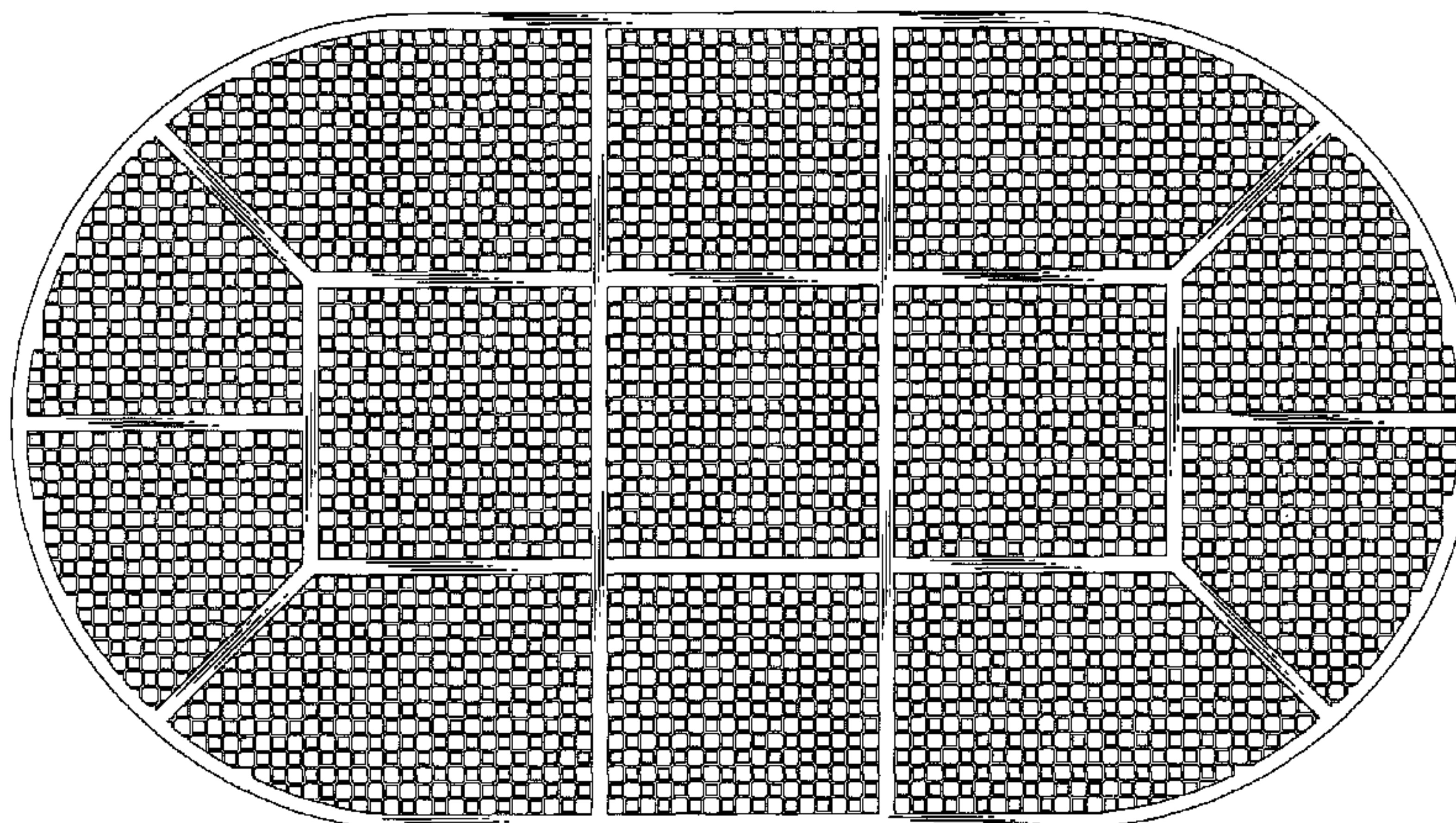
FIG. 5 is an enlarged cross-sectional view taken along line 5—5 in FIG. 1;

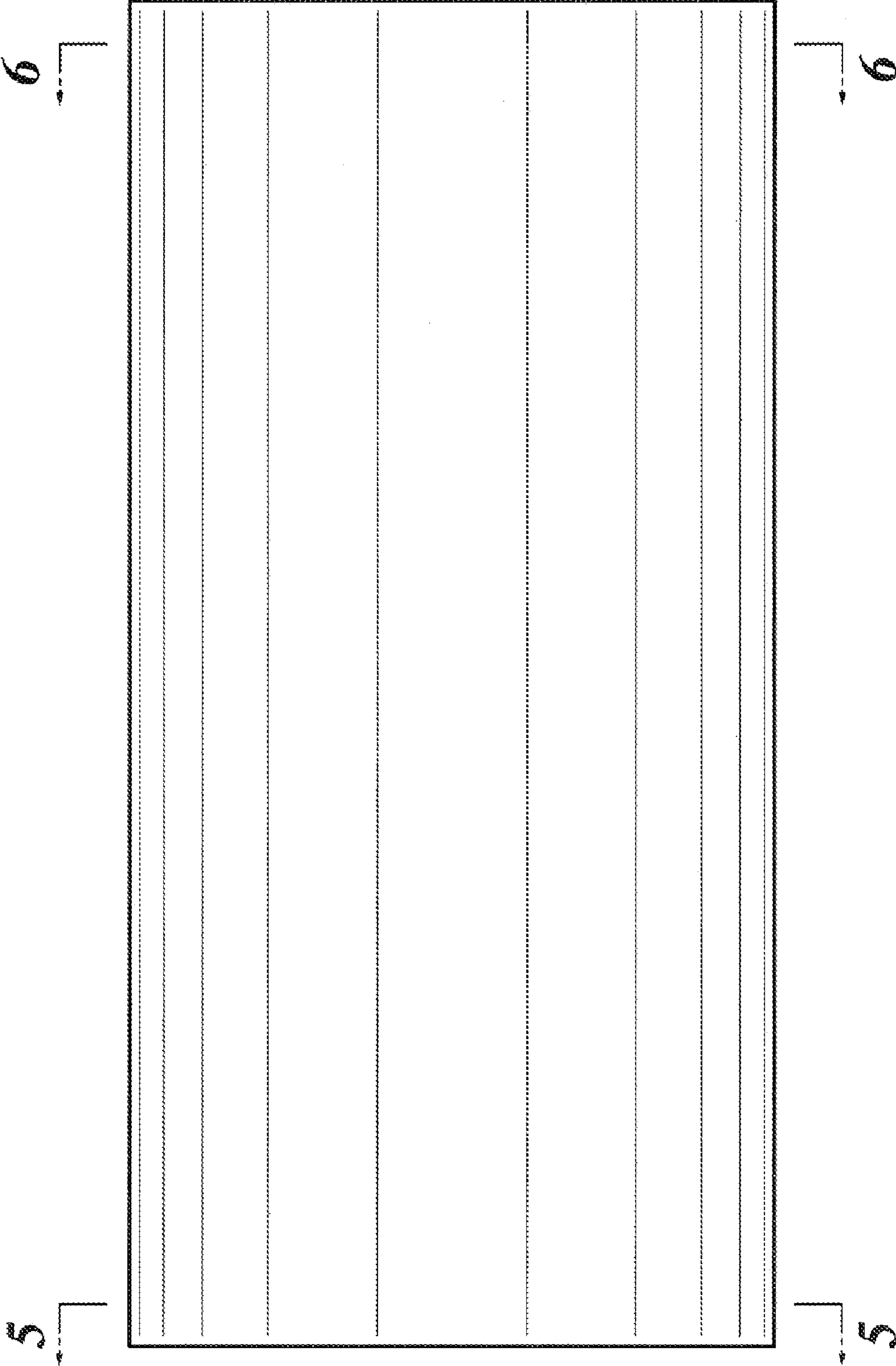

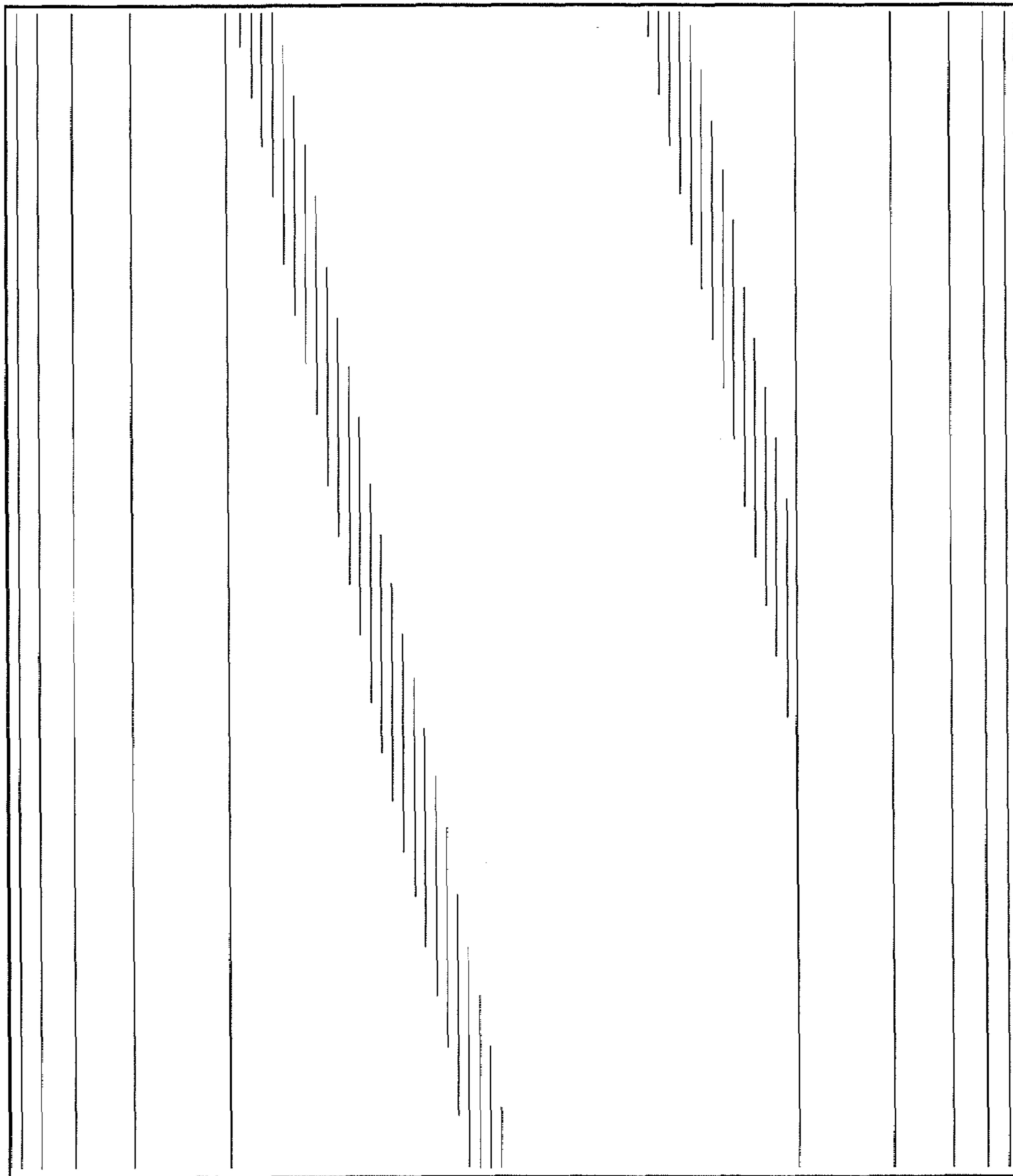

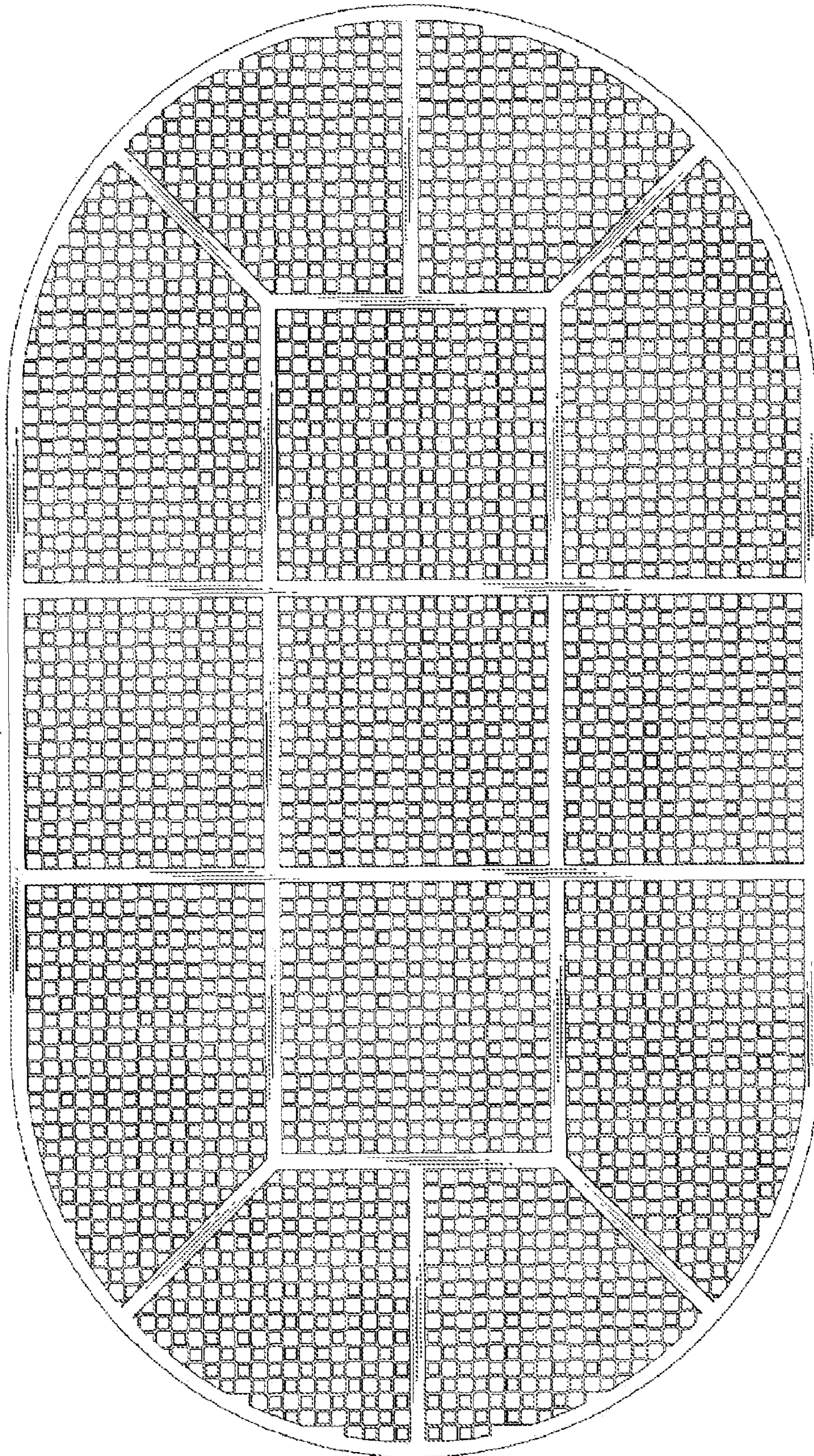

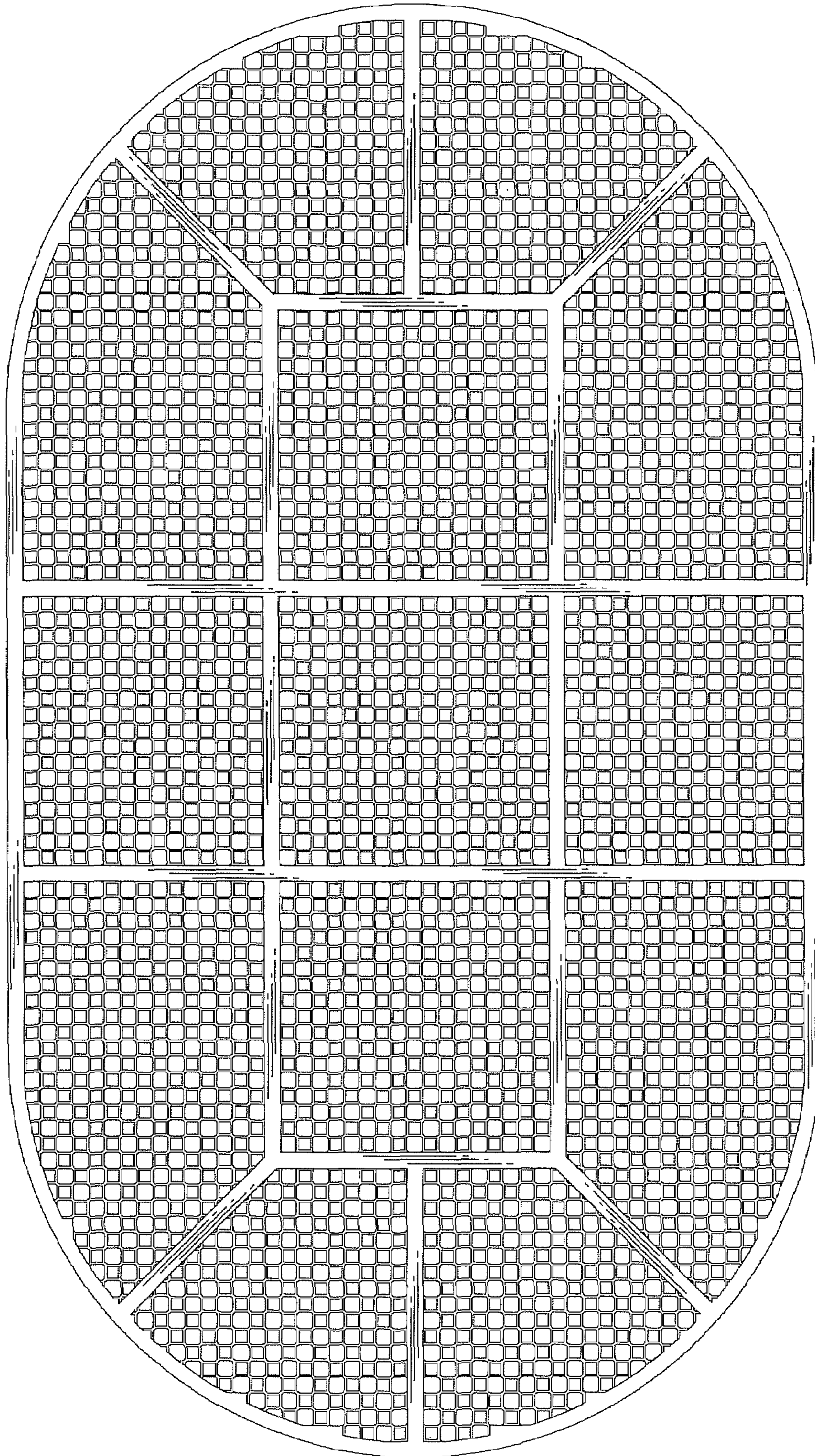

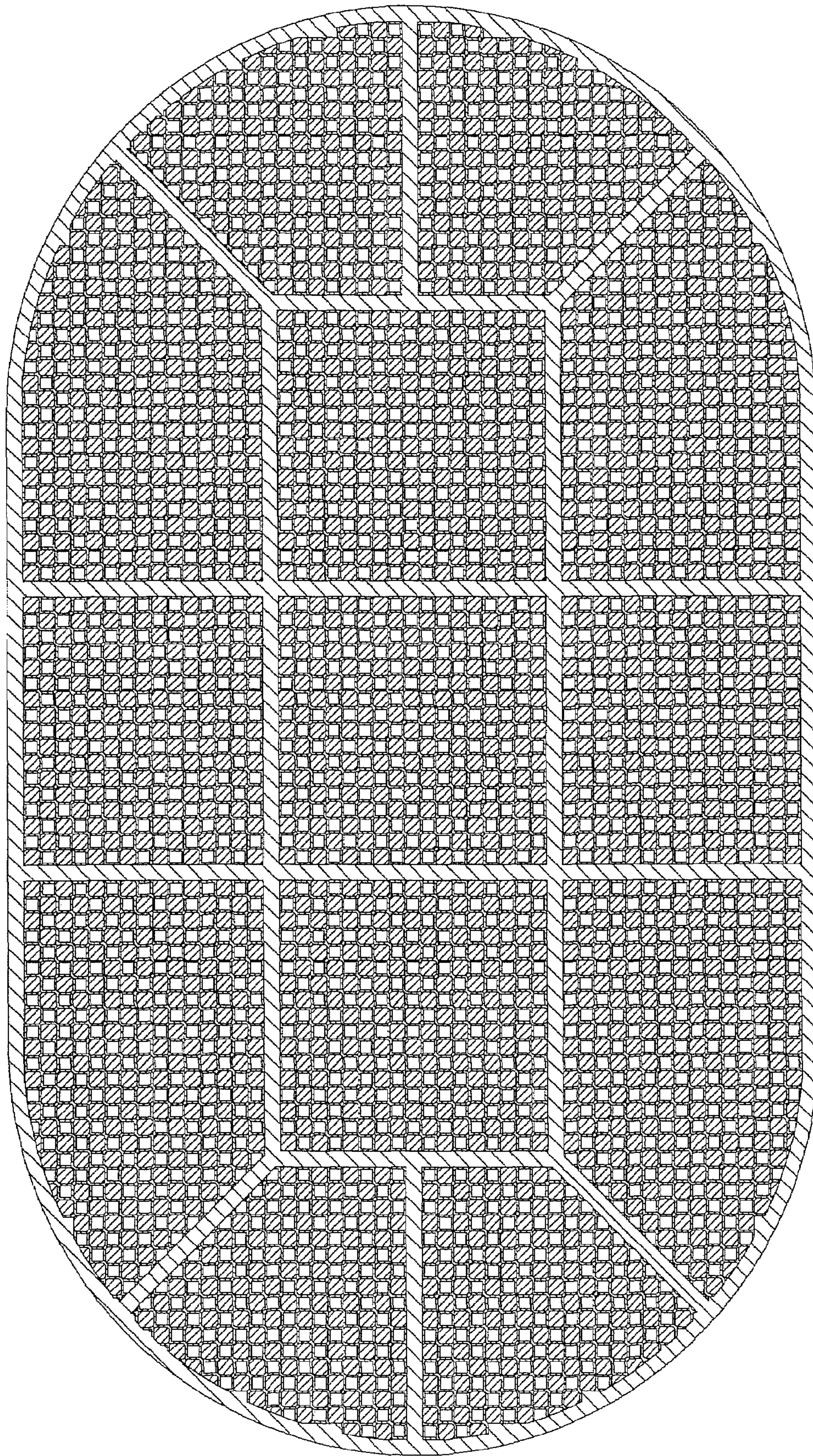

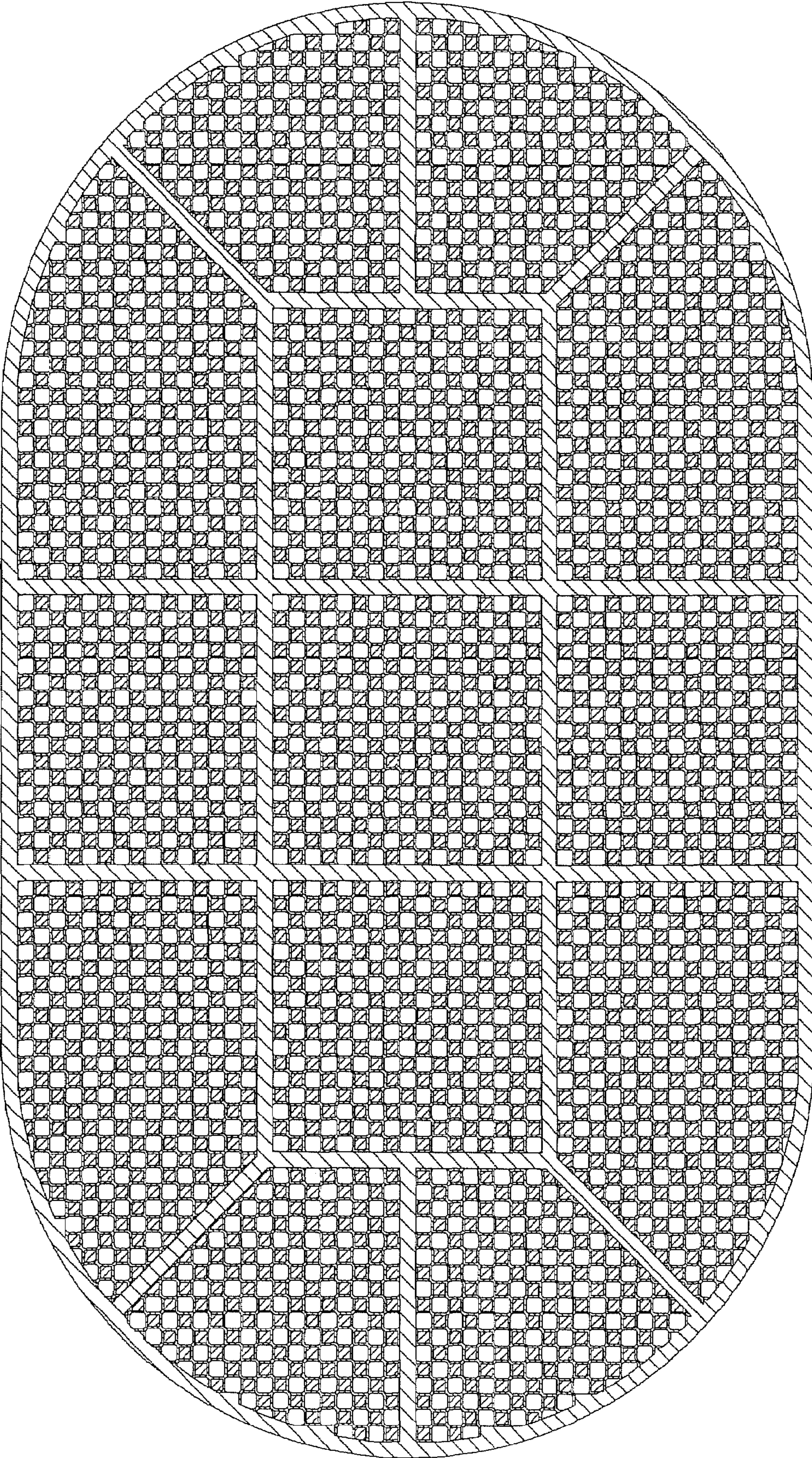
