FIG. 5 is a front elevation thereof;

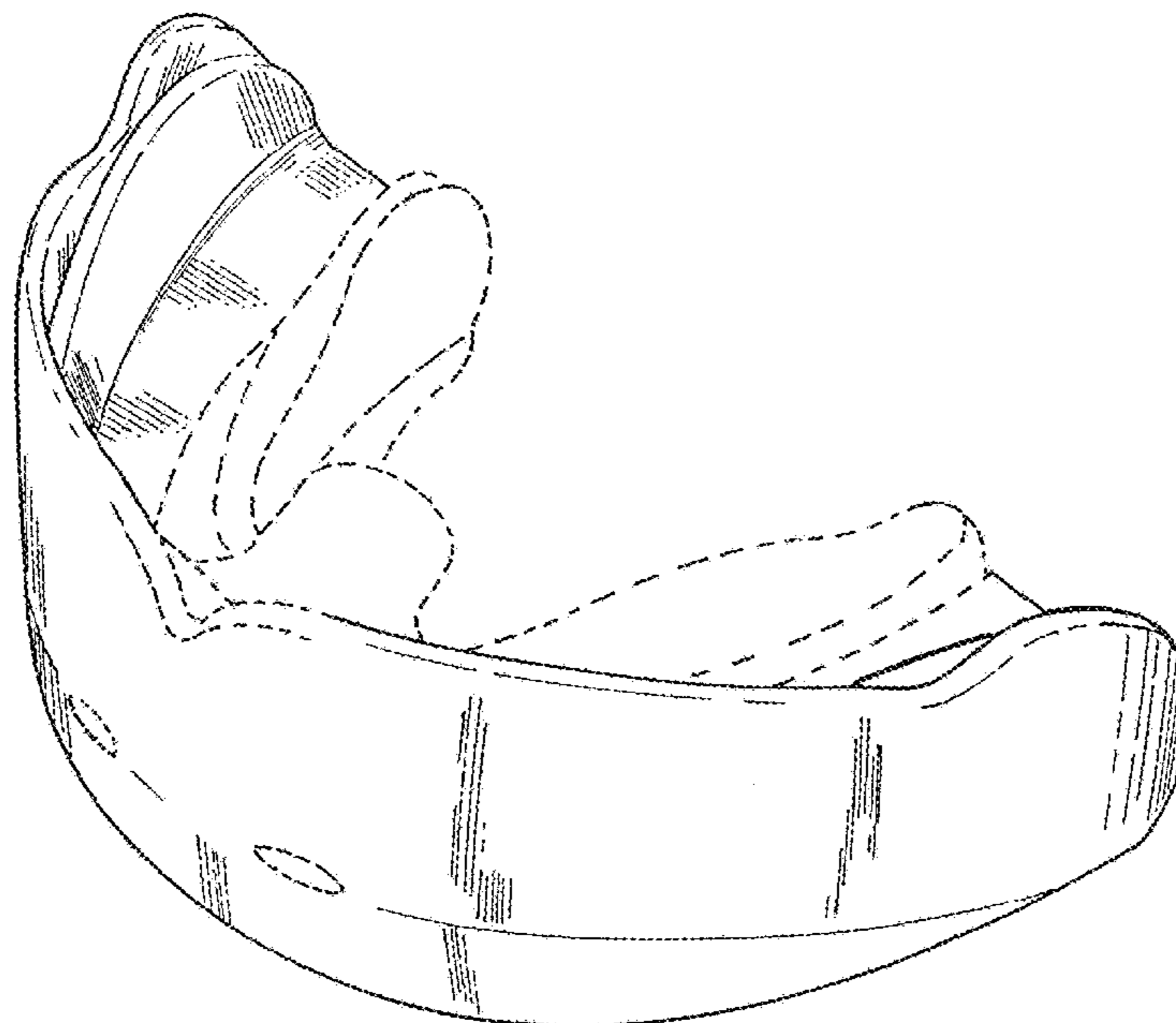
FIG. 6 is a rear elevation thereof;

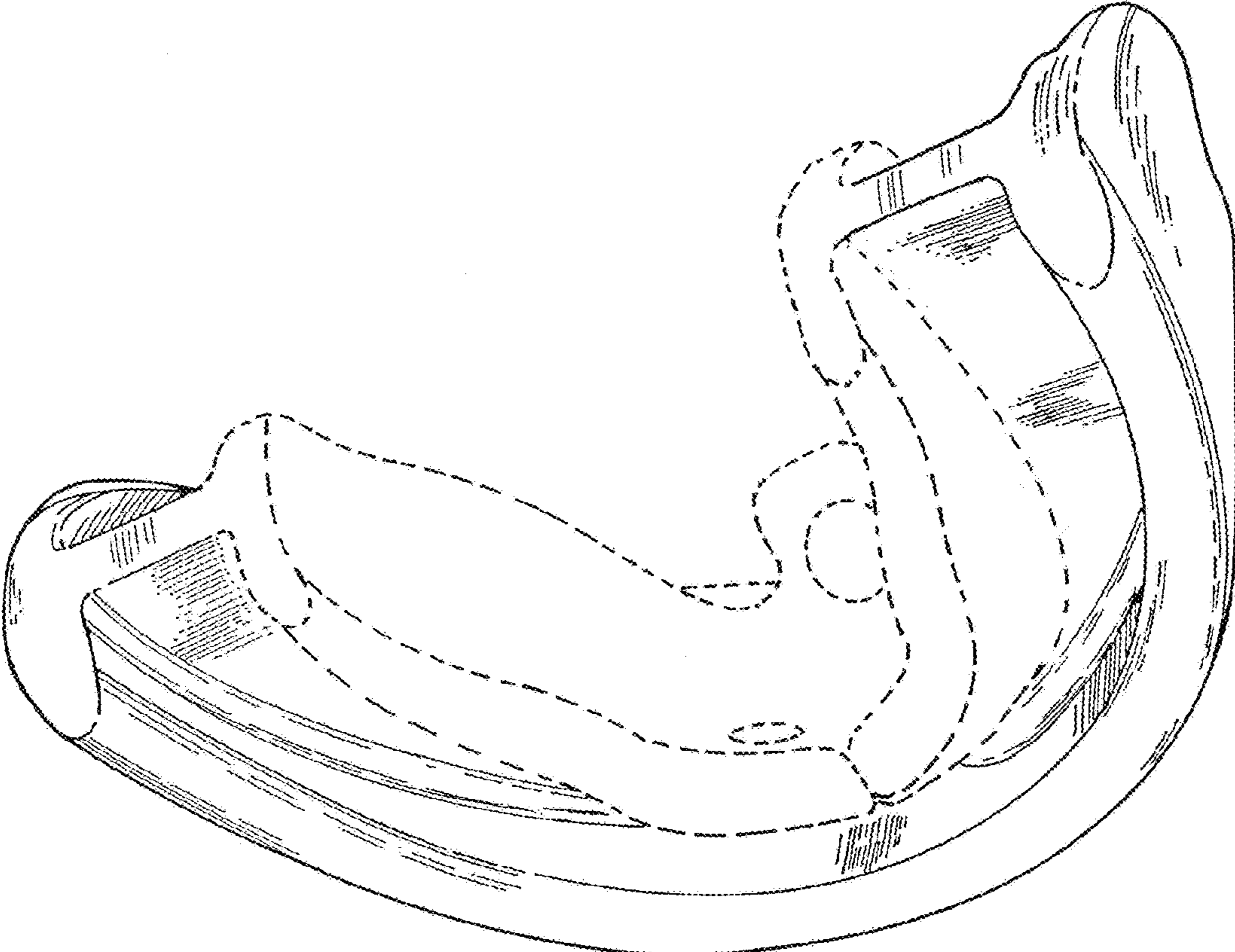

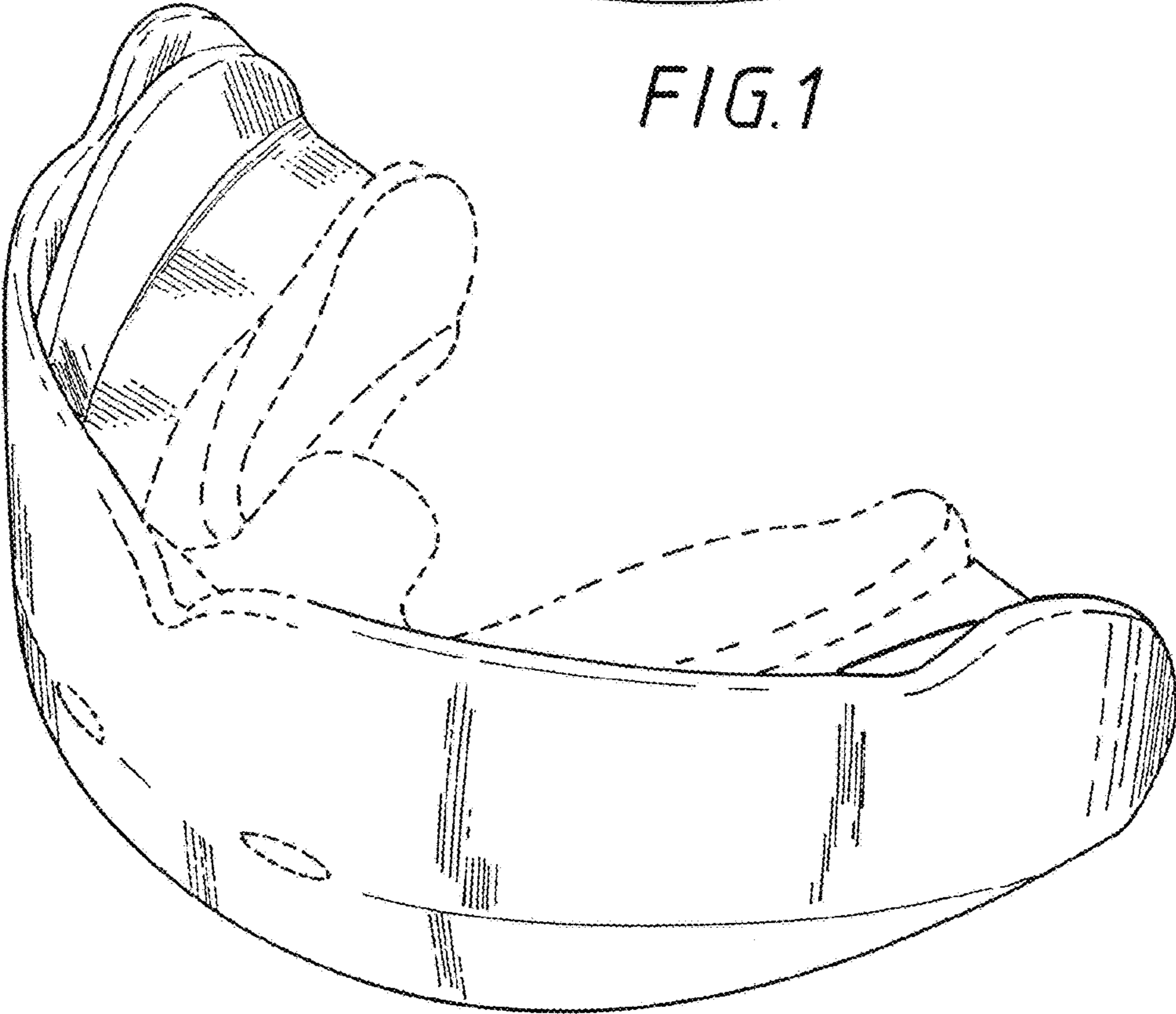

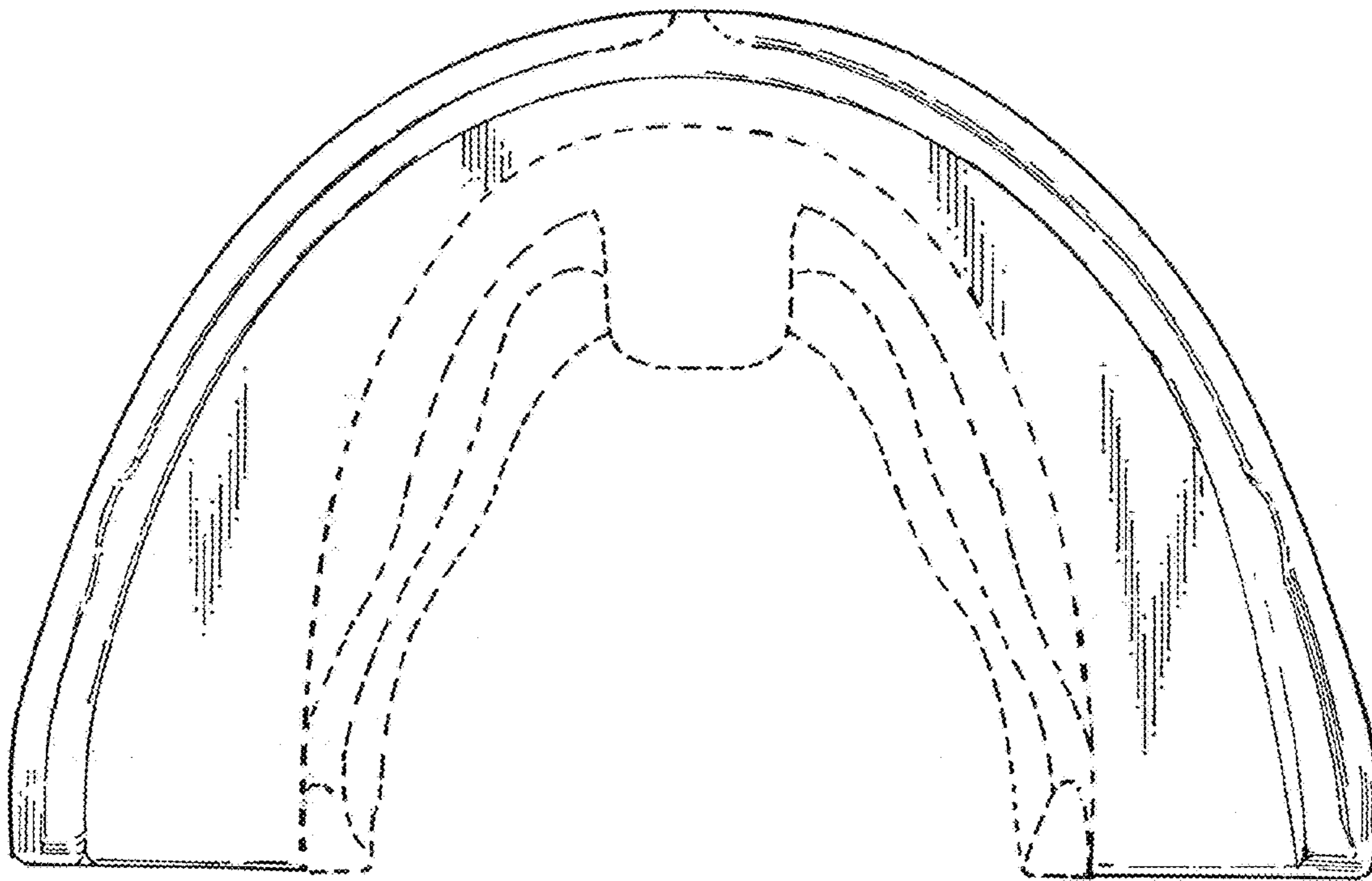

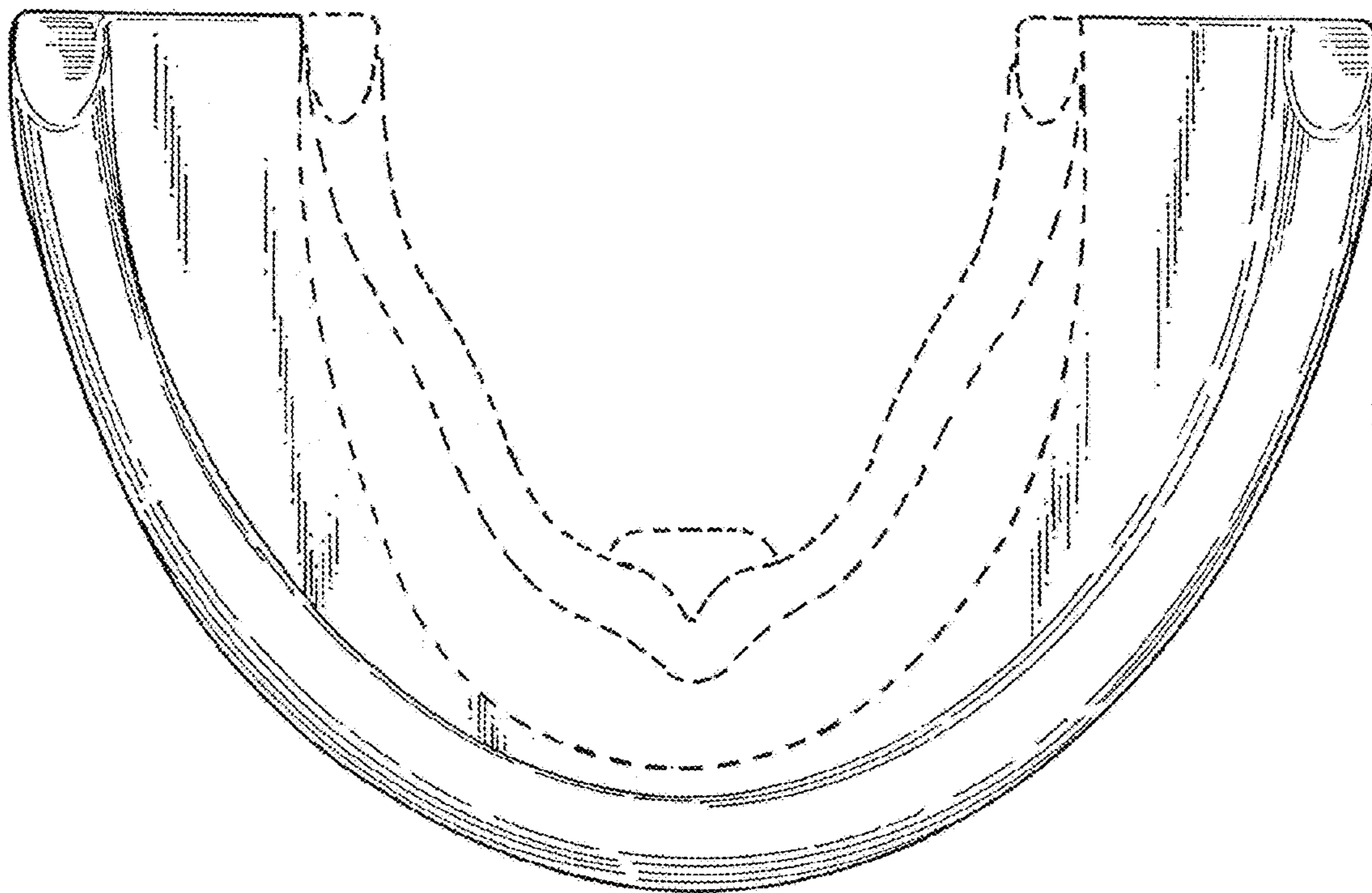

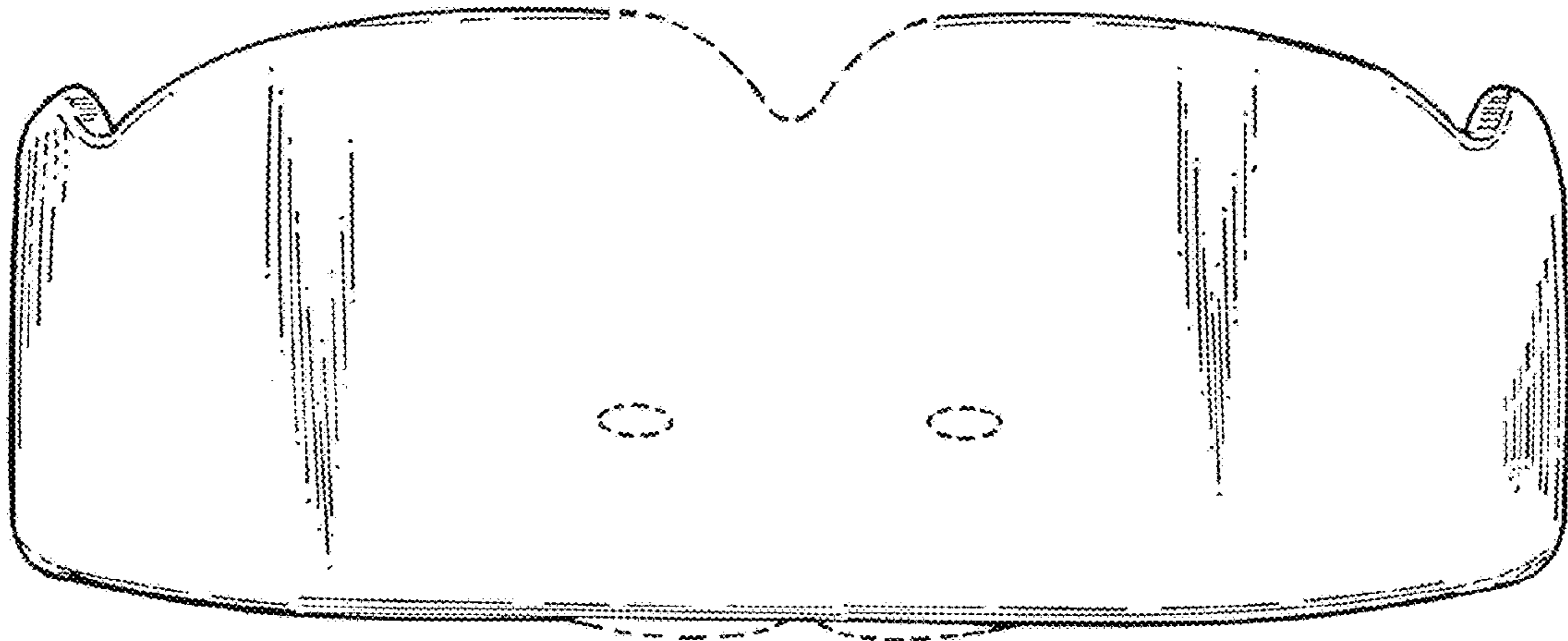

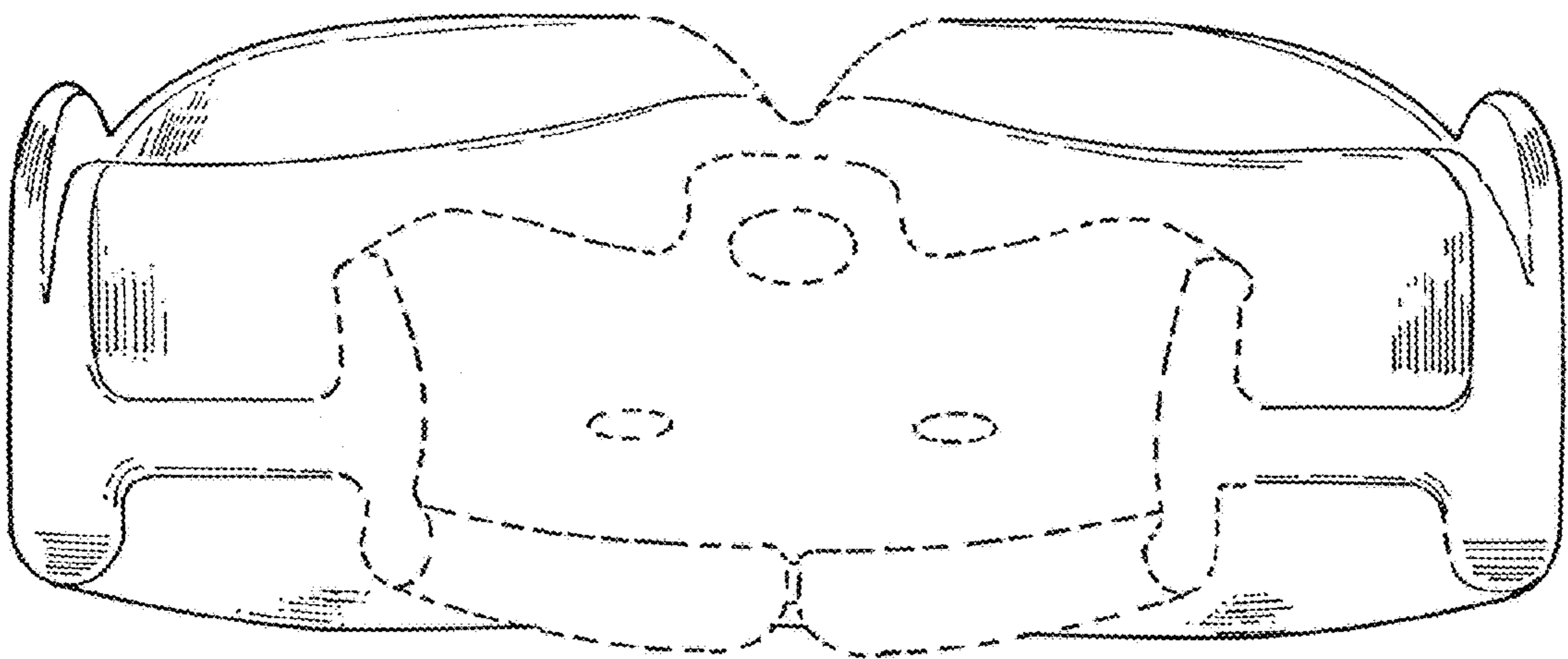

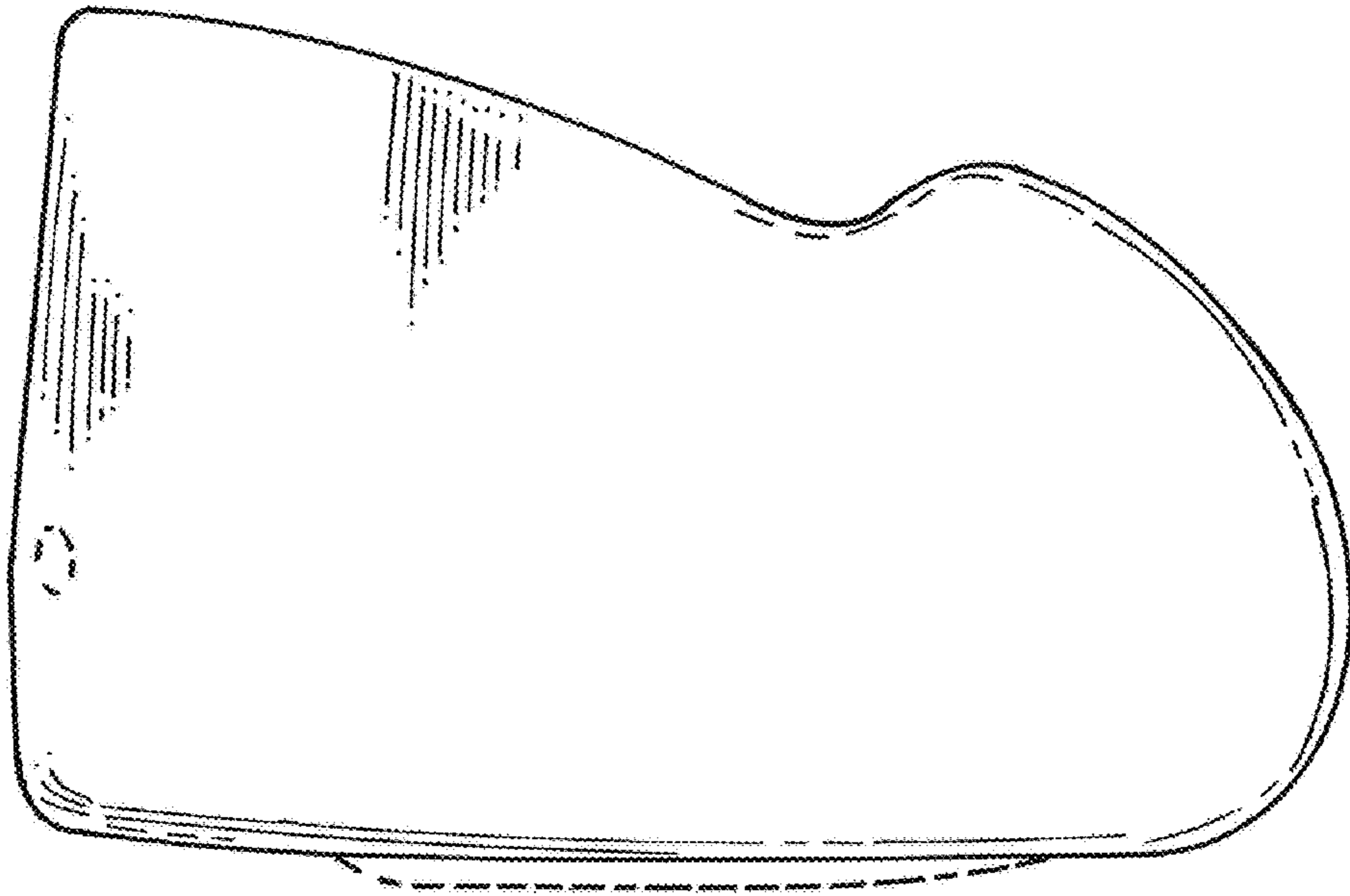

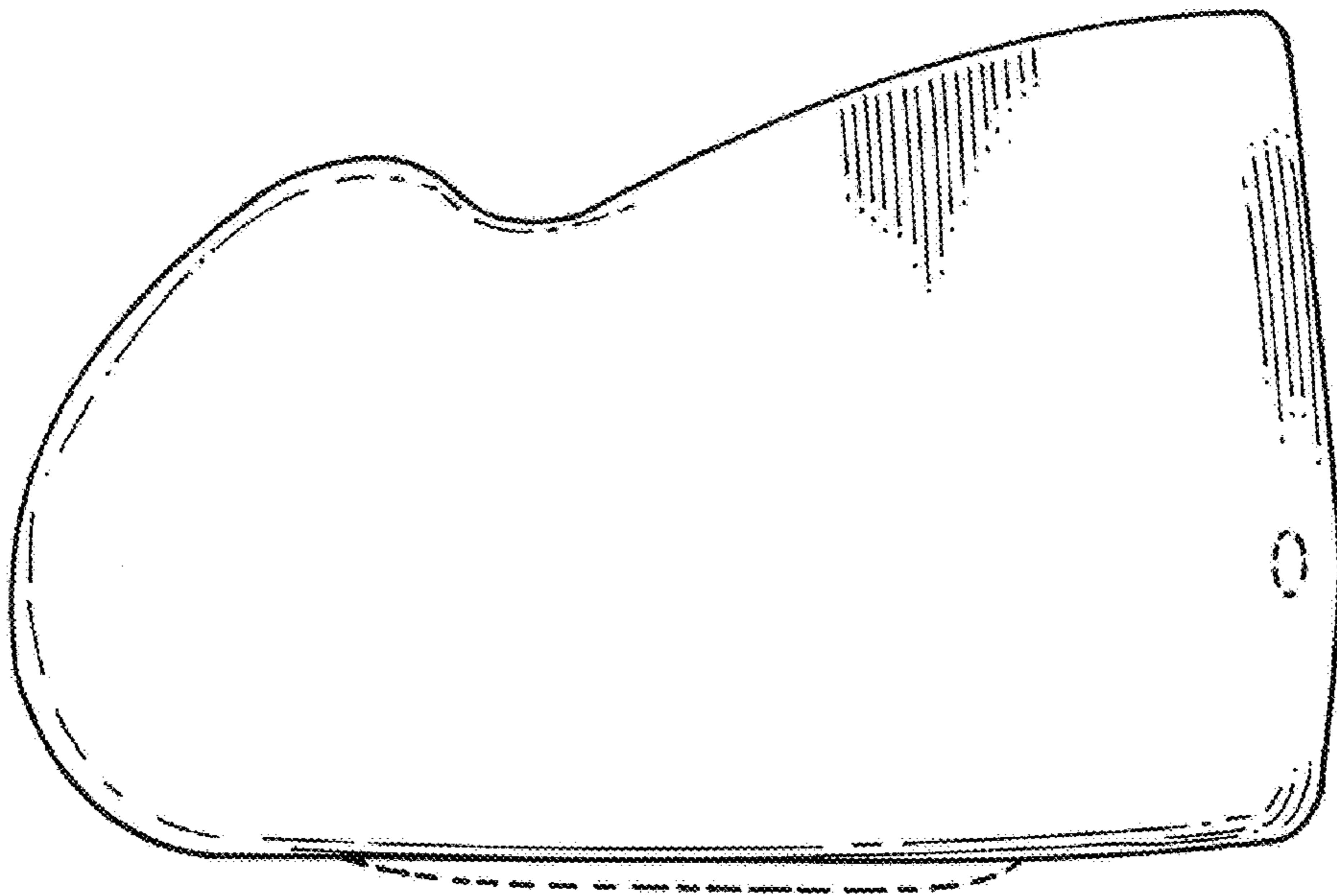
