FIG. 4 is a top plan view of the personal warming apparatus;

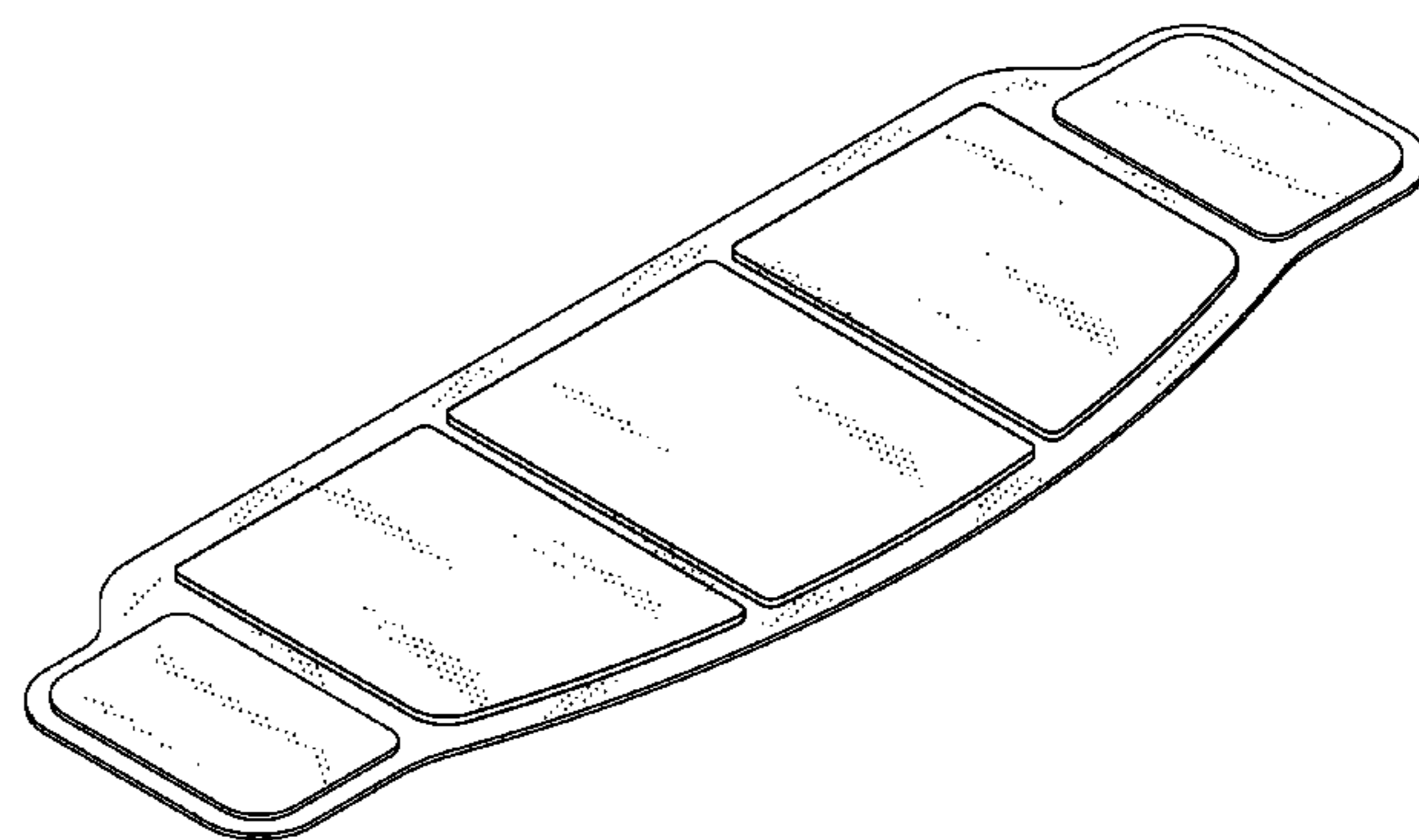
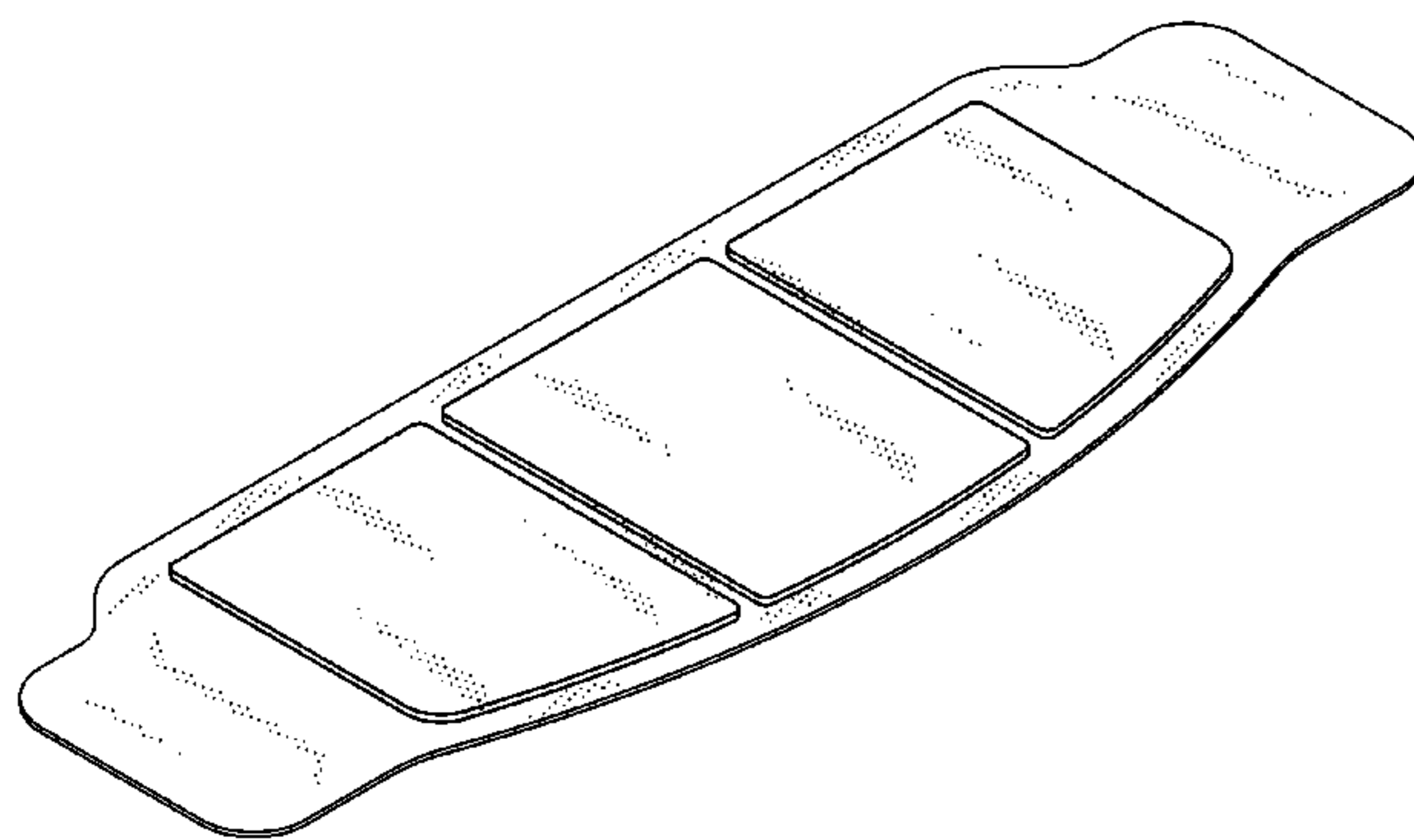
FIG. 5 is a rear elevational view of the personal warming apparatus;

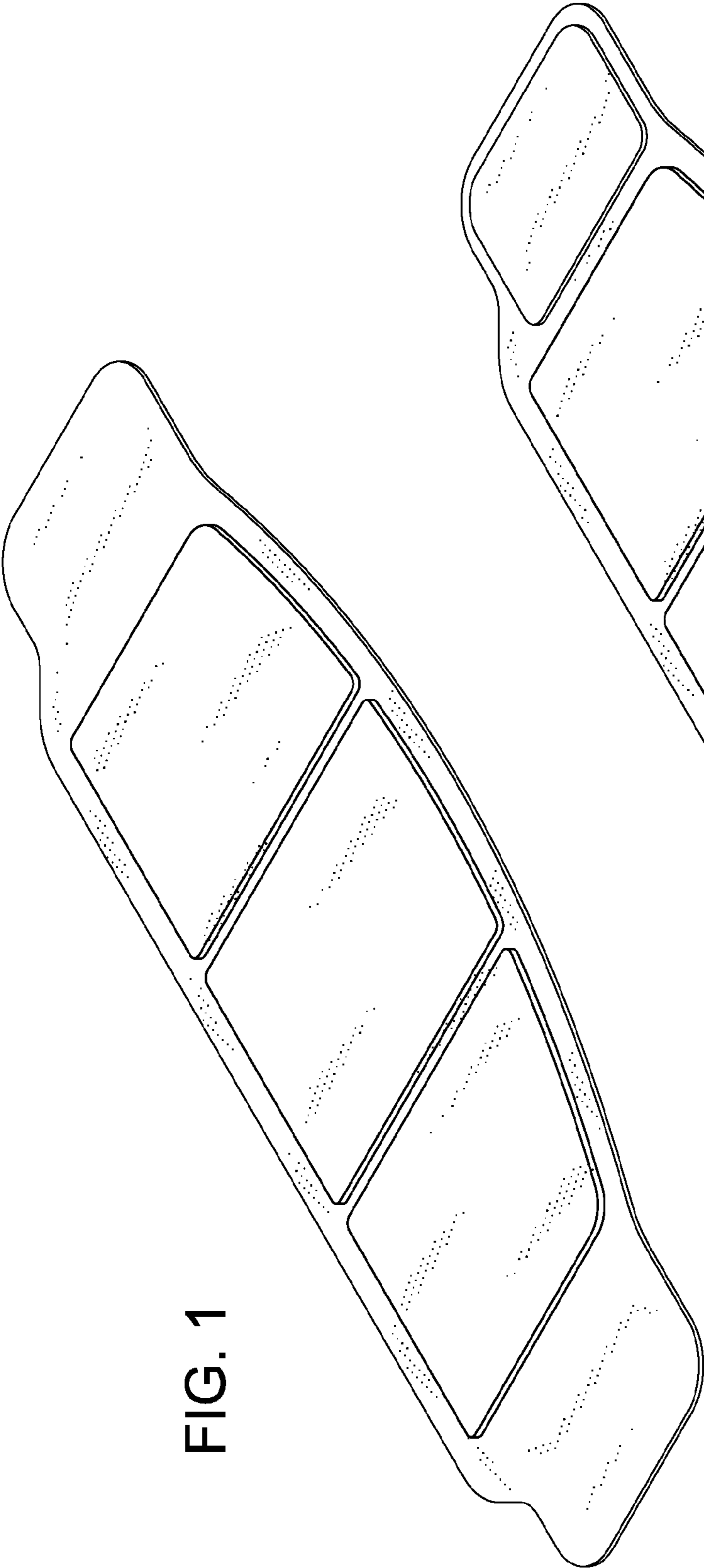

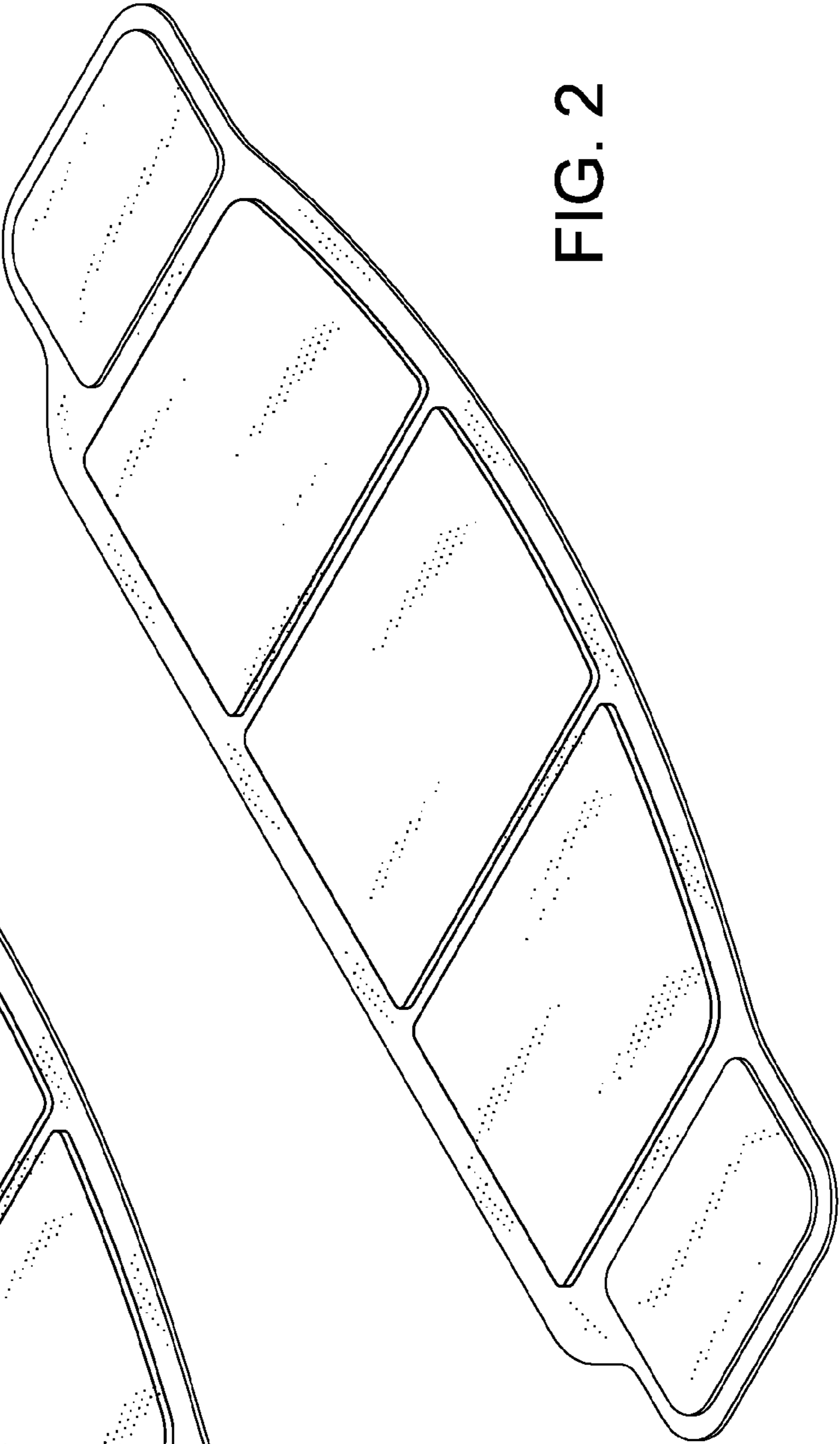

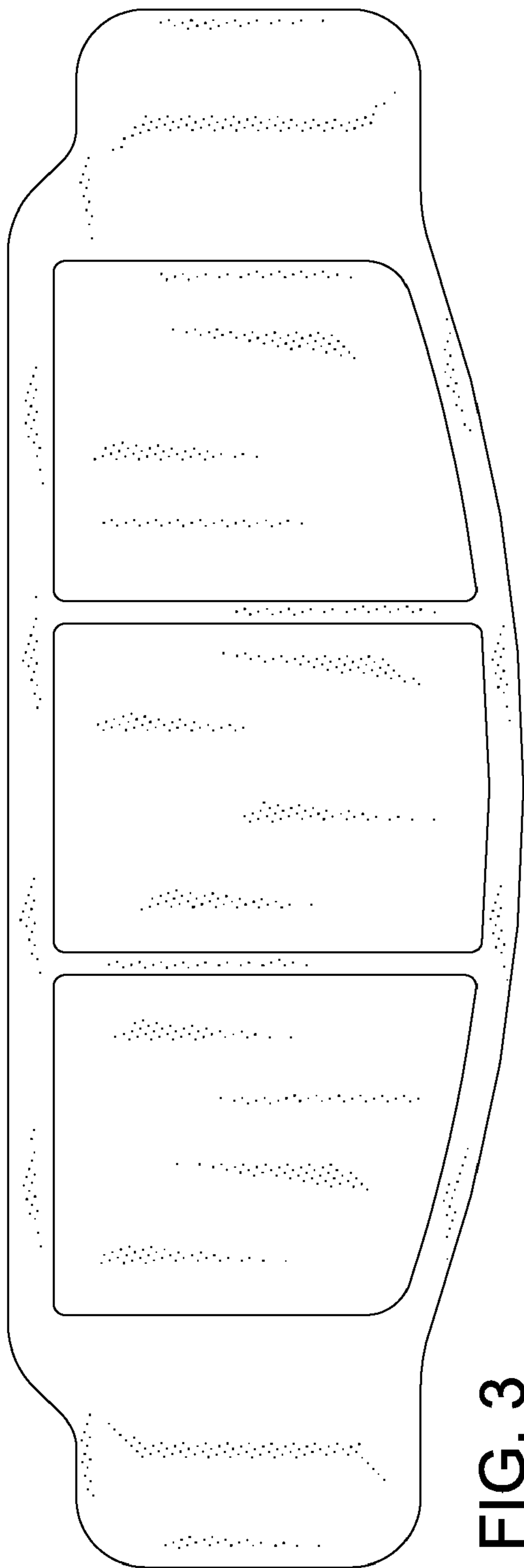

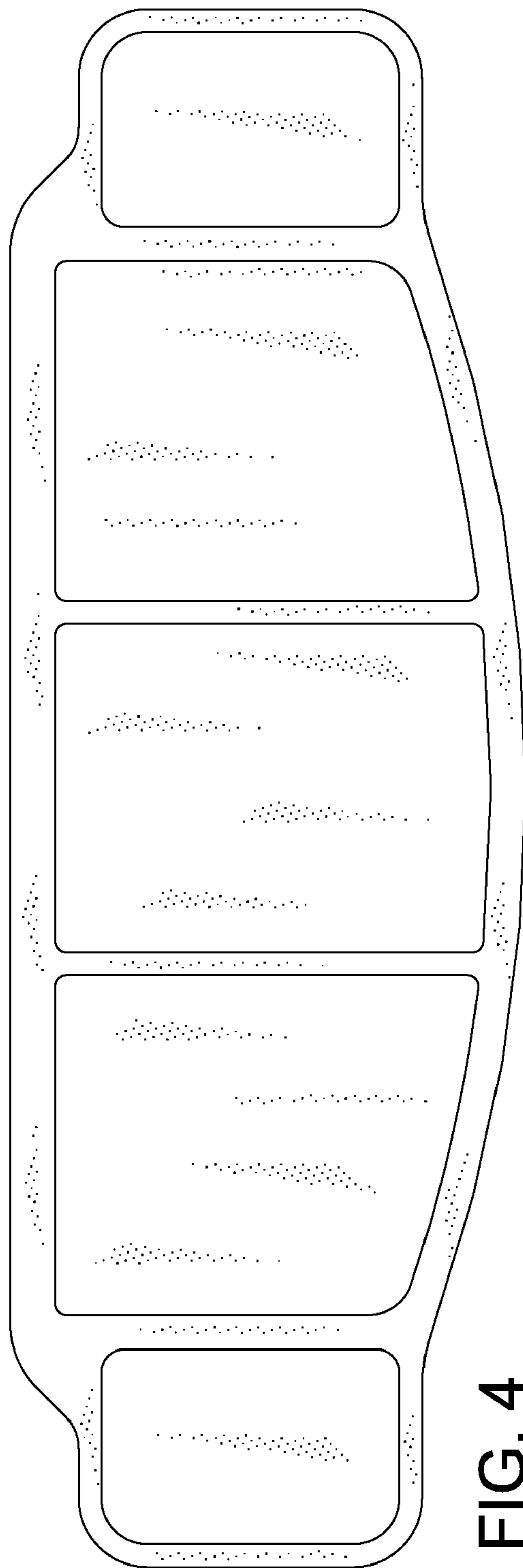

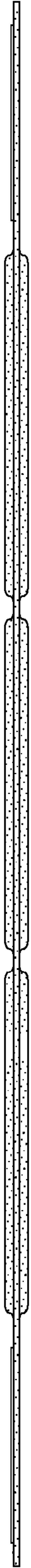
