FIG. 11 is a front view of the design of FIG. 7; and,

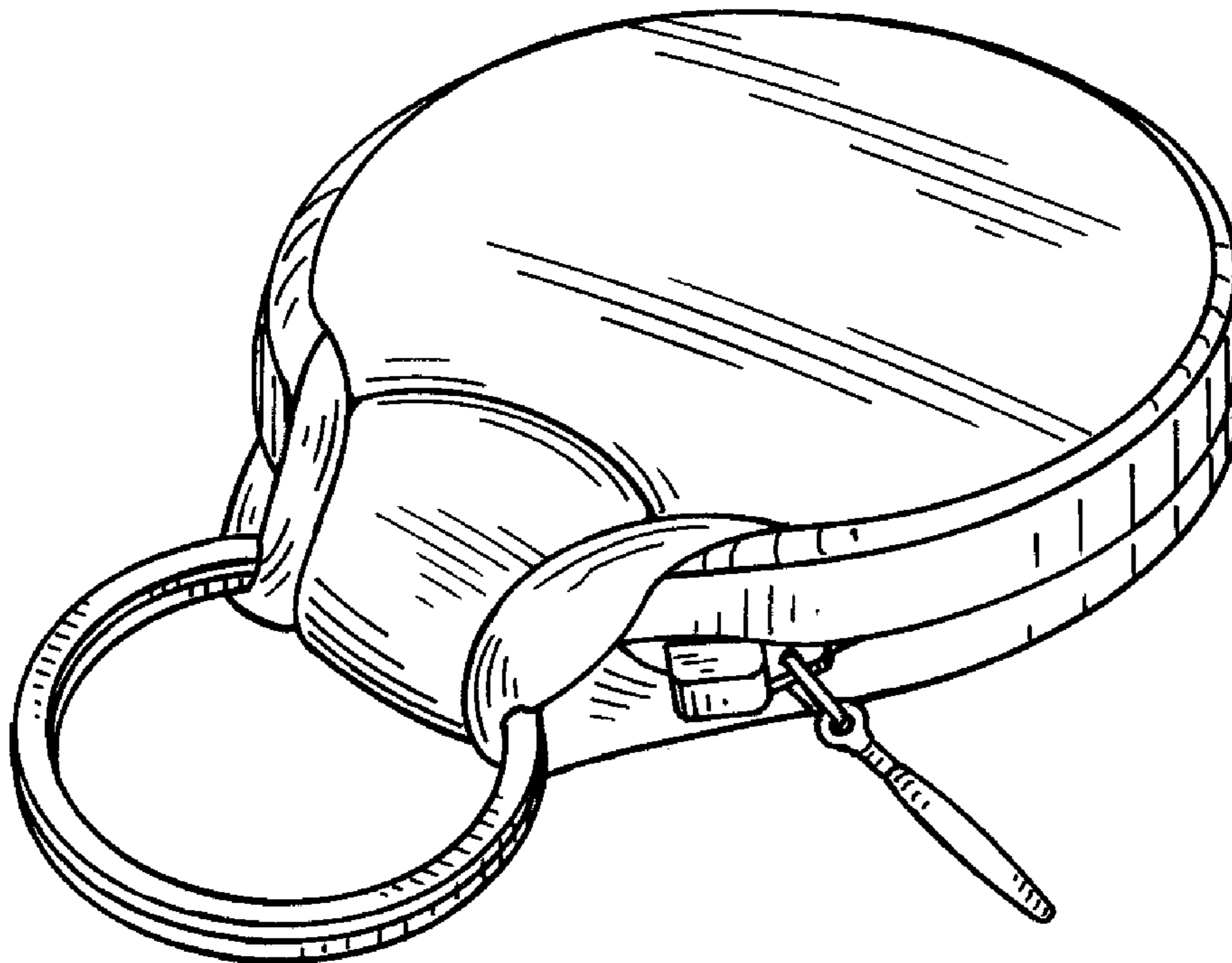
FIG. 12 is a rear view of the design of FIG. 7.

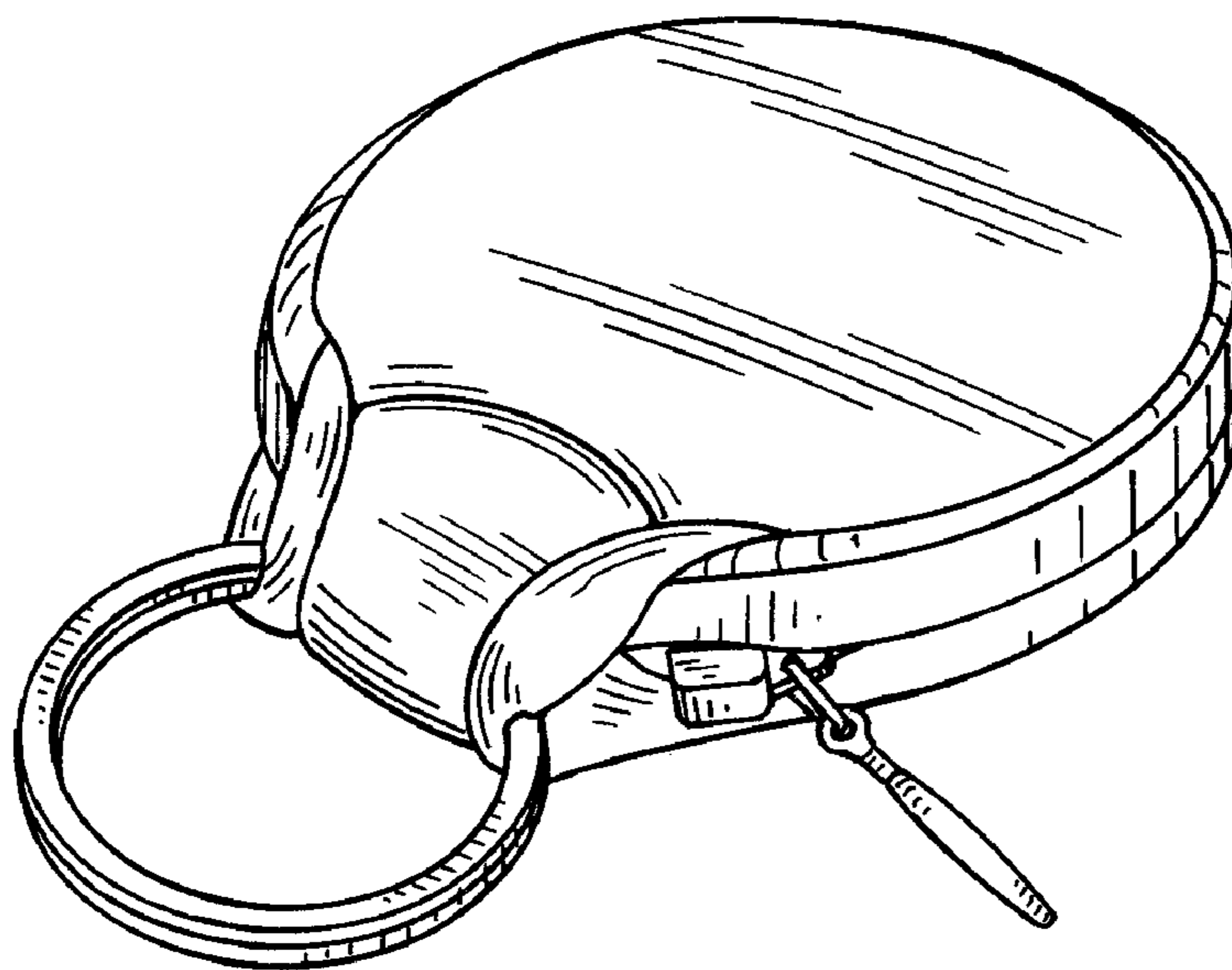

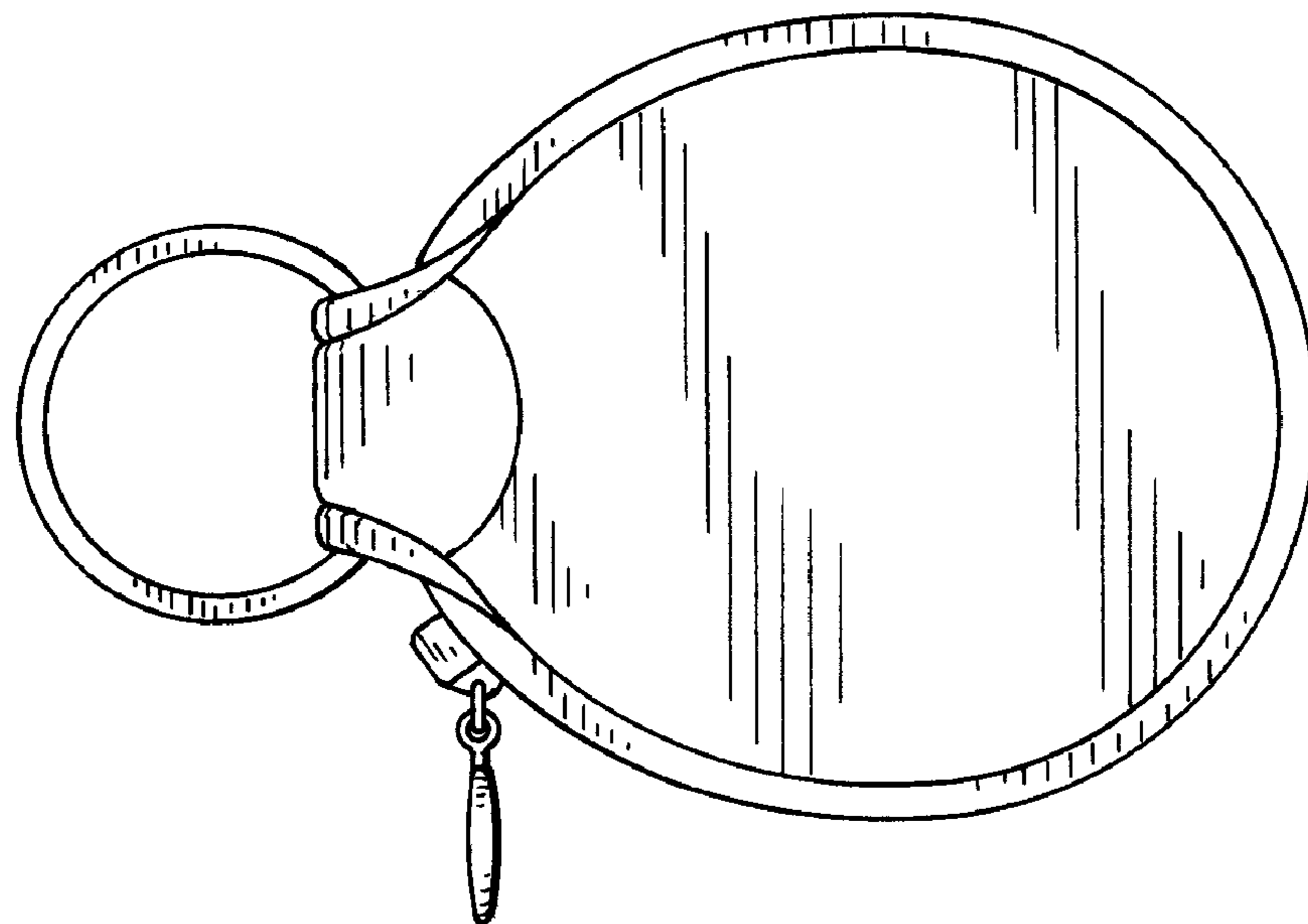

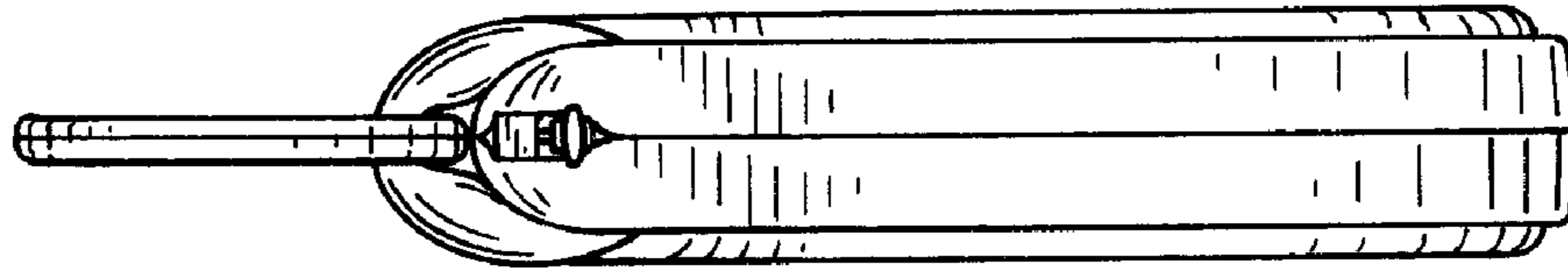

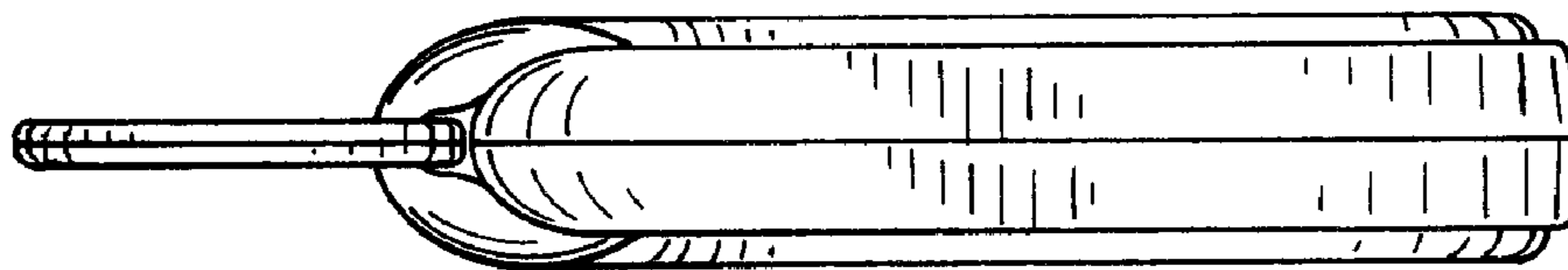

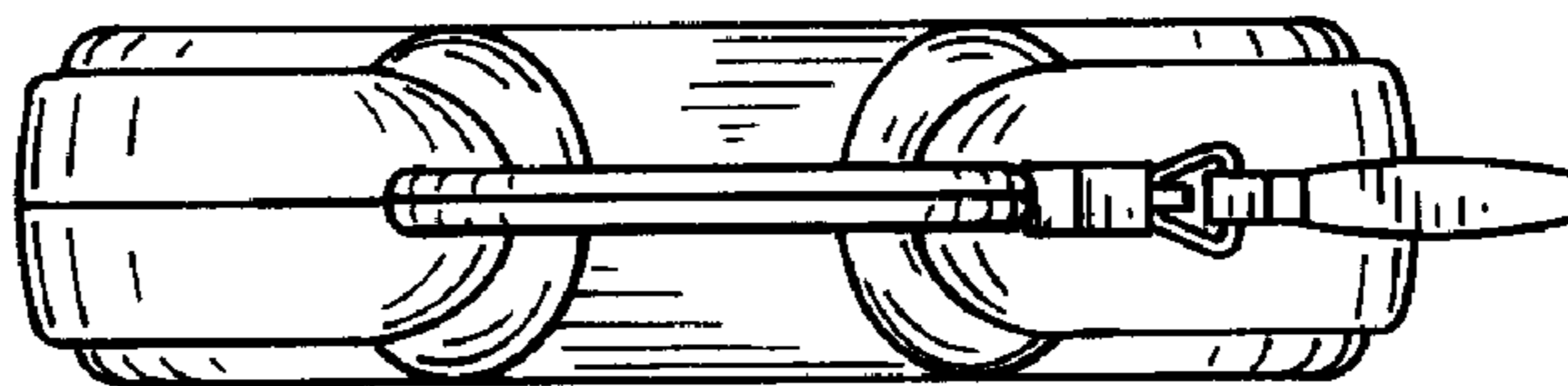

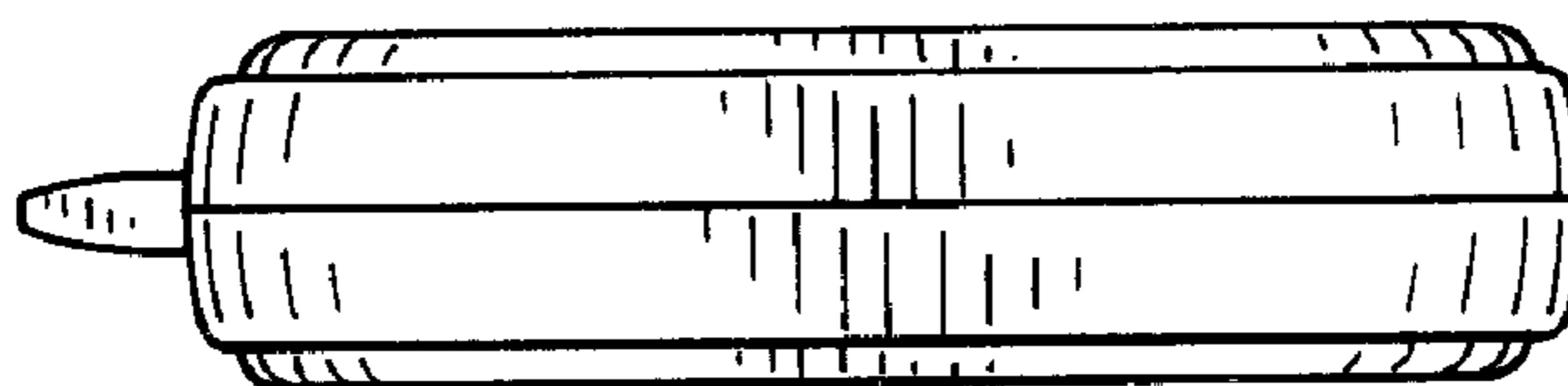

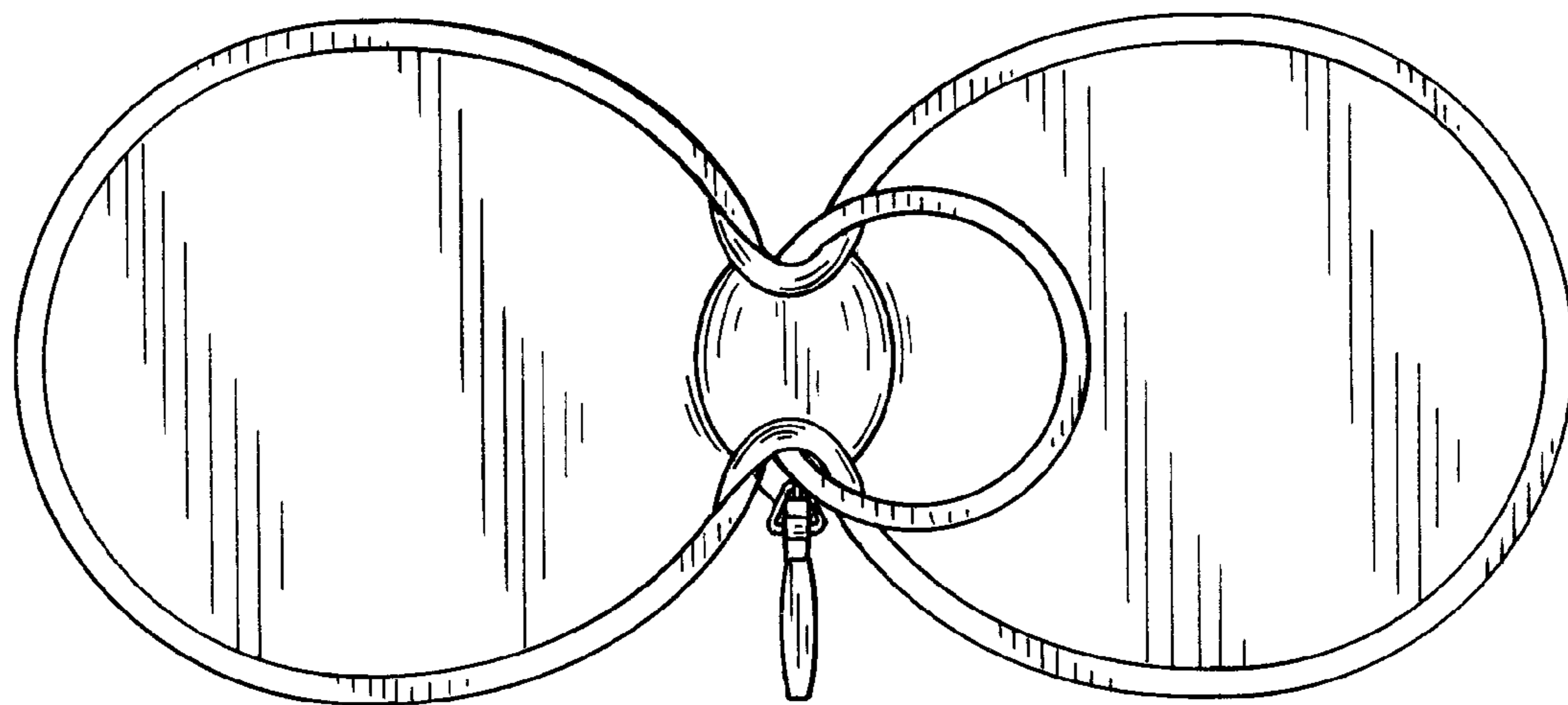

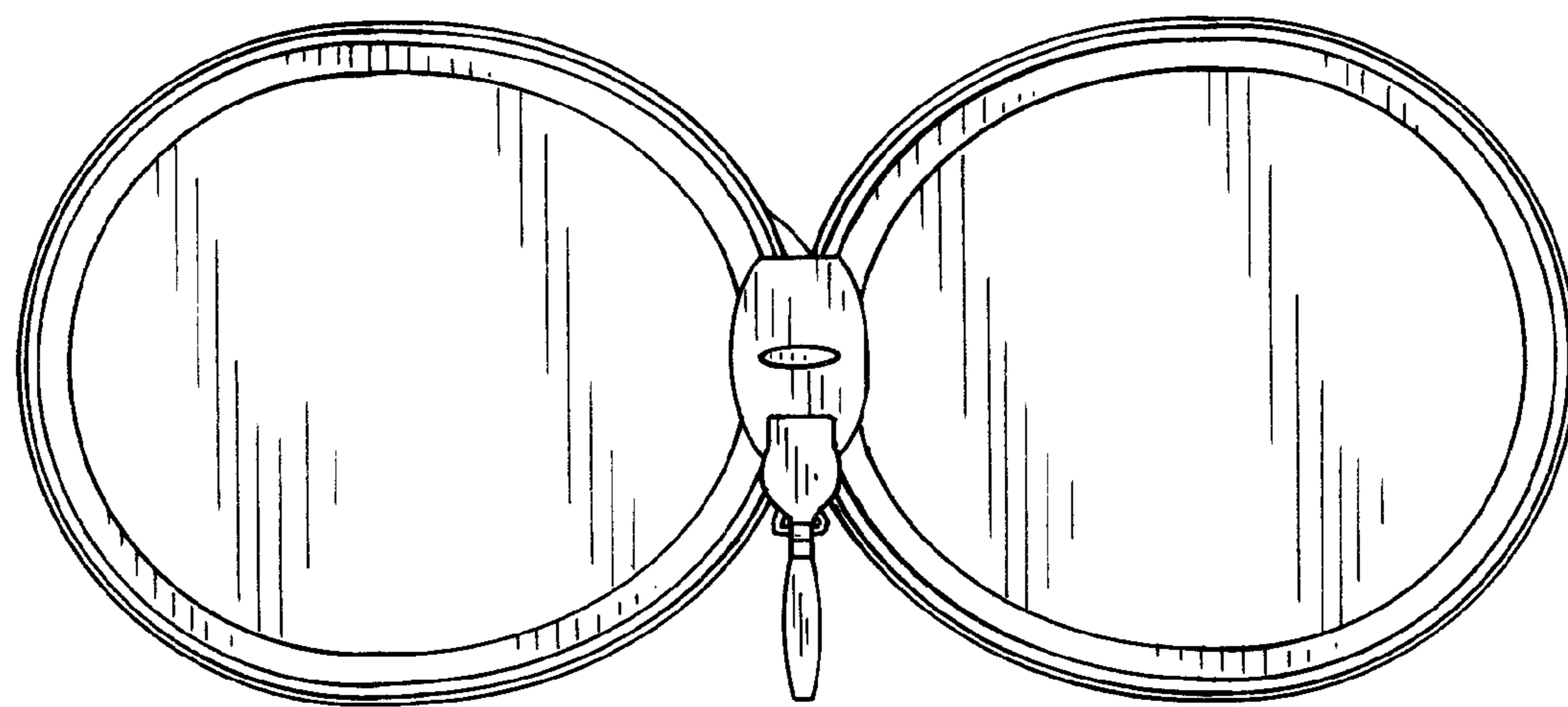

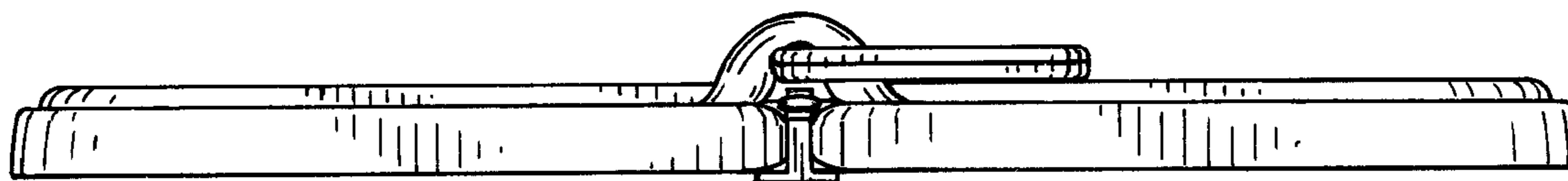

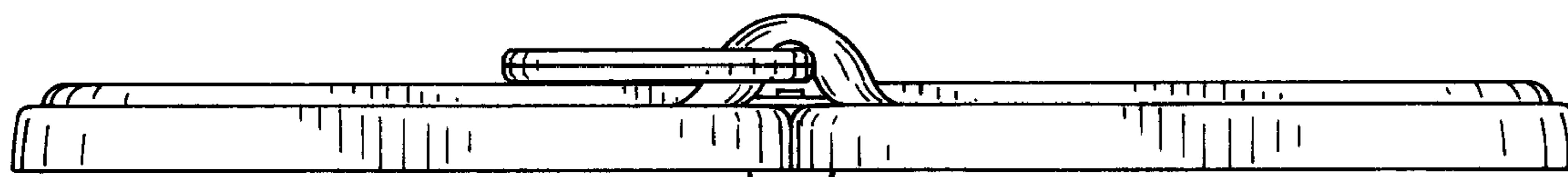

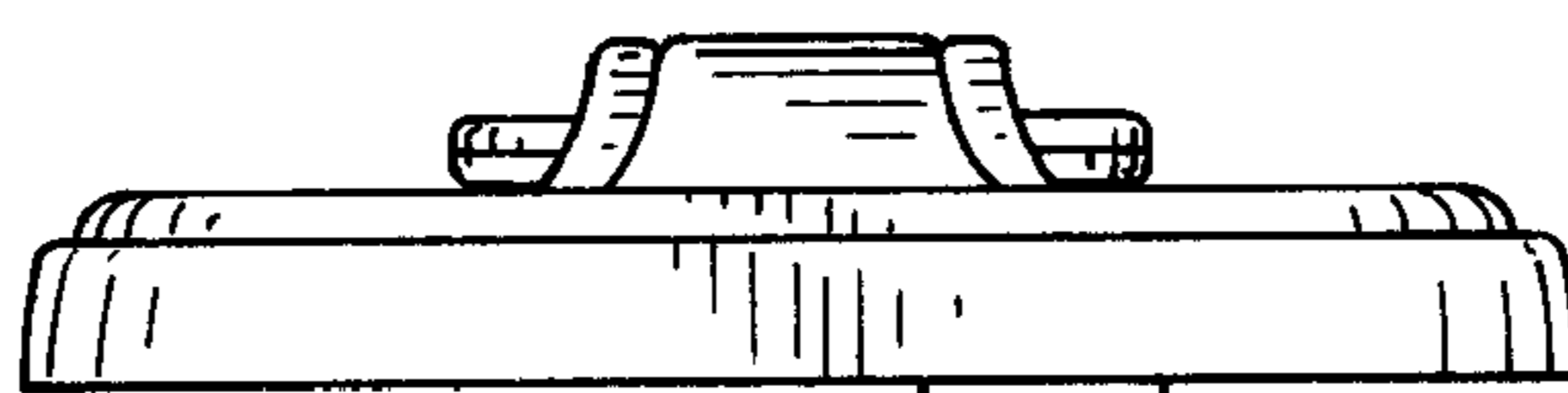

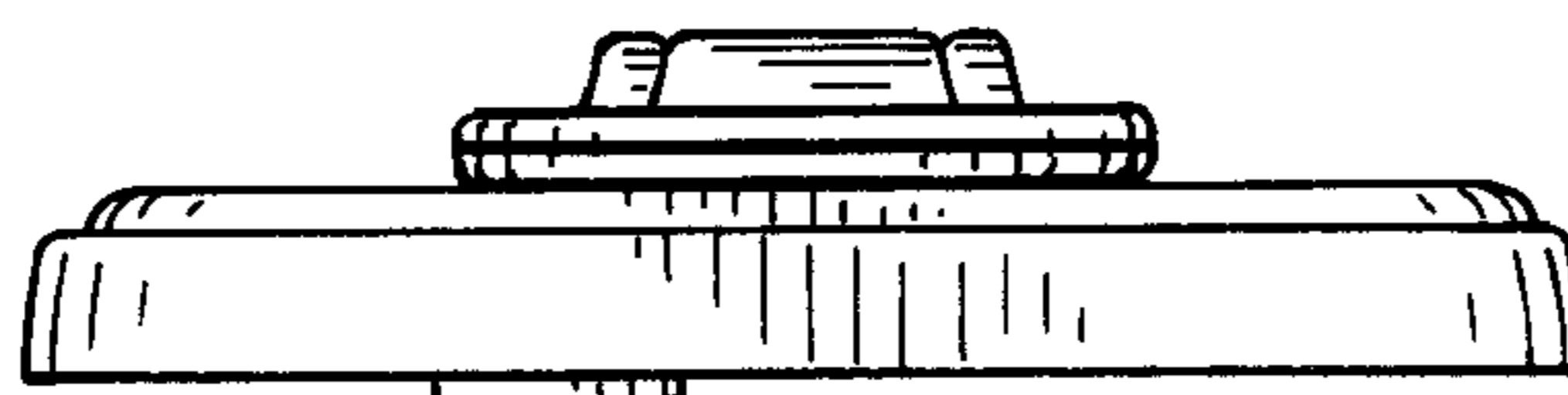
