**DESCRIPTION**

FIG. 1 is a front side perspective view of my insulated jug;

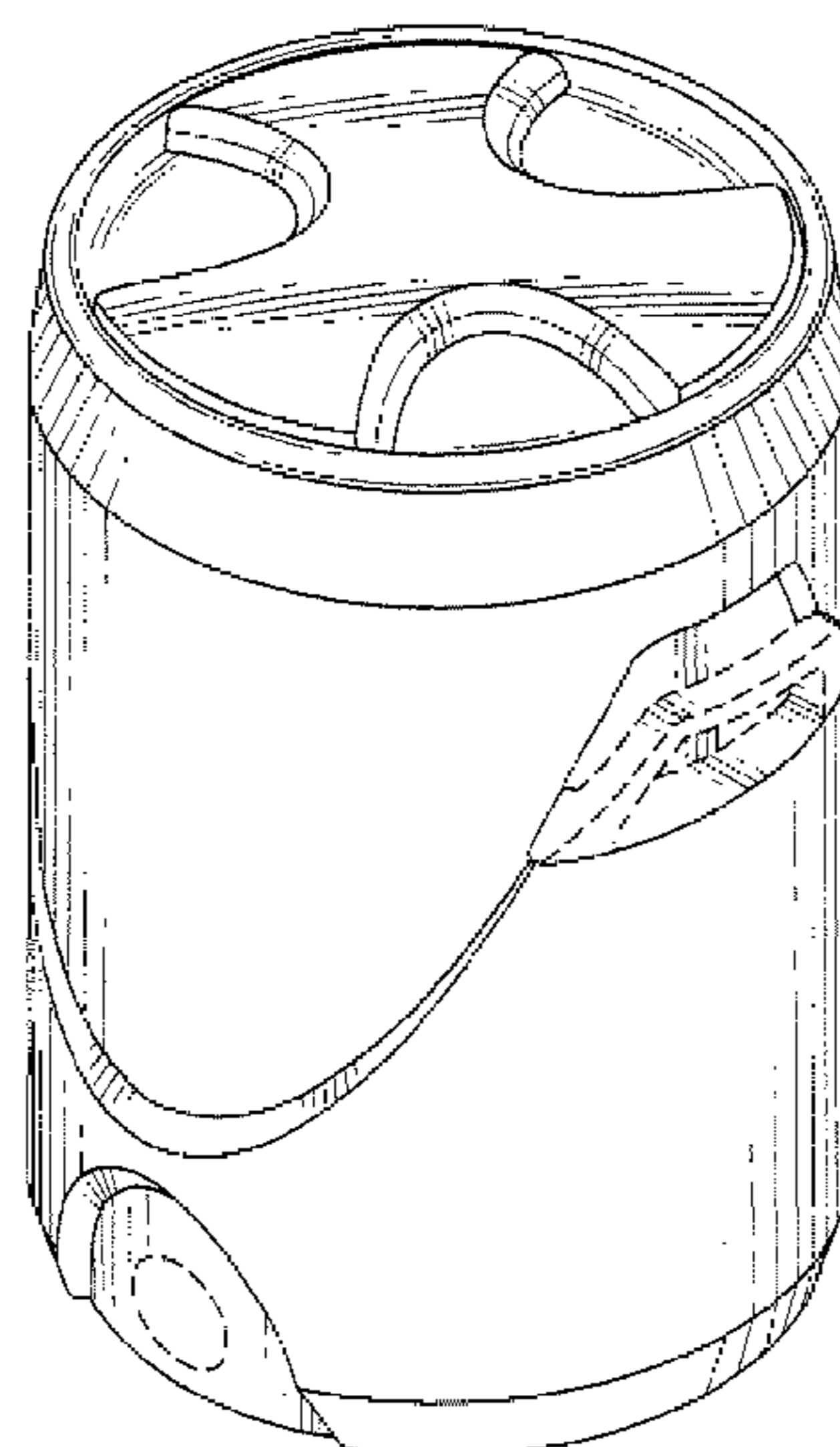

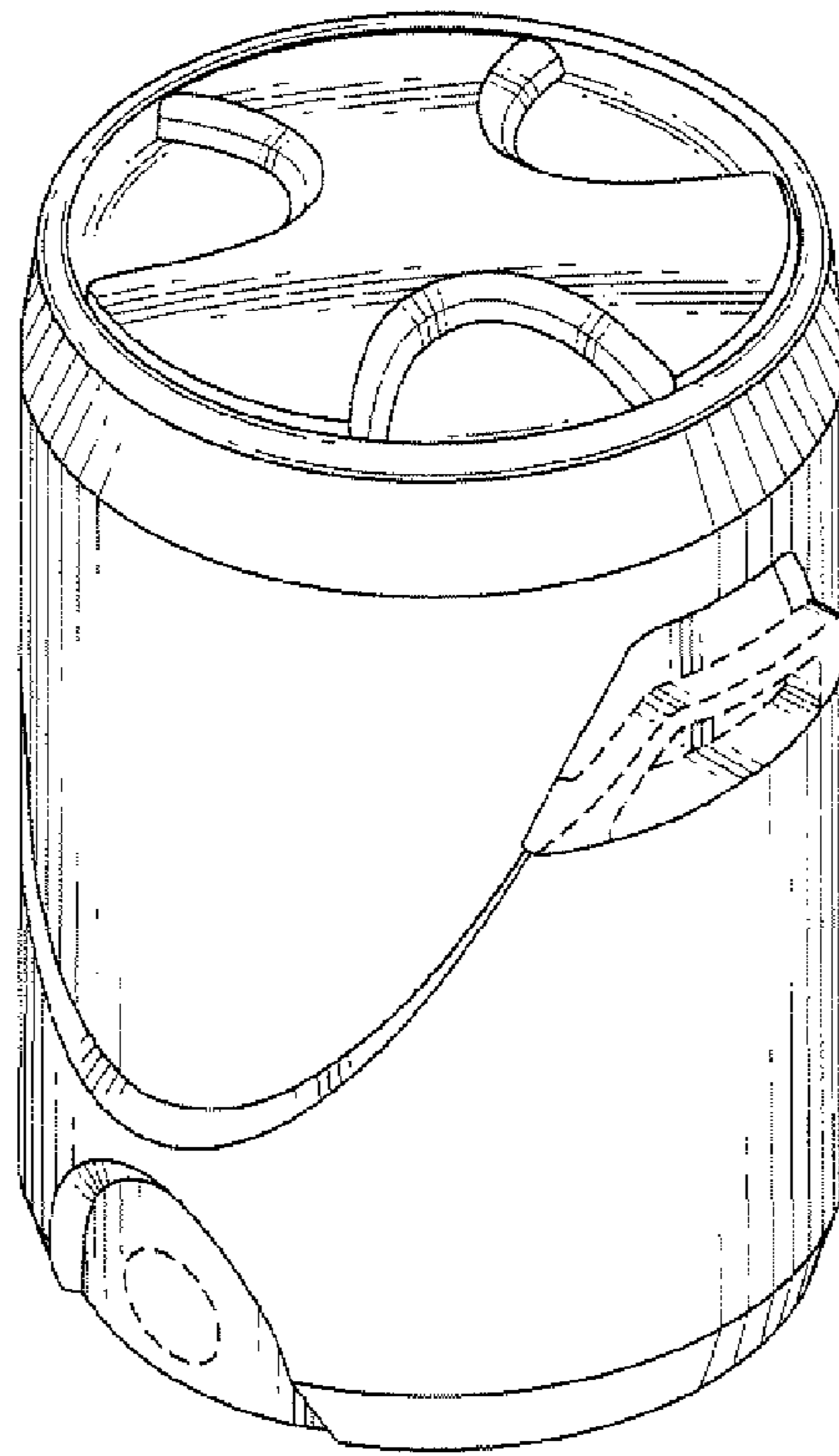

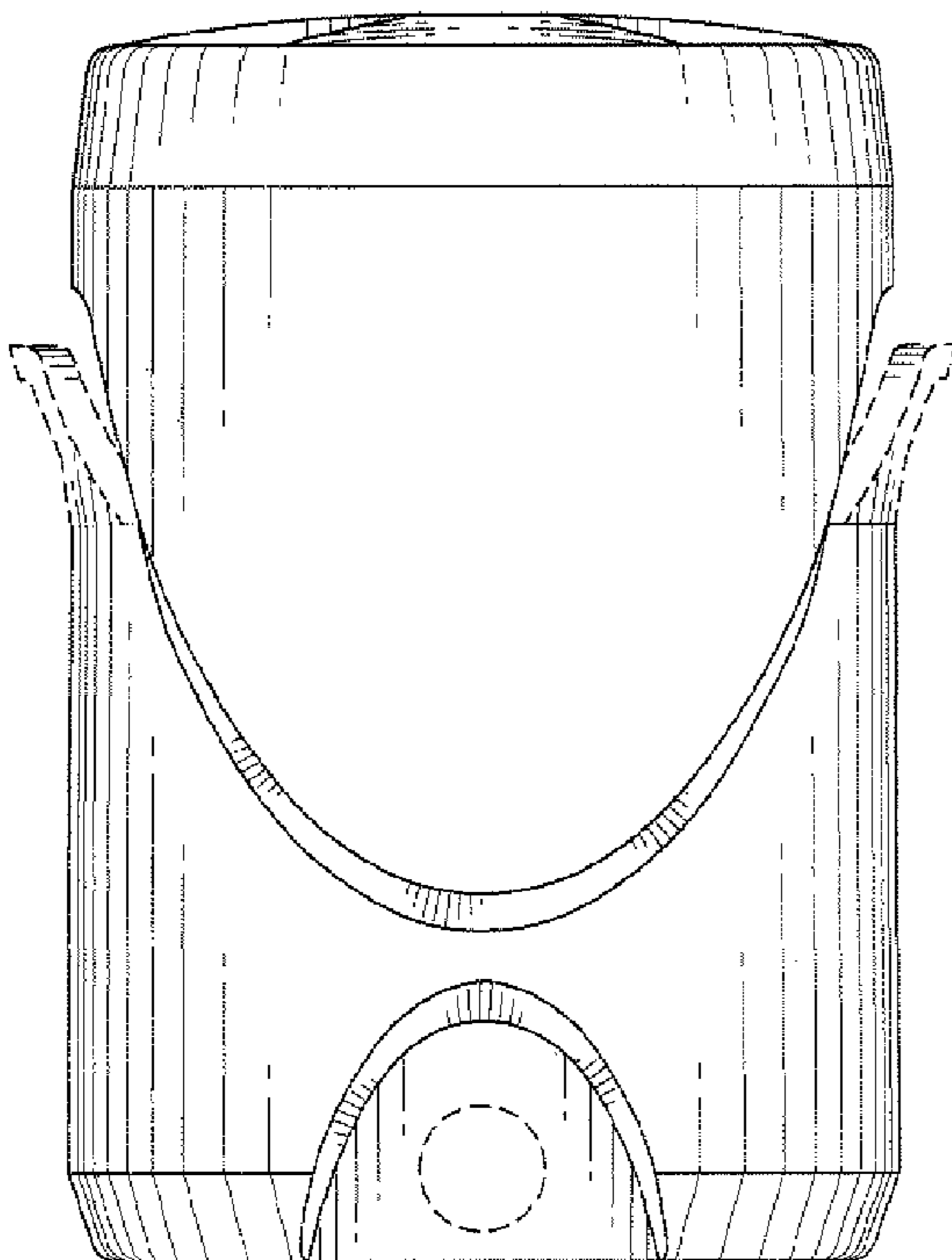
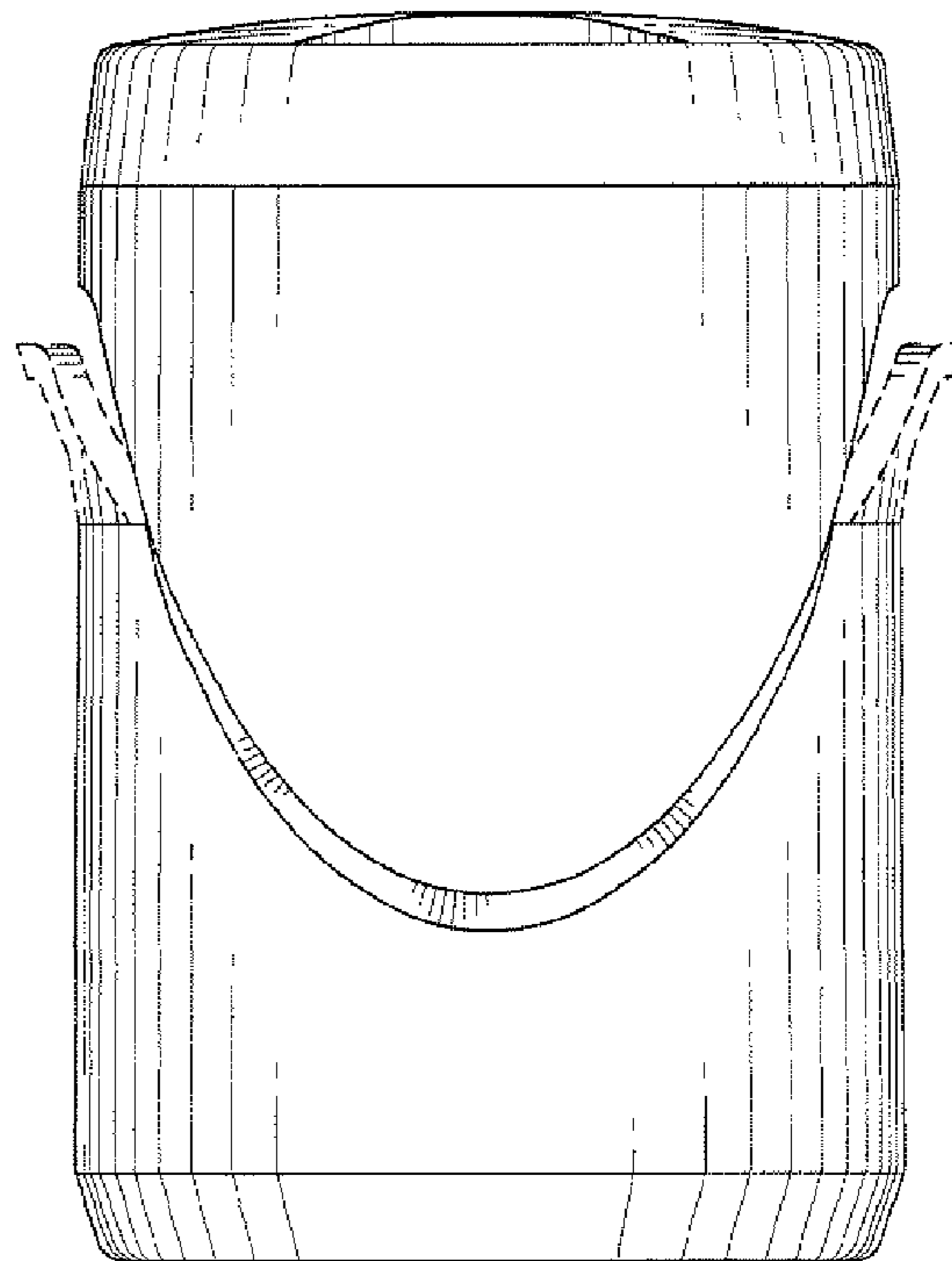
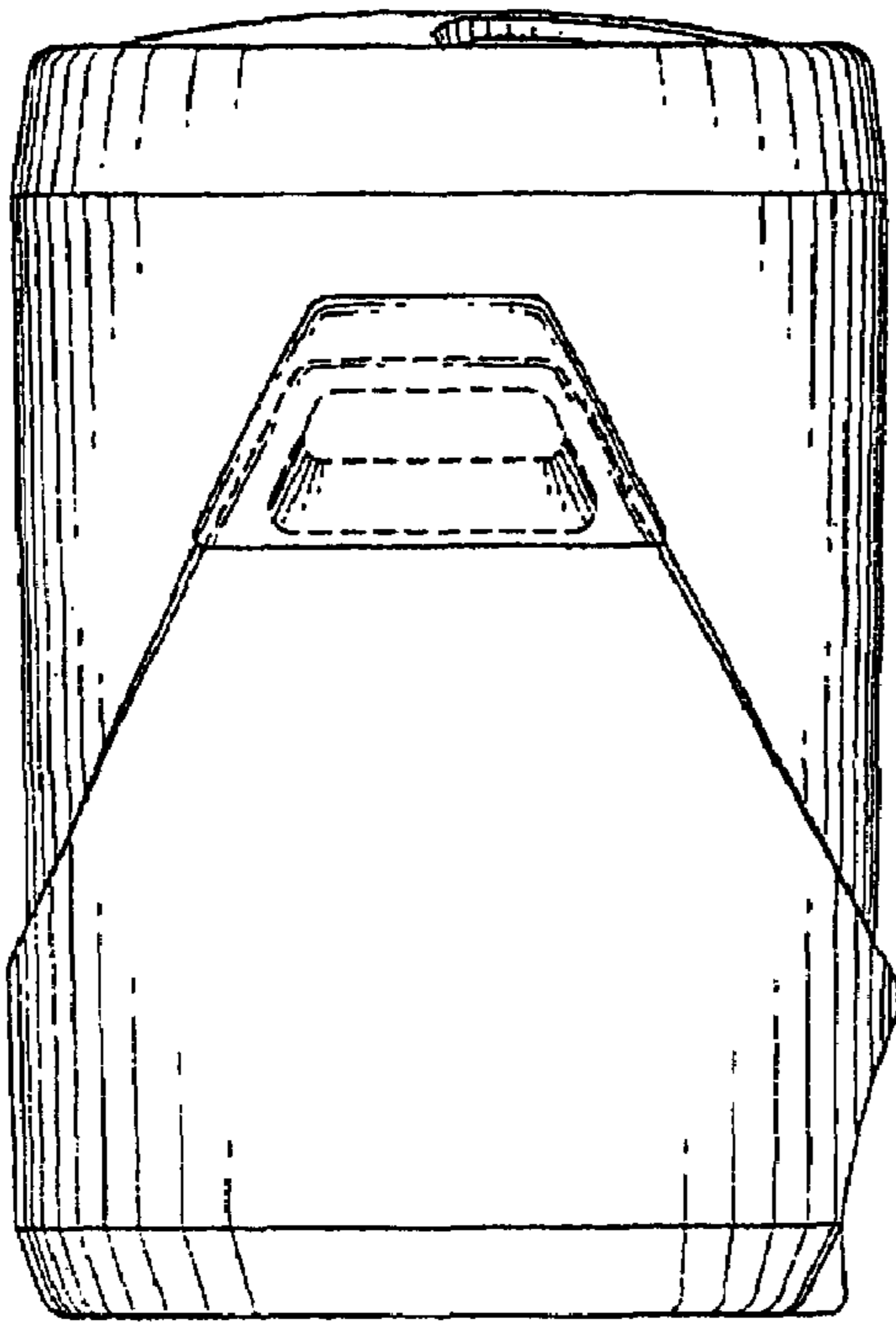


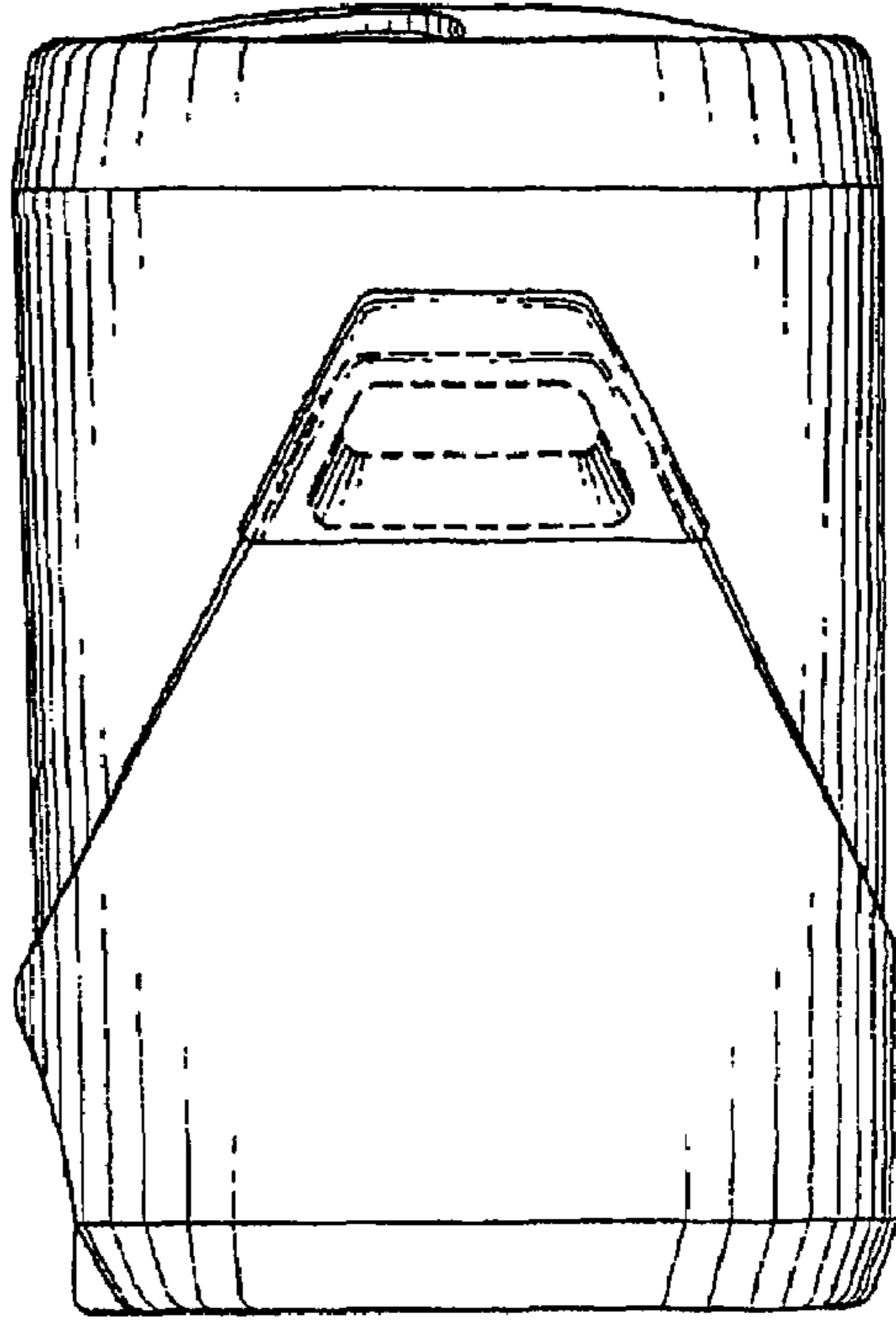

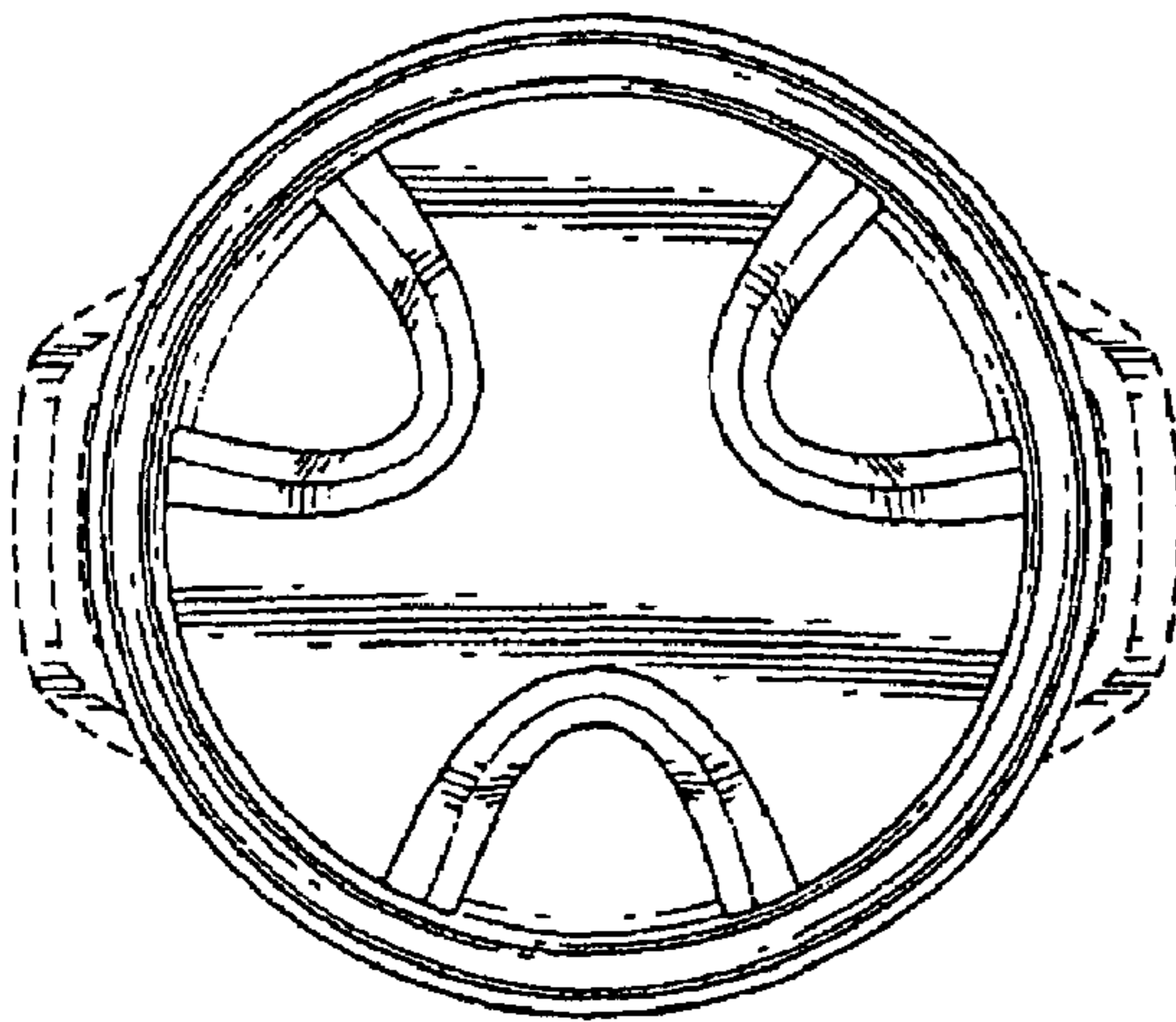
